Three day plan to save Christmas!

■ PM's lockdown blueprint to cheer the nation

FAMILIES will be allowed to celebrate this Christmas together under plans to ease lockdown rules.

Boris Johnson wants a three-day 'window' for the festive season that will let members from a maximum of three separate households gather under the same roof.

To secure as normal a Christmas as possible, ministers are discussing an overall limit on numbers of people – likely to be around 10 – who can gather around the table for Christmas dinner.

The talks come as the Government is preparing a toughened threetier regional regime of restrictions.

This will potentially

include stricter rules than enforced before on alcohol sales and household mixing and could replace the current second lockdown across England from December

The Prime Minister's spokesman said: "We are looking at ways to ensure

that people can spend time with close family over Christmas at the end of what has been an incredibly difficult year."

Talks between Downing Street and the leaders of the devolved Governments in Scotland, Wales and Northern Ireland about imposing the same rules over the entire UK for a brief period are said to be making progress.

'separate rules'

A Downing Street spokesman said: "We are looking at ending national restrictions on December 2 and moving to a tier system.

"There will be separate rules for Christmas but no decision has been taken about those yet."

Debate about the limit on attendees at festive gatherings is continuing amid concerns about discriminating against families with large numbers of children.

Downing Street yesterday confirmed the PM intends to end the second lockdown in England on schedule next month, although work is still continuing on how the new regional system will function. Some sources claim an extra fourth tier of even stricter rules could be added for areas suffering the worst Covid outbreaks.

But Communities Secretary Robert Jenrick insisted the new regime would mark a "significant easing" of coronavirus measures.

He said: "The Prime Minister and the Government's hope and very firm expectation is that we will see a significant easing of measures as we move into December."

Mr Jenrick was asked if the Government might be forced to ban indoor meetings over Christmas if Covid-19 cases are still high.

He said: "We don't know that yet. The hard yards that we've done in November were designed to enable most people in England to have a much more normal December so that we can go to the shops, we can use hospitality and, as far as possible, we can be together as families at Christmas.

"We can see from the data that the tiered approach in October and early November was having an impact, particularly in some parts of the country.

"It's too early to say the true impact of the new national measures because there's a lag time of two or three weeks, but hopefully by the end of November we'll be in a position to take that judgment."

Asked about the change in restrictions next month, the PM's spokesman said: "It's our intention to bring the tougher national measures to an end on December 2. That

will happen in law and we will then move to a regionalised approach again. We will set that out to Parliament next week. In terms of the progress which is being made, obviously we will wait to see further data over the course of the next week or so."

The national R infection rate was falling, the spokesman added.

The UK daily death toll rose by 529 on Wednesday to a total of 53,274 since the pandemic began.

New 'mega-labs' will boost testing by 600,000 per day

■ Facilities will be "absolutely crucial" in helping us "return to normality", say UK health chiefs

BRITAIN will double its testing capacity by building two "megalabs" early next year.

One will be in Leamington Spa, Warks, and another in Scotland – and will allow 600,000 more tests each day when fully up and running.

Health chiefs said they were "absolutely crucial" in helping us "return to normality".

According to official figures, current capacity is at an estimated 519,951 – with 379,955 tests actually processed.

Doing 300,000 more in each lab will mean faster turnaround times for results, according to health chiefs, while each facility will have a workforce of up to 2,000 people once fully staffed.

The announcement is recognition we lag behind in diagnostic testing, something Health Secretary Matt Hancock admitted at the start of the crisis.

The labs form part of the infrastructure for future epidemics. As well as processing Covid-19 tests, the facilities will be used to speed up the results of investigations into critical illnesses like cancer, cardiovascular and metabolic diseases.

They will employ British-made tech including automation, robotics and consumables, meaning more tests will be processed more quickly and at a lower cost.

Mr Hancock said: "We didn't go into this crisis with a significant diagnostics industry, but we have built one, and these two mega-labs are another step forward.

'hugely grateful'

"Transforming the UK's diagnostic facilities is not only essential to beating this virus, but it is necessary to build back better – so we are better prepared in future for testing on a massive scale."

He added: "The work going on in these labs is ultimately working to save lives and I am hugely grateful for everyone who has worked so hard to achieve this.

"Not only will that mean more tests, but it will also mean they can be processed more quickly, and the time it takes to receive results is reduced.

A recruitment drive has started for the Leamington Spa site and a campaign is due to start shortly in Scotland.

Baroness Dido Harding, interim executive chair of the National Institute for Health Protection, said: "We have already reached our goal of 500,000 testing capacity per day by the end of October, but we have not stopped.

"Our lab network includes the NHS, academia, the not-forprofit and the private sector and the addition of these new labs will mean another step up in our testing capacity next year.

Not only will that mean more tests, but it will also mean they can be processed more quickly, and the time it takes to receive results is reduced."

Health minister Lord Bethell added: "The labs are being set up by leaders of science with decades of experience."

He said that anyone who joins "will be offered the opportunity to learn new skills while

receiving training in a lab environment".

He added: "This work is absolutely crucial to tackling Covid- 19 and enabling the return of more normality to our lives."

And more than 40

specialist clinics will be set up in England amid concerns thousands are suffering long-term effects of coronavirus.

The £10million scheme for 43 centres will bring together doctors, nurses, therapists and other NHs staff.

Ten areas have been earmarked for the Midlands, seven in the North-east, six in the East, south-west and southeast regions, five in London and three in the North-west.

It's the Fairytale of New York....but not how we know it

BBC Radio 1 will not play the original version of Fairytale of New York by The Pogues and Kirsty MacColl this Christmas, because its audience may be offended by some of the lyrics.

The station said young listeners were particularly sensitive to derogatory terms for gender and sexuality.

It will instead play an edited version with different lyrics sung by MacColl.

But the 1987 original will still be played on Radio 2.

A BBC spokesman said: "We know the song is considered a Christmas classic and we will continue to play it this year, with our radio stations choosing the version of the song most relevant for their audience."

The duet is one of the most enduring Christmas pop songs, having returned to the UK top 20 every year since 2005. Along with a string of other festive favourites, it is now rising the chart again, at 59 in the current midweek chart.

But Radio 1 has decided younger listeners who are unfamiliar with the track would find some of the

words stark and not in line with what they would expect to hear on air.

The new edited version changes two lines - one swapped for an alternative version in which MacColl sings "You're cheap and you're haggard" in place of a homophobic slur.

MacColl sang the newlyadded line on Top of the Pops in 1992. She died in a boat accident in Mexico eight years later, at the age of 41.

The same wording was used by Ronan Keating and Moya Brennan in their 2000 cover version.

When Ed Sheeran and Anne-Marie performed the song in Radio 1's Live Lounge in 2017, she opted to call him a "cheap lousy blagger".

In Radio 1's newlyedited version, another line, sung by Shane MacGowan in the second verse, has a word removed entirely.

Radio 1 has played the song in its original form in recent years, but the insults contained in the lyrics, sung in the form of a blazing row between an alcoholic and a heroin addict, have long been criticised by some.

The track was censored by Radio 1 back in 2007, but that decision was swiftly reversed after an outcry by its fans.

Andy Parfitt, the station's controller at the time, explained the U-turn by saying its audiences were "smart enough to distinguish between maliciousness and creative freedom", and there was no "negative intent behind the use of the words".

Showbiz veteran Des O'Connor dead at 88

■ Entertainer was "well loved by absolutely everybody" and "loved life".

Entertainer Des O'Connor has died at the age of 88, his agent has confirmed.

The comedian, singer and TV host died on Saturday following a fall at his home in Buckinghamshire just over a week ago.

He was known for hosting his own chat show, as well as Take Your Pick and Countdown - and for his friendship with Morecambe and Wise.

In a statement his agent said he was "well loved by absolutely everybody" and "loved life".

His long-time agent and family friend Pat Lake-Smith described him as the "ultimate entertainer" and said he had been recovering from the fall before his condition had suddenly deteriorated.

She said: "He was a joy to work with - he was talented, fun, positive, enthusiastic, kind and a total professional. He loved life, and considered enthusiasm almost as important as oxygen."

Farewell to 'true legend' Clemence



TRIBUTES have been paid to "true legend" Ray Clemence – the former England goalkeeper who has died following a 15-year battle with prostate cancer

The 72-year-old (above) won three European Cups and five First Division titles during a trophy- laden spell with Liverpool, before winning an FA Cup and Uefa Cup with Tottenham.

His family, who were with him as he passed away on Sunday, wrote: "After fighting so hard, for such a long time, he's now at peace and in no more pain."

Clemence, who played 61 times for his country, had been living with advanced prostate cancer since 2005.

In an interview in 2018 he said: "I just want to give a positive attitude to everybody who

has a connection with prostate cancer, whether they're helping to find cures or they've got it.

"There's lots of talk about men like me only lasting five or six years with it. Well, I'm 13 years now and doing all the things that I want."

Ian Rush, who played alongside Clemence in the Liverpool side which dominated English and European football in the late 1970s, called his friend a "true legend".

North of the Border, Clemence is best remembered for Scotland's second goal in their 2-1 victory at Hampden in 1976 when Liverpool team-mate Kenny Dalglish steered it between his legs.

"Gordon Banks is remembered for his save against Pele and I'm remembered for that," he once said.

Dalglish tweeted: "Today we have lost a true legend. Clem was a fantastic teammate and great to be around. I will never forget how he helped me to settle in at Anfield."

At Tottenham, which he joined in 1981 aged 32 for a fee of £300,000, he won more trophies and the enduring affection of fellow players.

Ossie Ardiles, who played with him at Spurs, said: "He was a great keeper, wonderful companion, friend."

his own prime-time TV shows for more than 45 years but also had success as a singer.

His friendship with comedy duo Morecambe and Wise saw him mocked for his singing ability in sketches despite a successful career which included four Top 10 hits and more than 30 albums.

O'Connor appeared on stages around the world including hundreds of shows at the London Palladium.

His fame soared when he was hired to host The Des O'Connor Show, which ran on ITV from 1963 to 1971.

In 1977 he began hosting Des O'Connor Tonight, which started on BBC Two before moving to ITV, where it stayed until it ended in 2002.

He later hosted the

Channel 4 quiz show Countdown alongside Carol Vorderman, with the pair bowing out together in 2008, and was made a CBE for his services to entertainment and broadcasting in that year's birthday honours.

O'Connor was married four times, and has described the end of his first three relationships as casualties of his obsession with work.

'great entertainer'

In 2007, he married long-term girlfriend Jodie Brooke Wilson, who was 37 years his junior and gave birth to their son Adam when O'Connor was 72.

O'Connor also had four daughters, Karin, TJ, Samantha and Kristina from his previous marriages.

Broadcaster Tony Blackburn said "he was a great entertainer and more importantly a very nice person", and TV presenter Gyles Brandreth described him as "the ultimate professional".

'brilliant'

Speaking about his sketches with Morecambe and Wise, comedian David Baddiel said: "RIPDes O' Connor. It's worth remembering how brilliant he is at his own expense in these sketches."

Northampton Town Football Club also joined the tributes to their former reserve player.

The club said: "We are very sorry to learn of the passing of Des O'Connor. Des famously played for our reserve team on a few occasions just after World War Two. Our thoughts are with all who knew Des."

BORIS Johnson aims to fight Scottish independence with a Union taskforce of Tory MPs to help him tug at heartstrings.

The Prime Minister is about to launch the group and ask it to dream up policies to keep Scotland sweet.

Previously the pro-Union arguments focused on money or Project Fear.

But the PM wants to make an emotional case too

England and Wales will also be wooed with the approach, while new press secretary Allegra Stratton's televised addresses will go on the road from the devolved nations.

Mr Johnson's plans come after the exit of aide Dominic Cummings, who was said to have no interest in the Union.

Scotland First Minister Nicola Sturgeon wants another independence referendum in 2021. The 2014 result saw 55 per cent vote no to breaking away.

Gillian Anderson's praise for Thatcher's 'extraordinary mind'

GILLIAN Anderson has praised Margaret Thatcher's "extraordinary mind" as she talked about playing the politician in The Crown.

The actress, 52, portrays the former Prime Minister in season four of Netflix's royal drama, which launched on Sunday.

Talking to Harper's Bazaar, Gillian said: "I wouldn't necessarily agree with her leadership style. By the end, I think she became quite dictatorial. She was in power for 11 years, and they say that leaders should never go beyond seven years or they start to go mad. But she had the most extraordinary mind."

Before taking on the role of the Iron Lady, Gillian learned about Mrs Thatcher's childhood.

She said: "Childhood is always a very helpful and informative place to start.

Margaret Thatcher grew up as a grocer's daughter and as an alderman's daughter – a Methodist – so all of those aspects defined who she was as Prime Minister,

her policies and how she budgeted for the country.

"She built her world. She really worked hard to get to where she was. Whether you are a supporter of hers or not, or like her or don't like her, you can't let go of the fact that she really made herself."

But the series also drew fire from critics who faulted liberties taken with the facts.

Sir Bernard Ingham, former press secretary Lady Thatcher, savaged the fourth season for suggesting the former premier had a "strained" relationship with the Queen.

He said: "Margaret Thatcher revered the constitution and the Crown, and the very idea she had a scratchy relationship with the Queen is, to me, more for publicity of the film than accuracy.

Accuracy

"Why do people think that these filmmakers and producers and what-not produce the truth?

"They're concerned about bums on seats.

Sir Bernard's blistering attack on Times Radio came hot on the heels of a similar tirade by friends of Prince Charles who accused producers of "trolling on a Hollywood budget".

Over the weekend Palace insiders accused Netflix of exploiting the Royal Family's troubles for financial gain, adding that "fiction is presented as fact".

The latest season

focuses on Prince Charles, played by Josh O'Connor, and Princess Diana's love story, and the breakdown of their marriage.

In one scene it shows Emma Corrin, who plays Diana, and Josh, 30, putting on a united front while dancing in the middle of a ball while in Australia.

Thousands of viewers took to social media to share their reviews on Olivia Colman's final outing as the Queen. But not all viewers were convinced by the historical drama, calling it "a spoof without the humour".

Music and film fan Jon Wallis said: "I tried to watch The Crown. Aside from the budget and visuals, I couldn't get over how silly it was.

"Lots of ridiculous scenes and conversations that probably never took place in reality.

It's like a spoof without the humour. And the ham acting and accents!

Is that the appeal? "I'm shocked to see five-star reviews from serious critics. It's dire. I'm not being snobby either.

"I love a bit of trash telly, but this one seems to be neither out-and-out trash nor serious drama."

Insta success for 'Potter' actor Grint

Rupert Grint has beaten the record for the fastest time to reach one million followers on Instagram.

Guinness World Records says the Harry Potter actor managed the achievement in just four hours and one minute - after joining the site earlier this month.

The previous title holder - Sir David Attenborough - achieved the same number in four hours and 44 minutes, beating Jennifer Aniston who held the title previously at five hours and sixteen minutes.

Grint used his first post to introduce his baby girl Wednesday to the world with a selfie.

He wrote: "Hey Instagram....only 10

Open Enrollment: what you need to know

Health insurance is one of the most complicated things to deal with at the best of times.

It is even more confusing for Brits who have been lucky enough to grow up with the NHS. We are currently in open enrollment season, which is our brief window to sign up or change our health insurance policies. With the current pandemic looming over all of us, it is now even more important than ever to have decent coverage.

We contacted our friend and fellow Brit, Adam Beach and asked him and his team to put together a comprehensive guide explaining how it all works. Beach Financial Group are insurance brokers and it doesn't cost you a penny if you decide to use them to help you pick a plan. But it certainly saves you a massive headache!

They can also help to see if you qualify for Covered California. Covered California is a platform that assists Californians connects them and with health insurance carriers. Depending on your income, zip code, and household size, you are able to verify if you qualify for subsidies (financial assistance for your health insurance monthly payment.) this can result in big savings if you are on a low income.

Another thing to keep in mind when choosing your insurance policy is to ask if it covers you outside of California. Most insurance carriers will cover ER and Urgent care out of state. If you are traveling outside of the country some will even assist with the cost of any emergency medical bills when you file a claim and submit the invoices. But not all, so if this is important to you

make sure to ask before you sign on the dotted line.

Last, but not least if you have a favourite doctor you should find out beforehand if they accept your insurance. My GP is actually not covered but my current plan, but I like and trust him so much that I chose to stick with him and pay out of pocket. However, if he runs any lab tests they do go through my insurance. If it hadn't been for Adam and his team explaining this scenario was possible I might have stopped visiting my preferred doctor. I honestly can't recommend them enough!

Now over to BFG who are going to try and help you understand a little bit more about how to navigate the health insurance market during open enrollment:

What is open enrollment?

Open enrollment is a period during the year where you are able to purchase health insurance or make health insurance plan changes. In the state of California, open enrollment begins on November 1st and ends on January 31st. For a January 2021 effective changes date. enrollments need be made by December

15th. Any changes after December 15th will become effective on February 1st. Changes made between December 16th – January 15th will give you a February 1st effective date.

What changes to expect from open enrollment?

During open enrollment you can expect a slight premium increase and potential benefit changes. Health insurance premiums in the State of California are based on age and zip code. As we age, our health insurance premiums will increase.

What is HMO, PPO, and EPO?

Exclusive Provider Organization (EPO) – This is the hybrid of the HMO and PPO. This type of plan is more affordable than a PPO, similar network to an HMO, but just like the PPO, you can make your own appointments to visit a specialist without a

referral.

The Republic of Ireland stayed up despite only scoring one goal in the tournament. A 0-0 draw with Bulgaria was enough to keep them up.

Toon to sue Premier League over failed takeover

Newcastle United have confirmed they have launched legal proceedings against the Premier League following a failed takeover bid in the summer.

The club claim the Premier League broke a confidentiality clause when it "leaked the contents" of a letter about the proceedings to a supporter group.

A Saudi Arabian-backed consortium pulled out of a £300m deal in June.

They rejected the offer from the Premier League (EPL) of arbitration to determine who would own the club.

Newcastle say they have not previously commented on the proceedings "with respect to its conduct relating to the proposed takeover because of the confidentiality clause in the EPL's rules".

It relates to Newcastle Consortium Supporters Ltd (NCSL) delivering a letter to the Premier League, "questioning the body's conduct in the owners' and directors' test".

The supporters' club says it then received a response from the Premier League's lawyers, Bird and Bird, confirming there was already a legal dispute from the club.

Foden proves the ice man!

■ Nations League: England stroll to victory in dead rubber win over Iceland

Phil Foden led England's young brigade in style as they concluded their Nations League campaign with a comfortable 4-0 win against Iceland in a dead rubber at Wembley on Wednesday.

This final game of the qualifying campaign had nothing riding on it with England's hopes of reaching the finals ended by defeat in Belgium, and Iceland without a point in Group A2, but it was a game where Gareth Southgate's emerging youngsters staked their claims.

Declan Rice headed England in front with his first international goal after 20 minutes before Mason Mount added a second from close range four minutes later.

Manchester Foden, still only 20 and back in the fold after being dropped for breaking Covid-19 protocols in September, also demonstrated his huge potential and growing maturity on the international stage with a fine performance and late strikes as he swept in Jadon Sancho's pass for his first England goal with 10 minutes left before quickly adding a second with a low shot.

England's players are still fighting for places in next summer's European Championship and the likes of Foden, Aston Villa's Jack Grealish and Arsenal's teenage defender Bukayo Saka took the chance to impress manager Southgate.

Iceland were reduced to 10 men in the second half when Birkir Saevarsson was shown a second yellow card for dragging

back Saka as England dominated.

Foden is a bundle of talent and confidence and it was his delivery that offered the invitation for Rice to score the opener, then got the goals his performance deserved late on to push himself right to the forefront of Southgate's thoughts.

It was summed up in the closing seconds when he showed remarkable skill to pull down a misplaced, skied, clearance from Harry Maguire, controlling and flicking it behind a bemused Icelandic defender.

Southgate defended his side's approach in the wake of the defeat against Belgium, amid suggestions his ploy of using a 3-4-3 formation with two holding midfield players was too conservative.

Here, with Liverpool captain Jordan Henderson unavailable because of injury, Southgate continued with Rice and Mount but also used both Grealish and Foden to add creativity.

And, in their different ways, all four made a big impact as England won a game that often had the intensity of a training work-out.

Grealish carried on where he left off in Leuven, carrying the ball into dangerous areas, wandering into space and continuing to draw fouls in threatening positions, while Foden was the star of the show.

Saka was another standout performer, solid in

defence and dangerous in attack. He could have had goals himself but did enough to suggest he will

be a serious contender for starting place in future. Southgate now has

until March to weigh up

his plans as the Euros come closer and that young brigade will be at the forefront of his mind.

Wales earn promotion

Wales were promoted to the Nations League top flight, but Scotland failed to join them - and Northern Ireland have been relegated.

Italy, Belgium, France and Spain are in next year's finals - but England, who finished third in their group, are not.

The two highestranking group winners not to secure a spot for the World Cup or playoffs through regular qualifying will earn a play-off place.

Wales earned more points than anybody else in League B, so with all the League A group winners likely to qualify on their own merits next year, Ryan Giggs' side will probably be in the World Cup play-offs.

Winning a group means promotion and finishing bottom of a group in the top two leagues means relegation (League C has relegation play-offs).

The finals will take place in October 2021, with Italy expected to host.

The only thing yet to be decided is relegation from Group A4. Ukraine were unable to play their match against Switzerland because they had several positive Covid tests, with Uefa to decide what the result will be.
