Big Brother Archie!

■ New royal baby on the way as Harry and Meghan are expecting a second child

HARRY and Meghan had a special Valentine announcement this week: "Archie is going to be a big brother."

The couple shared a black and white picture of themselves, with Prince Harry resting his hand on his wife's head as she cradles her bump.

A spokesman for the couple said: "We can confirm that Archie is going to be a big brother. The Duke and Duchess of Sussex are overjoyed to be expecting their second child."

The baby will follow the couple's son Archie Harrison, who will turn two on May 6.

Palace sources confirmed members of the royal family were informed by Harry and Meghan that they were expecting prior to the announcement.

A Buckingham Palace spokesman said: "Her Majesty, Duke of Edinburgh, Prince of Wales and entire family are 'delighted' and wish them well."

The couple have made no secret of their desire for a second child but Harry said in a Vogue interview in July 2019: "Two, maximum."

Their limit is for environmental reasons.

In November, Meghan, 39, disclosed she had suffered a miscarriage last July. The Duchess spoke

candidly about enduring "unbearable grief" in an article for the New York Times, writing: "I knew, as I clutched my firstborn child, that I was losing my second."

In recent weeks, Meghan has made several choreographed appearances online, but her bump has always been hidden.

The couple live with Archie in a multimillion pound mansion in Santa Barbara, California, after they officially stepped down from their roles as senior royals in March last year.

The photo was taken by longtime friend and photographer, Misan Harriman. He tweeted: "Meg, I was there at your wedding to witness this love story begin and, my friend, I am honoured to capture it grow. Congratulations on this joyous news."

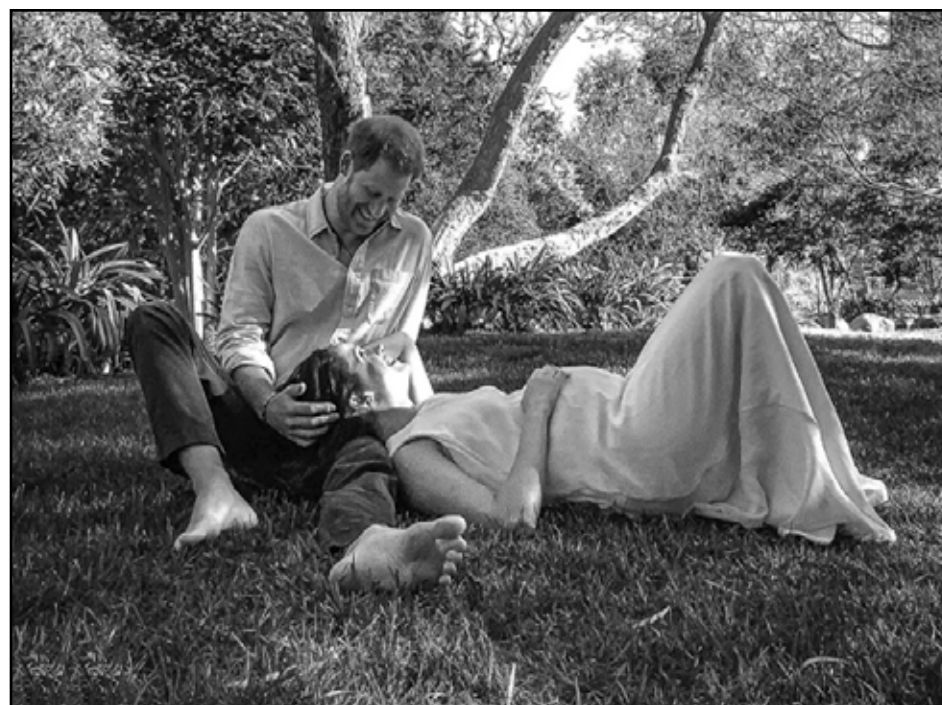
Baby Sussex will be the Queen and the Duke of Edinburgh's 10th or 11th great-grandchild, depending on whether he or she arrives before or after Zara Tindall's baby.

Harry retains his place in the line of succession despite quitting royal life and dropping his HRH title, and the new baby

will be eighth in line to the throne.

They are entitled to be a Lord or a Lady, but Harry and Meghan will again opt to style their second-born a plain Master, like Archie, or a Miss, with the surname Mountbatten-Windsor.

Bookies Ladbrokes revealed frontrunners for names are Alfie and Alexandra, at 4/1 apiece. Elsewhere, 6/1 says they call their second-born Freddie or Arabella, with Doria a less likely shot at 12/1 and Diana at 10/1.

It's official....lifting of lockdown will begin next month

LOCKDOWN will officially end for millions of beleaguered Britons next month with the reopening of schools and a relaxing of draconian stay-at-home rules.

All schoolchildren are likely to return to the classroom on March 8, while adults are expected to be allowed to picnic with one friend, or their household.

A second easing of social distancing rules is expected at the end of March with the resumption of outdoor sports, such as golf and tennis, for two

people from different households.

The opening of non-essential shops is likely to follow in a major boost to the flailing High Street.

And in a huge relief for the blighted hospitality sector, pubs and restaurants are understood to be opening up for al fresco dining in April.

The 10pm curfew and substantial meal rule is also reportedly being ditched.

Boris Johnson will set out the long-awaited first steps to freedom in a national address next week. He is encouraged

by faster than expected reductions in hospital admissions and falling infections – as well as the rapid rollout of the Covid vaccine.

Progress

Further lifting of lockdown measures will depend on the progress of the virus and the job programme.

The decision to reopen both primary and secondary schools goes against the advice of some government scientists who say it will push up the infection rate.

And the move to

prioritize the return of pupils over reopening the economy will put the Prime Minister on a collision course with Conservative MPs, 63 of whom signed a letter this weekend demanding the lifting of all restrictions by the end of April.

Downing Street regards a slow easing of social distancing measures as the price it has to pay for schools going back.

Foreign Secretary Dominic Raab confirmed that the Government is trying to get all schools reopened by March 8 but refused to rule out a

phased approach, with primaries reopening before secondaries.

He told reporters: "I don't think there's a high risk in relation to schools of children getting it, or even teachers and staff. The risk is the transmission in the household that comes from it. On that we have just got to look at the evidence.

We do need to wait."

A decision on when to reopen universities is yet to be taken.

Mr Raab played down suggestions that pubs and restaurants could reopen outdoors by Easter, on April 2.

He said: "It is difficult to say where we'll be in such a relatively short period of time.

"What I can tell you is that schools is a priority. On top of that non-essential retail. Then after that, given the wider risk of transmission, we want to get hospitality open."

There is growing hope that the jabs will reduce the transmission of coronavirus, seen as a key factor in easing the lockdown.

Data from Public Health England on the effectiveness of the vaccines suggests the "real world" impact of the jabs give 67 per cent protection against the virus three weeks after a

single dose.

Professor Tim Spector, of King's College London, said that data collected from 50,000 people on a tracking app suggests that vaccines give 46 per cent protection after two weeks and 67 per cent after three to six weeks.

He said he expects Britain will be in a "much better place" in two to three weeks and can begin to ease lockdown restrictions.

Prof Spector told Sophy Ridge on Sky News: "If that was around the country, then we'd have really knocked this on the head."

Ministers are understood to have drawn up a four-speed plan for restarting the economy, with all shops, pubs and restaurants open anywhere between early May and August.

The "superfast" plan would see restaurants and pubs reopening in early May once all the over-50s have been vaccinated.

Optimistic The slower alternatives would see the hospitality sector reopen by the spring bank holiday on May 31 or mid-June.

The slowest route would be to reopen by August.

Ministers and scientists also hope to be able to remove the requirement for the public to wear masks on public transport and in shops by

September.

But only No 10's most optimistic scenario seems likely to satisfy Conservative MPs.

Backbenchers in the Covid Recovery Group have written to Mr Johnson demanding that all pubs and restaurants are allowed to open by Easter and all restrictions be lifted by the end of April.

The letter is signed by Mark Harper and Steve Baker, the rebel ringleaders, and 61 other MPs.

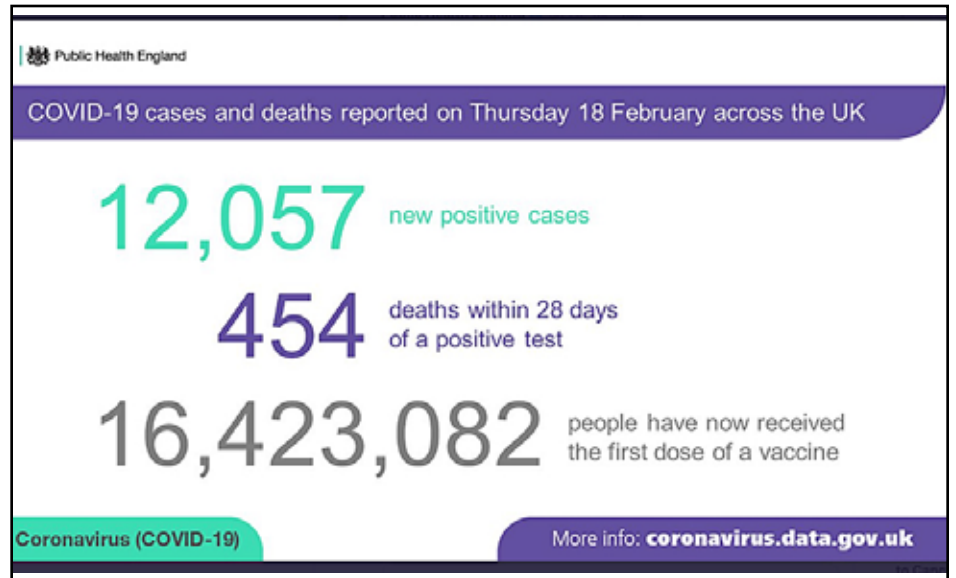
INFECTIONS have fallen by more than two-thirds since January due to the impact of lockdown, says a study.

Swab testing of more than 85,000 people in England between February 4-13 found one in 200 was infected, down from one in 65 between January 6-22.

Scientists at Imperial College London said this was "better than most people would have hoped for".

Health Secretary Matt Hancock said: "These findings show encouraging signs infections are now heading in the right direction across the country, but we must not drop our guard.

"Cases and hospital admissions remain high

Infections fall by two-thirds with lockdown

– over 20,000 Covid-19 patients are in hospital – so it is vital we all remain vigilant and follow the rules as our vaccination rollout continues at pace."

The React-1 study has been monitoring infection rates since May by randomly testing over a million people.

The latest round estimated that the R

value in recent weeks was around 0.72 and infections halving roughly every fortnight.

Prevalence fell in all regions and age groups, although there was greater uncertainty in the North-west, North-east, Yorkshire and the Humber.

The national infection rate has now dropped to a level last seen in

September. Experts said the impact of jabs may appear in the next few weeks of testing.

Steven Riley, a professor of infectious disease dynamics at Imperial, said the "trend is great" but if we do return to growth then we are at levels of hospital pressure "as we observed at the peak of the first wave".

Young volunteers paid £4.5k to get infected for study

BRAVE young volunteers will be deliberately infected with coronavirus to help scientists learn more about the virus.

The UK will become the first country to run a human challenge study after an ethics committee approved the plan.

Up to 90 volunteers aged 18-30 will be paid £4,500 each as they are exposed to increasing doses of the virus, in a controlled environment, to discover the smallest amount needed to cause infection.

The study is backed by £33.6million Government investment and could speed up development of vaccines and care.

Business Secretary Kwasi Kwarteng said: "Researchers and scientists around the world have made incredible progress in

understanding Covid-19 and developing critical vaccines to protect people.

"While there has been very positive progress in vaccine development, we want to find the best and most effective vaccines for use over the longer term.

"These human challenge studies will take place here in the UK and will help accelerate scientists' knowledge of how coronavirus affects people."

Human challenge studies have been used for decades to accelerate the development of treatments for diseases including malaria, typhoid, cholera, norovirus and flu. They allow researchers to study in detail how the body responds to an infection, while carefully monitoring the safety of volunteers.

The Covid-19 work will

use a strain of the virus that has been circulating since March, and has been shown to be of low risk in healthy young adults.

Participants will receive the virus as drops in the nose and have to quarantine for more than two weeks in hospital while they are monitored.

It is not designed to induce symptoms and as soon as volunteers start to "shed virus", they will be given the antiviral drug remdesivir as a pre-emptive treatment.

The study is due to begin in the next few weeks and will be delivered by experts from the Government's Vaccines Taskforce, Imperial College London, the Royal Free London NHS Foundation Trust and the company hVIVO, which has pioneered viral human challenge models.

Jobless total hits 2m

NEARLY two million people in the UK have not worked for at least six months, a study has revealed.

The Resolution Foundation think tank has called on Chancellor Rishi Sunak to address the damage to the UK labour force in his March 3 Budget.

Its study said although firms had adapted to operating through the Covid crisis since the first lockdown last March, its overall impact was causing the biggest challenges in the labour market.

Almost two million workers were unemployed or fully furloughed in January, and had been for at least six months. The study also found the number of workers in the Job Retention Scheme has risen to around 4.5 million in the current lockdown, half the nine million peak during the first lockdown.

While those on long-term furlough had more financial support and an easier route back into work, they faced many similar challenges, the study warned.

Problems included losing skills and missing out on earnings growth.

The think tank has urged Mr Sunak to keep the Job Retention Scheme running for several months after restrictions have been lifted, to give firms time to bring their staff back.

Foundation senior economist Nye Cominetti said: "The Chancellor must use his Budget to set out his own road map for phasing out the furlough scheme gradually, and in a way that acknowledges where the risks of rising unemployment are highest, in sectors like hospitality."

Meghan agrees to tell all to Oprah

■ Harry joins 'intimate' TV chat days after privacy win

THE Duke and Duchess of Sussex are giving an "intimate" interview to chat show queen friend Oprah Winfrey, it has emerged – just days after Meghan won a big privacy case.

The 90-minute US prime time show is likely to cause dismay in the Royal Household, a year since the pair's explosive interview with ITN's Tom Bradby and their first since quitting as senior royals to move to America.

CBS television bosses have unveiled plans for an "intimate conversation" between the couple and Oprah, who has made a fortune from confessional shows with stars such as Michael Jackson.

It came just a day after Meghan, 39, and Harry, 36, said they were expecting their second child.

CBS said that during the March 7 blockbuster Meghan will be asked by Oprah about "everything from stepping into life as a royal, marriage, motherhood,

philanthropic work to how she is handling life under intense public pressure.

"Later, the two are joined by Prince Harry as they speak about their move to the United States and their future hopes and dreams for their expanding family."

The revelation comes four days after Meghan won a High Court privacy battle against a Sunday newspaper that published a letter she wrote to her estranged father.

'beyond parody'

She argued it was a breach of her privacy but critics said the judgment would inhibit press freedom.

Piers Morgan, host of TV's Good Morning Britain, tweeted: "The Duke & Duchess of Privacy have given an exclusive 'wide-ranging' prime-time interview about their private lives to Oprah Winfrey... This is beyond parody, but true."

Buckingham Palace officials this week

remained tight-lipped about the idea of the couple again talking about their problems.

But sources said that as they had quit as working royals last March it was up to them what they did.

Oprah, 67, attended Harry and Meghan's wedding at Windsor Castle in 2018 and lives near them in Montecito, California.

She has worked with Harry on a TV series about mental health and in December promoted coffee made by Clevr Blends, a firm in which Meghan has invested.

She became US television royalty after launching The Oprah Winfrey Show in September 1986, creating a celebrity confessions juggernaut that has brought her a £1.8 billion fortune.

Stars including Elizabeth Taylor, Tom Cruise and Bette Midler opened their hearts to her – while her groundbreaking 1993 interview with Jackson at his Neverland ranch gave her two of her most-watched shows.

Meghan and Harry, whose son Archie was born in May 2019, were said to be relieved they finally could reveal her pregnancy after swearing

friends to secrecy for months. The duchess had a miscarriage last July.

One source said: "Harry excitedly messaged a whole host of his friends a few weeks ago saying that Meghan was pregnant and that the two of them were thrilled."

"He had them all sworn to secrecy though."

Meghan is thought to be at least five months pregnant. Speculation that she was expecting began in November when she requested a nine-month delay in the case against The Mail on Sunday for "confidential reasons".

But a judge ruled there was no need to go to a full trial on the main issues.

Pandemic brought air passenger numbers back down to earth

AIR passenger numbers dropped by 98 per cent at the height of the pandemic last year, official figures show.

Monthly arrivals to the UK fell from 6.8 million last February to 112,300 in April, data published by the Office for National Statistics (ONS) reveals.

The figures have been released as part of an analysis of how industries related to travel and tourism in the UK have been affected by the pandemic.

EuroTunnel also saw a sharp drop in traffic during the first lockdown. In April 2020, only 19,862 passenger vehicles travelled, compared with 227,393 in April 2019, a fall of 91.3 per cent.

After the partial relaxation of restrictions in both the UK and France, passenger traffic rose to a peak of 267,942 in August, a decline of 28.2 per cent from the same month in 2019.

The data also reveals Greater London saw the largest tumble in hotel room occupancy of any English region from 2019 to 2020, with just 20 per cent of rooms occupied in July last year, against 90 per cent the previous July.

Accommodation and travel agency businesses saw the sharpest decline in turnover during the first national lockdown.

It fell to 9.3 per cent of their February levels in May 2020.

Millions of cases going undetected, says boffins

MILLIONS of Covid-19 cases could be going undetected because people are only told to have a test if they develop a cough, fever or loss of smell, scientists warn.

A study suggests adding other symptoms including fatigue, sore throat, headache and diarrhoea would help pick up around a third more infections.

Classic symptoms

Professor Tim Spector, of King's College London, said: "The message for the public is clear – if you're feeling newly unwell, it could be Covid and you should get a test."

Scientists using data from 122,000 UK adults said testing those with any of the three classic symptoms would have found just 69 per cent of cases.

But extending the list to fatigue, headache, sore throat and diarrhoea in the first three days of illness would have detected 96 per cent of cases. The study, in the *Journal of Infection*, found 31 per cent of people ill with Covid-19 do not have any classic symptoms in the early stages of the disease when they are most infectious.

Clinical trials

The team said its findings could also be used in clinical trials to assess the effectiveness of potential Covid-19 vaccines.

A Department of Health and Social Care spokesman said: "The main symptoms have been carefully selected to capture those most likely to have Covid-19."

We must take 'prudent' steps to freedom, says Boris

PM insists 'data NOT dates' will dictate how lockdown rules are lifted

BORIS Johnson has vowed to free Britain from lockdown in stages based on scientific "data, not dates".

The Prime Minister said his "cautious, prudent" approach would make sure the return to normality is "irreversible" – and pubs and restaurants will be the last to open up.

A blueprint for easing Covid rules based on the latest scientific research is being drawn up over the next few days.

Mr Johnson will spell out details on Monday, but signalled this week that socializing would be among the final activities to resume.

'extra risk'

During a visit to a vaccination centre in Cwmbran, South Wales, he insisted: "We need to go in stages. We need to go cautiously.

"Last year we opened up hospitality fully as one of the last things we did because there is obviously an extra risk of transmission.

"We'll be setting out what we can on Monday about the way ahead and it'll be based firmly on a cautious and prudent approach to coming out of lockdown in such a way to be irreversible."

The Government is assessing how quickly it will allow households to mix indoors and when vacations can resume.

There have been claims that holiday lets could reopen for Easter but Mr Johnson said: "I know there's a lot of understandable speculation about what we're going to do, what we're going to say and about the rates of infection and so on.

"I would just advise

everybody just wait, we'll try and say as much as we can on that."

Another 454 virus deaths within 28 days of testing positive were reported on Thursday, taking the UK total to 129,498. There were an extra 12,718 lab-confirmed UK cases, pushing the overall toll to 4,083,242. A total of 16,423,000 people had received the vaccine at press time.

'big questions'

Mr Johnson said it was very encouraging that infection rates "are coming down a bit now", but said further research was needed. He added: "I think one of the big questions people will want to ask is, to what extent now is that being driven by vaccination? "We hope it is, there are some encouraging signs, but it's still early days."

which represents hospital trusts, warned Mr Johnson not to ease lockdown until case rates fell below 50,000 – less than a tenth of the 695,400 people in England believed to have had Covid in the week ending February 6.

NHS Providers chief executive Chris Hopson said the nation was "still some way away" from relaxing curbs.

'really careful'

He has urged the Prime Minister to wait until cases and pressure on the NHS falls,

the vaccine rollout is advanced and plans to control future outbreaks are in place.

Mr Hopson said: "If you look at where we are against those four tests, each one of them tells you that we're still some way away from being able to start relaxing restrictions.

"We had 500 Covid patients in hospitals in September and yet 15 weeks later we had 34,000 and we were perilously close to overwhelmed.

"So what that says to you is that you

just need to be really careful before you start relaxing the restrictions prematurely."

However, Professor Sir John Bell of Oxford University's vaccine team warned against keeping tight restrictions once the country is protected.

He told the Commons' science and technology committee: "It's not plausible to imagine a world where we vaccinate the whole country and everybody believes they are still in a place we were in six months ago."

Harry Dunn court case given go-ahead

THE woman alleged to have killed Harry Dunn will be grilled in a US court over her role in his death.

The news comes after a claim for damages brought by the teenager's parents was given the go ahead by a judge.

Anne Sacoolas, 43, who has been charged with causing Harry's death by dangerous driving, can now finally be questioned by lawyers in a civil claim.

The American was given diplomatic immunity and "fled" the UK days after the crash near RAF Croughton, Northants, on August 27, 2019.

Her legal team had wanted the case dismissed, claiming the UK would be a "more

convenient" forum. But a judge in Virginia ruled it should go ahead, as Mrs Sacoolas feared she would "not receive fair treatment" in the UK.

The court also took

into account a letter from Foreign Secretary Dominic Raab, asking for the case to proceed.

Dunn family spokesman Radd Seiger said: "The Sacoolases were, on the

one hand, arguing the civil claim should be tried in the UK...whilst at the same time arguing that she would not return to the UK because she fears she would not get a fair trial."

Prince Philip back in hospital

■ Ailing royal, 100 this year, has 'good days and bad days'

The Duke of Edinburgh was admitted to hospital on Tuesday evening "as a precautionary measure" after feeling unwell, Buckingham Palace has said.

Prince Philip, 99, was taken to the King Edward VII Hospital in central London, the statement added.

A palace source said the duke travelled by car to the hospital, where he was admitted on his doctor's advice.

He had been feeling unwell for a few days, but it was not related to coronavirus, the source added.

They said the duke - who is due to celebrate his 100th birthday on 10 June - was "in good spirits" in hospital, where he is expected to

remain for a few days of observation and rest.

The decision to admit him was done with "an abundance of precaution", one source said.

He had been feeling unwell for a short period and a doctor from the Royal Family's medical household was called to Windsor Castle, where the Duke has been in lockdown with the Queen.

In a brief statement, Buckingham Palace said: "His Royal Highness the Duke of Edinburgh was admitted to King Edward VII's Hospital in London on Tuesday evening.

"The Duke's admission is a precautionary measure, on the advice of His Royal Highness's doctor, after feeling

unwell. The Duke is expected to remain in hospital for a few days of observation and rest."

The Duke, who retired from public duties in August 2017, has had several stays in hospital in the past decade.

His last spell was when he spent four nights at the King Edward VII's in December 2019, where he was treated for a "pre-existing condition" and discharged on Christmas Eve. It was never made clear publicly if the treatment had cured the condition.

He has suffered a number of ailments over the years, including a blocked coronary artery in December 2011. He then suffered a bladder infection in June 2012,

which forced him to miss the Queen's Diamond Jubilee celebrations.

Exploratory surgery on his abdomen followed in June 2013 and he began to use hearing aids by 2014, aged 93.

He later pulled out of a Battle of Jutland anniversary event in June 2016 citing a minor

ailment. Soon after that he retired from public duty in 2017.

Philip and the Queen celebrated their 73rd wedding anniversary on November 20, and were pictured together looking at a card made for them by the Cambridge children.

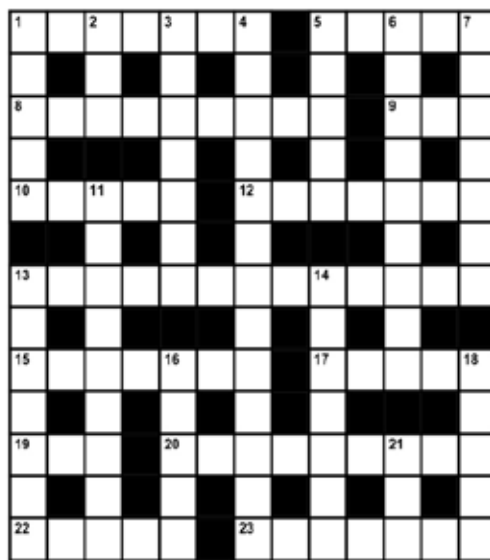

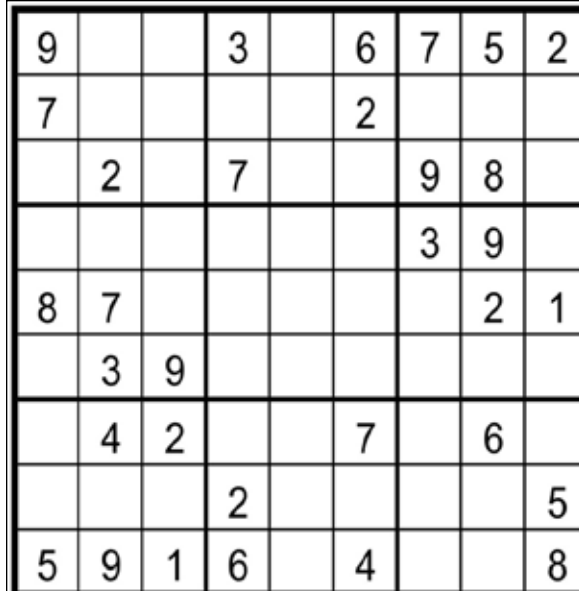

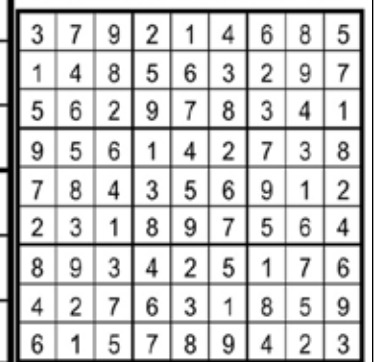

Every Mayor since then has recognized the month, especially the late Mayor Tom Bradley.

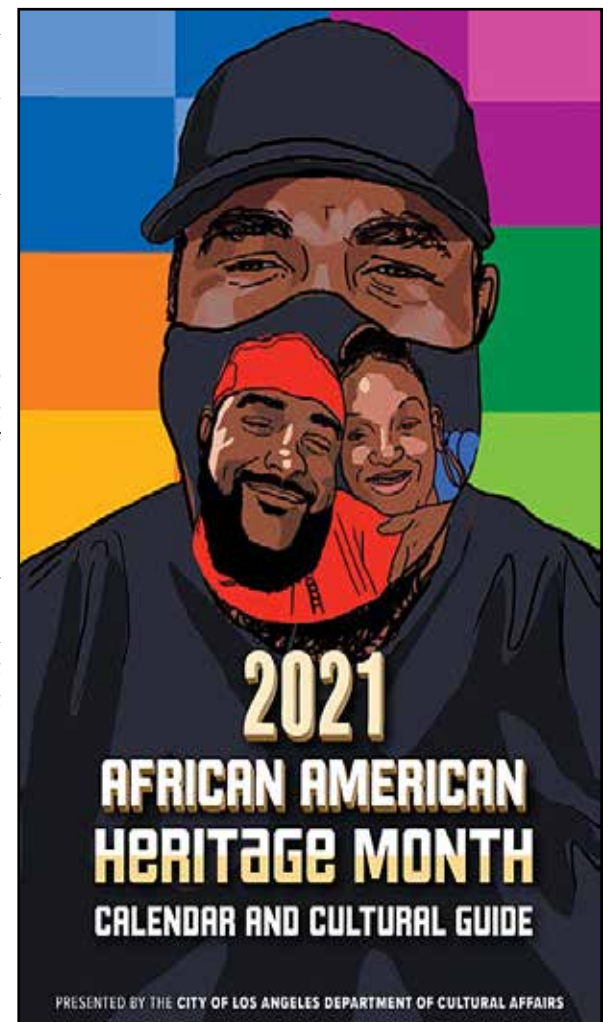

England succumbed to an inevitable 317-run defeat by India on the fourth day of the second Test in Chennai on Tuesday.

Faced with the hopeless task of chasing 482 on a deteriorating pitch, England lost all 10 wickets to spin as they were bowled out for 164 to leave the four-Test series poised at 1-1.

Only captain Joe Root provided prolonged resistance, but even he needed plenty of fortune in his 33, before Moeen Ali chanced his arm for 43 off only 18 balls.

Debutant left-arm spinner Axar Patel claimed 5-60, while off-spinner Ravichandran Ashwin took 3-53 - and match figures of 8-96 - to go with a century in India's second innings.

After two matches in Chennai, the series moves to Ahmedabad, with the day-night third Test beginning on 24 February.

Moeen will miss those matches, choosing to go home as part of England's rotation policy.

Halfway through, this series between two Test heavyweights is living up to its billing.

After England produced one of their finest away performances to win the first Test by 227 runs, India have dominated the second, exploiting

their expertise in dusty, spinning conditions.

While the tourists cashed in on winning the toss in the first Test, India did the same in the second. Even if this match will be remembered for the pitch, that should not detract from the fact that the home side have been vastly superior.

Rohit Sharma and Ashwin made more runs than the entire England team. Ashwin and Axar applied more pressure than England spinners Jack Leach and Moeen, while Rishabh Pant pulled off as many moments of wicketkeeping brilliance as Ben Foakes.

City certain to win title, says Carlo

■ **“At the moment they are the best team, they have quality, power, belief,” says Toffees boss after midweek loss**

Carlo Ancelotti believes Manchester City are hurtling towards a third Premier League title in four seasons after his Everton side were beaten 3-1 by the Premier League leaders on Wednesday night.

The Everton boss said it was “almost impossible” to compete against Pep Guardiola’s side, who extended their lead at the top to 10 points with 14 matches remaining.

“I think so, it is really difficult to say another name,” said the Italian when asked if Everton had lost to the team that will become champions.

“It was hard, almost impossible. At the moment they are the best team, they have quality, power, belief.

“It is very difficult to compete with them.”

Phil Foden fired City on their way to a 17th successive win in all competitions with a

right-footed shot which hit Everton substitute Seamus Coleman on its way past Jordan Pickford.

Hard-working Everton were back on level terms five minutes later, Lucas Digne’s powerful attempt coming back off the post and hitting Richarlison before flying over the line.

However, a wonderful curling finish from 18 yards by Riyad Mahrez restored City’s lead before Bernardo Silva beat Pickford from a similar distance in the closing stages.

By beating Everton they also become the first team in English top-flight history to win their opening 10 matches in a calendar year. This was Manchester City’s game in hand after the original fixture, due to be played on 28 December 2020, was postponed after Guardiola’s side reported a number of coronavirus

cases.

At the time, City were sixth in the table - six points behind then-leaders Liverpool - but their lead is now into double figures after a 12th successive league win.

Not that Guardiola’s players are getting carried away.

“I have not seen that the team is thinking of the table, we have spoken about that,” said the City boss.

“There are 42 points still to fight for, we are in the middle of February. Now we rest for a few days, there are so many games.”

City have not trailed for a single minute in any of the last 16 Premier League matches and did not panic after Everton became the first team to score against them from open play since 3 January.

This latest impressive

performance was achieved without Ilkay Gundogan, who has enjoyed a rich run of goalscoring form but was nursing a groin injury.

It looked business as usual when Foden broke the deadlock with aid of a deflection off Coleman, an early replacement after Yerry Mina suffered an injury.

Richarlison’s equaliser only served to antagonise

City, who stepped up another gear after the interval to take the game out of Everton’s reach.

Mahrez’s strike was the pick of the goals while Silva’s exquisite finish sealed another highly-satisfactory night for Guardiola’s relentless side, who ended the game with Kevin de Bruyne on the pitch for the first time since 20 January after injury.

We’re learning from our mistakes, says Ole

Ole Gunnar Solskjaer says his Manchester United side are out to correct last season’s Europa League mistakes after they took a huge stride towards the last 16 by thrashing Real Sociedad 4-0 in Turin on Thursday.

United, among the favourites for the competition after dropping down from the Champions League, were beaten by Sevilla in one of three cup semi-final defeats they endured last season.

Bruno Fernandes was once again in inspirational form, scoring twice as Solskjaer’s side dominated a poor Sociedad.

“We got nothing out of getting to the semi-final last year,” Solskjaer said.

“Sometimes you can say it isn’t worth it but the experience has helped this

team. We have to learn on the job.

Fernandes took advantage of hesitant defending to open the scoring in Turin and then stroked in from the edge of the area for a second - which was awarded by VAR after he was initially flagged offside.

Marcus Rashford and Daniel James - who both missed several chances - then scored on the counter to leave next week’s return leg looking a formality.

Two goals in the final seven minutes earned Rangers victory in an astonishing Europa League last-32 epic against Royal Antwerp in Belgium.

Steven Gerrard’s side led, then equalised twice, in the first leg of the tie, before Borna Barisic’s second penalty snatched the win with two minutes

of regulation time remaining.

Joe Aribo and Ryan Kent also netted for the Scottish Premiership leaders, but injuries to James Tavernier and Kemar Roofe diluted the joy a little before next Thursday’s second leg at Ibrox.

Tottenham manager Jose Mourinho said they had “one foot in the next round” after Gareth Bale inspired them to victory over Wolfsberger in the Europa League last 32 first leg.

Bale crossed for Son Heung-min to head the opener and then cut inside and blasted home their second goal. That was the first time since April 2013 that he scored and assisted a Tottenham goal in the same game.

Lucas Moura added a
