# QUEEN THANKS NATION FOR 'SUPPORT AND KINDNESS'

■ As she marks her 95th birthday, HRH shares a rare personal message with her subjects

**THE Queen gave the nation a courageous smile and her heartfelt gratitude on Wednesday as she spent her 95th birthday without her beloved husband for the first time in more than 70 years.**

A photo posted on the Royal Family's Instagram account showed a radiant, smiling monarch wearing a burgundy ensemble at a royal engagement last year.

It was quickly followed by an extraordinary personal message from the Queen, thanking people for their support during the period of mourning for the Duke of Edinburgh, who died aged 99 on April 9.

In a full statement posted on Twitter, she said: "I have, on the occasion of my 95th birthday today, received many messages of good wishes, which I very much appreciate."

## Walks

"While as a family we are in a period of great sadness, it has been a comfort to us all to see and to hear the tributes paid to my husband, from those within the

United Kingdom, the Commonwealth and around the world.

"My family and I would like to thank you for all the support and kindness shown to us in recent days.

"We have been deeply touched, and continue to be reminded that Philip had such an extraordinary impact on countless people throughout his life."

The Instagram accounts of Prince Charles and the Duke and Duchess of Cambridge quickly reposted the charming photo.

The Queen spent her birthday quietly at Windsor Castle. There were thought to be around 20 staff, dubbed HMS Bubble, attending her.

Royals including Princess Anne, the Duchess of Cambridge and the Countess of Wessex are understood to have come up with a

rota for walks to ensure she is not alone.

There were no public celebrations as the Queen continued to observe two weeks of mourning for the Duke.

Boris Johnson sent "warm wishes" to the Queen, saying: "I am proud to serve as her Prime Minister."

## 'no fuss'

Mike Tindall, who is married to the Queen's granddaughter Zara, yesterday spoke of the Duke of Edinburgh's funeral being perfectly judged to honour the memory of a man who believed in "no fuss".

# Covid pill on the way, reveals Boris

■ Home treatments will keep us on the “path to freedom” and stop the virus in its tracks, says PM

**BORIS Johnson** this week revealed that scientists are working on new Covid drugs to be taken at home.

The Prime Minister warned that experts believe the UK will be hit with another coronavirus wave this year.

But the home treatments will keep us on the “path to freedom” and stop the virus in its tracks, he said.

Mr Johnson has launched an antiviral taskforce to find two new drugs that could be used as early as autumn to treat Covid in British homes. He said the vaccination programme is making a “big difference” by helping to reduce suffering and save lives.

But he warned it is too early to assess the “exact strength of our defences” and warned we “cannot delude ourselves” that the virus has gone away.

The Prime Minister insisted the roadmap out of lockdown is still on track but said most scientists believe there will be another wave this year.

He said: “So we must, as far as possible, learn to live with this disease, as we live with other diseases.”

Mr Johnson said booster

shots will be carried out in the autumn and mass testing will continue. But antiviral drugs could form the third line of defence.

The taskforce will search for the most promising new medicines and support their development through clinical trials.

Mr Johnson wants two drugs to be available as early as the autumn.

He said: “This means, for example, that if you test positive there might be a tablet you could take at home to stop the virus in its tracks and significantly reduce the chance of infection turning into more severe disease.”

## Confidence

“Or if you’re living with someone who has tested positive, there might be a pill you could take for a few days to stop you getting the disease yourself.”

“And by focusing on these antivirals we hope to lengthen the UK’s lead in life sciences and to give ever greater confidence to the people of this country that we can continue on our path towards freedom.”

Mr Johnson said the success of the UK’s

vaccination programme has shown what the country can achieve “when we bring together our brightest minds”.

He said antivirals could provide “another vital defence” against any future increase in infections and save more lives.

The Government will also look for ways to produce the drugs within the UK to prevent a repeat of the ugly rows that broke out when Brussels threatened to block Britain’s supplies.

It is hoped that antivirals could help to reduce infections and limit the impact of any new variants.

They may also help to protect people who cannot take vaccines or those who are not fully protected after having the jab.

Health Secretary Matt Hancock said the Government has drawn on a diverse range of talent during the crisis.

He said: “We’re building on everything we’ve learned and finding even more ways to keep us safe – and we’ve put our brightest and best on the case.”

Scientists from the University of Oxford

last year discovered that dexamethasone, an inexpensive steroid, could reduce Covid deaths for patients on ventilators or oxygen.

Around 22,000 lives have been saved by the drug in the UK, and one million worldwide.

Sir Patrick Vallance, the Government’s Chief Scientific Adviser, said: “The speed at which vaccines and therapeutics such as dexamethasone have been identified and deployed against Covid

19 has been critical to the pandemic response.

“Antivirals in tablet form are another key tool for the response. They could also be another layer of defence in the face of new variants of concern. The taskforce will help ensure promising antivirals are available for deployment as quickly as possible.”

Meanwhile, vaccine take-up among ethnic minorities has improved after a campaign to reassure groups who

were hesitant about having the jab.

Dr Nikki Kanani, medical director of primary care for NHS England, said: “Since we set out our plan in February, uptake from all ethnic minority backgrounds has tripled, across all ethnicities.”

She said the progress was a “direct result” of action by NHS teams, work by community leaders and high-profile backing from stars such as comedian Lenny Henry.

## Upskirt offender walks free

A **PERVERT** who took more than 6,000 upskirt photos using a camera in his shoe has walked free from court – triggering fury from women’s rights campaigners.

Richard Whyley was finally caught when a 16-year-old girl heard his GoPro device click as she shopped with her 10-year-old female cousin. He had secretly taken a picture up her clothing.

Dad-of-two Whyley was found to have 6,436 photos of the private parts and underwear of 250 women. The university worker also filmed

women undressing at home and a couple having sex.

He admitted voyeurism but was given a

community sentence – which campaigners claimed would encourage other predators.

# LOCKDOWN LIBERTY: pubs jammed as urge to party proves too strong for some...

## Thousands cram the streets as weary Brits exit long Covid lockdown with a drink

**LOCKDOWN LIBERTY** was celebrated by millions across the UK at the weekend as bars, pubs and restaurants reopened amid easing Covid restrictions.

But inevitably the partying led to a messy hangover in many cities and towns, as cleanup crews were left swamped with the morning after's debris from the night before.

Town hall bosses slapped a 10pm curfew on Primrose Hill, north London, on Saturday, after complaints about anti-social behaviour, noise and drug use.

But it failed to stop large crowds and the beauty spot was found littered with debris.

Emergency services warned people to know their limits and most behaved impeccably.

But for others, the taste of freedom was too much.

A despairing mother tweeted: "With lockdown easing I spent six hours in A&E with an unconscious daughter who'd drunk too much and collapsed on Primrose Hill at a party."

"The police told me they'd dealt with another 10-12 of the same age and condition."

### blowout

About 20,000 pubs and 20,000 restaurants served 10 million pints to 12 million people in the busiest drinking bout for six months. Orders were double that of a usual Saturday as punters had a £100million blowout.

Outdoor seating in Leeds, Liverpool and Newcastle were fully booked for weeks as

people toasted the first weekend since Covid restrictions eased.

Tens of thousands descended on Soho, in London's West End, forcing police to disperse crowds who partied after last orders without masks or observing social distancing.

Professor Adam Finn, on the Joint Committee for Vaccination and Immunisation, said: "The risks of transmission outside are relatively low, but not if you start coming into very close contact."

England's beer gardens reopened

last Monday in Prime Minister Boris Johnson's freedom roadmap.

People must remain outdoors and are limited to groups of no more than six or two households. Pubs reopen in Wales and Scotland on Monday and outdoor service in Northern Ireland begins

on April 30.

Police in Worcester are investigating claims by three women taken to hospital that their drinks were spiked.

A further 10 people have died within 28 days of testing positive for Covid as of Sunday. The UK toll is now 127,270.

## Rollers singer Les McKeown dead at 65

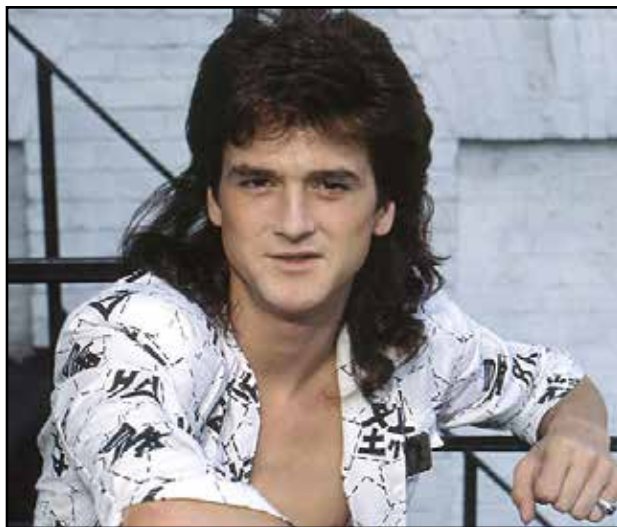
**Bay City Rollers singer Les McKeown has died suddenly at the age of 65.**

The Scottish pop vocalist was the frontman of the group during their 1970s heyday.

A statement from his family on Twitter said: "It is with profound sadness that we announce the death of our beloved husband and father Leslie Richard McKeown. Leslie died suddenly at home on Tuesday 20 April 2021.

"We are currently making arrangements for his funeral and ask for privacy after the shock of our profound loss. Thank you. Keiko and Jubei McKeown.

McKeown was born



**McKeown:** joined the seminal 1970s band in 1973

in Edinburgh to Irish parents and joined the Bay City Rollers in late 1973, just as they began their ascent to fame, leaving in 1978.

The news comes after bassist Alan Longmuir,

another member of the classic line-up, died at 70 in the summer of 2018.

Formed at the end of the 1960s, the Bay City Rollers enjoyed huge success at home and abroad with their

distinctive tartan outfits and upbeat pop tunes like Bye Bye Baby and Shang-a-Lang.

They had a massive teen following and sold more than 100 million records, and in the press were heralded as

"biggest group since the Beatles".

They broke through into the mainstream in 1974 after a series of singles which failed to dent the charts.

Alongside McKeown and Longmuir, the classic

line-up also included guitarists Eric Faulkner and Stuart Wood, with Longmuir's younger brother Derek on drums.

McKeown, Longmuir and Wood reunited for a comeback tour in 2015 with tickets selling out.

# House prices soaring at highest rate in 7 years

■ Average UK home now valued at £250,000 • Northwest sees 12% annual price rise

THE average UK home has surged in value by £20,000 in a year with signs that the property market is hotting up.

House prices rose by 8.6 per cent in the 12 months to February – the highest annual rate of growth since October 2014, according to the Office for National Statistics.

Homes are now worth £250,000 on average, a £20,000 increase on February 2020, it added. The North-west was the English region with the highest annual growth at nearly 12 per cent while London was the lowest at 4.6 per cent.

The figures were released as HM Revenue and Customs said that house sales in March 2021 were around

double the number a year previously.

HMRC said an estimated 190,980 sales took place, compared with 94,380 transactions in March 2020 and around a third higher than in February this year.

## 'upward pressure'

Nitesh Patel, strategic economist at Yorkshire Building Society, said: "Available properties appear to be getting snapped up quickly, adding upward pressure on prices. Buying behaviour continues to be dominated by the pursuit for space, with detached homes rising by 9.1 per cent in the year to February 2021, in contrast with flats and maisonettes, which saw

a 6.7 per cent increase.

"With the stamp duty relief in place in its current form until the end of June, and the jobs market fairly resilient... we expect price momentum to continue for a few more months."

Mark Harris, chief executive of mortgage broker SPF Private Clients, said: "Transactions are always a surer sign of the health of the housing market than house prices and a surge in activity in March shows that people continue to hunt for more space, while taking advantage of the stamp duty holiday and cheap mortgages."

Sam Mitchell, chief executive of online estate agent Strike, added: "Combined

with growing optimism due to the vaccination rollout and the desire for a fresh start in fresh surroundings, it's likely to be a hot summer

for Britain's property market."

However, the Office for National Statistics cautioned that the pandemic had an impact

on sales with more volatility than usual

in the latest house sales estimates and the numbers could be revised later.

## Security alert after intruder says she is Andrew's fiancée

■ Spanish woman calling herself 'Irene Windsor' detained and later sectioned under the Mental Health Act.

AN INTRUDER claiming to be Prince Andrew's fiancée was allowed into his home by bungling security staff, it has emerged.

The "smartly dressed" woman wandered around the grounds of the Royal Lodge at Windsor for 20 minutes.

The Spanish woman tricked her way through the gate by claiming she had a luncheon date with the Duke of York.

Staff were so taken in they even paid her taxi driver, it was claimed yesterday.

### 'female trespasser'

After walking around the gardens, the visitor strolled into the main building and asked a member of staff where she could find the Prince.

Police were called and she told them

her name was "Irene Windsor".

She claimed she was engaged to Andrew and lived at the Royal Lodge with him.

Maps of the Prince's home and other Royal residences were found in the woman's handbag, it was claimed.

The intruder was also allegedly carrying a cat-shaped self-defence key ring with two sharp prongs.

But there is no suggestion she ever threatened anyone or was aggressive during the incident on Monday. Officials have now launched a Royal security review.

Thames Valley Police said a 43-year-old woman was initially arrested for trespassing and later sectioned under the Mental Health Act.

A spokesman said:

"Thames Valley Police were called to the Royal Lodge at Windsor Great Park on Monday morning to reports of a female trespasser.

### Unaware

"The woman, aged 43, was intercepted and arrested. She was subsequently de-arrested and has been sectioned under Section 136 of the Mental Health Act.

"The investigation into the incident

continues, but there was no risk to any individual on the site.

"Due to the female being sectioned, we will not be commenting further at this time." It is understood the Duke was at home at the time but was unaware of the incident.

The woman is thought to have arrived in Britain on Saturday, the day of Prince Philip's funeral.

Sources described the mystery female as

"quite a glamorous and elegant figure".

Police and senior Royal officials are reviewing security and procedures for allowing access to visitors in the light of the incident.

As a son of the Queen, the Duke has a Metropolitan Police personal protection officer.

But his security was scaled back after he withdrew from Royal duties following a barrage of negative stories over his links to the late billionaire sex offender Jeffrey Epstein.

Andrew has lived at the Royal Lodge since 2004. Ex-wife Sarah, Duchess of York, also lives there.

Lisa Longstaff, of Women Against Rape, said: "This man violated women and girls by taking 6,400 intrusive and intimate images, and it was premeditated, yet he is spared jail – it's a green light to him and other men."

"This is another shocking case where the criminal justice system assisted men to sexually abuse [women] with impunity."

Judge Martin Jackson told Whyley, 32: "It is concerning that your offending is of such an extent. There was a significant degree of planning, in particular the use of the GoPro camera and adaptation of footwear."

Whyley was given a three-year community

order, told to pay £750 compensation to the 16-year-old, made the subject of a five-year sexual harm prevention order and ordered to sign the Sex Offenders Register for five years.

The engineer is also subject to an electronic curfew tag from 9pm to 6am for four months and must do 40 days of rehabilitation plus join an offenders programme.

His 16-year-old victim had earlier read out an impact statement at Worcester Crown Court. She said: "I had only just turned 16 and had gone shopping that day."

Since then, I have become so conscious of what I wear when I'm out...and am constantly looking over my shoulder to keep myself a safe distance from other people.

"I'm going to have to live with this for the rest of my life."

The 80-year-old singer was on holiday in Acapulco with pals during his heyday when he went off by himself.

He said: "I wandered off like a fool, started swimming out, then someone called me and I thought I better swim back."

"I swam down and hadn't moved an inch. I thought: 'This is it now'."

"I always used to put my jewellery in my man bag and for some unknown reason I didn't."

"I put my hand on my

chest and still had this big cross and chain on."

The Voice coach, whose album *Surrounded By Time* is out this week, continued: "I put my hand on it and said: 'God I'm desperate here. What do I do?' "I thought I'd take a load of water in and say good night."

"A voice came to me and said: 'If you think you can swim, now is the time to prove it'. 'Head down I go like the clappers."

"I'm caught and spun, surely I'm going to be thrown on the beach and break my neck?"

"The wave tossed me on to the beach."

After washing up on the sand Sir Tom was

told the area he swam out to was populated with sharks.

Locals then said that as the undertow caught him, swimming directly to the beach as he did would usually be impossible.

Asked by Alan Carr

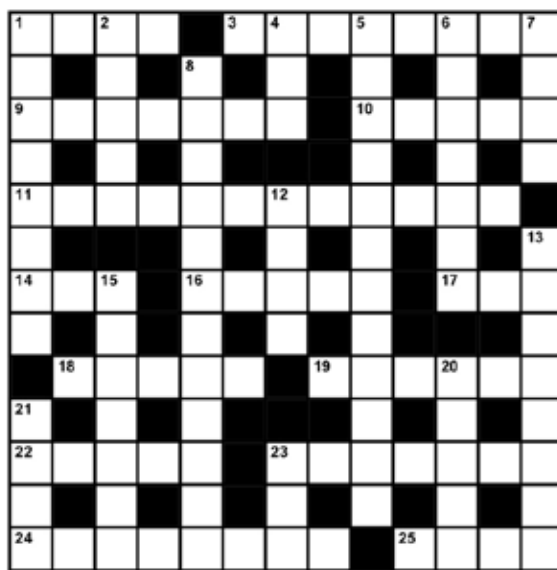
on his *Life's A Beach* podcast, out today, if he thinks God spoke to him Sir Tom said: "Definitely."

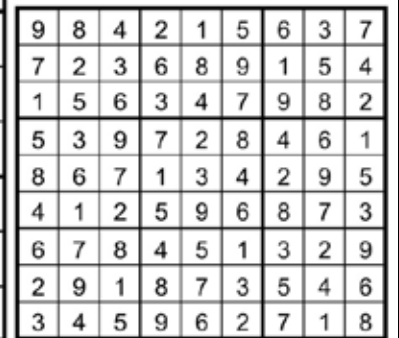

# Henry leads a sorry tale of 'Big Six' contrition

## Owners' plea to fans for forgiveness after 'mistake'

LIVERPOOL owner John W Henry has led a chorus of apologies as the shame-faced Big Six attempted to piece together shattered relations with fans.

Henry (pictured, right) on Wednesday offered a personal video message in which he held his hands up to a "mistake" over the European Super League, taking sole responsibility for what was an error of judgement.

Other members of the breakaway were less effusive in their contrition.

While Arsenal had offered an open letter to supporters in which they apologised for causing "distress", Spurs and Manchester United initially merely noted the reaction from fans—before Joel Glazer finally issued an apology yesterday.

Manchester City and Chelsea offered nothing more than a businesslike statement informing they would not now be proceeding.

With the exception of prime drivers United, who insisted they had "listened carefully to their fans", the relative strengths of the mea culpa were delivered by the chief architects behind the project.

And Fenway Sports Group's Henry just about held his hands up highest.

"I want to apologise to all the fans and supporters of Liverpool Football Club for all the disruption I've caused in the past 48 hours," he said.

"It goes without saying, but should be said, that the project put forward was never going to stand without the support of the fans.

"Over these 48 hours you were very clear that it would not stand. We heard you. I heard you.

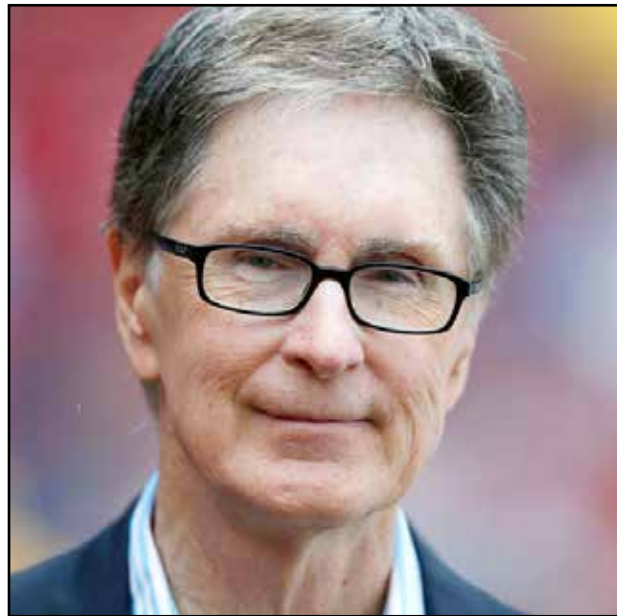
"I hope that you'll understand that even when we make mistakes

we are trying to work in your club's best interests. In this endeavour I've let you down and I'm sorry and I alone am responsible for the unnecessary negativity brought forward over the past couple of days."

Arsenal's board wrote to fans admitting the backlash to their doomed plan had given them time for "further reflection and deep thought".

"The last few days have shown us yet again the depth of feeling our supporters around the world have for this great club and the game we love," it read.

"It was never our intention to cause such distress – however, when



the invitation to join the Super League came, while knowing there were no guarantees, we did not want to be left behind

to ensure we protected Arsenal and its future."

# We want you out!

## ■ As Super League crashes and burns, football fans demand owners behind the scheme sell their stakes

**PRESSURE** was growing this week on the billionaire owners of football's shamed six to sell up as fans accused them of arrogance, deception and greed in trying to create a European Super League.

Liverpool owner John Henry and Manchester United coowner Joel Glazer have issued grovelling apologies to supporters, while Tottenham chairman Daniel Levy said sorry for the anxiety caused.

Arsenal, owned by American billionaire Stan Kroenke, have also expressed their regrets over the breakaway bid.

The six Premier League clubs involved all withdrew from the plan within hours of each other late on Tuesday following a furious backlash.

Fans of Manchester United, Liverpool, Tottenham and Arsenal all called on their owners to sell, while Chelsea supporters said they had

no confidence in the club's leadership.

Chelsea, faced with an angry protest from their fans outside their Stamford Bridge stadium, was quick to act, preparing documents to formally withdraw.

Manchester City also bailed early after supporters gathered to vent fury at their ground.

Juventus chairman Andrea Agnelli conceded the European Super League (ESL) project cannot proceed as AC Milan, Inter Milan and Atletico Madrid joined the six Premier League clubs in withdrawing.

He was one of the chief architects of the rebellion by 12 clubs from England, Spain and Italy.

Liverpool supporters' group Spirit of Shankly refused to accept John Henry's apology for signing up to the ESL.

The group said: "It has been a tumultuous, sickening few days for us all. The arrogance

and deception shown behind this money-grab is frightening. But not surprising.

"We have noted John Henry's apology, but this PR exercise is too little too late. Liverpool Football Club is not an American franchise, it is a community steeped in history and tradition.

"The 'future of football' came crashing down in 48 hours because of the solidarity and outcry of 'legacy' fans across the country.

"This debacle must be a catalyst for real change, not an exercise in damage limitation."

Former Liverpool player Jamie Carragher warned the owners, Fenway Sports Group, that they have "no future" at the club after the ESL debacle.

He said: "I don't see how they can continue. This will never be forgotten."

Joel Glazer, co-chairman of Manchester United, vowed to stay on, despite

the pressure. He said: "I understand it will take time for the scars to heal, I am committed to rebuilding trust with our fans and learning from the message you delivered with such conviction."

But former Manchester United star Gary Neville

said: "Jamie Carragher has just talked about FSG having no place in Liverpool, the Glazers have no place in Manchester anymore. The people have spoken. We were on the brink of anarchy if this had continued."

"These six sets of

owners in this country and the other ones in Europe have misread this situation badly. We are in the midst of a pandemic. We've been locked in for months. They've tried to run away with the crown jewels while we are all down."
