'Careful what you say': Wills and **Kate launch YouTube channel**

■ Debut video includes clips of couple on royal engagements, with William joking: 'these guys are filming everything'

The Duke and Duchess of Cambridge have become YouTubers, launching their own channel on the global video-sharing site with a fast-edited promotional video showing them at work and play.

YouTube debut post begins with the couple sitting on a sofa. Prince William jokes with Kate while pointing to the camera and people behind it, saying: "Be careful what you say now because these guys are filming everything."

"I know," Kate replies, as the 25-second video – accompanied by a staccato electronic soundtrack - rapidly showsclipsofthetwoof them on engagements, including Kate trying her hand at archery, William flying helicopter, and the couple on their official visit to Bhutan.

It also shows a laughing Kate shearing sheep during a visit to

a Lake District farm, William sitting with Sir David Attenborough to promote the duke's Earthshot environment prize, and the couple admiring billboards showcasing Kate's Hold Still photographic project. In one clip, an outtake from this year's St Patrick's Day video, Kate tells William: "You don't need to roll your Rs."

The future king and queen will continue to feature in exclusive videos posted on the site in the coming months.

Rapid retreat for French trawlermen as Navy flex their muscles in Jersey dispute

■ PM despatches two armed boats as 60-strong flotilla threatens to blockade St Helier

TEMPERS flared this week off the coast of Jersey as a simmering dispute between the British and French over fishing rights boiled over.

Following a confrontation between a flotilla of French fishermen and locals the Prime Minister sent two Royal Navy ships on Wednesday to guard Jersey's main, forcing a French retreat and with it, it seems a calming of emotions.

Barely 24 hours later Downing Street announced that one of the naval boats would return to the UK immediately and the second would leave Jersey on Friday after talks with the island's government. However, a spokesman added that the navy remained "on standby" to provide "any further assistance Jersey requests".

The dispute with French trawlermen stems from changed rules following the UK's departure from the EU's single market and customs union on 31 January 2020, meaning it left the common fisheries policy that has peacefully

divvied up the spoils of Europe's waters since the

It also ended the Bay of Granville agreement, signed in 2000 by Britain and the Channel Islands government, which had established a pattern of rights for French boats to fish up to three miles from the islands' coasts.

Within the Brexit trade cooperation agreement struck last Christmas Eve there is a new EU-UK fisheries agreement that offers French fishers the continuation of the status quo in a zone between six and 12 miles from the UK's shores up to 2026, if they can prove that they had previously been operating in those waters.

Jersey published on Friday a list of licenses issued for 41 French boats of more than 12 metres that could prove they had met the requirement they had fished in the island's waters for at least 10 days over a period of 12 months within the past three years. The licenses also show what species of fish they were fishing and the

numbers of days spent at sea.

An extended amnesty on providing such proof has been offered to smaller vessels. But there are 17 larger boats that have been unable to provide the evidence required and those who were granted access complain that additional conditions were set on securing the licences.

'null and void'

Those extra conditions were that dredgers could have only 12 lines coming off them and that the vessels respected the closure of the bream nesting areas for a small period of time to allow scientific research to be undertaken. The French government said those conditions were "null and void" claiming they were "were not arranged or discussed" with them. The European Commission has also said that the conditions are in breach of the trade and cooperation agreement.

Matters came to a head when the UK got wind of plans for 60 French boats, most of them dredgers



and trawlers, to sail to St Helier, Jersey's main port, at dawn on Wednesday. To prevent a blockade, Johnson dispatched two armed Royal Navy boats. France sent two military patrol vessels to "accompany" and "guarantee the safety" of its fishing boats.

When the French boats arrived, some crews set off smoke flares as HMS Severn and HMS Tamar kept watch nearby.

French trawlermen decided to end their protest as a result of discussions with the Jersey government. However, both sides warned that the fundamental dispute had not been resolved.

The French vessels amassed around St Helier but did not attempt a blockade and retreated towards France by the early afternoon. The waters near the port were largely clear of vessels by 1.50pm.

Josh Dearing, 28, a Jersey fisherman, said the scene had been "like an invasion", adding: "The French being the French, they don't mess around. They can blockade their own harbours - they wouldn't think twice about coming and doing it to us."

Sean Murphy, landlord of the Lamplighter pub, yards from the harbour at St Helier, said all his customers were talking about the protest, adding: "Most people are smiling about it, to be honest, and can't believe it has gone this far. We've got the Royal Navy here, the French navy on its way.

Everybody is waiting for the nuclear submarines to come next.

"I'm being tongue-incheek, but we're 100 per cent behind our fishermen. The way the French are behaving is despicable. They've been well looked after over the years and because they can't get their way they have thrown their dummies out of the pram again."

The Dean of Jersey, the Very Rev Michael Keirle, said: "There is inevitably some concern that Brexit has found a front line in Jersey. I'm not sure people need reassuring, but there is obviously concern that this has found its way to our shores and the impact of Brexit is playing itself out within a community that didn't even get to vote for it."



After his death, the Official IRA said he had killed 15 British soldiers.
Judge Mr Justice O'Hara ruled on Friday

that statements Soldiers A and C gave at the time were inadmissible as evidence.

The prosecution on Wednesday decided not to appeal his decision, leading to the acquittal of the elderly pair, who are in their 70s and cannot be named for their safety.

PC Tasered ex-Villa star and 'kicked his head like football', murder trial told

A POLICE officer Tasered a former Premier League star six times longer than normal before kicking his head like a football, a court heard this week.

PC Benjamin Monk, 42, is charged with the murder and manslaughter of ex-Aston Villa striker Dalian Atkinson in 2016, which he denies.

Birmingham Crown Court heard he pressed the Taser's trigger for 33 seconds instead of the standard five, and booted him in the forehead, leaving an imprint of his shoelaces.

On the first day of his trial PC Monk appeared alongside his colleague PC Mary Ellen Bettley-Smith, 31.

She is charged with assaulting Mr Atkinson, who had serious health issues, occasioning actual bodily harm.

She has also pleaded not guilty.

The court heard the West Mercia Police officers were "in a relationship" at the time of the alleged killing.

Mr Atkinson, 48, had played for a number of clubs, including Sheffield Wednesday and Ipswich Town, but retired from the game in 2001.

'bizarre'

Alexandra Healy QC, prosecuting, told how the star had gone to his father's home in Telford, Shropshire, in August 2016. His behaviour was

"disturbed and erratic" and he was shouting in the street. One concerned neighbour alerted police and the two officers arrived. PC Monk had a Taser with three cartridges and PC Bettley- Smith had an extendable baton.

Ms Healy said the former footballer came to the door unarmed "but his behaviour was bizarre and erratic. He said he was the Messiah".

Shortly afterwards PC Monk tried to Taser him. The first two attempts were ineffective, she added. But there was a third confrontation while all three were standing in the road.

to a criminal trial.

Admiral Lord West added: "It seems a travesty in Northern Ireland that terrorists who have committed terrible atrocities are not pursued, yet ageing servicemen who were doing their best to do their duty are reinvestigated again and again.

"These events were so long ago, it ceases to make sense. "The Government made a promise in their manifesto that they would do something about this.

"While they have done something about overseas operations, they have not done anything about Northern Ireland.

Slammed

"These men have been put under terrible pressure and that is not the way to continue. We have got to do something about it."

Legal experts have also slammed the proceedings.

Hilary Meredith, chairman of Hilary Meredith Solicitors, said: "This trial should never have taken place.

"The Government should hang its head in shame. Where is the legislation to protect our veterans who served in Northern Ireland? This witchhunt needs to stop right now."

The senior partner at Devonshires who represented Soldiers A and C, Philip Barden, demanded an independent inquiry to investigate whether the decision to prosecute was "political".

Mr Barden said:
"The stress of these
proceedings on the
soldiers and their
families cannot be
underestimated.

"For the last five years, the soldiers have fought hard to maintain their anonymity on the basis that they would face real and imminent risk to their lives and physical safety from terrorists, were their names to be published.

"I call for an inquiry by a senior judge to investigate the decisionmaking process and to ensure that the decision to prosecute these veterans was not political."

'appalling'

Public The Prosecution Service of Northern Ireland hinted the case's collapse could affect the trials of other veterans over so-called "legacy" killings from the Troubles. M McCann was shot after resisting arrest by a plain-clothed policeman. he was unarmed at the time. his daughter Aine said: "The judge was right when he used the word appalling to describe the failure of the state at all levels in relation to the murder of Joe McCann.

"The criminal justice failed, not only in this case but in the case of many other families." moved towards the officers, PC Monk fired the third Taser cartridge at him.

"This deployment was completely effective, and it caused Mr Atkinson n e u r o m u s c u l a r incapacitation. His muscles were overcome, and he fell forward on to the road."

'angry'

She said the default setting was five seconds. "But it is possible to override that by continuing to depress the trigger and PC Monk continued to depress the trigger for more than six times the length of

a standard phase. The Taser was deployed for 33 seconds."

PC Monk also kicked out. "At least two kicks were delivered by him to Dalian Atkinson's forehead with enough force to leave the imprints of the pattern of the laces from the top of his boot on two separate areas. PC Bettley-Smith struck Mr Atkinson while he was lying on the ground a number of times with her baton."

They were not acting in self-defence but were "angry" to have been "put in fear by this man", she said. The court heard a number of residents who saw the attack said it was "quite ferocious".

One resident said they saw the male officer's leg go straight back and snap forwards like "kicking a football".

Another said they were "kicking the ****" out of him, estimating they hit him 15 times, despite no longer posing any threat. Mr Atkinson died in hospital the same morning.

He had been suffering high blood pressure, heart disease and endstage renal failure. The officers claim he was trying to get up and they feared for their safety.

The case continues.

The Eighties crooner's heartbreaker classic Careless Whisper has topped a radio chart for the third year running.

The 1984 hit was again crowned best loved song in Smooth Radio's annual All Time Top 500.

Its resurgent fortunes were put down to featuring in 210,000 clips on social media platform TikTok.

It will go on sale on June 8 and features illustrations by awardwinning artist Christian Robinson.


An audiobook version, narrated by Meghan, will also be available.

It was revealed in Meghan and Harry's interview in March with Oprah Winfrey, that they have a chicken coop called the "Chick Inn", which is one of Archie's favourite places.

It is not known if any proceeds from the book will go to charity. Meghan follows in the footsteps of Sarah, the Duchess of York and Princess Michael of Kent, who have also written children's books.

■ Superstar links up with Bolton bakers for new ad campaign

FANS who think George Clooney is the best thing since sliced bread are in for a treat because the Hollywood A-lister is the latest in a line of celebrities to front Bolton bakers Warburtons' latest ad campaign.

The star, who turned 60 on Thursday, will be seen alongside bakery boss Jonathan Warburton in the minute-long clip which will air on ITV on Saturday.

The advert sees company chairman Warburton eagerly anticipating a slice of thick sliced white toast for high tea.

After patiently waiting for his toast, he lovingly

slathers it in butter and is about to take a bite when his office door bursts open and his secretary announces, "George Clooney is on the line".

The camera pans to Clooney on Warburton's laptop calling, "Mr Warburton? Johnnie?" as he waits to pitch an idea. But the Ocean's Eleven star is left dumbfounded when he is snubbed for the piece of toast as Warburton slowly closes the laptop, takes a bite of his toast and declares: "He can wait."

Clooney can be heard saying: "He hung up?" and then the action cuts to a posh vaulted- ceiling dining room where the actor is still staring in

disbelief into the laptop and saying, "No, he's not there, he's making toast."

Clooney, of course, is no stranger to grocery adverts having done a long campaign for Nespresso, bringing more than 50 million views to the coffee producer on YouTube.

He is the latest in a string of celebrity signings for Warburtons which have included Sylvester Stallone, Robert De Niro, The Muppets as well as Bolton-born comedian Peter Kay.

In 2019, two-time Oscar winner De Niro played an amalgam of his gangster film characters as he and his accomplices attempted to thwart Warburtons bagel sales in favour of their New York products.

He followed in the footsteps of Stallone, whose 2015 campaign, The Deliverers, featured a hilarious parody of some of his most famous film scenes from The Expendables and Rocky.

Talking about his appearance in the advert, Clooney said: "It's not every day your call is turned down for a slice of toast, but needless to say I had a lot of fun filming this spot.

"It was great working with the Warburtons team and I'm thankful for the support they are providing to the Clooney Foundation For Justice."

The star doesn't need the ads to earn a crust. The fee paid to George for his participation in the campaign was donated to the foundation that fights civil rights abuse.

It was founded by the actor and his wife, the international human rights lawyer Amal, 43. The couple and their three-year-old twins Alexander and Ella have spent the pandemic together in their home in Sonning, Berkshire.

Jonathan Warburton said: "We are thrilled to have George Clooney star in our latest campaign.

"Video calls have become part of normal life for so many of us during the last year, but George Clooney popping up on screen was quite a surprise!

"At Warburtons, we pride ourselves on the care that goes into making sure that every single loaf is as fresh and high quality as possible."



My second show was a virtual show hosted by seasoned comic Jessica Winther and produced by Mark Klaber. Virtual comedy, is tough.

Jessica remembered me from that virtual show and called me for her next big sold out show at The Comedy Chateau, along with Willie the awesome Macc. Being the newbie I opened the show. 18 minutes! I ran way over - apparently a big no-no in comedy.

The audience laughed, I had been funny. Again. I now had the bug!

During my set, I talked cancel culture, joked about British parenting, tried to understand pronouns and made fun of being looking single and like a "Nazi Lesbian". Apparently, I offended a lesbian, but she didn't seem to mind the Nazi part?

I walked off stage proudly and then the sneaked in to bathroom and shed a tear in relief and thanked God, I had after all seen rappers do this at the Grammys - a lot. I thanked Jerry for my son, Andre for the support and I thanked Lisa for her loyalty. Maybe they were laughing in heaven together?

Then I went back out and watched the master Bill Burr and all the other comedians share their humor and selfless energy to make others laugh.

So I thank them all-I am also thankful I watched 'The Marvelous Mrs Maisel' instead of posting food photos.



Fluent City leave Paris in ruins

Champions League Semi-Final, 2nd leg Man City....2 PSG......0 (agg: 4-1)

Manchester City reached their first Champions League final as they overcame Paris St-Germain at Etihad Stadium to secure a commanding victory over two legs.

In a game played in unseasonal snow on Tuesday night, the brilliant Riyad Mahrez capped a sweeping move started by goalkeeper Ederson's 60-yard pass to extend their 2-1 advantage from the first leg in Paris.

PSG suffered a serious blow before kick-off when world-class forward Kylian Mbappe was restricted to the bench because of injury. They did not lack endeavour or intent and had early hope when a penalty was awarded for a handball by Oleksandr Zinchenko before it was

correctly overturned, but with Neymar subdued and City throwing bodies on the line in defence, Mauricio Pochettino's side could not find a way through.

Mahrez punished them again just after the hour when he turned in Phil Foden's cross at the far post to effectively end the contest.

PSG, as they did when Idrissa Gueye was sent off late in the first leg, lost their discipline and Angel di Maria was shown a red card for a senseless stamp on Fernandinho following a touchline tangle.

City were in full control, avoiding further mishap to set up the Champions League final they and manager Pep Guardiola have craved, against Chelsea in Istanbul on 29 May.

Manchester City manager Pep Guardiola said: "I'm incredibly proud and my first thoughts are with the players who didn't play today. They all deserved

to play, everyone has made a contribution and now it is time to enjoy it. We have to win the league and we have two or three weeks to prepare for the final.

"They put a lot of players in the middle and we struggled a lot in the first half to high press and we changed at half-time. We recovered the ball better in the second half and we were much better in the way we played and 4-1 on aggregate againxst

a team that beat Barcelona and Bayern Munich means a lot to us.

"People believe it's easy to arrive in the final of

the Champions League. Getting to the final now makes sense of what we have done in the past four or five years."

....And Chelsea make it a full English

Champions League Semi-Final, 2nd leg Chelsea....2 Real Madrid.....0 (agg: 3-1)

Chelsea will face Manchester City in the Champions League final in Istanbul after convincingly overcoming a fading Real Madrid at Stamford Bridge on Wednesday night.

On a night of high tension, even behind closed doors, Chelsea fully deserved a victory that sets up an all-English final against Pep Guardiola's Premier League leaders on 29 May.

Thomas Tuchel's hosts were grateful to goalkeeper Edouard

Mendy for two fine first-half saves from Karim Benzema but they were able to build on the 1-1 draw they achieved in Madrid when Timo Werner headed in from almost on the goal-line in the 28th minute after Kai Havertz had lofted a finish on to the bar.

It set the platform for a second half of total Chelsea domination that was nevertheless laced with anxiety as the hosts missed chance after chance to put the game to bed.

Real's former Chelsea goalkeeper Thibaut Courtois saved from N'golo Kante and Havertz, who also headed against the bar, while Mason Mount shot wildly over the top when clean through.

It was Mount, though, who finally sealed Chelsea's place in their first Champions League final since they won the competition in 2012.

The outstanding Kante, who was also instrumental in the opening goal, fed substitute Christian Pulisic and his cross was turned in by Mount with five minutes left.

The result adds another chapter to the remarkable transformation under Tuchel since he succeeded the sacked Frank Lampard in January - and gives him the chance to make amends for the 2020 Champions League final, when his Paris St-Germain side lost to Bayern Munich.
