Borīs warns young: get jabbed or get banned!

PM pulls no punches on 'Freedom Day' as Covid cases continue to soar

BORIS Johnson celebrated 'Freedom Day' in the UK on Sunday – but then warned that it could come at a price.

And he told young people to get a jab or be banned from all public

The Prime Minister said that ending social distancing is the right thing to do because keeping restrictions in place will only "delay the inevitable".

And as the nation enjoyed its first day of freedom, chief scientific adviser Sir Patrick Vallance also warned that nightclubs could "potential super spreading events".

Some 35 per cent of 18 to 30-year-olds - three million people - are unvaccinated compared to far higher coverage in older age groups. The PM warned the pandemic is far from over and the only way to stop Covid measures being reimposed is by "continuing to be cautious".

Ironically Mr Johnson, spent Freedom Day isolating at Chequers after being 'pinged' by nationwide Covid

alert system that he had come into contact with a potentially infected The PM individual. also announced Covid passports showing vaccine status will be introduced in September for nightclubs and crowded indoor events.

He added that he wants the country to "enjoy the fruits of our massive efforts and our enormous vaccination campaign".

He added: "But to do that we must remain cautious and we must continue to get vaccinated.

"And that is why we are asking you to come forward and get your jabs

Soaring Covid case rates have fuelled concerns about the decision to push ahead with the so-called Freedom Day.

Johnson But Mr said the country is at a tipping point now that most adults have been vaccinated

Deaths hospitalisations are rising, but "well within the margins" expected at this stage by scientists.

The school holidays provide a "firebreak" and failure to open up now risks "even tougher" conditions in the colder months, it was said.

The PM added: "There comes a point after so many have been vaccinated when further restrictions no longer prevent hospitalisations and deaths, but simply delay the inevitable.

"And so we have to ask ourselves the question, if not now, when?"

Mr Johnson said he hopes the changes are irreversible.

But he said he "can't guarantee that" 'we've got to be humble in the face of nature".

Latest figures show 82.4 million Covid jabs have been given in the UK, with 36 million of those second doses.

Professor Jonathan Van-Tam, England's deputy chief medical officer, said lifting the rules will have a knock-

"Pingdemic' could ravage British economy, business leaders warn,

■ NHS Track and Trace app could prompt more than 5m to self-isolate by next month

FORGET PANDEMIC, the latest buzzword in the UK is 'pingdemic' - the word coined to describe the endless series of notifications being sent by the NHS Track and Trace app to millions of Britons across the country about their possible exposure to the Covid-19 virus.

But the success of the app has prompted business leaders to warn that the country could grind to a halt - with up to 5.2 million-a-week isolating by next month.

The Adam Smith think-tank Institute predicts that unless No 10 relaxes rules, those ordered to stay at home could soar by mid-August.

The crisis could result in supermarkets cutting opening hours or shutting due to staff shortages, with meat plants, shops, factories and the arts also hit.

Data from July 7 show 520,194 alerts were sent to Test and Trace app users in England and Wales, a 46 per cent rise over seven days.

But the think-tank estimates 1.73 million are

currently isolating after being "pinged" by the app or called by officials. The union Community, which represents transport drivers, said rising self-isolating was impacting drivers' ability to work.

A looming transport crisis was flagged up when the Metropolitan Underground line in London shut on Saturday and two others were affected due to staff being

Meanwhile, M&S CEO Steve Rowe said the number of staff selfisolating is "a major issue across every industry at the moment".

He added: "Our cases are roughly doubling every week and the pinging level is about three to one of Covid cases, so we're seeing that growing exponentially.

"If there's shortages we'll have to manage it by changing hours of stores, reducing hours. Where the industry will see the pain is in the supply chain, because logistics runs tight anyway to be efficient."

Morrisons spokesman said: "As per the whole of the UK, we are experiencing a rise in cases and close contact notifications."

But it added: "Throughout the whole of the pandemic, we have not been required to close a store."

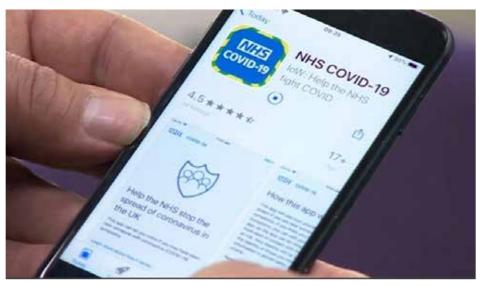
From August 16, the fully jabbed can avoid self-isolating "pinged".

Instead they must take a PCR test and if clear can carry on as normal. But the British Retail Consortium (BRC) wants the Government to bring forward those changes immediately so staff do not "needlessly quarantine".

BRC chief executive Helen Dickinson said: "This will only get worse right across the economy, as cases are already rising fast and the final restrictions are eased."

Lord Karan Bilimoria, president of the Confederation of British Industry, said amid "crippling staff shortages, speed is of the essence". He called for "a route out of isolation for those not yet fully vaccinated through daily lateral flow tests".

Car makers Nissan and Rolls-Royce have

91F...UK gets first ever extreme weather alert

BRITAIN experienced near record breaking heat this week, prompting the country's first ever extreme heat warning as the mercury hit 91F on Moday.

With the country likely to be hotter than the Bahamas and Balearics, the Met Office is advising people to look out for children and elderly people, who are more susceptible to heat-related illnesses.

The West Midlands, South-west england, South Wales and further east into Hampshire and the Isle of Wight all basked in sweltering conditions throughout the week,

as a tropical blast from the Atlantic encouraged millions to head to the beach. The extreme heat notices were introduced on June 1 into the National Severe Weather Warning Service, part of the Met Office, which highlights the impact of severe conditions.

They are designed to highlight the downsides of heatwaves on health, infrastructure and other

Safety experts are also warning people to take extra care after at least six people died on Sunday.

One man died at Crookes Valley Park, South Yorks, while swimming in

Another fell off rocks at Stair hole near Lulworth Cove in Devon.

Two teenage swimmers died in Greater Manchester and Oxfordshire, as did a man in his 50s in North Yorkshire. emergency services also recovered a man's body from the water-filled Victory Quarry in Dove holes, Derbyshire.

The county's fire and rescue manager Paul hawker said: "No matter how warm the weather is, the water remains cold, which can cause the body to go into shock, making it difficult for the strongest of swimmers."

I won't play gigs where vaccination is required, insists Eric Clapton

British rock icon Eric clubs and venues from Clapton has said he will not perform at venues that require concertgoers to be fully vaccinated against Covid-19.

UK Prime Minister Boris Johnson has said vaccination shown at must be

September.

Clapton said he will not perform anywhere there is a "discriminated audience present".

His announcement came through the social media accounts of an outspoken anti-vaccine activist.

The guitarist said he felt "honour bound" to make the statement, which was posted on Wednesday to the accounts of Italian architect and film producer Robin Monotti.

In May, Clapton said he had experienced a "severe" reaction to the

AstraZeneca vaccine.

In a letter to Mr Monotti, he blamed "propaganda" overstating the safety of the vaccine. He added that he feared the "disastrous" reaction would leave him unable to play music again.

Experts stressed the benefits of vaccination outweigh the risks for the vast majority of people. Some people do experience mild to moderate symptoms after being vaccinated.

There is a very rare blood clot side-effect believed to be linked to the AstraZeneca vaccine, but the European Medicines Agency still

recommends the jabs for all ages.

Clapton's next UK show is scheduled for May 2022 at London's Royal Albert Hall. The venue has said people may be asked to show their Covid status ahead of an event.

Clapton also has eight US concerts scheduled in September of this year. Vaccine proof is currently not required at most music venues in the US.

This is not the first time Clapton has taken a stand on Covid measures: he appeared Northern Irish singer Van Morrison's anti-lockdown song "Stand and Deliver" in

December.

The song was one of three by Van Morrison to protest lockdown measures.

British-Sri Lankan singer MIA also made headlines in April 2020 after saying she would rather "choose death" than a vaccine. She later clarified her remarks to say she was "not against vaccines" but "against companies who care more for profit than humans".

A recent Imperial College London survey looking at 15 countries found that concerns about side effects and testing are the primary reasons behind vaccine hesitancy.

This time he is proudly showing off his adult teeth, following his gappy smile when he was losing his milk teeth two years

Releasing the picture, spokesman Kensington Palace said: "The Duke and Duchess of Cambridge are very pleased to share a new photograph of Prince George ahead of his eighth birthday tomorrow. The photograph was taken earlier this month in Norfolk by the Duchess."

George – recently seen alongside his parents at the final of Euro 2020 at Wembley - and

siblings Princess Charlotte, six, and Prince three, usually Louis. spend their birthdays in the countryside with their parents.

Kate, 39, admitted she usually stays up until at least midnight the night before their special days to make them a cake.

Anmer Hall is said to be her favourite spot and is where the Cambridge family spent much of the early part of the pandemic.

They only returned to London for the summer school term, with George and Charlotte both pupils at Thomas's Battersea, which has now closed for the holidays.

Prince George is third in the line of succession to the British throne - behind his grandfather Prince Charles, 72, and his father Prince William, 39.

Name That Tune's Tom O'Connor dies at age 81

NAME That Tune quiz favourite Tom O'Connor died aged 81 this week – forever grateful for turning his schoolteacher patter into a TV career.

Tom, the clean-cut star of game shows including Crosswits, had said his job was "like winning the pools".

And tributes poured in this week to the unassuming star from Bootle, Merseyside, who'd had Parkinson's for more than a decade.

Presenter Piers Morgan called him a "Liverpool legend", while BBC Breakfast host Dan Walker said: "He was kind, funny and a true gent."

Tom's son Steve Finan comedian on TV O'Connor – who is the right choice."

married to Olympic gold medallist Denise Lewis – said he was a "unique comedian who was light years ahead of political correctness".

The son of a docker, Tom's early career saw him juggle a job as a primary teacher by day with working the clubs as a comic at night.

He tried his jokes out on his pupils, leaving little room for the four-letter gags and crude humour of his rivals.

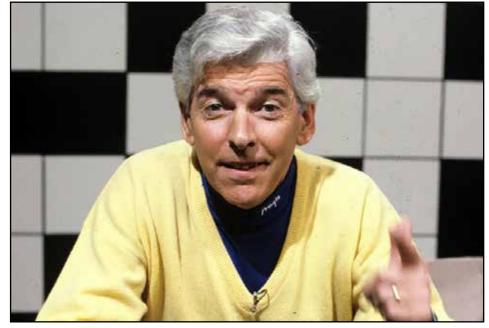
In 2016 he said: "Everyone on TV was doing the four letter words. I thought I can't do this... So for a long period I was the only clean comedian on TV. I made the right choice."

He got his big break in 1974 on TV talent show Opportunity Knocks where a hat-trick of wins saw him put him up for The Comedians.

Name That Tune came calling in 1976, which he hosted until 1983.

He recalled: "Someone said give that man Name That Tune as he teaches maths and music and we need a mathematical brain on a music quiz."

A succession of hit shows followed, including Pick Pockets, The Zodiac Game, Gambit and Crosswits, where his catchphrase was "Never a cross word". He also hosted The Tom O'Connor Show, with a peak audience of 12

million.

His career – and marriage to wife Pat with whom he had four children – could have been derailed in 1988 after claims in a Sunday newspaper about his private life. He later said: "It was all nonsense and luckily it didn't have any harmful effects on my career. I am fortunate to be blessed with a loving family, my rock being my lovely wife, Pat."

Tom went on to star in BBC daytime soap Doctors as a Catholic priest, and was crowned Celebrity Come Dine With Me champion. He also appeared more than 100 times on Countdown's Dictionary Corner.

Tom lived with Parkinson's and in 2013 discovered he had bowel cancer. He said: "It was successfully treated but a serious wake-up call."

White privilege is 'divisive' term says equality watchdog

THE term "white privilege" has been branded "divisive" by the head of the UK's equality watchdog.

Baroness Falkner of Margravine said she found the expression an "unhelpful way of looking at society".

She said: "If we taught rights in the curriculum – human rights, civic rights – that would be the more relevant thing to teach our young people.

"Rather than fretting about one group versus another group, and whether one group has had innate advantages that other groups don't have. I prefer a unifying discourse to a divisive discourse. And I find those expressions to be divisive."

Baroness Falkner, 66, said culture wars "are incredibly damaging to our health as a nation".

She said the Equality and Human Rights Commission, of which she is chair, will "try and get different bodies around the same table and to try and get some reasonableness".

A report from the Commons Education Select Committee last month claimed terminology such as "white privilege" may have contributed towards a "systemic neglect" of white working class pupils.

Baroness Falkner has been drawing up a new strategic plan for the EHRC.

The plan will "emphasise something that the Government too wants us to do, which is to be a better regulator, more agile".

Equalities minister Liz Truss has insisted that the best way "to reduce unfairness" is "through opening up opportunities for all".

Baroness Falkner added: "We've done some focus group research, and one of the things that came out was that we're very careful to get things right, but one of the consequences of that is that you're a bit slow."

Will upcoming book get Harry disinvited to Jubilee?

PRINCE Harry's decision to write a tellall memoir threatens to throw the Queen's Platinum Jubilee celebrations into disarray.

Buckingham Palace refuses to say whether Harry and his wife Meghan will be invited to take part in the central weekend of events marking the monarch's 70 years on the throne in June next year.

Earlier reports, before details of Harry's book emerged this week, suggested that the Duke and Duchess of Sussex would be welcome. But a palace spokeswoman said yesterday: "We're just not going to get into that. We're not going to speculate."

The revelation that Harry, 36, had been secretly working on his book for a year has shocked courtiers and added to the list of subjects that threaten to cast a dark cloud over the jubilee celebrations.

These are due to begin in February and culminate in a double bank holiday weekend of events in London in June next year.

Harry promised it would be a "wholly truthful and accurate" account of his life and is expected to provide fresh revelations on his and Meghan's decision to quit.

Harry, 36, said: "I'm writing this not as the prince I was born but as the man I have become. I've worn many hats, literally and figuratively, and my hope is that in

telling my story – the highs and lows, the mistakes, the lessons learned – I can help show we have more in common than we think."

His advisers have suggested that proceeds from the book, due out next year, will go to charity, but it is not clear what proportion.

It is understood that Harry only told the Queen, 95, and other family members about the book with ghost writer J R Moehringer shortly before making a public announcement following a story in a US newspaper on Monday. His spokeswoman in Los Angeles insisted that he would not be expected to obtain permission from Buckingham Palace to write the book.

However, he and Meghan gave a commitment that they would continue to uphold the values of the Queen after they quit their senior royal roles last year.

Royal author Penny Junor said: "The family must be despairing. This is a man who they all love and he seems to be doing his best to embarrass and damage his family."

Sources close to Prince Charles and Camilla said they were "surprised".

"I'm excited for people to read a firsthand account of my life that's accurate and wholly truthful."

Markus Dohle, chief executive of Penguin Random House, said it was "thrilled" to publish the memoir.

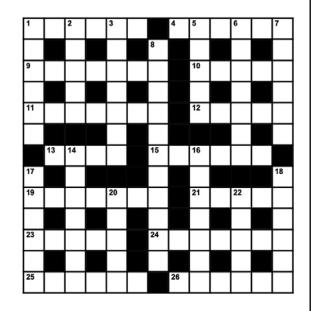

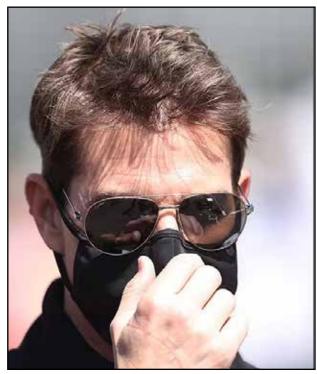
