FLU 'COULD KILL 60,000' THIS WINTER

- Health Secretary launches biggest campaign against the disease in NHS history
- Britons urged to book flu shots and Covid boosters immediately

Health chiefs are urging Britons to get jabbed as soon as possible amid warnings up to 60,000 people could die from flu this winter.

Experts fear a massive surge in cases because social distancing measures kept infections low last year, reducing population immunity.

The Government has launched the biggest flu programme in the history of the NHS, with more than 35 million people in England eligible for a free vaccine.

Covid booster jabs are also being rolled out, with around 1.7 million people given these third jabs so far and around 28 million people in England eligible.

Health Secretary Sajid Javid is calling on people to protect themselves against both viruses after experts predicted high infection rates could push the health service to breaking point.

It comes as colder weather and darker evenings lead to increased social contact indoors, making it easier for the viruses to spread.

The Covid booster must be given no earlier than six months after a second dose of any coronavirus vaccine, according to guidance from the Joint Committee on Vaccination and Immunisation (JCVI).

In some regions people may be offered the Covid jab in one arm and the flu vaccine in the other, although this will not be available everywhere.

Mr Javid said people should not delay having either jab when invited to get them - either on separate occasions or at the same time.

He added: 'The Covid-19' vaccine programme is a fantastic example of how successful vaccination programmes can be - with around 130,000 lives saved.

'It is vital we continue that incredible progress with all those eligible ensuring they get both their flu and Covid-19 booster injections as soon as they are invited.'

A report from the Academy of Medical Sciences, published earlier this year, assessed how the triple threat of coronavirus, flu and respiratory syncytial virus (RSV) might affect the NHS this winter.

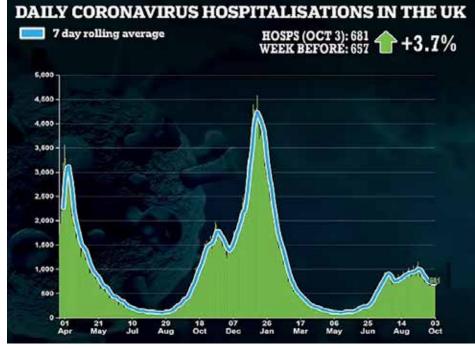
It found that hospital admissions and deaths from flu and RSV could be more than double those seen in a normal year, leading to as many as 60,000 flu deaths and 40,000 children in hospital with RSV.

A recent survey of 3,000 people for ministers found that nearly one third (32 per cent) were unaware that flu and Covid-19 can circulate at the same time.

TRAVEL EASIER: red list slashed to just seven countries

The number of countries on the UK Covid travel red list will be cut from 54 to seven, the government said on Thursday.

South Africa, Brazil and Mexico come off the red list, which requires travellers to quarantine in an approved hotel at their cost for 10 full days.

Transport Secretary Grant Shapps said the changes begin on Monday and "mark the next step" in opening travel.

This latest move will be seen as a boost to the airline industry and families separated during the pandemic.

Panama, Colombia, Venezuela, Peru, Ecuador, Haiti and the Dominican Republic remain on the red list.

Pandemic travel rules in the UK have recently been simplified, with the amber list cut, and advice against holidays changed for 32 countries.

But consumer group Which? warned the changes only reflect requirements for arriving back in the UK.

"Travellers should be

aware that they may still face restrictions on entry to many destinations, especially those under 18 who are not yet vaccinated," it said.

more expensive

Arrivals from 37 more destinations will have their vaccination status certificates recognised, meaning they can avoid more expensive post-arrival testing requirements.

Vaccinated travellers from Brazil, Hong Kong, India, Pakistan, South Africa and Turkey will be treated the same as returning fully-vaccinated UK residents so long as they have not visited a red-list country in the 10 days before arriving in England.

All arrivals will still complete a passenger locator form.

The Scottish government said the changes were "agreed on a four-nation basis".

The Welsh government said that they increased opportunities for new infections and variants, but it was adopting them because it was not practical to have its own border policy.

'Poohsticks' bridge sold for £131k to Sussex landowner

■ Bridge featuring in AA Milne stories bought by estate owner whose father used to play Poohsticks with author's son

To Winnie-the-Pooh fans, the bridge over the river on the edge of the forest where Pooh invents a new game is up there with heffalumps and pots of honey and the Hundred Acre Wood.

It is where Pooh one day accidentally drops a fir cone in the water on one side of the bridge, only to spot – to his astonishment – the cone reappearing on the other side. "And that was the beginning of the game called Poohsticks."

Now the original bridge has been sold for £131,625, more than double the top end of the presale estimate of £40,000 to £60,000. Its new owner is Lord De La Warr, who owns the 2,000-acre Buckhurst Park estate in East Sussex, which incorporates the wood made famous in AA Milne's children's books.

De La Warr said he was delighted to be the successful bidder. The bridge would "take pride of place on the estate close to its original position", he said.

Describing the

structure as "an iconic piece of literary history in physical form", James Rylands, the director of Summers Place Auctions which held the sale, said there had been interest from potential buyers in many countries. "But we are thrilled the bridge will stay in the UK – it's a really happy ending and we couldn't have hoped for anything better."

According to Rylands, De La Warr's father used to play Poohsticks with Christopher Robin Milne, the only child of AA Milne, who was the inspiration for the children's books along with his collection of soft toys. Rylands said the bridge was "going back home".

The original wooden structure was built from oak in 1907 to carry pedestrians, horses and carts over a river in Ashdown Forest, the setting for the Pooh stories and poems. It was replaced with a replica in 1999 after visits by thousands of people keen to recreate the famous EH Shepard drawing of Christopher

Robin leaning over the railings left it worn and rickety.

The original bridge was dismantled and placed in storage. It was later reconstructed and restored, and relocated to Kent after a private sale.

Now, said Rylands, Winnie-the-Pooh fans would again be able to set eyes on it, although games of Poohsticks may be ruled out in order to preserve the bridge for future generations.

He added: "Winniethe-Pooh's attraction is the innocence of a bygone age; it's so wholesome. There's so much badness in the world, but Winniethe-Pooh always brings a smile to your face."

The price achieved in sealed bids was "a reflection of its place as a national treasure, but more importantly it will be cared for and loved".

Johnny Gold, legendary owner of Tramp, dies at 89

■ Iconic London nightclub was favored haunt of showbiz superstars, moguls and royalty

LONDON'S nightclub scene has lost one of its legendary figures with the death this week of Johnny Gold, the founder of Tramp.

Gold, 89, presided over the Jermyn Street institution from its star-studded opening in 1969 until its sale in 2004. The intervening 35 years saw a non-stop parade of stars, moguls and royalty passing through its doors as the place became a byword for excess, carousing and most importantly discretion.

Tramp was the place where Rod Stewart partied until dawn, where Mickey Rourke drank with George Best and Joan Collins filmed The Stud. And it was where American superstars visiting London would almost always come for a drink and to visit its charismatic owner - be they Frank Sinatra, Sammy Davis Jr, Elizabeth Taylor or Muhammad Ali.

Mick Jagger was a founder member of the club when it opened in 1969 and fellow Stone I used to play Sunday Bill Wyman formed a lasting friendship with Gold when he hung out there with Bobby Moore, Albert Finney, Bjorn Borg, Robert De Niro and Anthony Newley.

'couple of years'

Membership initally set at ten guineas - about £200 today - but Gold, along with fellow ownes Oscar Lerman and Bill Ofner, had no idea they were creating an institution. "We thought it might last a couple of years at best," Gold once told a TV documentary crew.

Lerman's wife, bestselling author Jackie Collins, said of the club: 'At Tramp, you didn't have the paparazzi you have today, you didn't have the spies or cellphone cameras."

Regular Rod Stewart has said of Tramp in the past: 'Just as well it was before camera-phones. We'd all be in prison by now, the things we got up to!

'I'd come out of Tramp about 4am or 5am when

Mickey Rourke, who was also a regular, said: 'Back in the day, there was Tramp. That was it. All the best-looking girls in the world were there, all the best-looking guys.

'There would be all these stars but the star of the place was Johnny Gold because he looked after you.'

Other regulars, both at the club's London premises and its shortlived Los Angeles outpost - were Michael Caine, George Best and the 'other' Collins sister,

After selling his stake in 2004 Gold enjoyed a comfortable retirement with his wife Jan in The Bahamas.

Revealing the secret of his success, Gold said: 'I tried to treat the celebrities as ordinary people, and the ordinary people as celebrities. I'd walk down those stairs of Tramp every night and say "Showtime!"'

Beware of social media, Emma told

■ Gauff warns fellow teen tennis star

EMMA RADUCANU has been warned by American teenager Coco Gauff to be wary of social media following the Briton's maiden Grand Slam triumph at the US Open last month.

Raducanu, who became the first qualifier to win a major tournament, has since gained thousands of new followers on social media, setting up an account on Chinese microblogging site Weibo to keep in touch with fans in that country.

Gauff, who shot to fame as a 15-year-old when she reached the fourth round at Wimbledon in 2019, urged 18-year-old Raducanu to take time away from her phone.

'time limit'

"It is exciting when you get all the retweets, all the follows and all of that, but it can be a bit overwhelming, at least in my experience. That's probably what I wish I would've known, not to focus on social media," said Gauff, now 17.

"I put a time limit on my phone because I thought I was spending

too much time on it. From 8.30am to 9.30pm I have limited access to apps."

Raducanu returned to action this week at the Indian Wells Masters California after splitting with coach Andrew Richardson. She is preparing for the tournament with former British No.1 Jeremy Bates, who coaches Briton fellow Katie Boulter, but it emerged this week that the arrangement is purely temporary and the new queen of tennis does not expect to appoint a permanent coach before the end of the year.

Like Raducanu, Andy Murray is preparing for the BNP Paribas Open in Indian Wells. The 34-yearold says he does not feel bad taking wild cards away from younger players given all he achieved in tennis before missing time due to hip surgeries. Critics suggest wild cards are better suited to up-andcoming players but Murray, a three-time Grand Slam champion and former world No.1, who had hip surgery in 2018 and 2019, feels

"After what I've gone through the past three, four years and what I've achieved for the game beforehand, I don't feel like I need to justify why I should receive wild cards," said Murray.

Among the other wild-card recipients for the hard-court event are Raducanu and 38- year-old Belgian Kim Clijsters, a former women's world No.1 and four-time Grand Slam winner.

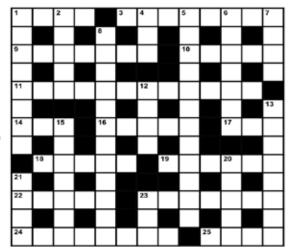

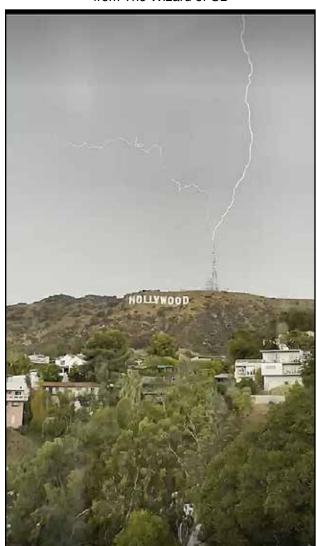

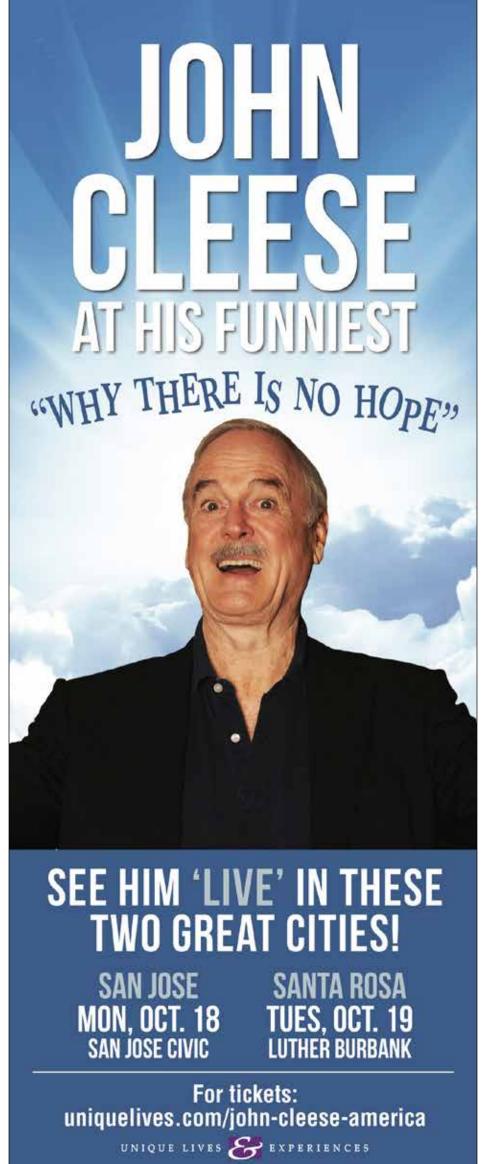

Staveley told the BBC that PCP Capital took concerns over Saudi Arabia's human rights record "very seriously" but reiterated that their partner "is not that Saudi state, it's PIF".

When asked if this was a case of 'sportswashing' said: "No, not at all, this is very much about the fantastic football team growing the club."

A Saudi Arabian-backed £305m takeover Newcastle United has been completed.

The Premier League has approved the takeover after receiving "legally binding assurances" that the Saudi state would not control the club.

Instead the Public Investment Fund (PIF), which will provide 80% of funds for the deal, is seen as separate to the state.

This is despite the Crown Prince of Saudi Arabia, Mohammed bin Salman, being listed as chair of PIF.

The sale went through after the deal passed the Premier League owners' and directors' test.

The takeover brings to an end Mike Ashley's 14year spell as Newcastle United owner.

Fans gathered outside Newcastle's St James' stadium Thursday to celebrate the takeover being approved.

PIF have assets £250bn, making Newcastle one of the richest clubs in the world.

Financier Amanda Staveley, who fronted the consortium, said the new owners are making a "long-term investment" to ensure Newcastle are "regularly competing for major trophies".

Newcastle's last major domestic trophy was the 1955 FA Cup.

A Premier League statement said: "The Premier League, Newcastle United Football Club and St James Holdings Limited have today settled the dispute over the takeover of the club by the consortium of PIF, PCP Capital Partners and RB Sports & Media.

"The legal disputes concerned which entities would own and/or have the ability to control the club following the takeover. All parties have agreed the settlement is

necessary to end the long uncertainty for fans over the club's ownership.

"The Premier League has now received legally binding assurances that the Kingdom of Saudi Arabia will not control Newcastle United Football Club.

"All parties are pleased to have concluded this process which gives certainty and clarity to Newcastle United Football Club and their

A deal was initially agreed in April 2020, but the buyers walked away four months later when the Premier League offered arbitration to settle a disagreement on who would control the club.

It is believed that a resolution came after Saudi Arabia settled an alleged piracy dispute with Qatar-based broadcaster beIN Sports, which own rights to show cont. on page 15, col. 6
