UK Covid Response: the good, the bad and the ugly

■ But the drive to develop and deploy the jabs was world-leading, MPs' report concludes

THE Covid vaccine programme was "one of most effective initiatives in UK history", but the first lockdown came too late, a major inquiry into the UK pandemic response found.

Britain's drive to develop and deploy the jabs was world-leading, MPs on the Commons health and science committees concluded.

However, they found scientific advisers initially took the wrong approach to the virus, costing lives.

In a joint statement responding to the findings, Jeremy Hunt, chair of the health and social care committee, and Greg Clark, chair of the science and technology committee, said: "The UK response has combined some big achievements with some big mistakes.

"It is vital to learn from both to ensure that we perform as best as we can during the remainder of the pandemic and in the future."

The year-long inquiry investigated why the UK was worse-affected than many other countries, reporting more than 160,000 fatalities with Covid on a death certificate.

After evidence from

more than 50 witnesses and 400 written submissions, the "Coronavirus: lessons learned to date" report concluded the vaccine drive was the most successful part of the response.

'uncertainty'

The jab rollout paved the way for "a resumption of much of normal life", the report said. It added:

"Millions of lives will ultimately be saved as a result of the global vaccine effort, in which the UK played a leading part."

But the inquiry identified serious flaws in leaders' actions between January and late March 2020

It acknowledged there was a "fog of uncertainty" hanging over early 2020, but said the "veil of ignorance through which the UK viewed the initial weeks of the pandemic" was "self-inflicted" due to delays with the testing system. And while the Scientific Advisory Group for Emergencies (Sage)

had recommended the gradual introduction of restrictions, the inquiry found this only aimed to slow rather than stop the spread. There was also an incorrect belief that the public would not tolerate a prolonged lockdown.

MPs ruled that was "the wrong policy" and that the death toll would have been lower if stronger measures had been implemented sooner.

recommendations

The report said: "Decisions on lockdowns and social distancing... and the advice that led to them, rank as one of the most important public health failures the UK has ever experienced."

Mr Hunt and Mr Clark added: "The Government took seriously scientific advice but there should have been more challenges to the early UK consensus that delayed a more comprehensive lockdown when countries like South Korea showed a different approach was possible."

The report also said the discharge of untested patients from hospitals into care homes fuelled the spread.

Shortages of staff, testing and PPE meant it was hard to isolate cases and keep the virus at bay.

Additionally, prepandemic planning was "narrowly and inflexibly based on a flu model" that failed to learn from SARS, MERS and Ebola.

In total, MPs made 38 related recommendations to the Government and public bodies.

Mark Woolhouse, a Sage member and professor of infectious disease epidemiology at the University of Edinburgh, thinks the conclusion about delaying lockdown is "too simplistic".

He said: "There is disagreement as to how many lives would have been saved. Lockdowns are harmful in their own right."

Prof Trish Greenhalgh, of Oxford University, said the report "hints at a lessthan-healthy relationship between the Government and its formal scientific advisory bodies".

But a Government spokesman said: "We have been guided by scientific and medical experts and we never shied away from taking quick and decisive action to save lives and protect our NHS. We have committed to holding a full public inquiry in spring."

It comes as a third of fully vaccinated over-80s in England – around 923,000 people – are reported to have had a booster.

As growth soars again, Chancellor heaps praise on 'strong economy'

BRITAIN'S remarkable economic recovery is almost complete after another surge in growth - and it could end the call for tax rises say experts.

GDP went up by 0.4 per cent in August, fuelled by a recreation and entertainment boom, in the first full month after Covid-19 restrictions were lifted.

It means the economy is now only 0.8 per cent smaller than it was before the pandemic began.

Forecasts suggest further increases September as bounceback continues with the UK economy now the fastest growing in the G7.

But experts have warned that the recovery will have been stifled in recent weeks as global supply chain woes take their toll.

Strong

Rishi Sunak welcomed the latest figures, insisting the economy "remains strong". The Chancellor, on his first official visit to the US, said: "Our economic

recovery is continuing with more employees on payrolls than ever before and the UK forecast to have the fastest growth in the G7 this year.

"As we rebuild from the pandemic, we are taking action to ensure our economy remains strong by helping people find great work through our Plan for Jobs."

Economists August's growth, which came after a slight dip in July, slams the door on the prospect of any further tax rises. Julian Jessop, of the Institute of Economic Affairs think tank, said: "The rebound in economic activity will help to repair the public finances without the need for any more tax increases."

But he indicated interest rates would need to rise, with analysts predicting they could hit 0.25 per cent by the end of the year, to cool inflation. He said: "With labour shortages and rising prices now the biggest threat, the focus needs to shift to tackling problems on the supply side.

should be on letting markets work properly, rather than further state intervention and pumping even more money into the economy."

The Office for National Statistics said growth rebounded strongly in the second quarter of the year, with GDP rising by 5.5 per cent.

But the recovery since then has been sluggish, with supply problems and the lorry driver crisis holding back the economy.

The ONS data showed that output in the construction sector fell for the second month running, down by 0.2 per cent in August following a 1 per cent decline in July, as supply holdups led to shortages of key materials and rocketing prices.

Having recovered in April to be 0.9 per cent above levels seen before the pandemic, the construction sector is now 1.5 per cent below its pre-Covid level.

The ONS added that July's contraction was also partly due to the difficulties in the car

manufacturing industry, which has been affected by a global shortage of microchips.

Tombs, Samuel Pantheon Macroeconomics, warned is "implausible" that growth will rise enough in September to remain on track with Bank of England forecasts, particularly given that the full force of the supply crisis is set to be felt from September onwards.

This week Mr Sunak called for "global action" to tackle supply disruption during a meeting of G7 and G20 finance ministers.

It is his first visit to Washington since Chancellor becoming in February 2020, just a month before the first lockdown when the furlough scheme started. He also met the UK's ambassador, Dame Karen Pierce.

Warnings

His trip comes as the UK continues to struggle with an HGV driver shortage that is impacting supermarket and fuel deliveries amid warnings this week there could be a shortage of salt gritter drivers this winter.

Mr Sunak used the meeting to encourage further support for vulnerable countries that are also struggling with supply chain issues.

In a statement before the meetings he said: "Global cooperation is key to addressing our shared challenges as we emerge from the pandemic.

Cops drop Andrew sex probe

BRITISH POLICE have dropped a criminal probe into the alleged sex crimes of Prince Andrew. It comes after reports they had spoken to the woman who claimed that he attacked her.

Met police are said to have approached Virginia Giuffre, 38, in a dramatic move that could have led to a full criminal investigation by the force.

The twist came after Met Commissioner Dame Cressida Dick warned "no one is above the law".

It also coincided with claims that the Duke of York's siblings Charles, Anne and Edward, plus Prince William, are determined to prevent him returning to public life. he Metropolitan Police said it would be taking "no further action" over allegations against Prince Andrew and Jeffrey Epstein, it has been revealed.

The force said after conducting two reviews and examining recent material, they would be dropping their investigation.

But officers said that they will continue to liaise with unnamed law enforcement agencies leading the investigation into the convicted paedophile and billionaire financier who hanged himself in prison two years ago as he awaited trial on

trafficking charges.

Epstein had been a close friend of the Prince.

Ms Giuffre, who now lives in Australia, has accused Prince Andrew of sexually assaulting her when she was 17 at the home of Epstein's friend Ghislaine Maxwell and at Epstein's Manhattan townhouse and on his private island.

The Queen's second son has strenuously denied all the allegations and claims not to remember meeting Ms Giuffre.

Andrew, 61, still faces a £14million damages claim from her over the allegations.

But his lawyers are seeking to have her lawsuit thrown out and have pledged to

way forward". Throwing down the gauntlet in a speech in Lisbon, Lord Frost urged EU chiefs to lose the "poison" from the deadlock for good.

He told diplomats: "Let us both be ambitious and agree a better way forward.

"Let's agree arrangements which we will both implement and which can in fact be implemented, because they command acceptance and respect across Northern Ireland."

He continued: "With some effort of will, we could still, despite all the problems, be in a position where the poison is drawn from this issue entirely and it is removed from the diplomatic top table once and for all."

But Lord Frost warned that the UK is willing to trigger Article 16, which allows either side to in effect override much of the Brexit agreement, if both sides cannot find common ground.

"It is this Government, the UK Government, that governs Northern Ireland."

Peace

He added: "Northern Ireland is not EU territory. It is our responsibility to safeguard peace and prosperity and that may include using Article 16.

"We would not go down this route gratuitously or with any particular pleasure but it is our fundamental responsibility to safeguard peace and prosperity in Northern Ireland and that is why we cannot rest until this situation is addressed."

The Government also wants to reverse its previous deal on the oversight role of the European Court of Justice (ECJ) – the highest EU court.

Lord Frost warned that it would be a "historic misjudgment" if the EU did not consider the changes.

The existing protocol has created barriers to trade across the Irish Sea and led to shortages of some goods that are supplied from Great Britain.

Unionist politicians claim it undermines Northern Ireland's constitutional position in the UK.

Lord Frost said that the new proposal would support the Good Friday Agreement.

He continued: "We have a short, but real, opportunity to put in place a new arrangement, to defuse the political crisis that is brewing, both in Northern Ireland and between us."

The peer also accused the EU of being an organisation "that doesn't always look like" it wants the UK to succeed.

The peer called the existing protocol "the biggest source of mistrust" with the EU, with border rules having "completely lost consent in one community in Northern Ireland. There is a widespread feeling in the UK that the EU did try to use Northern Ireland to encourage UK political forces to reverse the referendum result or at least to keep us closely aligned

"And, moreover, that the protocol represents a moment of EU overreach when the UK's negotiating hand was tied, and therefore cannot reasonably last in its current form.

"The situation has now moved on. We now face a very serious situation. "The protocol is not working."

"This is being seen across the European Union as the same pattern over and over again – the EU tries to solve problems, the UK dismisses the solutions before they're even published and asks

Leo Varadkar, its Trade Minister, said the UK demand to end the ECJ's role in policing the protocol was "very hard to accept.

"I don't think we could ever have a situation where another

court could decide what the rules of the single market are."

Jenny Chapman, Labour's shadow Cabinet Office Minister, said: "Lord Frost has effectively asked to rip up the agreement he negotiated, and the Prime Minister signed, just two years ago."

Steve Aiken, a Unionist member of the Northern Ireland assembly, claimed that the existing trade protocol "does not have the consent of the Unionist and pro- Union population".

I'd never make it in today's woke Britain, reveals Billy

■ TV executives not brave enough to broadcast edgy acts, claims legendary Scottish comic

BILLY Connolly claims woke culture would stop him starting out on a career in comedy in modern Britain.

The legendary comedian said he thought that he would be "cancelled", with his "fearless" material deemed too offensive for current audiences.

Sir Billy, 78, found fame

as a comic in the 1970s. He upset religious groups with routines such as the Last Supper, in which he imagined the final days of Jesus beginning in a pub on his native Glasgow's Gallowgate.

But he said that political correctness has now gone too far, and claimed that talented comedians

were not being given an opportunity to shine because TV executives were not brave enough to broadcast edgy acts.

Asked if he would be shunned today, US-based Sir Billy said: "Absolutely. You can't decide to be fearless, you're either fearless or you're not and you go about it.

"Because of political correctness people have pulled in the horns but I don't know how I feel about that. I couldn't have started today with the talent I had then, certainly not.

"There's a show here in America with all black comedians, men and women, and they are totally ruthless.

"They are totally without political correctness and they have always got me on the floor

howling with laughter.

"It's just the cheek of them and the bravery of it.

"There was a comedian who had a series on television and the suits involved were going to take it off at the first commercial break.

"They have got no bravery. We need people who give people time and a chance to develop and all that kind of stuff.

"I think things have changed forever [with political correctness] but you never know."

The film star and musician was speaking to New Zealand radio network Newstalk ZB in an interview to promote his autobiography

Windswept & Interesting which was published this week.

He said that writing some parts of the book, such as covering the abuse from his father and his aunts that he suffered as a child, had made him depressed.

Sir Billy, known as the Big Yin, continued: "It was difficult to write, and the trouble with it is when you bring it up it stays for a while and then you get over it and then you bring it up again and you get depressed again.

"I don't know if it helps or not but you are as well to get it off your shoulder and into the

open air. It's difficult but you get there."

Sir Billy – married to

former Not the Nine O'Clock News star Pamela Stephenson, 71 – announced his retirement from performing stand-up comedy in 2018.

He has carried on making documentaries and is currently filming a series called Billy Connolly Does... for TV channel Gold.

Sir Billy was diagnosed with Parkinson's disease nine years ago after a doctor approached him when he saw him walk with an unusual gait through the lobby of a hotel in Los Angeles.

The couple moved to Florida from their previous home in New York after medics advised him to live in a warmer climate.





Sir Paul: Beatles split 'hardest time of my life'

SIR Paul McCartney has tried to set the record straight about The Beatles' break-up – saying it was one of the toughest moments he has faced.

He says the split was instigated by John Lennon, not him. It had been thought Macca ended the Fab Four by saying he wanted to go solo in 1970.

The supposed evidence was a press release for his album, McCartney, where he revealed he was on a "break" from pop's biggest band.

Now Sir Paul, 79, has spoken out, telling an

interviewer: "Stop right there. I didn't instigate the split. That was our Johnny. I am not the person who instigated the split. Oh no, no, no. John walked into a room one day and said I am leaving The Beatles.

"And he said, 'It's quite thrilling, it's rather like a divorce.' And we were left to pick up the pieces."

The Beatles limped on for a few months and Paul eventually sued the other three to keep their music from new manager Allen Klein.

Macca was interviewed for BBC Radio 4 series This Cultural Life. Asked if the band would have continued had John not walked away, Sir Paul replied: "It could have. The point of it was that John was making a new life with Yoko and wanted to lie in bed for a week in Amsterdam for peace. You couldn't argue with that.

"It was the most difficult period of my life. This was my band, my job, this was my life. I wanted it to continue."

UK hate crime figures surge

■ Figures on racist, disability and sexual gender attacks all spike up

HATE crime has surged to a record level with a 12 per cent rise in racially-motivated offences, official figures reveal.

There were 124,091 such crimes recorded in England and Wales in the year to March 2021 – an increase of nine per cent on the previous 12 months. A total of 92,052 were racial in nature, according to data from the Home Office. Experts believe the true figure is far higher as offences are likely to be significantly under-

reported.

Jabeer Butt, of the Race Equality Foundation, said: "The fact that almost three quarters of hate crimes were racially motivated shows how far is left to go towards building a society that is truly tolerant and antiracist. It is all too clear that too many people still face horrific attacks simply on the basis of who they are."

Disability-related hate crimes rose by nine per cent and those relating to sexual orientation by seven per cent. Transgender identityrelated hate crimes went up three per cent. However, recorded offences linked to religion were down by 18 per cent.

Just over half of the crimes recorded in England and Wales were for public order offences.

Hate crimes include assault, threatening behaviour, robbery, damage to property, graffiti, harassment, online abuse and inciting others to commit such crimes.

Prostitutes


And Wayne himself admits: "People still look at me in a different way. For me it's important that people remember me for who I am rather than what I've done."

COLEEN AND WAYNE: the Rooneys married in 2008



It's so good to be back home!

Covid tests and petrol shortages can't stop Eileen Lee from feeling the love on a trip back to the UK

It is so surreal to be back in England after 18 months away. It is easily the longest I've not visited since moving to LA 24 years ago!

It wasn't until I landed that I allowed myself to realize just how much I'd missed it. Mostly my family of course - and whilst I will be eternally grateful for video chats it can never replace actually being in the same room as someone. I've not done much socially, as the purpose of this visit is to care for my elderly mum. I have managed to have my fill - and then some of chocolates and crisps and of course the requisite fish and chips supper.

The petrol shortage is real, as I drove up the M1 I was horrified to see signs saying "No petrol available" at nearly all of the service stations


between London and Nottingham. Although, my understanding is that it may have not been so extreme if the media hadn't stirred the pot which then resulted in the ridiculous panic buying. I was shocked to read on the local Nextdoor group that petrol was being stolen from parked cars. Insane! I also read posts from neighbours offering to share petrol with those in need, so it's not all bad.

Testing times

You may remember a few weeks ago I was preparing for this trip. Like many of us I was worrying about the testing requirements and feeling overwhelmed by all of the forms that needed filling out before I was deemed to fit to fly. Thankfully it all worked out just fine, but I couldn't

have done it without all the tips and tricks our fellow members had shared on our Facebook page. Of course the rules have changed again since then! If you are planning a trip to the UK you no longer need a test before you fly but you do still need to take one at some point during the first two days of your arrival. This must be booked in advance as you also are required to enter the booking reference number on the UK government locator form, which must be completed before you check in for your flight. I used a company called Randox; it was a fairly easy process - they delivered a self-test kit to the address I was planning to stay at in England, and gave me the option to drop it for free in one of their many collection boxes dotted across the UK, or mail it back to them at my expense. I chose to send it via the Royal Mail 'Special Delivery' overnight service which cost £6.75. I was a bit scared as have read so many horror stories about how unreliable the post office is at the moment, so I was very impressed that they managed to get it from London to Belfast in less than 16 hours! I received my (negative) test result back that same day and then I was good to go. All in it cost roughly £50 including postage.

Another good option is

to get the Day 2 test when you land at the airport. Heathrow has a test centre onsite and I am sure that many other airports do too. Perfect for those of you would rather get it out of the way as soon as you arrive, prices start at £69 so it actually doesn't cost that much more, although if you are a family of 4 it will soon start to add up.

You are still required to take a test before your return to the USA. The CDC's current guidelines for international arrivals are as follows:

• All air passengers coming to the United States, including U.S. fully citizens and

vaccinated people, are required to have a negative COVID-19 test result no more than 3 days before travel or documentation of recovery from COVID-19 in the past 3 months before they board a flight to the United States.

After travel:

- Get tested with a viral test 3-5 days after travel.
- Self-monitor for symptoms; COVID-19 isolate and get tested if you develop symptoms.
- Follow all state and local recommendations or requirements after travel. If you are not fully vaccinated follow the guidelines above you have to quarantine for 7 days after arrival no matter what your test

You can visit CDC. gov for further guidance.

I have booked my UK to USA preflight test with DocHQ (https://dochq. co.uk) for £29.75, although I am having second thoughts about this one as it apparently requires me to take the test at home via a video chat with one of their representatives. However, they do get 5 stars on Trustpilot!

I have managed to get to the grocery store and stocked up on a few British treats and plan to give some away as prizes at our weekly Pub Quiz at the Market Tavern. Dykes saves Scottish blushes

England's path to the 2022 World Cup hit an unexpected stumbling block when they were held to a 1-1 draw by Hungary on Tuesday in a qualifier Gareth Southgate called a "big disappointment".

The game was marred by crowd violence between Hungary fans and stewards and police.

Southgate's side are still in pole position to reach Qatar but this was a disjointed display despite England taking on the Hungarians with an attacking line-up.

The early stages at Wembley were overshadowed by ugly scenes involving Hungary fans, who jeered England's players while holding up a banner protesting against taking the knee before clashing with police and stewards.

In a subdued atmosphere and after a semblance of order had been restored, Hungary took the lead in the 24th minute when Luke Shaw was penalized for a high challenge on Loic Nego and Roland Sallai sent Jordan Pickford the wrong way from the spot.

England were level before half-time, John Stones turning in at the far post after Tyrone Mings and Declan Rice touched on Phil Foden's free-kick.

Hungary then survived in relative comfort, Harry Kane's struggles for form summed up when England's captain was substituted even though they were searching desperately for a winner.

"I don't think we played at the level we have done and Hungary defended very well. We didn't do enough to win the game," Southgate told BBC Radio 5 Live.

"I don't know if subconsciously we thought this was going to be an easier game because we beat them comfortably [4-0] in September but they've been very good defensively right through the summer.

"In the first few minutes we were taking heavy touches and colliding into tackles. We didn't show the composure and quality that we have done generally."

Foden and Grealish had their moments although Mount was quiet as England lacked the attacking thrust to apply serious pressure and break down a wellorganised Hungary defence.

It was a surprise when Grealish was replaced by Bukayo Saka just after the hour. It certainly came as a surprise to many in the Wembley crowd who loudly registered their disapproval, although Saka was given a rapturous welcome.

With Kalvin Phillips injured and Jordan Henderson on the bench, England's attack-minded selection left them more open to a counter-attack. Hungary did threaten on occasions but they were not good enough to accept the invitation. Better teams might so Southgate has certainly been given food for thought and will learn lessons from this.

England are still on course to go to Qatar but this was a disappointing

performance in what was a largely dull encounter, with most of the attention sadly focusing on the clashes between Hungarian fans and police and stewards moments after the kick-

This was a highly unsatisfactory night all round, although Hungary celebrated their hard-earned point after the final whistle.

England are three points above second-placed Poland with two qualifiers to go next month.

"We're in a very strong position in the group but tonight is a big disappointment," said Southgate. "We have to make sure we get it right next month."

England need four points from a home game with Albania and trip to San Marino.
