William launches Earthshot awards

■ Royal's honors takes aim at climate change and Earth's most pressing challenges

Celebrities joined Prince William in London on Sunday for the inaugural awards ceremony of his Earthshot Prize, an ambitious environmental program that aims to find new ideas and technologies around the world to tackle climate change and Earth's most pressing challenges.

The winners Sunday announced included the government of Costa Rica, which was honored for a project that pays local citizens to restore natural ecosystems, and the city of Milan, which was handed a prize for its Food Waste Hubs program, which recovers food from supermarkets and restaurants and distributes it to those in need.

at Alexandra Palace in
north London.

Guests were asked to "consider the environment when choosing their outfit," and Watson arrived wearing a gown made from 10 wedding dresses from the charity Oxfam. Kate wore an Alexander McQueen dress made for her in 2011, while her husband wore a dark green velvet blazer and a polo neck.

'amazing ideas'

William and his charity, The Royal Foundation, launched the Earthshot Prize last year, inspired by President John F. Kennedy's 1962 "Moonshot" speech that challenged and inspired Americans to go to the moon.


The prize, to be awarded to five winners every year until 2030, is billed as the most prestigious of its kind. Each winner will receive a grant worth 1 million pounds (\$1.4 million) to develop and scale up

their ideas.

"There's been lots of amazing ideas over the past decades but it's the implementation that really counts, so that's what this is all about. So it's really a reason to be cheerful," Thompson said.

The other winners were a land-based coral farm in the Bahamas to restore dying coral reefs; a green hydrogen technology developed to transform how homes and buildings are powered; and an India-based technology that creates fuel from agricultural waste in a bid to stop crop burning.

William has said he wanted the initiative to inject some optimism into the climate debate, and on Sunday he urged young people not to give up hope for the future.

Tributes flow for murdered MP

■ Sir David Arness described as "a dedicated constituency MP" and "the best bloke I ever knew".

MPs this week delivered emotional tributes to Conservative MP Sir David Amess, who died last week after he was stabbed in his Essex constituency.

At a special session in the House of Commons on Monday, Prime Minister Boris Johnson hailed him as a "seasoned campaigner of verve and grit" and a "steadfast servant" of his voters.

Labour leader Sir Keir Starmer praised a "dedicated constituency MP" who "held his beliefs passionately but gently".

Fellow Essex MP Mark Francois called him "the best bloke I ever knew".

Sir David, 69, who was the MP for Southend West, had been meeting constituents when he was stabbed multiple times on Friday.

A 25-year-old man was arrested on suspicion of murder after the attack at a church in Leigh-on-Sea. Police are treating the killing as a terrorist incident.

MPs observed a minute's silence earlier, and most of Monday's scheduled business was cancelled to allow them to deliver speeches in Sir David's memory.

Opening the tributes, Mr Johnson said the "tragic and senseless death" of the father-of-five had left "a vacuum that will not and can never be filled".

Describing him as one of the "most gentle individuals" to have entered Parliament, he said his views "often confounded expectation and defied easy stereotype".

He praised his record as a campaigner on issues including learning disabilities, and endometriosis, an oftendebilitating condition affecting women.

And he announced that Southend would now be granted city status, in recognition of a long-running campaign Sir David had led as one of the town's MPs.

Sit Keir also praised Sir David's campaigning on behalf of the town, adding that "the people of Southend have lost one of their own".

He also said MPs had a "duty" to learn from the

way Sir David conducted himself, describing him as a politician who "held his beliefs passionately but gently".

Tory MP Mark Francois, who grew up in Basildon while Sir David was the MP there, said he was "hurting terribly" after losing his "best and oldest friend in politics".

He said Sir David had helped him gain election to Basildon District Council, adding: "Without him, I would never have become a member of Parliament."


He said Sir David would be remembered for his "Essex cheeky-chappy smile" and as a "doughty champion for Basildon and then Southend".

James Duddridge, the Tory MP for neighbouring Rochford and Southend East, told colleagues that was a "good friend" who inspired great loyalty.

Like others during the debate, he noted the role played by Roman Catholicism in Sir David's life, describing him as a "man of faith and convictions".

"Difficult winter" ahead as Covid cases spike upwards again

Daily cases have been above 40,000 for seven days in a row, with 43,738 new Covid cases reported on Tuesday.

Another 223 deaths have been recorded, the highest since March, although daily figures are often bigger on Tuesdays.

PM Boris Johnson has told the cabinet the UK faces "a difficult winter".

Under the government's winter plan, if the measures

are not enough to prevent "unsustainable pressure" on the NHS, then steps like making face coverings mandatory in some settings and introducing vaccine passports could be considered as part of Plan B.

The prime minister told ministers the government had "a plan in place to steer the country through this period" and that people should "continue to follow the guidance and get their jabs when called upon".

Downing Street said Mr Johnson had stressed that the government's autumn and winter plan "continues to keep the virus under control".

No 10 said the government was "not complacent" about rising cases but that, due to the vaccination programme, "the levels we are seeing in both patients admitted to hospital and deaths are far lower than we saw in previous peaks".

The seven-day average of new Covid cases in the UK has risen from around 34,000 a day at the beginning of October to 44,145 cases per day.

And the number of people in hospital across the UK who have Covid has risen by 10% in a week, from 7,039 on 11 October to 7,749 on Monday.

Queen Elizabeth turns down Oldie of the Year award because 'you are as old as you feel'

■ Age is just a number, says HRH

The 95-year-old queen has "politely but firmly" turned down an award for "Oldie of the Year," declaring she doesn't meet the criteria.

"Oldie of the Year" is handed out annually Oldie magazine recognize contributions of older people. But according to The Guardian, when the queen was asked if she'd accept that award this year, her assistant private secretary wrote back, "Her Majesty believes you are as old as you feel, as such the Queen does not believe she meets the relevant criteria to be able to accept, and hopes you will find a more worthy recipient."

Ultimately, the award went to 90-year-old actor and dancer Leslie Caron, and according to the Evening Standard, the Duchess of Cornwall was at the ceremony where it was presented. Awards chair Gyles Brandreth described the letter from the queen as "lovely," per the Guardian, adding,



"Perhaps in the future we will sound out Her Majesty once more."

Queen Elizabeth earlier this year celebrated her 95th birthday amid what she described as a "period of great sadness" following the death of her husband, Prince Philip. Philip, HuffPost notes, was once named Consort of the Year by Oldie magazine in 2011, and he joked at the time, "There is nothing like it for morale, to be reminded that the years are passing - ever more quickly - and that bits are beginning to drop off the ancient frame. TV chef Mary Berry has said she is "proud and honoured" to be made a Dame Commander for services to cooking, writing and baking.

Dame Mary was honoured on Wednesday by the Prince of Wales during an investiture ceremony at Windsor Castle.

As well as her 50year culinary and broadcasting career, the honour also recognises her charity work.

She said she would celebrate by "going home for a sandwich and the children are coming tonight."

The 86-year-old former Bake Off judge recently had surgery after breaking her hip following a fall in the summer.

Yet she was able to attend the ceremony alongside husband Paul Hunnings, a retired antiquarian bookseller.

'extremely proud'

Speaking after her latest royal engagement, she said: "I'm extremely proud and honoured. I just wish my parents were here - they're looking down and my children are quite excited.

After studying cooking in France and the UK, Dame Mary worked for a number of food industry bodies and wrote recipe pages of Housewife magazine.

Her first cookbook, The Hamlyn All Colour Cookbook, was published in 1970 and she has gone on to write more than 50 others, selling millions of copies around the world.

She became a household name to a new

generation of cake lovers thanks to her role as a judge on The Great British Bake Off, alongside Paul Hollywood, Mel Giedroyc and Sue Perkins.

"I thoroughly enjoyed being on Bake Off, I was there seven years. We were a great team Paul Hollywood, Mel and Sue - we enjoyed every minute," she said.

In her latest upcoming BBC series, the veteran broadcaster will come to the rescue of novice cooks hoping to impress a loved one.

She revealed she loves it when she meets people in the supermarket

who say they have successfully learned how to make her lemon drizzle cake or lasagne.

Aside from cooking, Dame Mary has committed herself to charity work down the years. Her youngest son William was killed in a car crash at the age of 19, after which she became a patron of Child Bereavement UK.

"I was lucky to have a very supportive family but there are many people who are not in that position," she said.

"Whether it's the siblings who are left or the husband or the wife, it's a hand to hold and to realise other people are in the same boat."

Motorist fined after CCTV confuses his number plate with woman's T-shirt

David Knight was baffled when he received a fine for driving in a bus lane in Bath - about 120 miles away from his home.

But the builder and his wife, Paula, who live in Dorking, Surrey, laughed when they examined the photographic evidence of their alleged infraction and saw a woman with the word "Knitter" on her T-shirt, which the computer had mixed up with Knight's registration plate, KN19TER.

The private registration on his Volkswagen van is a nod to his nickname, Knighter.

The penalty charge notice, issued by Bath and North East Somerset council, includes a CCTV photo of Pulteney Bridge in Bath, where the alleged contravention took place.

A second photo shows an image of a woman wearing a protective mask, handbag over her shoulder and T-shirt declaring "Knitter".

Paula Knight contacted the council to alert officials to their mistake and they agreed to cancel the £90 fine.

The alleged offence took place in June but Knight, 54, did not receive the penalty notice until last month.

Paula Knight, also 54, said the council call handler "burst out laughing" when she alerted her to the error.

"The fine had already gone up from £60 to £90 because we hadn't paid within 30 days," she said. "Obviously no one had looked at the picture and it had been computergenerated."

She added: "We've been laughing about it a lot. There was no way I was going to pay for a woman walking in a bus lane with a funny T-shirt on.

"I wanted him to say, 'I am sorry, Pen'. He didn't, he just said, 'For God's sake you are pathetic, get on with it and go back to bed'," she said.

"It was just like, 'Pass the sugar'. I was in utter despair. I looked at him and said, 'I have done nothing wrong, admit you are sorry'.

"He literally couldn't be bothered - it was utter contempt."


She said she stabbed Mr Jackson once, and went to the kitchen to write a note confessing to the crime.

After that, she told the court, Mr Jackson went to get the phone to call the police and mocked her as he did, saying of the stabbing - "you couldn't even do that right, you're pathetic".

Mrs Jackson said her husband continued to goad her as he spoke to the 999 call handler, and she stabbed him again.

When asked by Clare Wade QC, defending, if she had intended to kill Mr Jackson, Mrs Jackson said she had not.

Life-saving doctor savors being a hero to the Gallowgate

A hospital doctor who performed CPR on a stricken Newcastle United fan has admitted that hearing thousands of Gallowgate End fans chanting "hero" was one of the best moments of his life.

Sunday's match against Tottenham Hotspur was stopped in the first half for about 20 minutes as it became clear there was a medical emergency in the stands. Tom Prichard, an A&E consultant at the University Hospital of North Tees in Stockton, was identified as one of the people who helped save the elderly Newcastle fan's life. He took over performing CPR on the unnamed man who had gone into cardiac arrest.

Prichard told BBC that he could see fans calling for stewards and first aiders so he went over to help. "It's something you see at work fairly often but I haven't really had it outside the hospital before," he said.

Others had started the CPR before Prichard, who added: "We gave the guy a shock through the defibrillator and he was quite fortunate this guy because very quickly an intensive care doctor arrived, a cardiologist arrived and we were able to bring him back again."

Prichard said he had no idea the game had been stopped. When it was over he was given a standing ovation by fans with footage widely shared on social media. "I do want to say, this wasn't just me," he said. "I had another doctor

friend helping me out. St John's [Ambulance] were brilliant, the Newcastle club doctor was there helping, so it really wasn't just me. But what I will say is when I was

walking back to my seat and 10,000 fans were chanting 'hero' at me, that was one of the best moments of my life."

Prichard said it was early chest compressions and early defibrillation which had saved the man's life.

Python's "Tired old stereotype" -Scousers see red after Cleese tweet

John Cleese caused something of an uproar in Liverpool this week by making a joke about the old stereotype that Scousers are thieves.

The 81-year-old Fawlty Towers star was responding to the news that car manufacturer Ford is investing £230m at its Merseyside factory.

Cleese tweeted: "Delighted to see Ford is creating 500 more jobs on Merseyside.

"Let's hope nobody half-inches the plant."

"Half-inch" is rhyming slang for steal (pinch). People from Liverpool are traditionally known as Scousers after the Scouse stew which originates from the area.

Many Twitter users responded to Cleese's tweet to say they were "disappointed" by the "tired old stereotype" and called it a "lazy joke".

"scousers are the best"

Scouserella tweeted: "Not all us scousers are thieves sick of being tarred with the same stereotypical brush. You get thieves everywhere but us scousers are the best, funniest and most kind hearted of all."

Ian McNabb pointed out that Liverpudlian and Beatle George Harrison's production company HandMade Films had financed Cleese's 1979 film Monty Python's Life of Brian. And another Twitter user accused Cleese of stealing a joke from the 1980s.

It was recently revealed that Cleese is set to front a new TV series exploring the phenomenon of cancel culture.

The Monty Python star will meet both those affected by being cancelled and those who are behind the cancelling in Channel 4 series John Cleese: Cancel Me.

He will question whether it is possible to make good comedy without offending someone, and look at the effects on the lives of people who have caused outrage with their work or comments.

It added that the offer for the space is "in excess of £750,000."





RON OF THOSE NIGHTS!

Cristiano Ronaldo headed the winner nine minutes from time as Manchester United came back from two goals down to record a memorable 3-2 Champions League triumph against Atalanta Trafford on at Old Wednesday.

Ole Gunnar Solskjaer's side had been booed off at the break, such was the lack of invention they showed in falling behind to goals from Mario Pasalic and Merih Demiral.

But the jeers turned to cheers as United, roared on by an increasingly frenzied crowd, rallied to complete one of their great European victories.

Marcus Rashford reduced the deficit with an excellent finish eight minutes after the restart before skipper Harry Maguire drove home after being left free at the far post to get on the end of Edinson Cavani's flick.

But, inevitably, it was Ronaldo who won the game, just as he did three weeks previously against Villarreal. This time it was with one of his trademark headers as he rose to meet Luke Shaw's cross and find the bottom corner to send United to the top of Group F.

Brave enough to drop Paul Pogba following Saturday's defeat at Leicester, when United boss bemoaned his side's defending at setpieces and said something had to change, Solskjaer was rewarded by one of the Frenchman's midfield replacements going missing for the Atalanta opener before his side conceded a second at a corner.

From a position of limited danger, United were suddenly in loads of it, purely because Davide Zappacosta's overlapping run went completely unchecked as Scott McTominay failed to react. The low cross invited the finish, which Pasalic duly applied from inside the six-yard box.

It was the fifth time in seven home Champions League games under Solskjaer that United had fallen behind. For the second, Demerai simply wanted it more as he climbed highest at a corner to power in the second, with both Shaw and Maguire ineffective in response.

There had been agitation before the half-time whistle, which brought a lot of boos, before the singing section close to the tunnel offered more positive support, which Solskjaer acknowledged as he made his way towards the dressing rooms.

United tore into their opponents and both Ronaldo and Rashford could have scored before the England man did, converting a brilliant pass from Bruno Fernandes by opening his body up and finding the far corner.

McTominay hit a post and Ronaldo had another shot saved as United continued to build pressure, in much the same way as Sir Alex Ferguson's great teams used to when they found themselves in a spot of bother.

The problem is Ferguson's teams tended

to be defensively secure. Solskjaer's most definitely is not and David de Gea needed to make acrobatic saves to deny Luis Muriel and Ruslan Malinovskyi at a point when had they conceded again, United would surely have lost.

As it was, they survived,

regrouped and - with Pogba, Jadon Sancho and Cavani introduced - went again.

Maguire's finish had plenty of feeling behind it. So had Ronaldo's celebration as he sank to his knees and did a double fist-pump after once more becoming the United hero.

With Liverpool, Tottenham, another meeting with Atalanta and Manchester City to come before the next international break, noone can be too sure where United go from here.

West Ham impress again in Europe

As West Ham took a significant stride towards the Europa League knockout stage with victory over 3-0 Genk, on Thursday, forward Jarrod Bowen said "teams will be fearing us".

David Moyes' side maintained their 100% record after three games and comfortably sit top of Group H, six points clear of second-placed Dinamo Zagreb, who were beaten 2-1 at Rapid Vienna.

The Hammers had the majority of the possession but barely threatened in the first half until Craig Dawson looped home a header from Aaron Cresswell's cross on the

stroke of half-time.

They took total control with two goals in the space of two minutes just before the hour mark.

Issa Diop headed in via the crossbar from another fine Cresswell delivery, while Jarrod Bowen cut in from the right and fired in shortly after, though goalkeeper Maarten Vandevoordt will be disappointed at not keeping the low drive out.

Bowen told BT Sport: "The main thing is topping the group. The home games are vitally important. We want to win away too.

"If we can stay strong, keep the confidence then I think teams will be fearing us. We could be the team to look out for. We're only a few games away from a big cup run.

"We'll keep pushing. We're winning games so that makes the players keep wanting to put the performances in."

West Ham were rampant and Nikola Vlasic could have converted a quick-fire fourth, but his shot from the edge of the six-yard box was blocked.

Genk were left to rue Paul Onuachu's big chance in the first half when he beat goalkeeper Alphonse Areola to a cross, but sent his header wide of an open net.
