



CHARLES: 'we're in the last chance saloon' to fight climate change

DELIVERING a speech to world leaders in Rome ahead of the COP26 climate summit in Glasgow this week, Prince Charles did not mince his words on the state of the climate crisis.

The heir to the throne said the summit was "quite literally the last chance saloon".

While acknowledging that progress had been made to reduce global emission, he stressed that there is still a long road ahead.

He said: "We have to reduce emissions urgently and take action to tackle the carbon already in the atmosphere".

Putting a value on carbon to incentivise carbon capture solutions is "absolutely critical", the prince said, while also noting that our "efforts cannot be a series of independent initiatives running parallel".

Commenting on how to give developing countries a helping hand with the costly conversion to renewables, he said we "need a vast military

style campaign to marshal the strength of the global private sector".

He added: "the cost of inaction is far greater than cost of prevention" and urges world leaders to find practical ways of overcoming differences so that "we can all get down to work together to save this precious planet".

The prince also met Amazon founder Jeff Bezos, who later posted on Instagram:

"The Prince of Wales has been involved in fighting climate change and protecting our beautiful world for five decades - far longer than most.

"We had a chance to discuss these important issues on the eve of #COP26 - looking for solutions to heal our world, and how the BezosEarthFund can help."

Prince Charles has long been an environmental enthusiast and has dabbled in unorthodox methods to give nature a helping hand - including his recommendation of talking to plants to help them grow.

BoJo warning

Boris Johnson had earlier warned the world faces "absolute catastrophe" if leaders fail to strike a deal to tackle the problem.

The PM said the stakes were high as he beat the drum for action ahead of the COP26 summit.

He said the UN gathering would be the "world's moment of truth" that would decide the future of our planet.

Mr Johnson wants a timetable to limit global warming by shutting down coal-fired generators, switching to electric cars and investing in green

technology.

He conceded he faces a "tough" battle to get 200 nations on board and rated his chance of success at barely 60-40.

But he vowed to "keep alive that dream"

of limiting climate change to 1.5C - for the sake of all humanity.

Using the G20 summit in Rome as a springboard to the talks, Mr Johnson declared: "COP26 will be the

world's moment of truth.

"The question everyone is asking is whether we seize this moment or let it slip away.

Attenborough urges world leaders to 'turn tragedy into triumph'

■ "If working apart we are a force powerful to destabilise our planet, surely working together we are powerful enough to save it,"

British naturalist Sir David Attenborough has urged COP26 climate summit delegates to "turn tragedy into triumph" and tackle climate change.

In an impassioned speech which drew a standing ovation, he said the fate of future generations must give delegates the impetus "to rewrite our story".

The 95-year-old warned that humanity was "already in trouble" because of rising carbon levels in the atmosphere.

More than 120 world leaders are in Glasgow for the two week summit.

The COP26 conference

is seen as crucial to limit global temperature increases, and changes to the climate.

The world is now about 1.2C warmer than it was in the 19th Century - and extreme weather events like heatwaves, floods and forest fires are already becoming more intense.

'already in trouble'

The 2015 Paris climate conference called for average temperatures to rise by well below 2C, and preferably only 1.5C, when compared to pre-industrial averages.

But unless more is done, the planet is already on track to warm by more than 2C by the

end of this century.

Sir David spoke for seven minutes alongside screens showing a graph that tracked the rise of carbon concentration in the Earth's atmosphere.

That number - which Sir David said was "the clearest way to chart" the story of humanity - currently sits at close to 414 parts per million. According to the Greenhouse Gas Bulletin, that is now 149% of the pre-industrial level.

"Our burning of fossil fuels, our destruction of nature, our approach to industry, construction and learning, are releasing carbon into the atmosphere at an

unprecedented pace and scale," he told the conference. "We are already in trouble."

He also criticised wealthier nations, saying this was also a story of inequality and that "those who've done the least to cause this problem are being the

hardest hit."

The naturalist however said people were "the greatest problem solvers to have ever existed on Earth" and called on leaders to think of the younger generation as they work to address climate change.

"If working apart we

are a force powerful to destabilise our planet, surely working together we are powerful enough to save it," he said, before concluding, "In my lifetime I've witnessed a terrible decline. In yours, you could and should witness a wonderful recovery."

"I hope world leaders will hear them and come to Glasgow ready to answer them with decisive action.

"We need to recognise the scale of the consequences if we fail.

"The difference

between restricting the growth in temperatures to 1.5C and allowing them to increase by 4C is potentially absolutely catastrophic for our children, our grandchildren and succeeding generations. We cannot discount their welfare.

"Together, we can mark the beginning

of the end of climate change - and end the uncertainty once and for all."

stumbling block

Mr Johnson and wife Carrie visited the Colosseum, where he gloomily predicted the best he can hope for by any action agreed is to slow the increase in

global temperatures.

His biggest stumbling block is the fact that China — responsible for more than a quarter of all carbon emissions — decided not to attend the

summit in the first place.

The communist giant plans to build 43 new coal power plants and 18 blast furnaces, adding 1.5 per cent to its emissions, despite a pledge to be

carbon neutral by 2060.

A massive 58 per cent of its energy is generated from coal as the world is being urged to switch to more expensive green power.

Yorkshire suspended over racial slur response

Yorkshire have been suspended from hosting England matches as the England and Wales Cricket Board delivered a devastating rebuke over the club's response to racism experienced by former player Azeem Rafiq.

An investigation found Rafiq was a victim of "racial harassment and bullying" - but the club said it would take no disciplinary action.

The ECB board says the ban will last until the club has "clearly demonstrated that it can meet the standards expected".

Meanwhile, a number of members of the

Yorkshire board are set to announce their resignations on Friday before an emergency board meeting, according to multiple sources.

The ECB said it was "clear" Yorkshire's handling of the issue was "wholly unacceptable and is causing serious damage to the reputation of the game".

A statement said: "Given recent events, it is clear there are serious questions regarding the governance and management of YCCC."

Rafiq accused several former teammates, including former England captain Michael Vaughan and batsman Garry

Balance of using racial language towards him.

Vaughan vehemently denied the charges. The BBC pundit explained that he had been accused of saying to Rafiq, Adil Rashid, Ajmal Shahzad and Rana Naveed before a 2009 game: "[There are] too many of you lot, we need to do something about it."

However, Vaughan vehemently denies the accusation. "I completely and categorically deny that I ever said those words," he said. "I have been involved in cricket for 30 years and never once been accused of any remotely similar incident

Tributes flow for Lionel Blair

■ Veteran actor, dancer and entertainer dies aged 92

Lionel Blair, the veteran actor, dancer and entertainer, has died at the age of 92, his agent has reportedly said.

Born Henry Lionel Ogus, he grew up in Stamford Hill, north London after his family moved from Canada, worked on television as an actor, tap dancer, presenter and choreographer across a seven-decade career. He died on Thursday morning surrounded by his family, his management company said.

The entertainer went on to work in the West End but decided to give up acting in 1947 during which he took up his stage name Lionel Blair.

In the 1960s he rose to stardom by being part of variety shows as part of his dance troupe in addition to appearing in films including *The Limping Man*, *A Hard Day's Night* and *The Beauty Jungle*.

He will perhaps be most remembered as one of the team captains on *Give us a Clue*, a gameshow based on charades which aired from the 1970s until the 1990s.

Blair also wrote a musical based on Tolstoy's *War and Peace*, which toured around the UK for six months.

tributes

In recent years, he made appearances on shows including *Celebrity Big Brother* in 2004 and *The Real Marigold Hotel*.

He married Susan Blair in 1967 and the couple have three children.

Blair fed his early passion for performing while sheltering from air raids during the second world war. When it began, he was

evacuated from north London to Oxford with his sister Joyce and mother Deborah.

However, the family's stint in the countryside did not last long and they returned to London after witnessing a German plane crash leading to his father, Myer, calling them back to the capital.

"If that can happen there, what's the point of being in the country away

from each other?" Blair said his father told him.

His father's parents were Russian, though Blair described him as "the archetypal north London barber". Blair was 13 when his father died after going in for surgery on a hernia and duodenal ulcer.

Tributes have been paid by numerous celebrities on social media. Christopher Biggins, TV

or disciplinary offence as a player or commentator.

"I have nothing to hide. The 'you lot' comment never happened. Anyone trying to recollect words said 10 years ago will be fallible but I am adamant those words were not used."

But Ballance has admitted that he used a racial slur towards his former teammate and that he regrets doing so.

Ballance, who played

23 test matches for England between 2014 and 2017, said that he "deeply regret[s] some of the language I used in my younger years" and that he and Rafiq share an "incredibly close relationship."

In a statement published on the Yorkshire website on Wednesday, Ballance said: "It has been reported that I used a racial slur and, as I told the independent enquiry, I accept that I did so and I regret doing so."

star and friend of Blair, said they often spoke on the phone. He told BBC News: "He was just the most wonderful, kind, funny, real giver of life. His energy was extraordinary."

He said Blair had a "great sense of humour" and is a "tribute to his wonderful family", describing him as the "king of the pantomime" and a man who was "adored" by the public.

'Phenomenon'

The standup comedian Ed Byrne tweeted: "One of the highlights of my short-lived Saturday morning radio show on BBC London (which I co hosted with my mother) was when we had Lionel Blair as a guest.

"Smoking fags and

knocking back gin and tonics with us at 11am. We even got him to tap dance on a sheet of plywood. Legend," he said.

The author Emma Kennedy tweeted: "I am very glad I got to meet Lionel Blair.

"He was a Phenomenon. Full of magical, fruity, end with a wink anecdotes. What a career. What a talent. RIPLionel."

Danny Baker, the broadcaster, wrote on Twitter: "A true chum, an entertainer beyond compare, an archive of a golden era, an immeasurable talent.

"Impossible to think he won't be in some Green room somewhere, dropping names and living out fantastic tales. A Giant. Really."

The actor Julian Clary tweeted: "RIP dear Lionel Blair. A showbiz trooper if ever there was."

In an interview with the Guardian in 2013, the entertainer discussed the secret behind his long marriage to Susan. He said: "The secret of a successful marriage is memories.

"You must have memories together.

"That's why my dad insisted that we went everywhere together, so we could talk about things.

"I'm so lucky to have a wife who is a nest builder. Her nest is the most important thing in the world to her."

The actor maintained a coyness over his true age and once famously said: "I am 59 plus VAT."

Ginger rolling in green: Ed Sheeran tops wealthiest under 30 list yet again

■ Singer/songwriter's fortune estimated at £236m
 ■ Harry Styles a distant second at £80m

Ed Sheeran has been named the richest British star under 30 for **THIRD** year in a row with his £236m fortune while Harry Styles retains second place with £80m.

Now in its eleventh year, the Rich List from Heat magazine reveals Britain and Ireland's youngest and richest stars.

Styles, 27, placed second, racking up a whopping £80m, while Jesy Nelson, 30, found herself on the list for the first time since leaving Little Mix this year, pocketing £13.5m.

Little Mix found themselves in third place, banking £66.7m. In the decade since winning X Factor, the group has sold over 60m records.

1D: coining it

Ex band member Jesy's £13.5m earnings saw her swoop into 19th place.

Niall Horan found himself two slots behind former bandmate Harry, with the Irish star's £57.5m earnings landing him in fourth place on the list. Most of his profits hail from his 1D days, however the 28-year-old also increased his earnings with solo music and business investments.

In fifth place was Cara Delevingne (£52m), whose company Cara & Co turned over profits of £9.6m last year.

Louis Tomlinson and Liam Payne placed joint sixth place with £47m each while Zayn Malik was not far behind, banking a tidy £38m, which earned him ninth place on the list.

With 43.5m to her

name, hit-maker Dua Lipa was in eighth place. Not only was the star's Future Nostalgia album a world-wide hit, but she's also secured high-income partnerships with Versace, YSL, Puma and Evian.

In tenth place was Sam Smith with £36.8m. Not only has the singer sold over 30m albums worldwide, but he recently picked up £183k for singing his

hit Stay With Me at the Las Vegas wedding of a casino heiress.

Notable new entries outside of the top ten include Scottish singer Lewis Capaldi at 16 - who despite claiming to have less than £200 in his bank two years ago, now has £17m.

Despite just being 17, actress Millie Bobby Brown of *Stranger Things* fame stands at number 25 with £7.2m.

Coleen Rooney set to sign £1m deal for Wagatha Christie film about Rebekah Vardy row

Coleen Rooney is set to sign a £1million deal to make her "Wagatha Christie" battle with Rebekah Vardy into a film.

Coleen, 35, is being sued for libel by Rebekah, 39, over accusations that her former friend leaked stories from her private Instagram account to newspapers.

The film will document all of Coleen's evidence against Rebekah in order to "let the public make their own minds up", reports the Mirror.

According to Coleen's friends, she would be "front and centre" of the film.

The movie could be streamed on Netflix or Amazon as producers

Lorton Entertainment - who are also making her husband Wayne's documentary - are in "very advanced talks".

The row between Coleen and Rebekah, wife of Leicester striker Jamie, began in October 2019 when Coleen posted her accusations regarding the leaks.

'online sleuthing'

A friend of Coleen told the *Mirror*: "Coleen has remained quiet ever since that famous online post. But this could all change in what could be the TV event of the year.

"Viewers would see all the evidence that Coleen has forensically gathered via her online sleuthing and see why she is convinced that

Rebekah leaked the stories about her and others.

"She is minded to get it all out into the public domain and let people make their own minds up. Talks are very well advanced."

While Coleen tends to avoid being in the limelight, the TV deal could mark a drastic change in strategy.

The friend said: "Coleen is thinking long and hard about her next steps and the time could be right to stick her head above the parapet.

She feels she has a very strong case and wants to share it with the world."

The libel case could cost the loser millions of

pounds.

Coleen's lawyer says her legal bill will be £537,000 while Rebekah's is estimated to be £838,000. A friend of Coleen stated that any move on TV would "undoubtedly" be seen as a "hostile act"





WORTH A BINGE: Sex Education on Netflix may keep you glued to the screen

If you haven't yet cottoned on to *Sex Education*, the British comedy-drama recently released its third season on Netflix, you are missing a real treat.

Set in the leafy fictional town of Moordale (and shot in and around Ross on Wye, Wales). The show follows the lives of the students, staff and parents of the fictitious Moordale Secondary School as they contend with various personal dilemmas, often related to sexual intimacy. It features an ensemble cast that includes Asa Butterfield, Gillian Anderson, Ncuti Gatwa, Emma Mackey, Connor Swindells and Kedar Williams-Stirling.

The show has (quite rightly, IMHO) has received critical acclaim, with particular praise for its ensemble cast, writing, directing, production values, and mature treatment of its themes. The series has been a viewership success, with over 40 million viewers streaming the first series after its debut.

The show centers on the will-they-won't they stuttering romance between the nerdy, kind and empathetic Otis Milburn (Butterfield)

and the troubled but fundamentally decent Maeve Riley (Emma Mackey). The pair start up a sex therapy clinic in the school, initially to make money but thereafter because of the huge demand among their fellow students – and because the pair can't keep away from each other.

Otis begins the series ambivalent about sex, in part because his single mother Jean (Gillian Anderson) is a sex therapist who frequently has affairs with male suitors but is unable to maintain romantic relationships.

Other students at Moordale include Eric Effiong, Otis' best friend and the gay son of Ghanaian-Nigerian immigrants; Adam Groff, the headmaster's son who develops a bullying nature out of his own self-loathing; Jackson Marchetti, the head boy struggling to meet the high expectations set for him; Ruby Matthews, Anwar Bakshi and Olivia Hanan, members of a popular clique known as "The Untouchables"; and Aimee Gibbs, an Untouchable who secretly befriends Maeve; and Lily Iglehart, an eccentric girl determined

to lose her virginity. The school is later joined by Ola Nyman, whose widowed father Jakob begins a relationship with Jean.

The teen coming-of-age genre is a beloved staple of TV, and yet *Sex Education* spins its own super-intelligent slant on growing up by showing how millennials are changing their attitudes to sex, sexuality and relationships, beyond the comprehension their parents. The show develops in tone and depth beyond its initial easy comic setup; at its heart is the notion that the problems, frustrations and disappointments of teenagers are as real and valid as those of the so-called grown-ups.

The story arc of Otis and Maeve could easily run out of steam by halfway through the one series, but thanks to a painstaking examination of numerous subplots and supporting characters, this show kept me enthralled while I binge watched all three seasons last month.

Netflix have announced a Season Four of the show is in the works, and we can't wait. But we will have to, probably till this time next year.

Sigh...

A VERY SPURSY START FOR CONTE

■ Europa Conference League: Spurs edge five goal see-saw battle as three players see red

Antonio Conte was given a highly eventful introduction to life as the new Tottenham Hotspur manager as they survived a scare before securing a 3-2 Europa Conference League victory over Vitesse on Thursday.

In a match that saw Spurs reduced to 10 men and the Dutch Eredivisie side to nine, Spurs threatened to throw away an early three-goal lead before eventually scrambling over the line.

The Italian received a warm welcome after succeeding the sacked Nuno Espirito Santo and Spurs looked to be giving Conte the perfect start as they went three goals up inside the first half hour.

Son Heung-min drove home the first goal of the Conte reign after 14 minutes, with Lucas Moura racing clear to add a second eight minutes

later. Jacob Rasmussen looked to have put Spurs out of sight when he bundled into his own net under pressure from Harry Kane.

frailties

Spurs then displayed their frailties to the new manager as Rasmussen rose to head home from a corner before Matus Bero's cool finish reduced the deficit further before half-time.

Vitesse were a danger throughout the second half, with home keeper Hugo Lloris saving superbly from substitute Lois Openda and Riechedly Bazoer.

Spurs lost Cristian Romero when he was sent off for a challenge on Openda but Vitesse's momentum was halted when captain Danilho was shown a second yellow card for hauling down Kane.

Keeper Markus Schubert then quickly followed for handling outside his area as he ran out to clear from Emerson Royal.

At the end of it all, Spurs gave Conte the win he wanted to move them into second place behind Rennes in Group G.

Conte will have plenty to ponder and work on after a patchy Spurs performance. He will have been pleased by the energy and invention shown in those early stages but concerned about how vulnerable Spurs looked when pressure was applied.

Son was a stand-out performer as Spurs looked likely to run riot but the latter part of the first half and after the break suggested Conte will need to focus on fitness and confidence before Sunday's visit to Everton.

He selected his favoured three at the back employing Romero, Eric Dier and Ben Davies but Spurs were troubled by the pace of Vitesse, also conceding sloppily from a set-piece when Rasmussen started the

Vitesse fightback.

Conte watched intently from the touchline, urging his players on and celebrating goals with the gusto that endeared him so much to Chelsea fans during his highly successful spell at

Stamford Bridge.

In the end, the best Conte would have hoped for was a win after only a couple of days at Spurs and at least they delivered that, even if this was a display that still left plenty of question marks.
