# DOOM AND GLOOM!

With inflation and fuel costs soaring, millions of Britons are now facing biggest drop in living standards for decades

**MILLIONS OF Britons are facing huge financial uncertainty this year, as the nation faces the worst drop in living standards for decades.**

Chancellor Rishi Sunak's mini-Budget this week did little to ease their fears, offering only a 5p cut from fuel duty to ease the crunch, which will do little offset the rapidly rising cost of petrol and natural gas, and the growing spectre of inflation, which has risen to a 40-year high.

Mr Sunak preferred to look on the bright side as he unveiled his plans, as he wiped £6billion from the tax bills of millions of lower-paid workers by raising the National Insurance threshold.

Telling voters the Government is "on their side", he also axed VAT on green house improvements and promised to cut a penny off income tax, from April 2024. But his handouts came as analysts predicted rampant inflation and downgraded growth over the next two years.

Former pensions minister Sir Steve Webb said: "I am genuinely shocked that the Chancellor has done nothing at all for pensioners."

Home heating bills are soaring and inflation has

rocketed to 6.2 per cent – but the state pension is being increased by just 3.1 per cent. One leading retirement policy specialist commented that many older people "won't have been planning to install solar panels" and a lot do not drive, so they were forgotten in Mr Sunak's handouts.

### 'total commitment'

The Chancellor had declared to MPs: "My tax plan delivers the biggest net cut to personal taxes in over a quarter of a century."

The Household Support fund was doubled, with an extra £500million for councils to help the most vulnerable. In a move made possible by leaving the EU, the Chancellor scrapped VAT on some energy-saving products.

He said: "We are no longer constrained by EU law, so I can announce that for the next five years, homeowners having materials such as solar panels, heat pumps and insulation installed will no longer pay five per cent VAT; they will pay zero."

The cut amounts to

£280million over the five years. He offered support for businesses by raising Employment Allowance from £4,000 to £5,000, letting small firms reduce their National Insurance payments in a measure worth around £500million a year.

Mr Sunak also rejected demands from Tory backbenchers to cancel April's 1.25 per cent NI rise – intended to boost funding for the NHS and adult social care system: "When I said the Conservatives were the party of public services – the party of the NHS – I did not just mean when it was easy; it is a total commitment. So it is right that the health and care levy stays, but a long-term funding solution for the NHS and social care is not incompatible with reducing taxes."

The Chancellor said in his keynote financial speech: "For the first time in 16 years, the basic rate of income tax will be cut from 20p to 19p in the pound – a tax cut for workers, for pensioners and for savers, and a £5billion tax cut." He said

his measures showed the Government will "stand by" hard-working households and build "a stronger, more secure economy".

Forecasts published by the Office for Budget Responsibility showed prices are set to surge further with inflation

predicted to average 7.4 per cent this year.

Mr Sunak later told listeners to LBC radio he was "working day and night" to help people hit by the soaring cost of living: "I'd say judge me by my actions."

Asked if he was embarrassed to call

himself a tax-cutting Chancellor while the overall burden was increasing, he replied: "I'm also the Chancellor that had to deal with a once-in-a-century pandemic. I have to deal with the world as it is, not as the way I would like it to be."

### SCOTLAND: new high for Covid hospitalizations

The number of people in hospital with Covid in Scotland has hit the highest level seen during the pandemic, as the same figure in two regions in England is also surging.

The latest figures reveal 2,128 hospital patients in Scotland recently tested positive

for the virus, compared to a previous peak of 2,053 in last January.

The figures come as most of the remaining legal Covid restrictions in Scotland have come to an end.

Last week Nicola Sturgeon announced that laws requiring masks to be worn on

public transport and in some other settings in Scotland will not be scrapped as planned due to the "current spike" in COVID cases.

Across the UK as a whole, 14,948 people with COVID were in hospital on 18 March, up 22% from the previous week.

# Boris confident he will not be fined over Partygate scandal

■ "The PM's pretty clear he's obeyed the law."

**BORIS Johnson is confident he will not be fined for lockdown breaches, a close colleague said this week.**

Tory party chairman Oliver Dowden insisted the Prime Minister was not concerned about the police probe into Downing Street parties.

He spoke out following reports that police have begun interviewing leading witnesses.

He said: "The Prime Minister is actually, absolutely, resolutely clear that he is not going to be subject to a fixed

penalty notice because he is confident that he's not broken the law.

"The PM's pretty clear he's obeyed the law."

Mr Dowden added: "I speak to the Prime Minister a lot, as you might imagine as party chairman. That is not where his mind is.

"I've been spending an awful lot of time discussing Ukraine, cost of living and so on. We are genuinely getting on with the job with dealing with that – and that's where our focus is."

A Downing Street

source said the PM has not been interviewed by police investigating the so-called "partygate" allegations.

The Met said more than 100 questionnaires have been sent out so far to people at the alleged gatherings, which have to be completed and returned in seven days.

Police investigators have started reviewing available evidence but have not yet made any referrals for potential fines to be issued.

The Metropolitan Police said: "The offences

under consideration comprise a number of elements and the legislation changed between the event dates.

"We are progressing

the investigation as quickly as possible. As yet, we have not made any referrals for issuing of fixed-penalty notices."

The force is probing

12 events, including as many as six which Mr Johnson is reported to have attended. Mr Johnson faced calls to quit over partygate.

## Britain to supply Ukrainians with 'better missiles'

**UKRAINIAN troops are to be given "more accurate" British missiles that can destroy helicopters from four miles away.**

The laser-guided STARStreak and Lightweight Multirole Missile (LMM) provide commanders with fresh ways to repel Russian air assaults.

STARStreak can be carried by a soldier and is the world's fastest surface-to-air missile, hitting its target at Mach 3 – three times the speed of sound. It is also harder

for defensive flares to jam it.

The LMM explodes up to 10ft from its target, giving a wider margin of error.

Like the anti-tank weapons already provided to the Kyiv regime by Britain, STARStreak lets troops take cover immediately before and after attacking.

Col Graham Taylor, Commander of 7th Air Defence Group, said: "How effective that is, depends on the quality of the training and depends

on how the Ukrainians will want to work with it.

"It is not like a Stinger [another surface-to-air missile]. A Stinger is an infrared, heat-seeking 'fire and forget' munition. The HVM [STARStreak High-Velocity Missile] is more complex in its aiming unit. At the same time, it is much more accurate. It is an extremely useful piece of kit."

Sgt Skee Sauligia, 42, of 12th Regiment Royal Artillery, who has trained with both missile systems, said: "They are

both efficient. They can both do the job."

Britain is also deploying a "game-changing" piece of defence kit to Ukraine's northern neighbour Poland – the Sky Sabre missile system.

Its radar can detect aircraft, missiles and smart bombs up to 74 miles away while its missiles have an improved range of 15 miles, giving defenders more time to repel air attacks.

Sgt Alex Henry, 42, of 16th Regiment RA said: "It is also programmed for future air threats."

Col Taylor added: "This is a defensive deployment and purposefully is protecting Polish airspace."

## Blow to living standards 'worst for seven decades'

**FAMILIES will be clobbered by the biggest hit to their living standards since the 1950s, the UK fiscal watchdog has said.**

Household spending will fall dramatically in the next year due to sky-high inflation and slower economic growth, according to the Office for Budget Responsibility (OBR).

The crisis represents a bigger hit than families suffered during the pandemic or the 2008 financial meltdown.

It is also a worse blow than the recessions of the 1990s or 1980s, and the oil shocks of the Seventies. In a bleak assessment, the OBR slashed its economic growth outlook and predicted inflation could

reach 8.7 per cent later this year – the highest for 40 years.

It is now forecasting gross domestic product to rise by 3.8 per cent in 2022, down from its six per cent forecast.

The OBR said real household disposable incomes will plunge by 2.2 per cent per person in 2022-23, the largest fall since official records began in 1956-57, and won't recover until 2024. And it warned: "The uncertain course of the invasion of Ukraine and international sanctions brings with it the prospect that energy prices could rise further than markets (and therefore our forecasts) currently assume... driving inflation close to double digits and GDP 0.8

per cent lower in the near term."

Mr Sunak admitted the OBR forecasts do not take into account the full impact of the war in Ukraine. He said: "We should be prepared for the economy to worsen."

The OBR forecasts that interest payments on UK debt will rocket to £83billion in 2022-23 due to soaring inflation and rising interest rates, the highest on record.

Borrowing is also set to soar to £99.1billion in 2022-23, the OBR warned. However, this will fall to £31.6billion by 2026-27.

Mr Sunak said: "By 2024, the OBR expect inflation to be back under control, debt falling sustainably, and the economy growing."

## On tour couple face calls for slavery apology

THE Duke and Duchess of Cambridge this week faced angry calls to apologize for the Royal Family's historic profiting from slavery in Jamaica.

William and Kate were met with protests as they arrived on the Caribbean island on the second leg of an eight-day tour to mark the Queen's Platinum Jubilee.

Some called for Britain and the Queen to pay reparations for the historic involvement of successive monarchs in the slave trade, going back to Elizabeth I.

### 'respectful way'

Mark Golding, Jamaica's leader of the opposition, called for William and Kate to apologize in an interview with the country's newspaper,

The Gleaner.

He said: "I would hope that I get the opportunity during the events I will be attending to have that dialogue with them and to bring it to their attention in a courteous and respectful way that this is the view held by many Jamaicans."

"And that I think it would be helpful both to the Royal Family and Jamaica for them to consider this as a means of starting to move forward to a new future."

The tour has been used to stir up calls for the country to become a republic. William is expected to echo his father Prince Charles in condemning slavery as a stain on the world's history during the couple's stay. But he is likely to stop short of a full apology.

## Cardiff man becomes world's first to be cured by Covid vaccination

A MAN forced to isolate from his family for nearly eight months after catching Covid has become the first person in the world to be cured by vaccination.

Ian Lester, 37, who has a genetic immunodeficiency, tested positive back in December 2020, beginning a seven-and-a-half-month battle with chest tightness, headaches and fatigue.

Ian could not get a jab when immunocompromised people were first eligible as he was still testing positive.

But scientists at Cardiff University then decided to give him two doses of Pfizer's jab to help his immune system

fight back.

His Covid levels plunged 64-fold within a fortnight of the first jab, and Ian, from Pontypridd, was finally rid of it last August, 72 days after his first vaccine.

The case report published in the Journal of Clinical Immunology shows his body's T-cell response also became stronger.

He said: "I was over the moon and beyond relieved to finally be negative."

The royal couple had been mobbed by crowds chanting: "We love you, we love you" as they walked to Trench Town Culture Yard and Museum.

William earlier played football with England's Kingston-born star Raheem Sterling, Aston

Villa and Jamaica winger Leon Bailey, and some local league players. William played despite forgetting his training shoes. Wearing a number 10 yellow vest, he set up Sterling to score from

The visit to the former home of Marley, who died in 1981 aged 36, and the football match celebrated the singer's twin passions. When

Villa fan William met Sterling and Bailey, he told Kate: "Two heroes of mine."

Sterling, 27, was given a pass from for England training to be at the match.

## PM tells allies: we must stick together

BORIS Johnson has vowed to work with Western allies to tighten the pressure on Vladimir Putin and is said to be keen to visit Ukraine.

In a conference call with US President Joe Biden and other world leaders, the Prime Minister agreed to maintain "wide-ranging and coordinated sanctions" on the Russian regime.

Afterwards, a Downing Street spokeswoman said: "The Prime Minister underlined his horror at President Putin's use of increasingly brutal tactics in Ukraine, such as siege warfare and the targeting of civilians."

"He welcomed the unity of allies standing steadfastly against

Russia's reprehensible behaviour, noting how effective collective action has been in undermining Putin's war machine."

French President Emmanuel Macron, German Chancellor Olaf Scholz and Italian premier Mario Draghi also joined the call.

The spokeswoman added: "The leaders affirmed their ongoing commitment to support Ukraine militarily, diplomatically and economically, equipping the democratically-

elected government in Kyiv with the tools it needs to defend itself.

"They also resolved to increase the pressure on Russia to halt its unprovoked invasion, including by maintaining wide-ranging and coordinated sanctions."

Of Mr Johnson's plans to visit Ukraine, Tory Party chairman Oliver Dowden, said: "I think the Prime Minister is desperate to go to Ukraine and has throughout this conflict felt a real

emotional connection with the suffering of the Ukrainian people."

Mr Dowden said the Prime Minister, who has spoken to Ukrainian President Volodymyr Zelensky almost every day during the crisis, wanted to "see what's going on, on the ground".

He added: "I should say that no decisions have been taken in relation to this."

Downing Street officials say there are "no plans" for Mr Johnson to visit Ukraine.

# “You’re not getting shot: this is England” - brave bystander tells of confronting accused killer

A BRAVE bystander who confronted the alleged terrorist accused of murdering Sir David Amess told him: “This is England, mate – you’re not getting shot,” a court heard on Wednesday.

Ali Harbi Ali, 26, said he wanted to be killed by police after he stabbed the MP to death at a constituency surgery, jurors were told.

But Good Samaritan Darren King assured him: “You’ve come to the wrong country because they do that in America. We’re in England, mate.

“I said, ‘Why do you want to die?’ “He said: ‘I’m going to die a martyr, I’m going to die a hero.’”

Mr King said he replied: “No, you’re just going to be dead.”

Shortly afterwards Ali was arrested by two plain clothes PCs armed only with batons and incapacitant spray.

Ali stabbed Sir David 21 times with a 12-inch

bladed carving knife at the Belfairs Methodist Church, Leigh-on-Sea, Essex, last October in an alleged revenge attack for the bombing of Syria. In a police interview played to the Old Bailey, Mr King said he considered trying to overpower Ali.

He said: “You wanna work out whether you can beat him or not. I weighed up his build, my build; he had a knife, I hadn’t.”

### ‘blood on the knife’

He added: “I could see David in the corner, he was crumpled up on the floor. I could see some blood, a gentleman standing there with a knife in his right hand threatening to stab me, and I could see some blood on the knife.”

Mr King said he then heard a woman on the phone to Ali, who he believed to be the defendant’s sister, discussing Iraq and

Syria.

Mr King and partner Yvonne Eaves arrived at the church shortly after the horrific attack. Ms Eaves said Ali “was not remorseful” and had “a look of, ‘I have achieved something.’”

The MP’s aide Rebecca Hayton told police Ali sent mobile messages during his appointment. When Sir David asked if he was recording the meeting, Ali put the phone down and it rang.

Ms Hayton said: “He stood up, looked at me and said, ‘Sorry, for the phone’. He reached inside his coat and pulled a knife from his jeans. He leaned over the desk and stabbed David straight in the stomach. I saw it go in once, and as I got up, he kept going.”

Sir David’s PA Julie Cushion said she dialled 999 after hearing Sir David let out a “piercing scream”.

Jurors heard Ali, 26,

lied in an email to Ms Hayton. He claimed he was a healthcare worker, new to the area, who “wanted to get to know” his MP. It is alleged Ali considered other MPs as targets, including Levelling Up minister Michael Gove, and Labour leader Sir Keir Starmer.

Ali, of Kentish Town, North London, denies murder and preparing an act of terrorism.

The trial continues.



## 5,500 kids on NHS waiting list for sex-change treatment

SOME 5,500 children are on an NHS waiting list for sex-change treatment after demand soared in lockdown.

Campaigners voiced their fears after the number of youngsters seeking to change gender rose by a fifth.

The 5,500 are in the queue for treatment at London’s Tavistock and Portman Trust’s Gender Identity Development Service (GIDS).

Stephanie Davies-Arai, founder of the Transgender Trend campaign group, said that was “concerning”.

“Children do not have the life experience to know how to

interpret what they are often experiencing. They’re bombarded with messages about being trans and that all of their problems and insecurities and anxieties are because they’re trans.

“They think these adolescent anxieties are down to being trans. They are sent down to the Tavistock and put on puberty blockers. It is easy to fall into this trap and it has been made worse by Covid.”

Trans issues campaigner Baroness Nicholson of

# Friends and family bid farewell to the legendary Shane Warne

**FAMILY, friends and former teammates gathered in Melbourne this week to say goodbye to one of the cricket's all-time legends – Shane Warne.**

Around 80 guests including the Australian star's three children, their mum – Warne's ex-wife Simone Callahan, 52 – and his parents Keith and Brigitte joined the service at St Kilda Aussie rules football club, his favourite team.

Ex-England captain Michael Vaughan and retired Australian skippers Michael Clarke, Mark Taylor and Allan Border were among the mourners. Son Jackson, 22 – one of the pallbearers

– his sisters Brooke, 24, and Summer, 20, heard football commentator Eddie McGuire, who led the service, salute their "superman" dad.

He said: "He did the things you dreamt of doing as a kid. The magic part about Shane Warne was that he sprinkled his gold dust everywhere he went."

Guests, who also included bowling great Merv Hughes and TV star Dannii Minogue, were asked to raise their glasses "high in the sky" to Warne.

The casket – draped in two St Kilda scarves – was then driven around the oval. As a boy Warne dreamed of a career in

the Australian Football League and played for St Kilda under-19s. But in 1988 coaches kicked him out, saying he too slow and unfit.

Time of My Life from Dirty Dancing was played before the hearse left the ground to Tina Turner's Simply The Best.

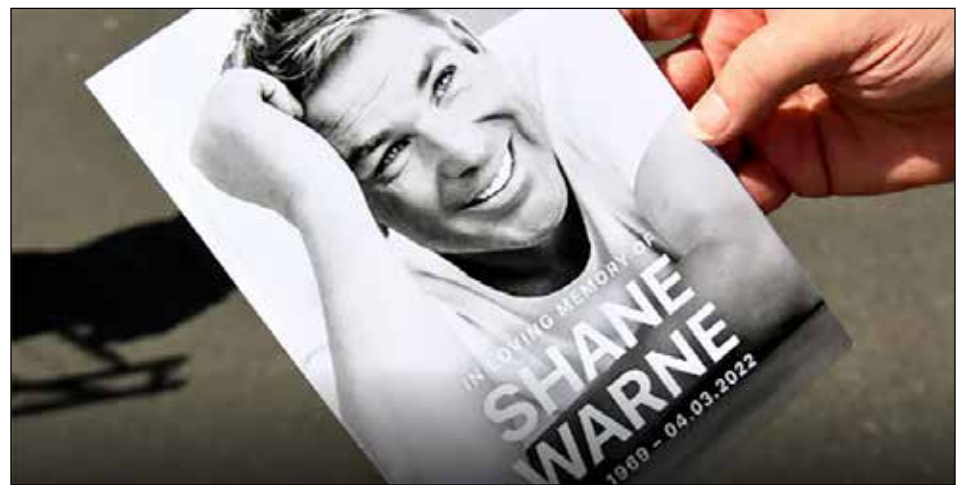
Liz Hurley, 56, the superstar's former fiancée, could not make the sent-off as she was working.

Warne died in Thailand of a suspected heart on March 4, aged 52. A state funeral will follow on March 30.

assessment of children who want to change gender.

Senior figures at Tavistock have expressed fears that "the list had grown substantially during the lockdown". Trust chairman Paul Burstow, a former Liberal Democrat health minister, said the growing waiting list was a "preoccupation" for

trustees.

The figures are a big rise on an estimate made last year.

In January 2021 the Care Quality Commission (CQC) said after inspecting GIDS there were 4,600 on the list. It saw a spike in cases from 138 in 2010/11 to 2,383 ten years later.

At the start of the last decade, most children referred for treatment were male-born, but female-born youngsters now dominate.

The CQC found numerous failings after

whistleblowers raised concerns that GIDS fails to support vulnerable children properly and has pushed them towards sex-change treatments.

A recent review found doctors felt under pressure to adopt an unquestioning approach to children seeking to change their sex, while a lack of formal clinical guidance and stifled debate left many medics "nervous" about offering the "more robust support" they want to deliver.

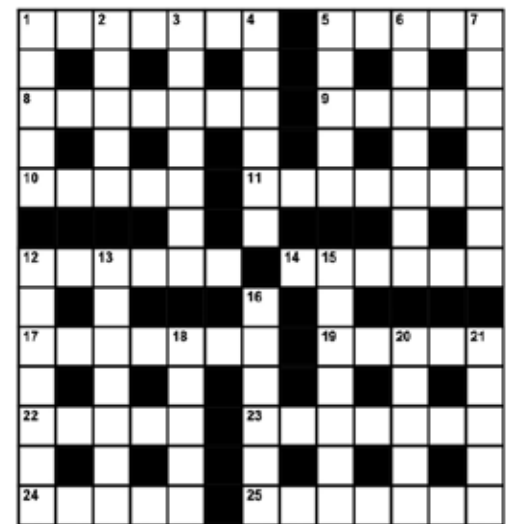

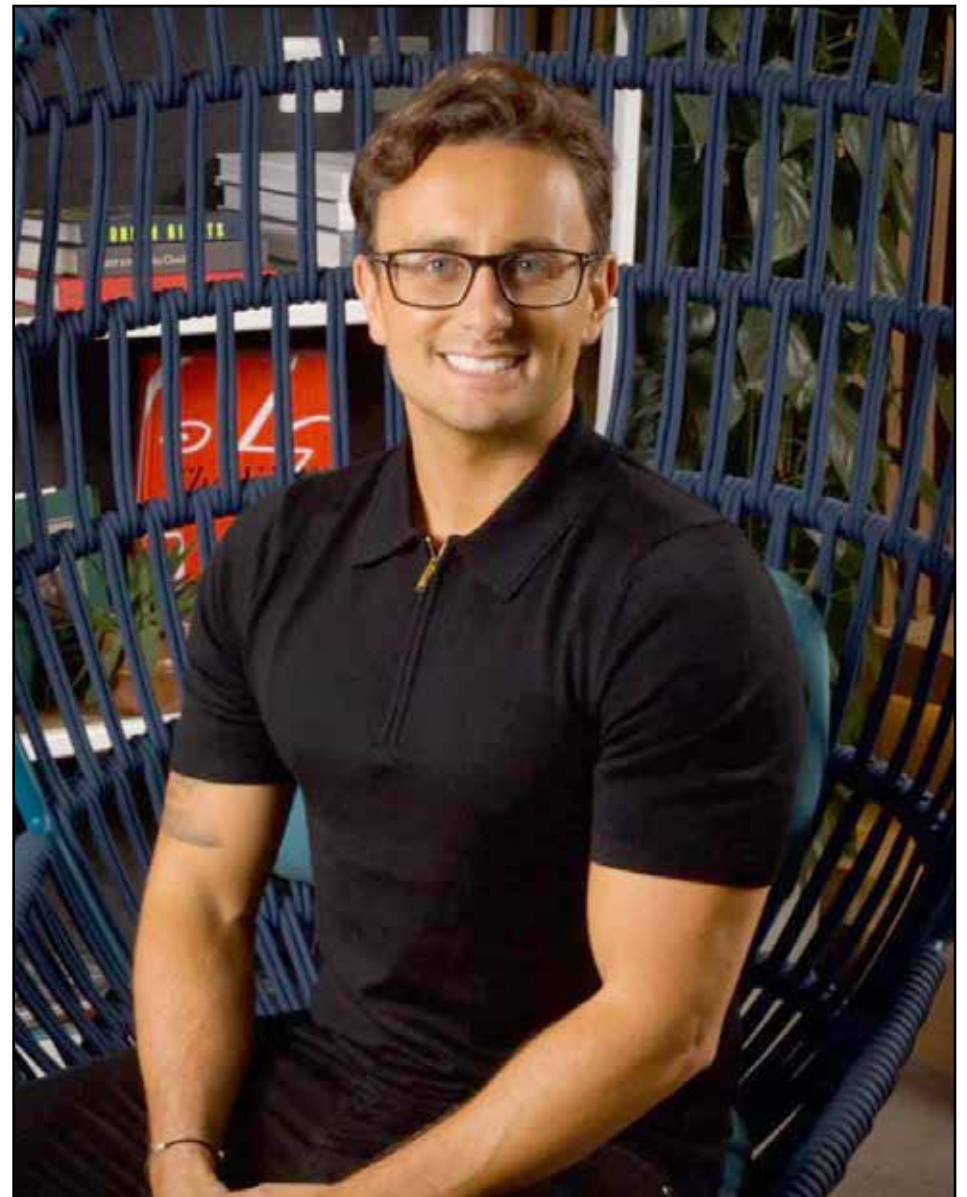
### What was your first impression of LA and has it changed since?

# Brilliant Bale bags a brace

■ Wales edge Austria 2-1 to put themselves one win away from first World Cup appearance since 1958

Gareth Bale scored two brilliant goals in a vintage individual performance on Thursday to take Wales a step closer to qualifying for their first World Cup since 1958 with victory over Austria in their play-off semi-final.

Austria's Christoph Baumgartner hit the crossbar in the fifth minute before Bale's majestic free-kick sparked ecstatic celebrations for an already thunderous home crowd in Cardiff.

Wales' captain struck again early in the second half, shooting beautifully on the turn from a short corner.

Marcel Sabitzer's deflected shot brought Austria back into the game and, although the visitors exerted sustained pressure, Wales stood up to the challenge with a stoic defensive display.

Wales will now face Scotland or Ukraine in their play-off final, a one-off tie which was meant to be played next Tuesday, but which has been postponed because of Russia's invasion of

Ukraine.

Scotland and Ukraine's fixture is expected to be played in June, with the play-off final set to follow later the same month.

The details of that one-legged final are yet to be confirmed but, for now, Wales can savour this win in the knowledge that they are one victory away from ending their 64-year absence from World Cups.

The 32-year-old has only played two hours of football for Real Madrid in the past six months and the build-up to this game was dominated by conjecture about his fitness, while the captain himself has mentioned that this might be his final World Cup campaign.

But his first goal was the Bale of old. A direct free-kick - the first he had scored for Wales since Euro 2016 - 25 yards out and hit with vintage precision, dipping just enough to clip the bar on its way in to send the Red Wall into raptures.

There were chances to extend Wales' lead before half-time - such as

Ramsey's shot well saved by Lindner - and it was Bale again who provided the inspiration after the break.

From a short corner, Williams swung in a low cross which Davies touched into Bale's path and Wales' all-time leading scorer took his tally to 38 with a fierce drive into the top far corner.

As Wales fans sang Don't Take Me Home, the soundtrack of their run to the Euro 2016 semi-finals, while they watched a Bale masterclass, it felt like that golden summer in France revisited.

This has been the most successful period in Wales' history, with the national team qualifying for back-to-back European Championships and soaring to the semi-finals of Euro 2016.

Yet despite the record-high world rankings and heroic contributions from Bale, Ramsey and others, World Cups have remained elusive.

The 1958 tournament in Sweden is still Wales' only appearance at a

World Cup and, since then, they have frequently and painfully fallen at the final hurdle.

When Sabitzer's shot deflected off Ben Davies

and bobbed into the Welsh net, a sense of anxiety swept around Cardiff City Stadium as supporters began to wonder if this was to

be the latest setback in a history littered with similar tales of anguish, from Scotland in 1977 to Romania in 1993.

## Pogba questions wasted years

PAUL POGBA has all but confirmed his summer exit from Old Trafford with a blast over his wasted years at Manchester United.

The France star has delivered a stinging assessment of his time at the club while on international duty. And he did not spare either the club, facing a season "dead" in the water, or interim manager Ralf Rangnick, who he slammed for playing him out of position.

Pogba said: "The last five seasons have not satisfied me - really not at all. This year it is dead, we won't win

anything. Whether it is with Manchester United or at another club, I want to win trophies."

United are locked in a three-way battle with Tottenham and Arsenal for a top-four spot and a place in next season's Champions League, during which they will need everyone pushing in the same direction.

Yet Pogba's relationship with Rangnick now looks strained to breaking point and, with the player set to walk out of Old Trafford on a free in the summer, his commitment may be in question. The midfielder has been played in a

succession of positions under Rangnick.

And Pogba said: "It's simple with France, I play in my position - I know my role and I feel the confidence of the coach and the players.

"It's normal to feel a difference at Manchester United because it's hard to be consistent when you often have a change to your position, or the team system, or your partners. I get along very well with France boss Didier Deschamps, he gave me a role that I know, but at Manchester United do I really have a role?"

"I ask the question but I don't have an answer."
