Harry silence raises eyebrows

■ Royal tensions stoked yet again as Prince refuses to say if he misses his brother and father

Prince Harry has further stoked Royal tensions by refusing to say if he missed his father and brother – and was pointedly non-committal over attending the Queen's Platinum Jubilee.

As his grandmother turned 96 on Thursday, Harry told an NBC interview at the Invictus Games in the Netherlands he did not know if he would return to the UK.

Questioned by Hoda Kotb in The Hague where injured veterans are competing in the Games, he delivered a series of damning barbs.

After the Duke said he missed his wife Meghan and their children Archie and Lilibet, the Today Show host asked him directly: "But do you miss your brother, your dad?"

Prince Harry replied: "Look I mean, for me at the moment, I'm here fo-

cused on these guys [Invictus competitors] and these families and giving everything that I can, 120 per cent, to them to make sure they have the experience of a lifetime."

He added: "That's my focus here. And when I leave here, I get back and my focus is on my family who I miss massively."

Asked to clarify if he will attend the Queen's anniversary celebrations, Harry, 37, shot back: "I don't know yet. There's lots of things with security issues and everything else. So, this is what I'm trying to do, trying to make it possible that I can get my kids to meet her."

But in an extraordinary sideswipe, the Prince suggested pointedly he visited his grandmother at Windsor Castle recently to ensure she was surrounded by the correct staff: "I'm just making sure that she's, you know, protected and got the right people around her."

That was seen in Royal circles as a dig at the monarch's closest aides – including her private secretary Sir Edward Young, who was accused by Harry of failing to do enough to support his wife Meghan when she joined the Royal Family.

The relationship that the sixth in line to the throne has with Prince Charles and the Duke of Cambridge has been severely strained since long before he and Meghan, 40, quit their royal duties in March 2020.

The Queen has extended an olive branch by making it clear that the Sussexes plus Archie, two, and 10-month-old Lilibet, are welcome to join the rest of the wider Royal Family at some of her Jubilee events in the summer, possibly on the Buckingham Palace balcony.

But Harry – citing security issues over the Gov-

ernment's refusal to give him automatic access to specialist Scotland Yard bodyguards and intelligence – said he did not know if the family would fly in from their California home.

Asked to name the best thing about his gran, he said: "Her sense of humour and her ability to see humour in so many different silly things.

"We have a really special relationship, we talk about things that she can't talk about with anybody else.

"But I think after a certain age you get bored of birthdays."

When questioned if the monarch would be bored with her Platinum events, he laughed: "No, I don't think so.

"She's had a few jubilees now, everyone is slightly different but I'm sure she's looking forward to it. It was really nice to see her. To be able to see her in some element of privacy was nice. I hadn't had the chance to go back the UK for couple of years apart from those two times.

"One for my grandfather's funeral and one for unveiling a statue of my mum.

"I had tea with her. It

was really nice to catch up with her and, you know, home for me now is, you know, for the time being, it's in the States. And it feels that way as well."

Harry – who was seen enjoying the Games' indoor rowing competition with a woman spectator and baby yesterday – opened up about his mother, Princess Diana, saying: "It is almost as though she's done her bit with my brother and now she's very much, like, helping me.

"Got him set up. And now she's helping me set up. That's what it feels like, you know?"

"He's got his kids. I've got my kids, you know the circumstances are obviously different.

"But now, I feel her presence in almost everything that I do now. But definitely more so in the last two years than ever before. Without question. She's watching over us."

The Duke said he and Meghan had told Archie about his late grandmother, who was killed in a Paris car crash in August 1997:

"(We) tell him all the stuff that happened... This is Grandma Diana' and we've got cont. on page 4, col. 4

Queen extends olive branch

THE Queen has invited the Duke and Duchess of Sussex to appear on the Buckingham Palace balcony during her Jubilee – raising hopes of easing the royal rift.

Sources have suggested the monarch – who celebrated her 96th birthday on Thursday – is planning to make sure the wider Royal Family appear with her during

the double bank holiday celebrations in June to commemorate her 70 years on the throne. That opens up the possibility of Harry and Meghan joining in, as well as the Queen's disgraced son Prince Andrew and other non-working royals.

It is understood that it is her dearest wish to see her family reunited and for the Sussexes to

Are the Tories finally tired of Boris?

■ **PARTYGATE: Influential Tory William Wragg states 'no confidence' in PM**
 ■ **Authority of PM 'fatally damaged' as own MPs tell him 'the gig's up**

Boris Johnson suffered humiliating blows to his authority this week after MPs backed a formal investigation to look at whether he lied to parliament, and senior party figures made new calls for him to resign.

The prime minister will now be investigated by a Commons committee over claims he misled MPs about lockdown parties – a potential resigning matter under the ministerial code.

The move came after the government tried to delay the inquiry only to make a U-turn hours later amid a backlash.

Speaking during a Commons debate after chaotic scenes in Westminster on Wednesday the former Brexit minister Steve Baker, an influential figure among Conservatives, said he was appalled by Johnson's private attitude towards the fine he had received for breaches of Covid rules and said the prime minister "now should be long gone".

Others made clear that they had told Tory whips they would not block or delay a new Partygate inquiry.

And former health

secretary Jeremy Hunt told constituents he had warned whips he would not support moves to delay the inquiry.

'best time'

Hunt said in an email to constituents that he found the fines issued to Johnson and the chancellor, Rishi Sunak, "shocking and disappointing". "We will also now see the privileges committee investigate whether parliament was lied to," he wrote. "I made it clear to the government that I would not have supported any move to delay such an investigation had we been asked to. But in the end

thankfully, we were not."

He said he would not make a final judgment until the end of the process but did not believe now was the "best time" to change prime minister. While other prime ministers had been removed in wartime, "in this situation we only have to ask ourselves, would Vladimir Putin be happy to see a two-month leadership contest in Britain?" Hunt added.

The turbulence in Westminster threatened to overshadow the prime minister's trade trip to India, where he toured Ahmedabad as MPs debated his political future for four hours on the floor of the Commons.

Minutes before the debate about whether to refer Johnson to the privileges committee, government whips pulled their amendment – tabled on Wednesday evening – that would have delayed any vote on the investigation until after the final Sue Gray Partygate report was published.

The Labour motion was passed on Thursday although the privileges committee investigation will not begin for weeks

or months, once the police and Gray inquiries are complete.

'utterly depressing'

Johnson's press secretary, speaking during a trip to India, sought to suggest the prime minister was relaxed about being referred to the privileges committee, with "no concerns".

At the Commons debate, William Wragg, chair of the Commons' constitutional affairs committee, said he had written a letter of no confidence in the prime minister and that he would have rebelled if the government had not withdrawn its amendment.

He said: "We have been working in a toxic atmosphere. The parliamentary party bears the scars of misjudgments of leader-

ship. There can be few colleagues on this side of the house, I would contend, who are truly enjoying being members of parliament at the moment. It is utterly depressing to be asked to defend the indefensible. Each time part of us withers."

Steve Baker had previously told the Commons he had been prepared to forgive Johnson but said that the PM's bullish approach to the fines, in a private meeting of the 1922 meeting of backbenchers this week, had changed his mind. He said Johnson's contrition "only lasted as long as it took to get out of the headmaster's study".

Baker added: "I have to say I'm sorry, that for not obeying the letter and spirit – and I think we

have heard that the prime minister did know what the letter was – the prime minister now should be long gone. I'll certainly vote for this motion. But really, the prime minister should just know the gig's up."

The Conservative MP Anthony Mangnall said he could not forgive Johnson for misleading the Commons. "I do forgive the prime minister for making those mistakes but I do not forgive him for misleading the house, as I see it."

Tobias Ellwood, the Tory chair of the Commons defence committee, who has already called for the prime minister to go, tweeted that it was time for his colleagues "to stop drinking the Kool Aid".

Longest Covid infection 'lasted more than 16 months'

UK doctors believe they have documented the longest Covid infection on record - a patient they treated who had detectable levels of the virus for more than 16 months, or 505 days, in total.

The unnamed individual had other underlying medical conditions and sadly died in hospital in 2021.

Persistent infections such as this are still rare, say the London medics.

Most people naturally clear the virus, but the patient in question had a severely weakened immune system.

The patient first caught Covid in early 2020. They had symptoms and the infection was confirmed with a PCR test.

They were in and out of

hospital many times over the next 72 weeks, for both routine checks and care.

On each occasion - about 50 in all - they tested positive, meaning they still had Covid.

The doctors, from King's College London and Guy's and St Thomas' NHS Foundation Trust, say the patient could not shake the infection, even after being given antiviral drugs.

Maddie: German named as formal suspect

■ German police had previously said that Christian Brueckner, 44, was likely responsible for toddler's disappearance in 2007

A German man has been formally identified as a suspect in the disappearance of British toddler Madeleine McCann 15 years ago, Portuguese prosecutors have said.

Christian Brueckner, a convicted rapist, has been made an "arguido", translated as "named suspect" or "formal suspect" who is treated by Portuguese police as more than a witness but has not been arrested or charged.

The German's lawyer said that his client has not been charged over the case.

Prosecutors in Faro did not publicly name the man but said in a statement he

was identified as a suspect by German authorities at its request.

The timing of the move could be related to the country's 15-year statute of limitations for crimes with a maximum prison sentence of 10 years or more.

official suspect

Madeleine disappeared almost 15 years ago, on 3 May 2007, while on holiday with her parents in Praia da Luz in Portugal.

It is the first time that Portuguese prosecutors have identified an official suspect in the case since Kate and Gerry McCann, Madeleine's parents, were

named suspects in 2007. They were later cleared.

German police said in June 2020 that Madeleine was assumed dead and that Brueckner, 44, was likely responsible for it, however he has not been charged subsequently.

He is currently serving a sentence in Oldenburg prison, northern Germany, for raping a woman in 2005 in the same area of Portugal's Algarve region where Madeleine went missing.

cooperation

Brueckner has denied being involved in the disappearance of Madeleine, who went

missing a few days before her fourth birthday, as her parents dined with friends at a nearby tapas bar. Her

disappearance sparked one of the biggest searches of its kind in recent years.

Portuguese prosecutors

said the investigation has been carried out with cooperation from British and German authorities.

appear with her on the palace balcony.

At her Diamond Jubilee 10 years ago, there was a slimmed down balcony appearance of just the Queen, Charles, Camilla, William, Kate and Harry. The balcony idea may threaten fresh tensions in the family amid a continuing rift between the Duke and Duchess of Sussexes.

There were also concerns expressed by Prince Charles and William about any attempt to put Andrew in front of the cameras.

big family gathering

Palace officials are said to be working on the assumption that non-working members of the family, including Harry, Meghan and Andrew, will be invited to family

events.

This could include the balcony appearance after Trooping the Colour on June 2, and a national service of thanksgiving at St Paul's Cathedral for the Queen's reign on June 3.

But their thinking is that they will not be able to play a central role in official parts of the four-day bank holiday weekend, such as the main trooping ceremony marking the sovereign's official birthday. Harry, 37, and Meghan, 40, along with Andrew, 62, could also be invited to join the Queen at the Derby horse racing extravaganza at Epsom on June 4, if there is a big family gathering in the royal box for one of the monarch's favourite days of the year.

But with opinion polls showing that Andrew and Harry and Meghan are all deeply unpopular with ardent monarchists after the controversies of the past couple of years, there is also the risk of crowds

booing at the celebrations. Buckingham Palace declined to comment but sources played down any suggestion that anything had been decided.

"This hasn't come from us," one source said.

There are also several potential stumbling blocks.

legal dispute

It is likely that Harry, who has claimed it is not safe for his family to come to Britain, would have to back down in his legal dispute with Home Secretary Priti Patel over the Government's refusal to allow him and his family automatic taxpayer-funded police protection.

In the absence of that, he has asked to at least be able to pay for police protection or gain access to national intelligence.

But instead the authorities have said the risks posed to the Sussexes will be assessed on a case-by-case basis each time they intend to visit.

Last week, Harry and Meghan secretly visited the Queen at Windsor Castle.

They also met Charles and Camilla, opening up the possibility of some

fence-mending after a bitter family dispute over the Sussexes' claims that they were the victims of racism.

much-loved

Royal sources have suggested that, while the Queen and other senior member of the family do not accept the allegations, the Queen has tried to maintain ties with the Sussexes.

"They remain much-loved members of the family," said one source.

But it is understood aides are planning on a more traditional big family gathering on the balcony this time. Harry and Meghan have yet to say whether they would

like to come to Britain for the jubilee in June.

This week their office said they were not in a position to discuss future travel plans.

The latest family moves come amid increasing concern over the growing frailty of the Queen.

Aides have said she hopes to attend as many of her jubilee events as possible.

But it is likely she will only make fleeting appearances at a handful.

Palace officials are working on plans to allow her to arrive at St Paul's by a side entrance without being photographed, to avoid the indignity of having to struggle up steps.

For the horse racing at Epsom, it is expected she will arrive privately and be driven as close as possible to the grandstand before taking a lift up to her box. This would be instead of a more traditional grand arrival in front of the crowds.

The Duchess of Cornwall, who has taken a growing interest in the sport, is expected to be given pride of place alongside her at the Derby as her intended successor as the main royal patron of racing.

Prince Charles is expected to play a key role at most of the main jubilee events and will represent the Queen if she is unable to be there herself.

27 years on: man found guilty of murder of six year-old Rikki

■ James Watson convicted as new DNA techniques bring long quest for justice to an end

A 41-year-old man described as a “fantasist” and a “monster” has been found guilty of the murder of the schoolboy Rikki Neave, who was found strangled in woods near Peterborough nearly 28 years ago.

James Watson, of no fixed abode, was convicted by a jury’s majority verdict at the Old Bailey in London on Thursday of the 1994 murder after a DNA breakthrough in 2016 revealed that, as a 13-year-old, he had been in physical contact with the six-year-old boy on the day of his disappearance.

Watson, who has a long list of previous convictions – including sexual assault – evaded detection for more than two decades, changing his account of his interactions with Neave as evidence piled up against him.

The conviction brings to a close a cold case mystery in which Rikki’s own mother, Ruth Neave, was acquitted of his murder in 1996, removing suspicion that had haunted her since she pleaded guilty to a litany of shocking child cruelty offences against the boy, of which the jury in her murder trial were unaware.

Speaking after the

verdict, Neave described Watson as a “monster” and criticised the original investigation, saying police and social services “totally ruined mine and my daughters’ lives”.

‘victory’

She said: “The only thing now is to close this chapter in my life and open a new one. I wonder what Rikki would be like today. Married, children, who knows? But this monster has taken that all from me and my daughters.”

Rikki’s sister Rochelle Neave, 30, hailed the verdict as a “victory” for the family who had campaigned for justice. “He thought he’d got away with it for that many years and thought we were just going to go away and roll under the table. We weren’t.”

She remembered her brother as a cheeky and loving boy who would look after his sisters. Sheradyn Neave, the youngest of the siblings, who was a baby when Rikki died, added: “I think we were let down by the police at the time, we were let down by everyone who was in our lives who was meant to care.”

The jury deliberated for 36 hours and 31 minutes to convict Watson by a majority of 10 to two after an 11-week trial.

The judge, Mrs Justice McGowan, said Watson would be sentenced as if he were a teenager. That means he will receive a life sentence but the starting point for the minimum term will be 12 years. The defendant was not in court on Thursday but watched verdict on a video link.

‘morbid fantasy’

The prosecution said he lured Rikki to woods near his home in Peterborough on 28 November 1994 and strangled him from behind with a ligature or anorak collar to fulfil a “morbid fantasy” he had told his mother about three days before.

He stripped Rikki and posed his naked body in a star shape for sexual gratification, deliberately “exhibiting” him near a children’s woodland den, jurors were told. Rikki was reported missing that evening by his mother and found the next day.

Watson obsessed over newspaper coverage of the killing, photocopying front-page stories at school. The next month he was interviewed as a

witness by police after a person reported seeing him with Rikki on the nearby Welland estate. His lies went unchallenged as police wrongly focused on a theory that Neave killed her son and used a buggy to dump his body.

The mother of four was cleared of murder in 1996 but jailed for seven years after admitting child cruelty. The case was unsolved for more than 20 years until Watson’s DNA was identified on Rikki’s clothes, which had been recovered from a wheelie bin.





What would you suggest to others who are thinking about making the move here?



Finding Faith in the Abstract

New art show in Santa Monica explores the ancient symbols of faith that lead us all to the same place...

Last Sunday saw the first convergence of Easter, Passover and Ramadan for 30 years, which is perhaps the perfect symbolism for an art exhibit currently on view at the Santa Monica Airport.

Organized under the auspices of the 18th Street Arts Center, Collective Acts of Peace is a selection of projects with the state aim of 'exploring different embraces of the creative mind in the midst of an endless global pandemic.

The exhibition highlights the connections among creatives who strive to make this a better world for all living beings, humans and non-humans alike.' The exhibit is a melange of images from all the major religions and highlights the interconnectedness

of us all, no matter what our beliefs and backgrounds.

'like a gift'

Among the artists featured is Julia Michelle Dawson, whose collection is titled "Finding Faith in the Abstract". One of the most striking of her works is Gudrun's Cross, named after Julia's late Icelandic mother.

"The inspiration for these paintings felt like a gift, a gift from my departed mother," says Julia. "After her funeral, I made 5x7 little paintings of white crosses with blue/green backgrounds for the people who helped me with the service. There were twelve of them. When I pushed them together on my drafting table for them to dry, they created a beautiful

abstract of which I had no intent. I decided to expand them and do the same with other major religious symbols. This is how "Finding Faith in the Abstract" came to be."

Julia describes herself as an artist, author and adventurer. Her open mind and heart owe at least a little to her father, an Englishman from West Sussex who met Gudrun on a round-the-world cruise. The couple had their first date in Tokyo before moving to California. Julia was born in Napa and raised a true Californian with strong British roots. She loves to visit England when she can, and lists London's Green Park as her favorite place to visit because that's where her then-infant son took his first steps.

"What is most interesting to me about

the public's reaction to my work is that how surprising it can be," Julia told us this week.

"My father, who is suffering from Alzheimer's, looked at the Gudrun's Cross image and said it reminded him of that famous line from The Sound of Music, - 'When the Lord closes a door, somewhere he opens a window.'

secret symbol

Another striking image features a field of sunflowers with sky of fish-shaped clouds – a reference to the secret symbol of Christianity in the first century AD when the religion was outlawed. When two strangers met on the road and wondered if the other was Christian, one would draw an arch in the dirt. If the

second person finished the drawing of a fish by creating another intersecting arch, they knew they were amongst friends. The symbol of the fish was used by Greeks, Romans, and pagans so the drawing in the sand created little suspicion.

"Because of times in which we live, this image has drawn many responses," said Julia. "Most commonly it's 'you are doing this for Ukraine, right?'. Only then did I realize that the yellow and blue palette and the Sunflowers (the national flower of that country) made the Ukrainian connection so strong."

And then there is the religious symbol whose hijacking is perhaps the most egregious: the Swastika. For thousands of years prior to the time

of Hitler, the spiraling four-legged cross was a symbol of divinity and spirituality in Indic religions, including Native Americans and Buddhists.

"Hitler hijacked the symbol, flipped it around and gave it the opposite meaning. I think there is one thing we can all agree upon, we all wish he was admitted to art school, if he had, maybe the middle of the 20th century would have been a more peaceful place," Julia added.

The exhibit is on view in the Slipstream Galleries 18th Street Arts Center's Airport Campus (3026 Airport Ave, Santa Monica) now until June 4, 2022. There will be a reception featuring many of the featured artists on Saturday, May 21st from 5-8pm.

Ronaldo was absent from the 4-0 defeat.

"Me and my family will never forget this moment of respect and compassion," Ronaldo wrote on Instagram.

"One world... One sport... One global family... Thanks, Anfield."

Ronaldo and his partner Georgina Rodriguez announced the death of their baby boy on Monday, saying it is the "greatest pain that any parents can feel".

The 37-year-old and Rodriguez, 28, were expecting twins.

Their baby girl survived - and they said her birth "gives us the strength to live this moment with some hope and happiness".

Both United and Liverpool players wore black armbands in a mark of respect to Ronaldo and his family.

United confirm Ten Hag appointment

■ Struggling Premiership giants sign Ajax coach on three year deal

Manchester United have appointed Ajax coach Erik ten Hag as their next manager.

The Dutchman, 52, will take over from interim boss Ralf Rangnick at the end of this season on a three-year deal which can be extended by a year.

Rangnick, who replaced the sacked Ole Gunnar Solskjaer in November, is set to move into a consultancy role.

Ten Hag will become United's fifth permanent manager since Sir Alex Ferguson retired in 2013.

"It is a great honour to be appointed manager of Manchester United and I am hugely excited by the challenge ahead," said Ten Hag.

"I know the history of this great club and the passion of the fans, and I am absolutely determined to develop a team capable

of delivering the success they deserve."

United are sixth in the Premier League with five games remaining this season, three points behind Tottenham, who occupy the fourth Champions League spot.

Ajax are top of the Dutch Eredivisie - four points clear of PSV Eindhoven - with five matches left, although they lost to their rivals in the Dutch Cup final.

Ten Hag, who took over as Ajax head coach since December 2017, led them to the league and cup double in 2018-19 and 2020-21.

They reached the semi-finals of the 2018-19 Champions League and were within a minute of making the final, only to be denied by a remarkable Tottenham comeback.

United's choice had

narrowed to Ten Hag and Paris St-Germain boss Mauricio Pochettino, after Sevilla coach Julen Lopetegui had also been spoken to about the role.

Ten Hag is expected to bring in a former United coach or player as part of his backroom team, given it is unlikely the remaining link to the Solskjaer era, Mike Phelan, will remain at the club.

Ten Hag joined Ajax after two and a half years at Utrecht, having previously coached Bayern Munich's second team, where he worked with Manchester City boss Pep Guardiola.

Solskjaer was sacked following a 4-1 defeat at Watford that left United seventh in the table.

Since Rangnick officially took charge on 3 December, United have

a record of nine wins, six draws and four defeats in 19 league games.

They were knocked out of the Champions League in the last 16 by Atletico Madrid and lost

to Championship side Middlesbrough in the FA Cup fourth round.

After Tuesday's 4-0 league defeat by Liverpool, Rangnick said United might need as

many as 10 new players this summer.

Ten Hag wants ex-England coach and Ferguson's former assistant Steve McClaren to work with him.

The Serbian striker netted twice in the first half, sandwiching an eye-catching strike by teenager Fabio Carvalho.


