# Can't you take a joke?

■ Gervais fights back after drawing fire for making light of "taboo subjects" in Netflix special

**RICKY GERVAIS** this week fought back against his critics after suffering an avalanche of condemnation following the release of his latest Netflix special.

In SuperNature, the British comic makes a string of what he describes as ironic and satirical jokes about trans people, female comedians and Aids.

US LGBT rights group Glaad labelled the show "dangerous", "anti-gay" and "anti trans" after its release on Tuesday.

However, Gervais told the BBC on Tuesday that comedy is for "getting us over taboo subjects".

He said: "I think that's what comedy is for, really - to get us through stuff, and I deal in taboo subjects because I want to take the audience to a place it hasn't been before, even for a split second."

### 'taboo subjects'

"Most offence comes from when people mistake the subject of a joke with the actual target."

He said audience members go through a mixture of emotions when hearing a near-the-knuckle joke. "It starts and they go, what's he going to say? I tell the joke. Phew,

they laugh.

"It's like a parachute jump - it's scary, but then you land and it's all OK."

"I think that's what comedy is for - getting us over taboo subjects so they're not scary any more. So I deal with everything. And I think we second guess the audience too much."

However, Glaad took issue with his latest routine, with officials posting on the group's Twitter page: "It's full of graphic, dangerous, anti-trans rants masquerading as jokes. He also spouts anti-gay rhetoric an spreads inaccurate information about HIV."

### 'just jokes'

They also said Netflix "refuses" to enforce its own policy that content "designed to incite hate or violence" is not allowed on its platform.

In his special, Gervais explained that for each joke, he momentarily takes whatever stance would make it funnier - "without prejudice" - and that the gags do not represent his actual views.

"In real life, of course I support trans rights," he said. "I support all human rights and trans rights are human rights."

"Live your best life, use your preferred pronouns, be the gender that you feel that you are," he said before adding a punchline about trans women. He also referred to Eddie Izzard, who has identified as being gender fluid and has requested she/her pronouns.

Gervais also said "it's mad to think that joking about something means you're anti-it".

On The One Show, Gervais referred to his darkly comic Netflix series After Life, saying some had questioned whether the audience can "take this".

"Of course they can," he continued. "Real life is much worse. These are just jokes. They don't mean anything. They're just for you to laugh for an hour or so. So that's why I deal in taboo subjects."

### broader debate

His comments come amid a broader

debate around what is acceptable to joke about in a comedy.

Last year, some viewers and Netflix staff complained about a stand-up special by US comedian Dave Chappelle, which they said was transphobic.

English comedian Jimmy Carr was heavily criticised earlier this year for part of another Netflix special that included material about the murders of hundreds of thousands of people from Europe's traveller communities

in the Holocaust.

Earlier this month, the streaming giant reportedly told staff it supports "the artistic expression of the creators we choose to work with", and they could leave if they did not like it.

# “Humbled” Boris vows to focus on the big issues

## As ‘Partygate’ report ends as a damp squib, relieved PM vows not to spend ‘a second longer’ on the issue

A “HUMBLED” Boris Johnson has vowed to get on with tackling the big issues facing Britain after avoiding much of the criticism in the Partygate report.

The findings by top civil servant Sue Gray, finally published this week after months of speculation, failed to contain any explosive new disclosures about the PM’s behaviour – and even credited him with implementing reforms to tackle the boozy culture at No 10.

It all turned out to be something of a damp squib for the Labour Party, who had pinned their hopes on a condemnation for the PM’s conduct scathing enough to warrant his resignation.

In the end the worst it got for the man some have dubbed ‘Teflon Boris’ were some newly released photos of Johnson raising a can of drink in the Cabinet Office on his 56th birthday with a few staff.

Mr Johnson was fined £50 for attending the Downing Street celebration in June 2020,

at which Rishi Sunak and senior civil servant Simon Case were also present.

Packets of sandwiches, jugs of orange and apple juice plus a few cans of beer are on view.

After Ms Gray’s long-awaited report was published, Mr Johnson declared his Government will “move on” from the row, accepting that he has “learned a lesson”.

The PM said he was “humbled”, and apologised to MPs and to the country for the Covid lockdown breaches and for his leadership.

Mr Johnson continued: “I overwhelmingly feel it is my job to get on and deliver.

“No matter how bitter and painful that the conclusions of this may be – and they are – and no matter how humbling they are, I have got to keep moving forward and the Government has got to keep moving. And we are. We will get on and continue to do the tough things.”

He also vowed to focus on the public instead of spending “a second longer” on Partygate.



But opposition leaders repeated their calls for the PM to quit.

Labour leader Sir Keir Starmer urged Tory MPs to “finally do their bit” and oust the Prime Minister: “They must tell the current inhabitant [of No 10] – their leader – that this has gone on too long. That the game is up. That you cannot be a lawmaker and a lawbreaker. That it’s time to pack his bags.”

Justin Welby, the Archbishop of Canterbury, said: “Standards in public life are the glue that holds us together – we need to rediscover them and

abide by them.”

By week’s end it was clear that Tory backbenchers were backing the PM with only more one MP declaring he was sending a letter of no confidence in him to party chiefs.

Mr Johnson also apologized personally to Downing Street security

and cleaning staff after it was revealed that drunken aides were abusive.

Ms Gray’s report, covering 16 gatherings in Whitehall over 12 months from April 2020, revealed that some drinking sessions continued until after 4am with discarded bottles and mess left in

their wake.

One official vomited in an office and a fight also broke out.

Staff were drinking at parties in No 10 until the early hours on the eve of the Duke of Edinburgh’s funeral in April last year, with the last person exiting the back door at 4.20am.

## Former Tory MP jailed for sex attack on boy

FORMER Tory MP Imran Ahmad Khan was jailed for 18 months this week – after finally facing “a day of reckoning” for groping a 15-year-old boy in 2008.

The victim, now 29, had come forward days after Khan, 48, won his Wakefield constituency, in West Yorkshire, in the

2019 general election.

Khan – who still maintains his innocence – was expelled from the Conservative Party and resigned his seat, triggering a by-election set for June 23.

Following a trial last month, he was found guilty by a jury of sexual assault.

Jailing him for 18 months at Southwark Crown Court, Mr Justice Baker said Khan had shown no remorse. He added: “The only regret you feel is towards yourself for having found yourself in this predicament as a result of your actions some 14 years ago.”

# BLOOMIN' MARVELLOUS: buggy-borne Queen thrills crowd at Chelsea Flower Show

THE Queen surprised crowds at the Chelsea Flower Show this week by making a last-minute appearance – in a deluxe electric golf buggy.

Wearing a pink Stewart Parvin coat and with her stick by her side, the 96-year-old looked delighted as she was chauffeured around.

The six-seat all-weather Royal Household buggy, made by Danish firm Daria, has a top speed of 43mph and a range of 50 miles on its lithium battery.

Costing £62,000, it features mod cons like a fridge, bluetooth speakers and a 10-inch screen with weather updates.

Sitting beside the Queen and giving a commentary, was Keith Weed, president of the Royal Horticultural Society, which stages the event.

Sat facing the rear were Mr Weed's wife Kate and a lady-in-waiting, who held a number of bouquets given to the Queen. The beaming monarch, who has attended the London event more than 50

times, arrived at 5.35pm and stopped to speak to designers and other experts.

At one point she joked about the appalling weather in her Coronation year. At a garden designed to highlight deforestation, the Queen asked designer Danny Clarke how long it took to create. "Two and a half years," he replied. "Covid helped!" she laughed.

## Dracula fans take bite of new world record

IT WHAT was hailed as a 'fangtastic' effort, 1,369 would-be vampires gathered in Whitby this week to celebrate the 125th anniversary of the publication of the Bram Stoker's novel, *Dracula*.

As one witty newspaper editor wrote, there had been a lot at stake. After months of meticulous preparation, the idea was to set a world record for the most people dressed as a vampire at a place *Dracula* would surely call his spiritual home.

As the cape-bedecked and fang-baring crowds swept into the Gothic ruins of Whitby Abbey on Thursday evening, the grey clouds and drizzle of the afternoon even made way for a vampire's nightmare: blue skies and

glorious sunshine.

Fortunately it was also incredibly windy, which ensured a maximum billowing of capes.

"These are just things I've got in my wardrobe," said Kit Robson, 24, in full vampire garb. She was there with her siblings Christine, 29, Nick, 27, and William, 23, from Cockfield in County Durham.

At the head of the queue to get in was retired photographer Chris Martin from Beer in Devon. "As soon as I heard about it. I knew I had to come up."

The author found his inspiration for the story while on holiday in the Yorkshire coastal town in 1890 and it provided atmospheric locations in

the book. And though it was a daft, classically British literary event, it was one they all took deadly seriously, said the abbey's manager, Mark Williamson.

"We have to take it seriously because we have a lot of respect for the people who set the record. We want to honour those people. It would be bad if we allowed people in trainers all of a sudden."

There were entry requirements. "Can I see your fangs, please," said stewards at the entrance. At just after 9pm on Thursday the news came through – efforts had not been in vein, the record had been broken with 1,369 vampires gathered in one place.

One designer who chatted to the Queen, Juliet Sargeant, said later: "The same with anybody with mobility issues, it's just great to find a way to do what you love."

"She loves gardens and it's a great way for her to be able to pursue her passion."

The buggy made its public debut as other members of the Royal Family toured the site at the Royal Hospital Chelsea in London on foot.

They included the Earl and Countess of Wessex and Princess Beatrice and her husband

Edoardo Mapelli Mozzi.

This year's show features floral artwork specially commissioned for the Jubilee and signed by the Queen.

The Queen's Platinum Jubilee Garden, by renowned florist Simon Lycett, features steel silhouettes of the monarch, surrounded by 70 planted terracotta pots, representing each year of her reign.

Another installation transports visitors to one of the Queen's favourite places, with a canopy of flowers including fresh delphiniums emulating the colours and planting of the Scottish landscape near her Balmoral estate.

The show – cancelled in 2020 and rescheduled to September in 2021 – opened to the public on Tuesday.

## UK home prices reach ANOTHER record high

The average price tag on homes has reached a record high for the fourth month in a row – jumping by £7,400 in May, a leading UK property website has revealed.

Rightmove.co.uk said the average asking price for a home is now £367,501, up from £360,101 in April.

Frenzied market activity has led to price increases over the past two years at levels Rightmove has never seen in its 20 years of tracking property values.

Average asking prices have soared by £55,551 in the past two years, compared with a £6,218 increase in the two years before the pandemic, it added.

The number of buyers contacting estate agents is down 14 per cent on the stamp duty holiday-fuelled market of this time last year.

But it is still up by 31 per cent compared with the “normal” pre-Covid market of 2019. The amount of properties available to buy is 55 per cent down on levels seen in 2019, meaning supply and demand look likely to remain out of kilter for at least the rest of 2022.

The number of sales agreed is up by 12 per cent in the year to date compared to 2019, says Rightmove.

Director of property science Tim Bannister said: “Though demand is softening from the heady levels we saw this time last year, the number of buyers inquiring is still significantly higher than during the last ‘normal’ market of 2019. Meanwhile, the number of homes for them to choose from remains more constrained.”

# Depeche Mode founder Andrew Fletcher dies aged 60

Andrew Fletcher, keyboardist and founding member of British electronic band Depeche Mode, has died aged 60.

A statement issued by the band on social media said: “We are shocked and filled with overwhelming sadness with the untimely passing of our dear friend, family member, and bandmate Andy ‘Fletch’ Fletcher.”

Formed in Basildon in the late 1970s, the

## Katie Price facing possible jail sentence

**Katie Price may be jailed next month for breaching a restraining order, a judge has warned her.**

The reality star and former glamour model, 44, had been banned from contacting her ex-husband's fiancée Michelle Pentecost for five years in 2019.

But a court heard this week that she sent a text to her ex, Kieran Hayler, in January this year, in which she called Michelle foul names.

The message read: “Tell your c\*\*\*\*\*g wh\*re piece of

s\*\*\* girlfriend not to start on me...

“She doesn't need people knowing she was having an affair with you behind my back, gutter sl\*g.”

Dressed in black, Price spoke only to confirm her name and to reply “guilty” when the charge was read out at Lewes Crown Court.

The mum of five, who was accompanied by her fiancé Carl Woods, 33, previously denied the offence. She asked for a full jury trial when she appeared at Crawley

magistrates' court last month.

The court heard that she had been banned from contacting Michelle directly or indirectly under the terms of a restraining order imposed at Horsham magistrates' court in June 2019.

She was also fined £415 after hurling abuse at Michelle and another woman in a school playground in Shipley, West Sussex, in 2018. In January this year she was arrested at her home in nearby Horsham,

after sending the abusive message to Kieran.

Jonathan Karani, prosecuting, told an earlier hearing: “When she was arrested she made comments suggesting she had done nothing wrong and said she had not contacted the victim directly and did not have her number.

“She later said, ‘I sent that message to Kieran, lol [laugh out loud].’”

Judge Stephen Mooney adjourned sentencing to June 24 for a probation report to be prepared.

But he told Price: “You have pleaded guilty and you are aware that you committed that offence while you were subject to a suspended sentence and you are at risk of going to prison.

“Your lawyer says there is a lot of information relating to the background of this offence. I will need to know about the relevant parts.

“Be under no illusions, I am adjourning for a pre-sentence report but you do run the risk of receiving a custodial sentence.”

# Headteacher wanted for remote Shetland island's four-pupil school

Islanders on Foula, one of the UK's most remote inhabited islands, are looking for a new headteacher to run their tiny primary school, with a register of just four pupils and another child in its nursery.

Foula, an island of 4.9 sq miles with a permanent population of 28 people, lies 16 miles to the west of Shetland and vies with Fair Isle, which is 44 miles to the south, as the most isolated and exposed inhabited place in Britain.

Its popular headteacher, Beverley McPherson, described by one islander on Facebook as "truly fantastic", has retired after four years running the island's single-room school.

Sitting on the eastern side of the island, protected from the Atlantic

weather by Foula's highest hill, the school house also features a nursery, kitchen, community hall and solar array – part of Foula's off-grid renewables supply.

The job specification promises a salary of £61,374, relocation expenses and a three-bedroom house. The advertisement placed by Shetland Islands council reads: "Are you a headteacher or aspiring headteacher looking for an exciting new challenge? Do you dream of being part of a friendly, dynamic island community with a slower pace of life?"

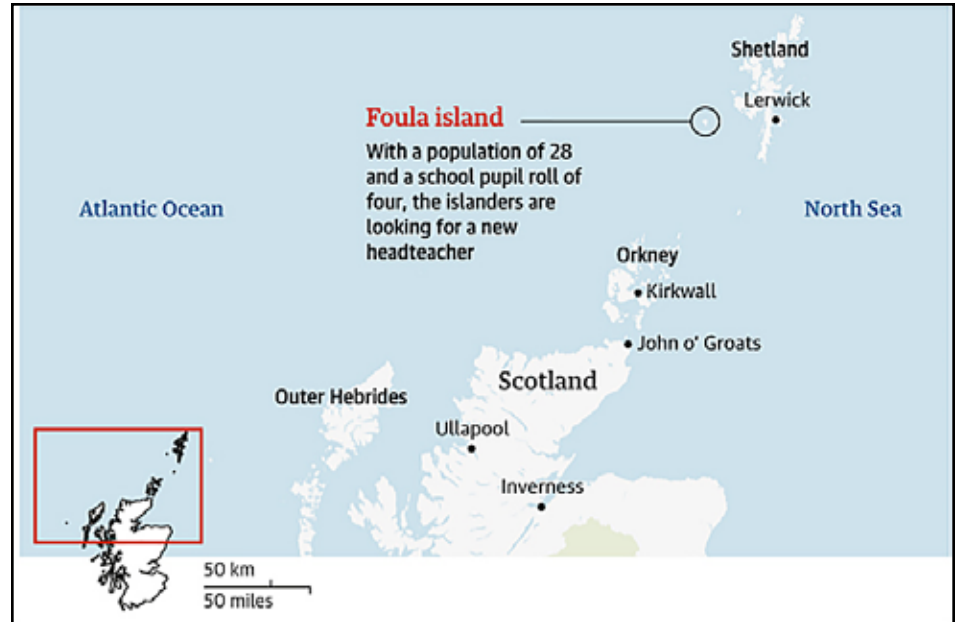
"Qualities we are looking for in the successful candidate are: a can-do attitude, vision, energy, initiative, good communication skills and self-discipline."

Other islanders work

part-time at the school covering early years, art and information technology. On Foula, as on many other Scottish islands, residents take on a multitude of jobs, while teenage children live off the island during term-time, staying in a hostel in Lerwick to attend Shetland's main secondary school.

Ken Gear, father to two of the children at the primary school, said: "Life on Foula is not for everyone, Gear said, "but for the kind of people who like this kind of thing, it can be idyllic".

The island is served by daily flights from Tingwall airport near Lerwick on Shetland's mainland during the summer, at a return cost of £46 for adult islanders, and three ferries a week during the summer.

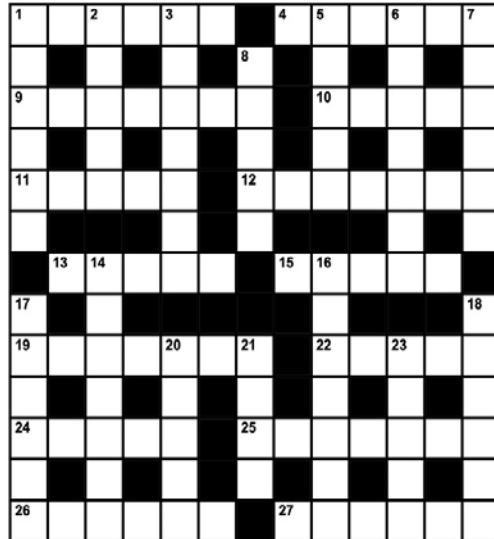

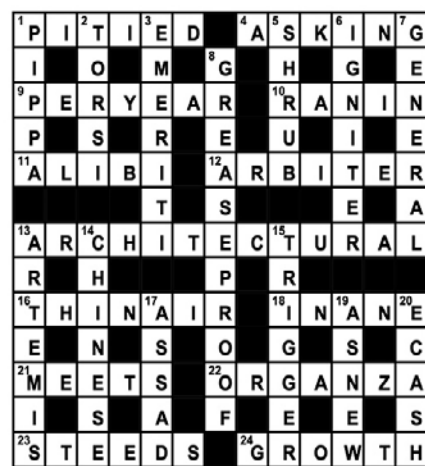

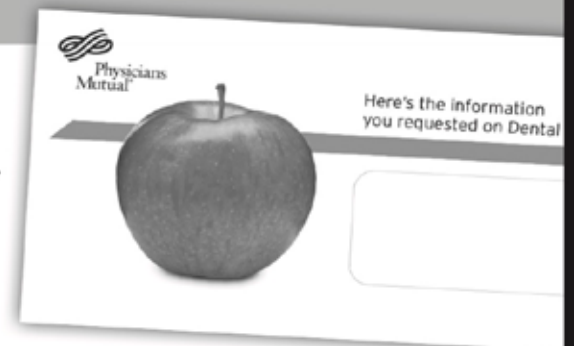

The Government have approved the £4.25billion takeover of the club by a consortium led by LA Dodgers co-owner Todd Boehly.

And Tuchel will now prioritise moves for long-time target Kounde and Sosa, with Antonio Rudiger off to Real

Madrid and Barcelona poised to land Cesar Azpilicueta, Andreas Christensen and Marcos Alonso.

Koulibaly, 30, has a year left on his contract and is yet to sign a new deal with Napoli.

It means he is available for much less than the £100million the Italian club demanded for him two years ago.

In a further boost to Chelsea, Mason Mount – the club's player of the season – is likely to

be handed a lucrative new deal to double his £80,000-a-week wages.

Reece James, Mount's team-mate with Chelsea and England, is also set

to receive a huge pay rise with three years left on his contract.

plans to turbo-charge the club's transfer activities after sanctions handed an advantage to their Premier League title rivals.

## England-Germany clash stirs unease in FA

ENGLISH football's governing body has voiced concern that a small but rising tide of hooliganism might reach a head when the national team play Germany in Munich on June 7th.

The host city Munich is the beer capital of Europe and has the sort of central square that encourages supporters to congregate.

Add an 8.45pm kick-off, a history of confrontation between the two factions and the fact that the eve of the match – when many are expected to travel – falls on the anniversary of D-Day, and there are understandable concerns the trip could end in disaster.

embarrassment already about previous bad behaviour from the fans, and strong messages are planned when the ballot process finally finishes on Friday. But the main concern is the recognition that UEFA will be keeping a close eye on things, as England have the threat of a suspended one-match behind-closed-doors game as part of the punishment for behaviour

at the Euro 2020 final.

German authorities are working closely with British police and stewards.

Alcohol will be banned at the Allianz Arena, but, there will be less control in the city centre where fans will be travelling en masse for the first time since Southgate's side played the Czech Republic in Prague in 2019.

In total, 3,466 tickets will be made available to England Supporters' Club members

But with 7,364 expressing interest in attending the game, there are concerns that some may travel to Munich without tickets. The FA admit that even those arrested after recent pitch

invasions in Premier League matches will be allowed to travel, if they have not been sentenced.

And there is a sense that a "new generation" of unknown travelling supporters will be making their first away trip with England due to the long break.

A dozen stewards and three senior FA security staff will travel to Germany to help liaise with the local authorities, who in the past have shown some understanding of handling English crowds.

As ever, though, alcohol abuse remains a huge concern, although police will increasingly be on the lookout for drug use by fans as an aggravating factor for poor behaviour.

## Spurs hand Conte £150m war chest

TOTTENHAM have handed manager Antonio Conte a £150million war chest to keep him and Harry Kane at the club beyond this summer.

An unexpected share issue by Spurs' owners ENIC placed the giant sum into the coffers for the transfer window, with the promise of further investment to come.

It is seen as a calculated gamble on staying in the lucrative Champions League places which they

only secured this season on the final day. But after the success of January signings Dejan Kulusevski and Rodrigo Bentancur, Conte, , is understood to be keen to sit down with chairman Daniel Levy and sporting director Fabio Paratici to start spending.

Spurs said in a statement: "The equity injection provides the Premier League club with greater financial flexibility and the ability to further invest on and off

the pitch.

"The investment represents permanent capital, with no ongoing interest cost to the club, and which may be drawn in tranches until the end of the year."

ENIC is owned by British businessman Joe Lewis, 85, who according to the 2021 Sunday Times Rich List has a net worth of £4.33billion.

All season Conte has been coy about serving the second year of his

contract, but after the top-four finish which he described as his "toughest" managerial achievement, Spurs hope the injection of funds will persuade him to stay.

Levy said: "The delivery of a world-class home was always key in driving diversified revenues to enable us to invest in the teams and support our ambitions to consistently be competing at the highest levels of European football."

# Champions League: Salah seeks final Real redemption

Mo Salah can barely think about the mental pain and anguish when he was helped from the pitch just 30 minutes into the 2018 Champions League final.

Talking to the press this week ahead of this weekend's rematch with Real Madrid, there was a visible wince as he recalled the moment.

"I remember when I went off, it was the worst moment in my career," he says of that incident where he was wrestled to the floor by Real Madrid's Sergio Ramos.

"It was the worst thing to happen for a player. I knew the result from the hospital. We couldn't lose that way.

"I was really down at that time. We had a good season and came to the Champions League final and then I went off."

Ramos used all the dark arts in the defender's armoury to put Salah out of the final and the Liverpool forward has made clear he feels it

was an intentional act.

No wonder his first reaction when witnessing Madrid's astonishing comeback against Manchester City in the semi-final was to tweet: "We have a score to settle."

He subsequently doubled down on those comments after receiving the Football Writers' Association Footballer of the Year award, adding: "Yeah, it's revenge time."

Liverpool skipper Jordan Henderson, who sat alongside Salah in the pre-Champions League press conference at the Reds' training ground on Tuesday, was in humorous mood as he teased his team-mate.

When asked about the Egyptian's revenge mission, he turned to Salah with a smile and a chuckle: "He didn't mean to say that, did you Mo?!"

But Henderson then added: "I can understand from Mo's point of view, it was a very emotional time, it was very tough

for him and tough for everyone.

"But for me, you don't need any more motivation to win a Champions League final. It was all you dreamed of as a kid, to play big games, and they don't get any bigger than a Champions League final."

Salah himself is more laid back about the prospect of facing Madrid, after overcoming an injury scare in the FA Cup final to declare himself fit for Saturday's game in the Stade de France.

He will relish the prospect of facing his old enemy, even if Ramos will be a mere spectator for the final.

"I'm very motivated, motivated through the roof, especially after what happened last time and what happened on Sunday [when Liverpool were beaten to the Premier League title by Manchester City], everybody is motivated to win the Champions League," he said.

"We fight for this and

everyone is excited."

But he could not resist one final word on the

subject of revenge.

When asked who Liverpool's

winner could be on

Saturday, Salah said: "Hopefully me!"

## KLOPP: 'Real aren't going to play friendly – and neither are we'

JURGEN Klopp is wary of the threat posed by Real Madrid in Saturday's Champions League final, saying they are still "world class".

The Liverpool manager is ignoring the bookies who make his side favourites and the pundits who say Real are not as strong as when they beat the Reds in the 2018 final.

Five of that Real side started in their sensational semi-final win over Manchester City and Klopp notes their midfield triumvirate of Luka Modric, Toni Kroos and

Casemiro is still intact.

Up front, Karim Benzema is enjoying his most prolific season at 34, while Brazil forwards Rodrygo and Vinicius Junior are both having strong campaigns.

Real won La Liga by 13 points and knocked out Paris Saint-Germain, last year's winners Chelsea, and new Premier League kings City during their march to Paris.

Klopp said: "It's always tough because first and foremost they are a world-class team, a world-class club, and they know how

to win football games.

"That says it all, and they're not out there to play friendly games, but neither are we and especially not in a final.

"The core [of Madrid's team], especially the midfield, is still intact. A lot of things are the way they were in 2018.

"Their back line has changed a lot. Cristiano Ronaldo is not there, true. But Benzema is still there, plus the young Brazilians and all these kinds of things, so it's a top-class team."
