Prince of Wales takes salute on his mother's behalf while flag-waving crowd enjoys parade and flypast

Four days of festivities for the Queen's platinum jubilee kicked off on Thursday with a display of military pageantry, large crowds and a royal reunion, as the nation marked the 70th anniversary of the longest reigning monarch in British history at Trooping the Colour.

The 96-year-old monarch was seen watching troops returning from the official Trooping of the Colour ceremony.

Earlier, members of the Royal Family gathered in central London to attend the parade marking the

Queen's official birthday. Trooping the Colour kicked off four days of celebrations for the Jubilee.

First to appear were Catherine, Duchess of Cambridge and Camilla, Duchess of Cornwall in

a horse-drawn carriage - together with Princess Charlotte, Prince George and Prince Louis.

Prince Richard, the Duke of Gloucester and a cousin of the Queen, and his wife Birgitte, Duchess of Gloucester rode to the ceremony in another carriage, alongside Princess Anne's husband, Vice Admiral Sir Tim Laurence.

Then Prince Charles, Prince William, and Princess Anne, the Princess Royal, appeared from Buckingham Palace on horseback for their central parts in Trooping the Colour. Prince Charles took the salute from guardsmen and officers at the parade.

Only "working royals" and some of their children were invited to join the Queen. The Duke and Duchess of Cambridge watched the event from a balcony in nearby Horseguards Parade.

Jubilee events coming for this weekend include the Epsom Derby at 12.40GMT, followed at 7.40pm with the

BBC Platinum Party at Buckingham Palace. Mabel, Celeste, George Ezra, Ella Eyre and Eurovision singer Sam Ryder will all be there, as well as a 22,000-strong audience including more than 7,500 key workers,

Armed Forces members and volunteers.

Sunday afternoon sees the Platinum Pageant, starting at 2.30pm GMT, to be held in central London, telling the story of Her Majesty's reign over the past 70 years. It

will include the Gold State Coach, as well as archive footage to remember and evoke the Coronation of 1953.

Street parties and Big Jubilee Lunches are also to be staged across the country.

Boris pledges to bring pounds and ounces back to British shops

BORIS Johnson is poised to mark the Queen's platinum jubilee with a post-Brexit pledge to bring back pounds and ounces in shops.

The Prime Minister wants to revive the use of imperial measurements as part of a bonfire of EU regulations.

He is expected to make the announcement later this week.

The EU weights and measures directive came into force in 2000, with traders legally required to use metric units for sale-by-weight or the measure of fresh produce.

It remains legal to price goods in pounds and ounces but they have to

be displayed alongside the price in grammes and kilograms.

There won't be a move away from metric units but a consultation will look at where it makes sense to incorporate or switch to imperial measurements.

From Friday, pubs will be able to sell pints in glasses bearing a crown for the first time since the 2004 EU Measuring Instruments Directive required the use of the EUwide CE mark.

Before a looser interpretation of the EU's directive was introduced, some shop owners were prosecuted for failing to adhere to the Brussels stipulations, becoming known as the

"metric martyrs".

The UK currently uses a mix of imperial and metric, with speed limits in miles per hour rather than kilometers, and milk and beer bought in pints. Food packaging in supermarkets is mainly labelled in grammes, while most soft drinks and other liquids on shop shelves are sold in litres.

Northern Ireland Secretary Brandon Lewis said that while the policy was "light-hearted", there were people who "want to go back" to using imperial weights and measures.


He told Sky News's Sophy Ridge On Sunday programme: "There are sectors out there - I know

people out there in my constituency, the market traders and vegetable traders as well as some of the pubs - which will be pleased to be able to go back to those imperial measurements.

"We're just saying you now have a choice, and now we've left the EU we can do that.

"Yes, it is one of the smaller things we can do since we left the EU, there are other bigger things we can do and want to do, but it is an indication we now have the freedom to make these decisions ourselves."

Brexit Opportunities Minister Jacob Rees-Mogg hailed the move to reintroduce the crown as "a very fitting symbol of

Spacey vows to "voluntarily appear" in British court to combat sexual assault claims

Kevin Spacey has said he will "voluntarily appear" in a British court because he is "confident" he can prove his innocence following allegations of multiple sexual assaults.

The American actor, 62, is facing four charges of sexual assault against three men, as well as causing a person to engage in sexual activity without consent, the UK's Crown Prosecution Service said last week.

Rosemary Ainslie, head of the CPS Special Crime Division, added: "The Crown Prosecution Service reminds all concerned that criminal proceedings against Mr Spacey are active and that he has the right to a fair trial."

In cases such as this, the defendant can choose to return to the UK to face

charges. If this does not happen, prosecutors can seek to start extradition proceedings.

'fair trial'

In a statement released to US TV show Good Morning America, Spacey said: "I very much appreciate the Crown Prosecution Service's statement in which they carefully reminded the media and the public that I am entitled to a fair trial, and innocent until proven otherwise. While I am disappointed with their decision to move forward, I will voluntarily appear in the UK as soon as can be arranged and defend myself against these charges, which I am confident will prove my innocence."

The alleged incidents are said to have taken place in London

between March 2005 and August 2008, and in Gloucestershire in April 2013.

The CPS authorised the charges following a review of evidence gathered by the Metropolitan Police in a previous investigation into the actor.

two Oscars

Spacey, has denied all allegations of sexual harassment and assault in the past. The police said the alleged victims are in their 30s and 40s.

Spacey has won two Oscars - the best supporting actor award for his role in the 1995 movie *The Usual Suspects*, and the best actor gong for 1999's *American Beauty*.

He was artistic director of The Old Vic theatre in London between 2005 and 2014.

Forgive Andrew, urges Archbishop

THE Archbishop of Canterbury has urged Britons to be more forgiving of Prince Andrew.

The Most Rev Justin Welby also suggested only those with perfect families could judge the rift between Princes Harry and William.

He told ITV News presenter Tom Bradby: "I think we have become a very, very unforgiving society... Now with Prince Andrew, I think we all have to step back a bit. He's seeking to make amends and I think that's a very good thing."

Earlier this year Andrew paid millions in an out-of-court settlement to Virginia Giuffre, who claimed she was forced to sleep with him when she was 17. He was stripped of his military roles and royal patronages.

He has always strenuously denied all the claims.

The Archbishop also addressed the controversial decision by the Queen to have Andrew as her escort at Prince Philip's memorial service in March. Mr Welby said: "At a big public occasion the Queen is fully entitled to have one of her children supporting her."

Asked about the rift between Harry and William, he said: "Of course it's sad when families are struggling, but what family isn't?"

"Jesus says, anyone who's never sinned cast the first stone and they all go away... If there's any family where the relationships are perfect, they're entitled to judge, but I'm not going to."

The Archbishop missed Friday's service of thanksgiving for the Queen's reign after catching Covid.

Liverpool call for inquiry after 'violent and shambolic' scenes at Champions League final

LIVERPOOL have called for an investigation after French authorities blamed its supporters for "violent and shambolic" scenes at the Champions League final in Paris.

Culture Secretary Nadine Dorries joined the club's demands to European football's governing body Uefa following incidents which saw some fans pepper-sprayed by police.

Pregnant women and young families were among those caught up in the chaos, which delayed Saturday's kick-off by 36 minutes.

One fan described running "a gauntlet of thuggery". Others had officers point guns at them after the game, which Liverpool lost 1-0 to Real Madrid.

'narrative of lies'

Youngster Olley Clemente was filmed sobbing as he wiped his eyes. His father, Carl, 38, posted the disturbing video on Twitter.

He wrote: "My nine-year-old suffered the effects of tear gas after the match, a football match! The police were throwing them for fun! I got hit directly! So toxic, defo not a place for kids! Football is finished."

Ian Byrne, Labour MP for Liverpool West Derby, said he had not witnessed such scenes of chaos since the 1989 Hillsborough disaster – in which 97 fans died. As with that tragedy, he said, he was concerned by the "narrative of lies" beginning to build.

Liverpool Mayor Joanne Anderson said she was "disgusted"

by the "appalling management and brutal treatment of LFC fans".

And Ms Dorries said footage and accounts from fans were "deeply concerning" and a formal investigation was "in the interests of everyone".

The Foreign Office has urged a thorough investigation with French authorities.

It came after a damning tweet from France's interior minister accused Liverpool fans of causing the violence outside the Stade de France. Gerald Darmanin claimed Liverpool fans were to blame for the disorder, which led to 68 arrests and 174 injuries. He said: "Thousands of British 'supporters' without tickets or with counterfeit tickets forced entry and sometimes assaulted the stewards."

Uefa first blamed the late arrival of fans before claiming the Liverpool end was blocked by thousands of fans with "fake tickets" which

did not work in the turnstiles.

However, Liverpool defender Andy Robertson, 28, said the match had "not been well organised", adding many of the players' families and friends were affected.

'shambles'

He said one of his friends was told his ticket was a fake. "I assure you it wasn't. It was a shambles really," he added.

Supporter Greg Scott, who missed

some of the match due to the mayhem, said: "I've travelled to many stadiums around Europe. But never have I seen anything like this, complete lack of control from the police."

"Their excuses stink. It's nothing to do with the fans, the club, it's Uefa and the French police. People could have been seriously hurt, we were piled in together for hours in the heat queuing up, and then we had no idea where to go next.

"French police were

using tear gas on a calm crowd like it was nothing, those with tickets were kept outside, I didn't see most of the first half."

Liverpool FC later released a statement calling for a thorough investigation into events outside the ground. They said they were "hugely disappointed" by the stadium entry issues.

In a statement, Merseyside Police said the behaviour of "the vast majority of fans" had been "exemplary".

Jilted lover created fake Instagram profiles to take revenge on ex

A BOURNEMOUTH MAN who never forgave his school sweetheart for jilting him posed as her online years later to proposition strangers and tout porn videos.

Thomas Berry, 26, said he “never forgave” Ellie Steele for breaking up with him when they were 16.

When she got a job at non-league Dorchester Town FC, where Steele was a football coach and social media officer, he set about getting revenge.

He stole her identity to set up dozens of Instagram profiles in her name. Posing as her, he sent male strangers suggestive messages and promised to send naked pictures.

He also made it appear that Ms Steele made pornography videos for the OnlyFans site.

Ms Steele, 26, only discovered the fake accounts when she got messages de-manding the images she had apparently promised. She reported the accounts to Instagram but Berry deactivated them before he could be caught – only to launch new ones.

Berry, of Poundbury, Dorchester, Dorset, admitted stalking Ms Steele between May and October last year.

He dodged jail and was only given a five-year restraining order by Poole magistrates despite prosecutors asking it be life-long.

Berry was also ordered to pay his victim £400 compensation.

Although the charge covered a period of five months, Ms Steele said the vendetta lasted six years.

In her statement to the court, she said “I have stopped using social media. I don’t trust anyone. I have lost all of my confidence.” She has demanded that social platforms do more to shut down fake accounts.

Sir Andy attacks US gun laws following Texas massacre

SIR Andy Murray attacked US gun laws this week following the Texas school massacre – saying a survivor’s account felt very similar to his own experience in the 1996 Dunblane massacre in Scotland.

The 35-year-old former Wimbledon champion said the deaths of 19 children and two teachers in the shooting had left him “angry” and “incredibly upset”.

He said: “I think there’s been over 200 mass shootings in America this year and nothing changes.

“I can’t understand that. “You can’t keep approaching the problem by having more guns in the country. I don’t see how that solves it.”

The shooting at Robb Elementary in Uvalde on May 24 provoked more calls for gun control measures in the US.

Senior Republicans have already expressed their opposition to tighter rules on gun ownership, such as background checks.

Murray believes that changes need to happen. “My feeling is that surely at some stage you do something different,” the dad of four told the BBC.

He added: “I heard something on the radio and it was a child from that school.

“i don’t get it”

“I experienced a similar thing at Dunblane...a teacher coming out and waving at all of the children, telling them to go and hide under tables.

“And it was a kid telling exactly the same story about how she survived it.

“They were saying that they go through these drills, as children at seven, eight years old.

“How? How is it normal that children should be having to go through drills, in case someone comes into a school with a gun? I don’t get it – it’s really, really upsetting and I hope they make some changes.”

Murray was an eight year old at Dunblane Primary School near Stirling in March 1996 when 16 children and a teacher were murdered by gunman Thomas Hamilton.

In the athlete’s 2019 documentary

Resurfacing, he told how his family used to give lifts to Hamilton.

He explained: “We knew the guy, we went to his kids’ club, he had been in our car, we had driven and dropped him off at train stations and things.”

Two million Brits now believed to be suffering from Long Covid

TWO million people are now thought to be suffering from long Covid in the UK – including 826,000 who have had symptoms for at least a year.

Latest estimates from the Office for National Statistics suggest 3.1 per cent of the population are affected by problems lasting more than four weeks after infection.

Some 376,000 people who caught coronavirus around the start of the pandemic were thought to have had symptoms lasting at least two years – and 1.4 million for at least three months.

The figures were based on self-reporting by almost 300,000 people who completed an ONS survey.

The commonest symptoms include fatigue, shortness of

breath, cough and muscle ache.

Sarah Woolnough, CEO of charity Asthma + Lung UK, called the total a “grim milestone” and warned there was a lack of treatments and support, plus long wait times for specialist care for the condition – which can affect health, work and relationships.

She said: “The government must invest more to find new treatments.”

Estimates for long Covid in the UK have risen sharply recently. It is likely to reflect the impact of the Omicron variant, which saw record levels of infection across the country in spring.

One in five of those suffering said the ability to undertake day-to-day activities had been “limited a lot” by

lingering symptoms.

Prevalence was highest among women, people aged 35 to 49, those in deprived areas, people with underlying health conditions and those working in teaching or

healthcare.

Ondine Sherwood, of the Long Covid SOS campaign, said: “There are now no measures in place to prevent infection. Anyone who gets Covid is vulnerable to

developing long Covid, irrespective of their age or health.”

Covid-19 infections in the UK have dropped to their lowest level for eight months, according to the ONS survey.

Life "too interesting to die" says Richards as Stones kick off European tour

SIX decades with the Rolling Stones have made life "too interesting to die" for hellraiser Keith Richards, ensuring he will not fade away.

The guitarist admits he is sometimes surprised he survived the legendary drug excesses of his youth.

But the 78-year-old added: "Life's just too interesting to die. Anything I wanted to do had to be done - I couldn't slack off. And hey, there was just an awful lot of cocaine involved."

Keith was speaking about life on the road with bandmates Ronnie Wood, 75, and Mick Jagger, also 78, ahead of the first date in their European tour SIXTY which kicked off

in Madrid Tuesday night. He reckons their bond has kept them rolling on for so many years.


Keith said: "That's a hell of a long time. I think the most important thing is the people in the band want to stay together. That helps! We had our ups and downs, of course. But in the end we always noticed we are more creative together. And, of course, across these - my God, six decades! - you have got used to each other."

Keith, who has five children and been married to US model Patti Hansen for 39 years, joked: "It's kind of like marriage in a way. Well, except for that not-so-minor thing that a

husband and wife share!" He has missed being on the road, since the Stones' last tour two years ago. He said: "Our fans seem like old friends to me. That's why I'm so looking forward to the European tour."

The Stones looked thrilled to be back on stage at Wanda Metropolitano stadium in Madrid, with Steve Jordan replacing drummer Charlie Watts, who died last year aged 80.

Bandmater Ronnie Wood celebrated his 75th birthday at the gig after having a tea party with his family earlier in the day. He said he feels "reborn" after giving up booze and drugs and bringing up twin girls.





Rudi's Real deal

Antonio Rudiger has completed his move to Real Madrid from Chelsea on a free transfer, signing a four-year deal.

The Germany international, 29, has joined the new Spanish and European champions after rejecting Chelsea attempts to extend his contract.

Rudiger moved to Chelsea for an initial fee of £29m from Roma in 2017.

He made 203 appearances and scored 12 goals for the Blues, winning the FA Cup, Champions League, Europa League, Uefa Super Cup and Club World Cup.

Chelsea described Rudiger as "as one of the most passionate characters to represent the club in recent memory".

Rudiger, who also spoke to Bayern Munich, was offered a contract worth more than £200,000/week to stay at Chelsea.

"We gave everything and now we enter a situation where we can't fight any more because of the sanctions and now Toni will leave," Chelsea

manager Thomas Tuchel said in April.

Tuchel was referring to the restrictions on the club resulting from the UK government's sanctioning of former owner Roman Abramovich in March, following Russia's invasion of Ukraine. Abramovich has denied the government's assertion that he has strong links to Russian President Vladimir Putin.

Abramovich put the club up for sale and a consortium led by American investor Todd Boehly and private equity firm Clearlake Capital completed a £4.25bn takeover in late May.

Chelsea are also set to lose Danish centre-back Andreas Christensen this summer to Barcelona on a free transfer, but captain Cesar Azpilicueta is expected to stay after a one-year extension was triggered in his contract earlier this season.

Real Madrid have said Rudiger will be publicly unveiled to fans on 20 June.

were even more exposed at the back. A series of long punts in the closing stages broke down, with one final roll of the dice allowing the Ukrainians to burst forward deep into injury time.

Substitute Dovbyk had all the time he wished to eventually dispatch the ball by Gordon.

After the final whistle Clarke told reporters "I'm suffering, my coaching staff are suffering. And more than anyone, the players are suffering."

"We'll have 24 hours where we'll feel sorry for ourselves. We'll analyse the game as a coaching staff and group of players. We'll try and get back on the horse and go again."

Clarke has been in charge of the Scotland for three years, with the highlight of his tenure coming last summer when he guided the nation to the European Championships, where they went out at the group stage.

With that raised expectation, the pain of missing out on Qatar later this year will increase further. However, the Scotland manager said it "shouldn't be forgotten" what progress the national side has made.

"It's a group that has developed together," he said. "We have to qualify for Euro 2024 and beyond that. By World Cup 2026, this group of players will have more caps, more experience and should be better. That's what we have to aim to be."

Forest return to the big time

Nottingham Forest ended their 23-year wait for Premier League football with a narrow win over Huddersfield Town in the Championship play-off final at Wembley - a victory worth about £170m.

Levi Colwill's own goal from James Garner's cross was the decisive moment.

Town improved after the break but struggled to create a big chance.

Their best opportunity saw Harry Toffolo booked for diving in the area by referee Jon Moss, officiating for the final time before retiring, and, although replays suggested Jack Colback had made some contact, it was not overturned by VAR.

Promotion back to the top flight caps a brilliant turnaround to their season, which had started with six defeats in seven before Steve Cooper took over from the hapless Chris Hughton and stamped his mark on the team.

Forest held out in the face of mounting

pressure to spark scenes of jubilation and end their two-decade exile from the Premier League.

Forest's promotion in their first ever play-off final comes at the end of a season which started disastrously under then-manager Hughton.

The two-time European Cup winners took one point from their first seven games - their worst start to a season in 108 years - and when Hughton was sacked in September it looked like the team was likely to spend the

campaign battling against relegation.

However, Cooper, who had taken Swansea to the play-offs in his two seasons in south Wales, quickly turned the ship around and they eventually moved into the top six for the first time this season on 9 February.

There were also impressive home FA Cup wins over Arsenal and local rivals Leicester City before being narrowly beaten by eventual winners Liverpool in the quarter-finals.

Mata set to leave Old Trafford

Juan Mata will leave Manchester United on a free transfer when his contract expires this summer.

The 34-year-old midfielder who helped Spain win the 2010 World Cup, cost United a then club-record £37.1m when he

joined from Chelsea in 2014.

Mata, who scored 51 goals in 285 appearances for United, played in seven Premier League games last season.

"Thank you for dedicating eight years of your career to United, Juan," the club said.

"Everyone at the club wishes you all the best for the future."

Mata, who agreed a one-year contract extension with United last July, won four trophies with the club, including the FA Cup in 2016, and the Community Shield, League Cup and

only 4ft 6in tall.

He grew to nearly 5ft 8in and by the time of his last victory - aged 58 on Palacegate Jack at the same course in 1994 - his stony expression had been likened to "a well-kept grave" by racing writer Jack Leach.

In between, Piggott had rewritten the record books. From boy

wonder to the so-called Housewives' Choice, when women who supposedly knew nothing about racing would have a flutter on Lester in big races.

He won the Derby for the first time aged 18 in 1954 on Never Say Die and was champion jockey 11 times between 1960 and 1982 in an era where rivals included talented riders like Willie Carson and Pat Eddery.

He won a total of 116 races at the Royal Ascot

meeting and triumphed a record 30 times in the British Classics, including an unprecedented nine wins in the Derby at Epsom.

"I've managed to win two Derbys and Lester won nine, which is beyond anyone's imagination," said jockey Frankie Dettori when Piggott was inducted into British racing's hall of fame.

"Looking back at the footage of Lester ride, he was 20 years ahead of his time, like Tiger Woods or

Ukraine pride breaks Scottish hearts

On an emotional night at Hampden, Ukraine overpower hosts to earn World Cup play off final berth

A heroic Ukraine produced a performance of spirit, endeavour and courage Wednesday night to stun Scotland 3-1 and earn a historic World Cup play-off final against Wales.

With their country enshrouded in trauma amid the ongoing war with Russia, a team hauled together shone brightly at a sun-drenched Hampden.

Andriy Yarmolenko and Roman Yaremchuk struck either side of half-time, before Callum McGregor gave Scotland hope late on. But Artem Dovbyk sealed a Qatar 2022 showdown in Cardiff on Sunday with the last kick of the ball.

While images of fans watching on in war-torn Ukraine circulated, 3,500 fans bedecked in light blue and yellow - including 65 orphans invited by the Scottish

FA - celebrated wildly in Glasgow on a night none will forget.

It was an evening which started with the lyrics of the Ukrainian national anthem striking an emotional chord at a charged Hampden.

Moments after their side strode on to the pitch draped in flags of their homeland, the words which were belted out took on a whole new significance. "The glory and freedom of Ukraine has not yet perished. Luck will still smile on us brother-Ukrainians."

As it transpired, luck had little to do with their team's triumph. In perhaps their finest hour, they were peerless.

The visitors ruthlessly exposed Scotland's vulnerabilities, which were made even more pronounced by the absence of Arsenal's Kieran Tierney. The

opener on 33 minutes articulated that perfectly. Yarmolenko timed his run on to a through ball to perfection as Scotland's high line failed. It was just him and the whites of Craig Gordon's eyes. Those eyes soon gazed up as the ball floated sublimely over the goalkeeper's head and into the back of the net.

Steve Clarke shuffled his pack at half-time, throwing on Ryan Christie. But just four minutes after the restart, Scotland were again ripped open with ease.

Oleksandr Karavaev was given way too much time to fire in another cross and Yaremchuk dealt with Aaron Hickey's attention without much trouble, his arching header back across goal and looping in.

The hosts threatened to get back in the game



Manchester City's defender Oleksandr Zinchenko delivered a commanding performance on Wednesday in Glasgow

but it never looked like being their night after John McGinn, gifted a header from six yards after Georgiy Bushchan flapped at a cross, headed wide with the goal at his

mercy.

With 11 minutes left Clarke's men were gifted a lifeline. McGregor's effort was again not dealt with by an increasingly rattled Bushchan, who

palmed the ball into the air and just over the line before it was hacked clear. Hampden erupted in a primal roar, but as Scotland pushed, they

Lester Piggott dies at 86

'The Long Fellow' enjoyed a long and glittering career in British racing

LEGENDARY jockey Lester Piggott died this week at the age of 86.

From his first victory aged 12 to his last nearly 50 years later, Piggott was a ruthless winner who became a racing icon.

Tall for a rider in flat racing, he spent much of his career on a punishing diet to keep


his weight down but had an insatiable appetite for finishing first.

Affectionately nicknamed the Long Fellow and regarded as one of the all-time great jockeys, it was not just the 4,493 victories which marked him out.

The partially-deaf rider had a quiet charisma

of his own, a fierce determination and a life story which took in prison and one of sport's most remarkable comebacks.

Piggott was an angelic-looking schoolboy when he rode his first winner, The Chase, at Haydock in 1948, weighing less than five stone and standing **cont. on page 19, col. 3**
