# Summer misery for millions? Heathrow faces summer of disruption as BA staff vote to strike

MILLIONS OF holidaymakers from the UK and beyond face misery this summer as hundreds of check-in and ground staff voted in favor of walkouts during the peak holiday period in a dispute with British Airways over

# pay.

The and Unite unions balloted about 700 workers employed by BA on industrial action. About half of the workers are represented by the GMB, and 95% of those who voted said they were prepared to strike on a turnout of more than 80%. Strike dates will be confirmed in the coming days, but they are likely to be during the school holidays. The Unite ballot closes on Monday.

The dispute stems from BA using "fire and rehire" practices to cut workers' pay during the pandemic when they could not fight back, the GMB union said.

"All our members are asking for - and these are primarily low-paid women - is for BA to reinstate the 10% taken

GMB from them during the off bonus for this year, pandemic," a GMB spokesperson said.

BA said: "We're extremely disappointed with the result and that the unions have chosen to take this course of action. Despite the extremely challenging environment and losses of more than £4bn, we made an offer of a 10% payment which was accepted by the majority of other colleagues.

"We fully are committed to work together to find a solution, because to deliver for our customers and rebuild our business we have to work as a team. We will of course keep our customers updated about what this means for them as the situation evolves."

GMB said while BA was offering a 10% one-

the union is demanding that the 10% pay cut imposed on workers during the pandemic be reversed permanently.

The union also pointed out that bosses' pay had returned to prepandemic levels, and the chief executive of BA's parent company IAG, Luis Gallego, is in line for a £4.9m payout this year if he hits all his targets.

His pay package prompted a sizeable shareholder revolt last week, with more than a quarter of investors failing to back it. IAG faced down a rebellion at its annual meeting in Madrid where 17.8% investors voted of against the controversial pay policy, and 7.8% abstained. Investment advisers Glass Lewis and ISS described the pay

plan as "excessive".

Nadine Houghton, a GMB national officer, said: "With grim predictability, holiday makers face massive disruption thanks to pig-headedness the of British Airways.

"Our members need to be reinstated the 10% they had stolen from them last year with full back pay and the 10% bonus which other colleagues have been paid.

"GMB members at Heathrow have suffered untold abuse as they deal with the travel chaos caused by staff shortages and IT failures. At the same time, they've had their pay slashed during BA's callous fire and rehire policy.

"What did BA think was going to happen? It's not too late to save the summer holidays - other BA workers have had their pay cuts reversed, do the same for ground and check in staff and this industrial action can be nipped in the bid."

The strike vote comes as Heathrow airport revised up its forecasts for passenger numbers in 2022. About 20.1 million people travelled Heathrow through between January and May, and the airport said it had seen a steady traffic increase this year following an "extremely challenging two years".

# As union unrest grows, Labour boss struggles to keep party in line

LABOUR'S simmering unrest between the moderate leadership of Sir Kier Starmer and his more hard line frontbenchers looked it could erupt into civil war this week.

Several leading Labour MPs joined a picked line during a transport strike – despite Starmer privately urging them to stay away - a position which found him under fire from his own party.

Deputy leader Angela Rayner said: "No one takes strike action lightly. I will always defend their absolute right to do so for fairness at work."

Richard Burgon, a shadow cabinet minister under Jeremy Corbyn, said Sir Keir was wrong and joining the picket line was the "right thing to do" for MPs.

Sir Keir is under pressure to sack frontbenchers who did.

Osborne, Kate а parliamentary aide to shadow Northern Ireland secretary Peter Kyle, joined strikers in Bromley, south-east London, saying: "I'm a trade unionist, I will always stand on the side of the workers."

Labour whip Navendu Mishra was at a picket London, saying: in

"As a proud trade unionist, I stand with all workers on our railway network who are taking industrial action to fight for their jobs and keep passengers safe."

Conservative Party Oliver chairman Dowden said: "Nothing to see here, just a Labour whip joining a picket as millions of line people have their lives disrupted. When we say these are Labour's strikes, this is exactly what we mean.'

But Sharon Graham, general secretary of the Unite union, hit back: "The Labour Party was founded by the trade

unions and we expect Labour MPs to defend workers, by words and by actions." RMT boss Mick Lynch

added: "If Keir Starmer wants to connect with working class communities that have fallen out of connection

with Labour, he's got to find some values and policies.'

Labour backbench MPs posted on social media from picket lines, including former shadow home secretary Diane Abbott in London and Ian Lavery in Northumberland. Supporters

also included ex-miners union leader Arthur Scargill, 84, who turned up at Wakefield, West Sarah Yorks, with Woolley, head of the Bakers, Food and Allied Workers Union.

# **More rail strikes** 'extremely likely' says Union boss

BRITAIN was rocked by a hugely disruptive transport strike this week – and union bosses say it is "extremely likely" there are more to come if talks with rail bosses and unions continue to fail.

Mick Lynch, the union boss of RMT, (named for rail, maritime and transport workers it represents), accused the government of blocking a deal, a claim denied by the government. For the second time this week a walkout by rail workers

has left travellers facing another day of disruption. Trains have ground to a halt across much

of England, Wales and Scotland, with about half the network closed.

Another walkout is already planned for Saturday.

Downing Street said the unions should call off the strikes "as quickly as possible", but Lynch, general secretary of the union, earlier told the that Saturday's BBC industrial action might not be the last.

He said talks would continue and he would consult members to see "if and when there needs to be a new phase of industrial action".

"But if we don't get a settlement, it's extremely likely there will be," he said.

Tim Shoveller, the chief negotiator for Network Rail - which maintains the railways throughout Britain - said there had been hopes on Wednesday of stopping the second day of strikes and it was "hugely

have There been accusations on both sides that third parties are hampering progress.

Lynch Mr told BBC's Breakfast: "The government's hand is in this... the [rail] companies leave the room, consult the government ministers department and the

officials and when they come back often the situation is worse."

But Network Rail with whom the RMT are negotiating - said it was the RMT, not the government which stalled negotiations.

Mr Shoveller said they thought they had a deal on Wednesday until the RMT left the room to get guidance from their board.

The RMT is calling for a pay rise of at least 7% to offset the cost of living crisis, as inflation hits 9.1% and is forecast to reach 11% in the autumn.

Employers have offered a maximum of 3%, on condition that the union accepts new working practices.

# Nigerian politician accused of trying to bring boy, 15, to UK to harvest organs

A Nigerian politician and his wife have been charged with plotting to traffic a homeless 15-yearold boy to Britain to harvest his organs.

Ike Ekweremadu, 60, an opposition senator and former deputy senate president, and his wife, Beatrice Nwanneka Ekweremadu, 55. appeared at Uxbridge magistrates court in west London on Thursday.

The couple were arrested on Tuesday at Heathrow airport before they flew to Turkey, the court heard. Both deny the allegations.

Police said the boy, who the court was told was homeless, had been safeguarded.

Ekweremadu is an opposition senator in the southern Nigerian state of Enugu. He is also a principal at a law firm and has been influential in Nigerian politics for several decades.

The couple have been charged with conspiracy to arrange and / or facilitate travel of another person with a view to exploitation. The investigation was launched by the police's Metropolitan specialist crime team after detectives were alerted to potential offences under modern slavery legislation in May. The charges relate

to alleged activity between 1 August 2021 and 5 May 2022.

Gavin Irwin, representing Ike Ekweremadu, said: "There is no question this is a serious allegation. Mr Ekweremadu is a member of the senate in Nigeria. He is a member of the bar in Nigeria. He is a principal in a law firm that bears his name.

"Those issues taken together go way beyond him being a person of good character ... rather that he has led a blameless life as a public servant." Irwin added that the allegations were "nothing short of preposterous".

# Palace bullying report 'to be buried'

A PALACE investigation into claims of bullying by the Duchess of Sussex will never be published, it was claimed this week.

The findings by an independent law firm paid for privately by the Queen have been "buried", sources said.

It is understood that courtiers don't want the details made public to protect those who took part and to prevent more tensions between the royal household and Meghan, 40, and Prince Harry, 37.

Instead, Buckingham Palace has "improved policies and procedures" within its HR department. These were expected to be outlined in the annual Sovereign Grant report - which includes information on royal staffing – later this month.

But the sources say the Palace no longer plans to publicly acknowledge any changes.

The probe began after two personal assistants were said to have been bullied out of their jobs by Meghan during her time as a working royal. One royal insider is quoted vesterday as telling a Sunday newspaper the worst instances never came out and there were more "harrowing" tales that hadn't been told.

Some staff are said to be disappointed the report will not be seen, and have not been told its results. The Palace declined to comment.

The first complaint was made in 2018 by Jason Knauf, then the Sussexes' communications secretary. He emailed Simon Case, then Prince William's private secretary, to say: "I am very concerned that the Duchess was able to bully two PAs out of the household in the past year."

# Celebrating his 40th, Prince William hangs out with an unlikely old chum

■ Duke revisits Big Issue vendor who helped him sell papers on the streets

William has Prince celebrated his 40th birthday with the Big Issue vendor who helped him sell the magazine on the streets of the capital earlier this month.

The Duke Cambridge dropped in on Dave Martin, 60, at a Tesco supermarket in Hammersmith, west London, where he was selling copies of the latest edition of the homeless fundraising magazine.

William sold 32 copies when working alongside Dave. The pair are pictured together on the front cover of a special edition of the publication to mark the Duke's birthday. He also wrote a candid essay explaining why he wanted to shine a

light on homelessness. He revealed he hopes to show his three children, Prince George, eight, Princess Charlotte, seven, and Prince Louis, four, the "fantastic" homelessness organisations he works with – "just as my mother did for me". The Duke is planning to throw a joint 40th bash at Windsor or Sandringham with wife Kate. Her own celebrations in January were cancelled due to Covid.

William also issued a personal thank you for the deluge of goodwill messages he received. Writing on Kensington Palace's Twitter account he said: "Thank you for

action to those who are struggling. I plan to do that now I'm turning 40, even more than I have in the past."

# **Murdoch and Hall** 'set to divorce'

**RUPERT** Murdoch and Jerry Hall are to divorce, it was reported this week – sparking speculation on whether his massive £14.5billion fortune will be split.

The end of the sixyear marriage will be the fourth to be dissolved for the newspaper baron, 91. It is unclear, what if any, prenuptial agreement was signed with former supermodel Jerry, 65.

It was the six-foot Texan's first marriage after previously being in a 22-year relationship with Sir Mick Jagger. Together she and the Rolling Stones singer share four children.

However, the two never wed during their partnership, which lasted from 1977 to 1999. Bryce Tom, a spokesman for the media mogul, declined to comment on the reports while Jerry's agent failed to respond to enquiries.

Mr Murdoch and Ms Hall were married in March 2016 in a lowkey ceremony in central London.

The billionaire marked the occasion by announcing on Twitter he would stop posting on the platform, calling himself "the luckiest and happiest man in the world".

In 2019, the couple spent £11.25 million on a house near Henley-on-Thames, near London. And in March last year, they celebrated his 90th birthday with more than 100 guests in New York.

Mr Murdoch has six children. They include daughter Prudence MacLeod, 64, with his first wife Patricia Booker and daughter Elisabeth, 53, and sons Lachlan, 50, and James, 49, with his second spouse Scottish journalist and novelist Anna Mann, 77.

He shares daughters Chloe, 19, and Grace, 21, with his third wife Wendi Deng, 53. Jerry and

Mick's four children are Elizabeth, 38, James, 36, Georgia, 30, and Gabriel, 24.

# Windrush generation 'moved to tears' as monument unveiled in London

■ Basil Watson's sculpture at Waterloo station celebrates pioneers who arrived in Britain after second world war

Members of the Windrush generation have been "moved to tears" by a new national monument that pays tribute to their ambition, courage and contribution to Britain, the artist behind the sculpture has said.

Basil Watson's permanent monument to the Windrush pioneers who arrived in Britain after the second world war was unveiled at Waterloo station in London on Wednesday.

The statue, backed by £1m of government funding, portrays three figures – a man, woman and child – dressed in their "Sunday best" climbing a mountain of suitcases hand in hand.

"The community probably never felt that this would happen," Watson said. "I've seen some moved to tears because their personal

experience, and their tremendous contribution to the development and culture of Britain, is being recognised in this way."

Members of the Windrush generation and the Duke and Duchess of Cambridge gathered at Waterloo for the unveiling. The event was livestreamed across the country including at Birmingham New Street station and the National Railway Museum in York.

# 'contribution'

The Queen also sent a message to mark the occasion. She said: "It gives me pleasure to extend my congratulations on the creation of the National Windrush Monument. The unveiling at Waterloo Station on Windrush Day serves as a fitting thank you to the Windrush pioneers and their descendants, in recognition of the profound contribution they have made to the United Kingdom over the decades.

"It is my hope that the memorial will serve to inspire present and future generations, and I send you my warmest good wishes on this historic occasion."

ThechairoftheWindrush C o m m e m o r a t i o n Committee, Floella Benjamin, said the monument would provide a permanent place of reflection, celebration and inspiration for Caribbean communities and the wider public.

"It will act as a symbolic link to our past and a permanent reminder of our shared history and heritage for generations to come," she said. "I hope it will be a catalyst for other monuments across Britain commemorating the extraordinary contribution to this country by the

Windrush generation.

Watson, who is based in Atlanta, Georgia, has designed public sculptures and monuments across the world, including in China, the US, Guatemala and Jamaica, of figures such as Martin Luther King, Usain Bolt and Merlene Ottey. The Windrush monument marks his first public artwork in the UK and was built in "record time".

"In trying to figure out how to depict a generation that spans four decades, I thought: where along that line do I pitch the design? I decided to start at the beginning, that's where everything starts and moves forward."

The suitcases, he said, represented the family's belongings and culture, "everything they brought with them".

# For less than a London flat, a private Shetland island can be yours.....

THIS island off the coast of Shetland with a 17thcentury house is on the market for the price of a posh London flat – and it comes with a flock of 200 pure-bred sheep.

The Isle of Vaila has been valued at £1.75 million, including 757 acres of land and a six-bed mansion with four front rooms. It also has a farmhouse, cottage and the 18thcentury Mucklaberry watchtower.

Good views are guaranteed with a coastline spanning around 6.5 miles.

There is even the skeleton of a 42ft sperm whale lying in a byre on the island after it was beached in 2000. In London the closest you could get to a prestigiously located property for £1.75 million would be a twobed apartment, a stone's throw from Hyde Park.

For 30 years Vaila has been owned by Richard Rowland and Dorota Rychlik, who left London for the island, where the Atlantic and North Sea meet. They married there in 1994.

They bought the mansion and its fittings and furnishings – and even the boat to make the 10-minute journey to and from mainland Shetland.

The couple have now decided to focus on their art gallery in Lerwick, and said it was "a wrench" to leave.

Richard said: "We were looking for a project to take on and had thought more of the Western Isles or mainland Scotland, and not Shetland until we saw this.

"We've had innumerable parties. We used to charter planes to bring guests up here. We've had 30 fantastic years and we're getting on now. So the time has come for someone else to take on the place."

The couple bought it from the descendants of Yorkshire mill magnate Herbert Anderton, who had Vaila Hall built as his summer getaway in the 1890s. Prior to the Anderton dynasty, founder of P&O ferries Arthur Anderson leased the island in 1837 and established the Shetland Fishing Company there. Luke French, from estate

Luke French, from estate agent Savills, said: "This is a wild and beautiful part of the world."

# Ed Sheeran just keeps breaking records

■ 'Bad Habits named most played single of 2021

ED Sheeran has been breaking records with his Bad Habits - which was last year's most played single in the UK and helped make him the most played artist too.

It means Ed, 31, is the first person to claim both accolades in two separate years.

He previously did the double in 2017, which saw the release of his album Divide and his hit single Shape of You.

Adele, 34, is the only other artist to have topped both charts in the same year, with Rolling In The Deep being the most played single and her album 21 making her the top played artist of 2011.

Ed, who is performing in London this week as part of his worldwide Mathematics tour, is used

to being the UK's most played artist. In the last five years,

Halifax-born the superstar has been dethroned just once – in 2020 when Londoner Dua Lipa took the title following the release of her album Future Nostalgia. The annual charts are compiled by music licensing company Phonographic Performance Limited (PPL) from music usage and airplay data from radio stations and TV channels as well as public performances.

Peter Leathem, chief executive of PPL, said: "Congratulations to Ed Sheeran. His charttopping success over the last five years is a testament to not only the quality of his output but also the strength of UK music."

Bedford-born Tom Grennan, 27, claimed the second and third most played tracks of 2021 with By Your Side with Calvin Harris and Little Bit Of Love respectively. Canadian singer The

Blinding Weeknd's Lights was the fourth most played track. despite having been originally releasedin November 2019. The fifth most played track of 2021 was Higher Power by Coldplay.

When it came to most played artist of the year, in second place was David Guetta with Dua Lipa in third. Little Mix, who recently went on hiatus, claimed fourth place. Coldplay took fifth place again.



The 30-year-old is expected to provide a strong challenge to **Martin Dubravka** for the No 1 spot at St James' Park, and is the club's second summer signing after full-back Matt Targett's loan move was made permanent earlier this month.

Pope's arrival at Newcastle is a boost for West Ham as they look to sign goalkeeper **Alphonse Areola** on a permanent deal from Paris SaintGermain. The Magpies were reportedly interested in Areola, who spent last season on loan at the London Stadium, but West Ham now look set to secure an agreement for about  $\pounds 10.5m$ .

The RB Leipzig forward Christopher Nkunku has extended his contract to 2026. The 24-year-old, who had attracted interest from clubs including Chelsea, has a release clause valid from next summer. The figure is €60m (£51.6m) but could grow as he gets further into his deal.

Manchester City have a verbal agreement to sign the goalkeeper

# SUARES: Nunez can 'write his own story' at Liverpool

LUIS SUAREZ has backed Darwin Nunez to "write his own story" at Liverpool following his record move to Anfield.

Nunez, 22, will become the third Uruguayan to don the red shirt after he completed his transfer from Benfica this month for an initial £64million.

The forward follows in the footsteps of former Reds forward Suarez, who became the first player from the South American country to sign for the club in 2011, before Sebastian Coates followed him later that year.

If Nunez can perform anywhere near to Suarez's level then Liverpool will have a superstar on their hands. Suarez scored 82 goals in 133 games across three-and-a-half years with the Reds, during which he almost led them to the Premier League title in 2013-14 before leaving for Barcelona.

The 35-year-old believes his compatriot, who could eventually cost a club-record £85m,

should not be compared to him.

Suarez said: "He will write his own story at Liverpool. He is Uruguayan and he is a forward but that is where the comparisons stop – he is a special player and doesn't need to be compared with anybody. "He is going to a great club with one of the best coaches in the world, players he can learn off, and of course those special fans." Suarez has offered to give his fellow Uruguayan some tips for life in England and the Premier League.

He said: "I can be there to offer him advice about England and about the style of play – but I don't think he will need it – he will let his talent do the talking."

Nunez became one of Europe's most wanted strikers last season as he notched 34 goals.

Liverpool manager Jurgen Klopp was highly impressed with

him when his side were preparing to face Benfica in the last eight of the Champions League as the Reds staff analyzed their opponents. Nunez then scored in both legs, despite Benfica being comfortably beaten.

But things could have been very different for

taken Suarez's advice. Nunez played with Almeria in Spain in the 2019-20 season and Suarez urged his former club to sign his compatriot.

His recommendation was ignored and he ended up leaving for

Benfica in September 2020. Suarez said: "Last

season Europe started to take notice of him because of his performances for Benfica – but from an early age I could see there was something special in him."

# Arsenal plan improved bid for Leeds' Raphinha as Spurs and Chelsea loom

■ Leeds likely to demand at least £65m for Brazil international

Arsenal have had an offer rejected by Leeds for Raphinha but intend to push again to sign the Brazil international amid competition from two other Premier League clubs and Barcelona.

Tottenham have told Leeds they plan to bid – that could arrive this week – and Chelsea's co-owner Todd Boehly, the interim sporting director, has explored the situation. Barcelona agreed personal terms with the winger months ago but Leeds want far more than the £35m-£40m the Catalan club have in mind.

It is likely to require at least £65m to convince

them to sell. Arsenal have been interested in the 25yearold since March and have been in negotiations with Leeds, who bought Raphinha from Rennes for about £17m in October 2020 on a contract to 2024. He scored 11 goals and set up three in the Premier League last season.

have Arsenal strengthened their options attacking by buying Fábio Vieira from Porto for an initial £30m but also want to bring in Raphinha and his international teammate Gabriel Jesus, who is poised to leave Manchester City.

Spurs and Paris Saint-Germain are among others interested in Jesus. But Arsenal are leading the race and are in advanced talks with the player's agents. If outstanding details are resolved they will look to settle on a fee with City.

Manchester City have agreed a £45m deal with Leeds for England midfielder Kalvin Phillips.

The club will pay  $\pounds$ 42m for the 26-year-old with potential bonuses of  $\pounds$ 3m.

The Premier League champions made Phillips their number one summer transfer target, with Fernandinho leaving this summer after nine years with the club.

Phillips was in the Leeds academy and has made 214 appearances for the side since his senior debut in 2015. The midfielder is expected to provide back up for Rodri at City in the single defensive midfield position favoured by manager Pep Guardiola. A key player for Leeds under former boss Marcelo Bielsa, Phillips has also shown his ability to operate higher up the pitch alongside Declan Rice for England.

England's Matt Fitzpatrick was swamped by his family after superbly holding off the world's best players to claim his first major title with a one-shot victory in the US Open at Brookline on Sunday.

The 27-year-old was also hugged by Rory McIlroy on the 18th green as he became just the third Englishman in 52 years to win the sport's second oldest major.

Fitzpatrick shot a twounder 68 for a six-under total to beat world number one Scottie Scheffler (67) and Will Zalatoris (69) in a gripping battle that went to the final hole.

"It's what you grow up dreaming of," said Fitzpatrick. "It's something I've worked so hard for for such a long time. I've got to give myself credit: I had so much patience." His win will be remembered for the stunning shot he played from a fairway bunker on the 18th.

In scenes reminiscent of Sandy Lyle's final-hole bunker shot on his way to winning the 1988 Masters at Augusta National, Fitzpatrick launched a high cut at the green, the ball landing 20 feet beyond the flag and spinning a couple of feet closer.

A two-putt par was then enough to spark scenes of sheer jubilation as his mum, dad and brother embraced him on the green.

S h e f f i e l d - b o r n Fitzpatrick, who also won the US Amateur title at Brookline back in 2013 joins Jack Nicklaus as the only two men to win both that and the US Open at the same venue - Nicklaus achieved the feat at Pebble Beach. He is also the first non-American to win both titles.

And he joins 1970 champion Tony Jacklin and 2013 victor Justin Rose as modern-day English winners of the US Open. He is the first British winner of a men's major since Danny Willett at the 2016 Masters.

Fitzpatrick hit 17 of 18 greens in regulation in a stunning display of control and consistency, but the shot he will be remembered for is his remarkable recovery shot from the bunker on 18.

"If there's one shot I just did not want this year it's a fairway bunker shot," said Fitzpatrick. "When I saw it leave the sand I couldn't be happier."

While Rahm saw his challenge fizzle out with a final-round 74, it was another missed chance for McIlroy to add to his four

McIlroy could never find any consistency in his one-under 69, following all of his three front-nine birdies with bogeys. Two late birdies pushed him up into a tied-fifth finish. It is a 16th top-10 finish,

this as another missed opportunity just as Southern Hills was, but missed opportunities are better than not contending at all, " said McIlroy.

"So that is a positive. I have to stay patient at this point because if I just keep putting myself in position, sooner or later it's going to be my day and I'm going to get one."

# United lead hunt for great Dane

MANCHESTER United are in pole position to snap up Christian Eriksen after Spurs backed away from resigning him.

The midfielder made a successful comeback with Brentford last season after his cardiac arrest while playing for Denmark at Euro 2020.

He is available on a free transfer but Tottenham have not been involved in any serious discussions to take him back.

Eriksen has been offered the chance to stay at Brentford and will make Bees boss Thomas Frank the first to know his next move.

Spurs head coach Antonio Conte worked with Eriksen at Inter Milan, where they won Serie A in 2021. Before Eriksen returned to playing competitively, Conte said "the door is
