# EMBATTLED TRUSS COMES OUT FIGHTING

## ■ PM goes on offensive after damaging tax cuts U-turn

**THE PRIME Minister shrugged off an embarrassing public U-turn on tax cuts this week with a defiant speech to her fellow Tories, vowing to get Britain “through the tempest”.**

Speaking to the Tory grassroots at the end of the party's autumn conference in Birmingham, Liz Truss promised to protect the British people saying: “I've got your back.”

Truss was clearly eager to haul her premiership back on track, throwing the party faithful some reliable red meat, including taking aim at “enemies of enterprise” who she blamed for stopping the country from prospering.

She also insisted that she is on the side of people who do the right thing.

She said: “In these tough times, we need to step up. I am determined to get Britain moving, to get us through the tempest and put us on a stronger footing as a nation.”

“You can trust me to do what it takes. Together, we can unleash the full potential of our great country.

“That is how we will build a new Britain for a new era.”

The Prime Minister came out fighting after a difficult week of divisions, saying “we must stay the course” in pursuit of her three priorities, which she said were: “Growth, growth and growth.”

She endured a rocky first conference as Prime Minister after senior figures in the party turned on each other over taxes and benefits.

### ‘same old answers’

Explaining her call to reverse plans to axe the 45p top tax rate – announced by Chancellor Kwasi Kwarteng, Ms Truss told delegates: “I get it and I have listened.”

The PM described the party's real opponents as an “anti-growth coalition” of vested interests who always turn to tax increases and red tape.

Ms Truss was unfazed when two Greenpeace protesters stood up, shouting and waving a banner.

She used the disturbance to highlight her opposition to people who prefer “protesting to doing” – such as militant unions, Brexit critics and Extinction Rebellion activists.

Ms Truss told Tories those groups prefer “talking on Twitter to taking tough decisions. They taxi from North London townhouses to the BBC studio to dismiss anyone challenging the status quo.

“From broadcast to podcast, they peddle the same old answers. It's always more taxes, more regulation and more meddling.” The Prime Minister described her opponents as: “Wrong, wrong, wrong.”

She went on: “We see

the anti-growth coalition at work across the country. Keir Starmer wants to put extra taxes on the companies we need to invest in our energy security. And his sticking plaster solution will only last six months.

“He has no long-term plan and no vision for Britain.”

Lumping in Welsh First Minister Mark Drakeford and Scotland's leader Nicola Sturgeon, Ms Truss said: “Have these people ever seen a tax rise they don't like?

“Or an industry they don't want to control? They don't understand the British people. They don't understand aspiration. They are prepared to leave our towns and cities facing decline.”

She said the “anti-growth coalition just doesn't get it” as they do not face the same challenges that typical working people do.

She told delegates: “These enemies of enterprise don't know the frustration you feel to see your road blocked by

protesters, or the trains off due to a strike.

“In fact, their friends on the hard Left tend to be the ones behind the disruption. The anti-growth coalition think the people who stick themselves to trains, roads and buildings are heroes. I say the real heroes are those who go to work, take responsibility and aspire to a better life for themselves and their family. And I am on their side.”

# Truss in humbling U-turn over tax cuts

■ PM faces huge early setback after party revolt, but spins retreat as "listening to people's concerns"

Liz Truss has ditched plans to axe the 45p top rate of tax after what she described as "listening to people's concerns".

The Prime Minister, who has been in the top job for barely a month, admitted it had not been an "easy week" but promised to reward the nation's trust in her.

The tax row and ensuring financial chaos, which exploded two weeks ago following Chancellor's Kwasi Kwarteng mini-budget, was overshadowing her plan for growth to get Britain heading in the right direction, she said.

Ms Truss added: "Our plan for growth is essential to get the British economy moving...rest assured: we will reward your trust."

"It has not been an easy week, but we have shown that we listen to people's concerns and we are determined to deliver on our core plan for economic success and security. Growth is the only way to create jobs, boost wages and fund our vital public services like the NHS."

"With our Energy Price Guarantee we are

supporting families and businesses with their energy bills.

"With our tax cuts we will put money back in the pockets of hard-working people and grow our economy."

"With our investment plans we will unleash the potential of the whole country and get Britain moving."

"This is the best country in the world and I will do what it takes to put us on the path to a more secure, prosperous future."

One Cabinet minister

said the move was a "sensible retreat" and that wars are won from the flank rather than from a head-on assault.

Tory veteran Nadine Dorries, who backed Ms Truss for the Conservative Party leadership, said the PM should call a general election if she wants to break away from the policies put in place under Boris Johnson.

She said there was "widespread dismay at the fact that three years of work have effectively been put on hold".

# Gove slammed by Braverman over tax 'coup'

IN A SIGN that the Conservative Party remains as divided as ever despite its recent election of a new leader, top Tory Suella Braverman this week lashed out at Michael Gove and rebel Tories who as she put it, "staged a coup" over the Government's plans to slash income tax for the highest earners.

The Home Secretary expressed her disapproval that Liz Truss and Kwasi Kwarteng had been forced to ditch the plan following an MPs revolt.

She told a fringe conference event in Birmingham: "I'm very disappointed that members of our own parliamentary party staged a coup effectively and undermined the authority of the Prime Minister in an unprofessional way."

Ms Braverman revealed she had been in favour of cutting the higher rate of tax, which she said would have driven growth and encouraged higher earners to work more. She said: "I'm disappointed about the subsequent reversal but I accept their reasons."

And she singled out Mr Gove, saying he should not have intervened, adding: "He got it wrong on this. We should be uniting behind our Prime Minister. We're on the same team and we should be focused on delivering for the British people."

Asked what she would say to Mr Gove, she replied: "Michael,

if you've got concerns, raise them in private."

Levelling Up Secretary Simon Clarke, one of Ms Truss' closest allies, said: "Suella speaks a lot of good sense, as usual".

But Tory MP Steve Double said the dissenters were simply "doing our job" as backbenchers and warned the Cabinet is "in for a bumpy ride".

# British missiles the key to success, say Ukrainians

DEVASTATING British guided missiles are helping Ukraine to push back Russian invaders in the east of the country.

The commander of an artillery unit said: "Thanks to these weapons, we've carried out really high priority missions."

These included hitting key enemy military bases, columns of armoured vehicles and ammunition supplies.

The missiles, fired by six British supplied Multiple-Launch Rocket Systems,

or M31A1, are precision-guided and have a range of more than 50 miles.

Speaking to Sky News, the commander said, in his opinion, around 30 per cent of the successes achieved by Ukraine in a major counter-offensive in the east were thanks to British, as well as German, rocket launchers.

Kyiv says it has made significant gains across four regions illegally annexed by Moscow. Luhansk governor Serhiy Haidai said: "Several

settlements have already been liberated from the Russian army."

There are also reports of major breakthroughs in the Kherson, Donetsk and Zaporizhzhia regions.

In a rousing address, Ukraine president Volodymyr Zelensky declared: "Our soldiers do not stop."

"And it's only a matter of time before we expel the occupier from all of our land."

Vladimir Putin seem to have disappeared after the Russian president's decision to rubber-stamp the "annexation" of the four regions on Monday.

Andriy Yermak, head of Zelensky's presidential office, said: "Worthless decisions by a terrorist country are not worth the paper they are signed on."

Retreating Russian forces have been ordered to dig in on a new defensive line. Dmitry Peskov, Kremlin spokesman, claimed: "The four regions will be with Russia forever."

A pledge by the Biden administration to send an extra £547million in military aid to Ukraine triggered threats of a "direct military clash" between Russia and the US.

Anatoly Antonov, Russia's ambassador to America, said: "We call on Washington to stop its provocative actions that could lead to the most serious consequences."

# Harry and Meghan reportedly 'at odds' with Netflix over docuseries

■ Harry keen to tone down criticism of Royal Family after trip home for Queen's funeral

**THE DUKE and Duchess of Sussex are reportedly "at odds" with Netflix over their docuseries – after the nation's reaction to the Queen's death made them "desperate" to delay it.**

It is claimed Harry and Meghan have asked the streaming network to hold airing the show "until next year" while making edits to the content.

These reportedly include "toning down" remarks about the Duke's father King Charles III and his stepmother Camilla, the Queen Consort.

A Netflix insider said: "Harry and Meghan are panicked about trying to tone down even the most basic language. But it's their story, from their own mouths."

And another source said: "They've made significant requests to walk back content they

have provided – to the extent some Netflix staff believe, if granted, it will effectively shelve the project indefinitely."

The production was due to air in December – after the fifth season of *The Crown* next month. Netflix sources insist filmmakers are trying to keep it unchanged and push forward.

Harry, 38, and Meghan, 41, made the series as part of a reported \$100million (£88.5million) deal with the streaming giant. Netflix had no immediate comment.

Meanwhile the Duke's literary memoir – originally expected to be published by Penguin Random House in November – is also said to have been pushed back until next year.

It is suggested Harry, who has a near £40million three-book deal, wants to make alterations,

The royal couple struck a \$100m content deal with Netflix - and now they have to deliver



including to content that "might not go down too well".

The delays come as a bombshell book claims anxious royal staff felt "sick" before working with the Sussexes. Some are said to have been left "shaking" ahead of meetings with Meghan. The Duchess's representatives

have denied bullying allegations.

They said it was she who was bullied and the couple are being targeted with a smear campaign. But Valentine Low, author of *Courtiers: the Hidden Power Behind the Crown*, says staff called themselves the "Sussex Survivors' Club". Buckingham Palace

launched a review into 2018 claims of bullying by Meghan, but refused to release details of the findings earlier this year.

Commenting this week, Mr Low described Prince Harry as "paranoid" and told ITV's *Good Morning Britain* he would do "loyalty tests" on Palace staff to check if they were still "fighting for him".

## Rolf Harris is "gravely sick" and receiving round-the-clock care

**CONVICTED paedophile Rolf Harris is "gravely sick" and receiving round-the-clock help, according to friends and neighbours.**

The 92-year-old former TV personality rarely leaves his home and is now relying on carers and nurses.

Harris, (pictured, right) who lives in Berkshire with wife of 64 years Alwen Hughes who has Alzheimer's disease, was released from prison five years ago.

The Australian is reported to have taken a turn for the worse after the death of his beloved poodle this year.

Neighbour Portia

Wooderson said: "I'm told he can't eat any more."

Author William Merritt confirmed Harris was "gravely sick" and revealed it was difficult to understand him when he communicates.

But he insisted the artist would still try to be an entertainer on the rare occasions he had guests.

Merritt added: "As soon as one of two people walk into the room, he turns into a big kid again. He's an artistic type, and he'll try to perform on cue, even when he is unwell."

A neighbour reported in 2019 that Harris's health had "declined rapidly" and that he left

the house only with a carer.

It is reported the curtains of the house are now rarely opened before 11.30am and the couple effectively spend their entire time at home.

Harris was freed from jail in May 2017 having served three years of his five years and nine month sentence after being found guilty of 12 counts of sexual assault, one of which was later overturned.

He has not spoken publicly since his release but he is quoted in Merritt's 2022 book *Rolf Harris: The Defence Team's Special Investigator Reveals the Truth Behind the Trials*.

Harris said: "We live in the post-truth era and know few will want to know what really happened during the three criminal trials I cont. on page 4, col. 3

# Olivia's grieving parents come face to face with alleged killer

**THE grieving parents of nine-year-old Olivia Pratt-Korbel came face-to-face with the man accused of killing her when he appeared in the dock for the first time this week.**

Olivia was shot dead and her mother Cheryl wounded while trying to stop a gunman chasing convicted burglar Joseph Nee into their home in Dovecot, Liverpool, on 22 August.

Cheryl, 46, and Olivia's father John Francis Pratt watched as Thomas Cashman, 34, appeared before the city's magistrates accused of the schoolgirl's murder – and later at Liverpool Crown Court.

The first hearing lasted just 10 minutes with Cashman flanked by four police officers. Olivia's parents were joined by more than 20 members of the media.

In the afternoon the accused appeared in handcuffs wearing a grey T-shirt at Liverpool Crown Court where he was remanded in custody.

## 'never be forgotten'

Cashman, of West Derby, stared at the floor for most of the 15-minute hearing. No application was made by his legal team for bail.

He is charged with Olivia's murder and with the attempted murders

of Cheryl and Nee, as well as two counts of possessing a firearm with intent to endanger life. A provisional trial date was set for March 6, with a plea and trial preparation hearing to take place on January 10.

Prosecutor David McLachlan KC told a judge that the murder trial is expected to last four weeks.

Judge Neil Flewitt KC said Cashman will appear at the next hearing via video-link, adding: "In the meantime you must remain in custody."

Earlier, Paul Russell appeared at Liverpool Magistrates' Court charged with assisting an offender.

Russell, 40, also of West Derby, is alleged to have helped Cashman by driving him away from the scene and disposing of clothing, the court heard.

No application for bail was made and he was remanded in custody until October 31.

Olivia's funeral was held at St Margaret Mary's Church in Knotty Ash last month, with mourners wearing pink ties, jackets, scarves and bows after her family asked people to wear a "splash of pink".

Cheryl carried a pink teddy bear into the service, during which she said: "Liv touched so many people's hearts

and was loved and adored by everyone. She will never be forgotten. "I will never say

goodbye but what I will say is goodnight, love you, see you in the morning."

## Wagatha Christie trial: loser Vardy may have to pay millions

### ■ Rebekah ordered to pay Coleen's legal costs

**WAGATHA Christie libel loser Rebekah Vardy must fork out £1.5million towards rival Coleen Rooney's legal costs, a judge ruled this week.**

Mother-of-five Rebekah, 40, faces the bill after unsuccessfully suing Coleen, 36, for saying she leaked private stories about her to a national newspaper.

The High Court trial was dubbed Wagatha Christie after Coleen, wife of ex-England captain Wayne Rooney, 36, accused Rebekah following an online sting op in 2019.

The humiliating court defeat also means Rebekah, who is married to Leicester City striker Jamie Vardy, 35, faces a multi-million-pound legal bill of her own. That could bring her combined cost to £3million-plus. Court

documents show she must pay 90 per cent of Coleen's costs, with an initial £800,000 payment by November 15.

The Rooney legal team has not yet produced a final fees total, but the

last figure presented to the court was £1,667,860.

Mum-of-four Coleen had argued Rebekah should pay 100 per cent of her costs. Rebekah had asked to pay 80 per cent.

The judge, Mrs Justice Steyn, justified the 10 per cent reduction by citing issues arising from the seven-day trial. They included Coleen's "weak" allegation that Rebekah was one of

the people behind The Sun's "Secret Wag" gossip column, and unsuccessful public interest defence.

Rebekah will also have to pay some of the costs incurred by seven journalists who were potential trial witnesses, but did not give evidence.

She has always denied she passed the information from Coleen's private Instagram to The Sun. But in July, Mrs Justice Steyn ruled

Coleen's accusation was "substantially true". The judge said it was likely Rebekah "knew of, condoned and was actively engaged" in the process of leaking stories about Coleen, in collaboration with her agent, Caroline Watt.

Ms Vardy this week posted an image on her private Instagram account saying: "It's always the ones with the dirty hands pointing the fingers."

It was not clear who or what the post referred to.

faced.

"It's easier to condemn me and liken me to people like Savile and Glitter. I was convicted of offences I did not commit in my first trial.

"That is the view of

the Court of Appeal who overturned one of my convictions. The evidence William Merritt found proved my innocence to two subsequent juries.

"I'd be in prison for crimes I did not commit if it were not for William's investigation. It is difficult to put into words the injustice I feel."

understands the “hopes and fears” of the public since they are the same as hers.

Setting out a vision of “modern Conservatism”, the Prime Minister declared: “I believe that you know best how to spend your own money, to get on in life and realise your own ambitions. That is what Conservatism is about.

“It is a belief in freedom, in fair play and the great potential of the British people.

“So, I’m not going to tell you what to do, or what to think or how to live your life.

“I’m not interested in how many 2-for-1 offers you buy at the supermarket, how you spend your spare time, or in virtue signalling.”

## Rugby Union internationals ‘more than twice as likely’ as the general population to develop dementia

**Rugby union internationals are more than twice as likely as the general population to develop dementia, research on Scottish players suggests.**

Studies also show their cases of motor neurone disease rise 15-fold while Parkinson’s hits three times as many.

The findings, from 412 Scottish ex-internationals aged at least 30 by the end of 2020, echo earlier studies of other sports. The players were matched with 1,236 members of the public.

Scientists say changes to reduce head impacts and injuries are needed in all sports and rugby officials have moved to improve the detection of concussion injuries and

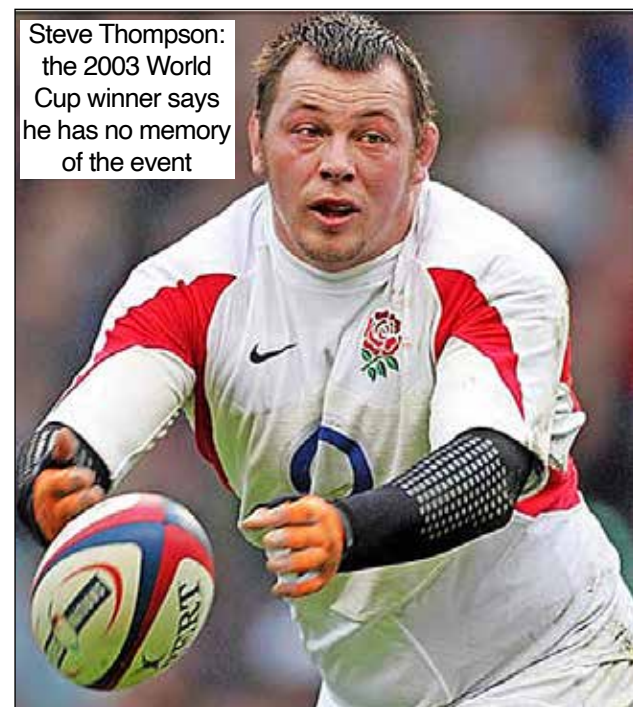
to cut in-game risks.

But study lead author Dr William Stewart, of the University of Glasgow, said: “Head impact exposures and concussion risk are not isolated to match play. Measures to reduce exposures in training might also be considered a priority”.

England World Cup winner Steve Thompson was diagnosed with early-onset dementia in 2020. He has said his career “wasn’t worth it” as he does not want to be “a burden” to his family.”

In the BBC Two documentary Head On: Rugby, Dementia and Me, Steve, 44, says he cannot recall winning the Webb Ellis Cup in 2003.

Traumatic brain injury is a major risk factor for neurodegenerative disease. The chance of being diagnosed with a neurodegenerative disease was 11.5 per cent for the rugby players, 5.5 per cent for other men. No differences in cause of or age at death were seen in the groups.

The study is in The Journal of Neurology Neurosurgery & Psychiatry.

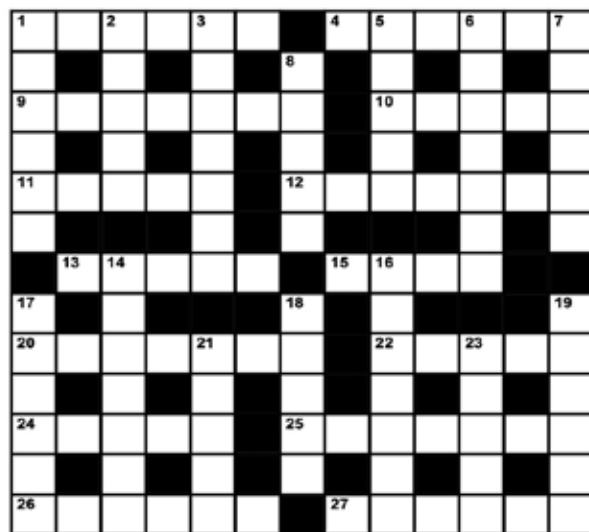

Supportive Son urges patience

HEUNG-MIN SON has told Tottenham to stick with head coach Antonio Conte's methods because he's a winner.

Last season's Golden Boot winner has failed to score in the past two games after breaking his goal drought with a 14-minute hat-trick

And no Spurs player has netted in open play in their past four away games, leading to criticism of the caution shown by Conte.

The fiery Italian bristled that he could "teach football to many people" before the goalless Champions League draw against Eintracht Frankfurt.

But Son said it was important to persevere with Conte's blueprint after he delivered a top-four finish in the Premier League

The Korea striker said: "Last season nobody believed we'd be in the Champions League. "The gaffer always wants more, more, more, and as a player I want to follow his way. If we don't, then you know you'll struggle."

"He's a winner and we have to sacrifice and do the hard things." Conte cut an agitated figure on the touchline in Frankfurt as Spurs spurned a hatful of chances to leave their Champions League progress in the balance.

But Tottenham, who go to in-form Brighton on Saturday, are third in the Premier League and second in a tight Champions League Group D.

Son said: "We have to stick together in these tough games. These criticisms are because expectations are higher." Spurs have not won away in Europe since February 2021.

## Europa League: Nketiah, Holding and Vieira on target as Arsenal brush aside Bodo/Glimt

**Arsenal put in another strong display to comfortably see off Bodo/Glimt, 3-0 in the Europa League at the Emirates Thursday night.**

Striker Eddie Nketiah reacted to poke in the opener after Kieran Tierney's powerful effort came back off the post.

Fabio Vieira crossed it in for Rob Holding to head in a second before the Portuguese made it 3-0 late on.

Mikel Arteta's

side have won four successive matches in all competitions and top their Europa League group, as well as leading the Premier League.

They looked like a team playing full of confidence despite Arteta making eight changes from the side that beat rivals Tottenham in the weekend's north London derby.

Nketiah, who also scored in the 2-1 victory over Zurich in September, came into the

team and was a threat throughout.

He deserved his goal when he pounced on the rebound from Tierney's strike - he had curled it inches wide earlier and teed up Vieira for his effort which struck the crossbar within 10 minutes.

Vieira was also hugely impressive, coming close on several occasions as well as providing the quality service for Holding's goal and scoring himself when he

finished off a scintillating move by Gabriel Jesus.

Captain Granit Xhaka had a free-kick tipped over the bar and another shot saved by goalkeeper Nikita Haikin as Arsenal could easily have added to their tally.

Norwegian side

Bodo/Glimt grew into the game in the second half and posed a threat but Arsenal goalkeeper Matt Turner was not tested enough and they lacked a clinical edge.

There were signs though that Arsenal will need to be at their best

again when they travel to Norway for a second meeting next week.

With two wins from as many group games so far, Arsenal now top Group A by two points over PSV Eindhoven, who they face on 20 October.

## Resurgent Rashford saves jittery United's blushes

**An inspired substitute performance from Marcus Rashford earned Manchester United a nervy 3-2 Europa League win over Omonia Nicosia on Thursday night.**

The Cypriot side took a shock lead into half time through Karim Ansarifard, before United manager Erik Ten Hag introduced Rashford and he scored eight minutes later before setting up fellow sub Antony Martial to finish.

Rashford made it 3-1 late on, before Nikolas Panayiotou pulled one back on an unexpectedly edgy night for United.

Following United's chastening derby defeat at the weekend, Ten Hag made three changes with the headline being the return of Cristiano Ronaldo in place of Rashford up front.

However it was ultimately the English forward who saved his side from an embarrassing defeat, while Ronaldo spurned several chances to score his 700th club career goal.

The visitors made all

the running in the first half an hour - nine shots and around 80 per cent possession - but the Cypriots stood up well and took their chance when it came.

Fernandes hit the crossbar with a chipped effort midway through the first half, and shortly after Fabiano brilliantly denied a 25-yard effort from Antony before Iran striker Ansarifard struck.

United overcommitted at a corner, allowing a three-on-one Omonia breakaway with striker Bruno carrying the ball nearly 50 yards. The Brazilian played in Ansarifard, and the former Nottingham Forest striker superbly finished into the roof of the net.

Ten Hag's double change saw Rashford and Luke Shaw replacing Tyrell Malacia and the Jadon Sancho, and it paid off eight minutes after the restart - Rashford was released by a raking ball down the left by

Fernandes, Ronaldo's run drew the defence and the England international had time and space to curl

beyond Fabiano.

Ten Hag then introduced Martial after the hour, and he combined with Rashford to put his side ahead.


Martial's second touch of the game began a flicked one-two with Rashford, the third saw him finish with power a shot past Fabiano at the near post.

Ronaldo meanwhile continued to struggle, his clearest opening coming when Diogo Dalot pulled the ball back to him eight yards out with Fabiano stranded, but somehow he contrived to hit the post.

Instead Ronaldo had to settle with an assist for United's third and Rashford's second, firing a low cross into the six-yard area for a tap-in.

Spirited Omonia were not done yet though, reducing the deficit almost straight away as Panayiotou turned a tricky bouncing cross home with his left foot.

United saw the game out, but remain second in Group E after Real Sociedad won 2-0 in Sheriff.
