# SPACEY 'TRIED BY SOCIAL MEDIA'

■ Defence rests in London trial of Hollywood star accused of nine sexual offences

Oscar-winning actor Kevin Spacey was "tried by social media" after he was accused of sexual assaults, a court has heard.

He is charged with nine sexual offences relating to four men allegedly committed between 2001 and 2013.

The 63-year-old American sat in the dock on Thursday at Southwark Crown Court in London as defence barrister Patrick Gibbs KC gave a closing speech.

Mr Spacey, a two-time Oscar winner, denies all of the charges against him.

"What the defence suggests is that three people have lied and they have lied in ways and for reasons which, ultimately, will only ever be known to themselves," said Mr Gibbs, who suggested the fourth complainant was intoxicated.

He told jurors: "It's not a crime to like sex, even if you're famous and it's not a crime to have sex, even if you're famous, and it's not a crime to have casual sex.

"And it's not a crime to

have sex with someone of the same sex because it's 2023 not 1823."

He challenged the Crown's claim that there was a "pattern of similarity" between the accusers because three claim Mr Spacey "grabbed" them by the crotch, a term Mr Spacey previously told the court he "objected" to.

He told the jury it was "easy" to lie convincingly, especially when it is about someone such as Kevin Spacey who he described as a man "who is promiscuous, not publicly out, although everyone in the businesses knows he's gay who wants to be just a normal guy to drink beer and laugh and smoke weed and sit in the front and spend time with younger people who he's attracted to".

He said perhaps Mr Spacey had led "a bit of an odd life", but that it was "a life that makes you

an easy target when the internet turns against you and you're tried by social media".

"That's when these claims were taken to the police, when it was, I suggest, only too easy to do and the prospects of a pay-off from the bandwagon were at their most irresistible."

Mr Gibbs praised Sir Elton John and his husband David Furnish for risking the "wrath of the internet" to be called as defence witnesses after they gave evidence via video link from Monaco on Monday.

Mr Spacey pleaded not guilty in January to three counts of indecent assault, three counts of sexual assault and one count of causing a person to engage in sexual activity without consent.

He also previously denied four further charges of sexual assault and one count of causing

a person to engage in penetrative sexual activity without consent.

A further charge of indecent assault, an alternative count, was added mid-trial - taking

the total number of alleged offences listed on the indictment to 13.

On Wednesday, the four indecent assault charges, which were all alternative counts,

were struck off by the judge, due to a "legal technicality" and not as a result of the prosecution abandoning any allegation.

The trial continues.

## 18 months of bird for Creme Egg bandit

A man referred to as the "Easter bunny" by police has been sentenced to 18 months in prison for stealing almost 200,000 Cadbury Creme Eggs.

Joby Pool, 32, stole more than £31,000 worth of the chocolate eggs when he

broke into an industrial unit in Telford on 11 February and made off with the haul in a stolen lorry cab.

Judge Anthony Lowe jailed Pool for 18 months at Shrewsbury crown court on Thursday, half to be spent in prison and the other half on licence. The

six months he has already spent in custody will be counted towards his nine months in jail.

Shortly after his arrest, West Mercia police described the incident in a series of tweets as an "eggs-travagant theft" of a "chocolate collection box".

# Commonwealth Games future in doubt as Australian hosts bow out

## ■ State of Victoria in U-turn over cost fears

The 2026 Commonwealth Games are in doubt after the Australian state of Victoria cancelled its plans to host due to budget blowouts.

The Commonwealth Games Federation (CGF) struggled to find a host before Victoria volunteered in April 2022.

But the premier said the projected cost had now tripled and become "well and truly too much" for the state to bear.

The CGF called the decision "hugely disappointing" and said it is "committed to finding a solution".

The Commonwealth Games are a multi-sport tournament that take place every four years.

They have only ever been cancelled during World War Two.

To be eligible to participate in the games, competitors must be from one of the Commonwealth's 56 members. Most of the countries in the Commonwealth were once part of the British Empire.

### 'all cost and no benefit'

Victorian Premier Daniel Andrews said on Tuesday that his state had been "happy to help out" when approached to host last year, but "not at any price".

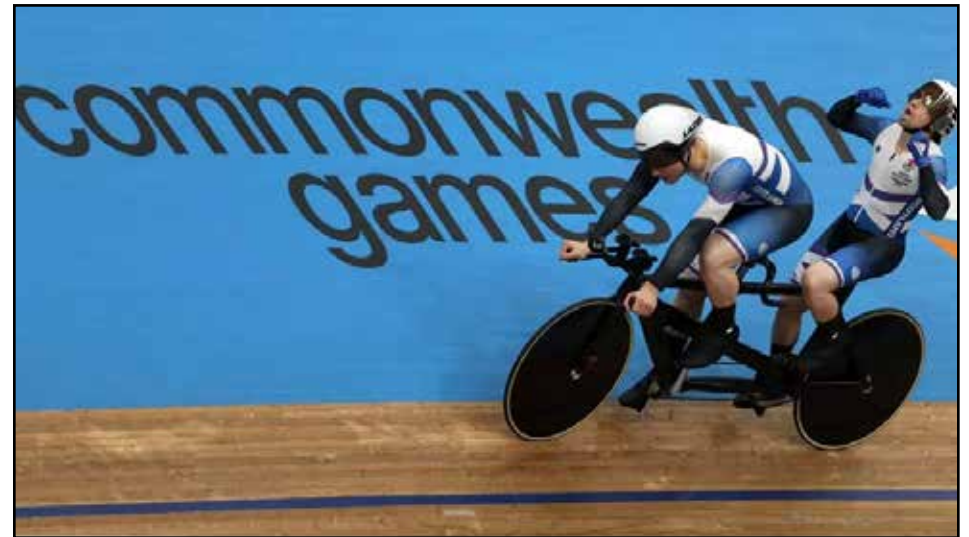
Downing Street said the cancellation was "disappointing" for fans

and athletes.

Prime Minister Rishi Sunak's spokesman said the UK government hoped "a viable solution" could be found by the Australian authorities and the CGF.

He rejected a claim of the move was a sign of the decline of the Commonwealth as a whole, suggesting the King's coronation showed "the strength of the Commonwealth and commitment of countries to it".

Organisers had originally estimated the event - hosted across cities including Geelong, Bendigo and Ballarat - would cost A\$2.6bn (£1.4bn; \$1.8bn) and the

state government had billed it as a boost for the regions.

But now the 12-day tournament was expected to cost more than A\$6 billion (£3.13bn; \$4.09bn), Mr Andrews said, adding that the new figure was "more than twice the estimated economic benefit" it would bring to Victoria.

"I've made a lot of difficult calls, a lot of very difficult decisions in this job. This is not one

of them," he told a press conference.

"That is all cost and no benefit."

The government will still complete the stadium upgrades it had promised ahead of the games, while using the money it is now saving on housing and tourism initiatives.

Mr Andrew said the government had considered "every option" including moving the games to Melbourne, before informing CGF of

their decision.

"Amicable and productive" meetings had occurred in London overnight, he added.

But in a statement on Tuesday, the governing body said they were blindsided by the decision.

"We are disappointed that we were only given eight hours' notice and that no consideration was given to discussing the situation to jointly find solutions," it said in a statement.

## British Army set to shrink to lowest numbers since Napoleonic Wars

THE BRITISH Army will have its fewest number of troops since the Napoleonic Wars, ministers have confirmed.

Despite fears we are already unable to field a war-fighting division, commanders can call upon just 73,000 fully trained soldiers - the lowest number since 1800.

The warning comes in the face of cuts to troop numbers that had been planned since 2021, before the start of the war in Ukraine.

But critics including senior Tory MPs warned yesterday it was "bonkers" to slash them further.

Former Armed Forces minister, Mark Francois,

said: "If you look at the Army, some of the vehicles we would have to fight with, because of these procurement failures, are 40, 50 or even 60 years old.

"We cannot field a full war fighting division, which is a commitment to Nato.

"The [Commons] Defence Committee has only just published a

report saying our Army is already too under-equipped to meet our Nato commitments. So to now cut it even further is just bonkers."

Ex-Army colonel Hamish de Bretton-Gordon, said: "The Ukraine war is showing us that manpower, as well as tech, is important.

"You get the feeling that this might be too heavily focused on cyber 'kids' and tech, forgetting that we still need soldiers to close with and kill the enemy."

Meanwhile, the Ministry of Defence is also set to cut the number of tanks operated by British troops, as the war in Ukraine has shown how simple handheld weapons can destroy them.

The Government is expected to defend the planned manpower cuts, arguing that the Ukraine war had demonstrated that quick, well-executed

operations could destroy large forces.

A Government source said: "The war in Ukraine - fought on a scale not thought possible in this generation - has taught us many lessons.

"We have seen there, for instance, how our forces

can become fletcher of foot.

"As we provide for our troops with the highest-ever defence budget, this command paper will see us modernise and adapt to emerging technologies and defend these shores with forces that are fit for the future."

# United legend Giggs “deeply relieved” as domestic violence charges are dropped

■ “His intention is to resume his managerial and coaching career. He’s got unfinished business in the game.”

**MANCHESTER** United legend Ryan Giggs is “deeply relieved” and hopes to rebuild his life after domestic violence charges were dropped.

Giggs, 48, denied head-butting ex-lover Kate Greville, 38, and elbowing her sister Emma, 26.

He also denied controlling or coercive behaviour towards Kate.

The ex-winger was due on trial again on the same charges after a jury last year failed to reach a verdict.

But Manchester Crown Court heard the Greville sisters did not want to be involved again as the first trial had “taken its toll”, prompting prosecutors to offer no evidence

on Monday. Not guilty verdicts were entered.

Sources close to Mr Giggs said: “His intention is to resume his managerial and coaching career. He’s got unfinished business in the game.

“The last three years his life has been put on hold but he’s a huge football man.”

**‘very many lies’**

The star’s barrister Chris Daw KC said he “is deeply relieved the prosecution has finally come to an end after almost three years in which he’s been fighting throughout to clear his name”.

Mr Daw added: “He now intends to rebuild

his life and career as an innocent man. He has always been innocent of these charges – there’s been very, very many lies told about him in court.”

The Cardiff-born star, left, made 672 senior United appearances and won 64 caps for Wales.

He became national coach but stepped back in 2020 after being arrested and quit altogether in June last year while awaiting the case.

During the trial Giggs admitted to being unfaithful but, when asked if he had ever physically assaulted a woman, he said, “No”, adding that he had never set out to control or coerce a woman.

The trial was told of

the alleged assault in November 2020 at his home in Worsley, Greater Manchester, where the couple returned following a row at dinner in which Kate Greville accused Mr Giggs of messaging other women.

Jurors heard the pair tussled over their phones. Emma, who was looking after the couple’s dog, called the police. Mr Giggs alleged Kate kicked him in the head,

which she denied.

Prosecutor Peter Wright KC told the court yesterday the decision to drop the case was not “taken lightly”.

He said: “Ms Greville and her sister Emma gave evidence over a number of days in a case when there was considerable media and public interest, and it is that particularly that’s taken its toll, in particular Kate Greville.”

Mr Wright said there was no realistic prospect of conviction on controlling behaviour, and it was no longer in the public interest to proceed to prosecute on the other charges of assault.

The Crown Prosecution Service added later: “Following a recent change in circumstances in this case we have determined our legal test is no longer met.”

## Charles reportedly miffed as William and Kate rent out his beloved Welsh bolthole

**KING** Charles is upset over his eldest son’s decision to rent out his beloved Welsh holiday bolthole.

The monarch snapped up the £1.2million cottage through the Duchy of Cornwall in 2007 and has spent years lovingly restoring it.

The Llwynywermod holiday home, on the outskirts of the Brecon Beacons National Park, was taken over by William when he became the Prince of Wales after the late Queen’s death last year.

Now it’s said William wants to turn the secluded cottage into a holiday home – leaving Charles “miffed and disappointed”.

The King will have to pay rent if he ever stays there again.

Llwynywermod will be marketed to holidaymakers after

September and Charles is currently having his belongings at the house placed in storage.

The King spent at least a week every year at Llwynywermod after leasing it back from the Duchy.

He voluntarily gave up the lease when the Duchy passed to his elder son. A Royal source said: “The King was quite miffed but that was the deal. It means he can continue to stay there, but will pay rent to the Duchy, and the rest of the time it will be rented out.”

The King and Queen invested a lot of time and energy into the renovation of Llwynywermod.

It was restored with the help of architect Craig Hamilton and the interiors are by the Queen’s sister, Annabel Elliot, in a rustic style.

The Royal source added: “Charles has agreed to pay

for the topiary upkeep as he doesn’t want to see all the good work go to waste.”

The idyllic cottage includes a barn attached to the main three-bedroom house, which was renovated using traditional techniques, and 192 acres of rolling countryside.

Nearby properties owned by the Duchy are already let out. Three-bed North Range costs £2,400 a week.

William wants to spend more time in Wales, but will stay in B&Bs and holiday rentals, supporting the tourist industry.

Buckingham Palace said: “Should His Majesty stay there in the future, that would be under commercial terms with the Duchy, in the same way that applies to His Majesty’s occupancy of Highgrove, similarly owned by the Duchy.”

## Jobs boost as Jaguar/Land Rover's Indian owner confirms plans for UK battery factory

Jaguar Land Rover-owner Tata has confirmed plans to build its flagship electric car battery factory in the UK.

The new plant in Somerset is expected to create 4,000 UK jobs and thousands more in the wider supply chain.

Tata said it will invest £4bn in the site but it is understood that the government is providing subsidies worth hundreds of millions of pounds.

The plant is described as the most important investment in UK automotive since Nissan arrived in the 1980s.

The new gigafactory near Bridgwater will be one of the largest in Europe. It will make batteries for Jaguar Land Rover vehicles like Range

Rover, the Defender and the Jaguar brands.

The plan is to supply other car manufacturers as well, with production at the new factory is due to start in 2026.

Tata have been in negotiations for months to secure state aid for the project. It had considered a rival site in Spain for the battery plant.

### cash grants

Sources said a significant level of subsidy has been provided, which are likely to be in the form of cash grants, discounts on the cost of energy, and training and research funding.

Energy Secretary Grant Shapps told the BBC's Today programme, that the incentive offered to

Tata "is large".

"I make no bones about that," he said. "When I was first involved nine months ago, it was a call from Tata to tell me that the factory was going elsewhere. We have fought very hard for it." He added: "It wasn't just about money, it was also the UK's lead in things like battery research."

Prime Minister Rishi Sunak said: "With the global transition to zero emission vehicles well underway, this will help grow our economy by driving forward our lead in battery technology whilst creating as many as 4,000 jobs, and thousands more in the supply chain."

Liberal Democrat Treasury spokesperson

Sarah Olney MP said: "This is a welcome move by Jaguar Land Rover after years of the south west being neglected by Government investment."

The plant is Tata's first outside India and, it is hoped, will help the car manufacturing sector transition from petrol and diesel to making electric vehicles.

The Society of Motor

Manufacturers and Traders said that the investment comes at a critical time for the UK.

"With the global industry transitioning at pace to electrification, producing batteries in the UK is essential if we are to anchor wider vehicle production here for the long term," said SMMT chief executive Mike Hawes.

Batteries typically account for more than half of the value of an electric vehicle, so a reliable supply is expected to be vital for the future of the UK car industry.

The government has been criticised for lacking a clear industrial strategy and falling behind the US and EU in attracting investment in low-carbon technologies.

## Late term abortion mum freed after appeal

■ "It is a case that calls for compassion, not punishment," - says judge

A mother who was jailed for illegally taking abortion tablets to end her pregnancy during lockdown will be released from prison after the Court of Appeal reduced her sentence.

Carla Foster, 45, admitted illegally procuring her own abortion when she was between 32 and 34 weeks pregnant.

A judge told her last month she would serve half her 28-month term in custody and the remainder on licence.

But the Court of Appeal reduced the term to 14 months suspended.

Dame Victoria Sharp, sitting with Lord Justice Holroyde and Mrs Justice Lambert at the London court on Tuesday, called it "a very sad case".

"It is a case that calls for compassion, not punishment," Dame

Victoria said.

Foster appeared at the hearing via a video link from Foston Hall prison, Derbyshire.

The mother-of-three from Staffordshire was jailed at Stoke-on-Trent Crown Court on 12 June.

The court heard she had moved back in with her ex-partner at the start of lockdown, while carrying another man's baby.

### 'no useful purpose'

She procured pills by post from the British Pregnancy Advisory Service (BPAS) after providing information that led staff to believe she was seven weeks pregnant.

Although abortion is legal up to 24 weeks, after 10 weeks the procedure is carried out in a clinic.

On 11 May 2020, after she took the abortion pills, emergency services

received a call to say she had gone into labour.

The baby was born not breathing during the call and pronounced dead about 45 minutes later.

Foster was initially charged with child destruction, which she denied.

She later pleaded guilty to an alternative charge of section 58 of the Offences Against the Person Act 1861, administering drugs or using instruments to procure abortion, which was accepted by the prosecution.

Dame Victoria told the court there was "no useful purpose" served by detaining Foster in custody, and added her case had "exceptionally strong mitigation".

Foster's barrister Barry White said there had been a lack of "vital reports" into his client's mental health and the pandemic

had added to her existing anxiety.

The Court of Appeal also heard the prison had not allowed Foster any communication with her children during her 35-day incarceration, one of whom is autistic.

Mr White highlighted Foster had voluntarily revealed her actions to police, adding: "Had she not done that, it is highly unlikely that she would have ever been prosecuted."

Robert Price, from the Crown Prosecution Service, said the

original sentence was not "manifestly excessive" and the judge had "correctly made allowances for mitigating factors in this unusually sensitive case".

As well as the 14-month suspended prison sentence, Foster will also have to complete up to 50 days of activity.

In response to the verdict, chief executive of the BPAS Clare Murphy said she was "delighted" the mother would be released from prison and called for a change to the law.

"The court of appeal has today recognised that this cruel, antiquated law does not reflect the values of society today," she said.

"Now is the time to reform abortion law so that no more women are unjustly criminalised for taking desperate actions at a desperate time in their lives."

Right to Life UK, however, urged the government to reject legislation changes and called for a "full inquiry" into how BPAS had come to dispatch Foster's abortion pills.



# Old grey mare? No way say Wiltshire locals as restoration begins on iconic White Horse

**Work to turn Wiltshire's iconic White Horse monument back from grey to white has started.**

A conservation team abseiled down the Westbury landmark on Wednesday to clean, repair and paint it.

Work on the site is expected to take eight weeks and involves jet-washing to remove algae from the surface.

Standing at 175ft (53m) tall the figure, which was originally carved in the

late 17th century, is said to be the oldest in Wiltshire.

The much-loved local monument is thought to have been created to commemorate King Alfred's victory over the Danish at the Battle of Ethandune in 878.

English Heritage has engaged the Somerset-based firm, Sally Strachey Historic Conservation, to undertake the works.

Cut into the chalk, previously the horse had to be scoured regularly to

keep it white, according to English Heritage

The last recorded scouring took place in 1853. In the late 1950s, the horse was preserved by covering it in white-painted concrete.

The monument was last cleaned in 2016 and has once again turned from white to grey.

Win Scutt, senior properties curator at English Heritage, said maintaining the landmark is a costly process.

"From a conservation perspective, the ongoing care required by the Westbury White Horse is extremely complex," he said.

"Its position on a steep slope means that we can't

prevent the water runoff from the surrounding grasslands, and it's this which creates algae build up and makes it unavoidable that the surface turns grey - even with regular cleaning."

A team of volunteers from English Heritage will be on site during the eight-week period to help explain the conservation cleaning process and the history of the White Horse.

## Beach boy Rod still looking dandy on the sand

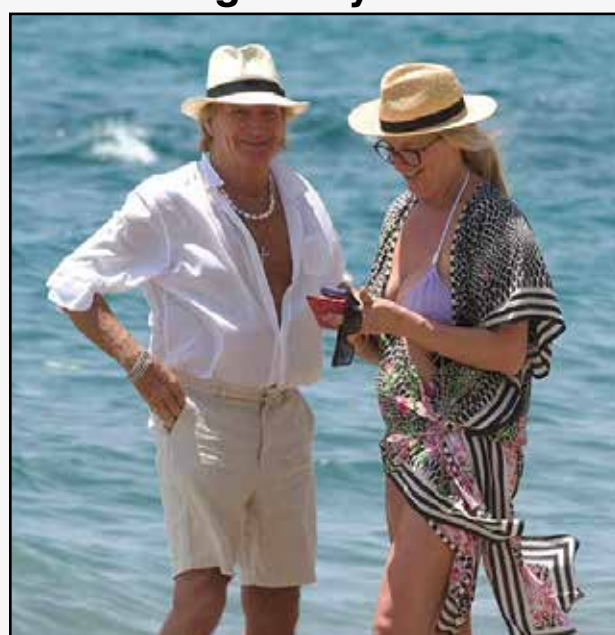
**ROCKER Rod Stewart looks all loved-up on a sun-kissed break from his world tour this week.**

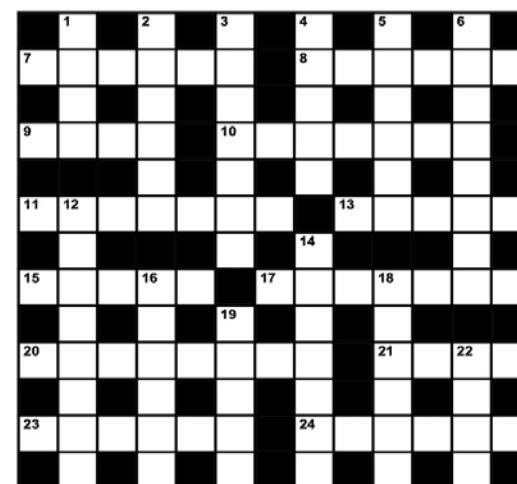

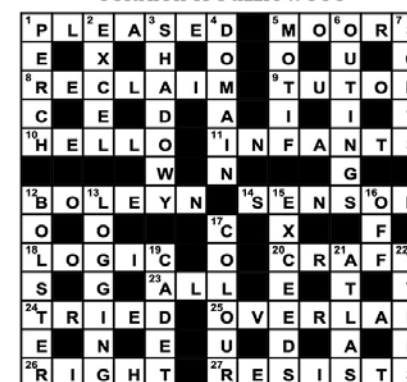

## Jane Birkin, the 'most French of Britons', dies in Paris at 76

**ACTRESS and singer Jane Birkin has died at her Paris home at the age of 76.**

She was reportedly found dead yesterday by her carer.

President Emmanuel Macron led the tributes, saying: "Because she embodied freedom, because she sang the most beautiful words of our language, Jane Birkin was a French icon. "She bequeaths us tunes and images that will never leave us."

And France's Minister of Culture Rima Abdul Malak said: "The most French of Britons is gone."

Jane was best known in Britain for her steamy 1969 single *Je T'aime*

– *Moi Non Plus* with singer lover Serge Gainsbourg. He wrote it for former girlfriend Brigitte Bardot. The song topped the UK charts but was banned elsewhere.

Jane charmed France with her British music and fashion style, and inspired the Hermes Birkin handbag.

She wed James Bond composer John Barry when she was 17 but they split after three years.

Jane and Serge had daughter Charlotte, now 51, during their 12-year relationship.

And she went on to have singer Lou Doillon, 40, with film director Jacques Doillon during a 13-year relationship.

Jane was treated for leukaemia in the nineties and had a mild stroke in 2021.

In March this year she cancelled concerts after breaking her shoulder.

Jane released several solo albums and her acting credits included Agatha Christie's *Death On The Nile* and *Evil Under The Sun*.

She was also involved in humanitarian causes, including working with Unicef and Amnesty International.

In 2001, she was awarded the OBE for services to acting and to UK-French cultural relations. She had also twice been awarded the French *Ordre National du Merite*.

Swan upping is the annual census of the population and counts the number of cygnets, checks their health and ensures numbers are maintained.

Marker for 29 years and continues in the role for the King.

On Sunday his team wore newly updated uniforms bearing the monarch's cypher for the first time.

Gvardiol, who came through the ranks at Dinamo Zagreb and has been at Leipzig for two seasons, joins a long list of central defenders at City. Manuel Akanji, Rúben Dias, Aymeric Laporte, Nathan Aké and

John Stones play there, although Pep Guardiola has used centre-halves at full-back and Stones has also been deployed in midfield.

The transfer activity on Wednesday continued the manager's squad adjustments after winning the treble. The midfielder Ilkay Gündogan left for Barcelona last month on a free and Mahrez's impending departure removes another player who has been part of the club's success over several seasons.

# Reds star Henderson set to decamp to Saudi league

**Jordan Henderson is poised to join Steven Gerrard at Al-Ettifaq after Liverpool agreed a fee in principle of £12m plus add-ons for their captain with the Saudi Pro League club.**

Henderson was omitted from Liverpool's first friendly of pre-season on Wednesday, against Karlsruher SC in Germany, after a breakthrough in negotiations.

The 33-year-old midfielder agreed a contract with Al-Ettifaq last week and could undergo a medical within days. He will sign a two-year contract with

the option of a third on wages that will dwarf his current £200,000 a week at Liverpool.

Liverpool and Al-Ettifaq, managed by the Anfield legend Gerrard, reached a compromise over the structure of the fee for a player who has two years on his contract.

Henderson was initially reluctant to relocate with his family to Saudi Arabia but Al-Ettifaq's offer prompted a rethink. He also held talks over his first-team prospects with Jürgen Klopp before deciding in principle to end his 12-year stay on Merseyside.

Liverpool have signed

Alexis Mac Allister and Dominik Szoboszlai for £35m and £60m respectively and Klopp was in the market for another midfielder even before Saudi Arabian interest in Henderson and Fabinho disrupted his pre-season plans.

Liverpool remain in talks with Al-Ittihad over Fabinho's exit. Al-Ittihad, unlike Al-Ettifaq, are one of the four Saudi Arabian clubs owned by the country's Public Investment Fund. The Brazil international is expected to leave for about £40m. Two other Liverpool players, Luis Díaz and Thiago

Alcântara, are attracting interest from the Saudi Pro League but the club is expected to resist any advances for the Colombia international.

Klopp said about both deals: "As long as things

are not really finally decided, we don't have to talk about it. There will be a moment where we probably have to talk about it, but it's not now. I don't know that anything is decided, which means

nothing to say in the moment. In the end, all of these decisions are made by me. And because I respect the players a lot, it's usually with consent. It was in this case and it is all fine."

## ARTETA: Rice will be our 'lighthouse'

**MIKEL ARTETA has described Declan Rice as the "lighthouse" to guide Arsenal to the Premier League title.**

Arteta is clearly buzzing about the club's record £105million signing and what the England midfielder will bring to Arsenal's midfield next season.

The Gunners ran Manchester City close in the last title race but were lacking a top-class midfield general and leader, which is exactly what Arteta believes Rice will bring, together with a physical presence.

The Arsenal manager became infamous for his strange comparisons in the Amazon All Or Nothing documentary – using a lightbulb during one team talk as he urged his players to feed off the electricity.

Now on his new recruit, the Spaniard said: "I see him like a lighthouse. He is willing to put light in others and improve others and make the team better. That is a huge quality.

"For me, to be a midfielder you have to have that and he's got it,

100 percent.

"The way he talks and presents himself, the ambition he has and his passion for the game is exactly what we needed.

"It's his leadership, his aura, the experience he already has in the league that means he is going to bring the team to a different dimension. He has the physical qualities we were missing for a while as well.

"That is why we had to do what we had to do to get him, because it was really important for us to get him.

"Every transfer window we are trying to improve and every season we are trying to develop our players to a level.

"When we don't reach that level, we have to recruit and what we have done this summer improves the squad significantly."

Arteta admitted signing Rice was a very long pursuit, as they spent most of last season trying to get him.

It was Arteta and sporting director Edu who sold Rice their vision, and the England

midfielder bought into their plan. But the Arsenal manager said they knew Rice was the perfect fit a long time ago and that was why they paid so much to beat off the competition from Bayern Munich and Manchester City – as the player's mind was long since made up.

Arteta said: "It was a while ago. We were discussing how he could evolve the team and how he could complement the players that we already had and give us more flexibility, quality and depth.

"We also need that winning hunger in the team with players who really want to push themselves to a different level.

"We have three new players who will be really important in that."

It is clear that the Spaniard feels this team can take the next step and start winning trophies. They have already added Rice, Chelsea forward Kai Havertz and Ajax defender Jurrien Timber in a £210m spending spree.

The 27-year-old shot-stopper has been top of Erik ten Hag's wish list this summer as United replace long-serving David De Gea.

United have now reached an agreement with Serie A side Inter to sign Onana for an initial 51m euros (£43.8m) with a potential further 4m euros (£3.4m) in add-ons.

Personal terms are also understood to have been agreed with the

goalkeeper, who is set to sign a five-year deal with the option of a further season.

A medical is imminent but it remains to be seen whether the respective paperwork will be completed in time for Onana to be on Wednesday's flight to the United States for their pre-season tour.

The Cameroon international will become United's second signing of the summer after bringing in Chelsea midfielder Mason Mount earlier in the month for an initial £55m.

The goalkeeper should

slot seamlessly into Ten Hag's system thanks to his ability and confidence on the ball, which he used to great effect at Inter and prior to that under the Dutchman at Ajax.

A new goalkeeper had not initially been a key priority for the United boss this summer, but towards the end of the campaign it was decided to pursue a new number one.

Onana is now set to succeed De Gea after his recent departure on a free transfer, while speculation continues over the future of Dean Henderson and Tom Heaton.

# Rashford inks whopping new United deal

■ Updated contract worth £78m to the rejuvenated striker

Marcus Rashford has signed a new five-year contract at Manchester United worth a basic £300,000-a-week.

Rashford, 25, will earn £78million if he stays at Old Trafford for the duration of the new deal through until 2028.

United will be delighted to secure Rashford's future after clinching the signing of Mason Mount from Chelsea and agreeing terms with Inter Milan for goalkeeper Andre Onana.

However, it was always Rashford's preference to stay with his hometown club, and the new contract is set to

keep him at Old Trafford through the prime years of his career and into his 30s.

'I joined Manchester United as a seven-year-old boy with a dream,' Rashford said.

'That same passion, pride, and determination to succeed still drives me every time I have the honour of wearing the shirt.

'I've already had some amazing experiences at this incredible club, but there is still a lot more to achieve and I remain relentlessly determined to win more trophies in the years ahead.

'As a United fan all

my life, I know the responsibility that comes with representing this badge and feel the highs and lows as much as anyone.

'I can assure you that I will give everything to help the team reach the level we are capable of, and I can feel the same determination around the dressing room.

'I couldn't be more excited for the future under this manager.'

The £50,000-a-week pay rise means Rashford will stay as one of the highest-paid English players in the game, with only Chelsea's Raheem Sterling believed to be

earning more.

It's a reward for the best season of Rashford's career in which he bounced back from a difficult 2021-22 campaign to become the first United player since Robin van Persie

a decade ago to score 30 goals for the club.

Rashford only reported for pre-season training with the rest of United's international players on Sunday so was not involved in Wednesday night's friendly against

Lyon at Murrayfield, having missed the victory over Leeds in Oslo last week.

But he could return to action in Saturday's opening US tour game against Arsenal in New Jersey.

## ....but Harry loses the armband

HARRY MAGUIRE has admitted he is devastated at being stripped of the Manchester United captaincy by manager Erik ten Hag.

The decision plunges Maguire's Old Trafford future into further doubt, although initially the centre-back is understood to have reaffirmed his commitment to fighting for his place.

Although United are yet to announce who will be appointed as Maguire's

successor, Bruno Fernandes is expected to step up into the role following his prolonged stint as vice-captain.

Maguire said in a statement on social media: "After discussions with the manager today he has informed me he is changing captain. He outlined his reasons to me and while I'm extremely disappointed but will continue to give my all every time I wear the shirt.

"So I wanted to say a

massive thank you to the United fans for all their brilliant support whilst I've been wearing the armband.

"Since the day I took on the role three and half years ago it's been a huge privilege to lead United and one of the proudest moments of my career to date. It's one of the greatest honours in club football. I've done everything I possibly could to help United be successful – on and off the field."
