Controversial Irish singer found dead at her south London home • Death 'not suspicious', say police

Irish singer and activist Sinéad O'Connor has died at the aged of 56.

In a statement, the singer's family said: "It is with great sadness that we announce the passing of our beloved Sinéad.

"Her family and friends are devastated and have requested privacy at this very difficult time."

She was best known for her single Nothing Compares 2 U, released in 1990, which went on to hit number one around the world.

Taoiseach (Irish PM) Varadkar paid Leo tribute to her, saying her music "was loved around the world and her talent was unmatched and beyond compare".

The singer, who was outspoken in her social and political views, brought out 10 studio albums in all.

Her first album The Lion and the Cobra came out in 1987, entering the top 40 in the UK and US. Her follow up I Do Not Want What I Haven't Got, which included Nothing Compares 2 U, was a number one hit.

The Dublin singer's 17-year-old son Shane died last year, days after he was reported missing.

Writing on social media following his death, she said he had "decided to end his earthly struggle" and requested "no-one follows his example".

Converting to Islam in 2018, changing her name to Shuhada', but continued to perform under her birth name.

creative talent

Her rebellious nature was mainly driven by resentment at the abuse she suffered as a child and her experience in a Dublin reformatory.

It was music that rescued her, unleashing a creative talent that made her a worldwide music star - but also a rebel prepared to be controversial and never play the game of being an image-led pop star.

With her elfin features and skinhead look she was one of pop music's most recognisable figures.

Sinéad Marie O'Connor Bernadette was born on 8 December 1966 in the affluent Glenageary suburb of Dublin

She was the third of five children of Sean O'Connor and his wife Marie. The couple had married young and their relationship, often stormy, ended when O'Connor was eight.

Her brother, Joseph, once described their mother as deeply unhappy and disturbed and prone to physical and emotional abuse of her children.

But controversy from was never far away. She refused to perform at a concert venue in New Jersey unless it dropped its normal practice of playing the US national anthem before she went on.

The venue reluctantly agreed but it led to a boycott of her songs by a number of US radio stations.

sexual abuse

A month after the release of I'm Not Your Girl, a collection of jazz standards, O'Connor performed a version of Bob Marley's War on NBC's Saturday Night Live, substituting some of the words so it became a protest against child sexual abuse in the Catholic Church.

To the horror of the producers she held up a photo of Pope John Paul II to the camera and tore it in half. NBC received more than 4,000 complaints from viewers and many destroyed copies of her records.

At a subsequent live appearance she was booed so much she couldn't perform. At the end of 1992 she returned to live in Dublin.

O'Connor proved she could still deliver the goods with the release of her 2014 album I'm Not Bossy, I'm the Boss. She appeared on the cover wearing a wig and figure-hugging black dress while caressing a guitar.

'badly triggered'

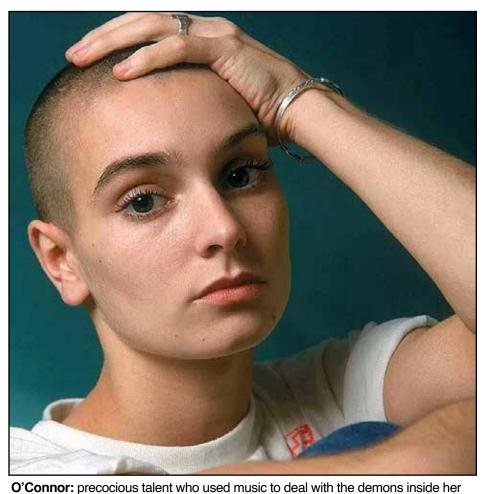
But her mental health was still precarious. In November 2015, after recovering from a hysterectomy, she posted a message on Facebook announcing she was in an Irish hotel and contemplating suicide. She was found safe and well and received medical treatment.

She released a memoir, Rememberings, in June 2021 and took part in media interviews to promote it, some of them fraught. The singer said she felt "badly triggered" by an interview on BBC Radio 4's Woman's Hour about her mental health struggles and the media's coverage of it.

More trauma came in January 2022, when her 17-year-old son Shane took his own life. The musician posted a series

of concerning tweets in the wake of his death, indicating she was considering suicide and telling followers she had been admitted to

hospital. Sinéad O'Connor was a precocious talent who used music as a means of dealing with the demons inside her. A contradictory figure in many ways, she always refused to toe the establishment line, something that saw her achieve less success than she deserved.



"Kidnapped by the state"

■ Court of Appeal frees Andrew Malkinson after serving 17 years for a rape he did not commit

A man who spent 17 years wrongly locked up for rape has said he was "kidnapped by the state".

Andrew Malkinson was jailed for life with a minimum term of seven years for the 2003 attack on a woman.

The 57-year-old's conviction was quashed by the Court of Appeal on Tuesday after DNA came to light which linked another potential suspect to the crime in Greater Manchester.

Lord Justice Holroyde said he could "leave the court free and no longer be subject to the conditions of licence".

Outside the Royal Courts of Justice Mr Malkinson said: "Today we told this court I was innocent and, finally, they listened. But I have been innocent all along, for each of those 20 years."

He accused Greater Manchester Police of being "liars" and said he endured a decadeand-a-half nightmare, wondering if he would be killed or would take his own life in prison. He said: "As a minority of one, you are forced to live their false fantasy."

Mr Malkinson added: "It has taken nearly 20 years to persuade my kidnappers to let me go...

"After every parole hearing I sat before a panel who shook their heads, considering me to be dangerous. All that time the real perpetrator

was free."

His mum Tricia Hose, who is in her mid-70s, said: "My son is no longer a monster. But what has been done to him cannot be undone.

"The damage will be with him for the rest of his life and the woman who got attacked has been denied justice."

Mr Malkinson's conviction was based solely on identification evidence. The Crown Prosecution Service conceded it was unsafe and said it was "possible" another man will be charged.

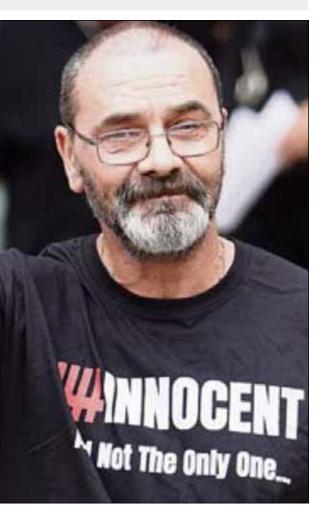
Lord Justice Holroyde said "crucial" material not disclosed at the time of his trial "raised important points" and would be considered by the court.

Mr Malkinson was turned down twice by the Criminal Cases Review Commission, which probes possible miscarriages of justice. But after his release in 2020 DNA advances allowed his legal team to cast doubt.

The CCRC's own testing found DNA from the victim's clothes matched another man on the police database.

GMP confirmed in January that a man was held amid new information.

The force's Assistant Chief Constable Sarah Jackson apologised for "such a grave miscarriage of justice", adding that such cases are "very rare".

Top bank boss quits after being revealed as source of 'too poor' Farage press leak

■ NatWest CEO admits 'serious error of judgment'

NatWest boss Dame Alison Rose has resigned hours after admitting she had made a mistake in speaking about Nigel Farage's relationship with the bank.

She had been heavily criticised for being the source of an inaccurate BBC report about Mr Farage's account at Coutts, which is part of NatWest Group. The announcement came just hours after NatWest said it had full confidence in her in continuing to lead the bank.

Dame Alison had admitted a "serious error of judgment".

In a statement released early on Wednesday morning, NatWest Group chairman Sir Howard Davies said: "The board and Alison Rose have agreed, by mutual consent, that she will step down as chief executive of the NatWest Group. "It is a sad moment."

In a separate statement, Dame Alison thanked her colleagues "for all that they [had] done", saying: "I remain immensely

proud of the progress the bank has made in supporting people, families and business across the UK, and building the foundations for sustainable growth."

NatWest shares fell more then 2.5% after the announcement. Dame Alison was paid £5.25m last year. Whether Dame Alison will get a severance payment will emerge in the banking group's next report on pay. Chair Sir Howard said hours before Dame Alison resigned that it was in the interest of shareholders and customers that she stayed on as chief executive. It is understood he intends to remain as chair.

Following her resignation, ex UKIP leader Mr Farage told the BBC it had taken a long time for Dame Alison to resign.

He said that anybody in a more junior position at the bank would have been "out of the door".

Dame Alison had come under mounting pressure from Downing Street, the chancellor and other senior cabinet ministers to resign, with the BBC told there were "significant concerns" over her conduct.

40c could become the norm in UK'



Experts say that extreme heat and temperatures over 40C will become increasingly likely in the UK because of climate change.

The Met Office is preparing to release its State of the UK Climate report for 2022.

Last year saw temperatures over 40C recorded for the first time ever, as well as heat-related deaths and wildfires.

Oli Claydon, from the Met Office, said: "The likelihood of exceeding [40C] is increasing due to h u m a n - i n d u c e d climate change."

Experts warn that Britain is not equipped to cope with extreme weather.

DrCandiceHowarth, of the London School of Economics, said the country "only just managed to respond" to the record temperatures in 2022.

The Department for Environment, Food and Rural Affairs recently shared a fiveyear plan to protect against climate change risks.

Prosecutors told the jury the star had left the four complainants feeling "small, diminished and worthless".

Mr Spacey, who turned 64 on Wednesday, denied all charges - saying the allegations against him were "weak", "madness" and a "stab in the back".

accusations

Under questioning from Mr Spacey's lawyer, Patrick Gibbs KC, the complainants had all denied either seeking financial gain, attempting to further their career or giving false accounts to the jury. By law all complainants are entitled to life-long anonymity.

The Crown Prosecution Service (CPS) said prosecutors respected the jury's decision.

In a statement, a spokesman said: "The function of the CPS is not to decide whether a person is guilty of a criminal offence, but to make fair, independent and objective assessments about whether it is appropriate to present charges."

The trial lasted nearly four weeks and jurors heard from multiple witnesses - including Mr Spacey himself.

Defence witnesses included Sir Elton John, who appeared by video link from Monaco, as well as Sir Elton's husband, David Furnish.

The Hollywood star won best actor Oscar in 2000 for American Beauty, and best supporting actor in 1995 for The Usual Suspects.

He was also the artistic director at the Old Vic Theatre in London

Mr Spacey's career came to a halt in 2017 after a number of accusations of inappropriate behaviour were made against him.

At the time, he had the starring role of Frank Underwood in Netflix political drama House of Cards, a job he lost when the allegations were made public. He was charged with the offences against three men by the CPS in May 2022, with additional charges from a fourth complainant added in November 2022.



Environmental campaigner Feargal Sharkey claimed Yorkshire Water has shown "casual а indifference" to its customers by running a "ridiculous" advert.

It was part of the word of mouth campaign, which encourages people in Yorkshire to share tips about saving water.

The company said the "teaser video" on social media which featured stock footage has been taken down and it will be replaced by one which features residents and a small business in Harrogate. Mr Sharkey said the advert shows the company is prepared to treat the "staunchly proud" people of Yorkshire with "casual indifference".

The former rock star has heavily criticised the company and other utility firms in recent years for polluting the country's waterways by discharging sewage.

He said: "I personally think it was a ridiculous thing to do and it calls into question, in my mind, who within the company actually approved it?

Life term for cop killer

■ Louis De Zoysa smuggled an antique revolver and holster into a police station during his arrest

A man who shot dead a Metropolitan Police custody sergeant after smuggling a gun into a holding cell has been handed a whole life jail sentence.

Louis De Zoysa was convicted of Sergeant Matt Ratana's murder in June - and it is believed he had concealed the antique revolver and holster under his armpit.

Jurors were shown CCTV distressing footage of the 26-yearold gun fanatic using the legally-bought gun to shoot Sgt Ratana.

Northampton Crown Court was told the former tax office data analyst deliberately fired the weapon without warning into the 54-yearold's chest, causing a overcoat to hide the gun

fatal wound to his heart and lung. He later died in hospital

De Zoysa was handcuffed at the time, and suffered brain damage after one of the shots fired hit him in the neck.

had He claimed diminished responsibility but was found guilty after a jury decided he pulled the antique weapon's trigger deliberately to fire homemade bullets, and had not suffered an autistic meltdown.

CCTV footage suggests he managed to retrieve the weapon with his right hand about 16 minutes before the shooting - and used a vent at the back of his

until the attack.

A total of four shots were fired within 20 seconds within a custody block in Croydon, south London, in the early hours of 25 September 2020.

Sgt Ratana had worked in policing for 30 years, and was close to retirement.

Sentencing De Zoysa, Justice Jeremy Mr Johnson told the 26-yearold: "You acted in cold blood. You intended to kill Sergeant Ratana.

"You aimed the gun at his chest at near pointblank range. Even as he fell you re-aimed and fired a second shot at him

"The aggravating factors outweigh the mitigating factors. There is therefore no justification to depart from the starting point of a whole life order."

De Zoysa showed no obvious reaction as he was told he will spend the rest of his life in prison.

Scottish man admits to burying cyclist he killed while drunk driving

drink-driver Α has admitted killing a charity cyclist and burying his body to cover up the crime. Alexander McKellar, 31,

was speeding and had been drinking when he caused Tony Parsons' death.

He and twin brother Robert McKellar admitted trying to defeat the ends of justice by hiding the body in a grave in the Auch Estate near Bridge of Orchy in September 2017.

Mr Parsons' remains were not found until January 2021.

His family said it had been "heartbreaking" to live with so many unanswered questions over the six years since he went missing.

The High Court in Glasgow heard how McKellar Alexander collided with Mr Parsons on the A82 between Bridge of Orchy and Tyndrum on

29 September 2017.

McKellar did not seek medical assistance for the 63-year-old at the roadside.

The damaged car involved in the killing was dumped at the nearby Auch Estate along with the brothers' phones.

They then returned in a truck to where Mr Parsons was still lying.

He was placed into the vehicle along with his bike and other personal belongings.

The brothers went back to the Auch Estate and initially hid Mr Parsons' body in a part of the woods. He was later taken to another location used for

"the purposes of disposing of dead animals". The brothers then dug

a grave and buried Mr Parsons along with his personal possessions. Prosecutors said the

brothers got help trying

to repair the car used in the killing, claiming it had been damaged when it hit a deer.

The two men had been due to stand trial accused of Mr Parsons' murder.

But Alexander McKellar pled guilty to the reduced of culpable charge homicide.

His brother had his not guilty plea to murder accepted.

Mr Parsons was last seen in September 2017 outside the Bridge of Orchy Hotel. He then continued cycling south along the A82 in the direction of Tyndrum, but there were no further sightings.

Extensive searches were carried out in the area, involving local mountain rescue teams, volunteers, Police Scotland dogs and the force's air support unit.

His remains were eventually found in a remote area in January 2021.

British billionaire Joe Lewis indicted on insider trading charges

UK billionaire Joe Lewis, whose family trust owns Tottenham Hotspur football club, has pleaded not guilty to insider trading charges in a Manhattan court.

He was granted \$300m (£230m) bail. New York prosecutors allege he hatched a "brazen" scheme that enriched his friends.

He allegedly supplied confidential information that allowed them to profit from buying or selling related stocks.

The court granted two co-accused, Mr Lewis' pilots, bail of \$250,000.

His lawyer David Zornow earlier said charging the tycoon was an "egregious error". He added that the charges would be "defended vigorously in court", and that the 86-year-old had come to the US voluntarily to defend himself against the "ill-conceived charges".

He usually resides in the Bahamas, but surrendered on Wednesday to federal authorities in the US.

In a statement, a Tottenham Hotspur spokesperson said the charges facing Mr Lewis had no bearing on the club: "This is a legal matter unconnected with the club and as such we have no comment."

Mr Lewis was charged with 16 counts of security fraud, and three counts of conspiracy for crimes alleged to have taken place between 2013 to 2021, according to the 29-page indictment.

Allegations against Mr Lewis were laid out in a video statement posted to the US State Attorney's Office for the Southern District of New York.

"We allege that, for years, Joe Lewis abused his access to corporate board rooms and repeatedly provided inside information to his romantic partners, his personal assistants, his private pilots, and his friends," US attorney Damian Williams said in the video.

The indictment quoted one pilot texting a friend that "Boss lent Marty and I \$500,000 each for this," and that he thought "the Boss has inside info" because "otherwise why would he make us invest".

It listed several occasions on which Mr Lewis allegedly told his pilots to sell or invest in shares on the stock exchange, after he received confidential information.

The indictment also alleges that Mr Lewis told a girlfriend to invest in a biotech company in July 2019, before the results of its clinical trial were made public. **Cheeky Woody rolls back the years as Mick turns 80**

Tributes flow for Trevor Francis: "a wonderful gentleman" and British football's first £1m transfer

FORMER England star Trevor Francis – Britain's first £1million footballer – has died after suffering a heart attack, aged 69.

The Nottingham Forest and Birmingham City striker, who was also a successful manager and TV pundit, was staying in Spain where he spent half the year.

His family said he fell ill Sunday morning at his apartment near Malaga.

A statement released on their behalf said: "This has come as a huge shock. We are all very upset.

Tributes poured in for the father of two and two-time European Cup winner who won 52 England caps, scoring 12 goals –including two at the 1982 World Cup.

Forest, with whom he hit the heights of club football after a recordbreaking move, said they were "deeply saddened" to learn of his passing and described their hero as a "true Forest legend who will never be forgotten".

Birmingham tweeted: "Trevor will forever be revered as a giant of the club, the player everyone wanted to see."

Match of the Day presenter Gary Lineker described Francis, who also played for Manchester City, Rangers, Sampdoria, Queens Park Rangers and Sheffield Wednesday, as a "wonderful footballer and a lovely man".

Former England and Rangers team-mate Terry Butcher believes Francis's playing style would have fitted in with the modern game. He said: "He was sophisticated, elegant – modern football would have suited him. "He was just class, he really was.

"He was smooth, he was silky, scored some great goals, a phenomenal player and a very, very nice guy, as everybody says."

After making his first team debut at just 16 for Birmingham City, Francis scored 133 goals in 328 appearances in nine years at the club.

That success attracted the interest of Forest, who rocked the football world with a £1million offer in February 1979. The transfer was double the previous record UK sum and created headlines across the globe.

. And just three months later it paid off as Francis, then aged 24, headed the winning goal in the European Cup final against Malmo in Munich.

Aussies are the raining Ashes champs

ENGLAND'S hopes of winning back the Ashes were washed away at a soggy Old Trafford at the weekend.

After swashbuckling performances and onfield drama, repeated downpours blew away all chance of a series victory on Saturday and Sunday.

The fourth men's cricket Test was abandoned at tea time without a ball being bowled on the final day, leaving the Ashes in Australia's hands.

With England now 2-1 down, the best they can achieve is to draw the five-Test series by winning the final match, which started at the Oval on Thursday.

England fans packed the Manchester ground Sunday morning, hoping to witness history after Ben Stokes' team put themselves into a winning position. But the stands turned

into a sea of umbrellas and ponchos as the rain fell. Hopes were raised

at one point as it eased off and ground staff removed the covers from the pitch. The umpires held an inspection and play was due to begin at lunchtime - but yet another downpour put paid to that.

England's players headed out for a warmup and even kicked football around despite the drizzle to try toboost the morale of the spectators,but conditions became bleaker as the day wore on.

With the rain lashing down into the late afternoon, fans began heading to the exits.

Seagulls rebuff latest Caicedo bid

Brighton have rejected a further bid from Chelsea, believed to be about £80m, for midfielder Moises Caicedo.

Caicedo, 21, is with Roberto de Zerbi's squad in New Jersey, where they are set to play Newcastle on Friday.

Brighton are understood to have rejected the revised offer instantly, and are said to be committed to keeping the Ecuador international.

Caicedo is one of Chelsea's long-term transfer targets and two bids have been previously rejected.

However, Brighton adopted a similarly hardline approach with Chelsea last year and relented when the bidding rose above £60m for defender Marc Cucurella.

Brighton boss De Zerbi last week said he was planning to have Caicedo in his squad for next season.

The player was a key component in the side who finished sixth in the Premier League last season, securing a Europa League groupstage spot.

Bayern despatch top duo to London as Kane transfer edges closer to completion

BAYERN MUNICH are cranking up their bid to sign Harry Kane after tasking their two big transfer hitters to get the deal done.

While Thomas Tuchel's Bundesliga champions flew out to Japan to Treble-winning face Manchester City in a pre-season friendly, chief executive Jan-Christian Dreesen and technical director Marco Neppe have stayed behind in Germany broker Kane's to £100million departure from Tottenham.

Bayern believe they now have a free run at England's record goalscorer after Manchester United dropped out of the running – and are ready to shatter their transfer record to make it happen after having two bids knocked back.

Tuchel refused to comment on Bayern's efforts to land Kane and City full-back Kyle Walker. But when asked why Dreesen and Neppe had missed the trip to the

Dreesen and Neppe had missed the trip to the Far East, he said: "They are doing something it is necessary to do in Europe to support us."

A meeting between Daniel Levy and the Bayern pair is understood to be pencilled in for Friday, with the Spurs chairman under orders from owner Joe Lewis to sell Kane if he refuses to extend his deal, which expires next summer.

Bayern president Herbert Hainer said: "Harry Kane is a highly attractive player, England captain and top scorer. He would do

Walking through the mixed zone after the match, the right-back stopped to sign a shirt for a supporter whilst a German reporter repeatedly asked if he was joining Bayern. Walker simply ignored the repeated questions and walked through the area after signing the City fan's shirt.

Thomas Tuchel also refused to address the

"I don't know what's going to happen. Both clubs are in touch but we will fight for him.
