Pensioner walks free after mercy killing of wife

Cyprus court frees David Hunter, 76

A BRITISH pensioner convicted of the manslaughter mercy killing of his terminally ill wife, wept as he walked free this week.

David Hunter, 76, wept on the steps of Paphos District Court in Cyprus as he struggled to describe his relief.

His daughter Lesley Cawthorne, 50, was also in tears as she said: "I thought I had lost him forever."

The former miner was last month cleared of the premeditated murder of childhood sweetheart Janice, 74, who he suffocated after she had pleaded with him to end her life. She was suffering from terminal blood cancer.

It was unclear until

the last minute whether David might have to serve more weeks in jail.

A morning of high drama in court saw Judge Michalis Droussiotis sentence David to 20 months. But after the hearing had finished, it transpired that with good behaviour and having already served 19 months, he could go free.

David became emotional outside the court as he thanked his family and former Northumberland mining pals for their unwavering support.

He said: "I would just

like to say thank you to all the people who supported me. I don't know where I would be without them." Asked how he was feeling after his time in a Nicosia prison, David replied: "I hope I'm feeling the same as my family.

"When I say family, I also mean all my lads. We're all family. When you work in the colliery, you're all a family."

And when asked about reaching the end of the trial, he said: "I can't describe it. I'm sorry, I wish I could.

way it was going to go, you don't know."

In the cafe downstairs from the courtroom where he was freed, David Facetimed Lesley. He said: "The first thing I said was, 'I love you'." He added: "We were both crying. She couldn't talk."

His daughter said: 'Speaking to my daddy was the most amazing thing. I feel like my heart has been put back together."

who Lesley, unable to travel from the UK because of a health condition, wept as she added: "I cannot believe it. When I see him, I'm going

> "I'm going to feed him and make sure he's eating. I just didn't think, after the way the case has gone, that this was possible."

> David revealed a police officer embraced him when he told him he would be released after his sentence. He said: "The policeman hugged me and said, 'Congratulations David, you're free, you got the result you deserve'. I just shook his hand and said, 'Thanks, mate'."

> David, from Ashington, told his trial, which lasted for more than a year, that Janice "begged" him to end her life on December

He broke down in tears as he said he would "never in a million years" have taken her life unless she had asked him to. They were married for 52 years. The court heard he then tried to kill himself but medics saved him.

Judge Droussiotis said David would "soon be in a position to leave jail and live his life" due to time already served.

He added: "Before us is a unique case of taking human life on the basis of feelings of love, with the aim of relieving the person of their suffering that came due to their illness."

NFL legend Brady becomes part owner of Birmingham City

"The goal that Tom has committed to is to make Birmingham City a respected leader in nutrition, health, wellness, and recovery across the world of football."

Seven-time Super Bowl champion Tom Brady has become a minority owner of Championship side Birmingham City.

The NFL legend, who retired from the sport in February, has "entered a partnership" with Blues' new owners Knighthead Capital Management LLC.

The 46-year-old will become chairman of a new advisory board at St Andrew's.

"Tom Brady joining the Birmingham City team is a statement of intent. We are setting the bar at world class," Knighthead co-founder Tom Wagner said.

"Tom is both investing [as well as] committing his time and extensive expertise.

"As chair of the advisory board Tom will have a direct impact on the club. The men's, women's, and academy teams are going to benefit from [his] knowledge.

"The goal that Tom has committed to is

to make Birmingham City a respected leader in nutrition, health, wellness, and recovery across the world of football."

The club said Brady would also work closely with the board and the management team on global marketing efforts and the identification of new commercial partnership opportunities.

A number of American stars have made minority investments in English football clubs in recent months.

Former NFL defensive end JJ Watt became a shareholder at Burnley in May, while actor and producer Michael B Jordan invested in Bournemouth at the end of last year.

A m e r i c a n golfers Jordan Spieth and Justin Thomas, and NBA All-Star Russell Westbrook are also minority stakeholders in Leeds United.

Fellow NBA star LeBron

James also become a minor partner in Fenway Sports Group (FSG), the owners of Liverpool, in 2021.

US-based Shelby Companies Limited (SCL), a subsidiary of Knighthead Capital Management, completed its takeover of Birmingham in July.

As part of that deal SCL became controlling shareholders of the previously Chineseowned club.

"Birmingham City is an iconic club with so much history and passion, and to be part of the Blues is a real honour for me," Brady said.

"BCFC is built on teamwork and determination and I'm excited to work alongside the board, management and players to make our Second City club second to none.

"I've been part of some amazing teams in my day, and I'm looking forward to applying my perspective to create that

same success here in Birmingham."

Widely recognised as one of the greatest American footballers in NFL history, the quarterback won six Super Bowls with the New England Patriots and one with the Tampa Bay Buccaneers in 2021.

Brady's final season before his retirement earlier this year ended in the Bucs' 31-14 play-off defeat in January.

The Blues, who finished 17th in the Championship last season, begin the new campaign with a trip to Swansea on Saturday.

Mum seeks justice after shocking sentence for her child's killer

A mother has said she "needs justice" for her son after the driver who crashed into him and left him in the road was given just nine months in custody.

Gregg McGuire died from "catastrophic" brain injuries after he was knocked off his bike by a car while crossing a road in Washington last August.

Uninsured driver Kayn Galer, who was 19 at the time, later admitted causing death by careless driving.

Gregg's mother Alison said she "won't rest until the case is back in court".

Last week Galer was told by a judge he would spend up to half of the nine-month sentence in a youth offender institution before being released on licence.

He was also banned from driving for three years and must take an extended test to get his

licence back.

The sentencing guidelines in the case only allowed for a nine-month sentence.

Gregg's mother Alison Rudkin said: "This will stay with us forever and he only got a nine-month sentence, and he won't go to prison for nine months as the judge said a maximum of four-anda-half months, I think it's diabolical, just wrong."

Gregg was cycling to his cousin's house for a sleepover when he was struck crossing Silverstone Road.

She added Galer had not stopped after the collision, leaving her son in the road.

"I've got no sympathy for him - he chose to drive his car at a stupid speed and while he hit the brakes, he didn't stop," she said.

"He knew he had hit a child but he carried on driving and didn't call for help.

"I never imagined we'd have this fight for justice, and I won't rest."

Ms Rudkin has met with her local Labour MP Sharon Hodgson this week.

The member for Washington and Sunderland West said she would raise Galer's sentencing with the authorities.

Ms Hodgson added:

8 Doors, which is the most northerly mainland Scotch distillery, is also the first to produce whisky in the village since 1837.


Tour guide Susan Dearness said of the King: "He was lovely. He was asking about my experience with whisky and what I do.

The Prince of Wales put the fast food on the van counter, saying: "Morning everyone! Nicely cooked, ready to go".





Chris Woakes was immense in taking 4-50 while off-spinner Moeen Ali, battling a groin injury in the last Test of his career, picked up a crucial 3-76.

Resuming on 135-0 in pursuit of 384, Australia lost David Warner and Usman Khawaja to Woakes' morning burst, while Mark Wood accounted for Marnus Labuschagne.

The visitors were put back on course for one of their greatest runchases by Steve Smith, who made 54, and 43 from Travis Head.

But after a rain delay of more than two hours, Woakes and Moeen were the architects of an Australian collapse of five wickets for 30 runs.

Alex Carey and Todd Murphy raised tension with a ninth-wicket stand of 35 only for Broad to produce a last moment of theatre.

Looking to change England's luck, Broad switched the bails at the non-striker's end and, next ball, bowled a beauty to have Murphy caught by wicketkeeper Jonny Bairstow.

Broad then had Carey caught behind to seal victory and, amid high emotion at a ground renowned for goodbyes, left the field arm in arm with Moeen.

England's win replicates the 2-2 draw of four years ago and preserves an unbeaten home record in Ashes series that stretches back to 2001.

Though Australia retain the urn, which they will defend down under in 2025-26, their wait for a win in this country will be up to 26 years when they next visit in 2027.

This was a magnificent finale to a series for the ages, another tense affair in front of a passionate crowd with the added drama of the rain delay thrown in.

Before this summer, 25 of the 340 previous Ashes Tests had been won by three wickets or fewer, or 50 runs or fewer. This series has had four such victories.

The action on Monday was never less than compelling. Led by Woakes, England were excellent with the ball, only for old foe Smith to threaten another act of defiance.

If was after the rain delay that the match swung decisively in England's direction, with four wickets falling in as many overs. The scalp of Smith in particular sparked wild celebrations on the field and in the stands, a mixture of delight and raliaf

In the end, a draw feels like a fair result at end of a wonderful battle between cricket's oldest rivals. Australia took advantage of England's mistakes to lead 2-0 before the hosts roared back. Ben Stokes' side probably would have won 3-2 had rain not ruined the end of the fourth Test.

It has been a series of countless memorable moments: Zak Crawley driving the first ball for four, Stokes' declaration on the first day of the series, the controversy around Bairstow being stumped at Lord's, the nerve-shredding conclusion to the third Test and Crawley's hundred at Old Trafford to name a few.

But the enduring image was of Broad, an Ashes warrior, first conjuring the wicket of Murphy with one of his old tricks, then sparking joyous scenes with his final delivery in Test cricket.

Stay focused or get killed, Ten Hag tells squad

ERIK ten Hag has warned his Manchester United players they cannot let their standards drop or they will be "killed" next season.

Ten Hag raised standards on and off the pitch in his first season at United as they finished third in the Premier League and ended their six-year wait for a trophy with the Carabao Cup.

But the Dutchman has told his players they cannot stand still if they are serious about competing with Treble winners Manchester City.

During a break from United's US tour, Ten Hag – relaxed and tanned from the west coast sun – spoke candidly about the mess he inherited when he took charge last summer and the culture change he had to instil to turn the club around.

The United manager said: "When I came in, the standards were not right.

"I demand the highest standards in sleep, recovery and nutrition, because that makes the difference if you have to perform every third or fourth day.

"You have to live the right life. Our players can't match the sensational life with playing top football.

"Top football is tough nowadays – 60 games a year in club football and 10 international games. So 70 games means that every third or fourth day you have to match the highest physical levels.

"When you're not living the right life, you get killed. What is important? Sleep, recovery, nutrition. Three key areas and when you don't do this right, you have a problem."

Ten Hag has proved he can make tough decisions, dropping Maguire Harry and taking the captaincy from him, jettisoning David De Gea and bringing in a new goalkeeper in Andre Onana. The 53-yearold knows he has to be ruthless and said he is honest with players when it comes to the big calls.
