CHARLES CALLS FOR 'ENTENTE CORDIALE' ON CLIMATE CHANGE

■ On state visit, King urges France to join UK in efforts 'to tackle the global climate and biodiversity emergency'

King Charles became the first British monarch to make a speech from France's senate chamber on Thursday - and used his speech to declare global warming as 'our most existential challenge'.

The monarch spoke of the close friendship between the UK and France but focused on tackling climate change, calling for a new 'entente cordiale' specifically to 'tackle the global climate and biodiversity emergency'.

Speaking in perfect French, Charles suggested France and Britain needed the same unity shown in the World Wars and now Ukraine to 'stand together' on the environment, shortly after Rishi Sunak had announced a postponement of the UK's 2030 ban on all new petrol

and diesel cars.

Charles, who has spent decades campaigning on green issues, said: "The challenge facing our planet is both great and grave. These horrifying events have once more demonstrated the fragility of so much that we hold dear. Just as we stand together against military aggression, so must we strive together to protect the world from our most existential challenge of all - that of global warming, climate change and the catastrophic destruction of nature.

'Let us, therefore, cherish

and nurture our entente cordiale. Let us renew it for future generations so that, I would like to propose, it also becomes an entente *pour la durabilite* (agreement for sustainability) - in order to tackle the global climate and biodiversity emergency more effectively. Let us stride forward with hope and courage and do so together'.

'resolute solidarity'

The 74-year-old sovereign was given an enthusiastic welcome to the chamber - receiving a standing ovation from parliamentarians as he entered. When his late mother, Queen Elizabeth II, visited in 2004, she made her speech from the adjoining Salle des Conferences.

Charles vowed that "for the time that is granted to me as King" he would seek to strengthen UK-French ties, adding that "together, our potential is limitless."

The King - whose speech came 231 years to the day since France abolished its own monarchy and established a republic - spoke of being "flattered" to have been invited to speak by the two presidents of the two houses that make up France's parliament.

During his address, he saved some of his strongest words to rebuke Russia's invasion of Ukraine, while also urging further action to tackle the climate crisis. "Now, more than 80 years

since we fought, side by side, for the liberation of Europe, we once again face unprovoked aggression on our continent," Charles told lawmakers at the Palais du Luxembourg, where the French Senate is located.

"Our alliance and our resolve are as important as ever. Together, we stand in resolute solidarity with the Ukrainian people. Together, we are steadfast in our determination Ukraine will triumph, and that our cherished

freedoms will prevail."

He continued: "These horrifying events have once more demonstrated the fragility of so much that we hold dear. Just as we stand together against military aggression, so must we strive together to protect the world from our most existential challenge of all - that of global warming, climate change and the catastrophic destruction of nature."

Rishi hits the brakes on petrol car ban

■ **Trailing Labour by double-digits in the polls, PM takes huge gamble by loosening key green pledges**

Rishi Sunak has confirmed a major roll-back of several key U.K. green policies - despite a fierce backlash from business groups, climate activists and some members of his own party.

With a general election on the horizon and Labour enjoying a double-digit lead in the polls, the Prime Minister has taken a huge gamble by pushing back the country's ban on the sale of new petrol and diesel cars from 2030 to 2035.

In a hastily-arranged speech Wednesday - brought forward after details of his plan leaked - the prime minister said there was "nothing ambitious about simply asserting a goal for a short term headline without being honest with the public about the tough choices and sacrifices involved, and without any meaningful democratic debate about how we get there."

'ease the transition'

And he argued: "No one in Westminster politics has the courage to look people in the eye and explain what's really involved. That's wrong,

and it changes now."

The Tories passed a law in 2019 vowing to reach net zero carbon emissions by 2050. Even though that headline target remains in place, Sunak has sought to draw a dividing line with Labour party in how the pledge is met.

Speaking in Downing Street Wednesday, Sunak confirmed he would "ease the transition to electric vehicles," and there would, he promised, be "more time to transition to heat pumps," a cleaner form of heating, with a target for phasing out gas-powered boilers by 2035 slipping back. But cash grants offer to homeowners to upgrade their heating systems will, he promised, be boosted.

'losing the consent'

Sunak said he would ensure no new energy efficiency rules are imposed on landlords or homeowners. He delayed to 2035 what had been a 2026 target for banning off-grid fossil fuel.

He ruled out any new taxes aimed at discouraging flying and announced a rethink of planned new recycling schemes.

Seeking to justify his shift, Sunak warned that continuing down the current policy path risked "losing the consent of the British people - and the resulting backlash will not just be against specific policies, but against the wider mission itself, meaning we might never achieve our goal."

Sunak also sought to portray the UK as a global leader in emission reductions, citing the country's 50% drop since 1990, and urged other countries to follow Britain's lead.

deep rifts

But although the delay may win some favor with consumers, may yet cost him votes from the automotive and electric business sectors, who have invested heavily in manufacturing capability and infrastructure ahead of the mooted 2030 deadline.

In a statement, carmaker Ford U.K. - which has invested close to half a billion pounds in its U.K. facilities as part of preparation for the 2030 vehicle target - said it needed "ambition, commitment and consistency," from the

government. It warned "a relaxation of [the] 2030 [electric car goal] would undermine all three."

Sunak's climate shift also exposed deep rifts in the Conservative party, which includes MPs on the right who are skeptical of the green

agenda and its impact on voters amid pressure on the cost of living.

Home Secretary Suella Braverman gave voice to that thinking Wednesday, telling Times Radio: "We're not going to save the planet by bankrupting the British

people."

Sunak was backed too by the New Conservative group, a right-leaning caucus chaired by MPs Miriam Cates and Danny Kruger, who described the move as "put[ting] the working people of this country first."

Nuclear test 'guinea pigs' to relaunch compensation battle

Veterans of the UK's nuclear weapons tests are attempting to relaunch a battle for compensation a decade after being legally blocked from suing the government.

Campaigners say newly discovered documents suggest nuclear chiefs may have known the men suffered radioactive damage.

More than 22,000 personnel worked on detonations in Australia and the South Pacific in the 1950s and 1960s.

Campaigners believe personnel suffered cancers and had children with birth defects because of radiation.

The Ministry of Defence has repeatedly said large studies have found no link between the tests and ill health - and that it is not hiding documents from the veterans.

In 2012, the Supreme Court narrowly ruled that

more than 1,000 veterans could not sue the Ministry of Defence because they had run out of time to bring their case.

But recently found documents suggest the military have long held documents detailing blood and urine tests from personnel.

One of the documents seen by the campaign shows concerns about a pilot's blood after he had been flying scientific instruments through mushroom clouds.

The men and their families now plan to take the Ministry of Defence to court because they believe there could be thousands more such records.

If the records exist and prove military chiefs suspected radiation damage, that could lead to a last attempt at getting compensation.

Eric Barton, 82, of the "Labrats" campaign


group, said British personnel had been treated like guinea pigs.

He suffered cancer and received compensation from the American military because he had witnessed six test denotations of its bombs. But friends who witnessed British bombs have not received any money at all.

"The British government has for years said, 'you prove it,'" said Mr Barton.

"Well, we are now finding documents that are proving it - that the MOD has been covering everything up for years and years and years.

"People deserve compensation [from the British]," he says. "I know it's taken years and years and years - but a fight is a fight. Keep going. You don't give up in the first round. You don't give up in second round. You keep going."

New sex abuse allegation emerges against Brand

■ Los Angeles woman claims star exposed himself to her - then bragged about it on radio show just minutes later

THE SEXUAL ABUSE allegations against Russell Brand continued to grow this week when a woman came forward to accuse the star of exposing himself to her and then laughing about it minutes later on his BBC radio show.

The woman says it happened in 2008 when she was working in the same building as the BBC in Los Angeles. The encounter left her stunned, she says.

Minutes later, he was recorded laughing with his co-presenter who said Brand "showed his willy to a lady".

Neither Brand nor his co-presenter have replied to requests for comment.

The allegation comes just days after a bombshell report in The Times alleging a catalogue of accusations against Brand dating back two decades. But it is the first time that Brand has been accused of sexual misconduct and then heard discussing it.

'always consensual'

It also raises serious questions for the BBC about how that part of the show, which was pre-recorded, was allowed to be broadcast days later.

The woman never made a formal complaint. BBC management was informed about the incident in 2019, but no formal action was taken.

In a statement, the BBC said it was sorry to hear the allegations and would investigate them as part of a review into Brand's time at the BBC.

Four other women have also accused Brand, 48, of sexual assaults and rape between 2006 and 2013. He has denied the claims, saying his

relationships were "always consensual".

The woman worked for a media company in the same building as the BBC's Los Angeles office. On 16 June 2008, she says she answered the door to Brand and his team, who were there to pre-record an episode of The Russell Brand Show for Radio 2.

She then went to the bathroom to get some sinus medication, walking past the radio studio. While squatting to look through the medicine cabinet, she says she felt someone behind her.

She turned around to face a man's crotch. "I was startled and got up and I realised it was the man that I'd let in - Russell."

'showing his willy'

In the conversation that followed, she recalls him saying: "Oh, I think you're a bit alright. I think you're a bit of alright."

She says he told her he was going to call her Betty. When she said that wasn't her name, she says he replied: "Well, I'm gonna f**k you."

"And I said: 'No, you're not.'"

She says he then pulled out his penis on his hand and "pretty much served it to me as you would be serving someone some food".

She says the door to the bathroom was closed, and she felt trapped.

"There was a bit of banter going on because I didn't know what to do."

Olivia says he then put his penis back in his trousers, and she heard someone banging on the door. She says someone from his team called for him, at which point Brand left.

Olivia says she returned

to her desk in disbelief at what had happened, and texted a BBC employee in the office about it.

He told her that he knew what had happened because Brand was talking about it in the studio.

Following the investigation by The Sunday Times, The Times and Channel 4's Dispatches programme into Brand's alleged behaviour, published earlier this month, Olivia says she tracked down a recording of the programme.

The episode, which aired on 21 June, 2008, features the following exchange between Brand and Matt Morgan:

Morgan: "He got told off for ringing a bell, minutes later he's showing his willy." Brand can be heard laughing in the background.

Olivia, who has never worked as a receptionist, says she felt disgusted when she heard it.

"I feel ashamed, but more so I wonder had something been done, perhaps there would have been fewer women he would have done horrible things to, which we're reading about in the papers now."

Olivia never made a complaint but said she had hoped that someone from the BBC would contact her after hearing the recording. That never happened.

"Had I known audio existed, I probably would have done something as the incident would have been corroborated," she says.

Olivia says she feels let down by the BBC.

"What allowed that output go out like that? What made the BBC think

that was appropriate to go out like that? I just don't understand why they didn't investigate this much sooner. "And I suspect there's far worse in all those episodes that I can't even stomach to listen to."

Venables has been released from jail twice - but was sent back on both occasions

James Bulger killer Jon Venables gets parole hearing

■ Venables, who murdered the toddler in 1993 with Robert Thompson, is currently serving time for possession of child abuse images

Jon Venables, one of Jamie Bulger's killers, has been granted a two-day parole hearing.

The latest hearing will take place behind closed doors on Nov 14-15, the Parole Board confirmed.

Venables has previously been released from prison on two occasions but was sent back both times after being found in possession of indecent images of children.

Venables and Robert Thompson, both now 41, were just 10 years old when they abducted Jamie Bulger from the New Strand Shopping Centre, in Bootle, in 1993.

The two-year-old's mutilated body was found two days later on a railway line two and a half miles away in Walton, Liverpool.

Described by the trial judge as "wicked", he said they had committed a crime of "unparalleled evil and barbarity".

They were both sentenced to be held in detention for a minimum of eight years or until they were not deemed to be a danger to the public.

Venables was released in 2001 and provided with a new identity, but in 2010 he was returned to prison after being given a two-year sentence for downloading child abuse images.

He was granted parole in 2013 and, at huge cost to the taxpayer, was provided with a second new identity.

In 2017, he was again returned to prison for possession of child abuse images.

In February 2018, he admitted being in possession of more than 1,000 pictures of children being abused and was sentenced to three years and four months in prison.

In 2020, the Parole Board was asked to review his case when he became eligible, but the panel decided he should not be released.

At the parole hearing, victim impact statements from Bulger's mother, Denise Fergus, and father Ralph Bulger, are likely to be read out.

The parents have both pleaded with the Parole Board to reject Venables' bid to be released.

In 2017, after he was returned to prison for the second time, Ms Fergus said: "Venables has now proved beyond any doubt what a vile, perverted psychopath he has always been."

The three-person parole panel will also hear evidence from prison staff, psychiatrists and psychologists who have assessed Venables during his time inside.

Game of Thrones star Sophie goes to war over child custody

British actress Sophie Turner has sued her singer ex-partner Joe Jonas - requesting he return their two children to their "habitual residence" England.

The celebrity couple announced earlier this month that they were divorcing after more than four years of marriage.

They described the split at the time as "amicable".

However on Thursday, lawyers for Turner, 27, filed a legal petition citing the "wrongful detention" of their children in New York. The actress shot to global fame for her portrayal of Sansa Stark in the HBO series, Game of Thrones.

The 34-year-old Jonas Brothers singer, who is American, is seeking joint custody of their two daughters - Willa, who was born in 2020 and their second child, who was born last year but whose name has not been released to the public.

According to Turner's legal petition, the couple had made England their "permanent home" in April. The documents state that Jonas had incorrectly claimed in his divorce application that the children, who have dual citizenship, had lived in Florida for the six months before he filed it.

Turner and Jonas had agreed that the children

were allowed to travel to the US in August, where their father was on tour, the petition states, but this was a "temporary arrangement".

The court filing goes on to say that the pair met late last week to discuss their separation, during

which Turner reiterated their "agreed plan" for the children to return "home to England".

However, Jonas has allegedly refused to return their passports and to send them to the UK.

Turner is said to currently be in New York with the

children.

In response to the allegations, a representative for Jonas said that the pair's meeting on Sunday had been "cordial" and that his impression was that they had "reached an understanding that they would work together towards an amicable co-parenting setup."

"The children were born in the US and have spent the vast majority of their lives in the US. They are American citizens," the spokesperson said.

They added that Jonas wished for Turner to "reconsider her harsh legal position and move forward in a more constructive and private manner" and that "his only concern is the well-being of his children."

Jonas has also denied Turner's claims in the court documents that she found out about the divorce from media reports - saying she was aware in advance.

Earlier this week, Turner was photographed having dinner with pop star Taylor Swift - who dated Jonas in 2008. Online gossip blogs were in overdrive as photos of the two, walking along arm-in-arm, went viral.

English throughout his address, his joke warning against "low blows" but wishing "may the best man win" as France hosts the men's Rugby World Cup eliciting laughter from around the room.

The three-day trip began with the King and Queen touching down at Orly airport, near Paris, where they were greeted by the French Prime Minister

Elisabeth Borne, before driving to a ceremonial welcome at the Arc De Triomphe in Paris.

French President Macron and his wife Brigitte greeted the royals at the iconic French landmark, where they were treated to a joint flypast of the Air Force elite acrobatic flying team Patrouille de France and the RAF Red Arrows, while the King performed the re-kindling of the eternal flame at the Tomb of the Unknown soldier

using the Comite de la Flamme passed to him by Mr Macron.

From there they proceeded to the Elysee Palace for talks, before the King met members of the public on a walk from the Palace to the residence of the British Ambassador to France, where Charles, following a tradition set by his mother, Queen Elizabeth II, participated in a ceremonial tree planting.

On Thursday Queen Camilla and Brigitte

Macron visited the Bibliotheque nationale de France (BnF) on the other side of the Seine River, where they launched a new UK-France literary prize, the Entente Litteraire Prize. The royal couple then decamped to the city's northern suburbs, where they met French sport stars and local youth sports associations in Saint-Denis, where Charles was offered a Paris Saint Germain jersey by the club president Nasser al-Khelaifi.

Michael Caine has hinted that his upcoming film *The Great Escaper* could be his last, saying: 'I'm bloody 90 now, and I can't walk properly'.

The Academy Award-winning actor, 90, stars alongside the late Glenda Jackson in the forthcoming drama, which is inspired by true events.

The film tells a story of a Second World War veteran who escaped his care home in Hove, East Sussex, to attend the 70th Anniversary of the D-Day landings in France.

Sir Michael stars as Bernard Jordan, who made headlines around the world in 2014, while

Glenda will star as his wife Irene.

Glenda, who gave up her acting career in 1992 to serve in Parliament for more than 20 years, was working with Sir Michael on the film which proved to be her last just weeks before her death.

In an interview with *The Telegraph*, Michael expressed his concerns about the COVID-19 pandemic potentially marking the end of his career in 2020.

However later found hope by accepting a role in *The Great Escaper*.

He said: 'I was so happy to do it. I just loved the character of Bernie. I thought he was incredible, and it's so beautifully written.'

Discussing the possibility of concluding his remarkable eight-decade career he said that he was 'sort of

retired already.

He added: 'I am bloody 90 now, and I can't walk properly and all that...'

'I've had the best possible life I could have thought of. The best possible wife, and the best possible family...'

'They may not be a family that other people would say is the best possible family – but the best possible family for me.'

The *Interstellar* star who has been using support from a walking stick after undergoing back surgery last year explained how he used it with filming.

'I'd just do them once, and then fall over. But just one take, and that's it. Forget it.'

Michael's wife Shakira confirmed last year that Michael had undergone a major operation at a London hospital and has been suffering

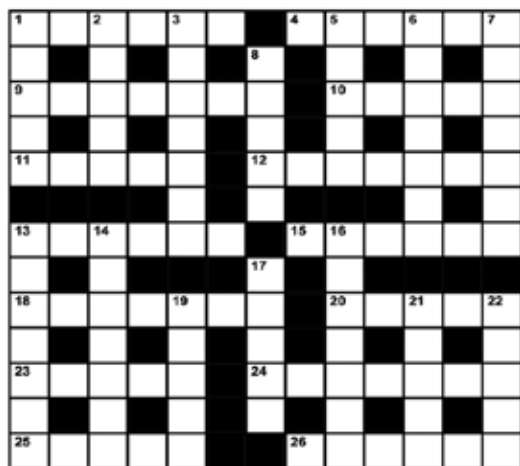
from spinal stenosis, a condition that narrows the spinal canal and can cause back and leg pain. Surgery is usually recommended

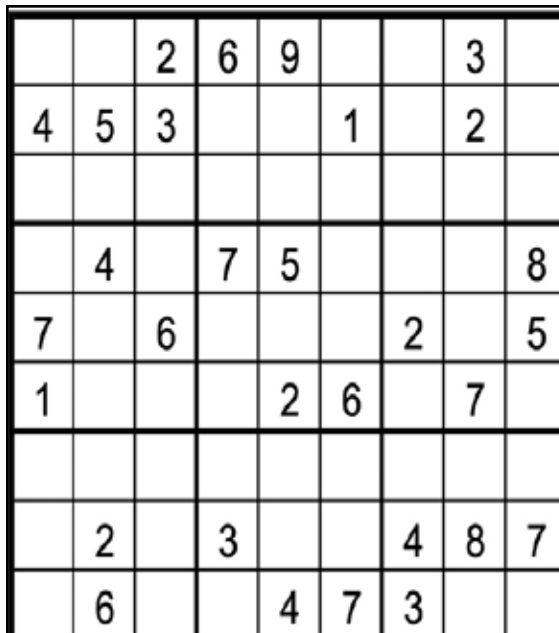

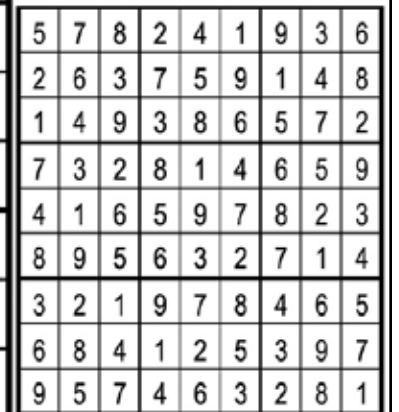

Sex Education: a very welcome return

■ Groundbreaking British series is back for a fourth - and final - season

THIS WEEK sees the very welcome return of the groundbreaking British series *Sex Education*.

The Netflix hit series is calling it quits after this, its fourth season, which makes sense now that the high-school age characters are aging out of their teen years. Maintaining a tone that is both comic and real, this instalment sees Otis (Asa Butterfield) and his friends head to a new, progressive school, Cavendish College. Ncuti Gatwa, soon to be the new Doctor Whok returns as Otis's best friend, Eric, as does Emma Mackey (Emily) as Otis's now-girlfriend, Maeve, who is studying in the US with a writing instructor played by Dan Levy (Schitt's Creek).

For the uninitiated, Sex

Education is essentially a coming-of-age story set which focuses on the trio of Otis, Maeve and Eric, and the rotating cast of characters who surround them, most of whom are dealing either with the hormonal and emotional challenges of young adulthood, or, in the case of the older characters, unresolved issues and trauma from their pasts which handicap their current interaction with the students.

Series creator Laurie Nunn recently explained her decision to end the show now, saying that while writing the fourth season, "it just started to feel very clear that the stories were coming to an end".

Laurie says the show started out as "this quite

basic idea of what would happen if we put a teenage sex therapist on to a school campus".

That teenage sex therapist turned into the inexperienced Otis (Asa Butterfield) who, encouraged by the entrepreneurial Maeve (Emma Mackey), ends up running a self-styled clinic at their school Moordale.

"It was a real opportunity to make a TV show that is really funny and entertaining and quite crude, and sometimes really outrageous," Laurie says.

"But it's also able to touch on topics that young people feel are important when it comes to talking about their sexuality and identity."

Viewers have grown attached to characters as they discover their sexualities and gender identities, while the show's also raised awareness of little-known conditions.

Empathy and warmth have been baked in from the start – as has a pronounced nostalgic quality. Though *Sex Education* is set in the present day at Moordale, a fictional British secondary school, the show has a retro US aesthetic conceived as an "homage" to the iconic 1980s teen movies of director John Hughes. Characters wear varsity-style bomber jackets and share confidences while leaning against high school lockers – just like Molly Ringwald in Hughes films like 1984's

Sixteen Candles.

According to an official synopsis, this season will have Maeve (Emma Mackey) and Otis (Asa Butterfield) learning a "very important lesson."

With distance, new settings and big changes in store, the season is promising drama, plus Dan Levy appearing as cult author Thomas Molloy, Maeve's course tutor at Wallace University, who nearly shatters her desire to write when he tells her she may not be fit to be an author. He's openly queer and hasn't been able to appropriately handle falling from his perch as a generational genius to the bottom of a mountain of rejection letters for his new work. He has an unorthodox teaching method that crushes students with the most potential into fragments of their former selves before he implores them to figure out how to build themselves back up.

The show's huge success internationally has been ascribed to its boldly treatment of topics including slut-shaming, abortion, virginity and masturbation - and that was just the first series.

It's also highlighted everything from sexual assault and STDs to disability and trans identities since it was first streamed.

So as the final series is released, writer Laurie reflects on the impact it's had.

"It's been really wonderful to see how

Newcastle's first shot on target arrived in the fourth minute of stoppage time when Sean Longstaff saw a fierce effort tipped over, but in the end a point at the San Siro is certainly an encouraging result for the Magpies.

Arsenal returned to Champions League football after six long years in the wilderness with a clinical dismantling of PSV at the Emirates in midweek.

The script for Arsenal's 4-0 win could have been penned by manager Mikel Arteta, so perfect was every aspect of this performance, played out in biblical rain in north London.

Yes, the weather was far from ideal but Arsenal's display was close to it as they outclassed a PSV side who had been unbeaten in 26 games, only to be totally overpowered.

It is far too early to debate just how deep Arsenal can go into the Champions League after one game, but no-one can doubt this was a hugely impressive return.

Arteta's obvious pleasure at the final whistle was brought on by a performance which was full of the old fluidity of last season, exemplified by a scintillating first half that served as a statement of intent about Arsenal's ambitions in Europe's elite competition this season.

PSV were swept aside

in those early phases, with fit-again Gabriel Jesus showing the quality he offers as well as the attacking focal point he provides when he is available to Arteta.

Bukayo Saka had already put Arsenal ahead when Jesus played him in after a lightning spin away from PSV's defence. He passed to

Leandro Trossard, who showed the class he demonstrated when scoring the winner at Everton on Sunday by steering in a smooth finish.

Jesus deservedly drove home a third before half-time, and Martin Odegaard's fourth was a fine flourish on a game that was already won.

So complete was Arsenal's control that Arteta was able to start preparations for Sunday's north London derby in advance by giving Saka, Trossard, Jesus, Declan Rice and Oleksandr Zinchenko an early night.

It simply could not have gone much better for Arsenal, Arteta or the Gunners fans, who made their way home in high spirits despite being drenched by the torrential downpour.

Reds stutter before brushing aside LASK

EUROPA LEAGUE: Liverpool find their feet after poor opening spell in Austria

LIVERPOOL were forced to come from behind on Thursday to beat a dogged LASK side, 3-1, in their Europa League opener in Austria.

Despite the wholesale changes this was a strong Liverpool XI, featuring Virgil Van Dijk as captain and summer signing Gravenberch, who made his full debut following his £34.3 million move from Bayern Munich.

Liverpool's bench was also packed with first-team talent, including Dominik Szoboszlai, Alexis Mac Allister and Salah, in case of emergencies.

Klopp indeed had to break the glass and bring on those three stars after an unimpressive early showing in which

Liverpool were stunned by Flecker's opener.

Sascha Horvath's corner found Flecker unmarked on the edge of the box, before Austrian took a touch and smashed the ball into the far corner.

Having fallen behind for the fourth time in five games this season, Liverpool responded and should have equalised before half time when Nunez headed towards goal from just three yards out, only to see LASK keeper Tobias Lawal claw the ball away on the goal line.

Liverpool raised their game and led 10 minutes after the break when Diaz was caught late by LASK defender Philipp Ziereis, with Nunez slamming the spot kick into the bottom corner.

Diaz and Gravenberch then combined with a rare moment of Premier League quality, the Dutchman firing in a low cross from the right which the Colombian lashed past Lawal.

LASK, though, could easily have been back before the Reds took the lead as they created chances of their own which forced Liverpool keeper Caoimhin Kelleher, making a rare start in place of Alisson, in to two fine saves.

The Irishman plunged

low to his right to keep out Elias Havel's effort from distance, before saving with his left leg

from Marin Ljubicic after a goalmouth scramble. Gravenberch suffered a knock with 15 minutes

to go and was replaced by Salah, who finished coolly through Lawal's legs in the closing stages.

AEK bring Seagulls down to earth

Brighton's eagerly awaited European bow fell flat as Greek heavyweights AEK Athens stunned Roberto de Zerbi's men with a 3-2 Europa League group stage victory on Thursday.

The Seagulls twice pegged AEK back after Djibril Sidibe and Mijat Gacinovic had taken advantage of Lewis Dunk's absence through injury to score from first-half set pieces.

But, even with 13 minutes' injury-time, Brighton had no answer after substitute Ezequiel Ponce converted a third after 84 minutes.

Niclas Eliasson was given too much time to cross after Tariq Lamptey had slipped as AEK launched a speedy counter-attack, Ponce applying the finish.

It meant Joao Pedro's unique double ended up counting for nothing.

Evidently, it is not unusual for the video assistant referee to intervene to award penalties. Remarkably, this time it happened twice, on

both occasions after the former Watford forward had gone down - he was booked for diving the first time.

Brighton's £30 million record signing took both penalties, twice sending the goalkeeper the wrong way.

Just before the teams came out, the stadium announcer called on the Brighton fans to "drink it in".

It is barely 25 years since the club were nearly relegated from the Football League, in the final match ever to be

played at their beloved Goldstone Ground.

Where the club has advanced to is remarkable.

Thanks to the vision of owner Tony Bloom, who was watching from the stands, they have a superb stadium, a state-of-the-art training ground and one of the most attractive and progressive teams in the Premier League.

Now they have Europe, with the mouth-watering visit of former Champions League winners Ajax to come next month and Marseille to follow in December.

Brighton manager Roberto de Zerbi congratulated his players even though their European debut fell flat but warned them they must be "smarter" to avoid a repeat of their 3-2 home defeat by Greek outfit AEK Athens.

"I congratulated the players afterwards," said De Zerbi. "I can't be happy when we win at Old Trafford and sad today because we lost if the performances were both good."
