Sunak tells Israel: 'We want you to win'

■ PM flies to Tel Aviv for crisis talks as major powers scramble to defuse a widening Middle Eastern conflict

RISHI SUNAK delivered a message of British solidarity with Israel during a whirlwind trip to Tel Aviv on Thursday, telling Prime Minister Benjamin Netanyahu: "We want you to win."

Standing alongside Netanyahu for a televised address, Sunak said he "knew" Israel is "taking every precaution to avoid harming civilians" as it responds to last weekend's attacks by Hamas.

The British PM arrived in Israel early Thursday morning for a two-day visit to the war-torn Middle East. He immediately held talks with Israeli President Isaac Herzog as well as Net-

anyahu.

Sunak told Netanyahu afterward: "I'm proud to stand with you in Israel's darkest hour as your friend, we will stand with you in solidarity, we will stand with your people, and we want you to win."

diplomatic push

Sunak also expressed the "deep condolences of the British people" at the mass loss of life during last weekend's attacks.

"We're increasing our aid to the region and we will look to get more support to people as quickly as we can," Sunak added.

The PM stressed the U.K. supports Israel's right to protect itself "in line with international law," and added: "I know that you are taking every precaution to avoid harming civilians," saying this was in "direct contrast to the terrorists of Hamas,

which seeks to put civilians in harm's way."

Sunak is set to visit other regional capitals during his two-day tour, although Downing Street has not confirmed a specific itinerary, citing security reasons.

A No. 10 spokesman did confirm that Sunak will travel next to Saudi Arabia for talks with Crown Prince Mohammed bin Salman.

U.K. Foreign Secretary James Cleverly is conducting his own diplomatic push to try to stop the conflict spreading across the region. He is

due to meet leaders in Egypt, Turkey, and Qatar to the Middle East.

In a measure of just how seriously London takes the risk of a wider escalation of the conflict, the Foreign Office said on Wednesday that it was advising its citizens against all travel to Lebanon because of risks associated with the conflict between Israel and the occupied Palestinian territories.

It also encouraged British nationals in Lebanon to leave now "while commercial options re-

main available".

"There are ongoing mortar, artillery exchanges and airstrikes in South Lebanon, on the border with Israel. Tensions are high and events could escalate with little warning, which could affect or limit exit routes out of Lebanon," the Foreign Office said in its updated travel advice.

British nationals in Lebanon should register their presence with the British Foreign Office, it said. Family members of staff at the British Embassy have been temporarily withdrawn.

Climate activist Greta Thunberg arrested during London anti-oil demo

Greta Thunberg was arrested at an environmental protest outside a London hotel hosting a summit of oil executives on Wednesday.

The 20-year-old Swedish activist smiled as she was put into a police van at the Inter-Continental Park Lane where the Energy Intelligence Forum is taking place.

She was among at least 20 people held at the demo.

Nuri Syed Corser, of protest organisers Fossil Free London, said: "We need direct action to take

back the power from the oil elite.

"Arrests like these will not deter us. Our right to protest is our own, it is not given to us by the Government."

'direct action'

The Met Police said: "There have been interventions by officers to enable members of the public safe access in and out of the venue. Six people were arrested for obstruction.

"Officers asked the protesters to move from the road on to the pave-

ment. A number of protesters failed to do so and we have now made a further 14 arrests for section 14 of the Public Order Act and a further one for criminal damage."

Ms Thunberg had claimed earlier that oil and gas firms were slowing the transition to renewables to make more money. She added: "We cannot let this continue. Their plan is to continue this destructive search of profits.

"That is why we have to take direct action. We

have no other option but to put our bodies outside this conference and to physically disrupt." Activists said they would continue to protest throughout the summit, which finishes tomorrow.

Forum speakers in-

clude the chief executives of Saudi Arabian refiners Aramco and Norway's Equinor plus net zero minister Graham Stuart.

Ms Thunberg added: "Fossil fuel industries were well aware of the consequences of their business models and yet

they have done nothing. They have actively delayed, distracted and denied the causes of the climate crisis."

Greenpeace protesters abseiled from the hotel roof and unfurled a banner reading "Make big oil pay".

British Muslim admits terror charges

■ Aine Leslie Davis was a member of the Islamic State death squad dubbed "The Beatles"

A BRITISH Muslim convert once suspected of being a member of the Islamic State death squad dubbed The Beatles has admitted terror charges.

Aine Leslie Davis, 39, was held at Luton Airport in August last year after being deported from Turkey where he had spent seven and a half years in jail for membership of Islamic State.

On Monday he pleaded guilty to two charges of funding terrorism between 2013 and 2014 and having a firearm.

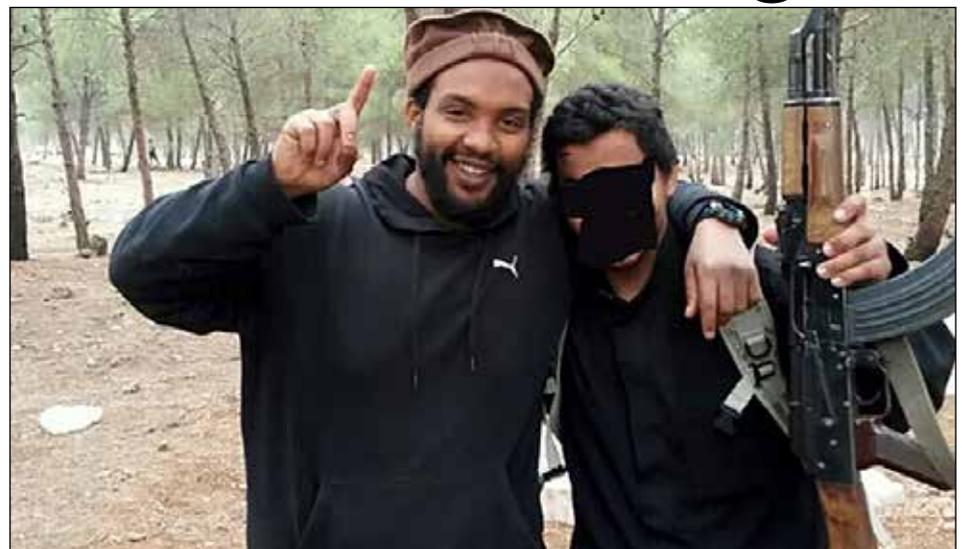
The defendant entered pleas via video from Belmarsh Jail to the Old Bailey. Judge Mark Lucraft KC adjourned sentence to November 13.

Davis's terrorist activities dated back to 2013 when he left his home in London to join IS in Syria.

Evidence was uncovered from communications with his then wife, mother-of-two Amal El-Wahabi, 36, who stayed in north London living on benefits.

Davis tricked her friend Nawal Masaad to courier money but she was caught at Heathrow on her way to Turkey with 20,000 euros in her tights.

Following El-Wahabi's arrest, police found

a stash of terrorist propaganda.

On her mobile phone was a picture of him posing with 13 others in military-style gear, with guns held aloft.

In 2014 El-Wahabi was the first convicted of funding terrorism in Syria and jailed for 28 months. Ms Masaad, 36, was cleared of wrongdoing.

Davis has always denied being connected with The Beatles cell – so-called because of their British accents – who tortured and beheaded western hostages in Syr-

ia.

Two of its members, El Shafee Elsheikh and Alexandra Kotey, are now serving life in US jails.

A third, Mohammed Emwazi, dubbed Jihadi John, was killed in a drone strike in 2015.

The hearing follows unsuccessful bids by Davis's legal team to get the case thrown out.

During legal argument at the Old Bailey in March, they claimed the then Home Secretary Priti Patel "begged" the US to prosecute Davis.

Davis's barrister Mark Summers KC claimed Ms

Patel veered into "Alice

in Wonderland territory" when she phoned US authorities in 2022. Mr Summers said the plan was ultimately abandoned but added: "The irregular personal involvement of the Home Secretary trying to persuade a foreign country to prosecute a UK national is frankly extraordinary.

"It's difficult to overstate the illegality and irregularity of what was under contemplation for some time."

The claim can only now be reported because of Davis's guilty plea.

Amazon drone delivery coming to the UK

Amazon has announced it will start using drones to deliver parcels in the UK in under an hour.

The online retail giant said the service would start in one location which is yet to be revealed, at the end of 2024.

The company already offers drone deliveries in two US states for goods weighing no more than 5lbs (2.2kg).

The aviation regulator said "exploring" how drones could be safely used in more of the UK's airspace was "key".

Amazon said it was working closely with the Civil Aviation Authority (CAA) to meet regulations, while the government said the move would help it understand "how to best use the new technology safely and se-

curely".

David Carbon, vice president of Amazon Prime Air, said he believed there was demand for the technology in the UK and that it was "absolutely safe".

"It's hundreds of times safer than driving to the store," he told the BBC in an interview in Seattle.

"I've never heard anyone say they wouldn't want something faster."

Customers will be able to choose from thousands of items which weigh 5lbs or less, from washing up liquid and toothbrushes, to beauty products and batteries to fill a "shoe-box size package".

The first area in the UK for deliveries by air will be named in the coming months.

Gallows humor kept me alive, says former soldier captured in Ukraine

A BRITISH former soldier who was tortured by Russian-backed forces in Ukraine has told how "gallows humour" helped him to survive.

Shaun Pinner, (right) from Watford, was serving with Ukraine's marines when he was captured in April 2022.

He was sentenced to death in a show trial but released in a prisoner swap with five other Britons five months later.

During his captivity, he said he was given electric shocks, Tasered, stabbed in the leg and pistol-whipped.

Mr Pinner, 49, said he had relied on "conduct after capture training" from his nine years in the British Army. "I had to draw on that experience from 30 years ago, I never lost hope," he said.

His knowledge of



Russian language and "gallows humour" also helped.

"I don't know how I would've done on my own, but I was with good guys that picked each other up with that sort of humour," Mr Pinner explained. He has now published a book about his experiences called *Live Fight Survive*.

Mr Pinner, who moved to Ukraine in 2018 and

wed two years later, added: "Sixty per cent of my wedding picture – the guys are either dead or captured."

Asked about the war, he said: "They [Ukraine] are certainly going to be fighting better on their doorstep, as Russian morale is really low. You can't expect anything, you can't predict anything, it's just going to go its course."

Guardian sacks cartoonist Steve Bell over 'anti-Semitic' Benjamin Netanyahu cartoon

VETERAN cartoonist Steve Bell says he has been sacked by The Guardian over claims that a new cartoon linked to Israel was 'anti-Semitic'.

The cartoonist, who has worked for the Left-wing newspaper for more than 40 years, claims he has been told it is no longer willing to publish his work after he submitted a controversial image of Benjamin Netanyahu.

In the picture, the Israeli prime minister wears boxing gloves and holds a scalpel over his exposed belly, readying a cut in the shape of Gaza, with the caption: 'Residents of Gaza, get out now.'

Critics have taken this to be a reference to Shylock, the Jewish moneylender in Shakespeare's play *The Merchant of Venice* who demands a 'pound of flesh' from someone who cannot pay him back.

Mr Bell has defended the image and decried accusations that he used anti-Semitic tropes – although it is not the first time he has faced these claims.

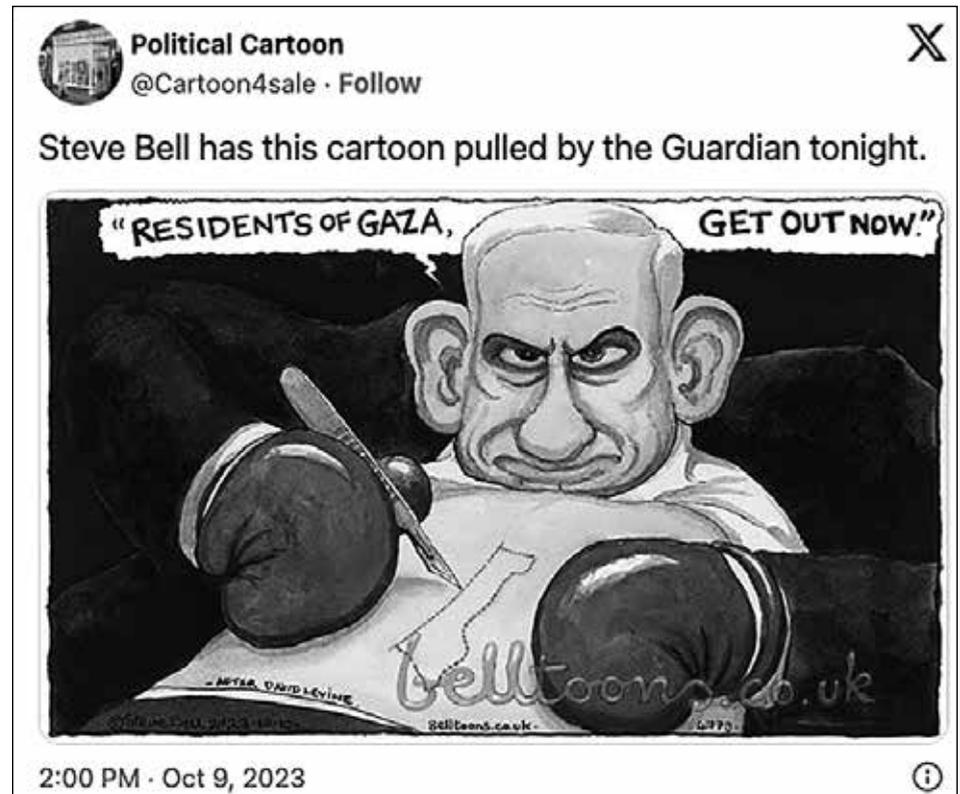
He has insisted it is a reference to a 1960s cartoon by David Levine, who drew US President Lyndon B. Johnson with a Vietnam shaped scar on his torso at the time of the war in the south-east Asian country. The cartoon Mr Bell submitted last week has the words 'After David Levine' above the artist credit.

On Monday, October

9, Mr Bell claimed on Twitter that he had submitted the artwork but it had been 'spiked again'.

He added that it was becoming 'pretty nigh impossible to draw this subject [Israel] for The Guardian now without being accused of deploying "antisemitic tropes".'

After filing it, he said he received a phone call from the newspaper

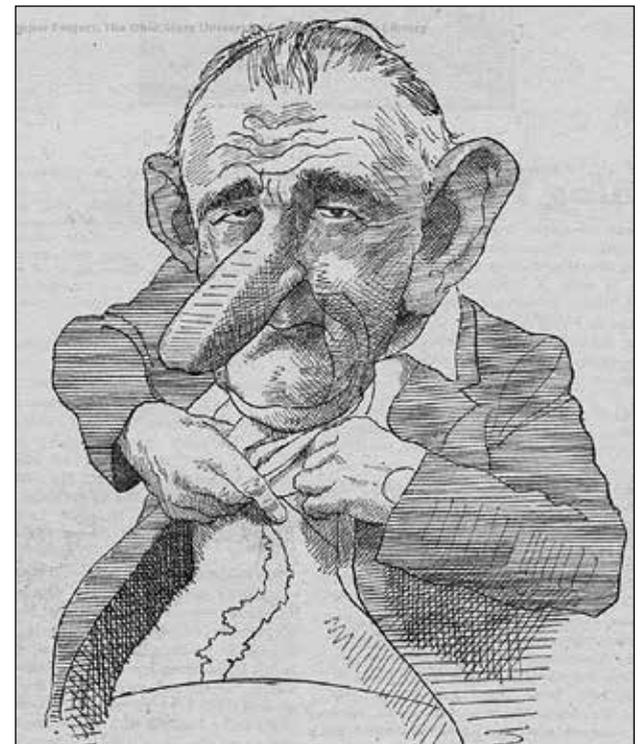


'with the strangely cryptic message "pound of flesh".'

Mr Bell later suggested the cartoon didn't make sense if it was a reference to the Shakespeare play, given Netanyahu is 'wearing boxing gloves'.

A spokesman for The Guardian confirmed the newspaper would not be renewing his contract.

They told the Telegraph: 'The decision has been made not to renew Steve Bell's contract. Steve Bell's cartoons have been an important part of The Guardian over the past 40 years – we thank him and wish him all the best.'



Don't look now, there's a nuclear submarine going down the street....

LOCALS in Cumbria got an eyeful of a very strange sight last month as parts of the Navy's newest ballistic missile submarine were transported through the streets of Barrow-in-Furness.

The move occurred on 21 September but given the highly sensitive nature of the program, the MOD only cleared the pictures of the transport for publication this week.

The submarine, part of the most recent Dreadnought class, was cloaked in a black covering to ob-

scure any further detail, is being constructed by BAE Systems at its nearby shipyard.

A BAE Systems spokesperson commented: "The longest ever 'mega-unit' so far for Dreadnought Boat 1 has been moved down the road into BAE Systems Submarines' Devonshire Dock Hall (DDH) in Barrow-in-Furness.

"At more than 20m, it was the longest submarine unit to move by road since the fore-end mega-unit moved to the DDH for the

final Vanguard boat in the mid-1990s.

"This mega-unit will now take its place on the Dreadnought build line as we continue construction of the next generation of deterrent submarine. Three of the four Dreadnought submarines are currently under construction in Barrow and will deploy into the Royal Navy fleet in the early 2030s.

The Royal Navy added: "All will be assembled under cover in the dock hall – 260 metres long, 58

wide and 51 high, making it almost large enough to accommodate the Titanic – where the final two

Astute-class submarines, HMS Agamemnon and Agincourt, are in the latter stages of construction/

completion, and where the 'mega unit' will take its place on the Dreadnought build line."

British Museum thefts were 'inside job', says George Osborne

■ Chair of trustees tells MPs security has been tightened and that recovered items will go on display

The British Museum was the "victim of an inside job" when approximately 2,000 artefacts were stolen from its collections, the chair of trustees, George Osborne, has said.

The museum, one of the most visited in the world, has been dealing with the aftermath of the thefts, which highlighted internal failings and led to the exit of its director. On Wednesday, it also announced plans to digitize its collection.

"Essentially we were the victims of an inside job by someone, we believe, who over a long period of time was stealing from the museum

and who the museum had put trust in," Osborne told parliament's culture, media and sport committee.

"Quite a lot of steps were taken to conceal [thefts] ... a lot of records were altered and the like."

Osborne said there were "lots of lessons to be learned" as a result, and that the thefts had prompted changes, including updating the museum's whistleblowing code and policy on thefts, as well as tightening up security.

The museum, which holds treasures such as the Rosetta Stone and the Parthenon marbles,

sacked a member of staff over the thefts, which are also being investigated by the Metropolitan police.

It has said the stolen items included gold rings, earrings and other pieces of jewellery dating back to ancient Greek and Roman periods, as well as small objects such as gems that were often set in rings.

Osborne also announced that the stolen items that had been recovered would be put on display. "There is a lot of public interest in these objects ... 350 have now been recovered and titles have been transferred to us so we have the mak-

ings of a good exhibition that was not previously planned," he said.

During the hearing,

Mark Jones, the museum's interim director, said steps had been taken "to improve security

and [we] are now confident that a theft of this kind can never happen again".

Storm Babet brings rare red weather warning to parts of Scotland

People in parts of Scotland have been urged to avoid travel and stay at home, with Storm Babet expected to bring severe flooding and disruption.

The Met Office has issued a rare red weather warning for "exceptional" rainfall in Aberdeenshire and Angus, stating there is a risk to life.

And amber and yellow warnings for wind and rain cover other parts of the UK.

The storm has already battered Ireland, with the army deployed to a

town where more than 100 properties were flooded.

Southern parts of the UK have also been affected as the weather front sweeps north and east.

Up to 10 inches of rain were expected to fall by Friday afternoon, and the red warning stated there would be "danger to life from fast flowing or deep floodwater" in Aberdeenshire and Angus, with extensive flooding and road closures also expected, as well as warning of wind gusts in excess

of 70mph (113km/h) affecting coastal areas.

It also warned of collapsed or damaged buildings and power cuts, and said some areas could be cut off for days.

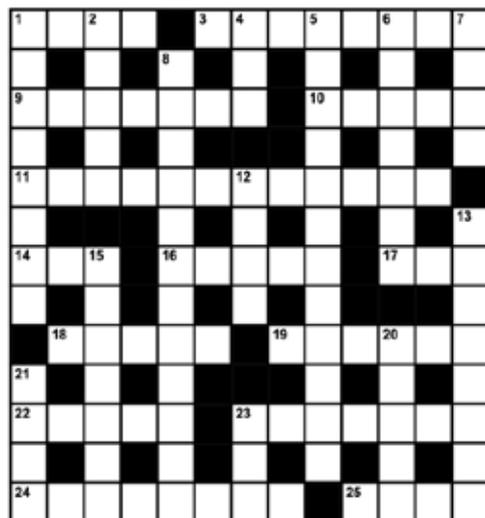
Angus Council closed schools in the region at lunchtime on Thursday and remained closed on Friday.

Sepa warned that Storm Babet was forecast to bring "unprecedented" levels of rain to the north east of Scotland, with flooding expected to cause the region "significant disruption".

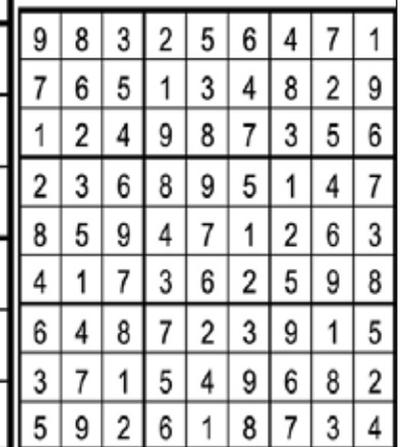

Itoje will start alongside Leicester's George Martin in the second row for only the second time, but says the 22-year-old will bring the edge required in a confrontation with South Africa's powerful front five.

England booked their semi final spot via a narrow win over Fiji in Marseille, with Owen Farrell's boot making the difference.

England led comfortably by 14 points with 15 minutes remaining, before Fiji's Peni Ravai and Vilimoni Botitu both crossed in a frantic four minutes to level the score at 24-24.

Farrell, whose name was booed when the team was announced in the stadium after he was chosen over George Ford to start at 10, vindicated his selection as his drop-goal made it 27-24 with eight minutes remaining.

CRICKET: World chumps thrashed by minnows

Afghanistan pulled off one of the biggest upsets in the history of the ICC Men's Cricket World Cup after they defeated defending champions England by 69 runs in Delhi on Sunday.

England's flat, error-strewn performance against a side that had only ever beaten Scotland in a World Cup was a reminder of the bad old days of English ineptitude and leaves their hopes of retaining their crown hanging by a thread.

This 69-run defeat will now sit alongside the 2015 upset by Bangladesh and the 2011 humbling by Ireland.

After also being mauled

by New Zealand earlier in the tournament, claims of a blip can be ignored.

The truth is this England ODI team have gone backwards since 2019 and the idea they will eventually be alright on the night is patently untrue.

They are a shadow of the trophy winners they were, and the players who have replaced Jason Roy, Eoin Morgan, Ben Stokes, Liam Plunkett and Jofra Archer are not quite producing.

Even a proven big-game player such as Chris Woakes has been way off his usual standards.

While Stokes may return imminently, it is a big ask for him to turn it all around.

Wilson double breathes new life into Dragons

HARRY Wilson struck a classy second-half double at the weekend to relieve the pressure on Rob Page - and put Wales right back into the Euro 2024 mix.

The Fulham playmaker celebrated earning his 50th cap with a cool brace as the Dragons earned a famous 2-1 win against Croatia in what was a must-win game.

Page had been put under pressure by FAW chief Noel Mooney to deliver safe passage to the Euros in Germany next year.

Defeat in Cardiff would have made it almost impossible - but Wilson came up with his most decisive display in a red jersey.

It was almost one decade to the day since he made his debut as a little-known apprentice at Liverpool.

He has moved on since then to become a performer of pedigree without truly stamping his mark on the international scene. That changed Sunday night.

Wilson, who operated on one side of target man Kieffer Moore with David Brooks on the other, might not have got his chance had Wales not been suffering injuries.

But Wales were on the

front foot from the start. It was Brooks' skill that created space for Neco Williams to thread a ball through to Wilson in the first attacking play. Domagoj Vida blocked.

Ten minutes later Wilson charged through again after Brooks found him with a neat ball. This time Vida picked up a booking after making his challenge somehow look clumsy rather than deliberate. The Fulham man picked himself up and curled a 25-yard free-kick goalwards that Dominik Livakovic did well to palm around the post.

For all the neat approach work, when the breakthrough came it was via an old-fashioned punt up field.

Keeper Danny Ward belted the ball towards Moore - he made a nuisance of himself all night - and it landed to Brooks who lifted a delightful ball forwards where Wilson's energy took him the wrong side of the Croatia back line.

The forward chested the ball down and then angled a chip beyond Livakovic who had come to meet him before finding himself in No Man's Land.

Three and easy for England!

■ Southgate's men confirm Euro 2024 place with convincing win over Italy
 ■ Harry Kane grabs a brace but Jude Bellingham steals the show again

England confirmed their qualification for Euro 2024 in Germany next summer after coming from behind to beat Italy 3-1 at Wembley on Tuesday night, inspired by another Jude Bellingham masterclass.

Gareth Southgate's side only needed a point to secure their place and it briefly looked like the celebrations may be delayed when former West Ham United striker Gianluca Scamacca gave Italy the lead from close range after 15 minutes.

Bellingham was England's talisman once more as the 20-year-old Real Madrid star led the comeback, winning the penalty that brought captain Harry Kane's equaliser.

Kane scored his 60th goal for his country after Bellingham ran through and was fouled by Giovanni di Lorenzo after 32 minutes.

And it was

Bellingham's surging run and pass that set up Marcus Rashford to cut inside and beat Italy keeper Gianluigi Donnarumma just before the hour before Kane extinguished any hopes of an Italy recovery when he raced clear to score England's third with 13 minutes left.

The win was England's first home victory over Italy since November 1977 and completed a double in the group after victory in Naples in March.

England are top of Group C with 16 points, while the defeat means Italy are third and will play Ukraine in their final qualifier in what will be a decisive match

to determine who finishes second.

Bellingham's performances for England and Real Madrid this season have fully justified all the superlatives aimed in his direction and this was another magnificent display from the youngster.

The midfielder was involved in everything, from being at the heart of most good things produced by England to even orchestrating the Wembley crowd when the atmosphere threatened to become subdued.

He is the real deal and already marked down as England's superstar.

Bellingham's relentless running and fierce determination was instrumental in England's recovery from that early blow of conceding, with Italy unable to cope with his energy and creation.

His two bursting runs

led to England's first two goals, fully deserving the standing ovation he was afforded when he was substituted late on from England's fans and he rightly lapped up their cheers after the final whistle.

RUGBY: We can best mighty Boks, Itoje tells England teammates

Mario Itoje has told his England team-mates to disregard the past and ignore the future to derail South Africa in Saturday's Rugby World Cup semi-final.

England lost to the Springboks in the 2019 final and were well beaten when the teams last met in November 2022.

"These occasions don't come by very often," Itoje said on Thursday.

"We can't afford to be distracted about what happens next week, in two weeks' time or four years ago. It is all about what happens on Saturday night."

Ten of England's

starting XV - including Itoje - played in the 32-12 defeat by South Africa four years ago in Yokohama and the 28-year-old says the atmosphere around the camp has ratcheted up as they attempt to avenge that loss and end the Springboks' title defence.

"It is an incredible opportunity, an incredible privilege and honour to be here," he added. "These moments are special in your career."

"You can definitely tell this is a big week, from the mood in camp, from the concentration of the boys, you can definitely tell there is a different

energy about the place."

England are distinct underdogs after South Africa produced a superb performance to eliminate hosts France last weekend.

Itoje has played South Africa 10 times for either England or the British and Irish Lions, winning four of those encounters.

"The DNA of South African rugby is more or less always consistent - strong set piece, strong kicking game, they have some very, very quick backs, good at the breakdown," he added.

"They are a good team, a good all-round team."
