# ARGIES AT IT AGAIN!

■ Regaining the Falklands a "permanent and unwaverable objective", says incoming President ■ "This is a long-settled issue and there are no plans to revisit it" says PM's spokesman

ARGENTINA has started a new phase of sabre-rattling over the future of the Falklands after Right-winger Javier Milei was elected president in a landslide victory this week.

Buenos Aires quickly went on the offensive, with the country's foreign office renewing its claim to the islands it calls the Malvinas, about 300 miles from mainland Argentina, saying regaining the territory was a "permanent and unwaverable objective".

Argentina invaded the islands in 1982, before being defeated by a British taskforce sent by then PM Margaret Thatcher.

The war claimed the lives of 255 UK servicemen, three islanders and 649 Argentine troops.

### 'self-determination'

Mark Pollard, chairman of the Falkland Islands Legislative Assembly, said: "It is not unusual in Argentina for a new president and their party to make commitments in relation to the sovereignty of the Falkland Islands. We, the democratically elected members, are very clear discussions on our sovereignty are nonnegotiable.

"We exercised our right to self-determination 10 years ago where 99.8% voted to retain our status as a United Kingdom Overseas Territory, in which there was a 92% turnout."

Meanwhile, Mr Milei, 53 – who reportedly uses a medium to communicate with his dead dog for advice on political matters – told a TV election debate: "What do I propose? Argentina's sovereignty over the Malvinas Islands is non-negotiable. The Malvinas are Argentine."

But he added: "We had a war, that we lost, and now we have to make every effort to recover the islands through diplomatic channels."

Defence Secretary Grant Shapps said Royal Navy ship HMS Forth had been sent back to "protect the islands", 8,000 miles from Britain, after a nine-month stint by HMS Medway.

The Government said it "will continue to proactively defend the Falkland islanders' right to self-determination".

Milei, a self-described anarcho-capitalist who has been compared to former US president Donald Trump, said during the election campaign "we have to see how we are going to get them back".

He is proposing

diplomatic negotiations rather than another invasion.

But the Prime Minister's official spokesman said: "This is a long-settled issue and there are no plans to revisit it. The position of the Falkland Islands was settled some time ago and will not be changed."

Foreign Office officials believe the issue resurfaces whenever the Argentine economy struggles, while local politicians like to make bold declarations during election campaigns.

Inflation is rampant with 40% of the population of the South American country in poverty.

Mr Milei has promised drastic changes such as cutting welfare and slashing bureaucracy by closing ministries including health and education.

He has described Margaret Thatcher as one of the "great leaders in the history of humanity".

But he also asserted "non-negotiable" sovereignty over the Falklands.

He said of the islands in the final TV election

debate: "We had a war – that we lost – and now we have to make every effort to recover them through diplomatic channels."

He proposed a similar solution to the handing over of Hong Kong by the British to China in 1997. Mr Milei told La Nacion: "Now we have to see how we are going to get them back.

"It is clear that the war option is not a solution.

"What we are proposing

is to move towards a solution like the one England had with China over the Hong Kong issue and that in this context the position of the people who live on the islands cannot be ignored."

# Immigration hits new peak

### ■ 745,000 more people moved to the UK than left in 2022

### ■ Latest figures pile more pressure piles on embattled Sunak

Net migration has hit a new peak with 745,000 more people moving to the UK than departing last year, official figures revealed on Thursday.

The Office National Statistics said migration net total for 2022, which had previously been estimated at a then record figure of 606,000, been upwards after census returns showed it to be at a significantly higher level than previously thought.

The statisticians said the rate of migration had slowed since then with the most up-to-date figures covering the 12 months to the end of June showing a net inflow of 672,000 migrants.

But the numbers will heap new pressure on Prime Minister Rishi Sunak — who has been criticised for focusing on small boat arrivals rather than the overall scale of migration — to find ways to bring the figures down.

The new figures came separate figures showed that rising migration has also triggered a record 578,00 leap in the population of England and Wales in the year to the end of June, adding to the need for more housing and increasing demand for public services.

The immediate focus, today, however, was on the record net migration figure. A breakdown, covering the 12 months to the end of June, shows that it was the result of an inflow of 1.2 million people balanced against a much smaller outflow of 508,000 people.

### healthcare workers

Most of those arriving were from outside the EU, with 968,000 migrants moving to Britain from countries in Asia, Africa and elsewhere, with largest number coming from India, Nigeria, China, Pakistan and Ukraine.

Immigration from EU countries was much lower, at 129,000, and only fractionally up on the previous year's tally. Britons returning from a life abroad made up the rest of the inflow.

The figures show that a third of migrants from outside Europe came for work, with a big increase in arrivals taking jobs in

health and social care.

There were also large numbers of international students with 39 per cent of those coming from outside Europe doing so to study.

The statisticians say that the large increase in net migration, which the Conservative Government wanted to cut to below 100,000, follows the introduction of a new immigration system introduced at the start of

It aimed to replace the free movement of EU citizens into Britain with a "points-based" system that made it easier for those outside Europe to move here.

The figures will heap further pressure on Rishi Sunak from within his own party, with a growing number of MPs openly critical of his failure to meet the party's own targets for immigration.

In an interview at the Nissan car plant in Sunderland on Friday, declined Sunak comment when asked whether he would apologise for not meeting the manifesto pledge. "I'm very clear that the

### Dublin erupts after children are stabbed

**DUBLIN** erupted civil into disorder and looting this week following a stabbing attack on primary school children by an immigrant reported to be Albanian.

Anti-immigrant protesters rampaged through the Irish capital, Thursday night setting fire to vehicles and looting stores after three young children stabbed.

rioters The were condemned by the country's prime minister the following day. Leo Varadkar said the county had endured two attacks, one on innocent children, the other on "our society and the rule of law."

"These criminals did not do what they did because they love Ireland, they did not do what they did because they wanted to protect Irish people, they did not do it out of any sense of patriotism, however warped," Varadkar told



a news conference. "They did so because they're filled with hate, they love violence, they love chaos, and they love causing pain to others."

Police blamed far-right agitators for starting the violence on Thursday, which began after three children and a number of people were attacked on Dublin's Parnell Square.

A five-year-old girl was receiving emergency treatment after sustaining serious injuries in the stabbing, police said in a statement Thursday.

A five-year-old boy and six-year-old girl suffered less serious injuries, the statement said, adding that the boy had been discharged from hospital. A teacher's aide in her 30s was also being treated for serious injuries, police

A man in his 50s was arrested, police said, adding that they were not looking for any other suspect. He "remains in a serious condition in a hospital in the Dublin Region," police said in an update Friday.

### Joss Ackland dead at 95

### ■ Acclaimed actor enjoyed long career on stage, TV and in film

British actor Joss Ackland has died at the age of 95, his family said in a statement.

The prolific stage and screen actor, who has been in more than 100 movies and TV series, died "peacefully" and was "surrounded by family", they said.

He was also described as a "beloved father" and had been married to his wife Rosemary for 51 years before she died in 2002.

The family statement said: "With his distinctive voice and commanding presence, Ackland brought a unique intensity and gravitas to his role.

"He will be remembered as one of Britain's most talented and beloved actors."

Born in 1928 in London's Ladbroke Grove area, Ackland grew up in Kilburn, north London.

He honed his skills by working for a variety of regional theatre troupes, eventually joining London's Old Vic.

Throughout his dazzling career, which spanned over six decades, he starred along a number of A-list actors, including Alec Baldwin and Sean Connery in The Hunt

for Red October, and produced a memorable turn as a South African criminal battling Mel Gibson in Lethal Weapon

The actor, who was made a CBE for services to drama in 2001, also spent much of his career on stage, starring alongside other British greats such as Dame Maggie Smith, Dame Judi Dench and Tom Courtenay.

The star leaves behind seven children, 34 grandchildren and 30 great-grandchildren.

While struggling to find work as an actor in the 1950s, Ackland and his wife pair embarked on a seven-week voyage by cargo boat to South Africa, before travelling to Malawi where they began working on a tea plantation at the foot of M'lanje mountain.

After six-months, the couple decided to move to South Africa where Ackland would try to find theatre work.

They remained there for more than two years until 1957 when police raided their flat confiscating the children's book Black Beauty over fears that it was subversive of apartheid.

'Then one day we were raided by the police and they confiscated a book, Black Beauty, because the horse was black! I was faced with prison, so I got out in a hurry,' he previously told the Daily Mail.

It was when they arrived back to England that Ackland joined the Old Vic and his career began to soar.

His TV credits included an appearance in the The Avengers in the shows 1960s heyday, and he also appeared in one of the Hammer Horror films, as a bishop in Rasputin: The Mad Monk in 1966.

His most recent credits include appearances in TV mini series Pinocchio in 2009, film Prisoners Of The Sun in 2013 and movie Fall Of An Empire: The Story Of Katherine Of Alexandria, also called Decline Of An Empire, in 2014.

Throughout his life, he worked with a long list of stars from all over the world.

But his family remained his focal point: 'His longest-running mate was Rosemary Kirkcaldy. They produced seven children, 32 grandchildren, and ten great–grandchildren.'

### Legal battle over Cushing's resurrected role

A horror film company is suing for £200,000 after Peter Cushing was "resurrected" in Star Wars spin-off Rogue One.

Cushing, who died of cancer in 1994 aged 81, starred in numerous chilling Hammer outings from the 1950s to the 1970s, notably as Dr Van Helsing in five Dracula movies.

He also appeared in the first Star Wars film in 1977 as Grand Moff Tarkin, the imperial officer in charge of the Death Star.

His character was later "recreated" using special effects for 2016's \$1billiongrossing Rogue One.

But Disney companies

Lucasfilm and Lunak Heavy Industries (UK), which made Rogue One, are now being sued, along with the executors of Cushing's estate and his former agent.

London-based Tyburn Film Productions, a rival to Hammer, says it had the rights over the star being resurrected by tech after signing a contract with Cushing.

Jonathan Hill, barrister for the Disney firms, told High Court Judge Francesca Kaye that Tyburn signed a deal with Cushing in 1993 over him appearing in a TV movie "provisionally entitled a Heritage Of Horror"

which was never made.

Part of that contract "had sought to make provision for the fact that Mr Cushing was terminally ill and so there was doubt as to whether he might be able to contribute to the TV movie."

Tyburn says this gave it the right to veto the star's special effects image being reproduced if the film was not made.

Mr Hill said the claim to have first dibs on SFX use of Cushing's image was "not realistic", as Tyburn had never recorded any footage of him to recreate the star.

The case continues.

### Cocaine tea railman unfairly sacked after failed drug test

A Network Rail safety worker sacked after he drank a traditional South American herbal tea infused with cocaine has won his case for unfair dismissal.

Paul Glenholmes knew it was not "ordinary green tea" but said he was unaware of the ingredients.

He bought it – with no label – to aid digestion from a market stall.

Mr Glenholmes failed a drug test and was fired after being told by a laboratory "drinking cocaine in tea does not make it legal". Employment judge Martin Brewer has now ruled he was unfairly dismissed due to Network Rail following wrong procedure.

However, the East Midlands tribunal refused compensation because the on-train technician was "wholly to blame" for not checking the tea's ingredients.

Mr Glenholmes referred to it as Inka tea but it is also called coca or mate tea. It is made from raw or dried leaves of the coca plant.

He said it was an instant cure.

# Cops quiz Russell Brand over historical sex offence allegations

RUSSELL Brand has been quizzed under caution by detectives over alleged historical sex offences.

A man in his forties, understood to be the comedian and actor, attended a police station in south London on Thursday, where he was questioned about three "non-recent" sexual offences, according to the Sunday Times.

No arrest has been made but police said the investigation is continuing.

The force encouraged potential victims to come forward after allegations of rape, sexual assault and emotional abuse were made in The Times and Sunday Times plus Channel 4's Dispatches programme against the 48-year-old broadcaster, in September. The four allegations women's were for the period 2006 and 2013 - at the height of Brand's career when he was a BBC and Channel 4 presenter and Hollywood actor.

Detective Superintendent Andy Furphy, who is leading the inquiry, later said: "We continue to encourage anyone

who believes they may have been a victim of a sexual offence, no matter how long ago it was, to contact us."

He added: "We understand it can feel like a difficult step to take, and I want to reassure that we have a team of specialist officers available to advise and support." The force said that it had since received a "number of allegations of sexual offences in London" as well as elsewhere in the country.

Married dad-oftwo Brand has denied the allegations and said although he had been "extremely promiscuous" all relationships had been consensual.

A Metropolitan Police spokesman said: "A man in his forties attended a police station in south London on November 16

"He was interviewed under caution by detectives in relation to three non-recent sexual offences. Enquiries continue."

Allegations against Band had included claims of controlling, abusive and predatory behaviour.

### Four teens dead in as camping trip turns tragic

## ■ Schoolboys found in partially submerged car after skidding off the road in horrendous conditions in Snowdonia

FOUR school friends who went missing on a camping trip to Snowdonia were found dead in their partially submerged overturned car this week.

Loving tributes were paid to the teenagers after the wreckage was spotted near a mountain road.

The boys had been the focus of a major land and air search after they failed to return home to Shropshire from their trip to the Welsh national park.

They were named as Jevon Hirst, Harvey Owen, Wilf Henderson and Hugo Morris. The Shrewsbury College friends were aged between 16 and 18.

Police, mountain rescuers, coastguards and volunteers had searched for the A-level students and North Wales officers said their Ford Fiesta was found off the A4085 near Tremadog.

The boys had little driving experience between them and the weather was "atrocious" at the time, said locals.

The four friends had set out with a tent and sleeping bags on Saturday but worried family and friends raised the alarm on Monday.

Supt Owain Llewellyn, of North Wales Police,

said: "This appears to have been a tragic accident." He added that his "thoughts are with the family and friends of the four young men at this very difficult time" and he paid tribute to the search teams.

First Minister of Wales Mark Drakeford said the boys' deaths was "devastating news", adding online: "My thoughts are with their family and friends... as they deal with the unimaginable."

Crystal Owen, mother of Harvey, 17, said that she did not know he had gone on a camping trip.

She said she had thought that her son was staying at the house of a friend's grandfather.

Crystal added: "If I'd have known, I wouldn't have let him due to the winter weather conditions."

Snowdonia – known as Eryri in Welsh – is popular with climbers, hikers and campers.

But they can encounter severe gales, snow and driving rain with freezing temperatures.

Local resident Emyr Owen commented: "It was atrocious weather on Sunday. I don't know what happened." The teenagers were last seen in the Porthmadog and Harlech areas on Sunday morning.

Police believe their car came off the road at Garreg, near Tremadog. The local Plaid Cymru MP Liz Saville Roberts said: "This news is truly heartbreaking.

"Foremost as parents ourselves, our thoughts go out to the families and friends of the four young men whose lives have been lost in this tragic accident.

"We would like to pay tribute to the emergency services and local mountain rescue teams involved in the search operation, and to members of the public for their assistance in helping to locate the vehicle. No words can sufficiently reflect the sorrow that this news brings to our whole community."

A police statement said yesterday: "It is believed that the group travelled to Harlech on Saturday 18th with plans to camp in the Eryri area on Sunday.

"A large search was undertaken overnight and that continued into this morning.

"Shortly after 10am a member of the public contacted us, reporting a vehicle having left the road.

"Police officers attended and located a Ford Fiesta vehicle upside down partially submerged in water."

The statement went on: "Tragically the bodies of four young males were recovered from within the vehicle. The families of the missing men have been informed."

# Hurley has fans giving thanks for kitchen thirst trap





Wales have been drawn to host Finland in the semifinals of the qualification playoffs for Euro 2024. The match will take place on 21 March at Cardiff City Stadium.

Should Rob Page's men win that single-leg tie, they would then host either Poland or Estonia five days later to play for a place at next summer's tournament in Germany after the draw handed the winner of their semi-final home advantage in the decider.

Finland finished third in Northern Ireland's qualifying group – four points behind both Denmark and Slovenia – after winning six of their 10 fixtures. They sit 62nd in the Fifa rankings, 34 places below Wales, and are aiming to qualify for the European Championship for only

the second time following their debut at Euro 2020.

Wales are seeking to secure a third successive appearance at the finals and reach a fourth major tournament out of the last five after last year ending their 64-year wait to play at the World Cup. They finished third in Group D of qualifying, behind pool winners Turkey and second-placed Croatia.

"We were wanting to avoid Ukraine so it's gone to plan for us," said Page. "The form we're in at the minute and with the 'Red Wall' at home, we'll take anyone on in Cardiff. It's a great opportunity for us. We're hoping now for two big efforts."

Just three of the 24 places at Euro 2024 remain up for grabs, with Wales attempting to navigate Path A of the playoffs. In Path B, Israel face a semi-final against Iceland following Thursday's draw at Uefa's headquarters in Nyon, Switzerland, while Bosnia and Herzegovina will host Ukraine, who came third in England's group.

But it will be hard to shake a feeling of dissatisfaction given the nature of their controversial 1-1 draw with Turkey on Tuesday.

Wales took the lead and looked comfortable until referee Matej Jug awarded Turkey a dubious secondhalf penalty after rejecting three Wales penalty appeals in the first half.

Asked if Wales would have won had there been a different referee, Page said: "I believe so."

He added: "I have to be careful what I say, it was a stonewall penalty against Brennan [Johnson], one of the most obvious I have seen, and we have conceded the softest penalty I have ever seen.

"It's so frustrating at this level. I can't get my head around it. But the performance? I thought the lads were excellent. We were going for the win and everyone could see that."

# Ding-dong at Hampden seals joyous campaign for Scots

Scotland's successful Euro 2024 qualifying campaign ended with a thrilling draw as Mohamed Elyounoussi's late equaliser earned Norway a point at Hampden Sunday night.

Steve Clarke's side had already secured their place in Germany next summer but had to settle for second place in Group A, with Spain, as expected, overcoming Georgia to win the section.

The Scots twice came from behind in the first half, with sloppily-conceded goals scored by Aron Donnum and Jorgen Larsen cancelled out by John McGinn's penalty and Leo Ostigard's own goal.

Stuart Armstrong's strike looked to have earned another win in front of a jubilant Tartan Army, before former Celtic winger Elyounoussi capitalised on a wonderful, floated ball to level late on.

Scotland now await the Euro 2024 draw next month, for which they will be among the third pot of seeds.

With key players missing, this was an opportunity for squad players to impress. Scotland started with a back four but, with the

likes of Kieran Tierney and Andy Robertson unavailable, they looked exposed, particularly in the first half.

Norway capitalised when the impressive Oscar Bobb caused havoc, Larsen outmuscled the defence and Donnum stroked home the loose ball via a deflection off Nathan Patterson and a post.

The response was swift in front of a party-mode Tartan Army, determined to celebrate their passage to Germany.

After McGinn was caught on the edge of the box, the free-kick was half-cleared but a follow-up shot struck Donnum's arm and McGinn netted his 18th international goal from the penalty spot.

His contribution has been overshadowed in this campaign by the exploits of Scott McTominay, but the ovation the Aston Villa midfielder received when substituted said it all as he moved to sixth on Scotland's all-time goalscoring list alongside Kenny Miller.

Scotland were caught again, though, when they failed to defend a ball from the right and Larsen nipped in front of the despairing Clark to bundle home. Again,

the defending looked suspect.

To their credit, Clarke's side responded once again when Kenny MacLean flicked on McTominay's corner and the ball rebounded off Ostigard and over the line

Scotland side exerted more control after halftime and Armstrong looked to have secured victory with a fine finish after an excellent exchange with McGinn.

Norway would not be denied though as Julian Ryerson's dink caught Clark out and Elyounoussi made sure with a neat back-post header to offer small consolation for their failure to qualify directly.

Scotland defender Jack Hendry says getting out of the group at a major tournament will be "top of the list" of their ambitions.

"To get back-to-back European Championship is a major achievement," he told BBC Scotland.

"We want to go there and make an impact on this tournament. I feel that we can do that."

# Everton "aggrieved" at 10-point deduction

### ■ Penalty for breaching financial rules 'disproportionate', says Dyche

Sean Dyche says Everton feel "aggrieved" at their "disproportionate" 10-point deduction for breaching financial rules.

The Toffees were given the biggest sanction in Premier League history last week, dropping them from 14th to 19th, joint-bottom alongside Burnley.

The club has said it intends to appeal.

"Like everyone in these parts, I was shocked. [From] the wave of noise it seems like everyone in football was shocked," said Dyche.

"The enormity of it. Disproportionate is a word being used and obviously we are going to feel aggrieved by that."

Despite the punishment, Dyche says his job "hasn't changed" and his players are prepared "for the next challenge".

The Toffees host Manchester United at Goodison Park on Sunday (kick-off 16:30 GMT) and, after a poor start to the season, go into the fixture having won six of their past nine games in all competitions.

"It doesn't change the focus, which is sorting things out on the pitch, getting the team to win and the performances to feel different," said former Burnley boss Dyche.

"We were on the right lines for that and delivering strong performances - [the punishment] has given us a push back to go forward again. The job hasn't changed for me, [but] it has made it more difficult in the current circumstances until the appeal.

Everton say the financial breach centres around interest payments for their new £760m stadium at Bramley Moore Dock.

The club believed those interest payments represented permissible 'add backs' for profit and sustainability calculations in the 2021-22 financial year, but the investigating commission disagreed

and did not accept the club's claim of mitigating factors.

Director of football Kevin Thelwell said Everton's spirit remains "strong" and "unwavering", and insists the club is "united".

Meanwhile, a group of fans has raised more than £40,000 for anti-Premier League protest material for Sunday's game.

Dyche said: "I can't get involved in all of that, but [there is a] swell of Toffees getting behind the club, and the feeling of Evertonians is one of [injustice].

"There is a feeling of standing stronger more than ever, and all we can ask for is their backing and support in the stadium. They will be supporting that team and we need to continue building the connection.

"What happens on the pitch is the vital thing. We have been changing that, the results have shown that."

# Southgate upbeat as campaign ends with a damp squib in Skopje

England manager Gareth Southgate believes "he has learned a lot" despite his side finishing their European Championship qualifying campaign unbeaten with a disappointing draw at North Macedonia.

Already-qualified England got the point they needed to secure a top seeding at Euro 2024 in Skopje on Monday, but were unable to improve on their underwhelming performance in Friday's 2-0 win over Malta.

"I think in both matches we've been able to look at different players as well as trying to win," Southgate said.

"Normally you're waiting until March to do that. We've learned quite a

bit from those two games which is an advantage for us."

The hosts were awarded a controversial penalty at the end of the first half when England debutant Rico Lewis caught striker Bojan Miovski with his hand as he jumped up for a header.

North Macedonia captain Enis Bardhi put his side ahead from the rebound after his spot-kick was saved by England goalkeeper Jordan Pickford.

England equalised in the 59th minute when Phil Foden's corner deflected in off Macedonian Jani Atanasov under pressure from Harry Kane.

The point sealed England's place in pot one for the draw for next summer's European Championship in Germany as one of the top five group winners, with 20 points from eight qualifying matches.

One positive for Southgate was teenager Lewis who became England's 20th youngest player, making his debut a day before his 19th birthday.

The versatile Manchester City player made his club debut less than 12 months ago, but has also impressed for Pep Guardiola's side this campaign in defence and midfield.

"I thought he was excellent," added Southgate. "His ability to receive in tight areas was a standout."
