

# A FOND FAREWELL, SHANE MACGOWAN

■ Tributes flow as The Pogues's hard-living frontman passes away at 65

The Pogues frontman Shane MacGowan has died aged 65, following a recent hospital stay after being diagnosed with encephalitis.

The singer-songwriter, whose hits include 1987's Fairytale of New York and A Pair of Brown Eyes, had been unwell for some time.

MacGowan also had well-documented problems with drugs and alcohol.

His wife Victoria Mary Clarke said on Instagram that MacGowan "meant the world to me".

She wrote: "I don't know how to say this so I am just going to say it. Shane... has gone to

be with Jesus and Mary and his beautiful mother Therese."

She said MacGowan "will always be the light that I hold before me and the measure of my dreams and the love of my life and the most beautiful soul and beautiful angel and the sun and the moon and the start and end of everything that I hold dear".

A statement from MacGowan's spokesperson confirmed he "died peacefully at

3.30am this morning (30 November) with his wife and sister by his side".

"Prayers and the last rites were read during his passing," he added.

On 22 November, Clarke said he had left hospital, and just a few days later she said they celebrated their wedding anniversary, and were grateful they were "still alive".

Born in Kent, MacGowan was the son of Irish immigrants and fronted The Pogues from 1982 until their break-up in 2014.

He had formed the Irish punk band Pogues Mahone, later shortened to The Pogues, in 1982 and released seven studio albums.

In 1988 Kirsty MacColl collaborated with The Pogues for the Christmas song Fairytale of New York, written by MacGowan, which got to number two in the UK chart and remains one of the UK's best-loved Christmas songs.

MacGowan revealed

he was diagnosed with encephalitis last year in a video posted to social media on New Year's Eve.

It is an uncommon but serious condition in which the brain becomes inflamed, according to the NHS website.

He had also used a wheelchair since 2015 after injuring himself in a fall.

In 2018 he was honoured with a lifetime achievement award at a 60th birthday party in Dublin's National Concert Hall.

A documentary about his life - Crock Of Gold: A

Few Rounds With Shane MacGowan - was released in 2020.

He was close friends with Irish singer Sinéad O'Connor who died in July.

In her statement, Clarke said: "I am blessed beyond words to have met him and to have loved him and to have been so endlessly and unconditionally loved by him and to have had so many years of life and love and joy and fun and laughter and so many adventures.

"There's no way to describe the loss that I am feeling and the longing for

just one more of his smiles that lit up my world."

Irish President Michael D Higgins described Shane MacGowan as one of "music's greatest lyricists".

"Like so many across the world, it was with the greatest sadness that I learned this morning of the death of Shane MacGowan," he said.

"His words have connected Irish people all over the globe to their culture and history, encompassing so many human emotions in the most poetic of ways."

# Former Chancellor Alistair Darling dead at 70

## ■ Labour titan guided UK through 2008 banking crisis

Alistair Darling, the Labour chancellor who steered the UK through the 2008 financial crisis, has died aged 70, a family spokesperson has said.

Following Labour's landslide 1997 election win, Lord Darling served in cabinet for 13 years under Tony Blair and Gordon Brown.

He was best known as the steady pair of hands who shepherded the UK economy as half its banking system collapsed.

The ex-Edinburgh MP died after a short spell in hospital, his family said.

A statement issued on behalf of his family called Lord Darling a "much-loved husband of Margaret and beloved father of Calum and Anna".

The family said he died in "Western General Hospital under the wonderful care of the cancer team".

Labour leader Sir Keir Starmer said Lord Darling "lived a life devoted to public service".

"I consider myself incredibly fortunate to have benefited from Alistair's counsel and friendship," added Sir Keir.

"He was always at hand to provide advice built on his decades of experience - always with his trademark wry, good humour."

The whole Labour movement felt a "profound" wave of shock, he added.

Mr Brown, who after becoming prime minister brought Lord Darling in as chancellor, said he was "deeply saddened" to hear of his death.

He said: "In times of crisis Alistair was the person you would want in the room because he was calm and he was considered and he had great integrity."

### 'highly capable'

Tony Blair added his voice to the tributes, calling Lord Darling "a rarity in politics".

"I never met anyone who didn't like him. He was highly capable though modest, understated but never to be underestimated, always kind and dignified even under the intense pressure politics can generate."

Prime Minister Rishi Sunak said Lord Darling's passing "is a huge loss to

us all", while Chancellor Jeremy Hunt described him as "one of the great chancellors", who did "the right thing for the country at a time of extraordinary turmoil".

Alistair Darling was born in London in 1953 and but moved to Scotland to attend the prestigious Loretto school in Musselburgh.

Despite becoming known as the mild-mannered New Labour centrist, Mr Darling was associated with far-left policies as a student activist in Aberdeen - reportedly distributing "Marxist" leaflets at railway stations.

A lawyer by profession, he first entered politics in 1982 after being elected to the former Lothian Regional Council.

Five years later he became an MP, and was seen as a key ally of Tony Blair and Gordon Brown as they sought to modernize their party and transform it into New Labour.

Entering government 10 years later Mr Darling served as chief secretary to the Treasury, putting in place wide-ranging reforms to financial

regulation, after the collapses of Barings and BCCI.

He then replaced Harriet Harman as social security secretary - a role now known as work and pensions secretary - delivering Labour's welfare reforms and taking responsibility for spending a third of the government's budget.

While in this role Mr Darling once said he hoped to be remembered as "the minister who began to eradicate poverty".

Despite a long career in government little could

have prepared Lord Darling for his near three-year stint as chancellor - the job for which he was handpicked by Mr Brown in June 2007.

### 'Scariest moment'

He was appointed amid seemingly calm economic times. But it was a Number 11 tenure marked by financial chaos, unseen in Britain for decades.

His decision to nationalise Northern Rock at first, and then effectively the bulk of British banking amid runs on banks by the public and financial markets set

the tone for the global response to the 2008 financial crash.

Looking back on the financial crisis, Lord Darling said the "scariest" moment was when the Royal Bank of Scotland called to tell him they would run out of money that afternoon.

In his memoirs he wrote: "My initial reaction must have been a bit like that of the captain of the Titanic when he was told by the ship's architect that it would sink in a couple of hours. There were not enough lifeboats for all the passengers."

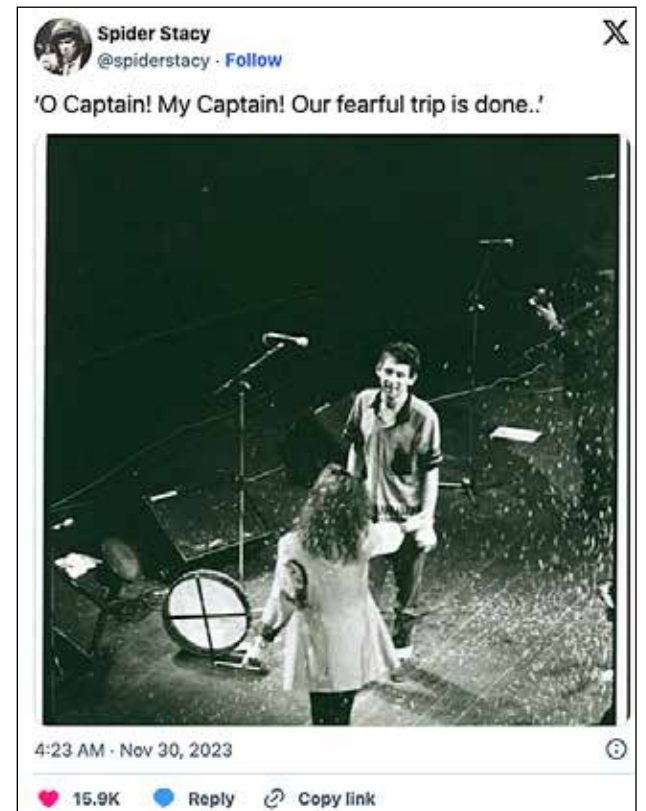

The musician Nick Cave called him "a true friend and the greatest songwriter of his generation," adding it was "a very sad day."

The Charlatans frontman Tim Burgess also paid tribute, describing MacGowan as "a lyrical genius. An inspiration to so many of us who wanted to be in bands. I followed The Pogues to far flung places, met Shane a few times and watched some of the most exhilarating shows I've ever witnessed," he also said on social media.

Derry Girls actor Siobhan McSweeney has said that Shane MacGowan "was the voice of London for us Irish" and said when she was scared about moving to the capital "he lured me over with songs about



chancers, drinkers, lovers, poets and scoundrels".

Fairytale of New York producer Steve Lillywhite said MacGowan was "truly a poet", crediting him for inventing "a new

style of music that was sort of the punk attitude with traditional Irish rhythms".

MacGowan's bandmate, Spider Stacy also paid tribute with a band photo (above).

# Race and the royals: Charles and Kate briefly 'outed' in Dutch version of new book

■ Pair inadvertently 'named' as the royals who speculated on the color of Harry and Meghan's first baby

The simmering race row between the Royal Family and the Duke of Duchess of Sussex erupted again with a bizarre incident in which identity the previously-unnamed royals who allegedly speculated on the color of Harry and Meghan's unborn child was revealed.

A Dutch version of Omid Scobie's book *Endgame: Inside the Royal* was pulped after King Charles and Kate, Princess of Wales were named as the pair in a section focusing on 'unconscious bias'. The book was withdrawn within hours and the book's publisher initially described it as a 'translation error', before revising their excuse to

just 'an error'.

Meghan Markle had initially made the claim in her bombshell interview with Opra Winfrey in 2021, although she decline to name the royal family members allegedly involved.

The book claims conversations about Archie related to how it opened up discussions about whether there was "unconscious bias" in the royal family.

### withering

Buckingham Palace declined to respond on Thursday. "It is not something we are going to comment on," a spokesperson said.

The broadcaster Piers Morgan, who has been outspoken in his

criticism of Harry and Meghan, used his TalkTV show on Wednesday to name the royals and to pull apart the seemingly nonsensical reason offered by the publisher for the revelation. Morgan was withering in his criticism both of the book and its revelations, repeatedly referring to author Scobie as Harry and Meghan's 'lickspittle' and branding him 'a liar' for claims in the book that Morgan had 'regular phone conversations' with Queen Camilla. The presenter said of Scobie: "He's a liar...I have never had a single phone conversation with Queen Camilla"

### 'code of conduct'

Scobie himself insisted he had "never submitted a book that had their names in it", and could only talk about the English version that he wrote.

He said he had never used the word "racist", and that his book referred to "unconscious bias". He claimed other Fleet Street journalists had "known those names for a long time".

He said the inclusion of the names was "still being investigated right now. I wrote and edited

the English version of the book with one publisher. That then gets licensed to other publishers. I obviously can't speak Italian, German, French, Dutch or any of the other languages. So the only time you hear about the

book is once it's come out in the public domain. "I am as frustrated as everyone else. The reality is, though, that this is information that is not privy just to me. Journalists across Fleet Street have known those

names for a long time. We've all followed a sort of code of conduct when it comes to talking about it."

# PM's fury as EU boss says young Britons should reverse Brexit

**Tories fire back: "British people are not children. They are grown-ups who decided to exercise their treaty right to leave the EU."**

RISHI Sunak has dismissed suggestions from EU chief Ursula von der Leyen that young people should reverse Brexit, with one senior Tory calling her remarks "nonsense".

The Prime Minister insisted withdrawal has made Britain stronger, despite the European Commission President hinting the UK could soon be on a path to rejoining the bloc. Mr Sunak also lashed out at Labour leader Sir Keir Starmer, who has pledged to forge closer ties with the EU if he gets elected.

The PM warned that Sir Keir will "back Brussels over Britain every single time".

Tensions erupted after Ms von der Leyen suggested that Brexit was a mistake that needed to be "fixed".

Asked whether Britain could ever rejoin the EU, the German politician told an event in Brussels: "I must say, I keep telling my children, 'You have to fix it. We goofed it up, you have to fix it'."

"So I think here too, the

direction of travel, my personal opinion, is clear."

She also described the Windsor Framework, signed by her and Mr Sunak to address Northern Ireland's Brexit issues, as "a new beginning for old friends".

### "Brexit freedoms"

Asked if Brexit was "in peril" and whether he agreed with the President's remarks, the PM's spokesman said: "No. It's through our Brexit freedoms that we are, right now, considering how to further strengthen our migration system.

"It is through our Brexit freedoms we are ensuring patients in the UK can get access to medicines faster, that there is improved animal welfare. That is very much what we are focused on."

Brendan Clarke-Smith, deputy chairman of the Conservative Party, described Ms von der Leyen's remarks as "nonsense".

David Jones, a former minister, said: "Ms von der Leyen should understand that the British people are not children. They are

### "true colors"

Mark Francois, chairman of the European Research Group of Eurosceptic Tory MPs, said Ms von der Leyen needed to "come to terms with Brexit".

"What did he come up with? Well, he showed his true colours and chose Ode to Joy, literally the anthem of the European Union, and he will back Brussels over Britain every single time."

reprinted: "I'm glad to hear so."

Asked if he was upset about the names appearing, he said: "I have never submitted a book that had their names in it. So I can only talk about my version. I'm obviously frustrated, but I wouldn't say I'm upset about it because, to be honest, I've been operating in a bubble of no emotion for the last 10 days. But I'm frustrated about it just like many of the other things I've seen said or written about the

book."

Scobie said: "Firstly, I have never used the racist word in this subject. Even the book makes it very clear we are talking about unconscious bias here.

"We're talking about a conversation that was raised about the colour of Archie's skin, that they called "concerns". For me it was important to get to the bottom of that; why was it not covered ever again, why did the Sussexes never talk about it, what happened behind the scenes? The palace said it was being dealt with privately. Was it?"

## Greek PM in Elgin Marbles blast

THE Greek prime minister has compared the British Museum's possession of the Elgin Marbles to the Mona Lisa painting being cut in half.

Athens has long demanded the return of the Parthenon Sculptures, which were removed from Greece by Lord Elgin in the early 19th century. Kyriakos Mitsotakis will raise the issue with Prime Minister Rishi Sunak and Labour leader Sir Keir Starmer during talks in London this week.

But neither supports changing the law to allow the collection to return to Greece permanently. Mr Mitsotakis, speaking on BBC TV, said "If I told you that you would cut the Mona Lisa in half,

and you will have half at the Louvre and half at the British Museum, do you think your viewers would appreciate the beauty of the painting in such a way?"

The Greek prime minister has been accused of using the Elgin Marbles for his own domestic political goals amid a furious diplomatic row.

Rishi Sunak pulled out of talks with Mitsotakis at the last minute following the remarks.

The Prime Minister is against returning the friezes to Athens, fearing a "slippery slope" that could lead to other artefacts being removed from British museums.

Conservative MP Tim Loughton, chair of the

All-Party Parliamentary Group on the British Museum, said: "You do not trade away cultural treasures for political expedience and our Prime Minister was right not to allow his Greek counterpart shamelessly to use them for his own domestic political agendas.

"That would be the worst possible reason for tearing away the sculptures from the home where they have been safely and widely appreciated for over 200 years."

He also accused Mr Mitsotakis of "grandstanding and trying to make a political issue out of one of the world's greatest treasures".

# Confederate flag just won't fly any more for Country-loving Glaswegians

Scotland's most famous country music club has narrowly upheld a decision to ban the American Confederate flag.

Members of Glasgow's Grand Ole Opry voted by 50 to 48 this week to maintain a ban agreed by the venue's committee last month.

The flag dates to the Civil War era of the 1860s when it was used by slave-owning states in the South.

Many Americans now view it as a racist symbol although others defend it as an emblem of southern heritage.

The Confederate flag had been the centrepiece of a flag-folding ceremony held at the end of each night at the venue.

One member of the Opry, speaking to reporters on condition of anonymity before the vote, said: "It is a disgrace in this day and age that there are still members who wish to use the Confederate flag for their ceremony."

The original decision to remove the flag had been made by club officials on 9 October - a move that led to the club's president resigning.

Some members had requested a vote to reinstate the flag and a secret ballot was held during an emergency meeting.

In a statement, officials at the Opry said the flag had been "causing offence to visitors and a lot of members" and had led to "disturbances"

which had affected the safety of the committee, members and visitors.

Numerous bookings and events had been cancelled because of the connotations of the Confederate flag, they said.

The Grand Ole Opry takes its name from the famous venue in Nashville, dubbed the home of country music.

The Glasgow venue held its flag-folding ceremony - dubbed the American trilogy - at the end of each club night.

The Opry says this was to commemorate the estimated 620,000 Americans who died during the US Civil War of 1861-65.

The club's website explained: "As the Southern states lost the

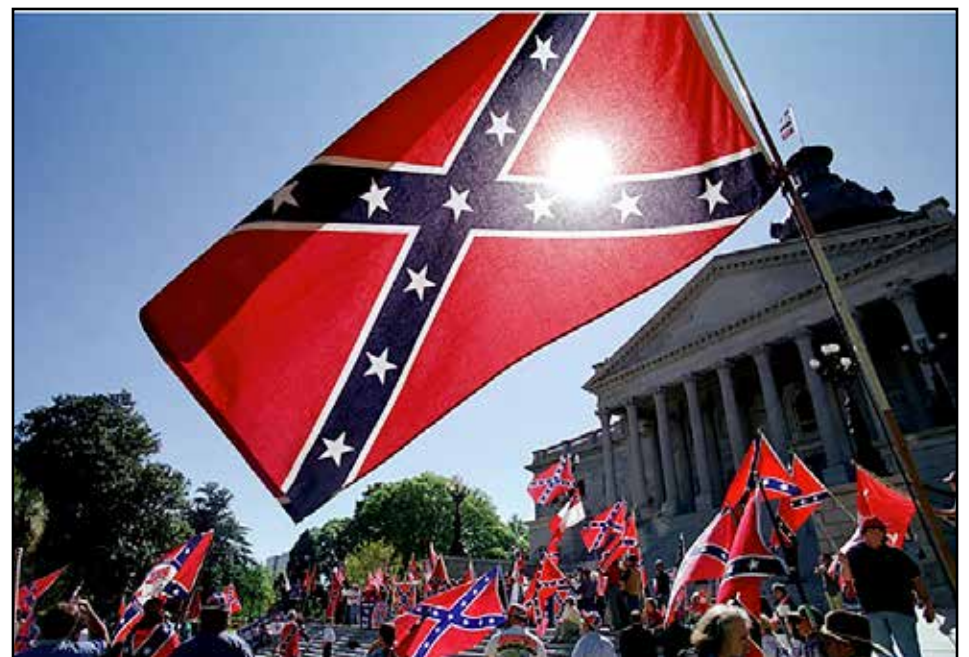
war, and due to the fact that this part of America supplied us then, as now, with most of the trends that influence our music, dress and dance, it is the Southern flag (often called the Confederate Battle flag) which is

folded."

The ceremony was accompanied by the 1972 Elvis Presley hit, An American Trilogy, a song which combines the southern Confederacy's unofficial anthem, Dixie, with the northern

Union's Battle Hymn of the Republic.

The website added that the occasion "takes the form of a more traditional salute that encompasses both a flag folding ceremony and a number of shots fired in tribute."

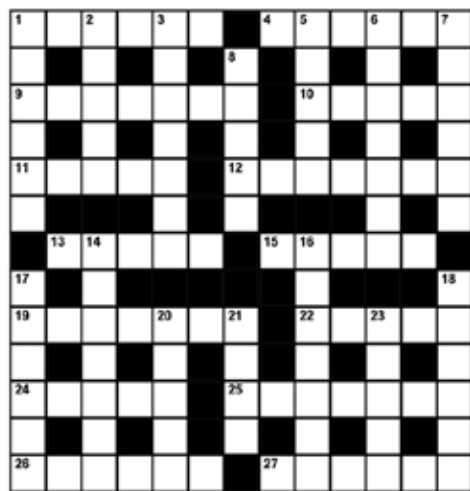

# Another day, another record for Haaland

Erling Haaland obliterated a Champions League goalscoring record at Etihad Stadium in midweek as Manchester City fought back from two goals down to complete a thrilling victory against RB Leipzig.

The Norway forward is the quickest player ever to score 40 goals in the competition - reaching the milestone in just 35 matches, 10 fewer than Ruud van Nistelrooy, the previous record holder.

His goal also sparked a comeback win that

Three minutes from time, Alvarez completed the fightback, steadying himself eight yards out before delivering a precise finish to the corner after Foden had provided the cross.

## Impressive Villa just keep on winning

Alex Moreno returned from a six-month injury lay-off to score the winner as Aston Villa beat Legia Warsaw and moved above them at the top of Europa Conference League Group E on Thursday.

The Spanish defender was named in Unai Emery's starting XI for the first time since suffering a hamstring injury in May, and was on hand to turn home Douglas

Luiz's pinpoint free-kick for already-qualified Villa.

Emery's team had led through Moussa Diaby's first-half drive, before being pegged back as Ernest Muci took advantage of Boubacar Kamara's stray pass at the back.

Among Villa fans' jubilation, news filtered through that missiles were thrown at police outside the ground before kick-off,

resulting in Legia supporters not being allowed to enter the stadium.

Police later said they made 39 arrests as officers were "faced with disgusting and highly dangerous scenes".

Villa had already qualified before kick-off, thanks to AZ Alkmaar's win over Zrinjski Mostar earlier in the day, but they couldn't find a third goal which would have sealed top spot in the group.

## High flying Seagulls clinch knockout phase spot

Roberto de Zerbi hailed a "historic day" for Brighton & Hove Albion on Thursday as they beat AEK Athens 1-0 to book their spot in the knockout phase of the Europa League.

The Seagulls, playing in Europe for the first time in their history, earned revenge for their 3-2 loss at home to AEK in the opening match of the group stage to ensure their adventure continues.

"We showed a different mentality tonight, showcasing our soul and resilience," De Zerbi told Uefa.com.

"It was a historic day for Brighton, for the club and our fans.

"It is a massive evening for the club and everyone involved, the players and the fans, a result we will always remember."

Joao Pedro, who scored two penalties in the reverse fixture on the south coast, was accurate again from the spot as he sent goalkeeper Cican Stankovic the wrong way for the only goal in Greece.

Referee Sandro Scharer did not initially give the penalty after Pedro went down under pressure from Damian Szymanski, but he overturned his on-field decision after being advised to check the pitchside monitor following a VAR check.

AEK's hopes of forcing their way back into the encounter were dashed just 10 minutes later when forward Mijat Gacinovic, who had been a thorn in Brighton's side all night, was sent off after receiving a second yellow card for a late challenge on Joel Veltman.

With an extra body on the field, Albion monopolised possession and maintained a firm grip on the contest for the final 25 minutes to claim just their third clean sheet of the season.

# Making a right Onana of himself...

■ Another horror show from United keeper leaves Ten Hag's men on brink of Champions League exit

Manchester United's Champions League hopes suffered another setback in midweek as a horror show from goalkeeper Andre Onana allowed Galatasaray to earn a 3-3 draw in a classic match in Istanbul.

Erik ten Hag's side did so much right and twice held a two-goal lead but errors from Onana threw Galatasaray lifelines to leave United bottom of Group A with their hopes of reaching the knockout phase in the balance before their final game at home to Bayern Munich.

After Bayern Munich's draw with Copenhagen later in the evening, Manchester United will be knocked out of the competition if

they fail to beat the German champions and there is a winner between Galatasaray and Copenhagen in a fortnight.

United, as they did in their last Champions League game in Copenhagen, were in a commanding position early on after superb strikes from Alejandro Garnacho and Bruno Fernandes inside the first 18 minutes.

Onana's poor attempt to stop Hakim Ziyech's free-kick got Galatasaray back in the game before half-time but United looked to have gained control again in what was a hostile atmosphere when Scott McTominay turned in Aaron Wan-Bissaka's cross 10

minutes after the break to make it 3-1.

However Ziyech was gifted a second goal from another free-kick after an even more stark blunder from Onana, who made a hapless attempt to keep the ball out, before Galatasaray substitute Kerem Akturkoglu's explosive finish brought them level with 19 minutes left.

In a dramatic end-to-end finale, Wilfried Zaha missed a glorious chance for Galatasaray and Fernandes struck the upright as United's Champions League destiny was taken out of their own hands.

United saw history repeat itself - and not in a good way - as they were left to regret squandering
