Extinction Rebellion founder dodges jail

■ Gail Bradbrook tells court she had 'permission from nature' for her criminal damage, before accusing the judge of 'mansplaining'

The co-founder of Extinction Rebellion has received a 15-month suspended jail sentence after a marathon legal battle over her breaking a pane of glass.

Dr Gail Bradbrook was convicted last month of causing more than £27,500 of damage to the Department for Transport.

At Isleworth Crown Court, Judge Martin Edmunds KC said Bradbrook had a conscientious motive but that did not excuse her actions.

During the sentencing hearing, she accused judges of "mansplaining".

Bradbrook, from Stroud, Gloucestershire, was joined by a group of supporters dressed as suffragettes. In court, there was applause as the Extinction Rebellion (XR) activist finished her address to Judge Edmunds.

In October 2019, during XR's second major protest that brought traffic chaos to parts of central London, Bradbrook climbed on

to an entrance canopy at the headquarters of the Department for Transport (DfT).

She used tools to break a large pane of reinforced security glass, which cost £27,660 to replace.

During her police interview, she said she had been trying to stop crimes against humanity and "had permission from nature" to break the window.

'slightly deranged'

Over two trials she tried to make similar arguments despite being repeatedly directed not to do so by the judge because none of them amounted to a defence that a jury could consider.

On Monday, Bradbrook told Judge Edmunds: "It can't be that there's compelling, objective evidence of a threat to life, and that's just completely irrelevant to the whole legal process."

"I know that is not what justice seeks to serve."

Bradbrook's case is one of scores linked to

environmental protests since 2018 in which activists said damage, or serious disruption, caused as part of civil disobedience was legally justified.

She accused the courts in these cases of "condescension" and treating activists "as if we were acting in good faith but slightly deranged".

"I've had to listen to judges incorrectly characterizing and, worse still, mansplaining the effectiveness of civil disobedience," she said.

Becoming tearful, she concluded: "God help us... life is being actively killed. We are compelled to act. The court systems of the UK are on trial, not myself."

"I wonder how history will judge this sentencing."

Judge Edmunds said Bradbrook had "actively sought" prosecution to attract publicity, and had wrongly tried to tell the jury that her actions had been legally necessary.

"As a matter of law, that was certainly incorrect for damage on

this scale," he said.

"I put it down to an echo chamber of misinformation and wishful thinking. In many pre-trial hearings you accepted that the law did not provide you with a defence. Yet throughout, you have sought to avoid those penalties [for damaging the window] rather than accept them."

Earlier this year the Court of Appeal ruled

that judges hearing environmental protest cases should not evaluate the merits of the cause.

If a protester had been motivated by conscience, and the damage or disruption caused had not been excessive, judges were told to consider reducing the sentence.

Judge Edmunds said that the damage and disruption caused by Bradbrook meant she

would have normally have been jailed.

But taking into account the Court of Appeal ruling and wider personal factors he suspended Bradbrook's prison sentence, meaning she could leave court a free woman - but could be jailed if she commits another crime in the next 15 months.

She was also ordered to also carry out 150 hours of unpaid work.

I lied about my escape to protect my mum, Alex Batty tells tabloid

British teenager Alex Batty has revealed he lied about the details of his escape to protect his mother and grandfather from police.

In an interview with The Sun, Alex said doubts about the nomadic lifestyle they kept began when he was "14 or 15 years old".

The teen said future ambitions led him to

abandon the nomadic lifestyle in the French Pyrenees.

He was found walking along a road in France six years after going missing.

Back in the care of his legal guardian, his grandmother in Oldham, Alex has spoken extensively about the night of his escape and what drove him to leave.

Already present feelings

of doubt grew stronger a year ago, he told the tabloid, as his dreams of becoming a software engineer felt far away.

"I realised it wasn't a great way to live for my future," he said.

The life he could foresee if he stayed with his mum involved "moving around, no friends, no social life. Working, cont. on page 5, col. 1

Pair of teens guilty of 'senseless' murder of transgender teen Brianna

Two 16-year-olds have been found guilty of the "senseless" murder of Brianna Ghey, a "witty, funny and fearless" transgender girl who was stabbed 28 times in a Warrington park this year.

The murder-obsessed teenagers, known as Girl X and Boy Y to protect their identities, were found guilty unanimously by a jury at Manchester crown court on Wednesday after it deliberated for four hours and 40 minutes.

The judge, Mrs Justice Yip, said she would sentence the pair next month, and later revealed she plans to lift reporting restrictions so that the killers could be named.

She told the teenagers that she would have to impose a life sentence but that she needed to adjourn for further reports to decide on the minimum tariff they must serve.

The pair showed no reaction to the verdicts, but their mothers wept in

the court.

Afterwards, Brianna's mother urged "empathy and compassion" for the killers' parents, saying they "too have lost a child and must live the rest of their lives knowing what their child has done".

Girl X, who was fascinated by serial killers and boasted of watching torture videos on the dark web, said she was "obsessed" with Brianna. She and Brianna had been friends for a few months before she began plotting to kill her, along with Y.

Nigel Parr, senior investigating officer for Cheshire police, said Brianna had been betrayed by two teenagers whose only motivation was to experience how it felt to kill. "This was a senseless murder committed by two teenagers who have an obsession with murder," he added.

Y had never met Brianna until the day of the murder, which took place in the middle of the afternoon

in Culcheth Linear Park on 11 February. The teenagers were disturbed by a couple walking their dog, and ran away, before being captured on CCTV making their way home calmly.

Though X and Y had been friends since they were 11, they turned on each other after their arrests. The girl initially made up a story about Brianna "going off with some lad from Manchester", before changing her defence to claim that the boy was responsible for killing her.

Y blamed the murder on X, saying he was urinating against a tree in the park when he turned around to see X stabbing Brianna.

The jury was told they did not have to decide which one of the teenagers stabbed Brianna to find them guilty of the joint enterprise murder.

The court heard how their web of deceit began shortly after the killing when the pair began to

craft what they thought would emerge to be a subtle cover story.

Girl X messaged boy Y to say a "woman got stabbed" in the park.

"Holy crap" was boy Y's reply despite the pair later admitting to police they were present during the stabbing - albeit blaming each other for the killing.

The following day, girl X messaged Brianna saying: "Girl, is everything okay? Some teenage girl got killed in Linear Park its on

news everywhere.

For Det Ch Supt Mike Evans, it became clear early on that the two school pupils believed they could cover their tracks.

Girl X even assured boy Y that he would not be caught, criticising the capabilities of police in the area.

"These are really high functioning, intelligent children," said the officer, who is head of crime at Cheshire Police.

"I know people sat at

home reading this will have this sort of image that they've built themselves.

"But actually they're both really clever kids and very bright, very articulate.

"I think probably their downfall has been their confidence or arrogance around the fact that they thought that they could take another human life and then thought there would be no comeuppance for them and they'd never get caught."

DAD: 'a beautiful girl to be proud of'

Brianna Ghey was a trans influencer – a social media star beloved by her many fans.

But behind her brave exterior was a shy and trusting teenager.

Brianna had thousands of followers on TikTok, where she went by the name @gingerpuppyx. But she was also at times anxious and struggled with low spells, despite the support from her devoted, loving mum Esther Ghey and dad Peter Spooner.

One of her last ever TikTok posts sees her looking to the camera as she tells her fans she is "giving life one last try".

However her head teacher Emma Mills, of Birchwood Community High School, stressed that Brianna "didn't live her life as a victim", adding: "There was

never any evidence of Brianna being bullied within school or out of school.

"Brianna was very much able to give as good as she got in that way. And what was really hard was that she was portrayed as a victim. She was someone that was loud and proud and confident in who she was. Brianna was the most determined and hilarious student and she was never afraid to speak her mind. At school, we will miss her wit, her handbags and all the things that made Brianna the truly unique individual she was.

"She taught us so much about character and staying true to yourself – things we will value in her memory. It was a privilege to have had her as part of our school family."

Her dad Peter said his girl had "an amazing talent", remarking: "I look into her eyes and they shine back at me. I know she was a beautiful girl to be proud of."

When Brianna got the message from her "friend" Girl X to meet her near Culcheth Linear Park to "hang out", CCTV captured her leaving home and boarding a bus.

The jury heard Brianna did not tend to go out on her own and, as she rode on the bus, messaged her mum for the last time, telling her: "I'm on the bus by myself, I'm scared." Ms Ghey replied: "Oh that's well good xx."

Meanwhile X had been telling Y she wanted to stab Brianna "jus coz its fun lol... I want to see the pure horror on her face and hear her scream".

Terminally ill Dame Esther considering 'buzzing off' to assisted dying center

■ Veteran consumer campaigner Rantzen may head to controversial Swiss clinic to spare her family the final hours of a painful death

DAME Esther Rantzen is considering "buzzing off" to the controversial assisted death facility Dignitas to spare her family from the final hours of a painful death.

The TV star and campaigner, 83, has signed up to the Swiss centre as she battles stage four lung cancer.

She said: "My family say it's my decision and my choice."

And as Dame Esther prepares to enjoy a Christmas she feared she would not live to see, she called for a free Commons vote on assisted dying.

Dame Esther said going to Zurich would be her final selfless act for her loved ones.

She added: "I explained to them that, actually, I don't want their last memories of me to be painful.

"Because if you watch someone you love having a bad death, that memory

obliterates all the happy times. I don't want that to happen.

"I don't want to be that sort of victim in their lives."

Dame Esther, who was diagnosed with lung cancer last January, has spent a lifetime fighting injustices and championing the underdog.

But her plight has made her contemplate her life, legacy and those less fortunate than herself.

If Dame Esther was Prime Minister for a day she said she would call for a free vote on assisted dying, adding: "It's important that the law catches up with what the country wants."

She also told the BBC's The Today Podcast her next scan "that tells me whether the miracle drug is performing its miracle or whether it's given up"

is not scheduled "for quite a few weeks" yet.

She said: "I didn't think I would make it to my birthday [June 22]. I definitely didn't think I'd make it to this Christmas, which I am, it appears.

"The Christmas I didn't expect to have with my family is going to be so precious, and I think that once it's over, I would like to relive it.

"I have joined Dignitas. I have in my brain thought, well, if the next scan says nothing's working I might buzz off to Zurich but, you know, it puts my family and friends in a difficult position.

"They would want to go with me. And that means that the police might prosecute them. So we've got to do something. At the moment, it's not really working, is it?"

Dame Esther added: "The thing that cheers my

family up is the thought that all the lovely people who I have loved and lost and have gone before, like my late husband, my parents, my friend John Pitman and others, will be waiting for me with a cup of tea and maybe I'll stroll through the Pearly

Gates.

"But if you believe that, maybe you've also got to believe that I might be hurled into the fiery furnace."

Dame Esther's candid comments are a further endorsement for a campaign which has

steadily gained support among Britons. It calls for a law change to allow terminally ill people with less than six months to live, who are of sound mind, the option of requesting medical assistance to end their lives.

8 year-old British girl hailed by world of Chess

An eight-year-old girl has been crowned best female player at the European blitz chess championships.

Bodhana Sivanandan, from Harrow, north-west London, scored 8.5/13 at the event in Croatia, finishing ahead of seasoned professionals in the process.

She defeated an international master and drew with a grandmaster, in a result described as "unbelievable".

The chess prodigy, who began playing aged five, said she was "proud" of her performance over the weekend.

The tournament was held at the blitz time

control - a quick form of chess where players have just minutes on their clocks for their moves.

Chair of the board at English Chess Federation (ECF) Stephen Woodhouse said: "In essence, there are three types of timings in a chess game - standard, rapid play and blitz."

"A blitz game usually varies from three minutes to five minutes, so it's very quick," he explained.

Bodhana's opponents included grandmasters - the highest title given to the world's strongest players - international masters and experts.

"I always try my best

to win, sometimes it happens and sometimes it doesn't," Bodhana said.

"I was very proud of myself when I got top girl in the European blitz."

The chess world quickly praised her

performance.

Romanian International Master Irina Bulmaga, one of the players Bodhana finished ahead Tweeted that that it was an "unbelievable result" and added "what a phenomenon she is".

Dominic Lawson, president of the English Chess Federation, described it as an "extraordinary result for an eight-year-old and something we've certainly never seen in this country".

First Scottish space port earmarked for Shetlands

A SITE in the Shetland Islands has become Western Europe's first fully licensed spaceport for vertical rocket launches.

SaxaVord Spaceport on Unst has been given approval from the Civil Aviation Authority to begin launches next year.

Up to 30 a year will launch from the ex-RAF radar station bought 15 years ago by a couple who initially had plans for an eco-tourism attraction.

working, work and not studying," the 17-year-old said, describing a socially isolated adolescence.

A year ago, he raised the idea of returning to England with his grandfather, who he said was alive when he escaped earlier this month despite French police speculation he may have died months ago.

alternative lifestyle

He opted not to consult his mother as he said she was against his plans to go back to England, fearing he would be put in care if he returned.

"She wasn't really open to any other opinions whereas grandad is more of a listener," Alex said. He told the paper he fabricated the story about a four-day journey, hoping it would stop police being able to track his mother and grandfather down, fearing they could be arrested on suspicion of

child abduction.

"I've been lying to try and protect my mum and grandad but I realise that they're probably gonna get caught anyway," he told the Sun.

"I didn't get lost. I knew exactly where I was going," he added, describing his true journey as a two-day hike, first to the town of Quillan to pretend to ask for directions, then on towards Toulouse.

Alex was picked up by a delivery driver who spotted him on a road in the foothills of the French Pyrenees, near Toulouse in the early hours of a rainy morning.

The driver, French pharmaceutical student Fabien Accidini, said Alex told him he had been walking in the Pyrenees for four days and four nights, sleeping by day and walking mainly by night to escape being seen.

All he had was €100 in cash, no mobile phone and he was heading for Toulouse, and he fed on anything he could find

in fields and gardens, Mr Accidini has previously said.

He drove the teenager to Revel, just outside Carcassonne, and left him with local gendarmes who checked his identity and took him to Toulouse before his journey back to the UK was arranged.

Alex's grandmother, Susan Caruana told the BBC in 2018 that she believed Alex's mother Melanie Batty and grandfather David Batty had taken him to live with a spiritual community in Morocco. She said at the time they were seeking an alternative lifestyle and did not want Alex to go to school.

Melanie and David Batty left Greater Manchester with Alex for a pre-agreed week-long holiday to Marbella in Spain on 30 September 2017.

He was last seen at the Port of Malaga on 8 October that year, the day they were expected to return to the UK.

Wrightly to quit MOTD

Former Arsenal striker described the flagship BBC show as 'my Graceland'

FORMER England striker Ian Wright is quitting Match of the Day at the end of the football season.

The pundit revealed his decision to step back had been coming "for a while" and was "fast-tracked" by him turning 60 last month.

He said: "After my debut show whilst still a player in 1997 and many more memorable years, I'll be stepping back from BBC Match of the Day at the end of this season.

"I feel very privileged to have had such an incredible run on the most iconic football show in the world.

"I'm stepping back having made great friends and many great memories. This decision has been coming for a while - maybe my birthday earlier this year fast-tracked it a little - but ultimately it's time to do different things with my Saturdays.

"I'm really looking forward to my last months on the show and covering what will hopefully be an amazing Premier League title race."

Wrightly first appeared on the BBC show in 1997 during his distinguished playing days at Arsenal

and became a regular pundit in 2002, two years after his retirement from the game.

He left in 2008 but returned in 2015. In May, he appeared alongside Shaun Wright-Phillips to become the first father and son punditry team to star on the show.

"Graceland".

Philip Bernie, head of BBC sport content, said: "Ian has been a wonderful star player on MOTD since his first appearance over 20 years ago. His insight, wit and warmth have richly entertained and informed all those watching him.

"We will miss his unique style and presence when he goes at the end of this season."

COMEDIAN Suzy Eddie Izzard has failed in a bid to become a Labour candidate at the next general election.

The stand-up, who identifies as a gender-fluid trans woman, lost to Tom Gray in an attempt to represent Brighton Pavilion.

Mr Gray was a founding member of rock band Gomez, who secured five top-40 UK albums.

The current MP, long-serving Green politician Caroline Lucas, is standing down at the next election. Izzard previously tried to become Labour MP for Sheffield Central.

At a fringe event at the party's conference in September, Labour MP Rosie Duffield threatened to quit if Izzard was allowed on an all-women shortlist.

She also said: "Eddie Izzard is not a woman."





VAN DIJK: harsh words for United at the weekend

Van Dijk doubles down on Keane war of words

Liverpool captain Virgil van Dijk has hit back at Roy Keane as a war of words between the two escalated this week.

Keane had accused Van Dijk of being arrogant after the Holland defender claimed Liverpool were the only side trying to win Sunday's goalless draw with Manchester United.

The United great, who summarized the match for Sky Sports, dubbed Van Dijk's comments disrespectful, considering Liverpool have won just one title since 1990.

Van Dijk is not surprised by Keane's fierce defence of United, but could not resist another dig by claiming everyone watching the game would have agreed with his assessment.

He said: "I like Roy Keane, if he said that then it's fine. He's Man United through and through and I understand he could react like that. But I felt what I said and there is absolutely no arrogance in that. Everyone who watched the game probably felt the same. We move on. We had the opportunity, but we couldn't score and that's the frustrating part."

Undeterred by Keane's

attack, the centre-half repeated his claim United were happy to leave with a point after being hammered 7-0 on their previous visit to Anfield.

Van Dijk said: "Obviously they're not in the best situation and if you come here after you have lost last here with a big number, you're going to be more than happy with a point. "Everyone could see that. You could see what their game plan was and what we tried to do. I felt what I said was right and we move on."

The failure to beat United meant Liverpool lost top spot in the Premier League, with new leaders Arsenal coming to Anfield on Saturday.

But Liverpool had no problem scoring in midweek, putting five past West Ham in the Carabao Cup on Wednesday night.

Liverpool lifted the Cup last year by beating Chelsea on penalties at Wembley, and Van Dijk feels the competition is a great opportunity for Jurgen Klopp's new Liverpool 2.0, as he calls them, to win a trophy.

He said: "We don't look at the table. We're in December and it's the toughest period."

Toon Tripp'ed up again

■ Late defensive gaffe and penalty miss gifts Chelsea semi-final berth

Newcastle United's Kieran Trippier endured a Stamford Bridge nightmare as Chelsea reached the Carabao Cup semi-finals after a penalty shootout Tuesday night.

Callum Wilson's 16th-minute goal looked to be sending Newcastle into the last four until substitute Mykhailo Mudryk pounced on the veteran defender's error deep into stoppage time to send the game to spot-kicks.

The 33-year-old, who has suffered a dip in form recently, then fired Newcastle's second penalty wide and once keeper Djordje Petrovic saved Matt Ritchie's spot-kick Chelsea had gone from the despair of contemplating defeat to the sheer elation of a place in the last four.

It was cruel on Trippier, such an influential figure under manager Eddie Howe, but his fatal indecision on a header gave Chelsea that lifeline which Mudryk gratefully accepted.

Cole Palmer, Conor Gallagher, Christopher Nkunku and Mudryk were all on target for Chelsea but only Callum Wilson and Bruno Guimaraes scored penalties for Newcastle, who suffered fresh disappointment after their Champions League exit.

The draw for the semi-finals takes place after Liverpool v West Ham on Wednesday, with the first leg of those ties being played in the week commencing 8 January.

Following Mudryk's equaliser a male Chelsea fan climbed over the advertising hoardings before celebrating in the face of and bumping into Newcastle goalkeeper Martin Dubravka.

The fan was then led back into the crowd with referee Jarred Gillet speaking to stadium

security before the shootout began.

Chelsea may look back at the late twist in the tale here at Stamford Bridge as the moment they can use to try and finally kick the Mauricio Pochettino era into gear.

Pochettino's side were looking a damaging defeat squarely in the face until Trippier, his mind perhaps scrambled by recent mistakes, touched a tame header into Mudryk's path to set up the drama of penalties.

Chelsea strived to get back on terms after Wilson's early goal, the result of a comedy of defensive errors that ended with Benoit Badiashile stumbling over the ball to let the striker

through.

There were chances that were not taken, such as when Bruno Guimaraes made a miraculous block on the goalline from Raheem Sterling, while Newcastle keeper Dubravka was outstanding when called upon.

Even the introduction of striker Nkunku for his debut after months on the sidelines following his £52m move from RB Leipzig could not force a breakthrough until Mudryk's moment of opportunism.

The scenes of celebration, led by Pochettino, on the Chelsea bench when the equaliser went in and then when Petrovic saved Ritchie's

penalty demonstrated just how important this win is, and might prove to be, as the Argentine manager tries to put down foundations at this most volatile of clubs.

Trippier has arguably been Newcastle's most important figure on an off the pitch during the renaissance under Howe but there is no doubt he is currently suffering a miserable spell of form.

The England full-back was involved in all three goals conceded in the defeat at Everton then had a nightmare in the thrashing at Tottenham. He was culpable again here as Newcastle saw a heroic victory snatched away from them in the closing moments.

Good CL draws for City and Arsenal

Manchester City will play Copenhagen in the last 16 of the Champions League, while Arsenal face Porto.

Danish champions Copenhagen, who finished above Manchester United in their group, reached the knockout stage for the first time since 2011.

Holdings City will play the first leg in Denmark on 13 February, with the return at Etihad Stadium on 6 March.

Arsenal face Porto in Portugal on 21 February,

with the return at Emirates Stadium on 12 March.

Record 14-time winners Real Madrid meet RB Leipzig, while Inter Milan - runners-up last season - take on Atletico Madrid, and Bayern Munich face Lazio.

The final takes place at Wembley on 1 June.

Premier League leaders Arsenal, who topped Group B but have never won the Champion League, beat Porto 5-0 at Emirates Stadium the

last time they met in 2010.

Runners-up in Portugal's Primeira Liga last season, Porto won four of their six Group H games to finish level on points with Group H winners Barcelona.

City won Group G with a 100% record, while Copenhagen, who lost 1-0 at United before beating them 4-3 at home, were runners-up to Bayern in Group A.

City have progressed from the last 16 in the past six seasons.

Five star show from Reds

Liverpool cruised into the Carabao Cup semi-finals with a dominant 5-1 win over West Ham at Anfield on Wednesday night.

Once Dominik Szoboszlai had driven a superb 25-yard effort into the bottom corner after 28 minutes, Liverpool's place in the last four was never in doubt.

Curtis Jones added a second 11 minutes after the restart when he deceived Alphonse Areola into thinking he was going to cut a cross back from the edge of the six-yard box, and instead drove a shot through the Hammers' keeper's legs.

Cody Gakpo was given too much space to fire home his eighth goal of the season 19 minutes from time, then Mohamed Salah made it four when he raced clear of the visitors defence

and finished, before Jones finished off an excellent run by adding his second.

There could have been more as the excellent Harvey Elliott, Gakpo and substitute Trent Alexander-Arnold all went close and Salah put the rebound wide of an empty net after Areola had touched a Darwin Nunez shot on to a post.

disappointing night

It was the first time Liverpool had scored five at home against the Hammers since 1998 and keeps them on course for a record-extending 10th triumph in the competition they last won as recently as 2022.

They will face Fulham in the semi-finals, with the first leg in the week beginning 8 January and the second leg two weeks later.

For Hammers boss David Moyes, it was a disappointing night. The former Everton boss is still waiting for his first victory in this stadium after 21 visits and Jarrod Bowen's 77th-minute goal with West Ham's first shot on target was scant consolation.

The match-winning hero at Crystal Palace on 9 December, Elliott has made all but one of his Premier League appearances this season off the bench.

On a night when Liverpool matched their biggest win of the season, Elliott made a telling contribution without getting his own

name on the scoresheet.

West Ham's sizeable travelling support would have felt better about their trip back to London had they been given any hope to grasp at in terms of a result.

With only one win on this ground in 60 years, the Hammers have a minimal record of success at Anfield - and their overall performance here was poor.

A side showing six changes from the excellent win against

Wolves couldn't string a succession of passes together to generate a meaningful goal threat.

The only time it seemed as though they would shoot in that first half was when Bowen waited for the ball to drop as it deflected into the area. The hesitation was costly as Kostas Tsimikas nipped in to snuff out the threat.

United deal close to being done

Manchester United's drawn-out ownership saga could be resolved before Christmas Day.

Sir Jim Ratcliffe is eager to get a deal signed off before 25 December which would see his Ineos Group pay around £1.25bn to buy 25% of the club.

Reports from the club suggest there has been fresh impetus around negotiations this week.

It is more than a year since the Glazer family announced they were considering selling the club.

However, despite several false dawns, the long-mooted deal for Ratcliffe's Ineos to become minority shareholders has still not been confirmed.

It is expected advisers on all sides will work

late on Friday, or into the weekend, if necessary providing a positive outcome is still possible before the Christmas break.

Once a deal is agreed it will be followed by a six-to-eight week period for the purchase to be signed off by the Premier League.

Many at Old Trafford feel the continuing delay is having a negative effect on the club, with most still unsure of Ratcliffe's plans for the football side, nor who is likely to be working for him at Old Trafford, other than trusted Ineos director of sport Sir Dave Brailsford.


