Two former contestants on All American Girl are suing television executive Nigel Lythgoe over alleged sexual assault.

The lawsuit claims that Lythgoe "openly groped" them during filming of the series in 2003 and made unwanted advances after the show ended.

It comes days after US singer Paula Abdul also sued him, claiming multiple instances of assault.

The BBC has contacted Lythgoe's representatives for a response.

Last week, he denied abusing Abdul, saying he was "shocked" by the allegations.

Lythgoe, 74, was an

executive producer of Pop Idol and American Idol and has also acted as an on-screen judge on several talent programmes himself.

He was also a producer of All American Girl, a talent competition which aired for one series in 2003.

He first came to national attention in 2000 in the UK when he was named a judge on the reality show Popstars. His withering judgements on aspiring singers soon earned him the nickname "Nasty Nigel" from the British tabloids.

Lythgoe has not been named in the court documents, but several US media sources have verified it is him.

According to the documents, the two women claim he would repeatedly turn up in their dressing rooms and "openly swatted and groped" their bottoms while they were wearing dance costumes.

The women also allege that Lythgoe took both of them back to his home

in Los Angeles following a party after the show's finale, where he is said to have made unwanted sexual advances on them.

One woman says he "engulfed her in his sweater" and tried to kiss her, which she rejected.

The other alleges he pinned her against a grand piano and tried to force his tongue into her mouth.

Both women, who have filed the suit anonymously, are suing him for alleged sexual assault and battery, sexual harassment, negligence, and intentional infliction of emotional distress.

The TV mogul is also being sued by Abdul, who

claims the alleged assaults happened while the pair worked together on American Idol and So You Think You Can Dance.

Lythgoe was an executive producer of the singing competition and a co-judge on the dancing programme.

Abdul alleges the first instance of assault occurred during one of the "initial seasons" of American Idol in the early 2000s, according to court documents seen by the BBC.

The lawsuit claims Lythgoe assaulted her in an elevator while on the road during regional auditions for the popular talent programme.

She was able to escape from her boss when the

doors opened, and she immediately informed her representatives from her hotel room, the lawsuit says.

"For years, Abdul has remained silent about the sexual assaults and harassment she experienced on account of Lythgoe due to fear of speaking out against one of the most wellknown producers of television competition shows who could easily break her career as a television personality and of being ostracized and blackballed by an industry that had a pattern of protecting powerful men and silencing surivors of sexual assault and harassment," the lawsuit alleges.

From

AWARD-winning documentary maker and campaigner John Pilger has died aged 84, after a long battle with pulmonary fibrosis.

His family said he passed away in London on Saturday, adding: "His journalism and documentaries were celebrated around the world. But to his family he was simply the most amazing and loved dad, grandad and partner. Rest in peace."

As a journalist, Pilger never shirked from saying the unsayable. Across half a century, in newspapers and in his documentary films - many for ITV, but later also in the cinema – he became an ever-stronger voice for those without a voice, and a thorn in the side of those in authority.

Fellow journalist and TV host Piers Morgan wrote in tribute: "RIP John Pilger, a brilliant firebrand journalist and ferocious holder of the powerful to proper account."

Sydney-born Pilger was a reporter in Australia in the 1950s and moved to Fleet Street, via Italy, in the early 60s.

He made his name exposing injustices and abuses of power, particularly in politics and international affairs, and was seen as a thorn in the



Home Secretary 'sorry for awful date rape drug joke'

The Home Secretary has apologised for making a joke about spiking his wife's drink with a date rape drug.

James Cleverly said the remark – made at a Downing Street reception – may have "distracted" from efforts to protect women and girls from predators.

He said he hopes to be judged on his actions, not words.

Mr Cleverly joked about putting "a little

bit of Rohypnol" in his wife's drink nightly, adding it was "not really illegal if it's only a little bit".

But this week he admitted: "It was an awful joke and I apologised immediately, but ľm absolutely committed, and have been throughout my political career, to the protection of women and girls."

He said he was the first Home Secretary to bring forward legislation to crack down on spikings.

His "joke" sparked backlash from а campaigners, with some demanding his dismissal. Police receive 560 reports of spiking each month.

Office The Home has announced that hundreds of staff will be trained to spot signs someone may have been spiked and look out for predators targeting vulnerable women.

Tributes flow for The Full Monty star Tom Wilkinson, dead at 75

British actor Tom Wilkinson, known for films like The Full Monty, Shakespeare In Love and The Best Exotic Marigold Hotel, has died aged 75.

Wilkinson won a Bafta for 1997's The Full Monty, and reprised the role of Gerald when a Disney+ streaming series revisited the characters 26 years on.

He received six Bafta nominations in total as well as two Oscar nominations, for Michael Clayton and In The Bedroom.

He died suddenly at home with his wife and family, they said in a statement.

George Clooney, who starred with Wilkinson in the 2007 legal thriller Michael Clayton, praised the actor as "the epitome of elegance".

Paying tribute, he told Variety magazine: "Tom made every project better. Made every actor better.

"He was the epitome of elegance and he will be dearly missed by all of us."

With more than 130 film and TV credits in total, Wilkinson was as comfortable in period dramas like 1995's Sense and Sensibility and 2013's Belle, as he was playing criminal masterminds in movies like Rush Hour opposite Jackie Chan in 1998, or Guy Ritchie's RocknRolla in 2008.

He also earned an Emmy for playing US political figure Benjamin Franklin in 2008 miniseries John Adams and an Emmy nomination as John F Kennedy's father Joe in The Kennedys. He played President Lyndon B Johnson in 2014's Selma, and appeared in The Grand Budapest Hotel and Girl with a Pearl Earring.

His death on Saturday was confirmed in a statement shared by his agent on behalf of his family.

W i l k i n s o n was, according to the Encyclopaedia of British Film, "a major character star, with a remarkable gift - one among several - for conveying inner pain".

Robert Carlyle, who starred alongside Wilkinson in The Full Monty, described him, as "a huge performer, a real titan of an actor, one of the greats of not only his, but of any generation."

In a tribute on X, formerly Twitter, British actor Phil Davis called him "powerful and delicate and hugely intelligent - one of the very best", while singer and actor Will Young described him as "British acting royalty".

US film maker Scott Derrickson said Wilkinson was "an amazing talent" and recalled a time when the actor gave him a surprise kiss on the lips on the set of The Exorcism of Emily Rose.

Born in Leeds before moving to Canada and then Cornwall in childhood, he found his calling at the age of 18 when he was asked to direct a play.

"For the first time in my life, I started doing something I knew how to do," he said.

"I realised it wasn't necessarily just these southern middle-class types that got to be actors; it could possibly be people like me. And once I knew, I never changed my mind."

He trained at the Royal Academy of Dramatic Art (Rada) before following the well-worn path to theatre and television work. In 1986, he got his first major screen role in mini-series First Among Equals, based on Jeffrey Archer's best-selling novel.

Playing alongside him was Diana Hardcastle. The couple married in 1988, and also went on to play husband and wife in The Kennedys in 2011,


When he portrayed Pecksniff in Martin Chuzzlewit for the BBC in 1994, Wilkinson said: "I looked at it and I thought, I can't get it any better than that. It came out exactly as I meant it to come out. It won a couple of prizes and I thought, I can act, there's no question."

Three years later, he

turned out to be crap."

The low-budget movie, meanwhile, turned out to be the highest-grossing British film up to that point, and took his career to a new level on both sides of the Atlantic.

Wilkinson received high critical acclaim for Todd Field's 2001 US domestic drama In the Bedroom, in which he played a bereaved father. He was nominated for **cont. on page 4, col. 1**

CCTV shows callous killer mowing down boyfriend with car after row

A PHILOSOPHY student faces life behind bars after using her car as a weapon to murder her fiance after a row at a party.

CCTV showed Alice Wood, 23, drove at charity worker Ryan Watson, 24, three times before he was dragged for 518ft, after he had "clicked" with a woman at the party.

Manchester University graduate Wood, who had won a postgraduate place at Cambridge, denied murder, claiming her boyfriend's death at around 11.30pm on May 6, 2022, near their Cheshire home was a "tragic accident".

She told Chester Crown Court she did not realise he was trapped under her car.

But she showed no emotion on Monday as the jury convicted her of murder.

Judge Michael Leeming remanded her in custody, and told her: "There is only one sentence the law allows – life imprisonment. You may never be released."

Mr Watson's family said they had "finally got justice" for their son. They added: "Ryan's death has left our family heartbroken. He was taken from us far too soon. He had just started his career working for the charity Headway and helping other people, which is what he loved to do.

"Ryan had such a big personality. He was a bubbly, fun-loving, caring

person with a heart of gold who would do anything for anyone."

The three-week trial heard the couple rowed after returning home from a birthday party in Hanley, Stoke, for a user of the Headway brain injury charity where Mr Watson was a support worker. He had formed a rapport with a female guest, it was said. The couple returned home where, although over the drink-drive limit, Wood got in her car. She then played what witnesses described as a "game of chicken" with Mr Watsonby driving the car at him.

CCTV footage showed Wood's Fiesta hitting Mr Watson, sending him flying on to the bonnet before he got up. Seconds later, he was struck a second time, causing him to fall under. Mr Watson was heard screaming when trapped as Wood drove 518ft before stopping.

On her arrest a sobbing Wood, from Rode Heath, Cheshire, told officers: "It's fine, I deserve it." She will be sentenced on January 29. Det Insp Nigel Parr said: "She knew what she had done but since then has refused to take accountability for her actions."

Mr Watson's family said: "Alice is in prison where she belongs."

country after he left his native Australia in 1962. He reported on 98 uncompensated thalidomide victims, NHS cuts, racism, poverty and the treatment of children with learning disabilities. Abroad, he went undercover to interview Czech dissidents.

In 1991 he was honoured with Bafta's Richard Dimbleby Award.

an Oscar for best actor.

He hoped the film would do two things for him, he later said. "One, [prove] I could play the lead role in a movie. Two, I could play an American lead role. And it did both of those things."

The actor earned his second Academy Award nomination for his supporting role in Tony Gilroy's 2007 legal thriller Michael Clayton, starring George Clooney. Wilkinson's other credits included Batman Begins, The Patriot, Eternal Sunshine of the Spotless Mind, The Gathering Storm, Black Knight, Valkyrie, The Lone Ranger and Denial.

His long term agent Lou Coulson has described him in interviews as "one of the best".

Off screen, Wilkinson was known for being down-to-earth and keeping a relatively low profile. He said in an interview: "I like to go to Waitrose and not be recognised." Pilger:

bombed Cambodia, creating the turmoil that allowed Pol Pot to seize power. Also, said Pilger, western governments were unwilling to give substantial aid to those now running Cambodia for fear of displeasing the US, which had been defeated in the Vietnam war only four years earlier.

Pilger's reporting helped to raise \$45m in relief and earned him a

second journalist of the year title in the British Press Awards (the previous one was for his dispatches from Vietnam) and the United Nations media peace prize. Over the next decade, he continued to return to Cambodia and report on the power politics. He himself survived an ambush after being put on a Khmer Rouge death list. From his first ITV documentary, in 1970, Pilger made waves. In The Quiet Mutiny, for Granada Television's World in Action current affairs series, he broke the

when they allegedly tried to grab a £10 note that he had offered to Gascoigne towards a taxi home.

Mr Swinton, 54, believes that the couple had previously been trying to obtain cash from the star. He whisked the former Newcastle United, Tottenham, Lazio and Rangers hero inside the hotel to "sober up" then sat with him for 10 minutes before leaving him with staff.

Mr Swinton, from Clerkenwell, central London, said: "He is a hero of mine. When I saw him I was heartbroken to be honest.

"Men of a certain age - we all know who he is, we have grown up with him. He couldn't string a sentence together, he was physically and mentally battered."

Gascoigne, who lives in Poole, Dorset, later spent the night in the hotel and was in the reception area the following morning.

Mr Swinton added: "I said 'Good morning'

to him and asked him how he was feeling.

"He could still barely string a sentence together. As someone who has grown up with him, I was heartbroken to see him this way."

Gascoigne publicly battled mental health problems and alcohol addiction after his playing career ended.

In 2020 the star of World Cup Italia 90 said he had even paid £20,000 to have antiboozing pellets placed in his stomach in a desperate bid to stop drinking.

Gascoigne scored 10 goals in his 57 appearances for England.





Dyche: VAR palaver 'testing my patience'

Everton boss Sean Dyche says the use of the video assistant referee pitchside monitor is "testing my patience" after striker Dominic Calvert-Lewin was sent off at Crystal Palace on Thursday night.

The 26-year-old was dismissed for the first time in his career in the 0-0 FA Cup third-round draw at Selhurst Park.

He had his studs up in a challenge with Nathaniel Clyne and clipped the Palace defender's shin with minimal contact. "The slow motion shows a different picture," said Dyche.

"If you want to slow-mo everything, you have to slow-mo everything. There's minor contact and in live time he [referee Chris Kavanagh] doesn't give anything, then they slow it down and everything looks worse."

Kavanagh originally took no action but reviewed the incident on the monitor following an intervention from VAR Michael Salisbury before showing Calvert-Lewin the red card in the 79th minute.

Littler Love: nation is captivated by 16-year-old darts sensation Luke

Britain discovered an unlikely new sporting hero this week - in the shape of 16-year-old darts ace Luke Littler.

The teenager came from nowhere to storm into the PDC World Championships final, thrilling fans up and down the country during the past two weeks in a scintillating bid to become the youngest darts world champ.

But his fairytale journey did not quite end in triumph - he succumbed 7-4 in final a memorable Thursday night to another Luke, world No.1 Luke Humphries, who kept his cool in front of a sell-out crowd

at the Alexandra Palace in London.

Elsewhere, millions were glued to their televisions at home and in pubs and sports bars across the nation.

On his way to the stage, Littler hugged girlfriend Eloise 21, Milburn, before sharing a fist-bump with Humphries. Famous faces who bagged one of the hottest tickets in town were Tottenham star James Maddison, Brentford prospect Romeo Beckham with girlfriend Mia Regan and former boxing champ Derek Chisora.

Littler went toeto-toe with his more experienced opponent,

but it was the 28-yearold Humphries who showed why he was on a 19-game winning streak and looking to add to his World Grand Prix and Grand Slam titles from 2023

He clawed his way back to victory - after Littler led 4-2 in the middle of the match – by taking the last five sets.

Littler, from Warrington, had already secured a £200,000 prize in becoming the youngest player to make the final. Earlier he said he would prepare for the match with his traditional routine.

The teen explained: "I will go for my ham and cheese omelette. Then for lunch I will have my pizza. I will practise on the board. That's what I've done every day."

He began playing darts on a magnetic board when he was just 18 months old and entered this tournament ranked 164th in the world. His meteoric rise has transcended the sport and seen record audiences for a darts tournament. His semifinal match set a Sky tournament viewing record with 2.32 а million peak.

The record for a darts final is 8.3 million when qualifier Keith Deller won the 1983 title by upsetting favourite Eric Bristow on the BBC.

Rooney out at Birmingham

■ City's American owners pull the plug after dismal run of results sees the Blues plummet down the table

WAYNE ROONEY was shown the door at Birmingham City this week after a dismal run which saw the Midlands club take just 10 points from 15 games.

Despite the huge hullaballoo which greeted the former England star taking the managerial hot seat just three short months ago, the club's ambitious American owners soon tired of worsening results on the field and rumored unrest in the dressing room.

The bookies' favorite to replace Rooney is Tony Mowbray, the veteran manager who held talks with the club on Thursday. He has been out of work since being sacked by Sunderland in December, but is still seen as a canny operator with bags of experience at Championship level.

Mowbray led West Bromwich Albion to promotion in 2008 and has also had spells with Middlesbrough, Blackburn and Sunderland.

The 60-year-old took Sunderland to the play-offs last season in their first campaign in the second tier since promotion from League One but was ditched in favour of former Queens Park Rangers and Rangers boss Michael Beale at the end of 2023 – a move that was unpopular with many supporters.

Several senior players at Birmingham are said to be keen on a return for John Eustace, who was shown the door in October to make way for Rooney.

While Eustace would be open to returning, that would take huge climbdown from US owners Knighthead, who dismissed him even though the club were sixth in the Championship.

Among the other candidates for the job is Rooney's former England team-mate Frank Lampard. The Chelsea legend has the profile to appeal to the owners, who include NFL icon Tom Brady. But

source close to Lamps have indicated the man himself is not eager to resume his management career in the bottom five of the Championship. Gary Rowett – who managed Blues from 2014-16 – is another of interest along with Nathan Jones, who did an outstanding job during two spells at Luton but struggled in his last post at Southampton.
