JUSTICE DELIVERED FOR POST OFFICE VICTIMS?

■ Sunak orders hundreds of convictions overturned

Justice has finally been delivered for the hundreds of victims of the Post Office scandal as Rishi Sunak ordered their convictions should be overturned.

In a dramatic intervention on Monday, the Prime Minister vowed to "right the wrongs of the past" so victims get the justice they deserve.

After two decades of fighting, they could have their names cleared this year and handed compensation totalling £1billion. Payments of £600,000 will be handed to all those who are exonerated under unprecedented new laws that will be introduced in weeks.

Mr Sunak told MPs: "This is one of the greatest miscarriages of justice in our nation's history.

"People who worked hard to serve their communities had their lives and their reputations destroyed through absolutely no fault of their own.

"The victims must get justice and compensation. We will make sure the truth comes to light, that we right the wrongs of the

past and the victims get the justice they deserve."

Hundreds of sub-postmasters were convicted of stealing money on the basis of evidence from the flawed Horizon accounting system.

Ministers said the Post Office showed "not only incompetence but malevolence" in the way it acted against them.

Public fury following the airing of ITV drama Mr Bates vs the Post Office thrust the issue to the top of the political agenda after victims struggled for years to clear their names and secure proper payouts.

Ministers have now drawn up plans for new laws that will allow convictions to be overturned instead of victims having to make individual court appeals.

The plans are expected to be in place by the end of the year.

Mr Sunak also

announced a £75,000 payment each for the 555 ex-postmasters involved in a group legal action led by campaigner Alan Bates against the Post Office.

Ministers have set aside up to £1billion for compensation.

'momentous day'

The Government will also review whether people whose convictions were upheld after appeal can be exonerated by the new laws.

Only 93 out of 700 convictions have been overturned, with more victims coming forward since the drama aired last week.

Overtuning a conviction would usually be via the Criminal Cases Review Commission sending it to the Court of Appeal for a hearing.

Justice Secretary Alex Chalk held talks with senior judges to calm fears that Parliament was interfering with the

independent legal system.

Faulty Fujitsu software called Horizon began to be rolled out in Post Office branches in 1999.

Twenty years later the High Court ruled it contained "bugs, errors and defects" and there was a "material risk" that shortfalls in branch accounts were caused by the system.

By then hundreds of innocent men and women had been jailed or lost their homes and livelihoods as they were pursued relentlessly for supposed shortfalls.

Mr Bates welcomed this week's "good news" but

said the fight is not over for many of those still awaiting compensation.

Played by Toby Jones in the ITV drama, he said: "It is a leap forward, but it ain't over yet.

"The devil is in the detail and we're yet to see that.

"We're still going to have to keep pushing the whole issue forward until everyone is sorted."

Professor Christopher Hodges, chairman of the independent Horizon compensation advisory board, said it was a "momentous day for Britain". He added: "What strikes me is not just that it

is important in relation to finally getting justice and fairness and steps towards closure for all the victims.

"The British public have responded to this.

"And it says something deeply fundamental about British values that everyone knows this is not right."

Conservative MP Duncan Baker, who used to work as a postmaster, said the Post Office should be forced to reveal how much money it "stole" from "innocent men and women".

He said it will run into hundreds of millions

Britain and US join forces to strike at Houthi militia

■ Action taken after Iran-backed group target Royal Navy warship

WASHINGTON: - The United States and Britain have started carrying out strikes against targets linked to Houthis in Yemen, four U.S. officials confirmed on Thursday, the first time strikes have been launched against the Iran-backed group since it started targeting international shipping in the Red Sea late last year.

The Houthis, who control most of Yemen, have been targeting Red Sea shipping routes to show their support for Hamas, the Palestinian Islamist group. The attacks have disrupted international commerce on the key route between Europe and Asia that accounts for about 15% of the world's shipping traffic.

These are believed to be the first strikes the United States has carried out against the Houthis in Yemen since 2016.

The officials, speaking on the condition of anonymity, said a formal statement was soon expected to detail the strikes.

Earlier on Thursday, the Houthi's leader said any U.S. attack on the group would not go without a response.

The Houthis, who seized much of Yemen in a civil war, have vowed to attack ships linked to Israel or bound for Israeli ports. However, many of the targeted ships have had no links to Israel.

Britain made the decision to join their allies after the Iran-backed rebels aimed their biggest missile and drone strike at a Royal Navy warship in the Red Sea earlier this week.

Defence Secretary Grant Shapps warned the military might was in place "to do what needs to be done".

Asked if Britain would launch strikes on Yemen, he responded: "Watch this space."

HMS Diamond unleashed a barrage of Sea Viper missiles and anti-aircraft cannon to defend itself and other ships on Tuesday.

Mr Shapps said the Type 45 destroyer, with 260 crew, appeared to have been targeted, but the drones and missiles were downed with "no injuries or damage sustained".

British and American naval forces worked together to repel the attack. Warships and carrier-based jets shot down 18

kamikaze drones, two anti-ship cruise missiles and an anti-ship ballistic missile.

Mr Shapps tweeted it was "the largest attack on a Royal Navy warship in decades". He thanked the crew of HMS Diamond "for their heroic service in the Red Sea, as they continue to defend innocent lives and global trade from these intolerable Houthi attacks".

And he said their success on Tuesday was "a powerful demonstration of the expertise, bravery and leadership of all sailors aboard and an undeniable display of the importance of the entire Royal Navy in keeping Britain safe from growing threats".

The Houthis claimed they had targeted a US ship in retaliation for the killing of rebels who last month tried to attack a container vessel by using speed boats.

But Mr Shapps vowed there will be "consequences" and said: "We must be clear with the Houthis that this has to stop. That is my simple message to them today: Watch this space."

He added Iran was

"guiding" the Shiite group, which has held Yemen's capital since 2014 – and has vowed to continue attacking ships in the Red Sea until Israel ends its war with Hamas in Gaza.

The UK, US and allies last week issued a "final warning" over the attacks.

The Prime Minister's spokesman said: "We do reserve the right to take further steps to protect commercial shipping and

avoid the risk of further destabilising the region."

Some shipping lines and oil giant BP have already diverted vessels around southern Africa to avoid the Red Sea, which gives access to the Suez Canal.

of pounds and the organisation should be forced to publish "the grand scale of how much money they stole".

The furore has put the spotlight on ministers responsible for the Post Office since warnings about software flaws emerged in around 2010.

Tory deputy chairman Lee Anderson took aim at Liberal Democrat leader Sir Ed Davey who was Postal Affairs Minister between 2010 and early

2012.

There have been 19 ministers from all the three main parties in the post since 1999. Mr Anderson told the Commons Sir Ed has called for the resignation of more than 30 prominent people in the UK who have made mistakes in their job so he "should take his own advice and start by clearing his desk, clearing his diary and clear off".

Serving Post Office Minister Kevin Hollinrake admitted the Government's approach is not "foolproof".

He said: "The risk is

that instead of unjust convictions, we shall end up with unjust acquittals and we just do not know how many.

"As far as possible, we want to avoid guilty people walking away with hundreds of thousands of pounds of public money. But we cannot make the provision of compensation subject to a detailed examination of guilt."

As a safeguard, those involved will be required to sign a statement saying they did not commit the crime of which they were accused.

'Interest rates must be cut' - Hunt

JEREMY Hunt has warned interest rates must be cut because of the financial "pain" families are enduring.

The Chancellor said rates should be slashed from their 5.25% level because inflation has started to plunge.

Mr Hunt's remarks came during a TV interview. He was asked about NatWest chairman Sir Howard Davies' comments that it is not that difficult to buy a home.

The Chancellor said: "I just don't really understand how he could have said that.

"When I'm looking at the

pain that families are going through because they're seeing interest rates go up to 5.25%, mortgage rates go up by considerably more than that if they have to change it.

"People are finding it very difficult. I think we're seeing that in the volume of house transactions happening.

"And as a Conservative, I believe getting your foot on the housing ladder is a very important stage in your life and we want to do everything to help that."

Inflation has tumbled from more than 10% to 3.9% in the past year.

Economists expect it to

fall further in the spring, heaping more pressure on the Bank of England to cut interest rates sooner than planned.

Mr Hunt added: "The biggest thing I can do is to support the Bank of England as they bring down inflation because that means interest rates will come down.

"And that means in the end, mortgages will get cheaper. That's the thing I'm most focused on at the moment."

Mr Hunt hinted more tax cuts could come in the spring, saying low-tax economies were more "dynamic".

A VICTIM of Jeffrey Epstein claimed sex tapes were taken of the Duke of York, former US president Bill Clinton and billionaire businessman Sir Richard Branson, court documents have disclosed.

Sarah Ransome, who gave a victim impact

statement ahead of the sentencing of British socialite Ghislaine Maxwell for sex-trafficking, appeared to write communications claiming that the three were filmed by the paedophile financier.

The extracts were flagged by a firm

representing Epstein's lawyer Alan Dershowitz to demonstrate that Ms Ransome "manifestly lacks credibility".

Andrew stepped down from public life after the furore over his friendship with Epstein and paid millions, on no admission **cont. on page 4, col. 1**

'£75k is not enough to make up for 20 years of suffering'

■ Not every pardoned former postmaster is happy with government compensation pledge

A former sub-postmaster wrongly convicted of stealing more than £50,000 says new laws to compensate and exonerate the victims of the Post Office

scandal are "better late than never".

Sami Sabet, 68, owned three Post Offices in East and West Sussex and was among more than 700 postmasters convicted

due to the faulty Horizon system.

He has suffered severe PTSD and heart problems since his 2009 conviction, says the ordeal has taken years off his life.

The retired father of one admitted stealing after being told he faced jail if he denied the theft and was handed a suspended 12-month sentence.

'a little too late'

In 2021 he was among 93 postmasters whose convictions were thrown out by the Court of Appeal. Ex-engineer Sami, from Shoreham, West Sussex, cleaned toilets in petrol stations after his conviction. This week he welcomed Rishi Sunak's announcement.

He said: "They should have thought about doing this years ago, instead of doing what everyone seemed to be doing – the bare minimum.

"People were very frightened to clear their names because they didn't trust the Post Office."

Due to health complications Sami did not join the original 555 sub-postmasters and sub-postmistresses led by Alan Bates who brought initial litigation against the Post Office. Mr Sunak announced this group will each be offered an upfront £75,000 but Sami worries it has not been thought through.

He said: "Is it going to affect everybody else and not just the 555 people who first brought legal action? Will it be used as an excuse not to pay the others? I don't know.

"With inflation, the money is not worth what it was two years ago. So the longer it takes to pay the money, the more they

of liability, to settle a civil sexual assault case with Virginia Giuffre, a woman he claimed never to have met.

He was cast out of the working monarchy after Ms Giuffre, who was trafficked by Epstein, accused him of sexually assaulting her when she was 17. The Duke strenuously denies any wrongdoing.

A Virgin Group spokeswoman on behalf of Mr Branson said: "In a New Yorker report published in 2019, Ransome admitted that she had 'invented' the tapes. We can confirm that Sarah Ransome's claims are baseless and unfounded."

A US judge ordered hundreds of documents to be unsealed as part of Ms Giuffre's previously settled civil claim against Maxwell, filed in 2015. Also accused in the email extracts from Ms Ransome was former US president Donald Trump.

Addressing the claims about Andrew and Mr Branson in the document released as part of another tranche published on Monday, Ms Ransome wrote: "When my friend had sexual intercourse with Clinton, Prince Andrew and Richard Branson, sex tapes were, in fact, filmed on each separate occasion by Jeffrey.

"Thank God she managed to get a hold of some footage of the filmed sex tapes, which clearly identify the faces of Clinton, Prince Andrew and Branson having

sexual intercourse with her. Frustratingly enough, Epstein was not seen in any of the footage but he was clever like that.

"When my friend eventually had the courage to speak out and went to the police in 2008 to report what had happened, nothing was done and she was utterly humiliated by the police department where she went to report what had happened with Epstein, Clinton, Branson and Prince Andrew."

No video has ever been made public while Mr Clinton and Mr Trump also have denied any involvement.

In the letter from Emery Celli Brinckerhoff & Abady LLP to the court, the firm said allegations against Mr Dershowitz were false. The firm said Ms Ransome's "testimony was fabricated". It added: "The emails are a necessary antidote to Ms Ransome's deposition mis-statements because they demonstrate she manifestly lacks credibility."

The email extracts also saw Ms Ransome take aim at 2016 US presidential candidate Hillary Clinton, with one saying: "I will make sure that neither that evil bitch Hillary or that paedophile Trump gets elected."

Epstein was found dead in his jail cell in Manhattan, New York, in 2019 while awaiting trial on sex-trafficking charges. The death was ruled a suicide.

Maxwell was sentenced in June 2022 to 20 years in prison for sex trafficking – with an appeal scheduled to be heard in November.

will have to pay."

Sami would be satisfied for his fellow victims but far from pleased with £75,000. He said: "I am happy for everyone who is going to get their convictions quashed – most if not all of them deserve it. It has come a little too late

for some of them... But better late than never.

"When talking about compensation, we are talking about almost 20 years of suffering, loss of income, property, business costs, reputation, inability to get good jobs, health issues..."

"If it's an interim payment, and they start looking at how people can be properly compensated, that would be fair. But not £75,000."

Sami's lawyers are now calculating the compensation he should be paid.

London drivers stuck in the slow lane

WIDESPREAD speed limits of 20mph have made London the world's slowest city centre for drivers.

Journeys of 6.2 miles in the capital took an average of 37 minutes and 20 seconds last year, said location technology company TomTom.

This was one minute more than in 2022 and the

longest among 387 cities in 55 countries.

It means London is the slowest city for the second year in a row.

Next was Dublin, with 6.2-mile trips taking 29 minutes and 30 seconds.

It was followed by Toronto, (29m); Milan, (28m, 50s); and Lima, Peru (28m, 30s).

In the UK, Manchester

was ranked second (23m, 30s), followed by Liverpool (22m, 50s), Bristol (22m, 40s) and Edinburgh (21m, 30s).

Stephanie Leonard, of TomTom, said London had the world's third highest petrol prices.

She added: "Avoiding peak hours could save Londoners up to £187 per year on fuel costs."

Masks are back as Covid spreads across Europe

SPAIN'S Government wants to make masks compulsory in hospitals and health clinics as flu and Covid spreads across Europe.

The move came as Italy said respiratory illness infection rates had hit a record there.

In the UK, the Department of Health has so far not announced any similar proposals.

But Covid infections have also risen sharply there since November, with an average of 3,631

patients in hospital with the virus during the Christmas week – a jump of 57% in a month.

Norovirus was up 61% from the same period last year and serious flu cases were spiralling upwards.

There were an average of 942 patients with flu in hospital each day in the week to December 24, including 48 in critical care.

The record level for Covid cases in the UK was set in April 2022, when 7.6% of the population was infected with the virus,

said the Office for National Statistics.

While the latest rate remains around 5% – around one in 20 – the UK Health Security Agency called on all those eligible to get a Covid jab to do so, with infections set to reach their peak in the remaining winter months. A spokesman said: "Cases are expected to rise over the next few weeks following increased travel and socialising that occurred over the festive period."

The Princess wears her deep blue Royal Victorian Order mantle edged in scarlet and silver bullion, with a crystal and silver threadwork leaf embroidery headpiece.

The Duke and

Duchess of Edinburgh stand to the left as the family gather in Buckingham Palace with Charles after the ceremony last May. The Royal Family wished the Princess a happy birthday as they shared the picture.

Just over a year into her role as Princess of Wales, Kate has channelled her energy into her Shaping Us campaign, which aims to highlight and promote the significance of the formative years of a child's life.

The Prince and Princess of Wales – parents to Prince George, 10, Princess

Charlotte, eight, and five-year-old Prince Louis – had no major joint official overseas tour last year, with William and Kate taking a back seat to allow the King and Queen to embark on their inaugural travels.

But the couple are reported to be planning to travel to Italy this spring.

Kate did not join William on a trip to Singapore last autumn, as she stayed with son George ahead of his entrance exams to decide where he will study – with Eton and Marlborough College among the likely contenders.

'A true giant of the game...' icon of Wales rugby JRP dead at 74

FORMER Wales and British and Irish Lions rugby star JRP Williams has died aged 74.

The full-back, who was regarded as among the greatest of all time, won 55 caps for his country during the 1970s glory era for Welsh rugby.

Renowned as a fearless player with his aggressive and attacking style, the Bridgend-born ace played eight Tests for the Lions, including triumphant tours of New Zealand in 1971 and South Africa in 1974.

He was memorably involved in one of the greatest tries ever seen, representing Barbarians against the All Blacks in 1973, a fine flowing move that ended in Sir Gareth Edwards scoring.

Williams also won three Grand Slam titles with Wales in 1971, 1976 and

1978.

He qualified as a physician in 1973 while playing rugby and retired in 1981 to be an orthopaedic surgeon. Former Wales star Jonathan Davies said: "RIP JRP another legend goes too early. Thank you for the memories."

JRP's former club Bridgend Ravens said:

"Bridgend Ravens are devastated to announce the passing of JRP Williams.

"One of Bridgend's most decorated players and an icon of world rugby, JRP served the club most recently as club president.

"Our thoughts are with JRP's family and friends at this sad time."





The British actress, 28, (right) wore a pale pink sequinned gown from designer Rodarte at the 14th Annual Governors Awards on Tuesday night in a prelude to the big night.

Her *Oppenheimer* co-stars Cillian Murphy, 47, and Robert Downey Jr, 58, were also on the guest list for the starry do in Los Angeles this week.

IT was not a vintage year for British talent, with just six wins in 27 categories at the Oscar season curtain-raiser, held Sunday night at the Beverly Hilton in Beverly Hills.

Brits took home three gongs for individual performers and three for co-productions with other countries.

Matthew Macfadyen won best male supporting actor in a TV series for *Succession*; Ricky Gervais collected best performance in TV stand-up comedy for one-off *Armageddon*, plus Nolan's director gong.

Nolan's *Oppenheimer* was also one of Britain's three joint wins.

The US-UK co-production was named best motion picture drama; *Poor Things*, a dark comic fantasy produced by Ireland, the UK and the US, was best motion picture musical or comedy while *Barbie* was also a US-UK co-production.

The UK's tally of six wins this year is the highest since 10 in 2020 and 2021 and is an improvement on last year – when the total was just two.

Werner back to earn his Spurs in England

TIMO WERNER will be out to prove he is no Premier League flop after sealing his switch to Tottenham.

The former Chelsea forward, 27, completed his six-month loan move from RB Leipzig with the option of a permanent £14.5million deal in the summer.

Werner failed to hit the heights at Chelsea after a £47.5m move from Leipzig in 2020, returning to his old club in Germany two years ago.

He said: "When I left the Premier League straight away I missed it, as it's the best league in the world. "I missed London as well. I love England."

Spurs' forward resources have been depleted by injuries to James Maddison

and Ivan Perisic, while skipper Heung-Min Son is likely to be away for a month with South Korea at the Asian Cup.

Werner has played just once since early November due to an adductor injury and has scored only twice this season.

Spurs have also agreed a £21m-plus deal for Genoa defender **Radu Dragusin** after beating off late competition from Bayern Munich, despite the Germans offering a bigger fee and contract.

Dragusin is versatile and was clearly catching eyes as Tottenham faced competition from Bayern, Napoli and AC Milan.

The Romania defender has often played left-sided centre back but is good enough on the ball to play anywhere across

the back. Dragusin's agent revealed Bayern offered a bigger contract.

They were up all night weighing up whether to go to Germany but eventually decided Tottenham was the better move for his career. Agent Florin Manea told Romania's GSP: "There was more money from Bayern, but he decided that this is the right step for his career. I did not sleep at all as we weighed up the pros and cons.

"Both Napoli and AC Milan wanted him, but he has dreamed of playing in the Premier League from a young age.

The club's FA Cup-winning captain Gary Mabbutt earlier in the week handed his former club the biggest tie of the fourth round in this

Liverpool face the winners of Norwich and Bristol Rovers at Anfield, and Hollywood meets the History channel as Ryan Reynolds' Wrexham travel to Blackburn, three-time winners of the FA Cup in the 1880s.

He becomes Birmingham's third manager of the season, after John Eustace was axed for Rooney three months ago. Mowbray said: "I can't wait to be back out on the training pitch."

Sancho returning to United

JADON SANCHO will return to Manchester United at the end of his loan spell - because Borussia Dortmund cannot afford to make the deal permanent.

Sancho is set to go to former club Dortmund for the rest of the season, ending his United exile following his fall-out with manager Erik ten Hag.

Winger Sancho, who has not played for United since August and has been forced to train alone, joined the Dortmund squad at their winter training camp in Marbella this week.

Dortmund will pay United a loan fee of around £3million, but there is no agreement in place for the German side

to keep Sancho on a full-time basis once that short-term deal expires.

The Bundesliga club cannot afford Sancho's £250,000-a-week wages, which means he will return to United in the summer, where he has been frozen out by Dutchman Ten Hag.

Despite Sancho's refusal to apologise for publicly undermining Ten Hag on social media, United are hoping the 23-year-old can rediscover his best form at Dortmund. That will improve United's chances of selling him for a decent fee in the summer, although there is an acceptance they will get nowhere near the £73million they paid Dortmund in 2021.

Partey's primed for Gunners return

THOMAS PARTEY could give Arsenal a major boost by returning before the end of the month.

Partey has stepped up his rehabilitation work and could return for Arsenal's trip to Nottingham Forest on January 30. The Gunners midfielder has missed the Africa Cup of Nations because of his ongoing thigh injury.

Ghana head coach Chris Hughton made it clear they had good dialogue with Arsenal and realised

if they did pick Partey then he might not be available until after the group stages. But Ghana would not attempt to block Partey playing for Arsenal.

Gunners striker Gabriel Jesus could also be back after the sunshine trip to Dubai, as the knee issue which forced him to miss Sunday's 2-0 FA Cup defeat by Liverpool is believed to be minor.

Arsenal do not have scope for big deals in January, with the only realistic signing a loan deal for a defender.

Reds fight back to take cup edge

CARABAO CUP: Gakpo winner gives Liverpool slender advantage in semi-final

Liverpool staged a second-half turnaround to beat Fulham at Anfield in the first leg of their Carabao Cup semi-final tie on Wednesday.

The visitors had taken the lead in the first half when Willian showed great control inside the area to slot in.

It was no less than Fulham deserved after an impressive first half, but Liverpool stepped it up after the break and fought back with two goals in three minutes.

First, Curtis Jones equalised when his 68th-minute strike from distance took a big deflection off Tosin Adarabioyo to wrong-foot Bernd Leno in the Fulham goal.

Substitute Cody Gakpo then drove in a Darwin Nunez pull-back to send the home crowd wild.

It was the second time in just over a month that Liverpool had denied Fulham success at Anfield. Marco Silva's side had led 3-2 in the final 10 minutes of their Premier League clash on 3 December but lost 4-3.

The two sides will

meet again in the second leg at Craven Cottage on Wednesday, 24 January, with Jurgen Klopp's men now in the driving seat as they look to keep alive their hopes of a record-extending 10th League Cup win.

But the Reds boss warned: "It's not over yet.

"I didn't expect a result where we could book the hotel. Hopefully we will be better from the start. We couldn't do more than win the game - I'm absolutely happy."

This had the potential to be a tricky game for Premier League leaders Liverpool, who went into the game with a number of key players missing.

Trent Alexander-Arnold, who was excellent in their FA Cup third-round win against Arsenal at the weekend, is facing a few weeks out with injury, while Mohamed Salah and Wataru Endo are away on international duty.

Fulham gave Liverpool a scare at Anfield last month and having come so close to a result on that occasion, they looked

determined to cause an upset this time.

They were good value for their 1-0 lead at half-time with the hosts lacklustre and a little disjointed.

But Klopp's side were a different prospect after the break as they pressed much higher up the pitch and when Gakpo and Nunez were introduced midway through the second period, Fulham's defence was unable to cope.

In the end, Liverpool could have won by a bigger margin with the impressive Nunez once again unfortunate not to get on the scoresheet.

"I don't know how to explain the Darwin situation," added Klopp. "He can't be more unlucky in finishing situations. He does everything right and still sets up the goals.

"To bring Darwin and Cody from the bench is a proper change."

A big positive for Klopp was the performance of Northern Ireland international Conor Bradley. The 20-year-old started at right-back

in Alexander-Arnold's absence and impressed throughout.

It is now 16 games unbeaten at Anfield for the Reds - 14 of those victories - as they once again found the will and a way to extend their

dominant record on home soil.

Fulham, meanwhile, will take heart from their first-half display as they look to keep alive their hopes of a first League Cup win.

"We knew it was going

to be a tough one," said boss Marco Silva. "You can't play for a final thinking it's not going to be really hard. Even three days ago they were able to play Arsenal away from home in the FA Cup."

Poch 'being let down' by his players

Mauricio Pochettino is being failed by some of his Chelsea players.

That is the view of former Blues defender Wayne Bridge, who believes the manager must be given fresh backing by the club's big-spending hierarchy.

And while Bridge is baffled by Chelsea's "crazy" recruitment strategy, with the team still in need of improvement despite more than £1billion-worth of new signings, he is convinced Pochettino remains the right man to bring success back to the 2012 and 2021 Champions League

winners.

"He has been let down by the players," Bridge said. "He's a really good manager. I'd love to see him get time. You don't always get it but he should. It's crazy how inconsistent they are with the amount of money they have spent.


"But it's individual performances from certain players that have let him down."

Chelsea suffered their latest setback when they were beaten 1-0 in the first leg of their Carabao Cup semi-final away to Middlesbrough on Tuesday.

Bridge believes that defeat typified their season - because they do not yet have the mental strength to battle back from going behind. The former England left-back said: "If they get the first goal they are fine.

"But if they concede first it's such an uphill struggle. At Middlesbrough they had chances to go ahead, they didn't and then they really struggled. The teams they have won against recently - no disrespect to them - are not great teams.

"It will take time and I hope Poch gets the time. But they will have to add more players, definitely."
