

Anti-semitism 'has no place in society' says William

■ In visit to London synagogue, Prince tells audience: "both Catherine and I are extremely concerned"

Prince William has condemned a rise in antisemitism during a synagogue visit.

The Prince of Wales said it "has no place in society" as he met young people and students in London on Thursday.

He was told about an increase in antisemitism since the 7 October Hamas attacks and Israel's retaliatory military campaign in Gaza.

It was the prince's first public appearance since pulling out of a memorial service due to a "personal matter".

'dehumanizing'

He had been due to give a reading at Tuesday's memorial for the late former King Constantine of Greece.

While at the Western Marble Arch Synagogue

in central London, the 41-year-old met a Holocaust survivor, and Jewish student representatives and young people who told him how they had been affected by antisemitism.

The prince was told of its "dehumanizing" effect and said he wanted to "reassure you all that people do care". Edward Isaacs, the head of the Union of Jewish Students UK and Ireland, told Prince William about "an explosion of antisemitism on campus that we've never seen before."

"We've seen not only the number of incidents increase but the severity

too. We've seen Jewish students receive death threats, we've seen Jewish students physically assaulted on campus, we've seen Jewish property desecrated as well on campus."

Even Jewish students who have not faced antisemitism know someone has, he added, creating "a climate of fear that we've never known before".

'echo chamber'

"It's never been like this before," Emma Levy, the president of Leeds Universities Jewish Society, told him. "Our grandparents and parents say the same."

Condemning the rise in hatred towards the Jewish community, Prince William said: "Well, you've heard it from me, antisemitism has no place in society. I've said that before and I'll say it again."

He added: "Both Catherine and I are extremely concerned about the rise in antisemitism that you guys have talked about so eloquently this

morning, and I'm just so sorry you've had to experience that."

The prince also said it was "important" that people "break out" of "boxes" that keep them separate.

"A lot live in their silos, in their echo chamber on social media, they don't have different influences, they don't have anything else, they might not have anyone they know who's Jewish...it's so important we break out of those boxes."

The heir to the throne also met Holocaust survivor Renee Salt, who described her fears surrounding antisemitism and he told her: "It must be horrible for all of you worrying about this and I'm sorry

it's got to this. It will get better."

The 94-year-old told William how she was moved from "ghetto to ghetto" during World War Two.

The prince expressed his condolences when she said her mother died 12 days after they were liberated from the Bergen-Belsen concentration camp by the British Army in 1945.

He suggested it was important those who experienced the Holocaust continued to talk to the next generation, to which Ms Salt replied "some of the young people don't even believe it ever happened".

Ms Salt also said she wished the prince's wife Catherine - who

is recovering from abdominal surgery she had last month - had been with him, as she would liked to have met her.

Karen Pollock, chief executive of the Holocaust Educational Trust, said Prince William "reminded us that antisemitism is not only a problem for the Jewish community but for all society".

She added that his "visit sends a powerful message that Britain is a country where Jews, whether Holocaust survivors who came to find sanctuary or young Jewish students - are welcome and celebrated. He reminds us that even in the darkest days, the Jewish community is not alone".

Amid growing polarization and intimidation, PM calls for calm

■ Sunak: "The events of recent weeks are but the latest in an emerging pattern which should not be tolerated"

Rishi Sunak has warned of the dangers of polarisation and hatred in politics, after a fractious week in Westminster.

He was speaking after Tory MP Lee Anderson was suspended from his party for refusing to apologize for saying "Islamists" have "got control" of the Mayor of London.

The prime minister did not directly address the remarks, but talked about protests and the safety of MPs.

Labour's Sir Keir Starmer called for Mr Sunak to "get a grip" on his party.

Ashfield MP Mr Anderson was criticised by both Labour and Tory MPs after he told GB News on Friday evening: "I don't actually believe that these Islamists have got control of our country, but what I do believe is they've got control of London... He's actually given our capital city away to his mates."

Mr Khan called Mr Anderson's comments "Islamophobic, anti-Muslim and racist" and criticized the prime minister and his Cabinet

for what he called a "deafening silence" on the issue.

An hour later, a spokesman for the Tory party's chief whip Simon Hart confirmed that the whip had been removed from Mr Anderson "following his refusal to apologize" for his comments.

Removal of the whip means that Mr Anderson,

who is also a GB News presenter, has been suspended from his party in Parliament and can no longer sit as a Conservative MP.

Following his suspension Mr Anderson said he "understood the difficult position" he had

put the prime minister in and said he would "continue to support the government's efforts to call out extremism in all its forms - be that antisemitism or Islamophobia".

But Mr Khan described the Conservative Party's decision as "belated" and sought to maintain pressure on the prime minister by saying his silence on the matter was "tacit endorsement".

Until January Mr Anderson served as one of the deputy chairmen of the Conservative Party, but he resigned so he could rebel against the government over the Rwanda vote.

On Saturday evening, Labour leader Sir Keir questioned the prime minister's judgement in appointing him to the role.

He said Mr Sunak needed to "take on the extremists in his party" and had a responsibility to "stop this slide into ever more toxic rhetoric".

In a statement, also on Saturday evening, Mr Sunak did not address Mr Anderson's words but warned of an "explosion in prejudice

and antisemitism" since the attacks by Hamas on Israel on 7 October.

"The events of recent weeks are but the latest in an emerging pattern which should not be tolerated," the prime minister added.

He said legitimate

protests had been "hijacked by extremists" and said elected representatives had been "verbally threatened and physically, violently targeted".

"And in Parliament this week a very dangerous signal was sent that

this sort of intimidation works," he said.

Mr Sunak was speaking following a week which has seen a heightened tension in Westminster, with a row over a vote by MPs on a ceasefire in Gaza, and concerns for MPs' safety.

By George! Mint puts faith in Michael coin



A collectable coin celebrating George Michael has been unveiled by the Royal Mint.

It features the late singer's iconic look from his 1987 hit single Faith and has been approved by George's estate.

Designed by artist and sculptor Sandra Deiana, the coin shows a headshot of the star wearing his trademark sunglasses from the Faith video. A statement from George Michael Entertainment said: "We are deeply honoured that the Royal

Mint is paying tribute to him by creating a series of beautifully crafted coins.

"He would have been enormously proud and genuinely touched that a national institution should have decided to pay tribute to his memory in this way."

The coin follows Last Christmas – by George's group Wham! – topping the charts in December, 39 years after its initial release.

Sandra said: "From the beginning of the project, I was clear about certain elements that I

wanted to incorporate into the design. I wanted a detailed portrait that captured his charismatic expression. I was particularly thinking of his iconic sunglasses."

The coins are available to purchase at the Royal Mint's website – royalmint.com/us/

Prices start from £15.50 for a £5 denomination brilliant uncirculated coin. A 2oz gold coin, with a denomination of £200, sells for £5,305.

Harry loses High Court bid to overturn 2020 security downgrade

■ Judge rules there had been no unlawfulness in the decision to change Prince's protection detail

The Duke of Sussex has lost a High Court challenge against the government over his security when in the UK.

Prince Harry was contesting a decision to downgrade his security status when he stopped being a working royal.

He argued he had been treated unfairly in the changes to his police protection, when he still faced significant security threats.

Prince Harry is to appeal against the court's ruling that there was nothing unlawful in these security decisions.

"The duke is not asking for preferential treatment," said his lawyers after the High Court ruling, but they argue there has been an unfairness in how decisions were made about his publicly-funded police protection.

When Prince Harry stepped back from being a working royal and moved to the US, he was no longer automatically provided with the same level of police protection given

to the Royal Family, but instead had his security decided on a case-by-case basis, in the same way as other high-profile visitors to the UK.

Prince Harry's attempt to challenge how this was decided has now been rejected, with the court upholding the actions of the committee that oversees security arrangements for the Royal Family and other high profile public figures, known as "Ravec", which brings together representatives of the Home Office, Metropolitan Police and the Royal Household.

'legally sound'

The judge ruled there had been no unlawfulness in the decision-making or anything that could be called irrational in the changes to Prince Harry's security in February 2020 - and even if there had been any "procedural unfairness" it would not have changed the outcome.

Much of the hearing

had been heard in private for security reasons - and parts of the ruling were redacted - but the ruling found that the approach of having a "bespoke" arrangement for Prince Harry, rather than the same as working royals, was "legally sound".

An earlier separate court ruling had rejected a bid by Prince Harry to make private financial payments for police protection when in the UK.

Prince Harry's legal battles over his security in the UK have reflected his worries about his safety and for his family - with only a few brief visits to the UK in the past couple of years.

The court documents highlight concerns such as Prince Harry being "ambushed" by paparazzi photographers at a WellChild awards event in Kew in London in June 2021.

This was more alarming "in the light of what happened to his mother, Diana, Princess of Wales",

the court was told.

In March 2023 Prince Harry made headlines with a surprise appearance at the Royal Courts of Justice in London in a case against Associated Newspapers.

The court papers, although redacted, show his six-day visit had been preceded weeks before by exchanges between the prince's "director of European security" and UK security bodies,

including the Ravec committee.

It highlighted risk factors such as Prince Harry being "the son of King Charles III, a brother of the Prince of Wales, and that al-Qaeda had recently called for the claimant to be killed".

In response to the court ruling rejecting Prince Harry's challenge to the security arrangements, the Home Office welcomed the decision and said:

"The UK government's protective security system is rigorous and proportionate."

Prince Harry's lawyers will now pursue an appeal, arguing that the Ravec committee failed to apply its own rules and rejecting the "bespoke" approach.

"The Duke of Sussex hopes he will obtain justice from the Court of Appeal," said a legal spokesperson.

Tributes flow for "Stan the Man"

HEARTFELT tributes have poured in from the sporting world and beyond after the death of former England and Queens Park Rangers star Stan Bowles aged 75.

Despite earning just five caps for his country, Bowles was hailed as one of the nation's greatest ever footballing entertainers.

Revered as one of the game's great characters, Bowles - affectionately known to fans as Stan the Man - tragically spent his last years in a care home after being struck down with Alzheimer's.

His death was announced on Facebook by younger daughter Tracy, 54, who said: "Sad to be writing this but dad has passed away."

"He was with all the family and went peacefully."

At the height of his fame Bowles would often buy cigarettes in a corner shop near QPR's Loftus Road ground before popping into a pub for a pre-match pint.

He would nip into the betting shop on his way to the dressing room before heading on to the pitch to show off his dazzling

skills.

Against Middlesbrough in 1978 he stopped to read a programme thrown on to the pitch.

Match of the Day presenter and former England striker Gary Lineker posted: "Sorry to hear Stan Bowles has died. A delightful footballer and hugely charismatic man. Always loved watching him play. RIP Stan."

Former England and QPR winger Trevor Sinclair said: "Really sad to hear, the great entertainer Stan Bowles has passed away."

Church denies anti-semitism after leading choir in 'From The River to the Sea'

Charlotte Church says she is "in no way antisemitic" after being criticised for taking part in a controversial pro-Palestinian chant.

The singer faced backlash after she led a 100-strong choir in a rendition of From the River to the Sea at a concert.

It references the land between the River Jordan, bordering the occupied West Bank and Israel in the east, to the Mediterranean Sea in the west.

Critics say it calls for the destruction of the state of Israel.

The Palestine Solidarity Campaign and other activists contest this, saying the slogan refers to "the right of all Palestinians to freedom, equality and justice".

Broadcasting live on Instagram on Monday, Church addressed "alarmist" reports relating to the event.

She said: "Just to clarify my intentions there, I am in no way antisemitic. I am fighting for the liberation of all people. I have a deep heart for all religions and all difference.

Church confirmed the gig had ended with a chant of the words "from the river to the sea, Palestine will be free".

She said: "Clearly, if you know the history of it all, [it is] not an antisemitic chant calling for the obliteration of Israel. It is not that in any way shape or form. It is calling for the peaceful coexistence of Israelis and Palestinians."

Church said "lots of other beautiful songs... of

liberation and freedom" were performed at the event, including Arabic songs, Welsh songs, and South African songs from the anti-Apartheid movement, "the lyrics of which were adapted to the situation in Palestine".

The Campaign Against Antisemitism has previously said the "River to the Sea" chant is deeply offensive and threatening.

It accused the singer of "anti-Jewish racism" and has called for the Charity Commission to investigate.

Rabbi Dr Jonathan Romain MBE said on X: "Dear Charlotte Church: Let me translate for you - when you say 'From the river to the sea' it means expelling Jews from the Jordan to the Mediterranean i.e. from the Land of Israel entirely & destroying a nation."

However, the Jewish Voice for Peace (JVP), a US group which calls itself a "progressive Jewish anti-Zionist" organisation, includes a version of the chant in its mission statement: "We picture Palestinians — from the Jordan River to the Mediterranean Sea - living with their inalienable rights respected."

Church has not shied away from expressing her political views since the outbreak of the Israel-Gaza war.

Last month, in a statement posted to X, formerly known as Twitter, she said she was "in tears daily" over the situation and felt she must "do more to organise, resist, oppose, fight like a lioness" for the Palestinians.

Scottish police face scrutiny after man found guilty of Emma Caldwell murder

■ Scotland force under spotlight over handling of 2005 case and its attitude to violence against sex workers

THE SCOTTISH police force found themselves under intense scrutiny this week, after a man was found guilty of the 2005 murder of Emma Caldwell.

The conviction came after a trial that raised significant questions about the investigation of the killing and the key suspect over almost 20 years, as well as attitudes to reports of violence against sex workers.

Iain Packer, 51, was sentenced to at least 36 years in prison for Caldwell's murder and was found guilty of 32 other charges against a total of 22 women that amounted to a horrifying course of unchecked physical and sexual violence over two decades. The offences included 11 rapes and multiple sexual assaults.

Sentencing Packer to the second-longest term in Scottish legal history, the judge, Lord Beckett, said the killer was responsible for an "extreme campaign of sexual violence", preying on the vulnerable and causing "extreme and enduring suffering for so many women and their families".

Immediately after the verdicts, the Police Scotland assistant chief constable Bex Smith, who is the executive lead for major crime and public protection, apologized directly to Caldwell, her family and "many other victims", saying they were all "let down by policing in 2005".

Caldwell was living in a hostel in Glasgow when she disappeared in April 2005, aged 27. Her naked body was found five weeks later in Limefield Woods near Biggar, South Lanarkshire.

Her mother told the trial that Caldwell had started

taking heroin to numb her grief over the death of her older sister. She had been making money through sex work at the time of her death. The court heard from a friend of Caldwell's that Packer had become "obsessed" with her, following her and attempting to scare away her other clients.

'tragedy'

Although a rape allegation was first made against Packer in 1990, the prosecutor advocate depute, Richard Goddard KC, told the jury that at that time police were "dismissive" of reports made by sex workers. He said it was a "tragedy" that sex workers felt forced to accept sexual assault as "part and parcel of their job".

Many of the women who gave witness statements were sex workers at the time and some have since died.

Packer - who denied all charges apart from one of a prior indecent assault against Caldwell, for which he admitted he was "ashamed" - gave evidence at the trial over three days, insisting he had not killed Caldwell and that the other women accusing him were either

mistaken or liars.

He admitted taking sex workers to the woods where Caldwell's body was found - but not to the same spot where she was found. Asked where he was on the night Caldwell disappeared, Packer told the court he could have been at work or walking his dogs.

The court had heard earlier from an expert that soil found in his van was a 97% match for earth at the spot where Caldwell was dumped.

Information about the police investigation that came to light during the trial raised significant questions about why it took so long to bring Packer to justice. He gave six statements to police between 2005 and 2007, but was not interviewed under caution as a suspect.

A decade later, concerns about the unsolved case

were such that in 2015 the lord advocate ordered Police Scotland to re-investigate not only who killed Caldwell, but flaws in the original inquiry.

The original police investigation was focused on four Turkish men, who were charged with Caldwell's murder in August 2007, but that case collapsed and the men were released.

Smith made it plain that Strathclyde police, the force that first investigated Caldwell's murder before Scottish forces were merged into one force in 2013, had failed Packer's victims.

"A significant number of women and girls who showed remarkable courage to speak up at that time also did not get the justice and support they needed and deserved from Strathclyde police," she said.

On the block: love letters from classic rock's most famous love triangle

■ Pattie Boyd set to auction love letters from former husbands George Harrison and Eric Clapton

Model Pattie Boyd is selling letters that lift the lid on her notorious love triangle with guitarist Eric Clapton and Beatles star George Harrison.

Boyd was a muse to both men in the 1960s and 70s, inspiring Harrison's classic song Something and Clapton's hits Wonderful Tonight and Layla.

Initially married to the Beatle, she was pursued by his close friend Clapton in a series of passionate love letters.

Now she is auctioning notes from both men, along with other possessions.

The sale will take place at Christie's in London next month, with the items on public view from 15 to 21 March.

Boyd met the Beatles when she was cast in their 1964 film A Hard Day's Night and instantly felt a connection with Harrison, their famously "quiet" guitarist.

"He was quite shy, like me. I think that's why we got on," she said in an interview published on the website of auction house Christie's.

They dated for two

years before marrying in January 1966, during which time the Beatles were often away on tour,

"George was so adorable when he was away," she said. "He missed me, and I missed him terribly, and he would write amazing letters and wonderful postcards."

One note in the auction sees Harrison write: "Hope you're OK. I miss you. I'm starving - many grilled cheese sandwiches. Love you."

Clapton was a frequent guest at the couple's house in Surrey but, unbeknown to Harrison, harboured feelings for Boyd.

In 1970, he sent her a letter in impeccably neat, angular longhand. "I am writing this letter to you,

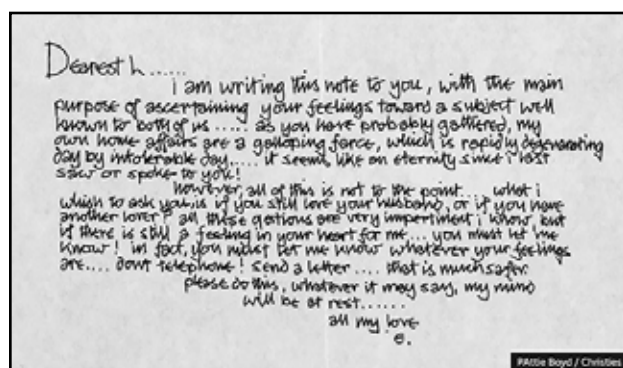
with the main purpose of ascertaining your feelings towards a subject well known to both of us," it began.

"What I wish to ask you is if you still love your husband?" he continued. "All these questions are very impertinent, I know, but if there is still a feeling in your heart for me... you must let me know!"

"Don't telephone! Send a letter... That is much safer."

Clapton later wrote the rock standard Layla for Boyd.

"It was so beautiful and so magical," Boyd recalled. "I was so flattered, but I was also so worried that George would work out why Eric had written this song."

Boyd originally rebuffed Clapton's advances but, after her marriage faltered in the early 1970s, the musician invited Boyd to join him on tour.

Their romance flourished and they married in 1979 - with the blessing of Harrison, who took to calling Clapton his "husband-in-law".

Ultimately, however,

Clapton's alcoholism and infidelity undermined the marriage, and they divorced in 1989.

Boyd, the daughter of a retired RAF bomber pilot, was a famous fashion model in the 1960s before turning her attention to photography.

She will sell her memorabilia including letters, paintings, photographs, jewellery

and fashion next month.

Among the lots is a doodle by Harrison, in which he drew himself sitting beneath an apple tree, and a Christmas card he made for her in 1968.

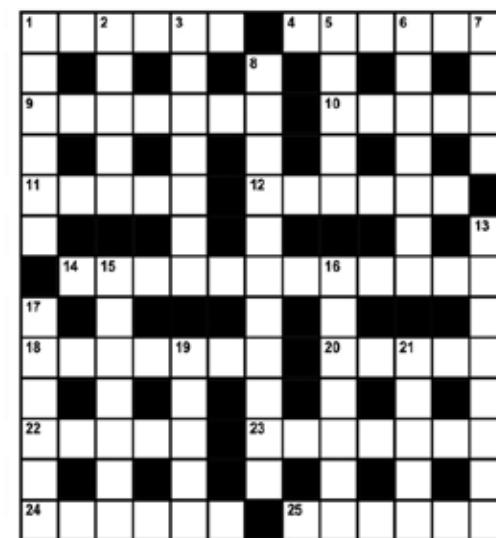
"I've had them all for so many years - far too long," Boyd, who turns 80 this year, told reporters.

"I thought, why don't I just sell everything and let everybody else enjoy it?"

Everton penalty cut to six points

Everton FC have had their penalty for breaching Premier League financial rules reduced to six points following an appeal.

The Toffees were hit with a 10-point deduction last November, outraging fans and officials.

It came after an independent commission found they had exceeded permitted losses under the league's profitability and sustainability rules by £19.5million over an assessment period ending with the 2021-22 season.

An independent appeal board has now cut that penalty by four points, which moves the club on to 25 points in

the table and up to 15th place - five points above the relegation zone

An Everton statement said: "While the club is still digesting the appeal board's decision, we are satisfied our appeal has resulted in a reduction in the points sanction."

"We understand the appeal board considered the 10-point deduction originally imposed to be inappropriate when assessed against the available benchmarks of which the club made the commission aware."

"The club is also particularly pleased with the appeal board's decision to overturn the original commission's finding that the club failed to act in utmost

good faith. That decision, along with reducing the points deduction, was an incredibly important point of principle for the club on appeal. The club, therefore, feels vindicated in pursuing its appeal."

Everton face a second PSR complaint over the assessment period running to the end of last season.

The statement went on: "Notwithstanding the appeal board's decision, and the positive outcome, the club remains fully committed to co-operating with the Premier League in respect of the ongoing proceedings brought for the accounting period ending June 2023."

Stokes 'proud' despite first series loss

England captain Ben Stokes said he was "proud" of his team despite a five-wicket loss in the fourth Test that sealed a series defeat in India.

The tourists are 3-1 down despite winning the first Test and having opportunities to win the other three.

India have stretched a 12-year unbeaten home record while inflicting Stokes' first series defeat as captain.

"The 3-1 score doesn't look great, but the way in which we've come at India is what I'm most proud of," said Stokes.

"This young, inexperienced team has been successful over the past two years, but coming to India is a completely different beast, something that this team has not been exposed to."

Set 192 to win, India were rocked by an England fightback on the fourth day in Ranchi.

The home side were 100-3 and 120-5, before an unbroken stand of 72 between Shubman Gill and Dhruv Jurel sealed India's 17th consecutive home series win.

"We didn't have a chance in hell of even competing with India, but even today that wasn't an easy win for India and I think they would admit that," Stokes said.

England were beaten despite having the better of the first two days of the fourth Test.

India fought back from 177-7 in their first innings, helped by Ollie Robinson's crucial drop of Jurel, who made 90.

With a first-innings lead of 46, England were bowled out for just 155 in their second innings, undone by the high-quality spin of India's Ravichandran Ashwin, Kuldeep Yadav and Ravindra Jadeja.

Chelsea edge Cup thriller

■ Poch's men bounce back as Gallagher grabs last-gasp winner over spirited Leeds side

Conor Gallagher scored a last-minute winner Wednesday night as Chelsea snatched a dramatic 3-2 victory over Leeds United to move into the FA Cup quarter-finals.

A thrilling fifth-round tie at Stamford Bridge looked to be heading towards extra time before the England international was free in the penalty area and lifted a finish past Illan Meslier.

The win keeps Chelsea's hopes of winning a trophy alive after they lost 1-0 to Liverpool in the Carabao Cup final on Sunday.

Mauricio Pochettino's side will return to Wembley for the FA Cup semi-finals if they win at home against Championship leaders Leicester City in the last eight in March.

The Argentine began his role as manager in July and felt the performances were improving, but the squad needed more time.

"The expectation is massive because we are Chelsea, but this team needs to build and build the confidence," said Pochettino. "The unity is starting to grow, it's not magic, you can't just create it.

"It's difficult because of the expectations. You need to find the right balance and need time so they can perform.

"In the past four weeks we are doing fantastically, the team are fighting and starting to behave like a team."

Chelsea fell behind early on when a defensive error led to Mateo Joseph scoring his first senior goal as Leeds went ahead after only nine minutes.

But the visitors, second in the second tier, were only leaders for six minutes.

Nicolas Jackson made it 1-1 with a low strike from



Moises Caicedo's pass before Mykhailo Mudryk gave Chelsea a 37th-minute lead, sweeping Raheem Sterling's pull-back into the bottom corner.

Yet Leeds were the better team at the start of the second half and got a deserved equaliser as Joseph grabbed his second goal with a header at the back post to connect with Jaidon Anthony's excellent cross.

Anthony could not convert two chances to put the visitors ahead before substitute Gallagher proved to be the match winner.

Chelsea won the Champions League in 2021 and then followed that up by clinching both the Uefa Super Cup and the Fifa Club World Cup.

But they only finished 12th in the Premier League in 2022-23, failing to qualify for Europe, and are 11th this season and in danger of missing out on continental football again for 2024-25.

Chelsea have spent more than £1bn on transfer fees since a consortium led by American investor Todd Boehly and private equity firm Clearlake Capital bought the club in May 2022.

However, their players were heavily criticised for the manner of their

Carabao Cup final loss against a youthful Liverpool side, with ex-England and Manchester United defender Gary Neville calling Chelsea the 'blue billion-pound bottle jobs'.

Pochettino felt the comment was harsh and added: "He [Neville] was frustrated because Liverpool won another title. It's not fair to accuse people in this way, with a team that's very young."

His side would have faced more criticism if they had gone out of the FA Cup but, despite being outplayed for large parts of the second half against a Leeds outfit that performed excellently, the hosts got the job done.

Gallagher admitted Chelsea had to respond in a positive way to the critics.

"It [the final loss] was a big disappointment and we wanted to bounce back and give the fans something to celebrate, and we managed to do that," said Gallagher.

"It has been a really tough few days and everyone has been down but we had to make sure we were right because it was such an important game and the boys dug deep to get the win."

For Daniel Farke's Leeds team they should be proud of their efforts

and now focus on their performance but felt promotion back to the Premier League.

Speaking to BBC Radio 5 Live, Farke said he was "very proud" of his side's

performance but felt Chelsea were "clinical". "In the second half we had more possession, more shots at goal and more expected goals," he added.

"It was no coincidence we scored the second goal, we wanted to dominate possession in order to stick to our beliefs - many compliments to my young lads."
