

# ARMS TO ISRAEL UNDER THREAT?

## ■ Sunak to review policy amid uproar over death of three British charity workers

**SALES of arms to Israel must be reviewed following the drone attack that killed three British aid workers, Rishi Sunak said on Thursday.**

Military veterans John Chapman, 57, James Henderson, 33 and James Kirby, 47, died while working with charity World Central Kitchen in Deir al-Balah, central Gaza.

And now the Prime Minister is under growing pressure to act after what some military experts described as a "deliberate" strike.

Senior Tory and Labour politicians, as well as a former national security adviser, urged Mr Sunak to "reassess our supply of weaponry" – amid fears British weapons may have been used in Monday's atrocity.

### 'consistently clear'

One branded the response to the killings from Israeli PM Benjamin Netanyahu "shamefully inadequate".

Mr Sunak stopped short of revoking arms licences to Israel.

He said: "We've always had a very careful export licensing regime that we adhere to. There are a set of rules regulations and procedures that we'll always follow.

"And I've been consistently clear with Prime Minister Netanyahu since the start of this conflict that – whilst of course we defend Israel's right to defend itself and it's people against attacks from Hamas – they have to do that in accordance with humanitarian law, protect civilian lives, get more aid into Gaza.

"What we want to see is an immediate humanitarian pause to allow more aid in and crucially for more hostages to also be released."

He added: "What's happened is a tragedy and it shouldn't have happened. And there are questions that need answering.

"And that's why I've

been very clear that what we expect is a thorough, transparent investigation.

"Also, I want to see a dramatic increase in the amount of aid flowing into Gaza and closer work with the aid agencies, so these types of things just do not happen."

### 'global outrage'

The Prime Minister also told Mr Netanyahu the humanitarian crisis in Gaza is "increasingly intolerable".

Former senior diplomat Lord Peter Ricketts had earlier called for an

"immediate ceasefire" and said the killing of the aid workers had sparked "global outrage".

The crossbench peer told BBC Radio 4's Today programme: "There is abundant evidence now that Israel hasn't been taking enough care to fulfil its obligations on the safety of civilians. And a country that gets arms from the UK has to comply with international humanitarian law.

"I think the time has come to send that signal. It would be a powerful political message.

"And it might just stimulate debate in the US, which would be the real game-changer, if the Americans began to think about putting limits... on the use of American weapons in Israel."

He added: "Sometimes in conflict, you get a moment where there's such global outrage that it crystallises a sense that things can't go on like this.

"I think – I hope – that this awful incident will serve that purpose."

The aid workers were attacked after leaving

the Deir al-Balah warehouse, where they had unloaded more than 100 tons of humanitarian food aid brought to Gaza by ship.

And one Israeli defence source told newspaper Haaretz: "If someone doesn't put an end to how some forces in the Strip have been operating, we'll see this happen time and time again."

World Central Kitchen founder Jose Andres said his team was only taking such drastic risks **cont. on page 5, col. 1**

# UK will leave European Court of Human Rights if Rwanda flights are blocked, pledges Sunak

■ Immigration control and border security “fundamental to our sovereignty as a country”

IN his most forthright statement yet on the UK's future within the European Court of Human Rights, Rishi Sunak says he will leave the treaty if it blocks flights to Rwanda.

Coming out fighting after a few turbulent weeks of dire polls and party unrest, Rishi Sunak, who has been under pressure from some Tory MPs to commit to leaving the international agreement, said immigration control and border security were more important than “membership of any foreign court” and they were “fundamental to our sovereignty as a country”.

The warning to Strasbourg judges is the strongest yet from Mr Sunak, who insists his Rwanda Bill complies with international law.

Speaking passionately about the need to stop the boats, the PM said illegal migration “offends my sense of fairness”. In an interview with The Sun he added: “Of course, we're welcoming and tolerant people and my own personal story is an example of that.

“But that's got to be done fairly. And when people jump the queue, come here illegally and then put pressure on public services in the way that they do and we are not able to remove them in the way that we want to, that's not right. It offends my sense of fairness and that sense of fairness is a central character.”

### ‘highly confident’

Another 800 illegal migrants arrived on UK shores over the Easter weekend after crossing the Channel on small boats. It takes the total number of arrivals this year to more than 5,435, a 43% increase compared with the same time in 2023.

But Mr Sunak defended his record on tackling the issue compared to his predecessors. He said: “More than any other Prime Minister in history I've really gone at tackling this problem and I spent more time on it than anything else other than the economy.”

Crossings were down by a third last year but the Prime Minister denied he is now back to

square one. He insisted: “No, we're not because progress is still being made.”

The Safety of Rwanda Bill is stuck in Parliamentary “ping pong” because peers are refusing to back the legislation in its current form. But Mr Sunak says he is confident it will

pass and flights will take off soon after.

He added; “We've got all the plans in place. I am highly confident I can operationalise the policy.”

### ‘more important’

The PM hit out at Labour for sniping from the sidelines and accused leader Sir Keir Starmer of having no plan for dealing with the small boats.

Mr Sunak previously warned the European Court of Human Rights that he will do “what is necessary” to make the Rwanda plan a reality, but went further last night. He said: “Our scheme, including the Rwanda part of it, all our plans to tackle illegal migration, are compliant with all of our international obligations including the ECHR.

“But I believe that border security and controlling illegal migration is more

important than our membership of any foreign court.”

Mr Sunak has endured a torrid few weeks after threats of plots to oust him after local elections next month.

### Tory meltdown?

Another major poll was released on Monday that put the Tories on course to suffer a General Election defeat similar to the 1997 meltdown. The YouGov study put Labour on 403 seats, leading to a 154-seat majority in the Commons.

The Conservatives would win just 155 seats, down from the 365 at the 2019 election.

Prominent Tory figures including Chancellor Jeremy Hunt, Penny Mordaunt, Sir Iain Duncan Smith, and Sir Jacob Rees-Mogg would lose their seats.

More than 18,000 adults were polled for the study, which found

the Reform Party would not win any seats despite growing support. Mr Sunak said: “It has been a frustrating time. There's going to be lots of polls. What matters is the General Election and that's what I'm focusing on.”

The Prime Minister said his continued “working assumption” is that an election will take place in the second half of the year.

Sunak later told reporters that he has not decided when this will be as he is “busy focusing on the things that matter to people”. Mr Sunak can go as late as next January but is expected to trigger an autumn vote.

The PM refused to rule out a June poll but again repeated his “working assumption” was that it would be later in the year.

The bookmakers currently have Labour at 6-1 on to win a majority.

# Scottish police refuse the bait after Rowling dares them to arrest her over 'misgendering'

■ The Hate Crime and Public Order (Scotland) Act 2021 makes it a criminal offence to make derogatory comments based on transgender identity

**POLICE have ruled JK Rowling's social media comments about trans women do not breach Scotland's new hate crime law.**

The Harry Potter author, 58, has long criticised legislation that came into force on Monday criminalizing "hateful" speech against people due to their protected characteristics.

On Monday the writer challenged Police Scotland to arrest her for "misgendering" as she described several trans women, including convicted sex offenders, as men.

But Police Scotland were eager to defuse the row, and on Monday evening said her comments were not being treated as criminal under the new law, and that despite complaints "no further action will be taken".

## 'charge us both'

Rowling welcomed the police's decision, saying: "I hope every woman in Scotland who wishes to speak up for the reality and importance of biological sex will be reassured by this announcement.

"I trust all women – irrespective of profile or financial means – will be treated equally under the law.

"If they go after any woman for simply calling a man a man, I'll repeat that woman's words and they can charge us both at once."

The Hate Crime and Public Order (Scotland) Act 2021 – which has taken three years of political wrangling to

come into force – makes it a criminal offence to make derogatory comments based on disability, religion, sexual orientation, transgender identity or being intersex.

Stirring up hatred based on race, colour, nationality or ethnicity was already illegal under the Public Order Act 1986.

## Twitter outburst

However, there was anger that Scotland's new bill did not include the female biological sex as one of the protected gender characteristics. On Monday, Rowling, 58, who campaigns on women's issues, lashed out in a series of posts on X, formerly Twitter, in which she branded several trans women "men". They included Scottish butcher Amy George, 53, also known as Andrew Miller, who was jailed for 20 years last year for abducting and sexually assaulting an 11-year-old girl while dressed in women's clothes.

## 'fragile flower'

Also on the list was Isla Bryson, 31, who changed gender while waiting to stand trial for two rapes committed when she was Adam Graham.

Rowling sarcastically urged her 14million followers to not use "he and his" for Bryson, as "misgendering is hate, so respect Isla's pronouns, please".

She also referred to "fragile flower" Katie Dolatowski, a trans woman jailed for sexually assaulting a girl

in a supermarket toilet and a big supporter of the new Bill.

The writer then declared: "April Fools!...Only kidding. Obviously, the people mentioned in the above tweets aren't women at all but men, every last one of them."

## 'most vulnerable'

Then she wrote: "The redefinition of 'woman' to include every man who declares himself one has already had serious consequences for women's and girls' rights and safety in Scotland, with the strongest impact felt, as ever, by the most vulnerable, including female prisoners and rape survivors.

"It is impossible to accurately describe or tackle the reality of violence and sexual violence committed against women and girls, or address the current assault on women's and girls' rights, unless we are allowed to call a man a man. Freedom of speech and belief are at an end in Scotland if the accurate description of biological sex is deemed criminal."

She said that despite the fact she was abroad at the time of writing, her posts were "an offence under the terms of the new Act", adding: "I look forward to being arrested when I return to the birthplace of the Scottish Enlightenment."

Scotland's First Minister Humza Yousaf claimed the law was designed to deal with what he called a "rising tide of hatred".

## Northerners 'make the nicest neighbors'

NORTHERNERS are more neighbourly than Southerners and Midlanders, a study claims.

Neighbours in the North of England are more likely to chat over the garden fence, feed your pet, accept deliveries and keep an eye on your home when you're away, the findings suggest.

From Liverpool to Newcastle, the streets are apparently teeming with people who would lend you their lawnmower or a cup of sugar, give you a lift and put your bins out, according to social networkingservice Nextdoor. They might even join you on a trip to the pub or invite you over for a dinner party.

But if all this sounds like your idea of hell and you'd rather just be left alone, you're better off living further south, the study found.

In the research, Nextdoor totted up points for each "neighbourly" attribute, such as knowing the names of your neighbours, and came up with a Good Neighbour score out of 100. Top of the list, scoring 72, was Liverpool – closely followed by Sheffield, Manchester, Leeds and Newcastle. Surprisingly, London – normally seen as home to people who are more aloof – was not bottom of the list.

That miserable "honour" went to Norwich, scoring just six out of 100, but the capital was next on seven points, followed by Nottingham, Birmingham and Brighton.

A spokesman for Nextdoor said: "If you want good neighbours, the secret is to move up North.

"Our study found that northern neighbours are nicer than those living in the South, with Liverpoolians coming out on top as the friendliest."

# British billionaire fined just \$5m for insider trading

■ Tottenham Hotspur owner Joe Lewis pled guilty as part of an agreement with prosecutors

Billionaire Joe Lewis, whose family trust owns Tottenham Hotspur football club, was fined \$5m (£4m) Thursday, but will avoid prison after pleading guilty to insider trading.

One of Britain's richest men, the 87-year-old Lewis pleaded guilty to insider trading as part of an agreement with prosecutors in January.

At a hearing in Manhattan on Thursday, he was fined \$5m (£4m) and sentenced to three years of probation, avoiding jail time.

Federal guidelines in the case called for a sentence of between 18 months and two years in prison, but both defence and prosecutors urged leniency, citing Lewis' guilty plea, co-operation with authorities and poor health.

Judge Jessica Clarke said his crimes were "serious" and "strike at the integrity of our markets" but said his circumstances did not warrant prison.

### "I am ashamed"

In court, Lewis referred to his childhood in London during the Blitz and said: "At an early age, I learned how precious life is. I made a terrible mistake. I broke the law. I am ashamed, sorry, and I hold myself accountable."

As part of the plea deal, one of Lewis' companies, Broad Bay Ltd, also pleaded guilty to securities fraud and was fined \$44m (£34.8m).

A substantial part of his fraudulent activity, according to an indictment, was not meant to pad his estimated worth of \$6.2bn (£4.9bn).

Lewis was found guilty of giving insider trading stock tips about his companies to his private pilots, friends, personal assistants and romantic partners, in order to enrich his close associates.

In part, the billionaire hatched the scheme

because he felt bad for never setting up formal retirement plans for his pilots, according to a statement he made in court at the time of his guilty plea.

Lewis was born in London's East End and took over a restaurant business started by his father before selling it to focus on currency speculation and investments.

He was reportedly one of the investors who made money betting heavily against the pound prior to "Black Wednesday" - the UK's withdrawal from the European Exchange Rate Mechanism in September 1992.

He founded the investment firm Tavistock Group, which has ownership stakes in a large array of property, sports, finance, energy and life sciences companies.

His position in the financial world gave him access to boardroom secrets, and for years, prosecutors said, he tipped off associates so that they could take advantage, in a fraud that netted millions of dollars. In addition to pilots and workers on his yacht, romantic partners were also on the receiving end of his criminal largesse.

In July 2019, a company called Solid Biosciences that Tavistock had invested in was looking for fresh cash. While considering the deal, Lewis was given confidential information about a clinical trial.

He was staying with his girlfriend in South Korea at the time, and told her to pour money into the company. She invested around \$700,000.

The following day the couple returned via private plane to the US. Along the way, Lewis shared his insider tip with his pilots.

As results of the clinical trial were released, the company's shares

skyrocketed. Lewis' girlfriend more than doubled her money.

The fraud also went beyond insider trading,

prosecutors said. Starting in 2013, Lewis concealed

the true scale of his holdings in companies in order to obtain favourable

terms for stock deals. His pilot, O'Connor, pleaded guilty to insider trading charges and will be sentenced in May.

## Former Scoutmaster who was once one of Crimestoppers' most wanted suspects arrested after 27 years on the run


A former Scoutmaster who was once one of Crimestoppers' most wanted suspects has been arrested after 27 years on the run.

Richard Burrows, 80, appeared in court on Monday. He was held at Heathrow last Thursday after returning from Thailand.

In 1997 he failed to attend Chester Crown Court to face trial for two serious sexual assaults and 11 indecent assaults between 1969 and 1971, including at a children's home in Congleton, Cheshire.

Burrows, of Audlem, Cheshire, was remanded at Chester Crown Court ahead of a hearing on June 21. Detective Inspector Eleanor Atkinson, of Cheshire Police, said: "Our determination to locate Burrows has not faltered over the past 27 years and his arrest is a big step forward."

The National Crime Agency and the Cheshire force traced Burrows to Thailand and were moving for an extradition order, at which point he decided to finally return to the UK.

## Edinburgh Castle gun salute to be made quieter after 'health and safety killjoys' complain

**Edinburgh Castle's famed One O'Clock Gun salute is to be made quieter to stop it being silenced by health and safety rules.**

The historic firing of the gun, which has happened at one o'clock in the afternoon every day - except Sundays, Good Friday and Christmas Day - since 1861, was in jeopardy on Easter Saturday after it was feared the noise was now too loud for the city.

Having originated as a way for ship captains to set their clocks while stationed at Leith Docks, the one o'clock gun has continued as a tradition that still draws crowds.

However, in recent months discussions have been ongoing between the castle, Historic Environment Scotland and the Ministry of Defence about noise concerns, after a safety notice was

issued following initial noise trials conducted by the Army Environmental Noise Team.

In December 2023, the cordon distance for the public watching the gun being fired by the District Gunner from the British Army's 105th Regiment Royal Artillery was increased and some 'ear defenders' (mufflers) were also made available.

However, concerns have persisted regarding the management of crowds, with fears that the firing of the gun could be cancelled altogether.

Grant Shapps, the Defence Secretary, is understood to have intervened owing to the gun's "importance to military history".

A Ministry of Defence source said: "The one o'clock gun has been fired for more than 160 years without complaint and

health and safety killjoys are trying to bring it to an end.

"This level of risk avoidance is ludicrous. Yes, keep people at a safe distance and make sure young children are OK, but this is truly health and safety gone mad.

"The Defence Secretary and a lot of people at the MoD thought it might be an April Fool's joke when they first heard about it.

"Anyone who's been to the New Year's Eve celebrations in Edinburgh and heard the fireworks will know that it's louder.

"But he's determined to make a sensible assessment of the risk and the gun will keep firing. It's a great tradition loved by the people of Edinburgh, the military and tourists."

### 'Beloved ritual'

They added that the one

o'clock gun had a 'historic and cultural importance' to the city, because of its "enduring presence as a daily event in Edinburgh".

"It serves as a reminder of the city's maritime history and its connection to global trade and exploration," they said.

"The firing of the gun has also become a beloved ritual for both locals and

visitors alike, symbolising the passage of time and the continuity of tradition."

While the original gun used to make one o'clock was a 64-pounder, a 105mm field gun has been fired since 2001 from the Mills Mount Battery.

Now, a new, quieter ammunition is to be introduced in late June, although the exact

ammunition is still being finalised.

Edinburgh Castle now instructs all spectators who visit the gun firing to stand in new, marked areas and they are asked to arrive at least 10 minutes before the gun is fired.

Access to some areas surrounding the gun have also been limited until after it has been fired.

because so little aid was being allowed into Gaza by road.

He said: "Benjamin Netanyahu has said of the Israeli killings of our team, 'It happens in war.'

"It was a direct attack on clearly marked vehicles whose movements were

known by the Israel Defence Forces. It was also the direct result of a policy that squeezed humanitarian aid to desperate levels."

Former head of the British Army, General Lord Richard Dannatt, said: "Given that charity workers and aid workers are giving their coordinates to the IDF, and the vehicles were

marked as relief vehicles, it's very hard to conclude this is anything other than deliberate."

Senior Tory backbencher David Jones called for a reassessment of weaponry to Israel. He added: "I thought Netanyahu's response - 'these things happen in war' - was completely inadequate. Frankly, shamefully inadequate."



# In an historic move, Charles opens Balmoral to the general public

Any fan of the royal family - or perhaps, anyone looking for some particularly regal design inspiration - should make a date in their diary to visit Balmoral Castle, the Scottish seat of King Charles, which is now open to the public in a historic move.

Per Balmoral Castle's website: "For the first time since the castle was completed in 1855, we have been granted permission to take you on a private tour with our experienced guides. They will take you on a historical journey through several of the beautiful rooms within Balmoral

Castle."

In 1852, Prince Albert purchased Balmoral as a gift for his wife, Queen Victoria. The original building was deemed too small, so the royals built a new castle (the one that exists today) and tore down the original.

### 'special place'

Visitors who go on the tour, Balmoral's official website says, "will learn about the origins of the castle and how it has been loved by generations of the royal family. Travel through time from the purchase of the Balmoral by Queen Victoria and Prince Albert, through

to present day, where you can see how rooms within the castle are used today by their majesties the King and Queen and other members of the royal family. You will see why Balmoral is such a special place - the much loved and celebrated Highland home of the royal family."

On the tour, visitors will also enjoy access to the grounds, gardens, and exhibitions, and get to see King Charles's watercolours, which show scenes at Balmoral, Highgrove and Sandringham.

specific purpose, like room for the pages, sitting or reading, TV many of whom I loved or tea, and one special like dotty uncles".

## Man pleads guilty to theft of £4.8m gold toilet from Blenheim Palace

A man has pleaded guilty to the theft of a £4.8m gold toilet from the Oxfordshire country house where Winston Churchill was born.

Blenheim Palace's 18-carat lavatory was stolen in September 2019 while it was featuring in an art exhibition. James Sheen, 39, from Wellingborough, Northamptonshire, pleaded guilty to burglary, converting or transferring criminal property and conspiracy to do the same at Oxford

crown court.

The fully functioning toilet, created by the Italian artist Maurizio Cattelan, was plumbed in at the time of the heist, causing flooding and damage to the 18th-century house in Woodstock.

Sheen appeared in court via video link from HMP Five Wells, where he is already serving a 17-year sentence for numerous thefts including £400,000-worth of tractors and high-

value trophies from the National Horse Racing Museum in Newmarket.

Three other men have pleaded not guilty to charges related to the theft of the toilet. Michael Jones, 38, from Oxford, is accused of burglary.

Frederick Sines, also known as Frederick Doe, from Berkshire, and Bora Guccuk, 40, of west London, are both accused of conspiracy to transfer criminal property. The men are due to go on trial on 24 February 2025.

The opener was scored by the hosts' outstanding captain in the 24th minute. The lesser used Emile Smith Rowe - making his first start since January - picked the pocket of Pelly Ruddock Mpanzu and fed Kai Havertz, who squared to Odegaard to side-foot home. In-form Havertz has now been involved

in five goals in his last six appearances at the Emirates.

Arsenal's second knocked the stuffing out of Rob Edwards' depleted side (missing 11 senior players) entirely, with Smith Rowe involved again, as the forward escaped wide left and waited for the perfect moment to tease a cross towards the run of Reiss Nelson, forcing Hashioka to turn inadvertently into his own net.

Speaking to BBC Match of the Day after the game, Arteta said: "We

managed to rotate and freshen the team up a bit. Those who came in did really, really well.

"We scored two very good goals and in the second half credit to Luton, they are a really good side and difficult to play against. But overall, a win and another clean sheet and in a couple of days we play again.

"To have a squad, they have to play. We have to make those decisions. The contribution they make to the team was very good. Now we recover and go again because we

have Brighton away."

On Luton: "As a manager you are always looking at it and analysing and they make

it really tough for you, credit to them. I wish them the best because they are a very likeable team.

"We want to be at the top, winning our games is the only thing we can do."

Luton remain 18th, three points shy of safety, with seven games left to pull off an increasingly unlikely escape.

# Cole strike wins thriller

Cole Palmer scored twice deep into stoppage time Thursday night to complete his hat-trick and earn Chelsea a remarkable win against Manchester United despite having previously given up a two-goal lead.

The latest winner scored in Premier League history, timed at 100 minutes 39 seconds, stunned United, who led through nine minutes of injury time, and sent Stamford Bridge into delirium.

United were ahead with 99 minutes 17 seconds on the clock, the latest a side has ever led in a Premier League match they have gone on to lose.

The two late strikes capped off a breathless game that started at pace, with Blues captain Conor Gallagher slamming the hosts in front, and barely relented throughout.

Inside 20 minutes Palmer doubled the hosts' lead from the spot after Antony fouled Marc Cucurella. But Alejandro Garnacho sparked a United comeback when he pounced on Moises Caicedo's poor pass across the back.

Bruno Fernandes pulled United level just five minutes later when he headed in Diogo Dalot's cross.

Garnacho scored his second when he headed

in an excellent outside-of-boot cross from Antony past goalkeeper Djordje Petrovic, with what United thought was the winner.

That was before a dramatic end to the match saw Chelsea take all three points.

Substitute Noni Madueke was brought down by Dalot in the area and Palmer stepped up confidently to bring the scores level on 100 minutes.

Then in the 101st minute, Palmer picked the ball up from a short corner and his drilled shot was deflected past United goalkeeper Andre Onana to spark wild scenes in the stadium.

# Mac's top whack wows Klopp

## ■ Argentine's wonder strike helps Liverpool back to top of the table

Jurgen Klopp praised Alexis Mac Allister for Thursday's "wonder goal" that helped Liverpool overcome battling Sheffield United and stay in control of the Premier League title race.

The bottom-of-the-table Blades were on course for a shock draw at Anfield, but Mac Allister - a World Cup winner with Argentina - scored with a brilliant 20-yard strike into the top corner to put the Reds 2-1 up.

Cody Gakpo added a 90th-minute third as Liverpool returned to the top of the table.

Boss Klopp said: "We needed Macca's wonder goal to turn it around. He is super important for us, a wonderful player and a wonderful boy - I'm really happy for Liverpool that we got him.

"His defensive work has been really good where people were doubting if he could be defensive, but I prefer him in the eight [attacking midfield].

"He is a really good player. In the first half he was playing [as a] six, but we knew we could move him slightly higher. Then he scores this kind of goal, the two biggest screamers of the season [after also scoring from long distance against Fulham] have come from him. Then the free-kick directly after [the goal] - absolutely insane, what a player."

Mac Allister, who joined Liverpool for £35m from Brighton last summer, also hit the crossbar with a curling free-kick.

Liverpool were gifted a 17th-minute lead when Darwin Nunez charged down goalkeeper Ivo Grbic's clearance with the ball rebounding into the net.

Despite having 84% of possession in the first half and wasting numerous chances, the hosts conceded a 58th-minute equaliser as Gustavo Hamer's header bounced off Conor Bradley and into his own net.

But Mac Allister - nominated for March's Premier League Player of the Month award - put the hosts back in front with 14 minutes left, before substitute Gakpo's header sealed a vital success.

The result moved the Reds two points clear of Arsenal and three ahead of reigning champions Manchester City, with eight league games left.

More importantly, it also kept Liverpool's title destiny in their own hands.

They know if they beat Manchester United, Crystal Palace, Fulham, Everton, West Ham, Tottenham, Aston Villa and Wolves, it will secure their second Premier League title and confirm them

as top-flight English champions for a 20th time.

The visitors were looking to win at Anfield for the first time since Jostein Flo scored twice in a 2-1 win on 2 April, 1994, while Liverpool had not lost a home league match in 27 games - a 2-1 reverse against Leeds in October 2022.

But Sheffield United nearly made a dream start, only for home goalkeeper Caoimhin Kelleher to make an excellent save to deny James McAtee in the opening 90 seconds. Striker Ben Brereton Diaz was then unable to convert Auston Trusty's flick-on from the resulting corner.

However, the visitors gifted the Reds an early goal with Grbic's clearance charged down by Nunez, who scored his 18th club goal of the season in all competitions.

The only mystery was how it was only 1-0 at half-time. Mohamed Salah twice missed the target when well placed, Nunez headed wide and shot at Grbic and Joe Gomez - still without a Liverpool goal - curled an effort past the post.

Ryan Gravenberch slipped when taking a shot after great skill from Luis Diaz and Dominik Szoboszlai fired just off target and forced a good stop from Grbic. Diaz's 25-yard attempt also went just wide as the chances came and went for Liverpool.

But Klopp's side were given a warning that the match was not over

just before the break when Jayden Bogle forced a smart save from Kelleher.

Then, against the run of play, the Blades equalised as Anfield

started to get nervous in what could have been a devastating loss of two points.

It needed something special to change the course of the outcome

- and Mac Allister provided it with a glorious strike for one of the goals of the season to calm the home fans' nerves before Gakpo put the game to bed.
