WELCOME TO GLASTO!

Record crowds flock to iconic British music festival amid gorgeous weather

GLASTONBURY: Thousands of people began pouring into Worthy Farm in southwest England as the Glastonbury music festival kicked off on Wednesday, with hundreds of artists including Dua Lipa, Coldplay and Shania Twain set to enthrall fans.

The festival, which sells out of tickets within minutes even before its line-up is revealed, will close on Sunday with R&B singer SZA slated to perform hits such as “Kill Bill” and “The Weekend” on the main Pyramid stage.

This year’s edition will also feature Afrobeat sensation Burna Boy, rapper Little Simz, American electro-rock group LCD Soundsystem, English singer PJ Harvey and K-pop group Seventeen, in one of Glastonbury’s least rock-heavy line-ups in recent years.

Sunny weather wel-

comed fans who arrived at Worthy Farm carrying rucksacks and camping gear.

James Trusson, 30, a sound engineer from Somerset who had queued overnight to be one of the first to arrive, said he had been coming to Glastonbury for 11 years and he would keep coming back because there was something going on in every field.

‘favorite place’

“It’s just that magic you just don’t get at any other festival,” he said. “There’s not a better feeling really. It’s magical.”

Known affectionately as Glasto, the festival was started by dairy farmer Michael Eavis in 1970, opening the day after guitar legend Jimi Hendrix died, with artists performing to 1,500 people who had bought 1-pound tickets which included free milk from the farm. Mr. Eavis took to the stage on Thursday to welcome attendees and thank them for coming.

More than 50 years since and with its current capacity of over 200,000 people, the site becomes a colourful and sometimes muddy little city of tents for five days

almost every June.

Thursday dawned bright and sunny and the day’s highlights included people doing workouts, dressing like lobsters and tying the knot.

YouTube fitness sensation Joe Wicks led a morning workout session from the stage, while performers took part in a parade to celebrate the Stag Beetle.

Sian Barklem, 25 and Johnjo Smith, 24, got engaged at Glastonbury last year and held a handtying ceremony at this year’s festival, which they said is their “favourite place on Earth”.

Uproar after Labour hopeful brands Churchill and Royals as 'racist'

A LABOUR candidate who called the Royal Family and Sir Winston Churchill "racist" in social media posts has been condemned by her party.

Sir Keir Starmer's spokesman described comments online by Mid Buckinghamshire hopeful Carissma Griffiths as "offensive".

She referred to war-time leader Churchill and the royals as "racists" in posts on Facebook between 2020 and 2021.

Ms Griffiths also claimed that Britain had only once in history been "the good guys".

She has apologised "for any offence caused" after a British tabloid uncovered the comments.

A Conservative Party spokesman said: "Ms Griffiths has no respect for our Royal Family or the great British leaders of our nation's past – these disgraceful comments prove it."

"The Royal Family and Winston Churchill both exemplify British values. They should be looked up to with pride, not looked down upon and treated with disdain."

"Labour has shown

their true colours, if they had any respect for Britain they should make their candidate retract her comments and apologise."

On June 13 2020, Ms Griffiths described Sir Winston as a "racist", who was "responsible for thousands of African deaths directly", and "at the most brutal and brutish end of the British imperial spectrum".

In another post nearly a year later, Ms Griffiths shared an article and commented: "but the Royal Family isn't racist...obvious ignorance doesn't look good on a lot of people", appearing to imply that the Royal Family is "racist" and that it is "ignorant" not to recognise this.

A comment posted by Ms Griffiths in 2021 said that "England doesn't want to own up" to the "evil in its history" and that's "why we...go on and on about the war because it's the one of the only times Britain was on the right side of history".

Ms Griffiths said: "I would like to apologise for any offence caused by these social media posts from several years ago."

"I have great respect for the Royal Family and our nation's history."

"Racial equality is an issue I am very passionate about but I know I should not have posted in this way when I was reacting to news events on the internet."

A Labour Party spokesman added: "These social media posts were offensive and do not reflect the views of the party which has nothing but the utmost respect and support for our King, the monarchy and Britain's great history."

Meanwhile, the party's Kettering candidate appeared to have liked tweets that branded deportation flights to Rwanda as "racist" and describing Britain as a "racist country".

One screenshot shows that Rosie Wrighting liked a post on X, formerly Twitter, by the Stop Deportations group after the first plane carrying asylum seekers on a one-way ticket to the east African nation was grounded following a last-minute intervention by the European Court of Human Rights on June 14, 2022.

The tweet said: "Everyone will be taken off the flight!! No one will be deported to Rwanda tonight!!"

"We have won today, but we will continue

the fight tomorrow and against every racist deportation."

A screenshot showed Ms Wrighting liked a post claiming the UK was a "racist country" in 2020 at

the height of Black Lives Matter.

A source close to Ms Wrighting said she could not recall liking the posts that did not represent her views.

Who's the villain? Actor branded a bigot for telling female MP to 'shut up' on women's rights issues

KEMI Badenoch has branded former Dr Who star David Tennant a "bigot" while criticizing the actor for telling her to "shut up" because of her views on women's rights.

The Equalities Minister accused the star of being a "rich, lefty, white male celebrity so blinded by ideology" in a social media post this week.

Mr Tennant won Celebrity Ally at an LGBT awards ceremony on Fri-

day for his support of the trans community.

He was cheered and applauded after saying he wished the Cabinet minister "doesn't exist", adding: "I don't wish ill of her, I just wish her to shut up."

The politician has spoken out about the Conservatives' pledge to change the 2010 Equality Act, which she said would "clarify that sex in the law means biological sex and

not new, redefined meanings of the word".

Ms Badenoch, who believes this change would protect women and girls' spaces, hit back at the actor on X, formerly Twitter.

She said: "I will not shut up. I will not be silenced by men who prioritise applause from Stonewall over the safety of women and girls."

‘Obsessed’ security guard hatched plan to kidnap, rape and murder TV presenter, court told

Gavin Plumb’s plans allegedly involved breaking into Holly Willoughby’s family home and using chloroform to subdue her

AN obsessed security guard plotted to kidnap, rape and murder a popular ITV presenter in a plan of “catastrophic violence”, a jury heard this week.

Gavin Plumb allegedly wanted to fulfil his “ultimate fantasy” of abducting Holly Willoughby, from her home, holding her prisoner at a remote dungeon where her “screams can’t be heard for miles”, and later slitting her throat.

Willoughby has been a fixture on British TV screens for almost two decades, fronting various shows, most notably the popular breakfast show This Morning from 2009-2023.

‘ultimate fantasy’

The 43 year old mother of three was targeted by Plumb over several years as his obsession with her grew to almost manic levels. He even contemplated becoming the star’s bodyguard and wanted to tour the ITV studios where she worked in a bid to get closer to her, the prosecution said.

Chelmsford Crown Court was told the father of one boasted it was his “ultimate fantasy” to kidnap Ms Willoughby, adding: “Fantasy isn’t enough any more. I want the real thing.”

Plumb denies three charges – soliciting murder last October, and encouraging or assisting the commission of kidnap and rape, from 2021 to 2023.

Opening the case, prosecutor Alison Morgan KC said Plumb’s plan was “not just the ramblings of a fantasist” and he had a “real intention to carry out a plot to kidnap Holly Willoughby from her family home, to take her to a location where she would be

raped repeatedly, before the defendant then intended to kill her”.

Ms Morgan said Plumb, 37, of Harlow, Essex, made purchases including 400 heavy duty metal cable ties to carry out his “graphic and sexually motivated” intention.

She told jurors: “This defendant had carefully planned what he would do and how he would do it, purchasing items that would assist him in carry-

“enjoy”, before “slitting her throat and disposing of the body”.

The court heard he was arrested after unwittingly striking up a conversation with an American undercover detective on a chatroom called Abduct Lovers. Ms Morgan said when police swooped on Plumb’s ground-floor flat to arrest him on suspicion of a conspiracy to kidnap Ms Willoughby, he replied: “I’m not gonna lie, she is a

ing out that attack.”

Ms Morgan said Plumb’s obsession went “beyond just fantasy” and would have involved “catastrophic violence” against Ms Willoughby if he had not been arrested.

chilling claims

The court heard investigators recovered online chats in which Plumb attempted to recruit accomplices for his murder plot and made chilling claims that fears of him going near Ms Willoughby’s children would be an “extra reason for her to be obedient”.

Using the name “Big-Bear” Plumb allegedly told how he would take a drugged Ms Willoughby to the remote location to

fantasy of mine.”

The jury heard voice messages sent to a man named Marc, in which Plumb allegedly said he would “pick out outfits for her we like” and spoke about using chloroform to disable the star and her husband.

Ms Morgan said Plumb developed an obsession with the star over a number of years, hoarding 10,322 photos of Ms Willoughby on his phone and sharing deep fake porn photographs online. He boasted of his past convictions and jail time for false imprisonment and attempted kidnap to “bolster his credibility”, the court heard.

Prosecutors said the convictions – including

tying a 16-year-old girl’s hands behind her back with rope and tape and the attempted kidnap of women on a train with the threat of a gun – showed he

knew “what it would take to terrify and overpower a woman”.

Ms Willoughby has waived her right to anonymity in connection with

the accusation against Plumb of assisting or encouraging rape – which could have given the TV host lifelong anonymity.

The trial continues.

by ideology he can't see the optics of attacking the only black woman in government by calling publicly for my existence to end. Tennant is one of Labour's celebrity supporters. This is an early example of what life will be like if they win.

"Keir Starmer stood by while Rosie Duffield was hounded. He and his supporters will do the same with the country. Do not let the bigots and bullies win."

Sir Keir said in 2021 it was "not right" for Rosie Duffield, a Labour MP who has stressed the importance of biological sex, to say that only women have a cervix. In its election manifesto, Labour has committed to making it easier for people to legally change gender, prompting Tory warnings about loopholes for sexual predators.

In his acceptance speech, Mr Tennant said: "I'm a little depressed by the fact that acknowledging that everyone has the right to be who they want to be and live their life how they want to live it, as long as they're not hurting anyone else, should merit any kind of special award or special mention, because it's common sense, isn't it? It is human decency..."

"However, until we wake up and Kemi Badenoch doesn't exist any more... I don't wish ill of her, I just wish her to shut up. Whilst we do live in this world, I am honoured to receive this."

It came as Harry Potter author JK Rowling criticised Labour on the issue, despite them offering an olive branch.

The best-selling author said of Labour policies on the issue: "The vulnerable women they're throwing under the bus, the well-informed women's groups they refuse to meet, the... attempts of women in their own ranks to make them listen – nah, let's talk to one token celeb."

Anne 'recovering slowly' after head injury**Princess suffered concussion and memory loss after collision with horse at her Gloucestershire estate**

The Princess Royal is "recovering slowly", her husband has said, after visiting her in hospital where she is being treated for a head injury.

Princess Anne, 73, has spent three nights in Southmead Hospital, Bristol, after she sustained what was described as 'a minor head injury and concussion' thought to have been caused by a horse at her Gloucestershire estate.

On Wednesday, Vice Admiral Sir Tim Laurence visited her in hospital for two and a half hours, leaving just before 2pm GMT.

When asked whether his wife would leave hospital the same day, he said: "She'll be out when she's ready."

The Princess Royal's daughter Zara Tindall

also visited her mother for more than an hour on Tuesday afternoon.

Buckingham Palace said on Monday that Princess Anne, King Charles III's sister, was expected to stay in hospital until later this week "as a precautionary measure for observation".

The Princess reportedly 'can't remember' getting injured, which has led to more than one royal observer speculating that the injury is far worse than the Palace is admitting. Her medical team suggested her head injury is consistent with the type of impact from a horse's legs or head.

According to the NHS, concussion can be the result of a "temporary injury to the brain caused by a bump, blow or jolt". It can cause forgetful-

ness, tiredness and a lack of concentration and can take a couple of weeks before a full recovery.

However, the Princess Royal is expected to make a full recovery, but she missed the state banquet with the visiting

Emperor and Empress of Japan on Tuesday and her trip to Canada this week has been postponed.

Princess Anne is the third working royal to temporarily step back from public duties this

year because of a health problem.

The King and the Princess of Wales both stepped back from public engagements in the first half of the year after they were both diagnosed with cancer.

Cheddar still Britain's favourite cheese**Tasty treat first appeared in****Somerset in the early 12th century**

CHEDDAR is still Britain's favourite cheese, nearly 1,000 years after it was first made by monks.

It was the overwhelming winner in a poll of 1,000 consumers with 42% choosing it as their top cheese.

Cheddar is the most commonly bought cheese with 75% of shoppers buying it every month.

Red Leicester followed by Stilton completed the top three favourites, each with 6% of the vote.

Despite being a nation famous for cheese, with more than 500 varieties, France secured only fourth and fifth spots with Camembert and Brie.

Just 2.5% voted for Edam, 2% for Gouda and 1% for mascarpone. Cheddar was first made in the early 12th century by monks in the Somerset village that bears its

name.

They made cheese from the milk of their own cows using techniques learned from the Romans.

Cheese production, which became an essential income for many monasteries, allowed the monks to preserve excess milk, ensuring a steady supply of food in winter.

'trusted flavors'

Today Cheddar accounts for 51% of the UK's £1.9billion annual cheese market and is the second-most popular cheese in the US behind mozzarella, with an average annual consumption of 10lb. The survey, from consumer insight business Vypr, confirmed that Cheddar's versatility won through.

According to the poll, 54% chose Cheddar as their favourite sandwich cheese followed

by red Leicester. Mozzarella came third. Britons love to cook with Cheddar (37%). For salads, it again proved most popular on 27% while feta was second with 25%.

Ben Davies, founder of Vypr, said: "As a nation, we are passionate

about our cheese and it's reassuring for British producers that native varieties tempt our tastebuds the most.

"Cheddar, red Leicester and Stilton are all comforting. People often look for nostalgic and trusted flavours

when the wider world is in a state of insecurity."

More than 750 cheese are produced in the UK today. Technology means cheese can have a longer shelf life, allowing it to be sold all over the world.

Brave hearts just not enough for Scotland

■ Last-gasp Hungary goal sends Scots home early yet again

SCOTLAND huffed and puffed but ultimately fluffed their lines as Hungary broke Tartan Army hearts with a 100th-minute winner in Sunday's last group stage showdown.

Steve Clarke's men were bidding to qualify for the knockout stages of a major tournament for the first time, ending decades of hurt.

Yet, despite dominating possession, Kevin Csoboth snatched a winner in the 10th minute of stoppage time, ending Scotland's Euro 24 campaign with a whimper rather than a bang.

Earlier, tens of thousands of supporters flocked to Stuttgart in south-west Germany determined to stage a party like no other.

Throughout the day the spine-tingling anthem Sunshine on Leith

was belted out by Scots who remained defiantly optimistic.

Almost exactly 70 years ago, Scotland were battered 7-0 by Uruguay at the 1954 World Cup in the final group game as they attempted to reach the knockout stage of a major tournament.

Sadly, that dismal run continues. After a 5-1 thumping by hosts Germany in the tournament's opening match and a spirited 1-1 draw against Switzerland, all hopes rested on Sunday's clash.

But cometh the hour, Scotland fell flat, with the chance of reaching the last 16 dashed by a classic sucker punch.

The Scottish faithful had done their best to set the scene for quite a party, whatever transpired later.

Hours before kick-off,

panicked officials in Germany's industrial heartland – home of Mercedes-Benz and Porsche – were forced to expand the fan zone as a flood of Scottish fans arrived for the fixture.

The Stadtgarten hub near the Stuttgart Arena was bolstered in capacity

by an extra 2,000 – with a car park converted for spectators with two big screens.

A cacophony of noise reverberated across the city all day, with the Tartan Army in full voice, ably assisted by the stirring sounds of thousands of bagpipes and

drums.

It helped to create an unforgettable pre-match atmosphere.

But defeat means Scotland's dream lies in tatters.

Meanwhile, Germany won Group A after drawing 1-1 with Switzerland, who finished second.

England players' families 'hit by cups'

Defender Ezri Konsa says the families and friends of England players were hit by beer cups thrown "from all angles" after their goalless draw with Slovenia.

A couple of plastic cups were aimed in the direction of boss Gareth Southgate as he applauded them from the pitch after the Euro 2024 Group C stalemate on Tuesday.

According to Aston Villa's Konsa more were hurled around the stands in Cologne at full-time, with the section seating the players' friends and families affected.

Konsa said the players knew Southgate had been targeted but have "not spoken about it as players" or raised it with him.

It has been reported that the players' partners and friends were neither recognised nor deliberately targeted by those who threw the cups.

"We were aware of it because I think some of our family members got hit with a few drinks," he said.

"We check on them. There's kids in the stands with family so we always have to check on them, reassure them and ask if they're all right."

England topped Group C and will face Slovakia in the last 16 on Sunday.

Konsa said "in football stuff like that happens", when pressed further on the reaction of fans.

He added: "My brother was hit, a few others. I spoke to him after, I asked him and how he was and he said he was fine.

"It was to the right [of the stadium], it wasn't directly behind the goal, but it was coming from all angles. We try not to think about it too much so we move on."

India hammer England to end T20 World Cup reign

England's defence of the T20 World Cup is over after they slumped to a 68-run thrashing by a superb India in the semi-final in Guyana on Thursday.

Captain Jos Buttler gave them a solid start with 23 but his wicket was the first of four for 20 runs.

Phil Salt fell for five, Jonny Bairstow a three-ball duck and Moeen Ali eight from 10 balls.

When the superb

Kuldeep Yadav, who took 3-19, bowled Harry Brook for 25, England were 68-6 and the game done, although there was still time for two dismal run-outs.

Buttler's side were also guilty of allowing India to get to a score above par, although that was largely down to the

excellence of Rohit Sharma and Suryakumar Yadav.

They overcame a slow surface that also kept low in a fine partnership of 73 from 50 balls that took India to 171-7 - Rohit hitting 57 and Suryakumar 47.

India, who have not won a World Cup for

13 years, will play first-time finalists South Africa - a meeting of the tournament's two unbeaten sides in Barbados.

England flew home on Friday and are next in action in a three-match Test series against West Indies, starting on 10 July.

want to see is linked to the manager's message really. It has to be a consistent theme coming from the manager to give the players the belief and freedom to be able to do it."

"So many of our players, the Arsenal and Manchester City boys and Jude Bellingham at Real Madrid for example, are used to playing high-tempo and high-energy football on the front foot for their clubs, and that way of playing is drilled into them every day of the week.

"With England they are asked to play a different way because Gareth Southgate is a bit more cautious with his set-up. Here, it looks like many of them are trying to play in a way they are not used to and it is creating a lack of cohesion and lack of belief in what they are doing."

■ England defender Guehi defends Southgate; remains upbeat ahead of last-16 clash with Slovakia

England defender Marc Guehi says the team have been "doing a lot of work" on penalties as they prepare for the Euro 2024 knockout stages.

England finished top of their group to reach the last 16 and will play Slovakia on Sunday.

Asked if time had been spent on penalties, Crystal Palace centre-back Guehi said: "Yes, we've been doing a lot of work."

"The work's been going really well across the team on penalties. It's important to make sure we're ready."

England were beaten by Italy on penalties in the final of the last European Championship, having looked like they were improving in shootouts.

They beat Colombia on spot-kicks in the last 16 of the 2018 World Cup, while they also won against Switzerland on penalties in a 2019 Nations League third-placed play-off.

"It [practising penalties] is something we've been doing anyway, it was regardless of if we

went through or not," added Aston Villa player Ezri Konsa.

"It's something that we like to practise anyway. We've been practising them after training, a few players go off and practise penalties."

"Look, we're not thinking about going to penalties on Sunday, but if it comes to it, we'll be well prepared."

Meanwhile, Guehi said England manager Gareth Southgate has the full support of all players in his squad.

The England team were booed off following the goalless draw in their final group game with Slovenia on Tuesday and some empty cups were thrown at Southgate as he applauded supporters.

Guehi was handed his first senior England call-up by Southgate in March 2022 and has 14 caps. He has been Southgate's first-choice centre-back alongside John Stones at Euro 2024.

"He has been fantastic for England. If you look at his record, it speaks for

itself," 23-year-old Guehi said.

"Everyone is behind the manager and we have a really close tight-knit group just focused on the next game. Everyone appreciates him, especially me."

"He gave me my debut for England and he's showed so much confidence in me. I am really grateful and I'm sure the rest of the team is as well."

Southgate has said the reaction to the team's performances in Germany is creating an "unusual environment" for the squad, but Guehi says the players are not listening to any outside noise.

"I don't think the team is too focused on that," he said. "We are thankful for all of the fan support because they have travelled to see us."

"It is a calm and focused camp. Everyone is just focused on the next task at hand."

As a result of winning their group, England have a path through the knockouts which avoids many

of the other major nations.

Spain, Germany, Portugal, France and Belgium are all on the other side of the draw and England cannot play any of them before the final, but Guehi believes there is no easy route to the showpiece in

Berlin on 14 July.

"Everyone has seen in this competition that I don't think there is a favourable side of the draw," he said. "Every opponent is tough to play against."

"We just need to remain

calm. We put pressure on ourselves, but it's a very calm and focused environment. We just need to continue focusing on one thing at a time."

England play Slovakia on Sunday and kick-off is at 9am PST.

Still in it: but what must England do better?

THERE seem to be as many differing opinions as to England's football woes are there are England fans, but one thing all would agree on is that their team must start to create more chances in front of goal

Before Wednesday's games, England's average xG of 2.26 for their three group games – which measures the quality of chances created – put them 19th out of 24 teams. Their total shots of 29 and shot conversion rate of 6.9% ranked them 17th.

Former England striker Alan Shearer, speaking on The Rest Is Football pod-

cast, said: "The stats are pretty damning in terms of England creating chances. When you look at the talent we have got in forward positions – which we all thought was going to be one of our strengths – actually that hasn't fired at all yet."

"We can massively improve and we are going to have to."

Former England captain Gary Lineker, speaking on the same show, said: "I still seriously worry about the tactical approach of the team. Phil Foden is one of the best number 10s in world football. I think there is a lack of balance to the

team and I find it really, really strange that he doesn't play somebody on the left side that plays on the left side."

"I saw a little bit of spark in the players [against Slovenia] that if they do get the right set-up and play high, aggressively and brave, then I think they could do really well. Do I think he [Gareth Southgate] will play that way? No, I don't sadly."

Former England midfielder Danny Murphy was of similar mind, saying: "It is probably the urgency of our play, or lack of it. But that high tempo we all
