# Archbishop steps down after latest sex scandal

## Welby speaks of 'profound sense of shame' at Anglican church's failures on abuse

The archbishop of Canterbury is to step down amid intense pressure over his handling of one of the church's worst abuse scandals.

Justin Welby's decision, announced on Tuesday, comes after mounting demands from victims and members of the clergy for him to quit.

Pressure on him had intensified since the publication last week of a damning report on the Church of England's cover-up of abuse by Christian church camp leader John Smyth in the UK in the late 1970s and early 80s, and later in Zimbabwe and, it is suspected, South Africa.

About 130 boys are believed to have been victims of Smyth, a powerful barrister who died in 2018.

### Makin review

Welby's decision had looked increasingly inevitable following the publication last week of the Makin review report, which concluded Smyth could have been brought to justice had the archbishop formally reported it to police a decade ago.

Welby said his decision, which came five

days after the report was published, was "in the best interests of the Church of England, which I dearly love and which I have been honoured to serve".

The announcement came hours after Keir Starmer, the prime minister, refused to publicly back him. A petition started by three members of the General Synod – the church's parliament – had amassed more than 13,000 signatures calling for the archbishop to quit.

In a statement posted by Lambeth Palace, Welby, the spiritual leader of 85 million Anglicans worldwide, said: "Having sought the gracious permission of his majesty the king, I have decided to resign as archbishop of Canterbury."

"The Makin review has exposed the long-maintained conspiracy of silence about the heinous abuses of John Smyth. When I was informed in 2013 and told that police had been notified, I believed wrongly that an

appropriate resolution would follow.

### 'wholesale change'

"It is very clear that I must take personal and institutional responsibility for the long and retraumatizing period between 2013 and 2024."

The king approved Welby's resignation on Tuesday morning.

The archbishop said the exact timing of his departure was yet to be confirmed, adding: "I hope this decision makes clear how seriously the Church of England understands the need for change and our profound commitment to creating a safer church. As I step down I do so in sorrow with all victims and survivors of abuse."

"The last few days have renewed my long-felt and profound sense of shame at the historic safeguarding failures of the Church of England. For nearly 12 years I have struggled to introduce improvements. It is for others to judge what has

been done.

"In the meantime, I will follow through on my commitment to meet victims. I will delegate all my other current responsibilities for safeguarding until the necessary risk assessment process is complete."

Welby said last week he had considered resigning over his "shameful" decision not to act on reports of abuse by Smyth when he was informed of them in 2013.

Welby, who had public roles at the funeral of the late Queen and the coronation of King Charles, will have consulted his team of close and trusted advisers on whether or not to quit.

The bishop of London, Dame Sarah Mullally, said the move provided

"the urgent impetus we need to change the face of safeguarding".

But Andrew Graystone, author of *Bleeding for Jesus*, a book about Smyth's abuse, said the church needed "a wholesale change of culture at the top of the organization", with other clergy taking responsibility for failing to act.

He said: "At least 11 bishops knew about John Smyth's abuse, but failed to stop him. In addition there were literally scores of rank and file church leaders and members who stood by, feeling it was someone else's job to act. This is not about the incompetence of one man. It is a deep-seated cultural issue about the privilege in the church."

Smyth sadistically

abused private schoolboys who attended evangelical Christian holiday camps in the late 1970s and early 80s. Across five decades, he is said to have subjected as many as 130 boys and young men in the UK and Africa to traumatic physical, sexual, psychological and spiritual attacks, permanently marking their lives.

When the abuse was discovered, Smyth was allowed to move abroad with the full knowledge of church officials, where he continued to act with impunity.

He died aged 77 in Cape Town in 2018 while under investigation by Hampshire constabulary, and was "never brought to justice for the abuse", the Makin review said.

# We must mend fences with Europe on trade, says BoE governor

The UK must "rebuild relations" with the EU "while respecting the decision of the British people" who voted to leave in 2016, the Bank of England's governor has said.

Andrew Bailey's Mansion House speech to investors marked some of his strongest comments yet on Brexit, saying one of its consequences has been weaker trade.

He has previously avoided commenting on the topic because of the Bank's independence from Westminster politics.

"As a public official, I take no position on Brexit per se," he will say. "But I

do have to point out consequences."

Mr Bailey said the changed relationship with the EU has "weighed" on the economy.

"The impact on trade seems to be more in goods than services... But it underlines why we must be alert to and welcome opportunities to rebuild relations while respecting the decision of the British people."

## economic shocks

Mr Bailey added that the UK should not focus "just on the effects of Brexit", warning about the "broader fragmentation of the global economy".

His Brexit comments go much further than he previously has on the topic. Last November, he said the decision had "led to a reduction in the openness of the UK economy".

Assessing the impact of the UK's decision to leave the EU on the economy has been tricky given the multiple economic shocks in recent years.

The Office for Budget Responsibility and other independent analysts estimate the economy will take a 4% hit over 15 years as a result.

Goods trade, especially in food and farm exports, has been especially hit by the imposition of new trade barriers. Trade in

services, such as banking, has done better than expected, however.

The government remains opposed to rejoining the EU, but Prime Minister Keir Starmer and some EU politicians have said there could be a better relationship.

A UK government spokesperson said: "We are committed to resetting

our relationship with our European partners... and improving our trade and investment relationship."

Vicky Pyce, chief economic advisor to the Centre for Economics & Business Research, said Mr Bailey may have made his comments due to the election of Donald Trump as US president.

Trump made a repeated

campaign promise to levy a 20% tax on all imports of goods into the US, and a 60% tariff on Chinese imports.

Ms Pryce said if that were to happen "it is actually quite questionable whether the UK could have a special relationship with the US when it still trades quite substantially with Europe".

# Rabid anti-vaxxer gets jabbed with five years of bird

An anti-vaccination conspiracy theorist who encouraged violence against Prof Sir Chris Whitty on social media has been sentenced to five years in prison.

Patrick Ruane, 55, from Paddington, west London, was convicted of two charges of encouraging terrorism on social media in 2021, following a trial at the Old

Bailey.

Ruane believed in conspiracy theories about the government having a "hidden agenda" to the coronavirus epidemic which he shared with thousands of users in Telegram groups, the trial heard.

His posts referred to "serious violence" including the use of explosives such as Semtex as

well as criminal damage and the disruption of electronic communication systems, said the prosecution.

Ruane had suggested "whacking" the Chief Medical Officer for England, Prof Sir Chris Whitty, and referred to executing politicians.

Sentencing him on Monday, Judge Richard Marks KC said the

"overwhelming view" around the world was that the vaccines were highly effective in saving lives.

"You and others, however, did not share that opinion," he said.

The judge said Ruane was entitled to publicly vent his views, but he had gone "much further" and in so doing had committed these offences.

Judge Marks said Ruane was encouraging the readers of his messages, many of who he believed were anti-vaxxers like himself, to use violence to frustrate the manufacture and use of vaccines.

What Ruane did was "extremely dangerous" as it would have only taken one person to act on what he had advocated - given the "volatile and vulnerable" mood of many people during a time of exceptional difficulty, the court heard.

"You had developed a compulsive and obsessive mindset about

the vaccine," said Judge Marks.

In mitigation the court heard Ruane had mental health issues from childhood trauma and had alcohol dependence.

The defendant claimed he had no memory of sending the messages as he was "blind drunk" every day at the time.

But Judge Marks said the defendant had exaggerated the extent of his drinking.

Ruane was also sen-

tenced to a one-year extended licence period.

## EPL ref suspended amid allegations of 'anti-Liverpool' bias

Premier League referee David Coote has been suspended after a video allegedly showing him making derogatory comments about Liverpool and the club's former manager Jurgen Klopp was circulated on social media.

Refereeing body PG-MOL says the suspension comes into force

with immediate effect and is pending a full investigation.

In the video, widely shared on social media, the man alleged to be Coote says Klopp had "a right pop at me when I refed them against Burnley in lockdown". He calls Klopp arrogant and also swears several

# RIP Timothy West

**Veteran actor enjoyed a 'long and extraordinary' life and career on television, stage and screen**

**Timothy West, one of Britain's most distinguished and versatile actors, has died at the age of 90, his family have announced.**

He was known for roles on stage and screen including in TV sitcoms Not Going Out and Bedtime, dramas such as Bleak House and Gentleman Jack, and soaps Coronation Street and EastEnders.

A statement released by his children said the actor died "peacefully in his sleep" and was "with his friends and family at the end".

The actor is also survived by his wife, Fawltly Towers star Prunella Scales, to whom he was married for 61 years.

In recent years, the couple had been followed in 10 series of Channel 4's Great Canal Journeys. Scales has had vascular dementia for more than 20 years.

Dame Joanna Lumley said: "Timothy really will be a huge loss, obviously, to Pru, but I think a huge loss to everybody who came to love and respect them, not just the general public, but particularly those who live with dementia.

"I think between them,

Timothy and Pru did an amazing job of convincing people that dementia was not something that you should be always afraid of, but something that you could embrace and live with and live well," she added on Times Radio.

## 'Wonderful man'

Broadcaster Piers Morgan recalled interviewing West for his Life Stories series with the actor's wife Scales sitting in the audience.

"[She was] the love of his life... his devotion to her after she developed Alzheimer's was profoundly touching," Morgan said.

Paying tribute, Dame Harriet Walter, who played West's on-screen wife in the 2002 film Villa des Roses, said: "We had a lot of giggles, but he was also a very serious, wonderful man."

In their statement, Juliet, Samuel and Joseph West described their father as having had a "long and extraordinary life on and off the stage".

West leaves "a sister, a daughter, two sons, seven grandchildren and four great-grandchildren", the family said, adding: "All of us will miss him terri-

bly.

West was born in 1934 in Bradford, the son of actors Lockwood West and Olive Carleton-Crowe.

He began his career in entertainment as an assistant stage manager at the Wimbledon Theatre.

He made his name on stage and screen in the 1960s, and in TV adaptations of Richard II and Edward II in the 1970s, which saw him reprise roles he had already played to critical acclaim in the theatre.

On the big screen, he played a member of the French intelligence service in the 1973 film adaptation of Frederick Forsyth's The Day of the Jackal.

## A Favorite Churchill

His lead TV roles included 1980s comedy-drama Brass, in which he played ruthless self-made businessman Bradley Hardacre.

He starred in Lynda La Plante's 1992 crime drama Framed, and was film-maker Frank Sheringham in 1994 children's TV series Smokescreen.

In Not Going Out, the British sitcom created by Lee Mack which has been running since 2006, West played Geoffrey, the father of Lucy Adams (played by Sally Bretton).

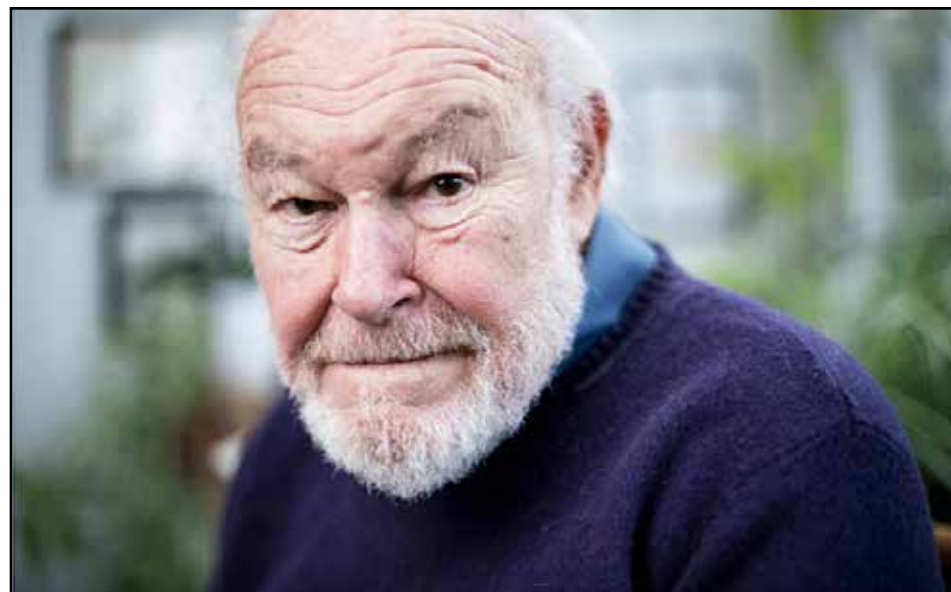

## Al Fayed brother also accused of multiple rapes

One of Mohamed Al Fayed's brothers also abused women who worked at the Harrods department store, according to three ex-employees who have made allegations including sexual assault and trafficking to the BBC.

The women allege that Salah Fayed abused them in London, the south of France and Monaco between 1989 and 1997. One woman believes she was raped by Salah after she was drugged.

All three women say they were also sexually assaulted or raped by Mohamed Al Fayed, then chairman of the company.

Harrods, which came under new ownership in 2010, said in a statement that the new claims point to the "breadth of abuse" by Al Fayed and "raise serious allegations" against his brother.

Salah Fayed, who died of pancreatic cancer in 2010, was one of three Fayed brothers who purchased the luxury Knightsbridge department store in 1985. Mohamed added the Arabic "Al" prefix to his surname some time in the 1970s.

One of the three women, Helen, has waived her right to anonymity. She was 23 and had been working at her "dream" job in Harrods for almost two years when Mohamed Al Fayed raped her in a Dubai hotel room.

Months later, when Mohamed offered her some personal assistant work with his younger brother, she saw it as an escape route - but instead she says she was drugged by Salah and believes she was then raped by him while unconscious.

"He [Mohamed Al Fayed] shared me with his brother," she says.

# Lineker to vacate MOTD hotseat

Broadcaster Gary Lineker is to step down as host of flagship football programme Match of the Day at the end of this season.

His departure was announced officially by the BBC on Tuesday.

The presenter's swansong will be leading coverage of the 2026 World Cup in the US, Canada and Mexico.

Reporters suggest Lineker was open to staying on at Match of the Day, but the BBC did not offer him a new contract for the show. Observers suggest the reason for his departure was likely a combination of his high salary and his often outspoken comments on social media.

The 63-year-old has hosted Match of the Day since 1999. He will have held the post for 26 years when he leaves at the end of the Premier League season in May 2025.

Lineker told Esquire

magazine in an interview published earlier this month that he accepted he will "have to slow down at some point".

### Big earner

Earlier in the year, the presenter joked about speculation he could leave the BBC. He opened a Match of the Day broadcast by saying it was his "final show". After a pause, he added "before the international break".

Lineker is one of the corporation's best-known presenters and its highest-paid star, of those whose salaries are declared, earning more than £1.3m a year.

He has also presented coverage of major tournaments like World Cups and European Championships for the BBC, as well as BBC Sports Personality of the Year ceremonies.

### 'a very good guy'

Lineker has worked for other sports networks

during his time at the BBC, including US network NBC and BT Sport (now TNT Sport). He has also branched out into podcasts, co-founding production company Goalhanger, which makes popular shows including The Rest is History, The Rest is Politics and The Rest is Entertainment.

Alastair Campbell,

who co-presents The Rest Is Politics podcast, said Lineker would be "a very hard act to follow", Sky News reported.

"He is an excellent broadcaster and a very good guy," Campbell said.

Lineker's new contract has now been agreed and he will leave on a high at the biggest tournament

in world football. But replacing a star presenter on a high profile show is always a risk.

Some fans have suggested Match of the Day 2 host Mark Chapman should step into the role, but other football presenters including Gabby Logan and Alex Scott are also on fans' lists as possible successors.

# Charles leads the nation in honoring the fallen on Remembrance Sunday

Tens of thousands of veterans and civilians joined the King in paying their respects to the fallen at the annual National Service of Remembrance ceremony at the Cenotaph in central London on Sunday.

by other members of the Royal Family, including the Prince and Princess of Wales, and political leaders.

Events to mark Remembrance Sunday - observed on the closest Sunday to Armistice Day - took place around the country.

The King laid the first wreath on behalf of the nation. Dressed in the Royal Navy uniform of the Admiral of the Fleet, he saluted after stepping back from the Cenotaph.

The King was fol-

lowed by Queen Camilla's equerry, Major Ollie Plunket, laying a wreath on her behalf as she is currently recovering from a chest infection.

Starmer and the country's other political leaders.

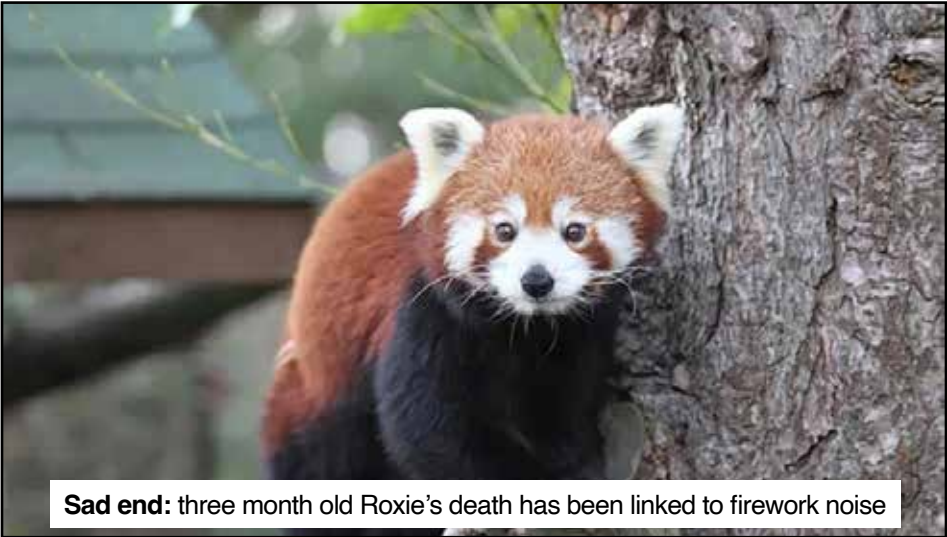
There were also a number of representatives from the new Labour government, including Home Secretary Yvette Cooper and Foreign Secretary David Lammy.

# Baby red panda dies from Bonfire Night stress

Edinburgh Zoo's baby red panda has died from stress caused by fireworks on Bonfire Night, according to veterinary experts.

The Royal Zoological Society of Scotland (RZSS) said three-month-old Roxie choked on her own vomit as pyrotechnics were being set off across the city.

Roxie's mother Ginger also died unexpectedly five days earlier, and vets say they cannot rule out this also being linked to firework noise.

The zoo is now joining with animal welfare charities and other campaigners in calling for tighter restrictions on fireworks.

Red pandas are native to the eastern Himalayas and south western China

but have become an endangered species, mainly due to habitat loss, human interference and poaching.

Roxie was born in July, taking the number of captive red pandas at Edinburgh Zoo to four, and a fifth arrived in Scotland from Whipsnade zoo in October.

But on 31 October, RZSS, which runs Edinburgh Zoo, announced the death of nine-year-old Ginger, and her kit Roxie died five days later.

New powers banning the use of fireworks came into force in four areas of Edinburgh between 1-10 November - though this did not include the area around the zoo.

Ben Supple, RZSS deputy chief executive, said

baby Roxie had access to her den on Bonfire Night but the "frightening noises" appeared to have been too much for her.

He said: "Roxie had recently lost her mum Ginger but was responding well to specialist care from our expert team and was feeding independently.

"Very sadly, she choked on her vomit on Bonfire Night and our vets believe this was probably a reaction to fireworks.

"We know that fireworks can cause stress to other animals in the zoo and we cannot rule out that they may have contributed to the untimely death of Roxie's mother Ginger, just five days' earlier."

# Glasgow's famed magic shop to disappear after 138 years

A historic Glasgow joke shop, which claims to be the world's oldest family-run magic and joke store, has closed after 138 years.

Tam Shepherds Trick Shop in Queen Street has been run by the same family since 1886 but will now operate exclusively online.

The attached buildings - formerly the site of the Archaos nightclub - are set to be re-developed into student flats.

The shop's owners cited "uncertainty over the redevelopment" and "high costs of being a small independent shop in the city centre" as the reasons for closure.

In a statement posted to social media, they said: "We are sad to announce that Saturday 9 November 2024 was the

last day of trading from our long established bricks and mortar shop in Queen Street.

"Tam Shepherds will continue with our online shop supplying customers with our range of magic, tricks, jokes and costumes.

"To all our customers and friends, thank you so much for your continued custom and support. We hope to welcome you back in the future.

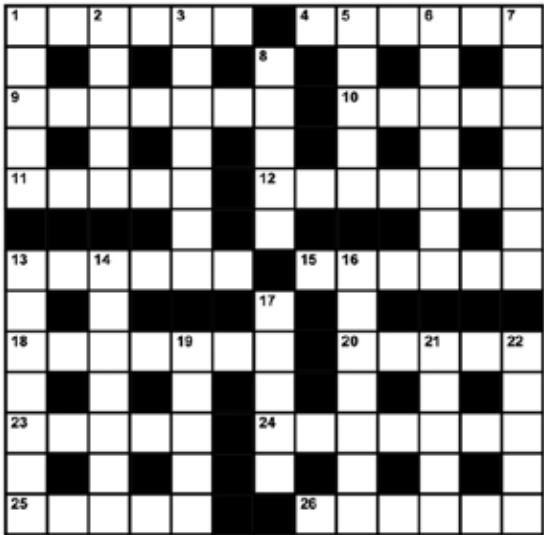
"And thank you to Glasgow for making Tam Shepherds the shop it has been."

In August, Glasgow City Council city planners approved proposals from developers Carrick Properties and CA Ventures for a 14-storey block of student accommodation, encompassing 21-41 Queen Street. The new block is set to include 195 beds, a cinema, gym and games lounge.

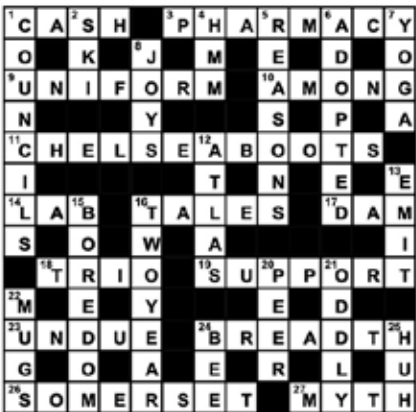

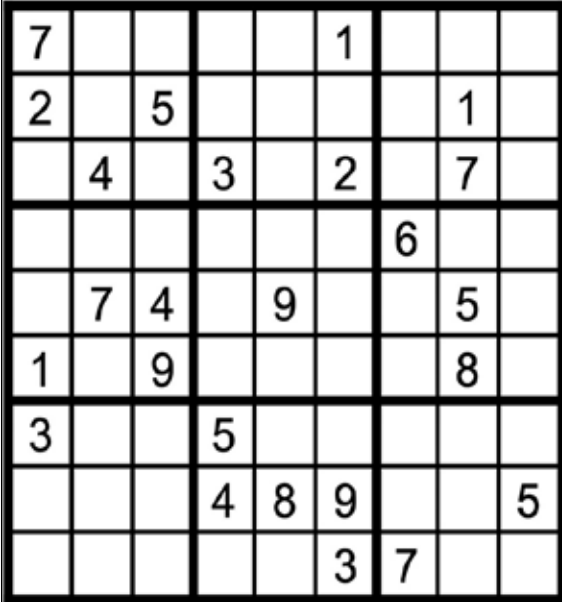

# Off the Meseta and into the hills

Ten Weeks on the Camino: as the final stages draw near, Nick Stark leaves the plains and climbs into the Montes de Leon

## Leon to Villa del Mazarife (21 miles)

After an indulgent dive into the gastronomic treats of León we reluctantly hoisted our backpacks and headed west, out towards Mazarife and then Astorga. This section marks the end of the Meseta, the large and mostly featureless plateau that occupies about 135 miles at the Camino's center. The 21 miles to Mazarife was a mostly bland trudge through the plain's final dusty margins, and the town itself was notable only for our albergue, Casa Tio Pepé (Uncle Pepé's House), a traditional bar/restaurant/motel combo presided over by an eponymous avuncular Spaniard. He and his harried assistant checked in a stream of tired pilgrims, served us cañas (small draft beers) and showed us to our rooms with unfailing good humor, and managed to feed us a

very respectable seafood paella before we drifted off into the land of nod.

## Villa del Mazarife to Astorga (19 miles)

Our destination the next day was Astorga, home to the Episcopal Palace - another Gaudi masterpiece, and something just as important to me - the town is considered the chocolate capital of Spain and even has its own museum devoted to this most important of commodities.

By now September had turned to October and although the sunny but coolish weather was still holding, we had experienced some rainy and windy days, a harbinger of what was to come as we entered Galicia a few days later. The 19-mile walk was punctuated by the charming village of Villavante, where we stopped for the requisite Spanish Elevenses of café con leche and a slice of

tortilla española, and the picturesque town of Hospital de Orbigo, famed for Romanesque bridge which once spanned a wide and raging river, now sadly reduced through flood control upstream to a feeble little rivulet.

We enjoyed both spots but we didn't linger. We were eager to get to Astorga and as we entered its Old Town and passed of its countless outdoor bars we spied a couple of faces we recognized from our travels, including Kevin, a gregarious 72-year-old from Derbyshire who greeted me with an 'hey-up me duck' as we walked by. This was not our last encounter with this very dear fellow, who became a firm part of our 'camino family', as the temporary but firm friendships you make here are known.

begin a gradual incline as you head towards the Montes de Leon mountain range. You climb from about 2500ft to a high of about 5,000 as you make your way to the famed Cruz de Ferro. Although the elevation is far lower even than many Southern Californian mountains, plodding uphill in mist and rain with a pack on your back while dodging the ubiquitous horse droppings is far from a walk

in the park. By the time you reach Foncebaddon, a hill town which seems exclusively made up of lodgings, you're ready for a warm drink and a hot meal. We certainly were.

A side note here: Spain doesn't observe daylight savings time. Back in 1940 when the dictator Francisco Franco wanted to curry favor with the all-conquering Germans, he synchronized Madrid's time zone to that of Central Europe - specifically Berlin. Where it stays to this day. In practical terms this means the sun rises and sets an hour later than in countries along the same longitude, such as the UK. It certainly suits the locals, who are notoriously late-night creatures, but for us, having our breakfast and setting out for a walk at 8.15am in the pitch dark, it took some getting used to. Especially in Foncebaddon, which was fogged in under rainy skies as we left, headlights set to high beam!

## Foncebaddon to Molinaseca 12

There are several notable landmarks on the Camino which impart some meaning or other to pilgrims, depending on your depth of belief. The Cruz de Ferro is one of them. Located just

outside Foncebaddon, its tall cross atop a mound of stones marks the high point of the journey and is a place to stop and consider the purpose of journey through the Camino - and through life. The guidebooks suggest you bring a pebble from your hometown or some other token of your past life, and leave it here, along with all your regrets, shame and other baggage that no longer serves you. We did just that, but we didn't linger at the summit. There was one very animated Brazilian lady loudly and tearfully Facetimeing a loved one back home, and she was displaying more than enough emotion for us both. So we took a couple of pictures and moved on, happy to anticipate a gentle downhill slope towards the charming town of Molinaseca.

Silly us. One thing we learned from our first day on this trip is that up is much easier than down. Burning quads and glutes are one thing, but aching bones, connective tissue, cartilage and tendons are another thing entirely. The gentle downhill we had hoped for was instead a rocky, stony, wet, slippery and treacherous three-hour ordeal which we just about negotiated

It was a good reward for a challenging day.

# Kane unhappy with England flakes

■ Country should come before club, insists captain

Captain Harry Kane is unhappy with the number of players who have withdrawn from the latest England squad, insisting “England comes before club”.

Nine players have dropped out of the squad for Lee Carsley’s final two matches as interim manager before Thomas Tuchel takes charge in January.

Speaking ahead of Thursday night’s must-win clash with Greece,

Kane told reporters: “I think England comes before anything. England comes before club.”

“England is the most important thing you play as a professional footballer and Gareth [Southgate] was hot on that and he wasn’t afraid to make decisions if, you know, that started to drift from certain players.”

When asked if the desire to play for England has drifted this interna-

tional break, Kane said: “Yeah, it’s a shame this week obviously.”

“I think it’s a tough period of the season, maybe that’s been taken advantage of a little bit.”

“I don’t really like it if I’m totally honest. I think England comes before anything, any club situation.”

and Levi Colwill have dropped out.

Everton’s Jarrad Branthwaite was one of the replacement players called up to the squad, until he became the ninth player to withdraw.

But interim boss Carsley remained upbeat ahead of the match,

which England won, 3-0.

“It’s important we make the most of the situation. With the amount of players that have pulled out, it gives an opportunity for the players that are here,” Carsley said.

“With the amount of pull-outs we’ve had in

this window, historically it’s been like that in the past. November has always been a challenging window.”

England must still beat the Republic of Ireland at Wembley on Sunday if they are to be promoted to League A of the Uefa Nations League.

## McIlroy ‘would pay to play’ in Ryder Cup

“I don’t think any of the 24 players on either team needs that 400 grand”

Rory McIlroy says he would “pay to play” for Europe in the Ryder Cup in the wake of reports that American golfers will each receive \$400,000 (£350,000) to compete in next year’s contest.

McIlroy was one of several European stars who said they do not need financial rewards to compete in the biennial match against the United States.

Last year’s contest in Rome was marked by Patrick Cantlay refusing to wear the American team cap in an apparent protest at the fact that the players were not being remunerated to appear.

But it emerged this week that a deal has been struck with the PGA of America, subject to board approval, that would lead to each player in Keegan Bradley’s team receiving an equal split of \$4.8m.

“I personally would pay for the privilege to play on the Ryder Cup,” McIlroy said after firing a five-under 67 to share the lead after round one

of the season-ending DP World Tour Championship in Dubai.

“The two purest forms of competition in our game right now are the Ryder Cup and the Olympics, and it’s partly because of that, the purity of no money being involved.”

The American move comes at a time when prize money in men’s professional golf has reached record highs in response to the arrival of the lucrative Saudi Arabia funded breakaway LIV circuit.

“I don’t think any of the 24 players on either team needs that 400 grand,” McIlroy said. “Every two years, there are 104 weeks and 103 weeks you can play golf and get paid.”

Cantlay’s refusal to wear a cap in Rome led to European fans removing their headwear to taunt the American player.

It ultimately led to a spat between McIlroy and the US golfer’s caddie Joe LaCava that spilled into angry scenes

in the clubhouse carpark.

“It was a discussion that was happening in Rome,” McIlroy added. “I can see the other side of the argument because the Ryder Cup does create a lot of revenue.”

“It is one of the probably top five biggest sporting events in the world. So I get the argument that the talent should be or could be getting paid.

“But the Ryder Cup is so much more than that, especially to the Europeans and to this tour.”

The continental team represents the DP World Tour - formerly known as the European Tour, while the US side is administered by the PGA of America, the body that represents the country’s club professionals.

McIlroy said that he and his team-mates in captain Luke Donald’s side have no interest in being paid.

“We have all had a conversation with Luke about it over the past few weeks because we obviously heard,” McIlroy revealed.

# England back in the driver's seat

Nations League: Carsley's second string impress in 3-0 away win in Athens

England can return to the top tier of the Uefa Nations League with victory over the Republic of Ireland at Wembley on Sunday after overcoming Greece in impressive style in Athens.

Lee Carsley's side gained revenge for the debacle of a defeat to Greece at Wembley in October, with an emphatic 3-0 win in Athens on Thursday - made even more satisfying for the interim manager after his squad was decimated by withdrawals.

The margin of victory ensured England have a better head-to-head record against Greece after their 2-1 loss at Wembley, leaving the Three Lions' fate in their own hands.

Ollie Watkins justified his selection ahead of captain Harry Kane when he put England ahead after only seven minutes, turning in Noni Madueke's cross after the Chelsea winger's fine run.

England goalkeeper Jordan Pickford excelled in the rare moments of Greek pressure and the three points were secured in style late on.

The second goal had a hint of fortune when Jude Bellingham's shot hit a post and ricocheted into the net off Greece keeper

Odyseas Vlachodimos after 77 minutes.

However, the third goal, six minutes later, was a flash of individual brilliance from Liverpool's Curtis Jones, who marked his debut by scoring with a stunning flicked finish from Morgan Gibbs-White's cross.

Jones has been increasing his claims for a full England cap with an impressive season at Liverpool, so it was a dream night for the midfielder when he not only finally made his full international bow, but crowned it with a moment laced with confidence and genius.

England were already on their way to the win as silence descended on the packed Olympic Stadium in Greece, leaving Liverpool-born Jones to provide the perfect ending to a hugely satisfying evening.

Jones had already shown several pieces of sleight of foot, as well as composure in possession, but there was rare audacity about the manner in which he flicked a finish across Greece keeper Vlachodimos with the inside of his right heel from Gibbs-White's delivery.

England went into this game surrounded by questions, as well

being threatened with the possibility of a play-off unless they secured the right result against a Greece side who were so much their superiors in October.

Carsley's bold move to leave Kane on the bench paid off, while he was also able to give first caps to Newcastle United left-back Lewis Hall, on at half-time for Aston Villa's Ezri Konsa, and fellow Villa player Morgan Rogers, who was introduced in the second half.

England controlled large portions of this game, but it still required Pickford to show once again how valuable he is, especially with a fine second-half save from Fotis Ioannidis with the score 1-0.

Carsley's final game is against the Republic of Ireland on Sunday, and he has now opened up the opportunity to allow his successor Thomas Tuchel to avoid a Nations League play-off.

Bellingham has been short of his brilliant best for club and country in recent times, but this was a reminder of why the 21-year-old is such a prized possession for Real Madrid and England.

Bellingham's swagger was back from the

first minute, roaming into dangerous positions to trouble Greece, who found it almost impossible at times to track his movement.

He set Madueke clear for the run the led to Watkins' opener, then it was

his shot that bounced in off keeper Vlachodimos to stop Greece in their tracks just when they threatened to gain momentum to give encouragement to the huge and vociferous home crowd.

Greece were a shadow

of the side that outplayed England at Wembley but Carsley and his players, who have endured some uncomfortable moments recently, deserve credit for the way the carved out this fully-merited win.
