Trump rebuffs PM's appeal on Ukraine

■ President also refuses to commit to helping in event of Russian attack on UK forces in Ukraine, saying "they don't need much help"

PRIME Minister Keir Starmer came away mostly empty-handed from his Oval Office meeting with President Trump on Thursday, failing to secure a security pledge to secure Ukraine's future existence.

Mr. Trump did suggest that a minerals deal with Ukraine is the security guarantee Kyiv needs against Russia, brushing aside a plea from Starmer for a commitment of U.S. military support.

Starmer, who was meeting Trump at the White House for the first time since the U.S. leader took office, turned on the charm, saying peace in Ukraine had only become possible because of Trump.

Starmer also delivered an invitation from King Charles for a future state visit, which Trump accepted.

But underlying differences between the allies remained, including transatlantic frictions over U.S.-Russia talks aimed at ending the Ukraine war and Trump's tariff threats.

Before the meeting, Starmer had said there could be no long-term peace in Ukraine without

firm U.S. security guarantees - an argument Trump all but dismissed.

"We are a backstop because we'll be over there, we'll be working," as a result of the economic partnership, Trump said. "We're going to have a lot of people over there."

State visit

Trump also backpedalled on one of his more controversial recent statements. Asked by the BBC's Chris Mason about his use of the word "dictator", to describe President Zelensky, Trump replied: "Did I say that? I can't believe I would say that."

In the news conference later, Trump also appeared to have softened his attitude to Zelensky, praising him as "very brave" and saying the pair got on "really well".

Sir Keir did briefly take his host by surprise, reaching inside his jacket

pocket midway through some opening remarks and pulling out an official letter from King Charles III - an invitation for a second state visit.

Trump appeared to be genuinely taken back for a few seconds, asking: "Am I supposed to read it right now?"

After taking a minute to read the letter, Trump said he accepted the invite and that it would be an "honour" to visit the "fantastic" country.

He added that King Charles was a "beautiful man, a wonderful man".

During Trump's first term as president, he met King Charles's mother, the late Queen Elizabeth II, during a three-day state visit in 2019.

'beautiful' accent

While cordial, the initial meeting in the Oval Office between Sir Keir and Trump left no doubt that the US president hoped to

be firmly in charge.

The meeting was a pattern we've now seen six times with foreign leaders at the Trump White House, including with French President Emmanuel Macron earlier this week: Trump taking control of the room and using the opportunity to get his own messages, both domestic and international, across to the reporters

there.

A joint afternoon news conference later began with a slightly more diplomatic and matter-of-fact tone, with both Trump and Sir Keir standing at their respective lecterns and going to considerable lengths to lavish praise on the other.

Trump joked he would have been president 20 years ago with Sir Keir's

"beautiful" accent.

At one point, Sir Keir was asked about Trump's controversial call to make Canada - a member of the Commonwealth - the 51st state of the US.

"I think you're trying to find a divide that doesn't exist," Sir Keir replied.

Trump interjected quickly with the words "that's enough" before

moving on – again taking control of the room as he stood next to a visibly surprised Sir Keir.

Asked to name similarities between the two men, Trump said: “He loves his country, and so do I.”

What else do they share? Trump said “we like each other, frankly, and we like each other’s country”.

Sir Keir had a number of tricky topics to raise with Trump - from trade to US security guarantees for Ukraine - and at the beginning of their news conference he called his counterpart “a very tough negotiator”.

‘advanced technology’

Asked if the prime minister had convinced him not to impose trade tariffs on the UK, Trump said “he tried”, adding: “He was working hard, I’ll tell you that. He earned whatever the hell they pay him over there.”

But he has said there was “a very good chance” of a trade deal “where tariffs wouldn’t be necessary”.

Such a deal, Trump said, could be made “pretty quickly”.

Sir Keir spoke of a “new economic deal with advanced technology at its core”.

But perhaps the most surprising part of meeting came when the President was asked if, in the event of British peacekeeping forces in Ukraine coming under attack from Russia, if they could count on American support.

“I don’t think they need much help, frankly,” said the President, to the astonishment of most of those present.

If Starmer was shocked by that response, he quickly recovered, as another journalist raised the issue of the Munich Security Conference last week, where US Vice President JD Vance attacked the UK and other European democracies, warning that “free speech is in retreat.”

Asked about the comments, Trump called on his deputy to defend himself. Vance argued “there have been infringements on free speech that actually affect not just the British” but also “American technology companies and by extension, American citizens”.

That led to Sir Keir cutting in, saying “we’ve had free speech for a very, very long time in the United Kingdom - and it will last for a very, very long time”.

He rejected Vance’s claim, saying “in relation to free speech in the UK, I’m very proud of our history there”.

Charles goes for a Burton

■ King proves he’s ‘sup’ to the job when asked to pull a pint at historic brewery

THE King proved he was sup to the job when tasked with pulling a pint on a visit to the brewing capital of Britain on Tuesday.

Charles poured – and then enjoyed – a glass of Gone for a Burton at family-run Tower Brewery in Burton upon Trent, Staffs, which makes a quarter of the UK’s beer.

The mid-strength ale is one of Tower’s special brands. Owner John Mills said of the King’s pint with its foamy head: “Are you going to have a slurp of that, Sir?”

Charles chuckled, noting if not he was “in the wrong place”, adding: “To your very good health,” before taking a sip.

Mr Mills also told the monarch about the 41% proof liquor, The Spirit of Burton, he had made with a colleague – a distilled version of one of his strong IPAs.

The King sniffed the clear liquid, took a sip and declared: “Mmmm.. interesting”, adding with a laugh: “Yes, it’s super-charged.” He was given a bottle of The Spirit of Burton and a 1902 King’s Ale, brewed by newly crowned Edward VII at the Bass brewery.

Charles’ great-great-grandfather started the mash, which involved 400 casks of 36 gallons, and the beer was stored to mature.

Some was released in 1905 and 1911, then in 1977 every employee was given a bottle to mark Bass’s 200th anniversary.

The King earlier walked through a mechanical guard of honour at JCB World Headquarters in near-

by Rocester, Staffs. He wished the company “many happy returns” on its 80th anniversary – the world-famous construction equipment company was granted a Royal Warrant this year.

Charles was given a tour by billionaire chairman Lord Bamford and fixed a wheel on a digger – production team leader Becky Bayliss, 32, judged his effort as “perfect”.

He later helped fuel up a new backhoe loader with hydrogen and greeted 100-year-old Ken Harrison who worked on the original factory floor when it opened in 1945.

Charles told Ken, who worked for JCB for a total of 36 years: “Are you sure you should be here today? I’m very impressed.”

“It must have done some good, I must say, to get to 100. I hope you got your message on your 100th birthday? I’m so glad the system works.”

A total of 3,500 staff, most of the workforce, lined up outside waving Union flags and cheered the King as he left.

PM blasts ‘Putin’s poodle’ Farage over defence spending

SIR Keir Starmer has accused Nigel Farage of “fawning over Putin” after the Reform UK leader failed to appear at a Commons debate about extra defence spending.

It came as Mr Farage and his MPs were described as “Putin’s poodles” after just one of the five, former Tory party deputy chairman Lee Anderson, turned up to hear the Prime Minister announce the boost.

Sir Keir said: “Nigel Farage didn’t turn up to the debate in Parliament today.

“Nigel Farage is fawning over Putin.

“That’s not patriotism.

“That is not what working people need.

“What I have done is take the duty of Prime Minister seriously, which is to ensure that our citizens are safe and secure, and this decision is made to ensure they are safe and secure.”

Stephen Flynn, the SNP’s leader at Westminster, said: “Aside from a few of Putin’s poodles who are not in their seats in the chamber here today, we are of course united in our support for the people of Ukraine.”

But Mr Anderson hit back over the “outrageous accusations”.

The Reform MP for Ashfield blasted: “Today, the bewildered-looking leader of the SNP stated that none of us Reform UKs were present.

“For the record – I’ve spent nearly four hours in the Chamber already today.

“I called this nonsense out earlier.”

Tate brothers flee Romania in dead of night, seeking safe haven in Florida

■ Romania's U-turn on freeing the influencers, who enjoy big support in US right-wing circles, raises eyebrows at home and abroad

Controversial influencer Andrew Tate and his brother Tristan landed in the US on Thursday after leaving Romania, where they face charges of rape, trafficking minors and money laundering, all of which they deny.

Questions remain about why they were allowed to travel and what happens next with their legal cases.

Andrew Tate, 38, and his brother Tristan, 36, are dual US-UK citizens who claim to have made millions from their social media empire. Their online output was controversial even before their legal troubles, with the pair attracting frequent criticism over offensive statements

about women.

The pair have an American father who worked for the US Air Force in Britain. Their parents met in the UK before moving to the US.

After their parents divorced, their mother moved to Luton, England. The brothers spent time in the UK, where they built their early careers.

radicalization

Police in the UK have linked Andrew Tate to the "quite terrifying" radicalization of boys and young men in a 2024 report into violence against women and girls.

The brothers were first arrested in Romania in 2022. They are fac-

ing separate, unrelated charges of rape and human trafficking in the UK. Both brothers also deny the charges against them in the UK.

The brothers had been under a travel ban in Romania for more than two years while they were under investigation.

Speculation that they would leave Romania had been mounting ahead of their journey, after the pair went quiet on social media.

They left from a Bucharest airport under cover of darkness at around 03:00 local time (05:00 GMT) on a private jet bound for Florida, sources said.

Prosecutors said the

travel ban had been lifted, and the pair's US passports had been returned to them, but investigations into their alleged crimes have not been dropped and they are expected to return to Romania.

The Tates have a large US following and are popular figures among some elements of the American right.

Earlier in February, some of Andrew Tate's alleged victims said they were "extremely concerned" by reports that US officials had asked for his travel restrictions to be relaxed.

'pressure'

It came after US special envoy Richard Grenell raised the Tate brothers with Romania's Foreign Minister Emil Hurezeanu at the Munich Security Conference.

Hurezeanu said he had not considered Grenell's approach as a "form of pressure". Grenell told the Financial Times his support for the brothers was evident.

The Tates have been vocal supporters of US President Donald Trump, while his close adviser, Elon Musk, restored Andrew Tate's account on X after he bought the social media platform in 2022.

The cases against the

Tate brothers in Romania are now being rewritten by prosecutors, who allowed them to leave the country on the condition that they return - possibly as early as the end of March.

The pair's request to leave the country was accepted, prosecutors said, but their request for the charges against them to be dropped was rejected.

The brothers face a number of civil and criminal legal cases.

The pair were charged with human trafficking and rape along with two Romanian female suspects in June 2023. They deny the charges.

They face separate, unrelated charges of rape and human trafficking in the UK. Last year, a Romanian court ruled they could be extradited to the UK after their case in Romania concludes.

A separate, civil case has been opened against the Tates in the US.

Separately, lawyers for four women who claim they were assaulted by the Tates said they were bringing a civil case against him at the High Court in the UK for "damages for injuries they suffered as a result".

A representative for the Tate brothers said in response that they "un-

equivocally deny all allegations".

A separate civil case in the UK, which the brothers are contesting, accuses the brothers and a third individual of being serial tax evaders.

Four women who allege they were sexually abused by Andrew Tate have said they are in "disbelief and feel re-traumatized" by news of him leaving Romania.

In a joint statement, the four said: "It is clear that he will now not face criminal prosecution for his alleged crimes in Romania; he will use it as an opportunity to harass further and intimidate witnesses and his accusers, and he will continue to spread his violent, misogynistic doctrine around the world."

They also urged British authorities to "finally take action, do something about this terrifying unfolding situation and ensure he faces justice in the UK".

Matthew Jury, a lawyer representing the four alleged victims, said the Trump administration was "interfering in due process" in Romania and the UK.

He added he didn't think the Tate brothers would "ever face justice in Romania now".

UK's youngest terror suspect 'fixated' on Hitler, inquest told

■ 16 year old autistic girl 'groomed' by American neo-Nazi

A Nottingham schoolgirl who was groomed online by a far-right extremist in the US became "fixated" on Adolf Hitler and wanted to "blow up a synagogue" before she took her own life, an inquest has heard.

Rhianan Rudd, 16, downloaded bomb manuals, guides on guerrilla warfare and media glorifying white supremacy and Nazism, Chesterfield Coroner's Court was told.

Her mother referred her to the deradicalisation programme Prevent - but she was later arrested by counter-terrorism officers and then placed under investigation by MI5.

The court heard several months after the charges were dropped, Rhianan was found dead at a children's home in Nottinghamshire on 19 May 2022.

Aged 15, she was the youngest girl charged

with terror offences in the UK, before the prosecution was discontinued.

Before the inquest evidence began, a statement paying tribute to Rhianan was read out on behalf of her mother, Emily Carter.

In it, she said her daughter had a love of horses and cats and had a passion for cooking, which was "one of the times she was the happiest" and that art became an outlet "when she couldn't say something".

But Ms Carter said Rhianan - who was autistic - became "fixated" on things due to her condition, and said: "Her being groomed was huge and I saw her change and it had a huge impact on her."

An email was read out from Rhianan's mother to Counter Terrorism Policing East Midlands (CTPEM) requesting help from the Prevent pro-

gramme.

It said: "I need help with my 15-year-old daughter. She has a very unhealthy outlook on fascism - she also has massive dislikes for certain races and creeds.

"I have done my best to deter her from any such ideologies, but it seems to be falling on deaf ears. I would like some help on the matter."

The subsequent referral form said this started off as an interest in world wars, but then turned towards a "fixation on Hitler" and admiration for him.

"She classes herself as a fascist and has quite a lot of hate towards other races," the form stated.

Ms Carter said they were waiting for hospital treatment for Rhianan's mental health. The court also heard Rhianan had a "history of self-harm".

Why your cuppa really could be a lifesaver

If you ever need an excuse to put the kettle on, this could be it – brewing tea removes toxic heavy metals from drinking water, researchers claim.

The process removes “significant” amounts of contaminants such as lead and cadmium, effectively purifying the drink.

The heavy metal ions stick to, or “adsorb” to, the surface of the tea leaves, where they remain trapped when they are discarded.

And the longer the bag or leaves are left in the mug or pot, the more toxins are removed.

Dr Benjamin Shindel, the first author of the US study at Northwestern University, Illinois, said:

“If people drink an extra cup of tea per day, maybe over time we’d see declines in illnesses that are closely correlated with exposure to heavy metals.”

The effect is not due to any special quality of tea other than that the leaves have a high surface area for toxins to cling to.

Dr Shindel said: “What is special is that tea happens to be the most consumed beverage in the world. You could crush up all kinds of materials to get a similar metal-remediating effect, but that wouldn’t necessarily be practical. With tea, people don’t need to do anything extra. Just put the leaves in your water and steep them, and they naturally remove metals.”

Senior author Prof Vinayak Dravid said: “Our work highlights the unrecognised potential for tea consumption to passively contribute to reduced heavy metal exposure.”

The tunes included Dolly Parton’s 9 to 5 and a specially-written rap by Nottingham’s own Bru-C.

Looking fresh-faced the morning after Tuesday’s night of gin and tonic and dancing, Hilda said: “I love a party. I’m not one for all the big rocking and rolling stuff, I like a waltz and a foxtrot.

“But I like listening to any music with a good tune.

“I’ve enjoyed every

minute of my life which I intend to keep on doing while I can. I never thought I’d get to this age but fortunately I’m here, which I’m grateful for.”

Hilda, whose party started at 6pm had welcomed guests in their 80s and 90s alongside family, amid 250 birthday cards – including one from King Charles and Queen Camilla.

The bash was such a hot ticket it was reported on websites for DJs and clubbers. Rebecca Wass, the manager of Holbrook Hall Care Home in Ripley, Derbyshire, thinks Hilda wanted a celebratory rave after seeing one on TV.

Rebecca revealed: “Hilda said she wanted a good celebration.

“She’s always been a big fan of dancing and living life to the fullest so she wanted to do something to represent that. She’s a very cheeky lady. She’s con-

stantly on the go, very determined.”

Hilda – born when David Lloyd George was prime minister and George V was on the throne – is Ripley born and bred. She worked in a textile factory after leaving school and made munitions during the Second World War.

She met husband Wal-

ter – her “one true love” – in her early twenties but he died in the late 1950s after which she lived with widowed sister Vera for 63 years until Vera’s death.

The pair would travel around Britain on dancing holidays and take cruises for the nightlife.

Hilda, who was still driving aged 100, said

of her youth: “I couldn’t get enough tennis, I can hear my mum saying you’re never going out again tonight playing tennis, you’ll be worn out.

“I haven’t got a secret at all. Just keep on, keep batting. But I just keep on and on while I can and take the day today as it comes.”

Time to rework the slogan: British Airways now named the world’s least favorite long-haul airline

BRITISH Airways has finished joint bottom of a league table of airlines flying long-haul in a survey of nearly 8,000 passengers.

Along with Air Canada it was the worst of 19 airlines with a score of 62%. The Which? study named Singapore Airlines the best long-haul carrier on 81%.

The survey was based on boarding the plane, seat comfort, last-minute cancellation policy, punctuality, cleanliness, cabin environment, food and drink quality and

value for money.

Jet2 came first for short-haul journeys with a score of 80% while Ryanair finished bottom. BA and Air Canada scored a measly two stars out of five across several categories including value for money, seat comfort and cabin environment.

‘progress’

BA also has high levels of last-minute cancellations, with around 2% of flights pulled within 24 hours of departure, according to official data.

One survey respon-

dent said that the airline had cancelled their flight by text in the early hours, leaving them to hurriedly try and rearrange

their plans.

BA claimed it had improved. It said: “We don’t always get things right, but we’re proud of the progress

we’re making.”

Ryanair said: “Not one of our 200 million passengers wish to pay higher prices as Which? falsely claim.”

Beckham At 50: Definitely not fussed about being olden balls

David Beckham says he is not bothered about turning 50 and has never felt happier – except for three of his children flying the nest.

The ex-England, Manchester United and Real Madrid footballer, whose milestone birthday is May 2, made the admission as he showed off the results of his fitness regime and apres-exercise style this week.

Inter Miami boss David – nicknamed Golden Balls by fashion designer wife Victoria, 50 – says he works out up to six times a week.

And his body is “feeling better than it has done for a long time”, thanks to his long-time personal trainer, Bobby Rich. He also plays racket sport padel three times a week, “especially when I’m in Miami”.

David, who is fronting 10 *Men's Health* world editions, said his half-century "doesn't bother me one bit".

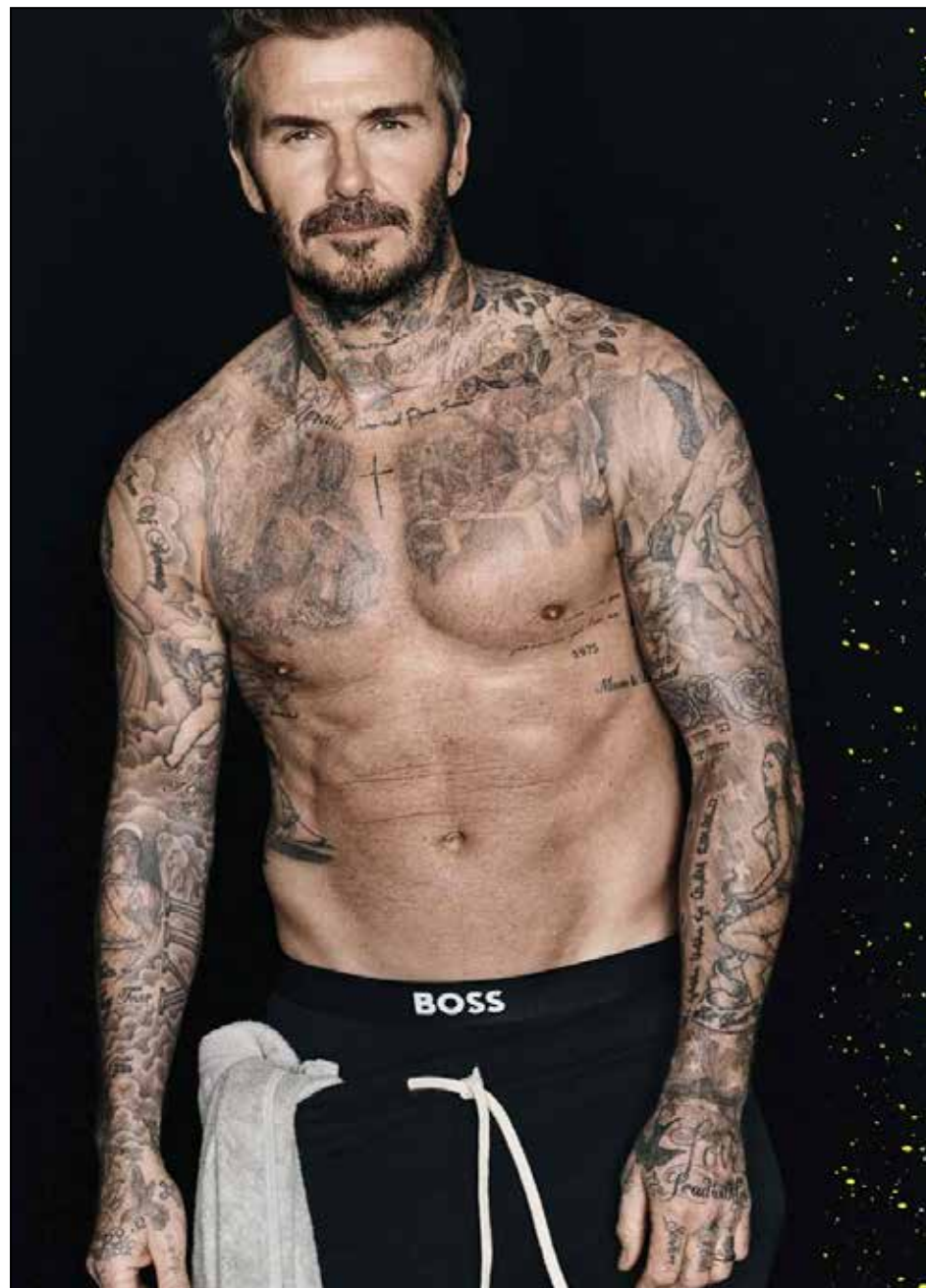
He added: "People are asking me about it gently, like it should be a big issue. As long as I'm fit and healthy and my family are healthy, that's all I care about. I'm really happy. I've

He said: "What I would give to have that back and be able to walk in, moaning to them about [wet towels on bedroom floors]."

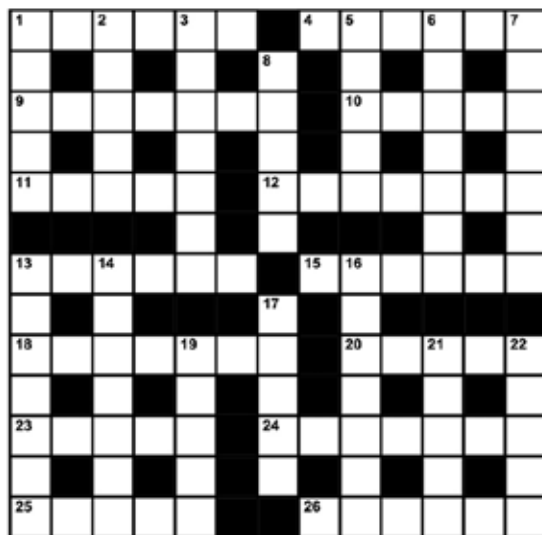


STILL A BIT FIT: Beckham stripped down to his skivvies for Men's Health

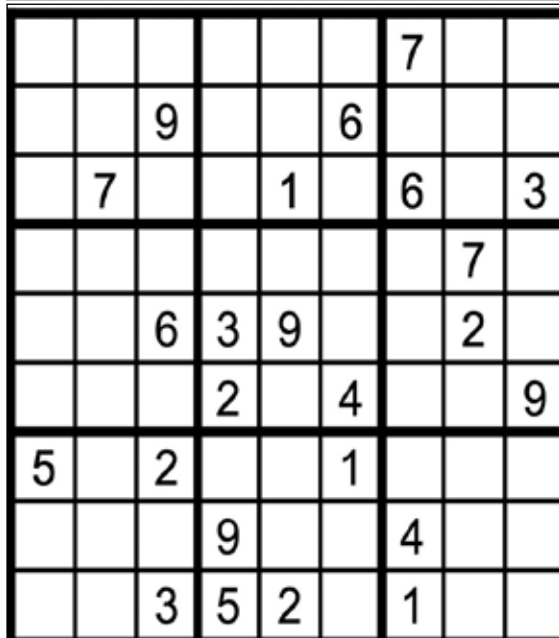

The Capture: BBC drama a terrifyingly timely thriller

In an age where misinformation and deepfake technology threaten the very fabric of truth, *The Capture* delivers as a spine-chillingly relevant thriller that forces us to question the reliability of what we see.

The BBC drama, now available for free on Peacock, was created by Ben Chanan and is a masterclass in paranoia, deception, and the unnerving possibilities of digital manipulation. Although the first season debuted back in 2019, the growing proliferation of deepfakes worldwide makes this show feel startlingly of-the-moment. The show brings a razor-sharp narrative, compelling performances, and an overwhelming sense of unease that makes it perfect for binge watching.

Set against the backdrop of modern surveillance Britain, the show's first season follows the story of ex-soldier Shaun Emery (Callum Turner), whose conviction for an unlawful killing in Af-



ghanistan is overturned due to flawed evidence. Just as he tastes freedom, new CCTV footage appears to show him abducting his barrister, Hannah Roberts (Laura Haddock). The evidence seems irrefutable - until it isn't. Enter DI Rachel Carey (Holliday Grainger), a principled detective whose investigation soon plunges her into a world of high-tech subterfuge, where reality itself is malleable. She soon learns that Emery is the victim of 'correction', video manipulation and CCTV hacking created by the British security forces to create actionable 'evidence' against terrorist threats when the real thing is not available.

Despite Carey's best efforts to get to the truth and be a thorn in the side of her highly compro-

mised bosses, the first season ends on a downbeat note with a miscarriage of justice and Carey herself seemingly willing to abandon her own principles. Things take a darker turn in season two, when we find the conspiracy extending to the highest levels of the British state, with Security Minister Isaac Turner (Paapa Essiedu) targeted - or possibly promoted via Correction, while BBC bigwig Khadija Khan (a deliciously prickly Indira Varma) proves an unlikely ally for Carey as she moves closer to exposing all the key players in a plot that originates (surprise, surprise) among the tech titans of Silicon Valley.

intricate web

What makes *The Capture* so gripping is its unrelenting commitment to suspense. From the very first episode, Chanan weaves an intricate web of twists, making the viewer question every frame. The series plays on our faith in visual evidence - an unnerving notion given the growing sophistication of deepfake technology and the prevalence of state surveillance. Each revelation is meticulously placed, ensuring that no moment feels wasted or gratuitous. The result is a taut, sophisticated thriller that never lets its audience relax.

Callum Turner delivers a compelling performance as Shaun Emery, capturing both the confidence of a trained soldier and the bewilderment of a man whose own eyes deceive him. But even better is Holliday Grainger's Rachel Carey, whose moral compass is gradually tested as she descends deeper into the labyrinth of deception. The supporting cast is just as formidable. Ron Perlman oozes sinister omniscience as Frank Napier, an enigmatic

American operating within the shadows of Western intelligence. Meanwhile, Lia Williams as DSU Gemma Garland exudes quiet menace, embodying the kind of bureaucratic power that thrives in ambiguity. Every character, no matter how minor, serves a purpose, adding layers to an already densely packed narrative.

unsettling

Rachel Carey takes center stage, with the narrative expanding beyond Shaun's predicament, delving into the broader machinations of intelligence agencies and their methods of information warfare, that affect everyone to the very highest levels of the government. The final episodes are particularly unsettling, not just for their revelations but for their implication that such tactics may already be in use. The

writing is deft, avoiding heavy-handed exposition and instead allowing the horror to seep in gradually.

Visually, *The Capture* embraces the bleakness of its subject matter. The cinematography is crisp yet claustrophobic, with tight framing and dimly lit sequences amplifying the pervasive sense of surveillance. London itself is depicted as a cold, omnipresent force—its labyrinth of CCTV cameras as a silent observer to the unfolding drama. The aesthetic choices lend an air of authenticity to the story, reinforcing the idea that this is not some dystopian future but rather a disturbingly plausible present.

At its core, *The Capture* is more than just a thriller—it is a searing commentary on the power of digital deception. The series explores how easy it is to manipulate 'truth' in an

era where video evidence is considered the gold standard. The ethical implications are profound: if we can no longer trust our own eyes, what can we trust? The show raises uncomfortable questions about state control, surveillance overreach, and the fragility of justice in a technologically advanced society.

The success of *The Capture* lies in its ability to be both a pulse-pounding drama and an intellectually stimulating discourse on modern surveillance culture. It taps into contemporary anxieties with chilling precision, making it one of the most unsettling yet necessary dramas in recent years.

In an era where digital truth is increasingly fluid, *The Capture* serves as both entertainment and warning - a gripping reminder that seeing is not always believing.

Dejan Kulusevski and Son Heung-min came off the bench - both were surprisingly left out of

the starting XI by Ange Postecoglou - and their involvement further shifted momentum, with Son denied an equaliser by Ederson following a fast break.

"The game, it was open second half because we didn't close the first. In this stadium always they have 20 to 25 minutes and second half we suffered," Guardiola later explained.

"Never will [we be] the old City this season. Old City were too good, but we will be back."

Haaland was back in the City side after missing the defeat by Real Madrid in Spain and the Premier League home loss to Liverpool.

The fit-again Norwegian thought he had

Set pieces the key as ten-man United come from behind to beat Tractor Boys

Ten-man Manchester United recovered from gifting Ipswich a fourth-minute opener at Old Trafford to come out on top in a five-goal thriller Wednesday night thanks to Harry Maguire's header.

Maguire powered home Bruno Fernandes' corner two minutes into the second half to give Ruben Amorim only his third home Premier League win.

United's success came despite having Patrick Dorgu sent off before the break following the intervention of VAR Craig Pawson after his awful tackle on Ipswich winger Omari Hutchinson had been missed by referee Darren England.

Ipswich immediately capitalised on the extra man to level when Jaden Philogene's touchline cross curled in at the far corner as Andre Onana failed to react once Liam Delap had missed it.

But that was not Onana's worst mistake of the night as the Cameroon goalkeeper started the

game by getting too close to Dorgu as the defender attempted to deal with a long ball downfield. Instead, Dorgu played the ball past Onana to present Philogene with a tap-in.

However, it was just the start of a crazy opening as United levelled thanks to Ipswich skipper Sam Morsy, who as he was trying to stop Rasmus Hojlund challenging for Fernandes' deep free-kick, planted a firm header straight into his own net.

Four minutes later, United took the lead as Maguire and Diogo Dalot both had attempts on goal saved before the ball broke kindly for Matthijs de Ligt, who sent it into the roof of the net.

At that point, it seemed the home side would coast to victory. The reality was far more entertaining. Nothing is quite so simple at Manchester United these days.

confirming on Monday up to 200 members of staff could lose their jobs and Amorim's criticism of a team that 'didn't turn up' for 70 minutes at Goodison Park, it should have been automatic the home players would be fully focussed from the first whistle.

As Dorgu hurtled back to catch a long punt downfield, Onana had a couple of options. He could either yell at his new team-mate to get out of the way so he could tidy up, or he could back off anticipating a back pass.

Liverpool continued their charge towards the Premier League title as a 2-0 win over Newcastle put them 13 points clear at the top of the table on Wednesday night.

On an evening when second-placed Arsenal dropped points in a goal-less draw at Nottingham Forest, Arne Slot's side took full advantage at Anfield.

Slot, beginning his two-game touchline ban, watched from the stands as Dominik Szoboszlai opened the scoring in the 11th minute with a scuffed strike past Nick Pope.

Alexis Mac Allister added to the jubilant atmosphere in the second half, with chants of "We're going to win the league" heard from the Kop after the Argentine swept Mohamed Salah's pass high into the left

corner.

The visitors lacked a clinical edge up front. Alexander Isak, their top scorer this season, was absent because of a groin injury.

Callum Wilson deputised for the in-form Sweden striker, but he skewed a clear-cut effort wide in the first half after being handed his first league start of the campaign.

Newcastle sit sixth after finishing this game empty-handed - three points behind Manchester City in fourth and a guaranteed spot in next season's Champions League.

However, Eddie Howe's team can gain revenge against Liverpool when they meet again at Wembley in the final of the Carabao Cup on 16 March.

When the final whis-

tle blew at the Etihad on Sunday, Szoboszlai dropped to the floor in exhaustion as Liverpool secured a 2-0 victory over the reigning champions.

The Hungary international had been a powerhouse in midfield, running from deep to grab a goal and an assist as the Reds established a double-digit points gap between themselves and Arsenal.

Again, the midfielder proved crucial against Newcastle.

For the breakthrough goal, he cleverly held his charge into the box, wrong-footing Sandro Tonali before his low strike trickled through.

Szoboszlai, who went close to adding a second with a curling effort from the edge of the Newcastle area before the break, won more

tackles than any other Liverpool player as they kept their visitors' chances to a minimum.

Mac Allister added to the magic, starting and finishing the move for his goal, playing in Salah before finding space in the box to have a clear

strike.

Salah had another strong game. He often waltzed past Lewis Hall and Dan Burn in the Newcastle box, but the Egypt star could not add to the scoring on this occasion.

He was forced to settle

for an assist - his 42nd goal involvement in the league this season.

With only 10 games left to play, and with six of those fixtures at Anfield, Slot's team are fast approaching the finish line and edging closer to a 20th English title.

Potter's magic grows stronger as Foxes are left facing Ruud reality

West Ham followed up their impressive victory over Arsenal with a 2-0 win against Leicester to increase the pressure on Ruud van Nistelrooy and his relegation-threatened side.

Tomas Soucek celebrated his 30th birthday with the opening goal in Thursday's clash, firing in a loose ball after Mohammed Kudus' shot was denied.

The hosts then put the game beyond the struggling Foxes just before the break when Jarrod Bowen's shot from a tight angle deflected in off Leicester defender Jannik Vestergaard, after Jamie Vardy's header from a corner had hit the woodwork for the visitors.

The Foxes, who were

looking to close the gap to safety to two points with a win, had made a positive start as Wilfred Ndidi saw a second-minute effort saved.

But the Hammers' opener proved a real blow and they struggled to create pretty much anything of note after that.

The defeat leaves Van Nistelrooy's side second-bottom of the Premier League and five points from safety.

West Ham, meanwhile, are 15th, with their back-to-back wins putting them level on points with Tottenham and Manchester United, comfortably clear of trouble.

Leicester completed one of football's fairytales when they won

the Premier League in 2015-16, but the season before they produced another memorable story by avoiding relegation against the odds.

Back then they looked destined for a return to the Championship as they sat bottom of the table by April, but seven wins from their final nine games kept them up.

Their current situation is not as dire but the team, as things stand, do not look capable of pulling off an unlikely escape.

Defending has been a real problem for the Foxes this season and West Ham's two goals against them meant the visitors have now conceded 61 in 27 games, compared to 47 for the Hammers.
