STARMER GETS THEM TOGETHER!

■ Coalition of the willing close to 20 strong
■ Group would work to uphold Ukraine ceasefire

THE “coalition of the willing” spearheaded by Britain and France is close to enlisting about 20 countries to help Ukraine, according to UK officials.

The plan, which was unveiled by Prime Minister Sir Keir Starmer at this weekend's summit of 18 European and Canadian leaders, would work to uphold any ceasefire in Russia's war on Ukraine.

It is not thought every one of the countries, which are largely from Europe and the Commonwealth, would necessarily send troops but some could provide other support.

Russia's foreign minister Sergei Lavrov said such a move “can't be allowed” because it would amount to the “direct, official and unveiled involvement of Nato members in the war against Russia”.

It comes as Kyiv attempts to mend relations with Washington after the US paused its military aid to Ukraine and intelligence sharing in a bid to bring President Zelensky to the negotiating table.

Speaking on a visit to a defence firm in Merseyside, Sir Keir said it would be a “big mistake” to think that “all we've got to do is wait for a deal now” between Ukraine and Russia, which US President Donald Trump claims to be attempting to broker.

The PM said it would be crucial that “if there is a deal - and we don't know there will be - that we defend the deal”, which meant ensuring Ukraine was “in the strongest position”.

‘early days’

But the PM stressed that defence plan should be made “in conjunction with the United States... it's that ability to work with the United States and our European partners that has kept the peace for 80 years now”.

British officials said it was “early days” but welcomed what they described as the expressions

of interest in joining a “coalition of the willing” as a “highly positive step”.

Europe to rearm

And in a rapidly developing situation, the European Union also signalled a more aggressive defence posture on Thursday, announcing a new €800 billion (\$843 billion) package to “rearm” the continent, dubbed ‘ReArm Europe.’

Unveiling the plan, European Commission President Ursula von der Leyen, was blunt, saying, “We are in an era of rearmament. And Europe is ready to massively boost its defense spending.”

“This is Europe's moment, and we must live up to it,” she added.

The announcement came only a day after President Donald Trump announced Washington was cutting off off military aid and may stop the transfer of weapons

to Ukraine.

ReArm Europe funding will be dependent on securing €650 billion over four years by triggering a “national escape clause” that suspends budget rules, allows national governments greater flexibility over public funding and could produce, on average, a 1.5 percent defense spending increase per member state.

A “new instrument” offering €150 billion of loans to member states would be responsible for delivering the remainder of the funding.

Additionally, member states will be able to redirect funding from other EU projects to increase defense related efforts.

The Prime Minister's Deputy Official Spokesman said the government had been “very clear that it is for Europe and for the UK to step up and I think you are seeing evidence of that consistently.”

The UK and France have proposed a one-month truce “in the air, at sea and on energy infrastructure”, backed up by a coalition of supportive western countries,

but this has been rejected by Russia.

Also on Thursday, Defence Secretary John Healey held talks with his US counterpart Pete Hegseth in Washington DC.

At the meeting, Healey said the US had challenged Europe to step up on defence spending and the UK had responded.

“We have, we are and we will further,” he said.

Hegseth said the UK was a “critical” partner, adding European leadership of the Nato alliance was “the future of defence on the continent”.

Kingdom United at last...in mocking "JD Duncce"

■ Britons in uproar over Veep's careless crack about 'some random country'

JD VANCE has caused a storm of controversy after suggesting the UK was a "random country that hasn't fought a war in 30 or 40 years."

The Vice-President made the comments on Tuesday as he discussed plans to send a peace-keeping force of 20,000 British and French troops to Ukraine when he made the comments.

He disapproved of the proposals, saying that the only way to ensure lasting peace was to give the US an economic interest in Ukraine.

"If you want real security guarantees, if you want to actually ensure that Vladimir Putin does not invade Ukraine again, the very best security guarantee is to give Americans economic upside in the future of Ukraine."

He added: "That is a way better security guarantee than 20,000 troops from some random country that hasn't fought a war in 30 or 40 years."

At the time of his speech only Britain and France had committed to put troops on the ground, which prompted many to question which of the two countries Vance was referring to.



The Vice President was roundly condemned for the comments by British politicians on all sides - and now the press have slammed the Republican as well for his comments.

In their front page, the Mirror labelled Vance a "disgrace" and described his comments as "Trump's sidekick's slur."

Meanwhile, the Daily Express slammed Vance as a "clown", saying that his words were a "slur on 636 war heroes."

This is a reference to the number of UK mil-

itary personnel who died fighting alongside the United States in Afghanistan and Iraq.

While UK politicians are largely united in agreeing that a US military presence in some form will be necessary in any peace deal, there was immediate outrage about Vance's apparent dismissal of a UK military that fought alongside American troops in Iraq and Afghanistan.

James Cartledge, the shadow defence secretary, said: "Britain and France came to their [the US's] aid, deploying

thousands of personnel to Afghanistan, including my own brother and numerous parliamentary colleagues, past and present. It's deeply disrespectful to ignore such service and sacrifice."

On Tuesday, Vance said it was "absurdly dishonest" to argue that he had been referring to the UK or France, despite the countries being at the forefront of efforts to provide a non-US peacekeeping force.

"I don't even mention the UK or France in the clip, both of whom have fought bravely alongside the US over the last

20 years, and beyond," he tweeted. "But let's be direct: there are many countries who are volunteering (privately or publicly) support who have neither the battlefield experience nor the military equipment to do anything meaningful."

The former foreign secretary James Cleverly condemned what he called Vance's "foolish and insulting, throw-away remark" given the support allies including the UK and France had provided after the 11 September 2001 attacks.

The Conservative MP

told Times Radio: "I understand that he has explained his position, but I think it was a hurtful and thoughtless remark."

Nigel Farage, the Reform UK leader, who is close to Trump and Vance, was trenchant in his response, telling GB News: "JD Vance is wrong - wrong, wrong, wrong." He added: "For 20 years in Afghanistan, pro rata our size against America's, we spent the same amount of money; we put the same number of men and women in. We suffered the same losses."

Trump 'destroying world order', says ambassador

The US is "destroying" the established world order, Ukraine's ambassador to the UK has claimed.

Valerii Zaluzhnyi said the White House had "questioned the unity of the Western world" and was "taking more and more steps towards" Russia, which launched a full-scale invasion of Ukraine in 2022.

The comments come as the US puts pressure on Ukraine to make concessions ahead of any peace talks, and after a public clash between

Ukrainian President Volodymyr Zelensky and his US counterpart Donald Trump.

Zelensky has since said he is "ready to work" under Trump's "strong leadership", an apparent cooling in tensions welcomed by Trump - and which comes after the US paused military aid to Kyiv.

But Mr Zaluzhnyi's remarks at a conference at Chatham House in London on Thursday suggest there remains discontent over the US's actions.

He told an audience: "We see that it is not only Russia and the axis of evil trying to destroy the world order, but the US is actually destroying it completely."

The Ukrainian envoy added that talks between the US and Russia - the latter of which was "headed by a war criminal" in President Vladimir Putin - showed the White House was making "steps towards the Kremlin regime, fully realising that in this case Europe could be a new target for Russia".

Florida launches probe into Tates

Florida has launched a criminal investigation into British-American influencers Andrew and Tristan Tate, who flew to the state last week from Romania, where they faced rape and human-trafficking charges.

Florida's attorney general, James Uthmeier, said investigators have issued search warrants and subpoenas as part of a "now-active" inquiry.

In the US, the brothers also face a civil suit from a woman alleging they coerced her into sex work, and then defamed her after she gave evidence to Romanian authorities. They strongly deny all the allegations against them.

A former kickboxer and self-described misogynist who appeared on UK TV show Big Brother, Andrew Tate has millions of followers online.

Andrew, 38, and his brother Tristan, 36, face separate charges in the UK of rape and human trafficking. They deny those allegations too.

Uthmeier, a Republican, said in Tuesday's statement: "Based on a thorough review of the evidence, I've directed the Office of Statewide Prosecution to execute search warrants and issue subpoenas in the now-active criminal investigation into the Tate brothers."

The Tates were first arrested in Romania in December 2022, with Andrew accused of rape and human trafficking and Tristan suspected of human trafficking. They moved to Romania from the UK several years ago.

They both denied the charges and spent several months under house arrest.

Drug-rape student 'among most prolific predators'

A PhD student who has been convicted of drugging and raping 10 women "may turn out to be one of the most prolific sexual predators that we've ever seen in (the UK)", according to the lead detective on the case.

Chinese national Zhenhao Zou, 28, attacked two women who have been identified and another eight who have yet to be traced, his trial at Inner London Crown Court heard.

The University College London (UCL) student filmed nine assaults as "souvenirs", and kept a trophy box of victims' belongings including jewellery and clothing.

Judge Rosina Cottage said Zou was a "dangerous and predatory" offender and warned him he faces a "very long" jail term when he is sentenced on 19 June.

The Met Police's Cdr Kevin Southworth said the video evidence showed there may be as many as 50 further victims, whom they are "desperate to trace".

"Such is the insidious nature of these offences, I think there is a possibility

that many more victim survivors may not even know that he has, in fact, raped them," he said.

Following the trial and as a result of the media coverage, the Met confirmed that one woman had already been in touch about Zou.

As well as 11 counts of rape, Zou was found guilty of voyeurism, possession of extreme pornographic images and false imprisonment.

The crimes he has been convicted of took place between 2019 and 2024.

Hidden cameras were discovered by the Met Police in his bedroom, as well as ecstasy and an industrial chemical the human body turns into the "date-rape" drug GHB.

Seven of the rapes happened during the pandemic in China. The evidence of those attacks was videos shown to the jury that Zou kept of him having sex with unconscious and semi-conscious women. Police have never identified them.

Four of the rapes took place in London. Two women were identified and gave evidence; the other two rapes were of the same woman, but she

has never been tracked down.

Jurors had to watch footage of nine of the rapes during court proceedings, appearing visibly upset and being given regular breaks as the material was shown.

In his defence, Zou told the jury he had discussed sexual preferences with one of the women he filmed, and she had said she liked "uniform role play".

"We specifically dis-

cussed the kinds of role play I like, which was rape role play," he said. He told the court this was how the videos came to be made.

The student comes from a wealthy family, and paid £4,000 a month in rent.

Zou moved to Belfast in 2017 to study at Queen's University before heading to London in 2019 to do a master's degree and then a PhD at UCL.

The Met Police has

launched an appeal to find any other victims.

"If you're a woman who's in any way had a one-on-one encounter with this man Zou, then we would like to hear from you," Cdr Southworth said.

The force said it was particularly keen to hear from women from the Chinese student community who may have met Zou and were living in and around London between 2019 and 2024.

Russians sentence British man caught fighting for Ukraine to 19 years in jail

A British man who was captured while fighting for Ukraine's armed forces has been jailed for 19 years by a Russian military court.

James Scott Rhys Anderson was reportedly captured in Russia's Kursk region last November, where Ukraine had launched a cross-border incursion, and was charged with terrorism and mercenary activity.

The 22-year-old is the first British national to be convicted by Russia during the war.

The UK Foreign Office said Mr Anderson was sentenced on "false charges" and described him as a prisoner of war.

A statement released by the Russian court claimed Mr Anderson had pleaded guilty but this cannot be verified, as he has not been heard from independently since he was taken.

On Wednesday, a Russian military court ruled that Mr Anderson would spend the first five years of his sentence in prison before being transferred to a penal colony with "strict" conditions.

Russian investigators had accused him of "committing a terrorist act" as part of an organised group, illegally crossing the border into Russia, causing "significant damage to property" and having "destabilised" the ac-

tivities of authorities.

But those claims were rejected by a UK Foreign Office spokesperson, who said they "strongly condemn" Mr Anderson's sentencing on "false charges".

"Under international law, prisoners of war cannot be prosecuted for participating in hostilities.

"We demand that Russia respect these obligations, including those under the Geneva Conventions, and stop using prisoners of war for political and propaganda purposes.

"We remain in close contact with Mr Anderson's family and are providing consular support."

Mr Anderson's three-day trial was held behind closed doors. Video footage released by the Kursk court showed Mr Anderson being led into court in handcuffs wearing a winter hat and jacket that appeared to be prison uniform.

While Mr Anderson is the first UK citizen accused of fighting for Ukraine to be captured and convicted by Russia, two British captives were sentenced to death in Russia-occupied Donetsk - however, they were later released in a prisoner exchange.

Golfing giant joins fight to save small Glasgow muni course

ONE OF the world's leading golfers has joined the fight to save a small municipal golf course in Scotland.

US Open champion Bryson DeChambeau has urged the local authority that operates Dalmeir, a nondescript municipal course on the north-west outskirts of Glasgow, open.

The public-run course's future will be debated by West Dunbartonshire Council at a budget meeting on Wednesday evening.

Dalmeir could be closed completely, reduced to 12 holes or remain at 18 but with a rise in membership rates and green fees.

More than 3,500 people have signed a petition urging the authority to save the course while the SNP group in the Labour-minority council has also backed the campaign to keep Dalmeir open.

Dalmeir was threatened with closure last year and the council says it costs more than £100,000 a year to subsidise the expenditure to run the course.

Long-time tour caddy Craig Connelly, who lives near Dalmeir, shared a video by DeChambeau on X during which the two-time US Open champion emphasises the impact golf can have on a community.

"I'm here to tell you how important a public golf course is to the ecosystem, not only just golf in general, but the community," said the 31-year-old American.

"This golf course is super important and I hope people can understand how important it is to go out and sign that petition and keep this course alive and to make a different future for generations to come."

Crossbow killer guilty of raping former girlfriend before her brutal murder

■ Jilted boyfriend killed ex-lover, her sister and mother horrific and prolonged attack

A man has been found guilty of raping his ex-girlfriend in an attack in which he murdered her and her sister with a crossbow and their mother with a knife.

Louise Hunt, 25, and Hannah Hunt, 28, suffered fatal crossbow bolt injuries at the family home in Bushey, Hertfordshire, in July 2024, while Carol Hunt was stabbed to death.

Kyle Clifford, 26, of Enfield, north London, admitted the murders but denied raping Louise, but a jury convicted him at Cambridge Crown Court.

Judge Mr Justice Bennathan said Clifford's crimes were "dreadful" and "almost unspeakable".

The lead detective in the case said he did not think "this is the case of a spurned lover in any way".

Louise had ended the relationship with Clifford two weeks earlier, and told him in a message, "Take care of yourself".

"He simply couldn't deal

with what he perceived to be a dent to his pride," said Det Ch Insp Nick Gardner.

"He then sought to control the situation, in terms of weapons purchases; the cold, calculating way in which he lay in wait in the house for [Louise]."

The women were the wife and daughters of BBC horse racing commentator John Hunt.

The trial heard that in the days leading up to the murders, Clifford bought a crossbow online, and a replica Glock air pistol from a shop in Essex.

Prosecutors also said "violent misogyny" promoted by social media influencer Andrew Tate "fuelled" his attacks. He searched for Tate's podcast less than 24 hours before the murders.

However, the defence argued this material had too vague a link and was far too prejudicial.

The judge agreed it was of limited relevance and of "great possible prejudice", and that it should not be

put before the jury.

Prosecutors said he arrived at the family home at 14:32 BST on 9 July, under the guise of dropping off Louise's belongings, before stabbing Carol, 61.

Screams and banging sounds were heard from the property.

Clifford attacked Louise, a dog groomer who had been working in a pod in the garden, as she entered the home at 16:13, before taping her ankles and wrists - and eventual-

ly raping her - in a horrific onslaught that lasted nearly three hours.

The former soldier stopped during the attack to send a text message to Louise's father using her phone, asking him, "What time are you home?"

When she arrived, Hannah screamed at Clifford "What is wrong with you?" - and managed to message her partner "He's tying us up" in the minutes before she was also fatally shot.

Clifford fled the scene

and was arrested by fire-arms officers in a cemetery near his Enfield home the following afternoon - but only after he had shot himself in the chest, paralysing him.

When he was finally deemed fit to be interviewed by police on 16 September, he said "Sorry" and "What I have done is atrocious."

On 22 January, he pleaded guilty to the murders.

Clifford is due to be sentenced on Tuesday.

40 years on, largest theme park in Wales to be shut down

Wales' largest theme park has announced it will shut down with immediate effect after almost 40 years.

Due to a drop in visitor numbers, Oakwood Theme Park owners Aspro Park said "future investment is unsustainable" and it would not be opening for the 2025 season.

The company added: "All possible avenues have been explored to avoid the closure, and we fully recognise the impact of the closure on the local community and the loss that will be felt as a result."

Oakwood, in Pembrokeshire, opened in 1987 and almost closed

in 2008.

But a £25m investment rescued the park, which employed up to 200 people, according to its LinkedIn profile.

The park added that "unrelenting economic challenges" from electricity costs, ride parts and food and drink inflation, as well as changes to national insurance thresholds affected the decision.

Aspro Parks said this was the first time it had closed a park or attraction in its "entire history".

It added: "Unfortunately, we could no longer see a sustainable way forward and will seek to improve our other parks using the assets and

where possible team elsewhere."

The owners said they felt "sadness" for the loss of "a rite of passage for many young visitors".

The Treasury said, while it was a commercial decision, "we understand this will be a concerning time for workers at Oakwood Theme Park and their families".

It added that the Budget meant "more than half of employers will either see a cut or no change in their National Insurance bills".

Rollercoaster enthusiast and Oakwood superfan Ryan Hackett said he was "gutted" at the news of the closure.

Mr Hackett, 64, from



Milford Haven, has been on the Megafobia ride at the park 6,200 times and was hoping to reach 7,000 rides over the coming season.

"As a rollercoaster enthusiast, it's the last thing you want to see - a park closure," he said.

"I just hope there's a buyer. I joked on social media earlier - can someone lend me £100m?"

"My phone has been ringing all evening from other rollercoaster enthu-

siasts from all over the UK and everyone is devastated."

Samuel Kurtz, Carmarthen West and South Pembrokeshire Member of the Senedd (the Welsh assembly), said the park's closure was "deeply sad" and it had a "special place in the hearts of many".

The Welsh government said: "We stand ready to offer support to the workforce affected by this decision."

Paddleboard operator admits manslaughter in deaths of four

■ Company owner took group out in ‘extremely hazardous’ conditions

A paddleboard tour company owner has admitted to gross negligence manslaughter after the deaths of four people.

Paul O'Dwyer, Andrea Powell, Morgan Rogers and Nicola Wheatley drowned while paddleboarding in "extremely hazardous conditions" on the River Cleddau, Haverfordwest, Pembrokeshire, in October 2021.

Nerys Bethan Lloyd, 39, an ex-police officer from Port Talbot, is the former owner of Salty Dog, the now-dissolved company operating the tour that the four, and four others who survived, were on. It was revealed she did not have the correct qualifications to run the tour.

At Swansea Crown Court on Wednesday, she also pleaded guilty to one offence under the Health and Safety at Work Act.

Following the plea hearing, the Crown Prosecution Service (CPS) said the paddleboard tour on 30 October 2021 occurred despite "heavy flooding and severe weather warnings" being in place.

It added "the river was running fast and the weir was in an extremely hazardous condition", and three of the participants became trapped after being pulled over the top of the Haverfordwest Town Weir.

Mr O'Dwyer, who was an instructor on the tour, initially exited the river safely, but then re-entered the water in an attempt to rescue the others.

The four victims died due to drowning.

The CPS added Lloyd did not have a suitable qualification, and her planning and supervision was inadequate, with the prosecution following a joint investigation by Dyfed-Powys Police and the Health and Safety Executive (HSE).

Lisa Rose, specialist prosecutor with the CPS special crime division, added it was "an avoidable tragedy".

"Despite going to check the state of the river before departing on the tour, Nerys Lloyd failed to inspect the weir," she said.

"The majority of participants had limited experience, and Lloyd was not qualified to take paddleboarders out in such

hazardous conditions.

"There was no safety briefing or formal risk assessments, and the participants were not advised that they would be traversing a weir or instructed on options to get out of the water."

Mr O'Dwyer, from Port Talbot, Ms Rogers, from Merthyr Tydfil, and Ms Wheatley, of Pontarddulais, all died at the scene.

Ms Powell, from Bridgend, died in hospital on 5 November 2021.

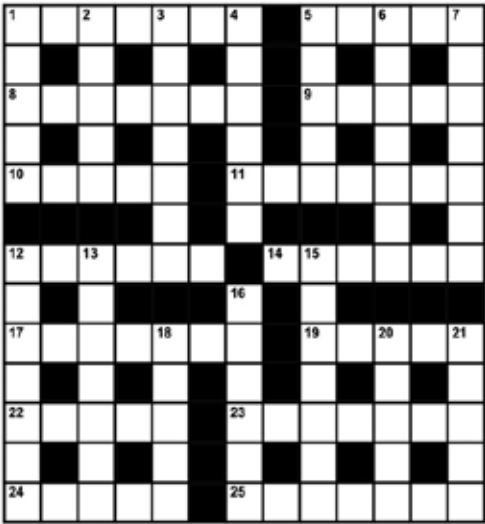
Ms Rose continued: "Final decisions to continue with the event were Lloyd's decision, and as a result she held complete and entire responsibility.

"I hope these convictions provide some sense of justice for those affected and our thoughts remain with the families and friends of the victims at this time."

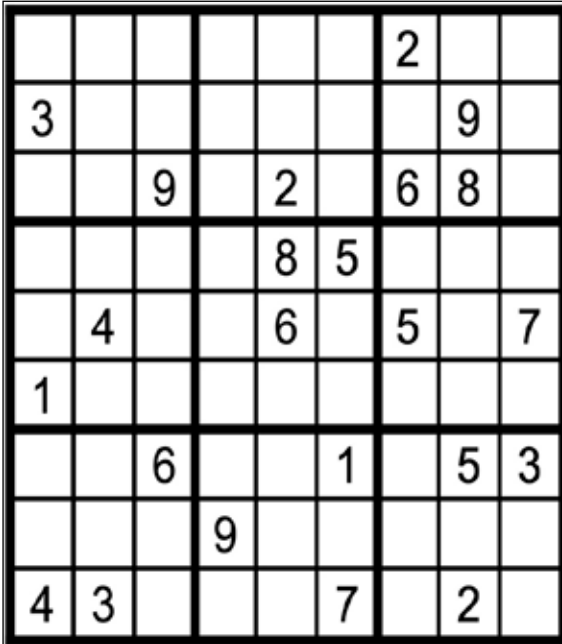

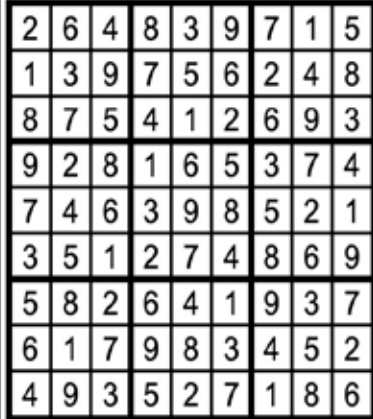

Brits may not have bagged any of the big name awards this year, but there's some serious heavy lifting going on behind the scenes, from Hollywood hits filmed at Pinewood Studios to masterful British technicians editing future blockbusters.

Eight British film technicians and writers bagged an Oscar at the 97th Academy Awards on Sunday night. They are:

British writer **Peter Straughan**, who won Best Adapted Screenplay for *Conclave*, which was based on the novel by British author Robert Harris

British musician **Daniel Blumberg**, who bagged

Best Original Score for his work on *The Brutalist*

British sound engineer **Gareth John** who shares Best Sound for *Dune: Part Two* with American colleagues Richard King, Ron Bartlett and Doug Hemphill

British production designer **Nathan Crowley** and British set decorator **Lee Sandales**, who share Best Production Design for their work on *Wicked*

The Nominees

It wasn't a huge showing of Brits in the top categories this year: one of the 10 Best Picture nominees can be counted as British, *Conclave*; three of the five Best Director nominees were American, the other two French; and only Cynthia Erivo, Ralph Fiennes and Felicity Jones flew the flag for British actors in the acting categories, though both missed out.

Further down the list, Nick Park, Merlin Crossingham, Richard Beek and the rest of the Aardman team were tragically snubbed in the Best Animated Feature category for their Bafta-winning *Wallace & Gromit: Vengeance Most Fowl*. The winner, *Flow*, marks Latvia's first ever Oscar win. Fellow British animator Nina Gantz missed out in the Best Animated Short category, with her 2023 film *Wander to Wonder* up for the prize.

Meanwhile, one of Britain's shiniest stars **Elton John** missed out on Best Original Song; he was nominated for 'Never Too Late' which accompanied his 2024 documentary of the same name, trumped by Emilia Perez's 'El Mal'.

While Brits won in the technical categories of Best Sound and Best Production Design, it was at the expense of other Brits: composer Paul Massey for *A Com-*

Gunners put seven past shell shocked Dutch

Eindhoven has been packed with carnival-goers in recent days but on Tuesday it was Arsenal enjoying their own party in the city, getting over their goalscoring crisis and setting a Champions League record in their 7-1 shellacking of the hosts.

Mikel Arteta's side became the first team in Champions League history to score seven goals away from home in the knockout stages of the competition as they romped victory over PSV Eindhoven.

It was the most goals the Gunners have scored in a single game since beating Newcastle 7-3 in the Premier League 13 years ago.

The Arsenal manager said the win had given his players "joy and confidence and belief", but was not getting carried away when questions were put to him about the records that his team had broken.

"For sure, it's something that hasn't been done, so great to be part of that," Arteta said. "But as a team we want

to achieve many other things that are far more important than that.

"The happiest thing is we are in a very strong position to go to the next round, which is where we want to be.

"But there's still a job to do in London in a week's time."

After failing to score in their past two games, a 0-0 draw at Nottingham Forest and 1-0 defeat by West Ham, Arteta may not have seen a victory like this coming.

Arsenal were ruthless with their finishing, some

of the combination play in the final third was sensational.

Martin Odegaard looked back to his best. To a man they were really strong and the centre-back pairing of Gabriel Magalhaes and William Saliba looked impregnable.

England and Arsenal midfielder Declan Rice was one of the players singled out for his performance during the game and said that the Gunners have got the reward for their hard work in recent weeks.

Rice, who had a goal ruled out for offside, said Arsenal were "fluid" and possessed the "enthusiasm, drive and hunger" that the knockout stages demand.

"But we've been playing like this all season," he added. "We feel we've been playing well as a team. Sometimes we score five, sometimes two, sometimes we don't score but [on Tuesday] we did well. It all clicked."

Arsenal's lack of a recognised striker has been well documented, with Gabriel Jesus and Kai

Havertz both injured. But six different players contributed to the rout on Tuesday - Odegaard scored twice, along with goals for Jurrien Timber, Mikel Merino, Ethan Nwaneri, Leandro Trossard and Riccardo Calafiori.

The emphatic win means that Arsenal can start planning for a trip to Madrid, as they are set to take on the winner of the tie between Real and Atletico, which finished 2-1 to Carlo Ancelotti's side. Next week's second leg takes place at Atletico.

Clueless in Alkmaar: feeble Spurs lose again

Lucas Bergvall's own goal led to a flat Tottenham losing the first leg of their Europa League last-16 tie at AZ Alkmaar on Thursday.

Ange Postecoglou's side only had one late shot on target - and only two inside AZ's box all night.

The difference ended up inadvertently being teenager Bergvall, who shinned an attempted clearance from Troy Parrott's cross into his own net.

Spurs needed goalkeeper Guglielmo Vicario to come up with three big saves to keep them firmly in the tie - including to deny former Spurs striker Parrott.

But Tottenham will have to do without midfielder Rodrigo Bentancur in next Thursday's

home leg after his third booking of the season.

The visitors created little of note in a muted display. Substitute Wilson Odobert's cross-shot was parried away by AZ keeper Rome-Jayden Owusu-Oduro and he headed over the bar right at the end.

To make Spurs' night even worse, striker Dominic Solanke - making his return after seven weeks out with a knee injury - had to be replaced 20 minutes after coming on and hobbled off the pitch.

One of the soundbites of Spurs' campaign has been Postecoglou's quote in September that he always wins a trophy in his second season with a team - a claim that is mostly accurate.

But Spurs will have to

improve - starting with actually creating some good chances - next week if he is to have a chance of continuing that run.

The Europa League is Spurs' last chance of silverware this season. Fail to win the second leg and they will probably not even be in Europe next season, given they are currently 13th in the Premier League.

AZ, who are sixth in the Dutch Eredivisie, were deserved victors and could have won by more.

Ernest Poku had four efforts, with three each for Republic of Ireland striker Parrott and substitute Denso Kasius.

The hosts' biggest chance to score a goal themselves came when Parrott, who left Spurs

and Bergvall all missed the target from about 20 yards out.

Odobert had an effort saved, although it may not have even been a shot, and should probably have done better when he headed over in the 95th minute.

Rangers' novice manager proves a bit Special in besting Mourinho

If only Jose Mourinho's Fenerbahce players had delivered a performance as accomplished as the one he offered up at the final whistle.

After watching his side burgled in their own home by an increasingly familiar Rangers away Europa League display, the Portuguese landed far more blows on the

visitors than his team had managed.

Rangers should "calm down". The tie is "not over". Fenerbahce were "bad everywhere". They made "incredible, incredible mistakes".

The Scottish Premiership side were "as pragmatic as I was expecting". They defended "basically well" and

wasted time with "20 injuries". Goalkeeper Jack Butland "took 30 seconds every time he had the ball in his hands".

But despite that, Mourinho said, this 3-1 loss in Istanbul was "a good result" because the defeat "could have been bigger".

He was referring to the fact Rangers had

two Cyriel Dessers goals ruled out for offside after VAR reviews as the hosts struggled to quell their threat on the break.

Ultimately, Barry Ferguson's side had to settle for a Vaclav Cerny double to add to Dessers' early opener.

But, despite their domestic troubles, they are still well placed to set up a last-eight tie with either Roma or Athletic Bilbao. Not that Mourin-

ho agrees, of course.

"For me, I have to say that we deserved a punishment of this result," he said. "But if someone wants to ask me if it's over, no, I don't think it's over.

"The only thing I tell this is don't celebrate too much, because there is a second match to play, that's my only advice.

"If they celebrate after the second match I will congratulate them but

now calm down because it's not over."

Rangers interim head coach Ferguson agreed, albeit his words carried a little less flourish than those of his feted counterpart.

Little wonder. This was a man in just his third game as Rangers manager and with only some underwhelming stints in the Scottish third and fourth tiers to call upon.

Villa enjoy dream night in Belgium

Aston Villa will be favourites to progress to the Champions League quarter-finals after scoring two late goals to beat Club Brugge in

Belgium.

Leon Bailey had given the Premier League club a lightning start in the last-16 first-leg - Villa's first knockout tie in European football's premier competition since the 1982-83 quarter-finals.

Bailey marked his return to Belgium with a goal as the former Genk player produced a sumptuous half-volley after just two minutes and 15 seconds, following a

headed assist by Tyrone Mings.

It was a satisfying moment for Mings after the England defender gave away a needless penalty for handball when these sides met in the group phase in November, which resulted in Club Brugge scoring the only goal of the game.

But Villa's lead lasted just 10 minutes, with Maxim de Cuyper levelling with a low finish,

soon after Marcus Rashford had been denied by former Liverpool goalkeeper Simon Mignolet at the other end.

In a tight and tense contest, home captain Hans Vanaken went agonisingly close to making it 2-1 in the 69th minute with a header before ex-Norwich player Christos Tzolis wasted another big chance, blazing over from eight yards.

However, Villa scored two late goals in six minutes to take a handsome lead back to Birmingham.

Brandon Mechele put past his own keeper in the 82nd-minute while stretching to intercept a cross by Morgan Rogers to put Villa ahead and then substitute Marco Asensio made it 3-1 from the penalty spot after Matty Cash had been fouled.

The return leg is at Villa Park on Wednesday, 12 March (20:00 GMT)

■ Reds No. 1 proves unbeatable as late strike stuns dominant PSG

Liverpool completed one of the biggest smash and grabs in Champions League history in midweek to come away from their last-16 first leg against Paris St-Germain with a 1-0 win.

PSG completely dominated the game, with 27 shots, and Liverpool goalkeeper Alisson had to make nine saves.

But the hosts could not find an opener - and the Reds scored with their second shot of the night in the 87th minute.

Harvey Elliott netted with his first touch, after replacing Mohamed Salah, when he was picked out by Darwin Nunez.

Luis Enrique's side were shell shocked - and how they failed to score will go down as a mystery. Well, an Alisson-shaped mystery.

PSG forwards Ousmane Dembele and Khvi-

cha Kvaratskhelia in particular were unplayable at times.

Kvaratskhelia had a fine goal in the first half rightly disallowed by the video assistant referee (VAR) for offside.

The VAR again sided with Liverpool, more controversially, when Ibrahima Konate avoided a red card despite shoving Bradley Barcola over just outside the box.

Liverpool will host the second leg next Tuesday.

Brazil goalkeeper Alisson was the reason they came away from the French capital still in the tie.

He pulled off sensational saves to deny a host of PSG players including Dembele (twice), Kvaratskhelia (four times) and substitute Desire Doue (twice).

The visitors had managed precisely one shot before the goal, Luis Di-

az's off-target effort in the 44th minute.

But Elliott stunned the hosts 46 seconds after coming off the bench to replace top scorer Salah, who had a rare quiet night.

Alisson played a long ball up to Nunez, who controlled the ball and picked out Elliott in space.

Gianluigi Donnarumma got a touch to his first-time strike but could not stop it settling in the bottom corner.

That goal now makes Liverpool favourites to set up a quarter-final tie with Aston Villa or Club Brugge.

Since their big-money Qatari takeover in 2011, PSG have flattered to deceive in the Champions League.

Just as it looks as if they are getting things together, it all goes wrong.

This one felt like it was going to be different.

The runaway Ligue 1 leaders had won their past 10 games and were unbeaten in 22 matches.

Previous collapses had come from trying to fit star names and big egos into a team - including all of Kylian Mbappe, Neymar and Lionel Messi.

But this was a different PSG, more of a team with fewer true household

names.

Dembele had scored 20 goals in his previous 14 matches. Some of his dribbles had the Reds defenders on toast, especially in the first half. Kvaratskhelia, a January signing from Napoli, was sublime when running with the ball too.

The hosts felt as if they were winning everything on Wednesday, quicker to

every ball, and ending up with 70% possession.

Luis Enrique's team will point to the red card Parisian Konate could have been shown in the first half too.

But they were ultimately made to pay for not taking their chances - and now face a huge uphill task at Anfield in six days' time.

Blues take small bite out of Danish
