ELON UNITES THE BRITS!

■ Fake ads attacking tycoon appear on London Tube and bus stops

■ Musk mocked for declining sales of Tesla cars after multiple controversies

Guerilla adverts mocking Elon Musk and encouraging X users to delete their accounts have begun to pop up around London on Tubes and on bus stops.

Some of the adverts call the X owner and SpaceX billionaire, who has taken over as Donald Trump's efficiency czar, a Nazi, and troll the declining sales of Tesla cars.

"Hate doesn't sell, just ask Tesla," reads one of the mocked-up fake ads, showing a declining sales figure of the electric cars disappearing into Mr Musk's arm, which appears outstretched in the controversial salute he performed at Mr Trump's inauguration.

Another poster on the Tube advertises a fake fragrance called 'Elon's Musk', which is packaged in a bottle with a swastika on the front and said to be "pour wankers".

Videos of the posters being put up on the Victoria line have been uploaded on TikTok by a group called Everybody Hates Elon. At bus stops, one poster pictures a Tesla and states "goes from 0-1939 in three seconds," in a reference to

the Second World War. Another simply states, "Elon Musk is a belend".

Transport for London, the government body which regulates public transport in the capital, has signalled its determination to remove all such posters, saying it views them in the same way it does flytipping, the British term of illegal dumping of controlled waste.

TfL has said that it regularly inspects stations and bus stops for rogue advertising, and that anything unauthorised will be removed.

A spokesperson added: "These posters were not authorized by TfL nor our advertising partners."

Why now?

Public opinion in Britain has turned sharply against the Trump Administration since the Jan. 20th inauguration, fuelled by his radical reshaping of American foreign policy, open hostility to Ukrainian President Zelensky

and his stated aim to take over both Canada and Greenland.

And Mr Musk in particular has been withering in his criticism of Keir Starmer, repeatedly dubbing the PM 'two-tier Kier' on X and suggesting that Britain is heading for "civil war" due to its immigration and border policies.

Sales of Tesla

cars have fallen by up to 75 per cent across Europe as Mr Musk has come under fire for his foray into politics, which has included cutting government services and his backing for the far-right Alternative für Deutschland (AfD).

There have also been a band of Tesla owners who have put stickers on their cars to say they

were bought before the tech billionaire doubled down on his support for Donald Trump and other right-wing causes.

The London adverts may be brief but they have been met with some support online.

One posted on Bluesky: "Nice! Accurate, too. I hope there are more of these ads posted around every

major city in the world. Make all his brands toxic and tank their stock value to destroy his wealth. This man is a clear and present danger every day."

Another added: "Can't tell if that's a joke mocking him or an actual advertisement out of Musk's sick mind."

Mr Musk has not commented.

Brawling Labour MP to leave parliament

■ Feisty member for Runcorn given 10 week suspended sentence for repeatedly punching a constituent

Former Labour MP Mike Amesbury has said he will stand down from parliament after being given a prison sentence for repeatedly punching a constituent.

The Runcorn and Helsby MP told reporters he will begin the "statutory process" of winding up his office before resigning as an MP "as soon as possible".

His resignation will trigger the first by-election of Sir Keir Starmer's Labour government.

Amesbury was given a 10-week prison sentence, suspended for two years, after he admitted assaulting Paul Fellows.

In his first interview since the sentencing, Amesbury said he "regrets" attacking Mr Fellows "every moment, every day".

But Amesbury said he would have tried to remain an MP - a job he said was his "calling" - had he been given a lighter community sentence.

"I would have continued to serve my constituents, I was elected just seven or eight months ago," he said.

"And that would have been my intention, if I was able to, to contin-

ue."

Under parliamentary rules, if an MP receives a custodial sentence, a "recall petition" is triggered.

If at least 10% of his constituents had voted to remove Amesbury, a by-election would have been called - potentially ousting him as MP.

Asked about his future, Amesbury said: "I'm going to step aside at the earliest opportunity."

"I've got processes I must go through - there's a statutory process in terms of redundancies," he said.

Amesbury described the fallout from his court case as "difficult", but said he "owns" his mistake.

Amesbury defended continuing to take his MP wages - despite not appearing in House of Commons debates since the video of him punching Mr Fellows first surfaced in October 2024.

He said he carried out casework for his constituents, even while behind bars.

"I actually picked up some casework in prison," Amesbury said, as his office manager forwarded on "correspon-

dence".

"Life doesn't stop as an MP," he added.

Amesbury spent three nights in jail following his 10-week sentence being handed down at Chester Magistrates' Court on 24 February.

Chester Crown Court later suspended his sentence, allowing him to serve his time in the community instead of behind bars.

As part of his suspended sentence, Amesbury must carry out 200 hours of unpaid work, undertake an alcohol monitoring programme, go on an anger management course and carry out 20 days of rehabilitation work.

Campaigners had called for Amesbury to be stripped of his wages during his trial and imprisonment.

The Independent Parliament Standards Authority (IPSA), which regulates MPs' pay, said the rules mean that until a member is suspended as a result of a House of Commons disciplinary procedure they must be paid their salary.

Asked how he responded to people who might think he had been treated lightly in having

his sentence suspended, Amesbury said he had been "punished accordingly".

"I pleaded guilty at the

earliest opportunity in terms of the law," Amesbury said.

He told the BBC he is "going to lose the fami-

ly home", his livelihood and walk away with a criminal record.

"If people think that's lightly, so be it."

Keir Starmer scraps NHS England to put health service 'into democratic control'

■ Health secretary says end of 'biggest quango in world' is final nail in coffin of Andrew Lansley's 2012 reorganisation

Keir Starmer has brought the health service back under the control of ministers by abolishing NHS England.

The prime minister said the NHS should be overseen by politicians rather than an arm's-length body, as it would bring greater accountability.

Starmer's move reverses the unpopular shake-up of the NHS carried out by the former health secretary Andrew Lansley in the first years of the Conservative-Liberal Democrat coalition.

The health secretary, Wes Streeting, said it was the "final nail in the coffin of the disastrous 2012 reorganisation, which led to the longest waiting times, lowest patient satisfaction, and most expensive NHS in history".

In a speech about reshaping the state, Starmer said NHS England would be

abolished to "cut bureaucracy" and bring management of the health service "back into democratic control".

He said the move would free up cash for doctors, nurses and front-line services, and speed up improvements in the NHS, with the government aiming to slash

waiting lists by the next election.

Streeting has already presided over plans to reduce the size of NHS England by half, and its chief executive, Amanda Pritchard, is leaving at the end of the month.

Streeting said on Thursday that the government

Crossbow killer of three will never be released

■ Judge describes Kyle Clifford as “a jealous man soaked in self-pity — a man who holds women in utter contempt.”

■ Bereaved father and husband describes the triple killer as “a psychopath disguised as an ordinary human being”

A former British soldier who used a crossbow and a knife to murder his ex-girlfriend, her sister and their mother at their family home north of London was sentenced Tuesday to a whole-life order, meaning that he would never be released from prison.

Kyle Clifford, 26, had pleaded guilty in January to murdering Louise Hunt, 25, and her 28-year-old sister Hannah Hunt with a crossbow and their mother, Carol Hunt, 61, with a knife on July 9, 2024. He was convicted of three counts of murder, one of false imprisonment and two counts of possession of offensive weapons.

He was also found guilty of raping Louise during the “carefully planned” attack on the family.

Sentencing Clifford, Justice Joel Bennathan said he was “a jealous

man soaked in self-pity — a man who holds women in utter contempt.”

Clifford refused to turn up for the sentencing.

Prosecutors said he planned the murders for days, ordering the crossbow, knife, an air pistol and other items after becoming enraged when an increasingly concerned Louise ended their 18-month relationship.

‘violent misogyny’

During the case, the jury was shown evidence that Clifford gained access to the family home in the quiet residential neighborhood of Bushey, northeast of the capital, by deceiving the mother on the pretext he was returning Louise’s belongings, before brutally stabbing her to death.

Clifford “lay in wait” for an hour for Louise to enter the house, before restraining, raping and ultimately murdering

her with a crossbow. He then fatally shot her sister, Hannah, when she returned to the property after work.

Prosecutors said that less than 24 hours before he carried out the attacks, Clifford had searched for the podcast of the self-styled misogynist influencer Andrew Tate. They said the “violent misogyny” promoted by Tate “fueled” Clifford’s attacks.

Following the murders, police launched a manhunt for the suspect before he was found injured the following day in a cemetery in Enfield, north London. Clifford had shot himself in the chest with the crossbow. He remains in a wheelchair, having been paralyzed from the chest downwards.

BBC racing commentator John Hunt, father to Louise and Hannah and husband of Carol, described the former soldier

as a psychopath disguised as an ordinary human being.

grace and empathy

Paying tribute to his daughter and the way she had shown grace and empathy when breaking up with Clifford, Hunt used an emotionally charged victim impact statement to describe how the love of his family sustained him.

“I hope women round the world will take Louise’s bravery as a shining beacon for their lives,” he said, citing his daughter’s disgust at Clifford’s racism and belittling language. “If you feel enough is enough, then it is.”

In his victim impact statement, Hunt said he had initially questioned why he needed to detail the impact of having three family members murdered.

“But then I realised that this was my final opportunity to say what I wanted to say, specifically to you, Kyle, words that will also be directed to your family, who will carry guilt forwards with them for the rest of their lives,” he said.

“They knew about the weapons, they knew,” he added, in a reference to conversations Clifford had had with his sister and brother about his possession of a crossbow.

“I also want to confirm to the world the truth, especially how Louise conducted herself within a textbook mature break-up on her part, understanding the conflict of saying goodbye to someone she once loved, but not allowing those memories to cloud her certain knowledge that you, Kyle, simply failed to be the person she needed. You failed.”

Clifford began plotting the attack two days after she ended their 18-month relationship because he was angry at being rejected. He was also angry at the Hunt family because he “correctly assumed” they had advised Louise to break up with him.

New evidence may free ‘killer’ who has already served 38 years

A CONVICTED murderer who has spent nearly 40 years in jail for battering a bride-to-be to death has had his case sent to the Court of Appeal following new DNA evidence.

Peter Sullivan, 64, dubbed “The Wolfman”, is serving life in prison for killing florist Diane Sindall, 21, with a crowbar in 1986 in Bebington, Merseyside.

Police said 21-year-old Ms Sindall left her blue Fiat van on Borough Road, Birkenhead, after it ran out of petrol and had been walking to an all night garage when she was at-

tacked.

But the recent discovery of crime-scene DNA from an unknown man could be a “pivotal moment” in Sullivan’s most recent appeal, his lawyers have said.

The Crown Prosecution Service (CPS) has been given a month to declare whether it will contest Sullivan’s appeal against the conviction.

If exonerated, the 67-year-old would likely be the victim of the UK’s longest miscarriage of justice involving a living inmate.

At a short hearing at the Court of Appeal in

London on Tuesday, the CPS said it did not dispute the results of new forensic tests that had uncovered DNA from sperm cells.

Sullivan watched impassively via video-link from HMP Wakefield, speaking only to confirm he could hear the proceedings.

Shortly after midnight on 2 August 1986, Miss Sindall was ambushed while walking home from the Wellington pub in Bebington, where she worked as a barmaid.

Her body was found that afternoon in an alley off Borough Road.

Detectives at the time

described her injuries as the “worst they had ever seen”.

Some of the 21-year-old’s belongings were later found burnt in woodland on Bidston Hill, about five miles away.

Sullivan was arrested and repeatedly interviewed without having a solicitor present.

While he initially admitted killing Miss Sindall, he then retracted his confession.

Sullivan’s conviction was based upon the confession, as well as circumstantial evidence relating to his whereabouts, and the assertion that a bite

mark suffered by Ms Sindall appeared to match his teeth.

After he was found guilty, Sullivan was advised he had no grounds for appeal.

His first application to the Criminal Cases Review Commission (CCRC) - the body set up to look for po-

tential miscarriages of justice - was rejected in 2008.

He applied again in 2021, after having first tried to persuade the Court of Appeal to re-examine his case.

The CCRC then carried out new forensics work, leading to the discovery of an unknown man’s DNA.

was “abolishing the biggest quango in the world” by getting rid of NHS England. Its functions, he said, would be taken into the Department of Health and Social Care (DHSC), and the merger would take about two years.

He had said before the election he did not want to be distracted by a massive top-down reorganisation of the NHS. However, he had also criticised the duplication of work between the DHSC and NHS England.

Whitehall sources said No 10 and Streeting, advised by the former Labour health secretary Alan Milburn, had quickly become frustrated with the inefficiency of the structure and concluded the best way of saving time and money was a straightforward abolition.

However, unions are concerned that Starmer's drive to save money in the civil service through reorganisations and technology may undermine morale further.

Pressed on whether the move to cut jobs in NHS England and other public bodies was a return to austerity, Starmer said this was not the case. “Part of the problem we've got with our public services is what was done to them a decade or so ago, so we're not going down that route. None of our plans are going down that route,” he said.

The Conservatives did not oppose the abolition of NHS England when Streeting addressed the House of Commons on Thursday. The Lib Dems said there was “no doubt we need big changes like this to fix the NHS after the Conservatives left it on its knees” but called for a greater focus on overhauling social care.

Russian skipper of crash vessel arrested

■ **Captain of The Solong detained by police over his suspected gross negligence in the death of one crew member**

THE CAPTAIN captain of a cargo ship that collided with an anchored US tanker just off the Yorkshire coast has been arrested on suspicion of manslaughter, police have announced.

The captain is a Russian national who remains in U.K. police custody, the vessel's owner said Wednesday, as it emerged that the ship failed several safety checks last year.

The 59-year-old man, who hasn't been named by authorities, was detained by police over his suspected gross negligence in the death of one crew member who fell overboard during the collision.

Shipping company Ernst Russ, which owns the Portugal-flagged cargo vessel Solong, said that the ship's 14 crew were a mix of Russian and Filipino nationals.

U.K. authorities say they have found no evidence of foul play in the crash, and there is nothing so far to indicate that it's connected to national security. Humberside Police said that detectives were conducting inquiries alongside port-

ner agencies.

The U.K. Marine Accident Investigation Branch is also involved in investigating what caused the Solong, bound from Grangemouth, Scotland, to Rotterdam, Netherlands, to hit the stationary tanker, which was anchored about 10 miles off of Grimsby.

The investigation is being led by the U.S. and Portugal, the countries where the vessels are flagged.

Port inspection documents show the Solong failed steering-related safety checks in Dublin, Ireland, in July, with the vessel's “emergency steering position communications/compass reading” unreadable. Inspectors found a total of 10 deficiencies, including “inadequate” alarms, survival craft “not properly maintained” and fire doors “not as required.”

An inspection in Scotland in October found two other deficiencies. The ship wasn't detained after either inspection.

The cargo ship collided Monday with MV Ste-

na Immaculate, a tanker transporting jet fuel for the U.S. military in the North Sea, setting both vessels ablaze. One sailor from the Solong is missing and presumed dead. The other 36 crew members from the two vessels were brought safely ashore, with no major injuries.

The Solong was drifting and still smoldering Wednesday, but is likely to remain afloat rather than sinking, officials

said.

The 183-meter (596-foot) Stena Immaculate was operating as part of the U.S. government's Tanker Security Program, a group of commercial vessels that can be contracted to carry fuel for the military when needed.

The collision sent jet fuel pouring into the sea and sparked fears of significant environmental damage. Environmentalists said that oil and

chemicals posed a risk to sea life, including whales and dolphins and to birds, including puffins, gannets and guillemots that live on coastal cliffs.

The U.K. coast guard agency said that no new pollution had been reported since the initial incident, and environmental campaigning group Greenpeace said the impact on marine life may not be as bad as first feared.

Uproar after couple who reported migrant stowaway in their camper van to police are fined £1,500

A couple who were fined £1,500 for unknowingly bringing a migrant into the UK have called for the system to be overhauled.

Prime Minister Sir Keir Starmer has asked the Home Office to review its action after Adrian and Joanne Fenton found the intruder after driving from France to their home in Essex.

Retired firefighter Mr Fenton said: “When you call the police, you don't expect to be fined for what you think is doing the right thing.”

The Home Office said penalties were “designed to target negligence rather than criminality”.

A spokeswoman added it was reviewing an objection made by Mr and Mrs Fenton.

The couple, who live in Heybridge, called the police after finding the intruder hidden inside the cover of a bike rack on their motorhome on 15 October.

It followed a six-hour drive from France, entering the UK via ferry.

Speaking during Prime Minister's Ques-

tions, Sir Keir said he was “concerned” to hear what had happened and stressed it was “important” the case was looked into.

‘Absurd’

Mr Fenton, 57, said it was “absolutely fantastic” to hear the prime minister was aware of the dispute.

“We're very pleased it has now reached that level,” he said. “We don't feel holidaymakers should be brought into this process.”

“The ultimate goal for us is it shifts away

from holidaymakers and they change the process.”

The ongoing row inspired a YouGov poll, which asked more than 4,500 British adults if they thought the fine was fair.

A total of 81% of respondents said it was “unfair”.

Mrs Fenton, 55, added: “The support we've had has been absolutely unbelievable and we can't thank people enough.”

The issue was brought to Sir Keir's attention by the Conserva-

tive MP for Maldon Sir John Whittingdale.

He said the couple acted “entirely responsibly” in reporting the migrant, who told attending police he was a 16-year-old from Sudan.

Sir John said: “I can see the point of the rules, but this is enforcing them in a way which I cannot believe was ever intended and most people would regard as absurd.”

The Home Office said it was committed to stopping people from illegally entering the country.

United unveil plans for new £2bn, 100,000 seater stadium

■ Jim Ratcliffe vows to revive ailing club with new, state-of-the-art “Wembley of the north”

Manchester United plan to build a new £2bn, 100,000-seat stadium that will be the biggest in Britain, next to the existing Old Trafford, the club announced on Tuesday.

The stadium is expected to be completed in five years, the Premier League side added.

“Today marks the start of an incredibly exciting journey to the delivery of what will be the world’s greatest football stadium, at the centre of a regenerated Old Trafford,” United’s co-owner Jim Ratcliffe said in a statement.

The British billionaire had been open about his desire for a new, state-of-the-art “Wembley of the north” since he became

a minority owner in February of last year, and the club have been studying whether to redevelop the existing stadium, which has been the club’s home since 1910, or build a new one.

United appointed Foster + Partners in September to develop a masterplan for the area around Old Trafford as part of a regeneration project.

The club unveiled architectural designs for the new stadium, which will feature an umbrella design, at an event on Tuesday morning in London.

“This has to be one of the most exciting projects in the world today,” Norman Foster, Foster + Partners’ executive chairman, said in a statement.

“It all starts with the fans’ experience, bringing them closer than ever to the pitch and acoustically cultivating a huge roar.

“The stadium is contained by a vast umbrella, harvesting energy and rainwater, and sheltering a new public plaza that is twice the size of Trafalgar Square.”

Foster was optimistic that they could speed up the building process by utilising the region’s canal network.

“Normally a stadium would take 10 years to build,” Foster said. “We halve that time. Five years.

“How do we do that? By prefabrication. By using the network of Manchester Ship Canal. Bringing

it back to a new life, shipping in components, 160 of them...”

The stadium will be part of a wider regeneration of the Old Trafford area, with British finance minister Rachel Reeves recently giving government backing for the plans.

But not everyone is a fan of the idea. Chief among the critics is club legend Eric Cantona, who last summer warned against demolishing the iconic old stadium.

“No, never,” he said to the idea. “I think the stadium is very important. I remember the first day I came to Manchester United, I could feel the ghosts of the club, of the players, and everything.

“The energy of the club. The history. It’s a heritage. You can feel the soul of the club, you can feel the energy of the past strongly. It’s very important.

“I cannot imagine Manchester United without Old Trafford. I cannot imagine Liverpool without Anfield or Real Madrid without the Santiago Bernabeu.

“I think some clubs change their stadiums and lose their soul, like Arsenal for example. When they left Highbury, they lost the soul of this club.”

And former Arsenal midfielder and Sky Sports pundit Paul Merson aired similar reservations, claiming the club were more interested in building the stadium than they are in producing a competitive football team that challenges for silverware.

“I’ve got no interest at all, I think it’s pathetic. If I’m a Man Utd fan I’d be fuming,” Merson said.

“Old Trafford is already one of the biggest stadiums in the Premier League. I can understand

if it’s Chelsea - they need a bigger capacity stadium to keep on living with the big boys.

“But when it’s Manchester United, who have a huge stadium, why would you need another stadium? They need new players, they need a team. This is what I can’t work out.

“I hear Sir Jim Ratcliffe going ‘England will be able to play here’. Don’t worry about the national team, worry about Man United and getting them into the top six. I’m flabbergasted at what I’m seeing.”

Old Trafford has been Manchester United’s home since 1910.

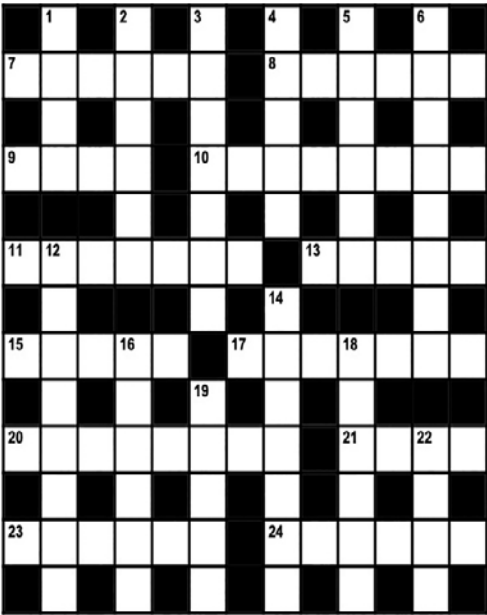
The club would continue to play at Old Trafford until the new stadium was ready.

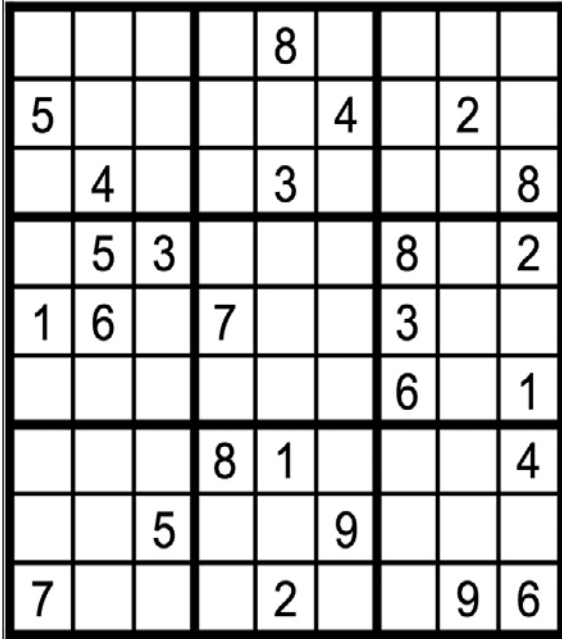

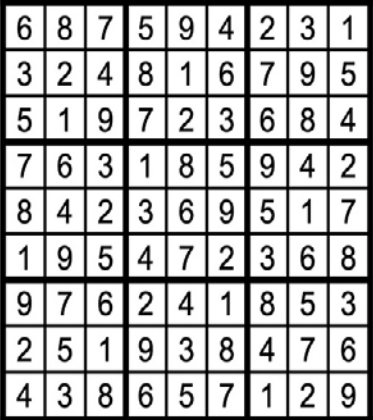

McClure brings a raw intensity to the role, often communicating far more through a single glance or the subtle tremor in her voice than with words. It's a performance that resonates deeply, capturing the mental exhaustion and anxiety of a woman who is often forced to make split-second decisions with life or death consequences.

Lana's relationship with her partner Joel Nutkins, played by Adrian Lester, is another key strength of the show. Joel is her dependable and experienced colleague, the calm to Lana's often tempestuous temperament. Their dynamic offers a layer of emotional depth to the series, particularly as the pressure of their job begins to take its toll.

While Lana's character is defined by her sense of responsibility and determination, Joel is more pragmatic, though no less affected by the constant threat of danger. Lester, known for his roles in *Hustle* and *The Night Manager*, brings a level of warmth and vulnerability to Joel, making him a character that feels both grounded and deeply human in an otherwise high-octane world.

The supporting cast also delivers solid performances, rounding out the ensemble with a sense of authenticity. From the various members of the bomb disposal team to the police higher-ups, each character is thoughtfully developed and contributes to the overall tension and complexity of the show. There's a palpable sense of cam-

aderie within the team, but also a feeling of isolation as these characters grapple with the personal and professional dangers of their work. The stakes couldn't be higher, and the emotional costs of failure are enormous.

At its core, *Trigger Point* is a thriller about life and death—literally. The bomb disposal team is thrust into perilous sit-

uations where every decision could mean the difference between life and death, both for the officers and for civilians. The sheer suspense of waiting for a device to be defused, or worse, waiting for it to go off, is a powerful element that drives the narrative. The series expertly plays with the tension of these moments, making viewers feel the weight

of each countdown, each dangerous scenario, as if they too were standing on the precipice of disaster.

Trigger Point is a reminder of why British television continues to excel in the thriller genre. It's a series that combines edge-of-your-seat action with emotional depth, creating a viewing experience that is both thrilling and thought-provoking.

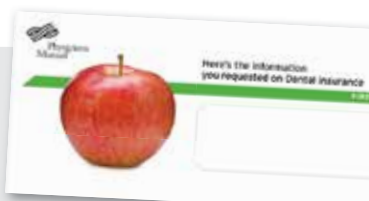

Villa's Brugge cruise

No drama as experienced campaigner Emery guides his men to quarter final date with PSG

Aston Villa completed a comfortable passage into a Champions League quarter-final with Paris St-Germain after cruising to victory against Club Brugge at Villa Park on Wednesday night.

Unai Emery's side were in prime position as they protected a 3-1 advantage from the first leg in Belgium, putting the tie out of the reach of the visitors following the half-time introduction of on-loan talisman Marco Asensio.

A risk-free first 45 minutes was only notable for Club Brugge defender Kyriani Sabbe's

16th-minute red card for hauling back Marcus Rashford as he chased keeper Emiliano Martinez's long clearance.

Asensio, outstanding since his arrival from PSG, secured Villa's passage into the last eight five minutes after coming on with a neat finish from Leon Bailey's clever pass.

Ian Maatsen added the second from close range seven minutes later, his first for the club, following good work by Morgan Rogers, then Asensio added his second

and Villa's third after 61 minutes. It was a simple finish set up perfectly by

Rashford.

It means Emery and Asensio will both face their former club, conquerors of Liverpool at the last-16 stage, in the last eight of the Champions League.

Unai Emery's European expertise, which brought him three Europa League triumphs with Sevilla and another as Villarreal coach, was on show as Aston Villa reached the Champions League last eight in consummate fashion.

Emery ensured Villa did not fall foul of any Club Brugge counter punches in a first half cloaked in caution, their

cause helped by the Belgians being reduced to 10 men following Sabbe's sending-off.

Once Villa had reached first half without any alarms, Emery stepped up the pace with the introduction of Asensio and Bailey.

The change worked perfectly as the pair combined for Villa's first goal, effectively snuffing out any slim chance of a Club Brugge comeback after they had played some neat first-half football without posing any serious threat.

Villa pressed home their advantage with two more quick goals

as the Belgians subsided, Asensio once more proving what a quality addition he has been since signing on loan from PSG. These two goals against Club Brugge took his tally to seven goals in eight games.

And the good news for Villa and Emery is Asen-

sio is able to play against his parent club in the last eight under European football legislation.

He brings class and experience to Villa after winning the Champions League three times at Real Madrid, the deal proving to be a masterstroke.

Formidable PSG bring down curtain on Reds' UCL hopes

Liverpool's Champions League ambitions were ended on Tuesday after they lost on penalties to an outstanding Paris St-Germain side after a night of drama at Anfield.

PSG, needing to claw back a 1-0 deficit from the first leg at home, demonstrated how they have matured under coach Luis Enrique as they knocked out a Liverpool side touted as favourites to win the tournament.

Ousmane Dembele's early goal provided the platform for the turnaround, with Liverpool unable to break the French visitors down, while PSG were a constant threat.

PSG's victory over two legs was thoroughly deserved, with keeper Gianluigi Donnarumma emerging as their hero in the shootout, saving from Darwin Nunez and Curtis Jones before Desire Doue hammered home the winning spot-kick in front of joyous

fans.

Liverpool made a lightning fast start in an attempt to extend that first-leg advantage, with Mohamed Salah twice coming close in front of the Kop, which was in expectant mood.

With Liverpool making the running, there was always the chance PSG's outstanding strikeforce could punish them on the counter and so it proved after only 12 minutes - with a large helping hand from the home defence.

Bradley Barcola's cross was routine, but a communication breakdown between Alisson and Ibrahima Konate proved costly, the defender knocking the ball out of the keeper's reach for Dembele to pounce from almost on the goal-line.

PSG had other opportunities but could not cash in, Alisson rushing out to save at the feet of Dembele and Khvicha Kvaratskhelia firing off target when well placed.

Liverpool mounted sustained pressure after the break but struggled to break down PSG's resilient rearguard, although it took a fine clawing save from Donnarumma to keep out Luis Diaz's header, while substitute Jarell Quansah struck the post and Dominik Szoboszlai had an effort ruled out for offside.

PSG were by far the better side in extra time, with Alisson making a magnificent save from Dembele before Liverpool's fate was sealed on penalties.

Liverpool players slumped to the turf in disappointment as the fates and fortunes of the Champions League were illustrated in this thrilling last-16 tie that provoked all the emotions on a classic European night at Anfield.

Arne Slot's side have barely broken stride as they topped the Champions League table and raced 15 points clear in the Premier League - but

this is the biggest setback Liverpool and their Dutch coach have suffered this season.

Ironically, Liverpool played much better in defeat at Anfield than they did when winning in the Parc des Princes in the first leg, but that was no consolation as this time luck did not smile on them as they were denied by the woodwork and then on penalties, when Donnarumma's expertise came to the fore.

And most of all, they were frustrated by a top-class PSG side who are shaping up as potential Champions League win-

ners.

Anfield provided its usual thunderous atmosphere but Liverpool could not quite deliver, looking leggy and second best in the added 30 minutes.

Liverpool will need to recover swiftly, with the Carabao Cup final against Newcastle United at Wembley on Sunday, but this was a defeat that will hurt deeply as they would have had Champions League expectations far beyond the last 16.

Trent Alexander-Arnold is expected to miss Sunday's final after limping off Tuesday

night.

In more positive news, Ibrahima Konate's withdrawal during the PSG loss could be down to fatigue rather than injury.

Manager Arne Slot told his post-match press conference: "I have to ask but for me Ibou was more that he was tired than it was an injury. With Trent, he had to come off. That's never a good sign.

"And from what I heard from people that saw the images or how he got injured, that didn't look very good. So I would be surprised if he is available for Sunday."

Bruno proves Real hero for Red Devils

■ Hat trick hero eases United past Sociedad

Manchester United skipper Bruno Fernandes scored a hat-trick to lead his side to victory against 10-man Real Sociedad at Old Trafford and book a Europa League quarter-final encounter with French club Lyon.

Needing a victory to keep alive their hopes of marking Ruben Amorim's first year in charge with silverware and knowing the tournament is their only realistic chance of securing European football next season, United got off to the worst possible start as Mikel Oyarzabal scored from the spot after being brought down by Matthijs de Ligt.

Thankfully for the hosts, the were level within six minutes as Fernandes kept his cool after Igor Zubeldia had taken Rasmus Hojlund down as the Dane was bearing down on the Sociedad goal.

Remarkably, it took a third penalty of the night to get United's noses in front.

Aritz Elustondo complained long after it was ruled he had fouled Patrick Dorgu. It made no difference, and for the third time, the goalkeeper went the wrong way as Fernandes found the net for from the spot for his 14th goal of the season.

The Spanish visitors' last chance seemed to disappear midway through the second half when Jon Aramburu was sent off for hauling down Dorgu, who would have been through.

But just for good measure, United struck twice more before the end.

Fernandes completed his second hat-trick for the club with a low finish across goal and into the far corner before fellow Portugal international Diogo Dalot drilled home a fourth in stop-

page time.

This was a positive insertion into a turbulent week at Manchester United.

It began with widespread protests against the Glazer family, Manchester United's majority owners before Sunday's draw with Arsenal.

Fears about summer spending were raised on Monday by minority owner Sir Jim Ratcliffe's claim the club was in danger of going bust by the end of the year without his wide-spread cost cutting. Those concerns were played down by chief executive Omar Berrada in an interview with broadcaster TNT before Thursday's game.

However, Ratcliffe also condemned some of Amorim's players as "overpaid" and "not good enough" in a devastating critique during an interview with the BBC.

The grand £2bn sta-

dium plans unveiled on Tuesday merely added to a sense of uncertainty, particularly as United's current debt, including outstanding transfer payments, is hovering around the £1bn mark.

Into this maelstrom stepped Fernandes.

Former United skipper Roy Keane may harbour serious questions about

the 30-year-old's application, leadership skills and team ethic.

But, in a crisis, the former Sporting midfielder is the player most likely to step up.

He knew the consequences of failure when he went to take his first penalty and did look slightly nervous as he waited for the referee's

whistle to signal it was time to step up. But Fernandes kept his cool, just as he did at the start of the second half.

His final finish merely confirmed his man-of-the-match status. Keane may rail against it, but without Fernandes United would be in a far greater mess than they already are in.

Double Dutch for wizard Wilson

Wilson Odobert scored twice to save Tottenham Hotspur's season as they overcame a first-leg deficit to beat AZ Alkmaar and reach the Europa League quarter-finals on Thursday.

Sitting 13th in the Premier League and out of both domestic cups, this competition is Spurs' only remaining chance of success.

They were poor in the first leg last week in the Netherlands, losing 1-0, but much improved at home on Thursday.

Odobert opened the scoring with his first goal for the club when Son's high pressing won the ball for Dominic Solanke, who picked Odobert out in space to fire into the top corner.

Tottenham took the lead in the tie early in
