Harry: could he be yanked out of USA?

PRINCE HARRY's right to live in the USA looked in doubt this week after documents relating to his US visa application were unsealed in court.

They are heavily redacted, however, and no details have been given as to what Prince Harry put on his immigration form.

A US court had ordered the release of the documents based on a freedom of information request by the Heritage Foundation, a conservative US think tank in Washington DC.

The foundation alleges that the prince concealed his past use of drugs, which should have disqualified him from obtaining a US visa.

The allegations are around his claims in his memoir *Spare*, where he referred to taking cocaine, marijuana and psychedelic mushrooms.

Application forms for US visas specifically ask about current and past drug use.

Admissions of

drug use can lead to non-immigrant and immigrant visa applications being rejected, although immigration officers have discretion to make a final decision based on different factors.

In the event, very little information was disclosed in the documents which were released on Tuesday.

The prince's visa form has not been released.

'foreseeable harm'

Instead, the documents that were released are supporting declarations and court transcripts created in the course of Heritage Foundation's case.

They reveal that the US government previously told a court that the duke could be subjected to harassment if his visa records were made public.

A chief freedom of

information officer within the US Department for Homeland Security (DHS) could be seen to argue that releasing the material "would potentially expose the individual to harm from members of the public".

The declaration from Jarrod Panter, submitted to the court in April last year, reads: "The USCIS (United States Citizenship and Immigration Services) routinely protects from disclosure the non-immigrant/immigrant status sought by third parties who do not have permission from the beneficiary to receive this information."

"To release such information would potentially expose the individual to harm from members of the public who might have a reason to manipulate or harass individuals de-

pending on their status in the United States."

The declaration added: "To release his exact status could subject him to reasonably foreseeable harm in the form of harassment as well as unwanted contact by the media and others."

Sam Dewey from the Heritage Foundation said he believes the DHS has not provided all its papers. He said he is "frustrated" and that this is "not the end of the road".

Dewey expects the next move to be a "sort of filing" that could lay out the next steps, adding: "We may well have another lawsuit against Department of Homeland Security." He accuses the prince of privilege, alleging he has benefited from his "wealth and status" by being allowed to live in the US.

Harry moved to the US with his wife Meghan in 2020 after stepping down as a

working royal. It is not clear what visa he entered the country on, while the duchess is a US citizen.

President Donald Trump previously ruled out deporting Prince Harry in February, telling the New York Post "I'll leave him alone... He's got enough problems with his wife. She's terrible."

Meghan has been a vocal critic of Trump in the past, labelling him a "misogynist".

Warm welcome for new Canadian Prime Minister

King Charles gives Mark Carney the Royal treatment while underlining UK-Canada bonds as Trump threats continue

King Charles gave a warm welcome to the new Canadian Prime Minister Mark Carney when he visited Buckingham Palace.

It was another symbolic gesture of support for Canada from a King, wearing a red tie, who has to send coded signals rather than spell things out in words, as Canada faces threats from US President Donald Trump.

But the King has sought to make clear his commitment to Canada - and if it had not been for his cancer diagnosis, he would have travelled there for an intended visit in 2024.

There are also suggestions that once Canada's election is out the way, a visit to Canada will be a priority, where he can further demonstrate his support.

The new Canadian prime minister told the King that his Order of Canada pin had broken this morning. The King joked: "Do you want mine?"

The King congratulated Carney on becoming

the new PM, ushering him to a seat, and perhaps hoping that the broken pin was not a symbol of a Commonwealth relationship under strain.

"These things are rather important," said the King, ahead of a 30-minute conversation with no one else in attendance.

Carney later went on to meet prime minister Sir Keir Starmer at Downing Street.

Sir Keir hailed the relationship between the two countries and said they had "so much in common - shared history, shared values, shared King."

Carney said he was "grateful for the welcomes and the constructive discussions" with Starmer and French president Emmanuel Macron, whom he had met earlier in the day.

At a news conference, he was asked if he felt let down by the lack of public support for Canada from other allies, given Trump's trade war with Canada, and his remarks about making Canada the 51st state of the US.

"We don't need another country to validate our sovereignty, we are sovereign, we don't

need praise from another country, we are proud in and of ourselves," he said, adding that Sir Keir had made a point of referring to Canada's sovereignty and to "our shared sovereign in King Charles III."

The meeting with Carney is the latest scene in an intricate diplomatic balancing act for a King who is head of state of both the UK and Canada.

King Charles has to show solidarity with Canada without disrupting the UK's relationship with Trump.

The King also has to avoid getting directly involved in politics - and has to speak on advice of ministers. Whatever he might personally believe about Trump's comments about taking over Canada, the King has to keep his thoughts to himself.

So messages from the King are sent in symbolic displays. In case anyone missed the signs over Canada, there have been multiple moments. And then some more.

For instance when the King visited aircraft carrier HMS Prince of Wales on Sunday, he appeared wearing a set of Canadian medals.

William pays tribute as the last of 'The Few' passes away

The nation owes "so much" to Battle of Britain pilot John "Paddy" Hemingway, the Prince of Wales said in an emotional tribute to the hero after he died aged 105.

The former fighter pilot was the last surviving member of The Few, as Winston Churchill hailed those who battled the Luftwaffe in 1940 against the threat of Nazi invasion.

The Prince of Wales said: "We owe so much to Paddy and his generation for our freedoms today. Their bravery and sacrifice will always be remembered. We shall never forget them."

Dublin-born Mr Hemingway joined the RAF as a teenager before the Second World War broke out.

In 1940 he destroyed a German airliner and the following day he downed a Luftwaffe plane, but his Hurricane fighter was hit by anti-aircraft fire and he had to make a forced landing. He then became one of the frontline members of 11 Group's response to daily attacks by German aircraft, which went on to be known as the Battle of Britain.

His logbook records up to five daily sorties he and his fellow pilots undertook. In August 1940, amid intense dogfights, he was forced to bail out of his Hurricanes twice.

In 1941 he was awarded the Distinguished Flying Cross and mentioned in despatches.

He went on to serve as an air fighter controller in D-Day operations, and in 1945 he joined the Mediterranean Allied Air Forces with 324 Wing.

Sir Keir Starmer said: "He never considered himself a hero and often referred to himself as the 'Lucky Irishman', a man simply doing his job, like so many others of his generation. Their sense of duty and service secured our freedom, and we shall never forget them."

Defence Secretary John Healey added that brave Mr Hemingway "embodied the deep courage of that incredible generation".

Hemingway remained a reluctant hero right to the end. At a reception at the British Embassy in Dublin to celebrate his 105th birthday, he said: "I am here because I had the staggering luck to fight alongside great pilots, flying magnificent aircraft, with the best ground crew, in the best air force in the world."

His son Brian said: "He was not particularly interested in the past. Like so many of his generation, he doesn't feel as though he did anything special. But he liked the idea that he was last Irishman to have fought in the Battle."

PM supports bid to show Netflix hit in UK schools

UK Prime Minister Sir Keir Starmer supports a campaign for TV series 'Adolescence' to be shown in schools to combat an alarming rise in toxic masculinity and violence.

Four-part British drama 'Adolescence' debuted last week on Netflix to widespread acclaim. It follows the events after a 13-year-old boy murders a girl in his school year. Each episode is a one-take insight into different aspects of the murder's fall-out: from the initial arrest, to the investigation at a school, a psychological assessment of the boy, and his parents' response.

Hanging over the drama is the question of how a culture of toxic masculinity has led to the tragedy. Particularly in the school episode, the influence of male content creators like Andrew Tate on young boys is highlighted as a dangerous radicalizing force in British society.

Writers and co-creators Jack Thorne and Stephen Graham have said they want the show to create real change in society. "I want it to be shown in schools, I want it to be shown in parliament. It's crucial because this is only going to get worse," Thorne said.

UK Prime Minister Keir Starmer has said that he watched the show with his 16-year-old son and 14-year-old daughter. Asked if he backed 'Adolescence' being broadcast in parliament and in schools, he said: "It's a very good drama to watch. This violence carried out by young men, influenced by what they see online, is a real problem. It's abhorrent and we have to tackle it."

Earning his stripes: Newcastle to give Howe the freedom of the city

Eddie Howe will be awarded the freedom of the city following Newcastle United's historic Carabao Cup win.

The manager led Newcastle to a 2-1 victory over Liverpool on Sunday, securing the club's first piece of major silverware since 1969.

He is now in line to receive the highest civic honour the city can bestow and one that has been awarded to legendary figures in Newcastle's football history - including Sir Bobby Robson, Alan Shearer and Jackie Milburn.

Meanwhile, Blyth-born Dan Burn had been nominated for the Freedom of Northumberland following his man of the match performance.

City council leader Karen Kilgour said she was "delighted" to nominate

Howe.

"Generations of supporters have never seen their beloved club lift a domestic trophy, and under his leadership we all now have treasured memories of a truly unforgettable day," she said.

'great victory'

The honour is expected to be formally confirmed at a full council meeting later this year.

On Monday, the leader of Northumberland County Council Glen Sanderson said he intended to nominate Burn for the Freedom of Northumberland after the 32-year-old scored Newcastle's first goal at Wembley in 25 years.

"It's a great victory for the region and the fact a local lad from Blyth played such a crucial

part of the journey is wonderful," he added.

Celebrations are set to continue in the city with the club announcing the date for an open-top bus parade.

The Magpies issued a "save the date" for 29 March, after the international break, to celebrate Sunday's Carabao Cup

glory.

It is the club's first major domestic trophy in 70 years, with supporters expected to line the streets of Newcastle to watch the team parade the silverware.

The honours continue to stack up for the winning side.

Northumberland Na-

tional Park has announced it has temporarily renamed Elsdon Burn Walk, near Elsdon, to "Big Dan Burn Walk".

Once the centre of defence in the Border Reiver battles, a spokesperson said it "seems like a fitting place to mark Dan's and the whole teams' heroic achievements".

Gang convicted of solid gold toilet theft

A thief who swiped a golden toilet from an English palace was convicted Tuesday along with an accomplice who helped cash in on the spoils of the 18-carat work of art insured for £5 million pounds (more than \$6 million).

Michael Jones had used the fully functioning one-of-a-kind latrine as he did reconnaissance at Blenheim Palace - the country mansion where Winston Churchill was born - the day before the theft, prosecutors said. He described the experience as "splendid."

'audacious raid'

He returned before dawn on Sept. 14, 2019, with at least two other men armed

with sledgehammers and crowbars. They smashed a window and pried the toilet from its plumbing within five minutes, leaving a damaging flood in their wake as they escaped in stolen vehicles.

"This was an audacious raid which had been carefully planned and executed," prosecutor Shan Saunders said. "But those responsible were not careful enough, leaving a trail of evidence in the form of forensics, CCTV footage and phone data."

The purloined potty has never been recovered but is believed to have been cut up and sold.

The satirical work, titled "America" by Italian conceptual art-

ist Maurizio Cattelan, poked fun at excessive wealth. It weighed just over 215 pounds. The value of the gold at the time was £2.8 million (\$3.6 million).

The piece had previ-

ously been on display at The Guggenheim Museum in New York. The museum had offered the work to U.S. President Donald Trump during his first term in office after he

had asked to borrow a Van Gogh painting.

Jones, 39, was convicted of burglary in Oxford Crown Court.

The theft was planned by James

Life sentence for 'truly evil' teen who hoped to become worst mass murderer in British history

■ Nicholas Prosper killed his mother and two siblings before planned attack on local primary school was thwarted

■ Doctor had diagnosed killer as suffering from autism spectrum disorder and displaying "psychopathic traits"

A "truly evil" 19-year-old who murdered his mother and two younger siblings as part of a failed plot to kill 30 children and become the worst mass murderer in British history has been jailed for life with a minimum term of 49 years.

Nicholas Prosper admitted murdering Juliana Falcon, 48, Kyle Prosper, 16, and Giselle Prosper, 13, last month. Their murders were part of a wider plot to storm a morning assembly at his former primary school with a shotgun and "cause the biggest massacre of the 21st century".

He also admitted buying a shotgun without a certificate, possession of a shotgun with intent to endanger life and possession of a kitchen knife in a public place.

Prosper initially refused to attend Luton crown court on Wednesday but was ordered to appear by Mrs Justice Cheema-Grubb, causing the start of the hearing to be delayed. He kept his head in his hands as she read out her remarks and he refused to stand to hear his sentence.

violent struggle

Addressing Prosper, the judge said: "You intended to unleash disaster on the community of Luton. Your plans were intelligent, calculating and selfish.

"Your ambition was notoriety. You wanted to be known posthumously as the world's most famous school shooter of the 21st century."

Prosper's plan failed when his mother confronted him after realizing he was in possession of a gun. A lengthy, violent struggle followed that resulted in the entire family being shot dead.

Cheema-Grubb paid tribute to Juliana, Kyle and Giselle, saying their "deaths are almost certain to have saved the lives of many children. The community owes them its gratitude and their memory should be honoured."

Her words were echoed by Raymond Prosper, the father of Nicholas, Kyle and Giselle, who said in a statement read by police: "We now see the deaths of Juliana, my son Kyle and daughter Giselle had much more meaning and importance.

'utterly shocked'

"Their deaths and the fast response of Bedfordshire police stopped any other family in the community going through the pain we have suffered." He added he wanted people to remember "loving" Juliana, "kind and funny" Kyle and "exceptional" Giselle for who they were.

DCI Sam Khanna, of Bedfordshire police, said he had never "encountered anyone capable of such horrific acts" throughout his entire police career.

Khanna said: "I've been utterly shocked and appalled by the actions and plans of the offender in this case, and I'm pleased that this truly evil individual will serve a significant proportion of his life behind bars."

On Tuesday, Luton crown court heard how he had shot his family dead at their home in Luton after a violent struggle and how it was part of a wider plan to carry out a mass shooting at St Joseph's Catholic primary school, where he and his siblings were pupils, to gain notoriety as a mass murderer.

His plan was months in the making. Prosper surveilled St Joseph's, taking images of staff and students from the school's website and noting the times of lessons and assembly.

The day before the murders, Prosper bought a shotgun from an online seller for £650 after he "made a high-quality forgery of a shotgun certificate or licence".

He had planned to murder his family while they slept on Friday 13 September, a date chosen on purpose, and then leave the home at about 8.30am to travel to St Joseph's school to carry out the attack.

His plans were disrupted when his family realised that something was wrong. After they challenged him, there was a violent struggle.

The court heard that Juliana was killed by a single shotgun shot to her head but her hands and arms had "slash injuries and bruising as if she had been trying to ward off blows from a knife". Giselle was killed with a single gunshot to her face. Her body was found underneath a dining table "as if she had been trying to hide there". Kyle died after being shot twice. His body was

found with more than 100 knife wounds.

Neighbours called the police after hearing the sounds of frantic footsteps, shouting and gunshots. Prosper fled the home before officers arrived, holding a bag containing the shotgun he had used to murder his family. Alongside the gun were 33 cartridges, which he had planned to use at a morning assembly at St Joseph's.

After hiding for two hours and believing his

plan was thwarted, as police swarmed the area, Prosper flagged down officers in a marked car and they arrested him.

'kill all'

The court heard details of a note outlining Prosper's plan. In it, he wrote the entire attack would be "one of the biggest events ever" and it included a diagram pointing to one of the early years classrooms at St Joseph's and an arrow pointing to a second

classroom. Beside the first classroom he had written: "Kill all."

Maureen Murphy, the headteacher of St Joseph's, said last month that staff were "very shocked" to learn of the plan.

Prosper has been diagnosed with autism spectrum disorder. A doctor who assessed Prosper said his diagnosis did not explain his lack of empathy and remorse and said he had "psychopathic traits".

After 27 years on the run, multiple sex offender and Scout leader is arrested

A former children's home worker and scout leader has been found guilty of sexual offences against boys after 27 years on the run.

Richard Burrows, 80, was held after flying into Heathrow from Thailand where he boasted of "living in paradise" since fleeing Britain in 1997 when he faced justice over his crimes.

But on Monday he was remanded in custody after being found guilty of 54 offences including indecent assault and serious sexual assaults. He had already admitted another 43 offences, including indecent assault of boys, making and possessing indecent images of children, and possession of false identity documents with intent, at a previous hearing.

Chester Crown Court heard Burrows systematically abused 26 boys across Cheshire, West Midlands and West Mercia between 1968 and 1995 while working as a scout leader and as housemaster looking after vulnerable children at Danesford Children's Home in Congleton.

He befriended his victims and, after gaining their trust and often that of their families, he went on to sexually abuse the boys, Cheshire Police said.

It was not until the 1990s, amid revelations over offences at other children's homes and institutions, that many victims had the confidence to come forward, police added.

Burrows was charged with sexual offences, but after his first appearance

before magistrates he was released on bail and failed to attend a hearing at Chester Crown Court in 1997.

He was finally found in 2023 in Phuket, Thailand, living under the name Peter Smith stolen from a terminally ill pal, which had allowed him to fraudulently obtain a genuine passport and leave the UK undetected.

There were plans to extradite him but when officers became aware of his plans to fly to the UK on his alias he was monitored and held on landing.

Det Insp Eleanor Atkinson, who led the investigation, said: "I hope this acts as a warning to any other wanted suspects – no matter how long you hide, we will find you and you will be held accountable."

Yoga mats and pool sliders are in; gammon joints and DVD rentals are out

■ Latest ONS inflation basket supplies snapshot of a nation's buying

Virtual reality headsets, yoga mats and men's pool sliders have been added to the shopping basket used to calculate the cost of living in Britain, while local newspaper adverts and oven-ready gammon joints have been removed.

In a snapshot of an increasingly online, time-pressed nation, the Office for National Statistics said the annual review of its inflation basket had taken into account shifting fashion trends, as well as growing consumer appetite for faster food and future technologies.

Sales of VR headsets, which allow users to immerse themselves in digital worlds, have grown

rapidly in recent years, and the goggles are used for everything from gaming to virtual therapy sessions to recreating the acid house rave scene of the 1980s and 1990s.

Although still relatively niche within the multi-billion-pound consumer electronics market, annual sales are expected to grow from about £350m last year to £520m by 2029.

On the flipside of the technological revolution, the continued decline in the centuries-old newspaper industry led the ONS to withdraw printed adverts placed in local papers, as consumers now usually place them online instead.

It also added pulled

pork to the shopping basket, in a direct swap for oven-ready gammon amid the dwindling popularity of pre-prepared joints of meat as consumers choose more convenient items.

Men's pool sliders were also added, reflecting the rise of the sandal worn by the former Conservative prime minister, Rishi Sunak, a fashion choice interpreted by some commentators as a play to attract young voters who might normally look to Kanye West for style inspiration.

Stephen Burgess, the ONS deputy director for prices, said the changes reflected evolving consumer spending patterns. "The addition of virtual

reality headsets for the first time shows our appetite for emerging technology, while the loss of printed newspaper adverts demonstrates a continuing shift towards the online world.

"The desire for convenience amidst our busy lifestyles also plays a part in this year's basket changes. Consumers are choosing easier options in

the kitchen, so oven-ready gammon joints make way for the quicker choice of pulled pork."

The ONS calculates the annual inflation rate by tracking the change in price for an array of goods and services, gathering the information on a monthly basis from online retailers and over the phone. The latest figures show inflation reached

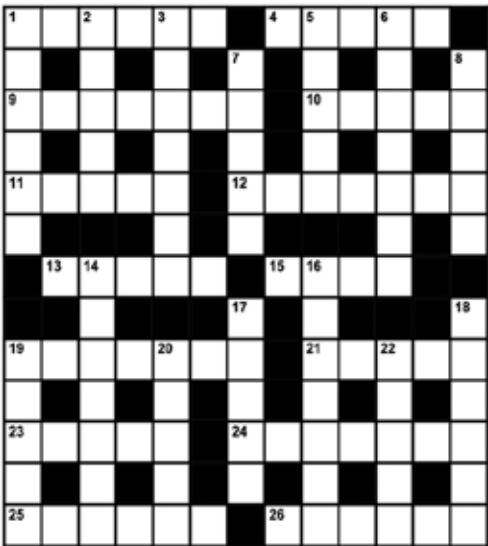
3% in January, although it remains below the 11.1% peak recorded in late 2022 – the highest level in four decades.

The basket of more than 700 items is designed to represent spending habits and reflect change in consumer behaviour. The annual update only covers a small number of items; 23 were added and 15 removed this year.

Sheen, 40, who previously pleaded guilty to burglary, conspiracy and transferring criminal property.

Sheen then worked to broker a deal with Fred Doe to cash in on

the haul, prosecutors said. In a series of text messages, Sheen referred to the loot as a "car," but he was actually talking about the gold.

"I'll link up with ya, I got something right up your path," Sheen told Doe in one message.

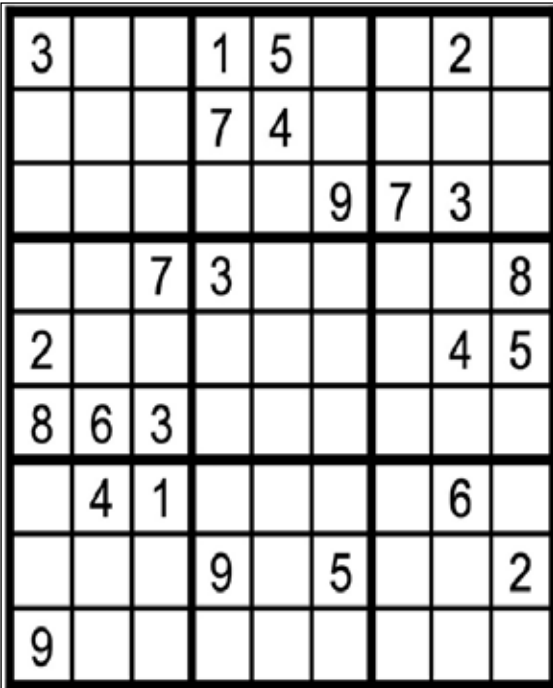
"I can sell that car for you in two seconds ...

so come and see me tomorrow," Doe said in a reply.

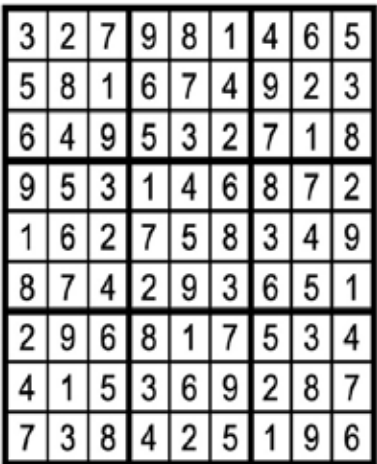
Doe, 36, also known as Frederick Sines, was convicted of conspiracy to transfer criminal property.

Adolescence: believe the hype

■ Netflix's latest smash is a mesmerizing, gripping and deeply disturbing drama delving into teen violence, online bullying and toxic masculinity

THERE'S only one possible TV show we could be looking at this week, and that of course is Netflix's wildly popular British crime drama Adolescence.

In case you missed it, the four-episode miniseries debuted last Friday on the streaming service and quickly became its most watched show worldwide. A harrowing thriller focusing on the aftermath of a fatal stabbing of a teenage British schoolgirl by one of her classmates, Adolescence deals with teen alienation, social media bullying, toxic masculinity and random, lethal violence among our children.

The show begins with the police storming a family home in an unnamed English town to arrest a skinny teenage boy Jamie Miller (Owen Cooper), while his parents Eddie and Manda (Stephen Graham, Christine Tremarco) and sister Lisa (Amelie Pease) look on in horror and bafflement, crying and pleading. From there the story unfolds as a sin-

gle take, fly-on-the-wall style, conveying a sense of claustrophobia, chaos and mounting horror. We see the capture of the teen and follow his ride to the police station. He is booked, stripped naked for photographs and interviewed all in real time, all in one continuous shot weaving back and forth between three or four characters, never breaking for an edit nor giving us time to take a breath.

But while Jamie looks dazed and confused his father can only watch in helpless horror. Stephen Graham, as so often, is superb here, as his confusion, indignation and barely suppressed fury at his son's ordeal gives way to something much worse...the jaw-dropping realization that police have the right suspect in custody.

As the four chapters unfold the show is, by turns, a police procedural; a sociological examination of male rage, cyberbullying, and a failing

British school system, a psychological thriller and a tragedy about how in the 21st century, a child's bedroom can be the most dangerous place in the world.

The second episode takes place largely at Jamie's school, where the kids are little more than feral monsters in ill-fitting uniforms and the teachers, helpless and demoralized. The lead investigator DI Luke Bascombe (Ashley Walters) requires his own teenage son's intervention to realize how clueless he and his colleagues are as to the reality of Jamie's Instagram feed while the various groups of students who swarm around him, none even remotely interested in helping the investigation, are having wildly disparate responses to the murder, from overwhelming grief to juvenile amusement.

Dramatic peak

But the show's emotional and dramatic peak comes with the third episode, which ranks as the most disturbing and riveting hour of television I have seen in years. In an intimate two-hander in the games room of the facility where Jamie is being held, the court-appointed psychologist Briony (Erin Doherty) painstakingly removes the suspect's layers of bravado, self-pity, confusion and rage as she tries to assess how much Jamie understands about the nature and consequences of this crime - and to try to make sense of what seems so completely senseless. As the camera swirls around these two sparring partners as they take each other's measure, it doesn't flinch as their conversation takes massive emotional swings. And here we see Cooper, a newcomer with virtually no professional acting history, quite superb in navigating each emotion-

al beat of the scene, by turns childish and vulnerable, then assertive and cocky and then intensely threatening, before being dragged out the room, wracked by tears of longing for validation which will never come.

The final episode focuses on the intense damage done to Jamie's family in the aftermath of the crime. They've moved to another town and try to live anonymously, but unsurprisingly social media has another agenda. While Eddie tries to hold his family together and enjoy his birthday, the futility of that hope is laid bare as he is targeted by some neighborhood teenagers. The tight framing and single shot technique

that features throughout the series is especially effective here, as the three family members squeeze into Eddie's van for a day out and reminisce about their school days and courtship, and later back in Jamie's bedroom, where they bare their souls to each other, try to decipher what went wrong, while insisting to themselves - and revealing to us - that these are basically good and hardworking parents confronted with a new reality wrought by modern technology which nobody saw coming and for which nothing could have prepared them. Jamie's family are victims, too, a fact laid bare in the most unflinching and ag-

onizing way imaginable. A popular buzzword in recent years is the so-called Paradox of Choice and nowhere is that concept more true than on our small screens. We are drowned, buried and overwhelmed by such much on-demand content, more than has ever been available to us, instantly. Yet the vast majority of it is derivative, unoriginal, badly-acted drivel. But if we keep persisting, we can find truly great television shows with the power to provoke, think and stimulate. If we are lucky these come along perhaps once or twice in a decade. Adolescence deserves that title in spades. Do not miss it.

Lando off to a flyer

Australian Grand Prix: British star takes the laurels with Verstappen second, Russell third as Piastri finishes ninth

Lando Norris and McLaren delivered on their potential with a copybook victory in a demanding Australian Grand Prix at the weekend to put their stamp on the start of the new season.

Briton Norris described his win as “stressful but rewarding”.

The first adjective was justified by the conditions in a madcap, crash-strewn, incident-packed race where one small error can spell disaster - as it very nearly did for Norris himself at one point.

The second adjective was a recognition of the fact that this was exactly the kind of race in which, last year, McLaren had proved less than perfect, and thrown away at least one potential victory, and perhaps another, too.

But in Melbourne they were as perfect as it is possible to be in conditions such as these - even the renowned rain-master Max Verstappen slipped up at one point. And Norris and McLaren came through the chaos unscathed.

The fine line between victory and defeat was underlined by an incident with 13 laps to go that defined the race.

Norris was leading from team-mate Oscar Piastri and Verstappen as a heavy shower of rain approached the track.

It hit as the leaders were negotiating the final corners on lap 44, with 13 to go.

Both McLarens ran wide on to the gravel at the exit of Turn 12, and Australian Piastri then

spun through Turn 13.

Norris was able to continue without losing too much time, but Piastri ended up on the grass on the outside of Turn 12, where he sat with his wheels spinning helplessly for what seemed like an age as his hopes of victory at home evaporated before finally rejoining. He fought back to ninth by the end.

Norris immediately pitted for treaded tyres. That decision won him the race, and demonstrated how far he and the team had come since last year - they had planned that they would pit as soon as it rained, and acted decisively on the plan.

Verstappen stayed out and took the lead, but as the rain intensified he lost more time, and Norris re-

sumed the lead when the Dutchman pitted himself two laps later.

Norris said: “It’s so easy to make a mistake, so easy to ruin everything. So quickly it can all have gone wrong within a second.”

“Any second of the race, you lock up, you hit the white line wrong, you have a big snap. It was just very, very difficult at times to just not go into a hole or a tyre barrier

somewhere.

“That’s a big enough challenge, but then when you’ve got the weather changing and the track conditions changing, knowing when to make the correct decision to change on to a slick tyre and stay out on the inter-tyre, and then even more when I’ve got Max behind me and Oscar behind me, it’s stressful.”

“But that’s what makes it rewarding.

“We worked a lot over the winter to prepare for a race like this, because it’s where we threw away a lot of opportunities last season - Canada, Silverstone, where we were not the best at preparing and knowing how decisive we’ve got to be.”

“Today we were very, very decisive, calling to box five metres before I boxed. But it was the right call in the end, and that won us the race.”

And were given a late scare when Greece were awarded a penalty of their own after Grant Hanley felled Taxiarchis Fountas, only for it to be overturned by the video assistant referee because the contact was outside the area.

Scotland managed to hold on from there to ensure McTominay’s 11th international goal in 22 matches was the winner, and they take a narrow lead into the return leg at Hampden on Sunday (17:00 GMT).

At half-time it was a lead the Scots richly deserved after a fluid 45 minutes, even though the penalty award for a foul on McTominay appeared soft.

Both Billy Gilmour and Che Adams had good chances to add to the narrow advantage, but profligacy meant a nervy second-half en-

sued as Greece came out swinging.

The introduction of 17-year-old Genk midfielder Konstantinos Kareltsas was the catalyst for their improved display, and his wonderful cross teed up Christos Tzolis for their best chance.

But the Club Brugge forward’s effort at full stretch came back off a post and, despite the late penalty panic, Scotland held on for a hard-fought win.

This was a Scotland performance with a mix of class in the first half, and sheer guts and concentration in the second period.

Clarke opted to give Bologna’s Lewis Ferguson a rare start alongside John McGinn and McTominay, with Kenny McLean and Billy Gilmour tucked in behind them.

It worked brilliantly as the midfield made a confident start, knocking the ball about and

slowly opening Greece up as the half wore on as they combined quickly to move up the pitch.

The penalty was perhaps dubious, but it was earned amid growing Scotland pressure and McTominay, so often Scotland’s hero, confidently tucked it away.

After the break, though, it was about clinging on.

Grant Hanley and John Souttar were outstanding at the back, the latter making a crucial block to deny Tzolis, but Clarke will be slightly concerned with just how drastically the momentum changed.

Greece had 18 shots in the second half alone, with Scotland registering just a single effort - McGinn’s strike from 25 yards.

It is a warning ahead of the Hampden return that Greece will not go away easily, but with a lead and home advantage Scotland are in a strong position.

Pochettino drops strong hint about Spurs return

Mauricio Pochettino says he has “unfinished business” at Tottenham – and could go back to manage them one day.

Pochettino has a brilliant relationship with the Spurs fans after leading them to the Champions League final in 2019 and transforming their fortunes despite not being able to win a trophy during his five years in charge.

And with Spurs drifting to their worst Premier League finish in a generation under Ange Postecoglou, questions about a Poch return are growing ever louder.

When asked whether he still has unfinished business, the USA manager said: “In the bottom of my heart I still feel the same. I would like one day to come back. Not because of my ego. It’s because my

feeling is I would like one day to win with Tottenham.

“I think now Tottenham are a club with an expectation to win because if you see the great facilities – training ground or stadium – now you can see it is about winning trophies.

“That is why I would like one day to come back

to the club. But if that doesn’t happen, it doesn’t happen.

“With all the possibilities again to build something special, that is my feeling and it didn’t change.”

Pochettino added: “It’s been six years since we left Tottenham, and it definitely is always going to be a very special club for me.”

Tuchel: England need 'hunger to win'

■ Three Lions coach seeks to change team's mentality ahead of World Cup qualifiers

England manager Thomas Tuchel says he wants the team to play with a "hunger to win" and not "a fear to lose" as he prepares for his first match in charge of the Three Lions.

England began their 2026 World Cup qualifying campaign against Albania at Wembley on Friday (after the BW went to press) before facing Latvia on Monday.

Under former boss Gareth Southgate, England reached back-to-back European Championship finals but Tuchel was critical of their style of play at Euro 2024.

"I've heard a lot that it's a heavy shirt. It is in fact not. But I know what the players mean," he said in a news conference on Thursday.

"Watching the Euros I felt tension and pressure on the shoulders of the players and they were playing not to lose.

"I want us to play with excitement and the hun-

ger and desire to win... and the acceptance of failure is part of it, especially in football."

Southgate led England to the final at Euro 2020 and 2024 - where they lost to Italy and Spain, respectively - and guided them to the semi-finals at the 2018 World Cup and quarter-finals in 2022.

But the 54-year-old was criticised by some for a perceived safety-first style at Euro 2024, where England scraped past Serbia in the group stage before drawing against Denmark and Slovenia.

Wins against Slovakia, Switzerland and the Netherlands followed in the knockout stage but Southgate came under fire for being unable to get the best out of a star-studded squad.

England captain Harry Kane says it feels like now is the time to take the next step and win a tournament.

"We have been extremely close to being two-time European champions," he told BBC Radio 5 live.

"We have been as successful as any other team for England for the last 15 years, but ultimately you are going to be judged on whether you win finals or not.

"Early on in Gareth's reign we spoke about getting to semi-finals, getting to finals, and keep repeating that.

Former Bayern Munich boss Tuchel, 51, led Chelsea to the Champions League title in 2021 having twice won Ligue 1 during his two-year spell in charge of Paris St-Germain and lifted the Bundesliga with Bayern.

He has never managed in international football but, on being appointed by the Football Association to replace Southgate in October, was tasked with trying to deliver a first piece of silverware

since the 1966 World Cup at next year's World Cup in the United States, Canada and Mexico.

"I think we have so many offensive players we should play on the

front foot," Tuchel told BBC Radio 5 live.

"I think we have a lot of wingers for example that are strongest when they play from the wide positions.

"This then feeds into our decision on how we want to play - to put the strength of the players to where they are used to playing and where they can express themselves."
