UK ESCAPES THE WORST

■ **Trump slaps 10% tariff on British goods - half of what the EU must face**
■ **PM vows a 'calm, pragmatic' response**

DONALD Trump hit Britain with 10% tariffs as he triggered a global trade war this week.

It was yet another sign that the so-called Special Relationship means little to the current incumbent in the White House, although the UK at least had some consolation in knowing that the EU was hit with a levy twice as large, prompting some to suggest that Brexit had saved the country from worse.

Making his "Liberation Day" speech in the Rose Garden on Wedn, Mr Trump confirmed the UK and the rest of the world would face massive levies which he claims will restore fairness across the planet. He also imposed a 34% trade tariff on China, 46% on Vietnam and confirmed there would be a 25% levy on all foreign-made cars - which could severely damage our motor industry.

Britain's 10% charge on exports to the US are less than feared but still likely to hammer businesses.

The Federation of Small Businesses warned it would deal a "major blow" to small and medium businesses, as 59% of small UK exporters currently sell into the US market.

Tina McKenzie, of the

FSB, said: "Tariffs will cause untold damage to small businesses trying to trade their way into profit while the domestic economy remains flat."

"The fallout will stifle growth, hurt opportunities, and put a serious dent in the global economy."

Sir Keir Starmer has already acknowledged his desperate efforts to secure a tariff exemption have been snubbed.

At Wednesday's Prime Minister's Questions, Sir Keir said the Government had "prepared for all eventualities" and was working with companies likely to be affected.

He said: "A trade war is in nobody's interests and the country deserves - and we will take - a calm, pragmatic approach."

'closest ally'

"Our decisions will always be guided by our national interest and that's why we have prepared for all eventualities and we will rule nothing out."

Business Secretary Jonathan Reynolds said: "Throughout the last few weeks, the Government has been fully focused on negotiating an econom-

ic deal with the United States that strengthens our existing fair and balanced trading relationship

'range of tools'

"The US is our closest ally, so our approach is to remain calm and committed to doing this deal, which we hope will mitigate the impact of what has been announced today."

"We have a range of tools at our disposal and we will not hesitate to act."

Lib Dem leader Sir Ed Davey accused Mr Trump of launching a "destructive trade war".

Rain Newton-Smith, of the Confederation of British Industry, said: "Today's announcements are deeply troubling for businesses and will have significant ramifications around the world."

Watched by his Cabinet, Mr Trump said there would be "reciprocal" tariffs to raise trillions of dollars and start a new "golden age" for America. However, he later said other countries would be charged "approximately half" of what they impose on the US.

The President held up a board with tariff rates

for nations ranging from 10-49%.

As he delivered his announcement, the US dollar fell sharply against key currencies.

Mr Trump declared: "Liberation Day" - a "declaration of economic independence".

He said: "In a few moments I will sign a historic executive order instituting reciprocal tariffs on countries throughout the world."

"Reciprocal. That means they do it to us and we do it to them. Very simple, can't get any simpler than that. This is one of the most important days in my opinion in American history." He added: "For decades, the United States slashed our trade barriers on other countries while those nations

placed massive tariffs on our products and created outrageous non-monetary barriers to decimate our industries. They manipulated their currency, subsidized their exports, stole our intellectual property, imposed exorbitant VAT taxes to dis-

advantage our products, adopted unfair rules and technical standards and created filthy pollution havens.

"They were absolutely filthy, but they always came to us and they said we're violating and we should pay for it."

Record number of small boats cross the Channel... and the weather is to blame, says Home Secretary

■ Migrant numbers crossing from France up 31% from last year

HOME Secretary Yvette Cooper yesterday blamed a record number of Channel crossings on calmer seas.

Border security was "dependent on the weather" when people smugglers launch more boats packed with dozens of asylum seekers.

More than 6,600 migrants have crossed the Channel this year, up 31% on last year.

Officials believe there have been far more "red days" – when crossings are likely because conditions are calmer – than in previous years.

Ms Cooper and Prime Minister Sir Keir Starmer are to use a two-day summit on migration, starting today, to push for more international co-operation on tackling supply routes, criminal finances and online adverts for dangerous journeys.

More than 40 countries and representatives from X, Meta and TikTok are expected to attend.

Ms Cooper said: "We've seen higher numbers in March, low numbers in January and February, and that's reflected in the number

of calm days.

"We cannot carry on with border security being so dependent on the number of calm days that happen in the Channel. But the reason that is happening is because the criminal gangs still have a deep hold. The action that we are taking is much stronger action with France, including new measures in the course of this year. France has agreed now to take action and to intervene in French waters."

'vile trade'

Criminal gangs are believed to make hundreds of millions of pounds every year from trafficking.

Sir Keir Starmer is expected to say at the summit: "This vile trade exploits the cracks between our institutions, pits nations against one another and profits from our inability at the political level to come together."

"I simply do not believe organised immigration crime cannot be tackled. We've got to combine our resources, share intelligence and tactics and tackle the

problem upstream at every step of the people smuggling routes."

Officials also confirmed a £33million funding boost to secure more prosecutions along the smuggling routes to the French coast.

Shadow Home Secretary Chris Philp said: "The Home Secretary has her head stuck in the sand about the extent of the challenge on illegal immigration."

"Crossings are up 31% since the election with

2025 the worst year on record. This is the clear impact of cancelling the deterrent and Labour's open-door policy.

"The Conservatives have set out tough plans to crack down on illegal migration."

Iran puts Chagos base on target list

Iran said British forces in the Chagos Islands will be legitimate targets if it is attacked by America.

The joint UK-US Diego Garcia base in the Indian Ocean was listed by Tehran's state media along with a naval base in Bahrain close to a Royal Navy facility.

US president Donald Trump has warned of military action if Iran fails to sign a nuclear programme deal.

A senior Iranian military official said: "There will be no distinction in targeting British or American forces if Iran is attacked from any base in the region or within the range of Iranian missiles."

Tehran says its missiles can reach Diego Garcia, which hosts bombers thought to be capable of striking its bunkers.

Of the 4,000 personnel on the base, around 40 are British, providing policing and customs. A small contingent of Royal Marines undertakes security duties.

The UK Government condemned "these threats in the strongest terms". It added that Diego Garcia is vital for "regional and international security".

Embassy siege PC dead at 85

PC Trevor Lock, a hero of the famous Iranian embassy siege in London, has died at the age of 85.

The Metropolitan Police bobby had only recently opted for what he thought would be a quieter life as a member of the diplomatic protection squad in April 1980, when he and others were taken hostage by terrorists in a six-day standoff that ended with the dramatic storming of the building by the Special

Air Service (SAS).

Modest and unassuming, Mr Lock died still regretting that he hadn't done more to save the life of an Iranian diplomat shot dead by the gunmen, a murder that prompted Prime Minister Margaret Thatcher to send in the then little-known SAS.

The elite troops, armed with sub-machine guns and gas grenades, abseiled from the roof and rescued 24 hostages and killed five of the six ter-

rorists. One other hostage died in the shootout.

The drama was filmed by TV crews who had set up cameras nearby at the start of the siege.

The BBC showed the rescue live, breaking into its coverage of the World Snooker Championship final and making a national star of young reporter Kate Adie.

PC Lock was the only officer on duty at the embassy in Kensington, west London, and was

'It's Harry's fault the donors are leaving'

■ Charity row rumbles on, with Sentebale head accusing the Prince of 'harassment and bullying at scale'

PRINCE Harry's decision to step down as a working royal and move to the US has seen the charity he set up in his mother's name lose donors, its chairwoman has claimed.

In an explosive interview, Sentebale head Dr Sophie Chandauka accused the King's youngest son of "harassment and bullying at scale" as she criticised the "toxicity" of his brand and its impact on the organisation.

This follows Harry's announcement last week that he had quit as patron for Sentebale amid a heated boardroom battle with the organisation.

The charity, which he co-founded with Prince Seeiso of Lesotho in 2006, helps young people and children in southern Africa, partic-

ularly those living with HIV and Aids.

Announcing their resignation in a joint statement, the Duke and Prince Seeiso said they had stepped back until further notice. They added it was "devastating" that the relationship between Sentebale's trustees and the chair of the board "broke down beyond repair". The move came as several trustees left.

'no discussion'

Dr Chandauka told Sky News: "The only reason I'm here is because at some point on Tuesday, Prince Harry authorized the release of a damaging piece of news to the outside world without informing me or my country directors, or my executive director. And can you

imagine what that attack has done for me, on me and the 540 individuals in the Sentebale organisations and their family?"

"That is an example of harassment and bullying at scale."

She went on to say that the royal wanted to "eject" her from the charity. When that failed she claimed he started to brief against her.

Speaking on Sunday Morning With Trevor Phillips, Dr Chandauka said she believes that donors were abandoning Sentebale because of the Duke of Sussex's reputation.

Having taken on the chairmanship in July 2023, she said she undertook a seven-year review of the financials.

She said: "There was quite a significant correlation between the

Cornell student targeted for deportation for pro-Palestinian activism is British citizen

■ Momodou Taal chose to self-deport from the US

A Cornell University graduate student who had his US visa revoked due to protest activities against Israel has chosen to leave the US rather than be deported.

Momodou Taal, who is a joint citizen of the UK and The Gambia, had his student visa revoked due to his on-campus protest activities last year as the Israel-Gaza war raged.

Mr Taal previously sued to block his deportation, but on Monday posted on X that he had chosen to leave the country "free and with my head held high". It comes after a judge had denied his request to delay his deportation.

The Trump administration is cracking down on international students who have been active in protests against Israel on university campuses.

Mr Taal is at least the second international student to opt to leave the US after being targeted for removal by the US Department of Homeland Security (DHS). The Trump administration identifies these cases as "self-deportations".

"Given what we have seen across the United States, I have lost faith that a favourable ruling from the courts would guarantee my personal safety and ability to express my beliefs," Mr Taal posted on X on Monday.

"I have lost faith I could walk the streets without being abducted. Weighing up these options. I took the decision to leave on my own terms."

A DHS official later confirmed that Mr Taal had departed the US, according to CBS News.

Mr Taal was suspend-

ed twice by Cornell, an Ivy League school in upstate New York, due to protest activities. On the day of the Hamas attack against Israel in 2023, he posted: "Glory to the Resistance."

"We are in solidarity with the armed resistance in Palestine from the river to the sea," he later told a crowd of protesters, according to The Cornell Daily Sun newspaper.

At least 300 university students had their student visas revoked due to involvement in pro-Palestinian protests, Secretary of State Marco Rubio said last week.

Trump officials said the Immigration and Nationality Act allows the State Department to deport non-citizens who are "adversarial to the foreign policy and national security interests" of the US.

time the organization started to see a departure of sort of major organizations and Prince Harry's departure from the UK itself.

"When you look at the board minutes, though, there is no discussion about what's happening with respect to some of our most significant funders. And then when you discuss with the senior executive team and ask why there isn't a conversation about this the answer is 'it's really difficult to have this conversation because the instruction was, it's an uncomfortable conversation to have with Prince Harry in the room'."

'negative media'

In an interview with the Financial Times, she alleged she was asked by Harry's team to defend his wife, Meghan, in the face of negative media coverage after an awk-

ward video emerged of the two women. At a Sentebale fundraising polo event in Miami last year, Meghan appeared to instruct the chairwoman to move away from Harry as they posed for photos with the winners.

Recalling the events which were heavily discussed in the media, Dr Chandauka said: "There was a lot of talk about the Duchess and the choreography on stage and whether she should have been there and her treatment of me."

"Prince Harry asked me to issue some sort of a statement in support of the Duchess and I said I wouldn't. Not because I didn't care about the Duchess, but because I knew what would happen if I did so, and because we cannot be an extension of the Sussexes."

A few days later, she said Harry sent her a 'hos-

tile' text, telling her to 'explain yourself'.

In a joint statement on Wednesday, the Duke and Prince Seeiso said they were resigning from their roles with "heavy hearts" and in "solidarity with the board of trustees".

They added they would be sharing their concerns with the Charity Commission "as to how this came about". Former trustees who also quit said they had lost trust and confidence in the chairwoman. But her legal action to block them from removing her meant they had no other option than to resign.

Sentebale was one of a small number of private patronages the Duke kept after he was stripped of his honorary military positions after he stepped down as a senior working royal. Dr Chandauka is resolute that the charity "lives on" without its royal patron.

Betty Webb joined Bletchley Park in 1941

RIP Betty Webb: last of the Bletchley Park codebreakers

The Bletchley Park code breaker Charlotte “Betty” Webb has died at the age of 101, the Women’s Royal Army Corps Association (WRACA) has confirmed.

Arriving at Bletchley from the Auxiliary Territorial Service (ATS) aged just 18, Webb spent four years during the second world war at the code-breaking centre working in various roles.

Webb, from Wythall in Worcestershire, intercepted German police messages, which revealed the beginning of the Holocaust, and paraphrased decoded Japanese messages for the Pentagon in the US. Confirming her death, the WRACA said on Facebook: “Betty inspired women in the army for decades and we will continue to take pride in her service during WWII and beyond, and as a champion of female veterans.

“The messages were in groups of five letters or figures in morse code – nothing was clear at all. Some dates appeared. It was total gibberish, but you had to register everything, so senior people could call on a date or message at any time. We knew very little of what was going on. We really were in the dark.”

Webb was appointed MBE in 2015 and Knight of the Légion d’honneur in 2021, a prestigious order of merit awarded for both military and civil

service in France.

She was president of the WRACA Birmingham branch.

In a statement, Bletchley Park said her contributions to the estate’s work during the second world war and to ensuring its legacy, would never be forgotten.

They said: “Betty was not only a member of the incredible team at Bletchley Park during world war two, but she also dedicated much of her life to raising the profile of Bletchley Park in more recent years.

“Her tireless efforts in bringing the history of Bletchley Park to a wider audience, through sharing the stories of those who worked here, helped ensure that the vital role of Bletchley Park during world war two and its impact on the conflict was recognised.

“Betty’s passion for preserving the history and legacy of Bletchley Park has undoubtedly inspired many people to engage with the story and visit the site. Betty’s impact at Bletchley Park will be remembered for many years to come.”

Tess Dunlop, historian and broadcaster, said she was with Webb on her final day. Posting on X, Dunlop said: “Betty was the very best. I was lucky enough to hold her hand yesterday as she gently glided to another place. She is one of the most remarkable women I have ever known.”

Richard Chamberlain dead at 91

■ Dr. Kildare heartthrob was later dubbed ‘king of the mini-series’

RICHARD Chamberlain, the actor who set millions of pulses racing as dashing Dr Kildare, has died two days before his 91st birthday, it has been announced.

The US star was propelled to international fame by the 1960s medical drama – leading to other hit TV lead roles including in *The Thorn Birds* and *Shogun*, both of which led to Emmy nominations.

He was also known for his film and theatre work during a glittering six decades long career.

Chamberlain died late on Saturday in Waimanalo, Hawaii – where he lived – after suffering complications from a stroke, his publicist Harlan Boll confirmed.

The star’s former partner Martin Rabbett called him an “amazing and loving soul”, adding: “Our beloved Richard is with the angels now. He is free and soaring to those loved ones before us. Love never dies. And our love is under his wings, lifting him to his next great adventure.”

Born in Beverly Hills on March 31, 1934, to a housewife and a kitchen equipment salesman, Chamberlain was drafted into the army after school and served for two years, including in post-war Korea, where he was promoted to sergeant.

On his return to Los Angeles he studied acting and formed a theatre group in 1959. A year later he started getting TV roles and landed Dr

Kildare in 1961, playing the part for five years.

Later that decade he moved to England where he honed his acting skills in the BBC series *Portrait Of A Lady*.

The Seventies saw his first Emmy nomination as the lead in the 1975 TV movie *Count Of Monte-Cristo*. In the Eighties he became known as the “king of the mini-series” for the critically acclaimed *Shogun* (1981) and *Thorn Birds* (1983), co-starring Rachel Ward. Another Emmy nomination came from the 1985 movie *Wallenberg: A Hero’s Story*.

Chamberlain was also

the original Jason Bourne in the 1988 mini-series *The Bourne Identity*. There were plaudits too for his appearances on stage, including as Professor Henry Higgins in *My Fair Lady* and Captain von Trapp in *The Sound Of Music*. He was no stranger to Shakespeare, either, starring in *Hamlet* and *Richard II*.

Most of his roles were as romantic leading men, which is why he did not publicly reveal he was gay until he was 68. He admitted he was petrified it would ruin his career, so lived most of his life as a lie.

Speaking in 2014 he said:

“When you grow up in the Thirties, Forties and Fifties being gay, it ain’t easy, it’s just impossible.

“I assumed there was something terribly wrong with me. And even becoming famous and all that, it was still there.” He added it was a huge relief to acknowledge his sexuality in his 2003 autobiography *Shattered Love: A Memoir*.

He met Rabbett when they both starred in the 1986 adventure film *Allan Quatermain And The Lost City Of Gold*. After more than two decades together, the couple parted in 2010 but remained close friends.

having a cup of tea when a young man walked up and fired a sub-machine gun at the door before bundling the officer into the building with others

who rushed in.

In tense negotiations over the following five days, the terrorists demanded autonomy for a southern region of Iran, the release of 91 prisoners, and safe passage out of the building.

PC Lock, who managed to keep hidden a

handgun strapped to his torso, was hailed a hero for raising the alarm, acting as a go-between during negotiations, and trying to calm the fears of his fellow hostages.

He was later awarded the George Medal for his bravery, though he shunned the limelight

and rarely gave interviews.

He told *The Independent* in 2010: “The other hostages have a reunion. I don’t enjoy that stuff. I don’t enjoy glorifying it.

“The grandchildren used to come home and say that they’d learnt about me in history.”

Easter Hot Cross Buns under threat as furious farmers revolt against Chancellor's Inheritance Tax plans

HOT cross buns could be in short supply this Easter as farmers stage the sector's first ever strike in protest against Rachel Reeves' controversial inheritance tax which, they claim, imperils their livelihoods.

Farmers will refuse to supply milling wheat this month to highlight concerns over food security and UK reliance on imports – which is expected to impact the availability of flour and bakery products ahead of Easter.

Farmer and protest organiser Andrew Ward said: "We want empty shelves, that's what we

want.

"We've got to the stage now where everything else isn't working. We have to create a food shortage."

'change direction'

When asked about the impact on consumers ahead of Easter, he added: "When is a good time?"

"We've been going with this now since November 19. Four months later, nothing's happened. The Government hasn't changed. We have to now do something different and change the goal posts. We need to be very mindful about

annoying the public and losing their support.

"But at the same time we need to change direction and do something different."

'no joke'

Standing behind 250 tons of milling wheat, which he said could create about 450,000 loaves, Mr Ward added: "It might be April Fool's day but food shortages are no joke."

Farmers are furious with the Government over the changes to agricultural and business property relief in October's Budget.

The Chancellor said

that from April 2026, combined agricultural and business property assets up to £1million will still receive 100% relief but anything above will be taxed at the rate of 20%.

Asset-rich farmers who are cash poor fear they will have to sell off their land – making it unviable for food production – to foot the tax bill.

Farmer Olly Harrison said: "Milling wheat is staying on farms. Farmers that are growing milling wheat have gone on strike.

"From April 1, they will not be loading trucks with milling wheat.

"We're probably going to run out of flour, which will result in running out of hot cross buns and bread. If you wonder why the shelves are empty, get on to your MP and say 'you need to help these farmers out. You can't carry on putting them out of business. It's not good'.

"If there's rationing of bread, cakes and hot cross buns then it's the

politicians' faults, not our fault. We can't carry on or we won't be in business."

Food growers have enjoyed huge support among members of the public since Ms Reeves' Budget.

But some fear this strike could damage that. Farmer Ben Aveling, said: "While I am a farmer and support farming causes, I fear this might not be the right one. It comes with its own risks.

"Some or most farm-

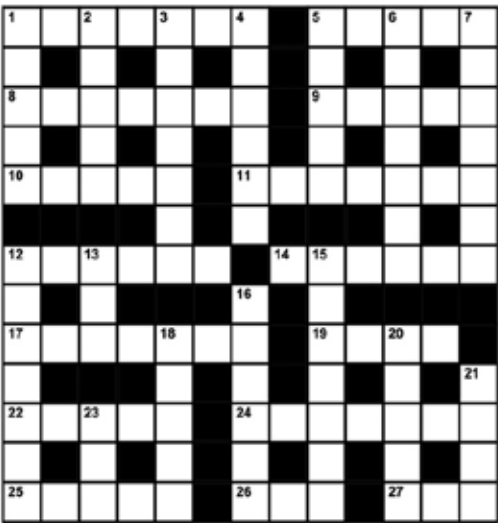
ers can't afford to hold on to the wheat and need to sell, making it so that the market will still have some local supply. They will possibly also have already been contracted to deliver wheat in April.

"In other cases the shortfall may then just be imported from other countries, building stronger import chains than ever before. This is the big one for me. This is what we need to stop and this is what the Government wants."

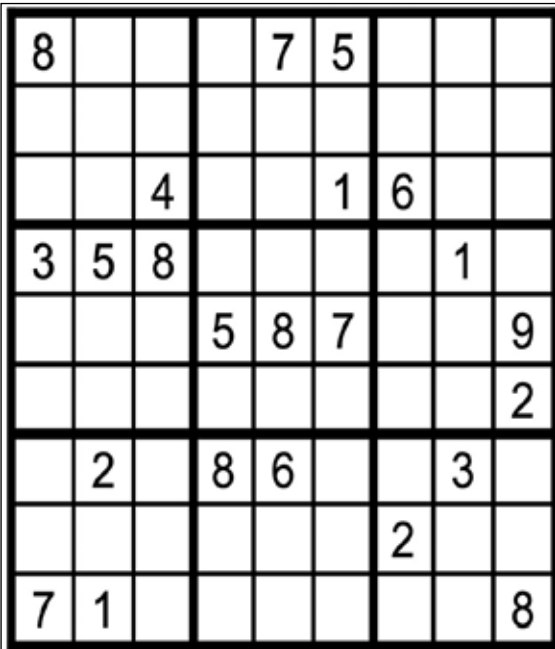

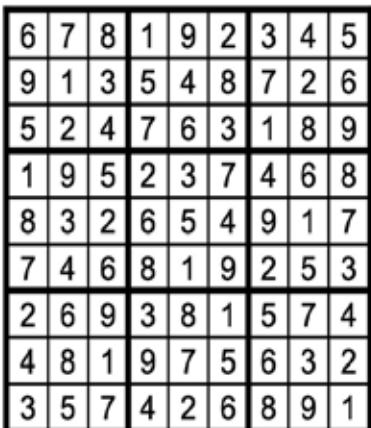

Mobland: Hardy presence elevates familiar fare

■ London crime drama benefits from strong performances from Hardy and Mirren

Tom Hardy has a particular gift for commanding attention, and in *MobLand*, which debuted this week on Paramount+, he's once again at the top of his game.

Whether it's a menacing growl, an imposing stare, or a line delivered with unwavering calm, Hardy's presence is magnetic. Over the years, we've seen him persuade, intimidate, and lead with an almost magnetic force in various roles.

Starring here as London gangland enforcer Harry Da Souza, Hardy harnesses that same power, but this time, it's not just about flexing his muscles - his character's influence is rooted in calculated control, sharp wit, and an innate ability to get things done.

Hardy's Da Souza is a seasoned fixer for the Harrigan crime family, a powerful Irish clan who rule London's underworld of drugs and firearms, but their reign is showing signs of wear

and tear. They've grown reckless, indulging in excesses, and perhaps losing their sharp edge.

The show began life as a script by writer Ronan Bennett as *The Donovans*, an origin story to the popular Showtime crime drama *Ray Donovan*, before morphing into a stand-alone series.

The plot kicks off when Eddie Harrigan (played by Anson Boon), the boorish, reckless grandson of the family's patriarch Conrad (Pierce Brosnan channeling his best Irish tinker) ends up embroiled in a nightclub altercation that leads to a stabbing.

Comforting and menacing

Eddie's wild behavior threatens to escalate tensions with the rival Stevenson crime family, which could ignite a bloody war between the two factions. Harry is tasked with reining Eddie in, smoothing over the situation with Richie Stevenson (Geoff Bell), and

using his persuasive skills to manage witnesses, ensuring they either stay silent or provide useful information. While Harry is off handling the gritty business of organized crime, he's also dealing with the tension at home with his wife, Jan (Joanne Froggatt), who, frustrated by his workaholic nature, insists they go to couples counseling. But before they can even finish the conversation, Harry is called away again. Duty calls, and he's back on the job.

Hardy's portrayal of Harry is a study in quiet confidence. This isn't a character who raises his voice or displays unnecessary aggression; instead, Harry's power lies in his reliability, his ability to manage people, and his calm demeanor in the face of chaos. As Harry says to a colleague who doubts his abilities, "If I say I'm going to do something, it gets done." His presence is both comforting and menacing, an executive who, with the right connections and a few well-chosen words, can handle any problem that comes his way.

The teleplay takes a business-like approach to organized crime, presenting it as an industry that requires careful management and decision-making. While the Harrigans may be the ones calling the shots, it's Harry who ensures everything runs smoothly on the ground. Director Guy Ritchie, who helms a couple of early episodes, is very comfortable in this milieu and reins in some of his more indulgent instincts, which made such a splash for him early in his career but which quickly became very tiresome.

Mirren a marvel

And yet there is little here that we haven't seen be-

fore, told with more verve and daring and with more of the unexpected to leaven the usual fare of tough guys in dodgy boozers, toffs slumming it with rough trade partners, country houses, dogs and Barbour jackets, and hard-as-nails mobster molls who wield the real power behind the throne. In this case that particular job is handled by the irreproachable Helen Mirren as Conrad's wife, in a surreal redux of her character from the *Long Good Friday* almost 50 years ago. Victoria Shand? Meet Maeve Harrigan.

The show's slow burn over the opening episodes is acceptable though, because Hardy dominates the screen so effortlessly. Harry's calm demeanor is often at odds with the

absurdity of the situations he finds himself in, and it's in these moments that Hardy's sharp delivery shines. In one scene, when confronting two young criminals who are trying to act tough, Harry calmly remarks, "Right now, I'm in first gear. Would you like to see me shift to sixth?" The line is delivered so softly, almost casually, that it's both chilling and amusing at the same time. It's a perfect example of how Hardy can turn a seemingly mundane moment into something memorable. In another instance, Harry casually warns a small-time crook that if he crosses the Harrigans, "I, or possibly one of my associates, depending on my availability, will find you." It's both funny and frightening, and it speaks

to Hardy's ability to make a line that could easily fall flat into a moment of real power.

The show doesn't delve too deeply into the psychological complexities of its characters, but it's clear that *MobLand* is more than just a surface-level crime drama. Beneath the sleek exterior, there are moments of real depth - especially in Maeve's calculated manipulation of the men around her. As for Hardy, he carries the series with such compelling presence that even when the plot falters or the drama lightens, he makes it impossible to look away. If you're ever in doubt about whether *MobLand* is worth your time, you can be sure that Tom Hardy will remind you, just by being there, why it absolutely is.

Saka makes dream return as Arsenal edge Fulham

Bukayo Saka scored just seven minutes into his return after 101 days out injured to help Arsenal beat Fulham 2-1 at Emirates Stadium on Tuesday night.

The England forward came off the bench in the second half, with the score at 1-0, and showed Arsenal what they have missed during his absence, heading in Gabriel Martinelli's flick at the far

post on 73 minutes.

Mikel Merino had given the Gunners the lead in the 37th minute when his shot was deflected into the corner after Ethan Nwaneri's cut-back.

Rodrigo Muniz pulled a goal back for Fulham in stoppage time when his shot was deflected by William Saliba and wrong-footed goalkeeper David Raya.

The win moved Arsenal to within nine points of runaway leaders Liverpool.

It was a mixed night for the Gunners though who, despite the positive of having Saka back from his serious hamstring injury, lost centre-back Gabriel early in the first half, which is a worry for manager Mikel Arteta with a Champions League quarter-final against Real Madrid next week.

Fulham defended deep throughout the match but should have pulled one back much earlier when substitute Muniz headed wide from six yards out with the goal gaping.

Arsenal take on Everton on Saturday in the Premier League before preparing for the first leg of their quarter-final against Real at home on Tuesday.

All of the talk before the match was of Saka's return after Arteta had said that the forward was "ready to go" after his lengthy injury.

The Gunners have suffered without him in the side and their failings in attack are one of the reasons they have not kept touch with Liverpool in the title race.

In the 16 games that the 23-year-old was available in the Premier League for Arsenal, they scored 34 goals at a rate of 2.1 per game.

In the 13 that he missed, the Gunners scored 19 at a rate of 1.5 per match - highlighting Saka's importance to the side.

His presence lifted the stadium and he received a standing ovation when he went out to warm up in the first half.

Arsenal initially struggled to break down Fulham, a common theme of their season which has seen injuries to attackers Kai Havertz and Gabriel Jesus alongside Saka.

But Saka's introduction was loudly cheered and the stadium erupted when he scored. The sight of him hitting his stride immediately is a welcome one for those Arsenal fans, with a big test to come against European champions Real. Fulham came to the Emirates with a very clear gameplan to defend deep and restrict Arsenal to limited chances.

Manager Marco Silva made five changes to the team that lost 3-0 in the FA Cup quarter-final to Crystal Palace and changed formation to play with five at the back.

The plan almost worked as Arsenal, as they have all season with their injuries, struggled to create clear openings before Merino's deflected shot gave them the breakthrough.

Fulham had good opportunities of their own as Raul Jimenez forced a good save from Raya and Muniz somehow missed before he eventually pulled one back.

Silva cut a frustrated figure in his technical area and will be hoping that these two results do not derail the good work that Fulham have done up to this point.

Injury misery for Gabriel

Arsenal defender Gabriel will miss the remainder of the season after the club confirmed he requires hamstring surgery.

The Brazilian was substituted in the first half of Arsenal's 2-1 win against Fulham at the Emirates stadium on Tuesday.

The former Lille defender has started 28 of Arsenal's 30 Premier League matches this term, helping the club to the best defensive record in the division with 25 goals conceded.

Arsenal say the 27-year-old is aiming to return to action in time for the start of the 2025-26 campaign.

"Gabi will undergo a surgical repair procedure to his hamstring in the coming days, and immediately begin his recovery and rehabilitation programme, with the aim to be ready for the start of next season," the club said.

Gabriel's absence could have a significant impact on the team, with the website Premier League Injuries reporting that Arsenal's win percentage drops significantly when he does not feature.

Since his league debut, Arsenal have won 63.5% of the 159 games he has played, but only 40.9% of the 22 he has missed.

It is the 119th hamstring injury in the Premier League so far this season, an average of four injuries to the muscle each round of games.

Last season saw 163 hamstring injuries - the highest for five years - according to figures from Premier Injuries.

Arsenal are second in the Premier League, 12 points behind leaders Liverpool with eight matches remaining.

The Gunners face holders Real Madrid in the Champions League quarter-finals.

Carlo Ancelotti's side visit north London on 8 April (20:00 BST), before travelling to the Bernabeu for the second leg on 16 April (20:00 BST).

Elanga strikes to hurt old mates

Nottingham Forest moved closer to realizing their Champions League dream as Anthony Elanga's solo strike defeated his former club Manchester United, 1-0 on Tuesday night.

The winger, who joined United as a 12-year-old, sprinted 70 yards before finishing into the bottom corner to catch the visitors cold with an early winner.

He joined Forest from United for £15m in 2023, in search of regular football, and continued his excellent season against his former club.

Murillo ensured the win with a dramatic goalline clearance from Harry Maguire in the final seconds.

Forest remain third in the Premier League and it is hard to see how Nuno Espirito Santo's side fail to secure Champions League football from here.

Into the FA Cup

semi-finals - where they face Manchester City at Wembley this month - and on the brink of a first European campaign since 1996, Forest are almost in dreamland.

Efficient and effective, they completed a double over United for the first time since 1991-92 with a 13th clean sheet of the season and condemned the visitors to their 13th defeat of the campaign.

Ruben Amorim's side were neat and tidy in spells but there was little punch to their attack, as they were unable to break down their organised hosts, while they struggled to contain Elanga.

Diogo Dalot's first-half header bounced off the bar and Bruno Fernandes tested goalkeeper Matz Sels early on but they are still looking for successive Premier League wins this season.

United remain floundering in 13th before Sunday's derby with

Manchester City and there was little suggestion at the City Ground their position will improve.

Forest were again back at their defensive best - the foundation of their success this season.

A 13th clean sheet of the campaign edges them ahead of Liverpool's 12 as they limited Manchester United until the last few seconds.

It was another robust

and organised defensive display, with every cog in the machine knowing exactly what to do.

That included the upheaval of losing Ola Aina to injury, with Alex Moreno replacing him in a first-half defensive reshuffle.

It did not upset their rhythm and only served to prove their mental and physical resilience.

In January, Forest were humbled 5-0 at Bour-

nemouth but responded with a 7-0 win over Brighton - and when they conceded four at Newcastle, they then kept back-to-back clean sheets against Arsenal and Manchester City.

On Tuesday, they kept United out - even if they needed Murillo's last-gasp goalline clearance to deny Maguire a leveler - to earn a fourth clean sheet in their past six games.

Bolstered by the return of key players from injury, a Champions League spot is in their sights, while the chance for silverware in the Europa Conference League seems a genuine possibility.

After looking lack-

lustre for much of the game, Tottenham's surge forward in search of an equaliser came all too late.

Son Heung-min was agonisingly close to netting an 89th-minute leveller as he slid in to reach Brennan Johnson's cross, but Robert Sanchez scrambled across his goalline brilliantly to deny the Spurs captain.

While Chelsea con-

stantly hassled their visitors, Tottenham looked panicked in defence, sloppy in possession and struggled to fashion many clear-cut chances.

Vicario, meanwhile, provided little reassurance to his backline with multiple wayward passes and an inability to command his box convincingly.

Frustrations boiled

over on the stroke of half-time when Cristian Romero's shove on Levi Colwill caused a maul as players squared up to each other.

But Tottenham were unable to channel their emotions into anything worthwhile.

And in the wake of this defeat, Postecoglou's future at the club becomes all the more uncertain.

The Australian directed a brief clap towards the furious travelling away fans from near the halfway line following his side's 1-0 loss at Stamford Bridge but, by then, it could be argued the damage had already been done.

Chants of "you don't know what you're doing" came from the away end after midfielder Lucas Bergvall was replaced by Pape Sarr in the 65th minute.

Remarkably, Sarr found the net with an excellent long-range strike just four minutes later,

leading Postecoglou to cup his ear and turn to the away end, only for VAR to then rule out the goal for a foul on Moises Caicedo.

When asked about the incident after the match, Postecoglou said: "Jeez mate, it's incredible how things get interpreted. We'd just scored, I just wanted to hear them cheer. Because we'd been through a tough time, and I thought it was a cracking goal."

Former Spurs midfielder Jamie Redknapp put it plainly when he said on Sky Sports: "Tottenham were awful. It could have been so much more. Not good enough in any department from Tottenham. Chelsea were so much better."

"It's not ideal for the manager. He's got some big games ahead. He's got to keep his head up, got to keep going, working hard and believing in what they do."

points clear at the top with eight games to play.

Slot has seamlessly taken over the Anfield hotseat from the much-vaunted Jurgen Klopp and the Dutchman's side have lost just once in the league.

Liverpool have impressed both in attack and defence - not only have they scored more goals than any other

team with 70, they have also managed to keep a joint-high 13 clean sheets this term.

The Reds were left convalescing during the international break after being knocked out of the Champions League by Paris St-Germain then losing the Carabao Cup final to a hungry Newcastle side.

The ball didn't quite seem to fall their way for much of Wednesday night, with Everton defenders diving in to make crucial blocks,

but Liverpool showed why they are champions elect following Jota's twinkling of inspiration.

His delightful goal came at the right time as it was just his sixth in the league this term and ended a barren run of 10 games without scoring.

With Manchester City dropping away this season and Arsenal failing to mount a serious challenge, the title is in sight for Liverpool and the earliest they can put red ribbons on the trophy is 20 April at Leicester.

Chelsea see off dismal Spurs

Enzo Fernandez scored the only goal as Chelsea beat Tottenham to move into the Premier League's top four and boost their hopes of Champions League football next season.

Thursday's defeat for Spurs piled more pressure on head coach Ange Postecoglou - whose side stay 14th, and remain on course to finish outside the top 10 for the first time since 2008.

The Blues, boosted by the returns from injury of Cole Palmer and Nicolas Jackson, dominated proceedings at Stamford Bridge, but they were frustrated by a goalless first-half having missed plenty of opportunities.

They carried the same threat after the interval and were rewarded in the 50th minute when Fernandez headed home Palmer's inch-perfect delivery.

Moises Caicedo swept a crisp volley past Guglielmo Vicario moments later, but the goal was ruled out for a marginal offside in the build-up following a four-minute VAR review.

Tottenham then had an equaliser ruled out after substitute Pape Matar Sarr fired in from 20 yards out.

Referee Craig Pawson, advised by VAR to have a look at the pitchside monitor, overturned his decision after watching the Spurs midfielder catch Caicedo with his studs before taking aim.

The result moves Chelsea to fourth in the Premier League, knocking reigning champions Manchester City down to fifth and Newcastle to sixth.

The Blues were in scintillating form from the off as they returned to action following the recent inter-

■ Liverpool edge tough derby to go 12 points clear

Liverpool claimed bragging rights on Merseyside with victory over rivals Everton on Wednesday night and edged closer to lifting the Premier League title.

Arne Slot's men require only 13 points from a possible 24 available to guarantee a deserved and record-equalling 20th top-flight triumph.

The Red were being frustrated by Everton's backline sitting deep, but claimed the three points courtesy of a moment of magic from Diogo Jota.

The Portugal forward was on the periphery of the game but collected Luis Diaz's cute back-heel before showcasing dancing feet by jinking past challenges and slotting home.

Replays showed Diaz had been standing in an

offside position earlier in the build-up to the goal, but he was deemed not to be interfering with play and it was allowed to stand

Before the deadlock was broken, there was another moment of controversy with Everton defender James Tarkowski incredibly fortunate to stay on the pitch.

Tarkowski received only a yellow card early on when he won the ball with a sliding challenge but caught Alexis Mac Allister on the knee with his studs with the follow-through.

The video assistant referee (VAR) decided not to upgrade the tackle to a red card and Dominik Szoboszlai curled the resulting free-kick narrowly wide, while the in-form Mohamed Salah headed straight at Jordan Pickford at the back

post.

Beto had the Liverpool backline rattled and saw a goal ruled out for offside after outmuscling Virgil van Dijk.

The striker got the better of the Reds captain again, but this time could only hit the post when one-on-one with Caoimhin Kelleher.

Liverpool and their supporters looked to up the ante in the second period and Ryan Gravenberch's stinging drive from range was pushed away by Pickford, but Jota's 56th-minute strike made the difference.

Red smoke billowed from the Kop End and chants of "we're gonna win the league" echoed around from the home supporters at full-time knowing a second Premier League title is within grasp after moving 12
