Another bumpy day in court for Prince Harry!

■ Disgruntled royal's High Court case interrupted by rowdy supporter

Prince Harry was dramatically escorted from his hearing at London's High Court on Wednesday after a supporter appeared to disrupt proceedings.

The Duke of Sussex, 40, was taken out of the courtroom by an entourage of bodyguards after an unnamed woman in her 50s shouted out in defense of the royal.

The woman in question had initially attracted attention by arriving late to the court to witness Harry and his legal team attempt to win back taxpayer-funded UK security protection.

After her tardy arrival, the woman continued to cause a scene in the quiet courtroom by moving around in her seat, playing with her two cellphones and flicking through a notebook.

Harry's longtime security honcho David Langdown, 57, was spotted keeping his eye on the woman in case her actions escalated, according to multiple reports.

Langdown and his associate were later seen escorting the Invictus Games founder out of

the room at the Royal Courts of Justice — ensuring that the woman did not come close to the prince.

As a visibly tense Harry passed her, the woman yelled out, "I support you, Prince Harry."

"If you're members of the press, you're the reason he's not in England," she was also heard saying at the court's public gallery.

The woman was immediately led out by a member of security, after which Harry and his bodyguards returned to resume the private part of the hearing.

During Wednesday's proceedings, Harry's legal team told the court that he and his wife, Meghan Markle, "felt forced" to step back from their roles as senior members of the royal family.

The Sussexes "wished to continue their duties in support of the

late Queen as privately funded members of the royal family," Harry's attorney, Shaheed Fatima KC, told the court.

Harry's team also insisted that a formal process never took place before he and his wife were stripped of public-funded protection. His security "does not appear to have been discussed at any formal RAVEC [Royal and VIP Executive Committee] meeting," Harry's lawyer told the court.

Instead, there was a meeting at Buckingham Palace on Jan. 27, 2020, to discuss the matter.

Harry's lawyer claimed that the RAVEC "diverted" from its standard process and failed to submit proper documentation explaining its decision to strip Harry of protection privileges.

At one point during the hearing, Harry appeared to be visibly irritated as he threw his pen

down before adopting a facial expression indicating disbelief.

King Charles' younger son also complained

about not feeling safe enough to return to his home soil with his wife and their two children, Prince Archie and Prin-

cess Lilibet, because "it is too dangerous."

But the Home Office's barrister said the Duke

British investors feel the pain

■ Tariffs: Pension funds take huge hit as FTSE plummets

DONALD Trump's global trade war wiped millions more off British pension funds this week as savings and investments plunged.

The FTSE 100 hit its lowest level in a year due to the maelstrom from the US president's import tariffs. On the first day of trading in the first full week after "Liberation Day" it closed 5% down.

The turbulence spooked investors worldwide, with trillions wiped off stocks.

Hong Kong's Hang Seng closed down 13.2% – a 28-year low – as Taiwan's index slumped 9.7%.

Some have described it as America declaring an "economic nuclear war" on every country in the world. One analyst predicted: "Business investment will grind to a halt, consumers will close their wallets and [the damage] will take years and potentially decades to rehabilitate."

In Britain – slapped with a relatively low 10% tariff, pension funds are being hit because they invest in FTSE 100 companies.

The index saw big falls on Tuesday and Thursday, including British Airways owner

International Consolidated Airlines Group and aerospace giant Melrose Industries, down 10.5% and 6.6% respectively. Shares in Shell plunged 5.2% while Rolls Royce, Astra-Zeneca and National Grid also tanked in the third day of turmoil since Trump's tariff announcements last week.

Even the most modest pension funds suffered big dips in value, leading to reports some well-paid earners had lost over £100,000 from their pots in a week.

defiant response

Experts say the ripping up of the rule book may spark a rush from Britons approaching retirement to put off taking an income from their pension through "draw-down", where they leave money invested and take a regular income directly from the fund.

Instead, tens of thousands could opt for an annuity – which converts the pot into an annual pension, giving them a guaranteed income for either life or a specified period.

Chris Eastwood, boss of workplace pensions specialist Penfold, said: "Someone with a £100,000 pension pot – roughly the average for a

50-year-old man – could be looking at a £6,200 drop in value.

"However, pensions are a long game. Dips like this are part of the journey and not a reason to panic."

Jason Hollands, MD of financial planners Evelyn Partners, warned: "It is hard to know how much further markets might fall."

The worldwide crisis prompted a defiant response from Sir Keir Starmer, while visiting Jaguar Land Rover in the Midlands.

He said: "It is a moment for urgency because we've got to rise together as a nation to the great challenge of our age, and it is the great challenge, which is to renew Britain so we're secure in this era of global instability."

There may be good news for British mortgage holders though. Laith Khalaf at AJ Bell, said: "Interest rate expectations are falling as markets price in the potential economic damage from US tariffs, and the likelihood is the Bank of England will respond with interest rate cuts."

"The market had been pricing in two this year, but in short order that has been ratcheted up to three."



Starmer calls for 'cool heads' as further cuts loom

SIR Keir Starmer has opened the door to more savage spending cuts as he tries to ward off recession after the economic meltdown from Donald Trump's trade tariffs.

The Prime Minister insisted he would stick to his economic master plan and called for "cool" heads to see Britain through the global crisis.

He promised not to hike revenue-raising income tax, National Insurance or VAT, saying: "The first lever can't be more taxes."

fiscal rules

But with the economy already flatlining, it could mean more brutal cuts to services and an increase in borrowing.

Sir Keir's remarks came as stock market volatility raged around the world in the wake of US president Mr Trump's import charges.

Economists warn it could force Sir Keir to raise taxes, make deeper spending cuts or break his fiscal rules to increase borrowing.

Asked if he would

stick with his pledge not to hike the three main taxes, the PM said: "That is a commitment we've made and a commitment that we will keep, because the first lever can't be more taxes."

"My strong belief is that we have to drive our economy, create the conditions for investment, which we have done – there's been record investment coming into our economy."

Speaking at a Jaguar Land Rover plant in Birmingham with Chancellor Rachel Reeves, Sir Keir added: "I'm still strongly of the view that the challenge we face is how to grow our economy" rather than using "tax-and-spend levers".

sluggish growth

Labour's election vow that surging GDP will fund its spending plans is already evaporated by a sluggish growth forecast.

Ms Reeves raised taxes by £40billion at the last Budget, including £20billion of National Insurance hikes on em-

No election deal with the Tories, vows Farage

NIGEL Farage has insisted that local election pacts between Reform UK and the Conservatives are not on the agenda.

The Reform leader was reacting to reports that the two parties could strike deals to prop each other up in order to take power in town halls across England after the ballots on May 1.

But speaking at a British Steel plant in Scunthorpe, North Lincs, this week Mr Farage said: "No, not happening."

"This place is closing because of their policies. It's the Conservatives that have closed down the steel industry and Labour are picking up the pieces."

"And after the elections if we have X number of councillors and other parties have Y number of councillors then you'd do deals with anybody if you thought it was in the interests of the area."

"You might even find the Liberal Demo-crats have a common view on a piece of local development or whatever it would be. But any talks of pacts, absolutely not happening."

The latest YouGov poll put Labour on 24%, Reform on 23% and the Tories on 22%. But Mr Farage, who also visited Stanley in County Durham, and Conservative leader Kemi Badenoch have publicly dismissed any prospect of a formal pact.

Mrs Badenoch acknowledged that the local elections were going to be "so challenging" as she campaigned in Salisbury.

She added: "We have to look at the context of what happened four years ago, the last time we fought these seats, we were polling at a high, winning seats that had never been Conservative before. So we know that this is a challenging set of elections."

Two Labour MPs say they are "astounded" to have been denied entry to Israel while on a trip to visit the occupied West Bank.

Abtisam Mohamed and Yuan Yang said it was "vital" parliamentarians were able to witness the situation in the occupied Palestinian territory first-hand.

of Sussex's appeal "involves a continued failure to see the wood for the trees".

Sir James Eadie KC, representing the Home Office, said: "It's important to emphasize that the decision was not that personal security of the kind previously provided would under no circumstances be provided.

"Rather it was simply that that security would not be provided on the same basis as before because of his (the duke's) change of status and because he was now going to live abroad for the majority of his time.

The hearing concluded on Wednesday with a decision expected in writing at a later date.

And royal sources it was only 'a clash of diaries' between Harry and his father that prevented them meeting before King Charles jetted off to Italy for a state visit this week.

The Duke of Sussex landed from Los Angeles on Sunday but his father spent the weekend at Highgrove, his private Gloucestershire home. His Majesty then flew directly to Rome from RAF Brize Norton with Queen Camilla on Monday afternoon.

They were refused entry because they intended to "spread hate speech" against Israel, the nation's population and immigration authority said.

Foreign Secretary David Lammy criticised Israeli authorities, describing the move as "unacceptable, counter-productive, and deeply concerning".

But Conservative leader Kemi Badenoch said Israel had a right to "control its borders", adding it was "significant" there were Labour MPs other countries did not want to let in.

'false claims'

Yang, the MP for Earsley and Woodley, and Mohamed, the MP for Sheffield Central, flew to Israel from London Luton Airport with two aides on Saturday afternoon.

The Israeli immigration authority said Interior Minister Moshe Arbel denied entry to all four passengers after they were questioned. It accused them of travelling to "document the security forces".

The Israeli embassy in London said in a statement on Saturday that the country "will not allow the entry of individuals or entities that act against

the state and its citizens".

It said Mohamed and Yang had "accused Israel of false claims" and were "actively involved in promoting sanctions against Israeli ministers".

It also said they had supported campaigns aimed at boycotting the country "at a time when Israel is at war and under attack on seven fronts".

The UK Foreign Office said the group was part of a parliamentary delegation. However, Israel's immigration authority said the delegation had not been acknowledged by an Israeli official.

The Israeli embassy said the MPs "were offered hotel accommodation, which they declined" and the cost of their return flight to the UK was covered.

Israel's Interior Ministry said the MPs left the country early on Sunday.

'free to speak'

Mohamed and Yang said their trip had been organised with UK charities that had "over a decade of experience in taking parliamentary delegations".

"We are two, out of scores of MPs, who have spoken out in Parliament in recent months on the Israel-Palestine conflict and the importance of

they would be in place for the next five years, Sir Keir did not categorically commit to keeping them.

As well as his 10% tariff on UK goods, Mr Trump also imposed 25% on cars and separate import taxes for steel and aluminium.

'pragmatic'

Sir Keir has also announced extra flexibility in the zero emission vehicle mandate as the automotive industry phases out petrol and diesel cars and vans.

complying with international humanitarian law," the MPs said in a joint statement.

"Parliamentarians should feel free to speak truthfully in the House of Commons, without fear of being targeted."

Lammy said the Foreign Office had been in touch with both MPs to offer support, adding: "I have made clear to my counterparts in the Israeli government that this is no way to treat British parliamentarians."

The Council for Arab-British Understanding and Medical Aid for Palestinians - the latter of which is a registered UK charity - said in a joint statement that they had organised the trip.

"This visit was part of that long-standing programme," they said.

"When questioned, the group was clear, open and transparent about the aims and objectives of the visit, which included visiting a range of projects run by humanitarian and development organisations operating in the West Bank.

"The group had informed the UK consul general in Jerusalem of their visit and was planning to meet with them as part of the itinerary."

Both Yang and Mohamed - who were first elected in 2024 - have made several interventions on the Israel-Hamas conflict in Parliament.

In February, Mohamed initiated a cross-party letter, signed by 61 MPs and lords, calling for a ban on goods from Israeli settlements on Palestinian territory, citing an opinion

from the International Court of Justice (ICJ).

She has also criticised Israel for withholding humanitarian aid from Gaza, telling the House of Commons in October that international law "prohibits the starvation of civilians as a method of warfare", and has mentioned humanitarian organisations' claims of "ethnic cleansing" in Gaza.

In January, Yang spoke in favour of bringing sanctions against Israeli ministers Itamar Ben-Gvir and Bezalel Smotrich, after they suggested building Israeli settlements in northern Gaza to encourage Palestinians to leave.

She has also highlighted the dangerous conditions journalists and medical professionals face while in the Palestinian territory.

Meanwhile, Reform UK leader and long-time Trump supporter Nigel Farage has admitted the president's tariffs are "a bit excessive". He said: "He promised he'd do it in the run-up to the American election, so you can't say he's breaking his promises.

"But...my own view is the impact of it has been bigger than he could have predicted."

Mr Farage said he now spoke to Mr Trump "far less" than during his first term as president.

Downing Street is still holding out hope for a deal with the US that will do away with tariffs and the PM's spokesman said negotiations were at an "advanced stage".

But Sir Keir is also consulting businesses on retaliatory measures for US goods heading to British shores.

On Sunday he spoke to European Commission president Ursula von der Leyen, outgoing German chancellor Olaf Scholz and German Christian Democrat Union leader Friedrich Merz.

'Laughing' teen convicted in slaying of 80 year-old man

■ Boy who craved social media notoriety and girl who filmed the fatal attack both face long custodial sentences

A boy who punched and kicked an 80-year-old man to death and a girl who laughed as she filmed the horror have been convicted of manslaughter.

The boy was 14 when he attacked retired factory owner Bhim Kohli as he walked his dog Rocky in a park near his home in September last year.

The girl, who was 12, could be heard laughing in her video showing the grandfather cowering on his knees as he was racially abused and hit around the face with a plastic sandal.

Relatives of the thugs, now aged 15 and 13, cried in court as the guilty verdicts were passed, and the girl began sobbing. The pair will be sentenced next month when a judge will consider lifting their anonymity.

The brutal killing was carried out because the boy killer's thirst for social media notoriety, said Leicestershire Police Det

Ch Insp Mark Sinski, who led the investigation. He said the killing of Mr Kohli ranked as one of the most shocking cases of his career.

"This is unusual," he said. "This has been of national significance and certainly very impactful on the local community."

'utterly disgusting'

"As a rule, elderly people aren't attacked by children but in this case he was, and that shocked the community, and the [victim's] family to the core, and indeed the wider public."

Mr Kohli's daughter Susan called their actions "utterly disgusting".

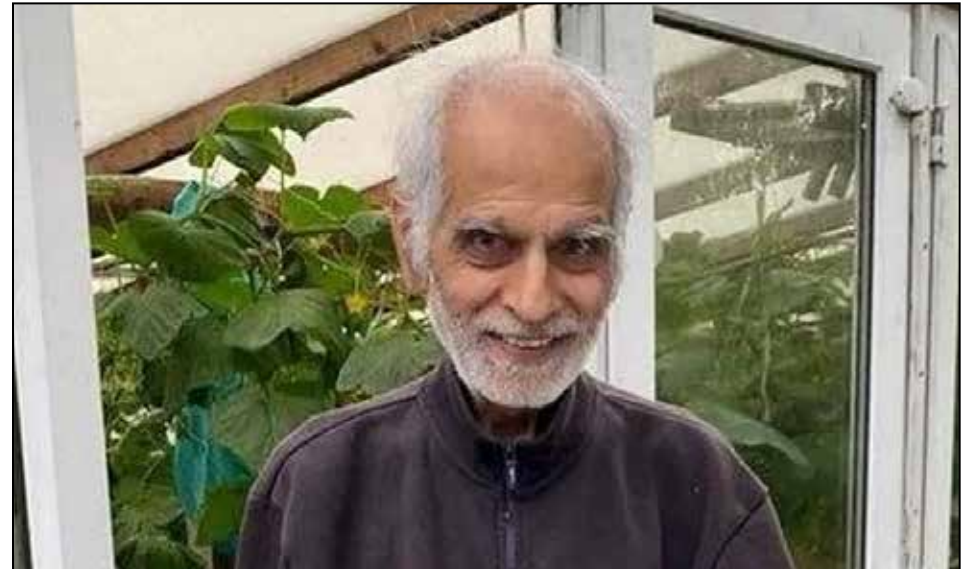
She added: "We feel anger and disgust towards the teenagers who took dad away from us. They humiliated him, an 80-year-old man, assaulted him, filmed it and laughed at him. Dad did not deserve this and wouldn't wish this on anyone else."

The boy, who was cleared of murder and found guilty of the lesser charge at Leicester Crown Court, wrote in a letter two months after the attack that he "kinda just needed anger etc releasing" after being dumped by a girlfriend, the court heard.

The girl "encouraged the violence" at Franklin Park in Braunstone Town, Leics, the court heard.

Harpreet Sandhu KC, prosecuting, said the girl knew what the outcome would be when she pointed the elderly man out to the boy.

Police found she had a picture of Mr Kohli on her phone, taken a week before the attack, which she used to "target him". The jury heard she regularly "recorded violence" on her phone. In a police interview she was asked if the video showing Mr Kohli being slapped with the shoe had given her enjoyment. She replied:

"Not really but it was a bit funny at the time."

Mr Sandhu told jurors the boy had used "gratuitous" and "intense violence" before leaving his victim for dead. Seconds before the attack he took a balaclava out of his Gucci bag and put it on "in preparation for violence" but told police he wore it "for fashion".

Shortly before Mr Kohli died the next day, the boy sent a laughing emoji to friends and said:

"Feds know it is me." Mr Kohli, a grandad and father of three from Punjab in India, who had lived in the area with his family for 40 years, had run factory making knitwear.

He lived with wife Satinder, 74, in a 1970s semi on a quiet cul-de-sac next to Franklin Park, where neighbours saw him walking his dog each day.

After the attack he was found near the park gates,

yards from his home, by his son and daughter and horrified neighbours. He died the next day in hospital. A post-mortem found the cause of death to be a neck injury "causing trauma to the spinal cord", and he had broken ribs.

Leicestershire Police Det Chief Insp Mark Sinski said: "Mr Kohli was the centre of his family, a very beloved husband. His family have been devastated by his loss."

"Narcisstic NHS plastic surgeon killed colleague who gave evidence against him

A plastic surgeon who wore camouflage to break into a colleague's £1million home at night and near-fatally stab him in the stomach has been convicted of attempted murder.

Peter Brooks attacked Graeme Perks and was said to have hated him for giving evidence in lengthy disciplinary cases at the NHS trust where they both worked.

Brooks, 61, was this week convicted of two counts of attempted murder, attempted arson with intent to endanger life and possession of a knife in a public place, on January 14, 2021, after his trial in Loughborough,

Leics.

Jurors heard he wanted his rival surgeon "out of the way" so cycled a mile from his home with a petrol mixture which he spread on stairs at Mr Perks's house in Halam, Notts, after breaking in through a conservatory.

delay tactics

Mr Perks, then 65, was woken by a bang and he ran naked downstairs, where he was stabbed while his wife and son were upstairs.

The court heard his insides were "sticking out" and he was saved by a doctor who said the injury was fatal in 95% of cases.

Brooks was arrested that morning, asleep on a garden bench in Southwell.

It can now be reported that "narcissistic" Brooks had tried to derail proceedings since, causing the trial to be listed nine times. Before it began last month he sacked his latest legal team, went on hunger strike and did not attend proceedings, saying it would be "inhumane".

A police source close to the case said: "This man (Brooks) is a classic narcissist. He will do anything to avoid taking responsibility for his actions".

Brooks, almost bed-

bound, faces a potential life term when Mr Justice Pepperall sentences him on a date still to be fixed.

He landed a job at Nottingham's City Hospital

in 2008 but later lost tribunal proceedings after he was excluded from wards following complaints from staff at Nottingham University Hos-

pitals NHS Trust.

Three days after disciplinary proceedings finished, with dismissal a possibility, Brooks launched his attack.

'Pretty terrified' fan Wills take his son to the Villa

He said it was a "big deal" to take George, who was wearing a Villa scarf, and the pair were seen punching the air and hugging when Morgan Rogers gave their team a first-half lead.

'big deal for me'

But PSG, who were crowned French champions on Saturday, fought back and scored three unanswered goals to take control of the tie.

Prince William, who was in the crowd for Villa's home win over Bayern Munich and in Monaco in January,

was asked if he was on a "lads' tour" by former England international Ferdinand.

"Well, I've got my son here as well, so I'm on best behaviour," he replied.

"But I thought, you know what, it's been 43 years since anything like this has happened in my generation as a Villa fan, and I want George to experience a night out away from home in a big European competition.

"I hope it's not 43 years until the next one happens, but I think those memories are really important to create and bringing him along tonight is a big deal for me."

like his three children to support Villa, who are seventh in the Premier League, Prince William said: "I'm generally very open to whoever they support, but obviously I'm a bit biased.

"But also they come to games with Villa. They're going to probably support Villa, but I've left the other two at home, probably watching tonight, so we'll wait and see who they support."

The prince was seen hugging some of Villa's players, including Marco Asensio and England international Marcus Rashford as

"The way he just dissected that there, I'm going to nick that for later on."

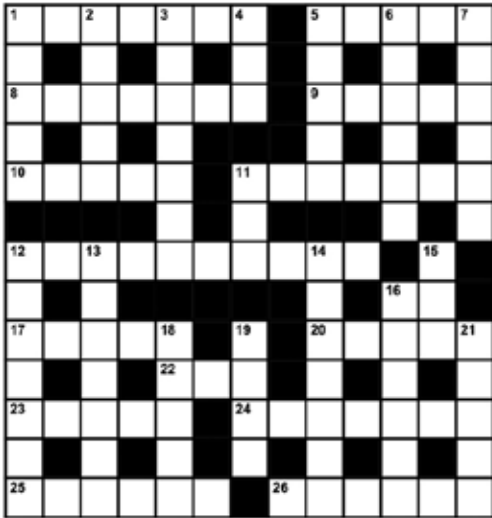

free-kick kept its line.

The ball bounced just before the Cameroonian and then skidded through his hands before hitting the net.

For the second Onana was unable to gather a shot which, although was hit with power, was straight at him, and Lyon's Cherki was gifted a late leveller.

It means since the start of last season Onana has made eight errors leading to goals in all competitions, the most of any keeper playing for a Premier League club.

With the Red Devils 13th in the Premier League table, their only realistic hope of qualifying for European football next season is through the Champions League spot afforded to the Europa League winner.

For large periods they looked well-organised, motivated and were probably the better team in Lyon.

But as has often been the case this season, United were hampered by poor finishing.

In the first half Rasmus Hojlund skewed a Patrick Dorgu cutback well wide, while Bruno Fernandes had a shot deflected over and Casemiro struck an overhead kick straight at the goalkeeper.

In the second period, an Alejandro Garnacho strike from a Dorgu cross was tipped over and Casemiro headed a corner just wide.

United forwards Hojlund and Garnacho both appeared to lack confidence.

Hojlund has now scored just one goal in his past 25 United appearances in all competitions, while Garnacho has one from his past 28.

Ruben Amorim will hope both will be able to turn their form around in time for the second leg.

Goalie masterclass leaves Ange bemoaning his luck

Ange Postecoglou said the "football gods" have deserted his Tottenham side after they were foiled by a goalkeeping masterclass from Eintracht Frankfurt's Kaua Santos.

The Brazilian produced a string of inspired saves in the 1-1 first leg draw of the Europa League quarter-final at Tottenham Hotspur Stadium, to the frustration of Postecoglou and his players.

Frankfurt's Hugo Ekitike showed why he has caught the attention of several Premier League clubs when he put the visitors ahead inside six minutes with a superb low strike.

However, Spurs responded well and took control before Pedro Porro equalised with a bold backheel flick.

Tottenham poured forward with intensity after the interval and would have scored had it not been for the woodwork and three big saves from

Santos.

In a frantic few minutes, Lucas Bergvall and Rodrigo Bentancur both rattled the crossbar, while Son Heung-min and James Maddison each had a curling effort stopped by the goalkeeper.

Deep into stoppage time, Santos was the hero for Frankfurt again with a fine fingertip save from Micky van de Ven's bouncing header.

"I'm resigned to the fact that the football gods have got their eyes elsewhere this year," Postecoglou said afterwards.

"They're obviously busy with other clubs and other managers, so whatever we get we're going to have to do it without them this year."

Sitting 14th in the Premier League and out of both domestic cups, the Europa League is Tottenham's only remaining chance of silverware success this season.

It also offers the tro-

phy winners a route into the 2025-26 Champions League.

This has been a disappointing season for Spurs and Postecoglou's future at the club may hinge on this competition, if his fate has not already been decided.

In his pre-match news conference, the under-pressure Australian boss said he was aware that even ending this term

with a European triumph may not be enough to convince some fans that he is the right person for the job.

With Frankfurt's spirited home support and a 58,000-capacity Waldstadion awaiting in the reverse fixture, a positive first-leg performance was a must for Spurs.

And, to an extent, they delivered. It was an entertaining showing from

Postecoglou's players, who did everything well after half-time apart from finding the back of the Frankfurt net.

"It's going to be that sort of the season - nothing is going to come to us easy," Postecoglou said.

"We're going to have to go there and fight now to get what I felt we deserved tonight, and that's what we'll try and do."

PSG brilliance leaves Villa with mountain to climb

Nuno Mendes struck deep into stoppage time to give Paris St-Germain a significant advantage against Aston Villa in the Champions League quarter-final first leg at Parc des Princes on Wednesday.

Villa looked like they would only need to overturn a one-goal deficit at Villa Park until Mendes stole in to deliver a devastating blow to Unai Emery's side in the dying seconds.

The visitors had stunned the newly crowned French champions when Morgan Rogers arrived at the far post to turn in Youri Tielemans' cross from the left after 35 minutes.

That breakaway goal to take the lead delighted an away support that included the Prince of Wales, a Villa supporter since his school days.

The lead only lasted four minutes before PSG

drew level, however, with Desire Doue leaving Villa keeper Emiliano Martinez helpless with a magnificent curling drive from 20 yards.

PSG's brilliant Georgian winger Khvicha Kvaratskhelia troubled Villa all night, and he put them ahead four minutes after the break when he turned substitute Axel Disasi before drilling a powerful shot high past Martinez at his near post.

Villa keeper Martinez, who had few friends in France following his antics at the 2022 World Cup final when Argentina beat Les Bleus in Qatar, made several fine saves on this occasion but was powerless as he was wrong-footed by Mendes in the closing moments.

It made it a bitterly disappointing finale for former PSG boss Emery and his Villa side, who were left despondent as the locals celebrated rapturous-

ly.

Villa's fans inside the vast bowl of Parc des Princes were in dreamland when they hit PSG with the perfect sucker punch 10 minutes before half-time, John McGinn's pinch of possession leading to Tielemans playing in Rogers to tuck home from close range.

Sadly for Villa, the lead

was only brief as they were forced to fight a rearguard action against this richly talented PSG side, who are now firm favourites to reach the last four.

Villa would have entered four minutes of stoppage time believing a one-goal deficit was eminently retrievable amid a big atmosphere at Villa Park, even though they

spent so much of this first leg clinging on.

Yet their task was made much tougher when Mendes pounced in the box to sit Martinez on the floor before shooting into the roof of the net.

Villa players slumped to the turf in agony, perhaps realising what a significant blow had been struck with only seconds left.

Two helpings of Rice gives Arsenal a very tasty result

Declan Rice stunned Real Madrid with two brilliant free kicks - the first scored in his career - as Arsenal took a commanding 3-0 first leg lead in their Champions League quarter-final.

Mikel Arteta had asked the Arsenal fans to arrive early to create an impressive atmosphere inside the stadium for Tuesday night's showdown, and the team responded by starting the game quickly with a number of dangerous crosses into the Madrid penalty area.

It took until the 20th minute for Madrid to have their first real chance, when Vinicius Jr curled an effort wide.

But Rice took control of the tie for Arsenal in the second half.

The Gunners were the better side all evening and took the lead in the 58th minute, when Rice curled the first of two excellent free-kicks round the Real Madrid wall into the corner of the net past Thibaut

Courtois.

Rice scored his second of the night with a free-kick of equal quality 12 minutes later, bending another long-range effort into the top right-hand corner to leave Madrid stunned.

Mikel Merino then made sure it was a memorable night for Arsenal when he curled a shot into the bottom corner from inside the area just five minutes later.

Things only got worse for Madrid when Eduardo Camavinga was sent off in stoppage time for picking up a second yellow card.

Arsenal have not reached the semi-finals stage of the Champions League since the 2008-09 season, but they have given themselves a huge chance of progressing to the last four with this result.

Arsenal came into this match as the less-experienced side in European competition, compared

with serial winners Madrid, but showed a ruthlessness and quality which Carlo Ancelotti's side could not match.

Arteta has been dealt a series of blows this season with injuries to key players and the focus before the game was on who would partner William Saliba at centre-back, with Jakub Kiwior ultimately getting the nod.

But those issues seemed trivial once the game got under way as Arsenal started the match so impressively. Bukayo Saka caused David Alaba all sorts of problems and one of his crosses should have been turned in during the first half.

Rice's two free-kicks nearly lifted the roof off of the Emirates before Merino added a third to seal the win, taking on the mantle of striker in the absence of Kai Havertz.

Merino has now scored five goals in his past nine appearances for Arsenal.

It could have been even

better for Arsenal as Jude Bellingham and Alaba had to clear balls off the Madrid goal line.

In a season where injuries have robbed Arteta of many key players, he has managed to lead his team

to a place where they can start dreaming about a Champions League semi-final.

Making Onana of himself...

Goalkeeper Andre Onana was at fault for two goals as a last-gasp Lyon equaliser put Manchester United's Europa League quarter-final tie in the balance at the half-way stage on Thursday night.

United went behind after 25 minutes when under-pressure Onana failed to get a strong enough hand to Thiago Almada's wide free-kick.

In the final seconds of the first half Leny Yoro equalised with his first goal for United by reacting quickly to Manuel Ugarte's volley and di-

verting the ball into the bottom corner.

The visitors thought they had won late on when substitute Joshua Zirkzee headed home Bruno Fernandes' looping cross in the 88th minute.

But, with the last play before the final whistle, Onana spilled Georges Mikautadze's shot and Rayan Cherki tapped in on the rebound.

United host Lyon in the second leg at Old Trafford next Thursday.

Attention was always going to be on Onana who was labelled "one of the worst keepers" in Manchester United

history by Lyon substitute Nemanja Matic on Wednesday.

Ex-United midfielder Matic had been responding to comments by Onana who said his side are "way better" than their French opponents.

Onana was booed every time he touched the ball inside Groupama Stadium, even if he had little to do before Lyon's opener.

With Lyon's first goal the 29-year-old reacted late to Almada's cross, having to wait to see if a Lyon player would divert the ball, and was caught out when the
