REFORM POLL SHOCKER!

■ Upstart party would win most seats if election held tomorrow, new survey shows

REFORM UK would win the most seats if a general election was held tomorrow, according to a new poll.

The survey suggests that Nigel Farage's insurgent party is on course to secure 180 MPs.

The Conservatives and Labour are predicted to be tied in second place with 165 each.

It would be a loss of 246 seats for Sir Keir Starmer's party with 10 Cabinet ministers ousted, including Deputy PM Angela Rayner, Health Secretary Wes Streeting, Home Secretary Yvette Cooper and Energy Secretary Ed Miliband, while the To-

ries would gain 44.

No party would be close to an overall majority, according to More in Common's poll of more than 16,000 people.

Luke Tryl, the group's UK director, said: "We are a long way from a general election and trying to predict the result is a fool's errand. But what we can say for certain is that as of today British politics has fragmented to an unprecedented level.

"The coalition for change that elected Keir Starmer's Government

has splintered right and left.

"Nigel Farage's Reform UK emerges as the biggest winners of this Parliament so far, with our model suggesting they could well become the largest party, something almost unthinkable a year ago.

"Though the party remains a long way from being able to secure a majority, it is clear the momentum is real. The question is whether their new level of support represents the start of a path to government or a ceiling that Farage's polarising brand finds hard to overcome."

Mr Tryl said Labour finds itself "on the wrong side of a disillusioned electorate frustrated at the slow pace of change and some of the Government's early missteps". He added: "Not only would an election see the gains of 2024 largely reversed, but the party is also suffering historic losses in heartlands such as the Welsh Valleys, Greater Manchester and South Yorkshire.

"Conservatives, meanwhile, may breathe a sigh of relief they haven't been entirely wiped out." Mr Tryl went on: "The nature of a splintered electorate means elections for the next

few years will be highly unpredictable, with candidates winning on small shares of the vote and knife-edge results. The test for all main parties will be which one can prove they can really deliver."

The survey, carried out last month, comes as Mr Farage said he will not be bullied by tech billionaire Elon Musk. There had been reports that the X owner could make a big donation to Reform.

But just weeks later Mr Musk called for the Reform leader to be replaced in a row over far-right activist Tommy Robinson. The Clacton MP said: "Nobody pushes me around - not even him."

But as has so often been the case with Reform, no sooner had they received the good

news than they found themselves embroiled in another controversy about some of their candidates. Campaign Hope Not Hate claimed this week that Reform had 'posted hate, pushed far-right conspiracies and praised extremists' - despite Nigel Farage's claim to have beefed up the party's vetting process.

Reform has recruited more than 1,600 candidates for 1 May's English council elections, has made much of its efforts to "professionalise" the party after a series of racism scandals at last year's general election. Speaking at a campaign event in Dover on Thursday, Farage said the party had put in place "a vetting system that was as good if not better than the other parties" for this year's elections.

Farage went on: "hundreds of people who applied to be candidates for the county council elections were rejected... often because of repeated use of words beginning with F and C on social media."

He said others had been rejected "because they just said things that were just ridiculous, outrageous, embarrassing".

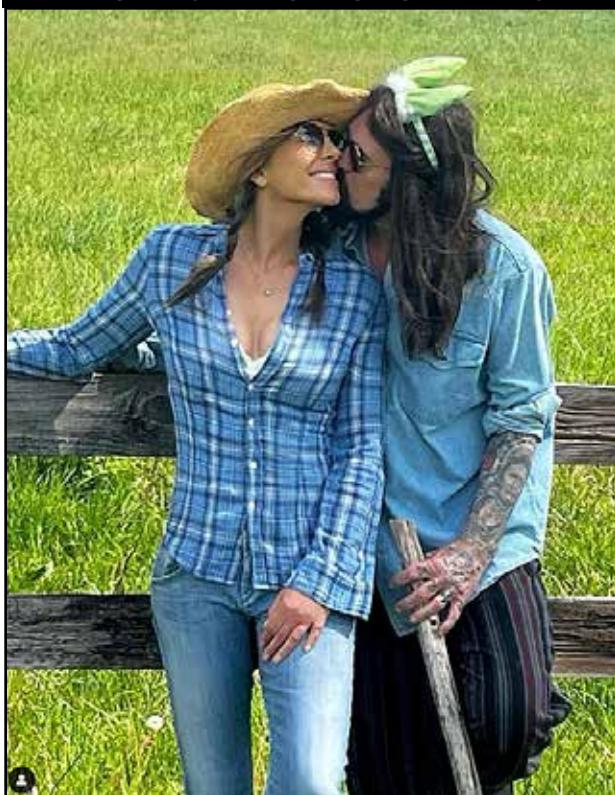
But Hope Not Hate gave several examples it had found which undermined his vetting claims.

The group published details of social media posts it had found from 14 different current Reform UK candidates, with one candidate saying "one big nuke bomb" should be used to remove Islam from the world.

Another said Bradford has a large Mus-

Westminster infested with Chinese bugs?

■ Security sources claim China is bugging pubs, park benches and other public places in widespread espionage campaign

CHINA is spying on UK politicians by bugging pubs, park benches and buildings in Whitehall, security sources believe.

Officials holding sensitive positions in Westminster have been warned about hotspots in London's SW1 area including the historic Red Lion, which is often frequented by MPs, five-star hotels such as Raffles, and St James's Park, which is next to Downing Street, the Foreign Office and

Treasury.

A source told a Sunday newspaper: "We have been told the Chinese literally have the park bugged, with devices in the bushes and under park benches." Targets are said to include junior staffers who work for MPs.

The source said: "Commons researchers are regarded by the Chinese and other spies – including the Russians and Iranians – as the soft underbelly of Whitehall."

'repression network'

Shadow Home Secretary Chris Philp warned that Britain "must be alert to the threat posed by China – and fast". He added: "On our infrastructure, our economy and national security, we must be realistic about the dangers we face."

"We know China is building a spying and repression network here in the UK."

He also hit out at the Government for "kow-towing" to Beijing, saying: "Our national security is at risk but

judging by this Labour Government's lazy embrace of China, you wouldn't be able to tell.

"In their desperation for economic links with China to offset the mess created by their disastrous Budget last October, Labour will do pretty much whatever China wants."

"This includes failing to place it in the enhanced tier of the foreign influence registration scheme, a move that would have kept tabs on those working in the interests of the Chinese state."

Parliament is already a target for cyber attacks by hostile actors, with MPs who have been critical of China experiencing hacking attempts. But Chancellor Rachel Reeves insisted at the weekend it would be "foolish" to stop engaging with China.

There has been speculation she may be pressed by Washington to limit Britain's dealings with China as part of her trade talks

She flew Stateside this week amid efforts to strike a deal, which the UK hopes will help soften the brunt of President Donald Trump's tariffs.

She said: "China is the second-biggest economy in the world and it would be, I think, very foolish, to not engage. That's the approach of this Government."

lim population and is a "shithole".

Others promoting the conspiracy theory that Muslims are seeking to "supplant the native population" in the UK.

Some of the posts, on Facebook or X, were made this year, others date back up to a decade.

They appear to have been open to anyone to view when Reform UK selected and vetted the candidates but some have now been hidden or deleted.

Home Secretary condemns Trans vandalism

Home Secretary Yvette Cooper has called the vandalism of several statues in Parliament Square, including one of women's votes campaigner Dame Millicent Fawcett, "disgraceful".

Transgender campaigners gathered on

Saturday in front of Parliament to protest against the Supreme Court ruling that biological sex defines a woman for the purposes of the Equality Act.

Cooper said she welcomed the Metropolitan Police's investigation and

that the government will strengthen the law "to better respect and protect important memorials".

The force said seven statues were damaged and they are investigating the incidents as criminal damage. No arrests have been made.

BBC wanted me gone, claims Lineker

Veteran Match Of The Day host Gary Lineker says he felt the BBC wanted him to leave the iconic show after 26 years.

The star, 64, will depart from the Premier League highlights series when the football season comes to a close next month but will still present FA Cup and World Cup coverage for the corporation.

Lineker told the BBC: "It's time [to leave]. I've done it for a long time, it's been brilliant, it's been great... Well, perhaps they want me to leave... There was a sense of that.

"I always wanted one more contract. It was their preference that I didn't do Match Of The Day for one more year so they could bring in new people, so it's slightly unusual that I would do the FA Cup and the

World Cup, but, to be honest, it's a scenario that suits me perfectly." A trio of presenters – Kelly Cates, Mark Chapman and Gabby Logan – will replace him on Match Of The Day.

'over-reaction'

Lineker, who has been the BBC's highest-paid star for seven years – with an estimated £1.35million in 2023–24 – was also questioned about the 2023 row over his tweet comparing the Government's asylum policy with 1930s Germany.

The former England striker was briefly taken off-air, and other sports hosts walked out in solidarity, before he returned.

Lineker said: "I don't regret saying them [the words] publicly because I

was right – what I said, it was accurate... Would I, in hindsight, do it again? No, I wouldn't because of all the nonsense that came with it...It was a ridiculous over-reaction that was just a reply to someone that was being very rude. And I wasn't particularly rude back."

He added: "But I wouldn't do it again because of all the kerfuffle that followed, and I love the BBC, and I didn't like the damage that it did to the BBC...But do I regret it and do I think it was the wrong thing to do? No." The father of four also said the BBC should "have ignored it, and it would have been fine", and called the corporation "silly" for its "over-reaction" in taking him off-air.

He added: "The BBC tries to appease the peo-

ple that hate the BBC, the people that always go on about the licence fee, attack the BBC.

"They worry way too much about that, rath-

er than worry about the people that love the BBC, which is the vast majority. Why shouldn't I have an opinion on things? I'm a bloody footballer who's

turned into a sports presenter."

Lineker ruled himself out of a career in politics, saying he has "never had a view".

Louis is seen sitting on a tree trunk against a beautiful spring backdrop, surrounded by bluebells, in the garden of Anmer Hall, the family's residence on the famous royal Sandringham Estate.

The fourth in line to the throne, who is known for his cheeky antics on the Buckingham Palace balcony, is wearing an open-necked shirt, dark green jumper and blue jeans – and is proudly showing off his missing two front

teeth.

His picture was accompanied by the message: "Wishing Prince Louis a very happy seventh birthday!" The text was then followed by a cake emoji.

Josh Shinner, who has photographed the Wales family before, took the new portrait.

Later the same day Kensington Palace released a behind-the-scenes video from the

photoshoot.

As gentle piano music plays in the background, Louis runs up to the camera and puts his face right up close, showing off his two missing front teeth.

The adorable 25-second video shows the young prince attempting to choreograph the shoot, telling Mr Shinner: "I can jump down from here." He is then shown walking along a fallen tree trunk and jumping into

the air.

Meanwhile, it has emerged the Prince and Princess of Wales will spend their 14th wedding anniversary on Tuesday in a self-catering cottage on a Scottish island.

William and Kate will travel back to the country where they fell in love for a planned two-day visit, meeting craftspeople, farmers and residents on the Isle of Mull, off Scotland's west coast.

Proof that gladiators fought lions found in York excavation

THE world's first scientific proof that Roman gladiators really were killed by lions has been found in York.

Experts have identified big cat bite marks on one of 82 skeletons discovered in a gladiators' graveyard in the city, known as Driffield Terrace.

The man was aged 26 to 35 when he died between 200AD and 300AD.

Scientists found evidence he suffered malnutrition as a child and spinal and lung issues in later life.

bite wounds

But the lion bite wounds, found on his pelvis, had not healed – indicating they caused his death. And he was likely bitten while duelling with the beast in a York arena.

Images of gladiators fighting lions appear in Roman mosaics and pottery, but researchers say this is the first skeletal evidence of big cat bites.

Malin Holst, of York University's Department of Archaeology, said the find was "hugely exciting" as it "confirms the presence of large cats...in arenas in cities such as York".

She added: "We often have a mental image of these combats occurring at the grand surroundings of the Colosseum in Rome, but the findings show these events had a far reach.

"An amphitheatre probably existed in Roman York – but this has not yet been discovered."

Ten year sentence for paddleboard tour operator whose negligence caused four deaths

■ Nerys Lloyd ignored "extremely hazardous conditions" on Pembrokeshire river

A former paddleboard firm owner has been jailed for 10 years and six months after the deaths of four people on a river in south-west Wales.

Paul O'Dwyer, Andrea Powell, Morgan Rogers and Nicola Wheatley died after paddleboarding in "extremely hazardous conditions" on the Western Cleddau river in Haverfordwest, Pembrokeshire in October 2021.

Nerys Bethan Lloyd, 39, an ex-police officer from Port Talbot, pleaded guilty to gross negligence manslaughter last month.

She was sentenced during a two-day hearing at Swansea Crown Court, which heard she was unqualified to lead a paddleboard tour of this kind.

Neither Lloyd nor co-instructor Mr O'Dwyer were qualified to lead the tour, and Mrs Justice Stacey criticised the "abysmal" approach to health and safety during her sentencing remarks.

heavy rain

Citing her police and RNLI training, the judge said Lloyd "knew better", although acknowledged she was "horried" at what happened.

The group of seven participants, led by Lloyd and Mr O'Dwyer, set off after 09:00 BST on 30 October 2021.

Three participants died along with Mr O'Dwyer.

During the sentencing hearing, the court heard there had been heavy rain in the days before and "the river was in flood conditions" with a "visibly strong current".

On Tuesday, the court was shown photos of a weir the group was trying to navigate.

This included a section called fish pass, which was 11m (36ft) long and on an incline of about one in seven, or 14%.

The court was shown conditions on the weir on the day of the incident, with Mark Watson KC, prosecuting, explaining on Tuesday it showed "immense turbulence" of the water.

Mrs Justice Mary Stacey said the group "fell down the face of the weir" in no more than 20 seconds.

'high risk of death'

They were sucked into a hydraulic jump – or spin – a recirculating flow similar to a washing machine.

She added: "The ankle leashes attached to the boards of those stuck in the hydraulic spin, which are totally unsuitable for fast-flowing water, made it even harder for them to get free."

Mrs Justice Stacey said that the "four participants were not wearing wetsuits and one had decided that a life jacket would not be necessary."

She added there had been "no safety briefing" beforehand, none of the participants had the right type of leash for their boards in these conditions and Lloyd did not have any next of kin details.

Mr O'Dwyer initially exited the river safely, but then re-entered the water in an attempt to rescue the others.

Mr O'Dwyer, from Port Talbot, Ms Rogers, from Merthyr Tydfil, and Ms Wheatley, of Pontarddulais, Swansea county, all died at the scene.

Ms Powell, from Bridgend, died in hospital on 5 November 2021, about a week after the incident.



Lloyd was jailed for 10 years and six months

The judge said it was clear to her Lloyd intended for the group to go over the weir down the fish pass if possible "which would be more interesting" than carry-

ing the boards round the weir.

Mr O'Dwyer had researched alternative routes, but all were "dismissively rejected by you", the judge said.

Mr O'Dwyer deferred to Lloyd as the company owner to decide the final route but raised valid concerns, such as the drop over the weir.

Meghan: American Riviera Orchard was 'word salad'

The Duchess of Sussex says that American Riviera Orchard, the former name of her lifestyle business, was a "word salad", adding: "I didn't love that so much."

Meghan hit trademark issues when the US Patent and Trademark Office said geographical locations could not be patented – and she eventually renamed her venture "As Ever".

On her Confessions Of A Female Founder podcast this week, Prince Harry's wife said it was "helpful to have that quiet period" before the rebrand "when no one was sniffing around".

The Duchess was chatting with her hair colourist and "dear friend" Kadi Lee.

She is co-founder of hair wellness brand Highbrow Hippie – Meghan reportedly invested in it last year.

Ex-actress Meghan said: "I had secured As Ever as a name in 2022 and then, as everything started to evolve last year, and bringing in a partner the size that it was, it was just so interesting.

"You remember, I said, 'I like American Riviera as an umbrella', and then be able to have verticals beneath it. And maybe have the Orchard really small.

"But when that's not feasible...suddenly it became this word salad. I didn't love that so much.

"I was like, 'OK, let's go back to the thing that I've always loved. Let's use the name that I protected for a

reason that had sort of been under wraps'.

The Duchess said the pair met in 2020, the year the Sussexes swapped duties as working royals for a new life in the US.

She recalled that her attempt to colour her hair at home during the pandemic using boxed hair dye resulted in "this very inky, almost Elvira-esque black hair". Lee, who was called in to help Meghan at the time, said: "You were so warm and both you and I wrapped us up in these big bear hugs and I was like, 'I don't even know these people and I'm not a hugger but let's do it'."

Mrs Justice Stacey said Lloyd's interest "seemed to be more in an exciting route than safety" and it was clear from CCTV she went straight down the middle of the weir rather than making any attempt to get to the side.

She added she showed "a blatant disregard for a very high risk of death".

Her lawyer told the court Lloyd took "full blame for the mistakes" that led to the deaths. He said there was a plan to get out of the water ahead of the weir but the force of the water meant she and the others were carried over it.

Lloyd trained as a firearms officer after joining South Wales Police following university and Mrs Justice Stacey said she would have been "well-versed" in the importance of health and safety and risk assessments.

■ Windsor service features surprise appearance by Prince Andrew

THE King wished the country a "very happy Easter" as he led the Royal Family at the traditional Easter Sunday service in Windsor on Sunday.

He was joined by Queen Camilla and other members of the Firm, including a surprise appearance by Prince Andrew and his ex-wife Sarah Ferguson.

But the Prince and Princess of Wales and their children did not attend the matins service at St George's Chapel as they spent the weekend on holiday in Norfolk.

Arriving in the state Bentley to spring sunshine, the King and Queen greeted the Dean of Windsor, Dr Christopher Cocksworth, before turning to wave to the crowds gathered opposite.

They joined just over a dozen members of the

Royal Family who were waiting outside the Galilee Porch, having gone on ahead.

Andrew and Fergie arrived with Princess Anne and her husband, Vice Admiral Sir Tim Laurence in a car.

Fergie stopped to wave to the public and stayed outside chatting while the Duke of York made a beeline inside.

His attendance had not been anticipated, as he bowed out of the Royal Family's traditional Christmas gathering at Sandringham last year amid the controversy surrounding his links to an alleged spy.

Andrew spent the festivities with his ex-wife, who he remains close to, at the home they share in Windsor, Royal Lodge.

It marks the second time the Duchess of York has attended the service since she divorced

Andrew in 1996, having joined the Duke for the service last year.

Other senior royals then arrived on foot, led by the Duke of Edinburgh, his wife Sophie and their son James, Earl of Wessex, 17.

The York daughters joined them, with Princess Eugenie wearing a striking ivory coat and matching hat as she walked beside her husband Jack Brooksbank.

Princess Beatrice, who gave birth to her second daughter Athena prematurely in January, followed behind in green with her husband Edoardo Mapelli Mozzi.

Lady Sarah Chatto, her husband Daniel and the Earl of Snowdon arrived moments later by car.

Andrew then rejoined the fold as the royals waited for the King and Queen to arrive.

They all headed inside for the hour-long service, which concluded with the National Anthem and the party heading to the deanery for some tea and cakes.

The King and Queen were the first to leave via the deanery where Camilla, who was wearing a pale blue embroidered dress and matching hat, was presented with a posy by a girl. She bent down to chat to the youngster and a young boy, who didn't want to be named, and told them: "Happy Easter, thank you so much."

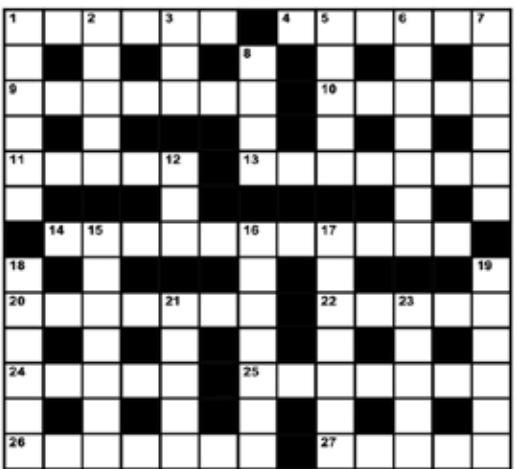
The couple later enjoyed a brief impromptu walkabout, shaking hands and greeting the cheering crowd.

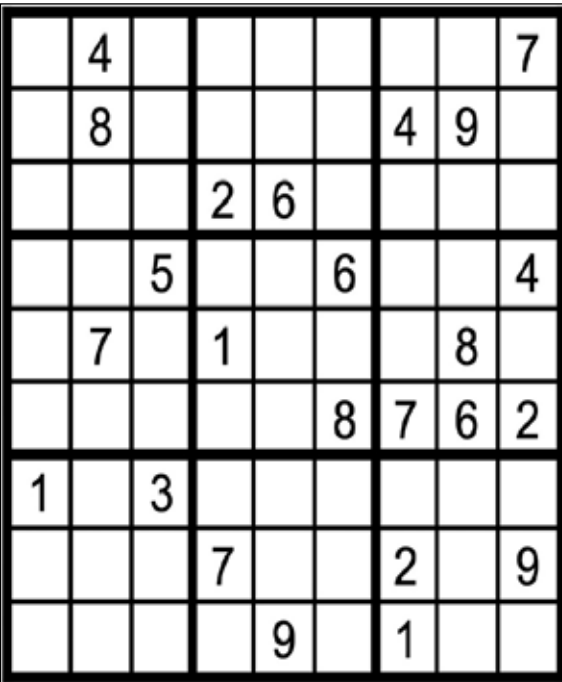

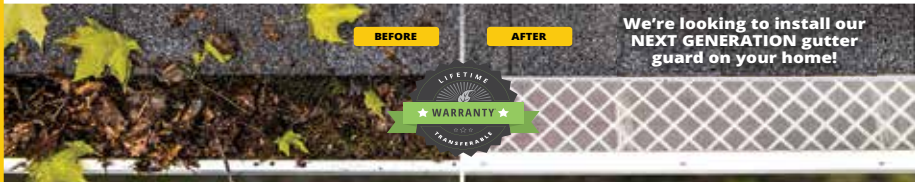

After years of missing out narrowly to Pep Guardiola's frustratingly brilliant Manchester City, it is bizarre how easy it all feels.

Their chief rivals Arsenal have drawn 13 games. City used to seemingly win every match from February onwards and Jurgen Klopp's sides would miss out by a point here or there. Liverpool could win the title on 80 points this season, but finished second on 97 and 92 points under the German.

Even last season's Liverpool team were only five points worse off at

Vardy set to leave Foxes

Jamie Vardy has announced he will leave the Foxes at the end of the season.

Described as Leicester City's "greatest ever player", Vardy leaves a legacy at a club he has served so well since his arrival 13 years ago.

From playing non-league football in 2010 to inspiring an astonishing Premier League title success just six years later, he struck 198 goals for the Foxes and seven more in his 26 England appearances.

A livewire, passion-filled, antagonistic striker, Vardy made the stunning leap from Stocksbridge Park Steels to become a Leicester legend.

Only Harry Kane and Mohamed Salah have scored more top-flight

goals than Sheffield-born Vardy in the past decade.

The 38-year-old's impending departure from the King Power Stadium is a perfect example of how the club is now at a crossroads following their relegation.

Their talisman, a force of nature up front at his peak, grew with the club and was the beating heart of their story - a fairy tale encapsulated by the 2016 title triumph that defied all odds.

It came two days after Vardy took to social media to express his 'anger and sadness' at a season he called a 'total embarrassment' and a 's***show' with Leicester having been consigned to relegation with five matches still to play.

Although he turns 39 in January, Vardy does not plan to call it a day and has expressed confidence in the past that he can continue playing beyond his 40th birthday.
