# Leaders hail new USA/UK trade deal

**PRESIDENT TRUMP and Prime Minister Starmer hailed a new trade deal between the US and UK on Thursday, which will slash US tariffs on metals and cars.**

Speaking at the White House, Trump called it a "great deal" and pushed back against criticism that he was overstating its importance.

"This is a maxed-out deal that we're going to make bigger," he said.

The announcement offers relief for key UK industries from some of the new tariffs announced in January, but it will leave a 10% duty in place on most goods from the UK.

Though hailed by leaders in the two countries as significant, analysts said it did not appear to meaningfully alter the terms of trade between the countries, as they stood before the changes introduced by Trump this year.

No formal deal was signed on Thursday and the governments were light on details.

Speaking from a Jaguar Land Rover factory in the West Midlands, Sir Keir Starmer described the agreement as a "fantastic platform".

"This historic deal delivers for British business and British workers

protecting thousands of British jobs in key sectors including car manufacturing and steel," he said, adding that the "the UK has no greater ally than the United States".

The two sides said the US had agreed to reduce the import tax on cars - which Trump had raised by 25% last month - to 10% for 100,000 cars a year.

## 'reciprocal access'

That will help luxury carmakers such as Jaguar Land Rover and Rolls Royce, but could limit growth in the years ahead, as it amounts to roughly what the UK exported last year.

Tariffs on steel and aluminium, which Trump had also raised earlier this year to 25%, have also been slashed, according to the Prime Minister's Office.

The office also said the two sides had agreed to "reciprocal access" for beef exports, with a quota of 13,000 metric tonnes for UK farmers.

Those figures were not confirmed by the White

House, though it said it expected to expand its sales of beef and ethanol to the UK, a longstanding demand on the part of the US.

The US said the deal would create a \$5bn "opportunity" for exports, including \$700m in ethanol and \$250m in other agricultural products.

"It can't be understated how important this deal is," US Agriculture Secretary Brooke Rollins said.

And UK Steel director General Gareth Stace welcomed the agreement, saying it would offer "major relief" to the steel sector.

"The UK government's cool-headed approach and perseverance in negotiating with the US clearly paid off," he said.

## 'tremendous win'

But other business groups expressed more uncertainty.

"It's better than yesterday but it's definitely not better than five weeks ago," said Duncan Edwards, chief executive of BritishAmerican

Business, which represents firms in the two countries and supports free trade.

"I'm trying to be excited but I'm struggling a bit."

And the Liberal Democrats demanded a vote on the deal in Parliament, saying it would show "complete disrespect to the public" if MPs were denied a say.

Sir Ed Davey said: "When it comes to any trade deal - and especially one with someone as unreliable as Donald Trump - the devil will be in the detail."

"One thing is clear, Trump's trade tariffs are

still hitting key British industries, threatening the livelihoods of people across the UK."

Reform UK Leader Nigel Farage said the deal was a "step in the right direction".

The US and UK have been discussing a trade deal since Trump's first term. They came close to signing a mini-agreement at that time.

But the US has long pushed for changes to benefit its farmers and pharmaceutical issues, which had been non-starters politically for the UK.

The UK has long refused to allow the im-

port of hormone-treated American beef or chlorine-washed chicken, and it was not clear how much those issues had advanced, but a government spokesman insisted there would be no weakening in food standards for imports.

But the National Cattlemen's Beef Association said the agreement in-principle had delivered a "tremendous win" for American ranchers while the US Meat Export Federation, which tracks trade barriers for farmers in the US, said it was still trying to pin down information about the changes.

## “The end of two party politics” claims Farage as Reform UK win big in local elections

■ Labour and Tories left reeling as upstart party takes power in ten local councils

Nigel Farage has hailed Reform UK's gains in Thursday's elections as “unprecedented” and “the end of two-party politics”.

The party has taken control of 10 local councils, won two mayoral races and added a fifth MP to its ranks in the Runcorn and Helsby by-election now counting has been completed.

Many of these wins came at the expense of the Labour and Conservative parties, which have both sought to explain the results.

Prime Minister Sir Keir Starmer conceded that people were not yet feel-

ing the benefits of a Labour government, while Conservative leader Kemi Badenoch pledged to make her party a “credible” alternative once again.

Farage claimed on Saturday: “In post-war Britain, no one has ever beaten both Labour and the Tories in a local election before.”

Writing in The Times, Sir Keir said the lesson learned from the elections was not that the country needed “ideological zealotry”.

“It's that now is the time to crank up the pace on giving people the country they are crying

out for,” he said.

But some within Labour have called on the prime minister to change direction, saying the decision to cut winter fuel payments to all but the poorest pensioners had put off voters.

Labour MP Rachael Maskell urged the government to ditch the cuts, telling reporters: “We have got that mandate, I believe, as a party to look at how we can better redistribute wealth, as opposed to taking out of the pockets of the poorest.”

With the results all in, Badenoch apologised to the defeated Conservative councillors, saying:

“I am going to make sure that we get ourselves back to the place where we are seen as the credible alternative to Labour.”

Writing in The Telegraph, she said: “I'm deeply sorry to see so many capable, hard-working Conservative councillors lose their seats. They didn't deserve it - and they

weren't the reason we lost.”

Badenoch blamed the party's 14 years in government and a “punishing” general election which had both “sapped morale and resources”.

She also reiterated her view that defending many local seats the party had gained in 2021, during a “vaccine bounce”, was a “tough

ask”.

The results were worse than Conservatives had feared, with the party not only losing to Reform but also the Liberal Democrats.

It lost 674 council seats and control of all 16 authorities it was defending - but wrested the Cambridgeshire and Peterborough mayoralty from Labour.

## Iranians nabbed as terror plot ‘targets Israeli embassy’

Israel's embassy in London was the target of an alleged terror plot involving a group of Iranian nationals who were detained by police after a series of raids across England on Saturday, according to multiple reports.

Four men remained in custody at press time

and were being questioned by police on suspicion of preparation of a terrorist act targeting what police and politicians have so far only been willing to describe publicly as “specific premises”.

But multiple sources have confirmed that Israel's embassy in Kensington, west London, was the building in question, though a spokesperson for the embassy did not immediately respond to a request for comment.

On Sunday Yvette Cooper, the home secretary, described the arrests as part of a counter-terrorism operation that reflected some of the

biggest threats “we have seen in recent years”.

Police and the Security Service, MI5, believe the plot was at an advanced but not imminent stage when the decision was made to detain the suspects at the weekend.

Arrests were made in Swindon, west London, Stockport and Rochdale.

Believing that the attack was ready to be put into action soon, they made the decision to go in with armed officers and special forces to ar-

rest the four men, aged between 29 and 46.

Iran's foreign minister, Abbas Araghchi, rejected reports of Tehran's involvement. He said in a post on X: “Iran in no uncertain terms categorically rejects any involvement in such actions and confirms that we have not been informed of any allegations via proper diplomatic channels.”

“Iran has urged the UK to engage so that we may assist any probe into credible allegations.

Timing and lack of engagement suggest that something is amiss.”

Araghchi said there had been a “history of third parties bent on derailling diplomacy” and “provoking escalation resorting to desperate measures, including false-flag operations”.

He added: “Iran stands ready to engage to shed light on what has truly transpired, and we reiterate that UK authorities should afford our citizens due process.”

## Call the Midwife delivers movie version

Call The Midwife will take a break from UK small screens after the next series as production switches to a prequel and a movie release.

Set during the Second World War's Blitz, the prequel will feature younger versions of beloved characters, likely to include Sisters Julienne and Monica Joan and Dr Turner.

The current cast will appear in the film, which could include Trixie (Helen George), as well as returning favorites such as Mother Mildred (Miriam Margolyes) and Chummy (Miranda Hart) and even some big-name guest stars.

One insider said: "Joanna Lumley as a nun? That's something I'd like to see."

### 'wonderful fans'

The film will be set abroad in 1972, with the rise in hospital births giving nuns and nurses a chance to take their skills further afield.

Insiders stressed that the new projects did not signal the end for the main series which will resume "in due course".

Writer Heidi Thomas said: "The Blitz years in the East End were extraordinary.

"The bombs fell, the babies kept on coming and the Sisters kept on going. There will be so much in the prequel for our wonderful fans."

And of the film, she teased: "Whilst the location remains top-secret, I can say it is going to look absolutely fantastic on the big screen."

The show's 15th series, set in 1971, is set to air in January next year and will be available in the USA on iPlayer, Netflix and Apple TV.

# VE Day Remembered: Camilla does the honors as Tower of London reprises stunning poppy display

Nearly 30,000 ceramic poppies are on display at the Tower of London to mark 80 years since the end of World War Two in Europe.

The red poppies have been positioned to resemble a cascading "wound" at the heart of the Norman fortress, which was bombed during the Blitz.

Some of the flowers were first shown at the site in 2014, when an installation of 888,246 poppies - each representing a military life lost during World War One - drew more than five million visitors.

### 'emotional power'

The new artwork, named The Tower Remembers, is designed to reflect the loss of life through war and provide a space for remembrance. Queen Camilla visited the site on Tuesday.

The artwork was designed by Tom Piper, while the ceramic flowers were made and designed by the artist Paul Cummins.

Piper previously said

the scale of the 2014 installation, named Blood Swept Lands and Seas of Red, could never be repeated, but that he came to learn "smaller installations could still carry great emotional power".

### 'suffering and loss'

He added: "Everywhere these poppies have been, they have brought people together, with their own stories of sacrifice, commemoration, and hope for the future.

"They have much to say about the universality of war and the anguish of suffering and loss."

Visitors will be able to see the poppies as part of a general admission ticket to the Tower of London, though a small part will be visible from the public footpath.

The display will remain until Armistice Day on 11 November, which marks when the World War One armistice came into effect.

A tradition with its roots in World War One, poppies are a symbol of remembrance in the UK and are worn to

commemorate those who lost their lives in two world wars and other conflicts.

During Tuesday's visit, Queen Camilla enlisted the help of a five-year-old schoolboy as she planted the final ceramic flower at the display.

Camilla arrived at the Tower's East Gate to be received by its Governor, Brigadier Andrew Jackson, and Constable, Gordon Messenger. She then walked through a Guard of Honour and on to the lawn to inspect the installation.

There was cheering and applause from the watching crowd of tourists, and one man shouted: "God save the King! We all love Camilla! Give us a wave!"

The Queen then met the Tower's Deputy Governor, Brigadier Anna Kimber, Yeoman Warder Tracey Machin and her son Harrison, five, and D-Day veterans Henry Rice, 99, a former Royal Navy signalman, and Richard Aldred, a tank driver in the Inniskilling

Dragon Guards.

Richard handed Camilla a poppy and Henry gave one to Harrison before they all paused to listen to Poet Laureate Simon Armitage read out a special VE80 poem, The World Asks A Great Deal Of The Poppies.

"That was lovely,"

said the Queen, who was handed a copy of the poem in a presentation box.

Over five million people viewed the previous installation, which was made up of 888,246 poppies to represent the military lives lost during the First World War.

# We may not live to see justice, say tainted blood campaigners

People given infected blood in one of the NHS's worst treatment scandals are scared they will not live to see compensation, campaigners say.

Their fears were revealed as the Infected Blood Inquiry hearings reopened on Wednesday and Thursday to examine the "timeliness and adequacy" of the Government's payout response.

More than 30,000 people in the UK were infected with HIV and hepatitis C from contaminated blood and blood products between the

1970s and early 1990s.

Some 3,000 died, and survivors have lifelong health implications.

The hearings will include evidence from groups representing people both infected and affected by the scandal.

Gary Webster, 60, who was infected as a Hampshire schoolboy, said he felt things had gone "downhill" since the probe published its main report last May.

He said: "We fought for so many years to get to this stage. Now they're saying they hope to pay all the infected by the end of 2027 and the

affected by the end of 2029.

"There's two people dying a week. That's a lot of people that aren't going to get paid, won't get the justice and will die not knowing what happened.

### 'least people deserve'

"I think people are scared now that they're not going to survive until they get compensation." Kate Burt, of the Haemophilia Society, said: "Far from supporting this deeply damaged community, the delays and uncertainty created by the Government have

added to their suffering."

Justine Gordon-Smith, whose father Randolph died of hepatitis C in 2018 said: "I think the affected are at the back of the queue. The infected should be prioritised. But we're concerned about the degree of elderly affected people - widows in their 80s, ageing parents."

Des Collins, of Collins Solicitors, which acts for affected people, said: "People are dying as they wait for justice."

Rachel Halford, of the Hepatitis C Trust, said she hoped inquiry chief Sir Brian Langstaff

could bring about a "step change".

She added: "After 50 years, this is the least people deserve."

The Infected Blood Compensation Authority said it was increasing the number of claims each week.

A Government spokesman said: "The victims of this scandal have suffered unspeakably. We have paid nearly £80million in compensation so far and have set aside £11.8 billion to deliver what is one of the most comprehensive compensation schemes in modern history."

## Why all the fuss? asks suspect in tree felling

A man accused of felling the famed Sycamore Gap tree has told jurors he could not understand the extent of the public outrage.

Adam Carruthers branded the historic feature beside Hadrian's Wall "just a tree", saying it was "almost as if someone had been murdered".

The mechanic, 32, spoke as he launched his defence case alongside his co-accused, former friend Daniel Graham, at Newcastle Crown Court this week.

Prosecutors say he and ground worker Graham, 39, drove overnight from Carlisle to the Northumberland landmark in September 2023, during Storm Agnes, and cut down the tree using a chainsaw.

Graham, of Carlisle, and Carruthers, right, from Wigton, Cumbria, are charged with causing £622,191 of damage to the tree.

They are also accused of causing £1,144 of damage to the Unesco' Roman world heritage site Hadrian's Wall. Both the wall and the tree belong to the National Trust.

The pair deny the criminal damage charges.

The Sycamore Gap tree, which dates from the late 1800s, had featured in many film and TV shows, including Robin Hood: Prince Of Thieves.

During his evidence, Graham claimed Carruthers had used string to measure the tree and asked him to take the blame for felling it.

Asked why he had shown so much interest

in the story the day after the tree was cut down, Carruthers said: "On the morning I woke up I had looked online and it was all over Facebook.

"I was thinking 'What's going on here?'. It was everywhere.

"My understanding was it was just a tree, I couldn't understand why everyone was sharing it. I just couldn't get my head round it." Asked by his barrister, Andrew Gurney, why he and Graham had been messaging each other about the story, Carruthers said: "I couldn't really understand why there was such a major outbreak.

"It was almost as if someone had been murdered.

"Daniel was a friend of mine at the time. I sent it across. It was everywhere."

Carruthers said on the night the tree was felled he was staying with his partner of 10 years, who had just given birth to their daughter by Caesarean section and needed help looking after their two children. He was also asked about a voice message he sent to Graham on September 28, 2023, referring to "an operation like we did last night".

He said: "I think it's been interpreted wrong, it should be 'launch an operation like what he did last night'. I'm referring to the person who done the job."

Carruthers said he "had no idea" who cut down the tree and "nothing was ever mentioned to me that [Graham] had anything to do with it".

# Not just the USA: Britain and India also ink new trade deal

The UK and India have agreed a trade deal to make it cheaper and easier to buy and sell goods and services to one another.

The hope is that the deal will benefit the economies of both countries.

The government said the deal was the "biggest and most economically significant" trade agreement the country had signed since leaving the European Union in 2020.

The deal will also allow British firms to compete for more services contracts in India.

The trade deal won't come into force for up to a year, so consumers will not see any immediate changes, but over time the government believes lowering tariffs on the likes of clothing, jewellery, and frozen prawns will lead to cheaper prices and more choice for the British consumer.

This deal could also be a big win for UK businesses which manufacture the goods which have seen tariffs slashed, such as car makers and whisky distillers.

For example, tariffs on whisky and gin being imported to India from the UK will be halved from 150% to 75% before reducing to 40% by the 10th year of the deal. Car tariffs will fall from more than 100% to 10%.

That will provide a boost to those two industries, which had looked set to be hit hard by US tariffs before Thursday's breakthrough deal, as it will mean Indian companies wanting to import those products will pay less import charges than before.

If businesses end up exporting more goods to India and make higher profits, this could lead to them spending more on hiring staff, investing and also paying more tax.

In India, consumers

could see much more choice among the goods which have been included under the deal. Clothing manufacturing businesses and jewellers will also be able to access the UK market which will boost their margins.

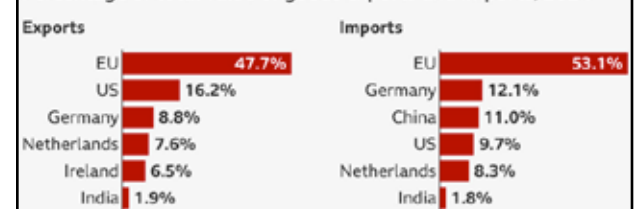
This deal has been a long time in the making, with on-off negotiations going on for some three years.

The UK's deal with India is its third biggest after its agreements with Australia and Japan. For context, the UK has signed trade deals and agreements in principle with about 70 countries and one with the EU.

The EU is the biggest trade partner for both the UK and India.

## Uproar causes postponement of Buddha relic auction

**The auction house Sotheby's has postponed its sale in Hong Kong of hundreds of sacred jewels linked to the Buddha's remains, after a threat of legal action by the Indian government.**

The sale of the collection - described as one of the most astonishing archaeological finds of the modern era - had drawn criticism from Buddhist academics and monastic leaders. India had said it offended the global Buddhist community.

Sotheby's said the sus-

pension would allow for discussions between the parties.

A British official named William Claxton Peppé unearthed the relics in northern India nearly 130 years ago, alongside bone fragments identified as belonging to the Buddha himself.

The auction of the collection, known as the Piprahwa Gems of the Historical Buddha Mauryan Empire, Ashokan Era, circa 240-200 BCE, was due to take place on 7 May.

In a letter to the auc-

tion house two days earlier, the Indian government said that the relics constituted "inalienable religious and cultural heritage of India and the global Buddhist community. Their sale violates Indian and international laws, as well as United Nations conventions".

In an emailed statement, Sotheby's said that in light of the matters raised by India's government "and with the agreement of the consignors, the auction ... has been postponed".



# Entering his 100th year, Attenborough hails ‘most important’ film of his career

Sir David Attenborough is launching what he says is one of the most important films of his career as he enters his hundredth year.

He believes his new, cinema-length film *Ocean* could play a decisive role in saving biodiversity and protecting the planet from climate change.

Sir David, who will be 99 on Thursday, says: “After almost 100 years on the planet, I now understand the most important place on Earth is not on land, but at sea.”

The ocean is the planet’s support system and humanity’s greatest ally against climate catastrophe, the film argues. It shows how the world’s oceans are at a crossroads.

The blue carpet was rolled out for the premiere the Royal Festival Hall in London.

In attendance was the

King, told Sir David he “can’t believe” his 99th birthday was on Thursday.

The pair posed for photos before they entered the auditorium for the screening.

A host of celebrities also attended, including singer Geri Halliwell-Horner, astronaut Tim Peake, singer James Blunt and model Cara Delevingne.

Earlier, Prince William attended a matinee in a “private capacity”, along with hundreds of children from schools across the country.

Toby Nowlan, who produced *Ocean*, says this new production is not a typical Attenborough film. “This is not about seeing brand new natural history behaviours. It is the greatest message he’s ever told,” he says.

The film docu-

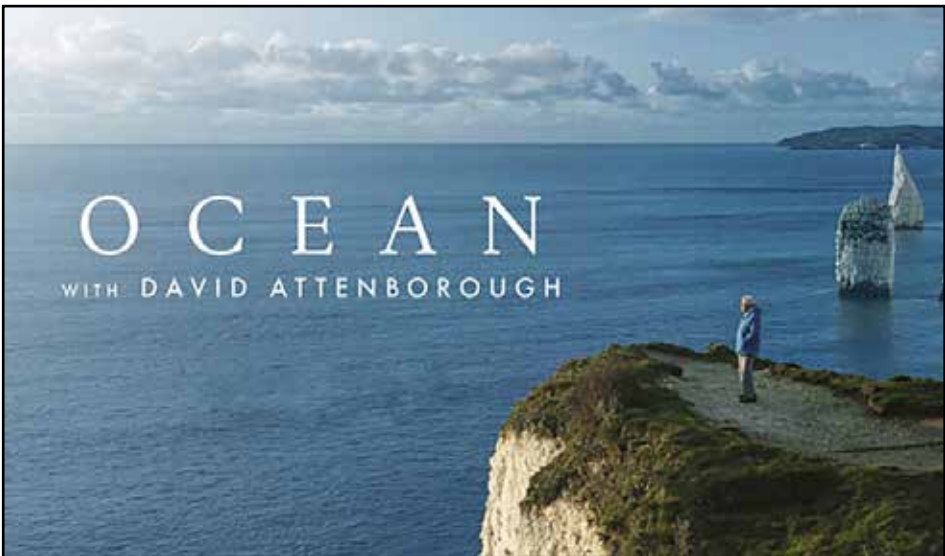
ments how the state of the world’s oceans and our understanding of how they function have changed in the course of Sir David’s lifetime.

## catastrophic decline

Sir David remembers his first scuba dive on the Great Barrier Reef way back in 1957: “I was so taken aback by the spectacle before me I forgot – momentarily – to breathe.”

Since then, there has been a catastrophic decline in life in the world’s oceans. “We are almost out of time,” he warns.

*Ocean* contains some of the most graphic footage of the damage that bottom trawling – a common fishing practice around the world – can do to the seabed. It is a vivid example of how industrial fishing can drain the life from the world’s oceans,

Sir David claims.

The new footage shows how the chain that the trawlers drag behind them scours the seafloor, forcing the creatures it disturbs into the net behind. They are often seeking a single species: more than three-quarters of what they catch may be discarded.

“It’s hard to imagine a more wasteful way to catch fish,” comments Sir David.

The process also releases vast amounts of carbon dioxide which contributes to the warming of our planet, yet bottom trawling is not just legal but is actively encouraged by many governments.

Sir David says the state of the ocean has almost made him lose hope for the future of life on the planet. What has kept him from despair is what he calls the “most remark-

able discovery of all” – that the ocean can “recover faster than we had ever imagined”.

Sir David says the story of the world’s whales has been a source of huge optimism for him.

## ‘very creative’

It is estimated that 2.9 million whales were killed by the whaling industry in the 20th Century alone. Scientists have said it is the largest cull of any animal in history when measured in terms of total biomass. It pushed almost all whale species to the edge of extinction.

Just one per cent of Blue Whales were left, recalls Sir David: “I remember thinking that was it. There was no coming back, we had lost the great whales.”

But in 1986 lawmakers bowed to public pressure and banned commercial

whaling worldwide. The whale population has rapidly recovered since then.

One of the film’s directors, Keith Scholey, has worked with Sir David for 44 years. “When I first met David, I was in shorts,” he jokes. That was in 1981, two years after Sir David had resigned as the BBC’s director of programmes – one of the most senior jobs at the Corporation. “He’d done one career, and he was off on his next.”

Despite now nearing his 99th birthday Sir David is still remarkably energetic, says Scholey.

“Every time you work with David, you learn something new,” he says. “It’s really good fun. But also, David keeps you on your mettle, because he is so on his mettle and so, you know, it’s always a very creative process.”

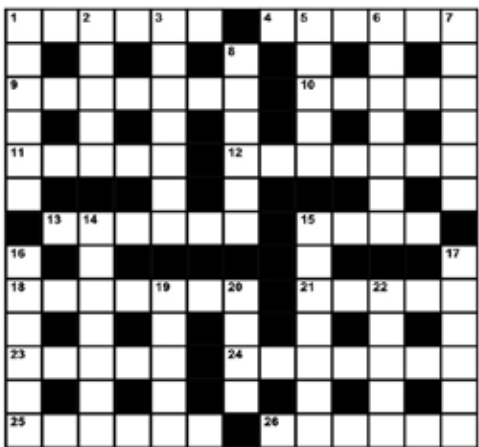

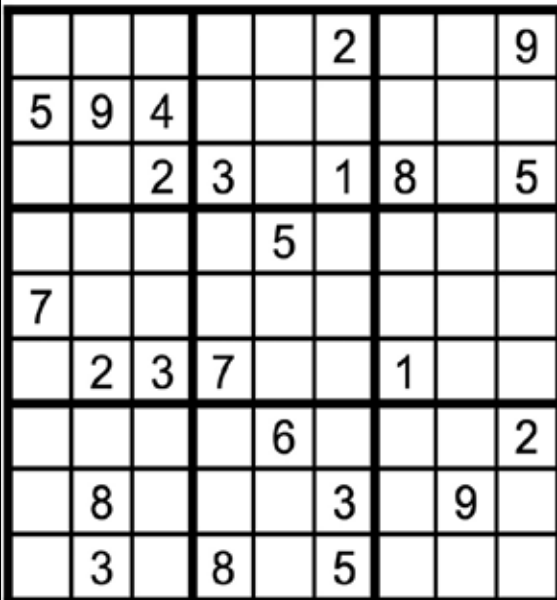

# We must commit to peace says Charles, as the nation honors 80th Anniversary of VE Day

King Charles said on Thursday the world had a duty to commit to seeking lasting peace and preventing warfare in a speech to mark the end of four days of commemorations for the 80th anniversary of Victory in Europe Day.

Following a sombre thanksgiving service at Westminster Abbey, Charles and senior royals joined 10,000 guests including veterans for a music concert at Horse Guards Parade near Buckingham Palace as part of events to remember Nazi Germany's unconditional surrender, which took effect on May

8, 1945.

The anniversary, which comes at a time of ongoing conflict in Europe with Russia's war in Ukraine, was also marked with events in France and Germany, while Moscow will hold a major military parade on Friday.

In a speech at the concert, the British monarch echoed the words of his grandfather George VI from 80 years earlier, saying how those who had died in the cause of freedom in World War Two should never be forgotten.

"As we reach the conclusion of the 80th anniversary commemora-

tions, we should remind ourselves of the words of our great wartime leader, Sir Winston Churchill, who said 'Meeting jaw to jaw is better than war'," Charles said.

"In so doing, we should also rededicate ourselves not only to the cause of freedom but to renewing global commitments to restoring a just peace where there is war, to diplomacy, and to the prevention of conflict."

Earlier the 76-year-old king and heir to the throne Prince William,

standing beside elderly veterans in wheelchairs, laid wreaths at the Grave of the Unknown Warrior at the Abbey, while Britain observed a two-minute silence at midday.

Britain began its official VE celebrations on Monday with actor Timothy Spall delivering some of the words of Sir Winston Churchill's 1945 victory speech.

Speaking in Parliament Square in front of a statue honouring Sir Winston after Big Ben struck midday, Spall said: "My dear friends, this is your hour."

"This is not victory of a party or of any class."

"It's a victory of the Great British nation as a whole. We were the first, in this ancient island, to draw the sword against tyranny."

Wearing a dark grey suit, the bespectacled actor continued: "Every man, woman and child in the country had no thought of quitting the struggle."

When shall the reputation and faith of this generation of men and women fail?

"I say that in the long

years to come not only will the people of this island, but of the world, wherever the bird of freedom chirps in human hearts, look back to what we have done and they will say: 'Do not despair, do not yield to vio-

lence and tyranny, march straightforward and die if need be unconquered'."

There followed a day of parades down the mall by the British armed forces, with King Charles and other senior royals looking on.

## Europa League: United Basque in glory and Spurs ice Arctic's team's dreams to ensure all-English final

**MANCHESTER United overcame the nerviest of starts on Thursday to book their spot in the Europa league final with a 4-1 demolition of Athletic Bilbao.**

Mason Mount ended 20 months of torment with a brilliant second half double after the hosts made it so hard for themselves despite starting the second-leg of their semi-final with holding a three-goal advantage.

But Mount chose exactly the right time to step up.

Beset by a succession of injuries that have limited the England man to just 10 Premier League starts since his £55m move from Chelsea in 2023, Mount had only

been on the pitch 10 minutes when he turned onto Leny Yoro's short pass inside the Bilbao penalty area.

Mount's strike was true and arrowed into the far corner.

It was his third United goal but it was by far the most important and ended lingering fears the visitors might become the first side in 134 attempts in Uefa competitions to overturn a three-goal first leg deficit away from home.

But there was more to come.

After Casemiro and Rasmus Hojlund had steered United into a winning lead, Mount pounced on a loose ball 45 yards out and floated a superb shot into an

empty net.

The goal capped a memorable Old Trafford night and maintained United's unbeaten record in the competition.

The final outcome was harsh on the Spanish visitors, who were the better side for long periods and led at half-time thanks to Mikel Jauregizar's magnificent 30-yard effort.

That did not matter to the home fans at the final whistle as they will now get a shot at salvaging their season against the Premier League's other great underachievers.

The smile across Mount's face as he took part in a walk of honour with the rest of his teammates at the end of the game told its own story about the 26-year-old's

stalled career.

An integral part of the England side that reached the final of Euro 2020, Mount's career has never got going following his move north from Chelsea in 2023.

Injury has followed injury and frustration has

piled on frustration.

Yet United head coach Ruben Amorim has said on more than one occasion that Mount could be just the right man to fit his system, either in one of the two advanced attacking roles or in midfield.

Both his finishes underlined an inherent confidence that has been retained despite all the doubts repeated setbacks bring.

Mount can only hope it marks a screeching U-turn on what has gone before.

## Spurs stay cool on trip to Arctic

**Tottenham will face Manchester United in the Europa League final as they cruised past Bodo/Glimt to stay in the hunt for a first European title in 41 years.**

Ange Postecoglou's men navigated a tricky semi-final second leg in Norway to reach their sixth European final - and first since the 2019 Champions League final.

Dominic Solanke and Pedro Porro struck in the second half to seal a 5-1 aggregate success and confirm an all-English showdown with United in Bilbao on 21 May.

Spurs' trophy drought stretches to a League Cup triumph in 2008, but further back to 1984 in Europe when they won the Uefa Cup.

Postecoglou's bold statement in September that he always wins silverware in his second

season at a club had been met with mockery at times this term, with Tottenham 16th in the Premier League.

Yet they are now one game away from ending their barren spell to prove the Australian right, despite their abject domestic season.

They succeeded without the injured James Maddison, Lucas Bergvall and Heung-min Son in what was a historic game for the hosts, who had never reached a European semi-final before.

The 3-1 home first-leg win last week gave Spurs a cushion and they managed the return expertly, limiting energetic Bodo to few opportunities on the artificial pitch.

The hosts, who knocked out Lazio in the quarter-final and beat Porto at home, needed an early goal but it nev-

er came, with Guglielmo Vicario turning away Patrick Berg's free kick.

A textbook tight opening half gave way to a controlled second as fears Tottenham would freeze in the Arctic Circle proved unfounded.

Full-back Destiny Udogie thwarted Kasper Høgh, but Solanke put the tie further out of reach after 63 minutes when he poked in from close range from a Cristian Romero knock-down.

Six minutes later Porro's looping cross dropped in off the post to end any Bodo hopes, with the Norwegian side having an injury-time penalty overturned by the video assistant referee (VAR).

It never gets completely dark in Bodo at this time of year and the light has refused to go out on Tottenham's season.
