Blistering Britain set for record temperatures this weekend

THE HEAT is on in the UK this weekend, with the highest June temperature in years expected.

Meteorologists are predicting the Mercury will rocket to 33C (91F) in the coming days, with the boiling point expected to peak on Sunday in parts of Eastern England – closing in on the record high of 35.6C observed in Southampton back in the long hot summer of 1976.

Conditions are classed as a heatwave when areas hit a certain temperature on three consecutive days.

Thresholds vary from 25C to 28C in different parts of the UK.

At press time temperatures were expected to reach 30C (86F) on Friday and 32C (88F) on Saturday.

Met Office deputy chief meteorologist Dan Holley said: "Heat is the main story this week, with high pressure building and temperatures rising to heatwave levels.

"Sunday looks to see the peak of the very warm spell, with a headline max of 33C possible.

"This is most likely to be in the East of England, with other areas seeing temperatures into the high 20s to low 30s. Warm and perhaps even 'tropical' nights will also

be a feature.

"The warmest day of the year so far was 29.4C on June 13, recorded at Santon Downham in Suffolk. High pressure is expected to move away from the UK into early next week resulting in temperatures falling."

The weather across the UK has been warm and sunny for much of the past month, with the South East and South West counties enjoying the best weather in years.

'strong summer'

But while the heat will put renewed pressure on the national grid, the warm spell is proving a bonanza for the hospitality businesses as thirsty Britons flock to pubs, wine bars and beer gardens.

Kate Nicholls, of trade body UKHospitality, said: "This spell of warm weather will no doubt be a welcome lift for hospitality venues... as people look to eat, drink and socialise outdoors. Businesses will now be hoping for a strong summer to help counterbalance the significant cost pressures they're contending with. I'd encourage everyone to get out and

support their local hospitality businesses."

Ice cream seller Katy Alston, of Pinks Parlour in Bognor Regis, said: "We get so excited as

this is what we wait for. You never know when that big yellow ball is going to come out."

She had 84 inquiries in one morning from firms

wanting an ice cream van visit. Katy said: "We're now making gelato around the clock."

Yorkshire and North-West England have

meanwhile been declared as being in official drought status, with low river and reservoir levels, following the driest spring for 132 years.

The King cut a dash in a sharp top hat as he and the Queen descended on Ascot Racecourse on Tuesday for one of the most glamorous events in the summer calendar.

Camilla's feathered hat was in a cool shade of silver – disappointing punters who put their money on the favourite, betting it would be blue.

She and Charles arrived in an open landau carriage for the Royal Procession around the grounds.

They were hoping for a winner from their thoroughbred Reaching High, among the favourites for the Ascot Stakes and one of a number entered by the monarchs this week, but it came a

Russia does NOT hold all the cards, insists Starmer

■ PM seems to rebuke Trump as he joins with G7 partners in pushing for harsher sanctions on Moscow

SIR Keir Starmer appeared to rebuke Donald Trump this week as he pushed for a new sanctions package against Russia and insisted Vladimir Putin must not be allowed to dictate terms.

The PM announced further action against Moscow at the G7 in an attempt to keep focus on the European war amid the conflict between Israel and Iran.

The group – consisting of Britain, Canada, France, Germany, Italy, Japan and the US – confirmed a further economic squeeze on Putin's brutal war machine.

Downing Street insisted that the existing financial restrictions on the Kremlin was having an effect.

But it could not say whether the new proposals would be backed by all of the nations in the group.

The PM said: "The fact is – Russia doesn't hold all the cards.

"So, we should take this moment to increase economic pressure and show President Putin it is in his – and Russia's

interests – to demonstrate he is serious about peace.

"We are finalising a further sanctions package – and I want to work with all of our G7 partners to squeeze Russia's energy revenues and reduce the funds they are able to pour into their illegal war."

financial challenges

His comments are a stark contrast to those by US president Donald Trump during his explosive Oval Office showdown with Ukrainian President Volodymyr Zelensky, when he said: "You don't have the cards right now."

The sanctions will target Russia's energy revenues. The Government claimed to have new evidence that Russian state enterprises, including Rostec, Rosatom, Gazprom and Rosneft, are facing huge financial challenges as a result of the West's existing sanctions package.

It is believed that sanctions have deprived the Russian economy of at least £330billion since February 2022, the equivalent of two years' worth

of funding for Moscow's war effort.

The UK has so far targeted more than 2,300 individuals, entities and ships since the beginning of the invasion. However, the G7 appeared hugely divided on Russia as Mr Trump suggested Putin could be allowed to return to the summit following his expulsion in 2014 after the invasion of Crimea.

Speaking at his first official meeting of the Canadian summit, the president said it had been a mistake to kick Russia out a decade ago.

'good opportunity'

Following a meeting with Canadian PM Mark Carney, Mr Trump said: "The G7 used to be the G8. Barack Obama and a person named [former Prime Minister Justin] Trudeau didn't want to have Russia in. And I would say that was a mistake, because I think you wouldn't have a war right now if you had Russia in."

He also said he "wouldn't mind" bringing China into the group.

spokesman initially refused to comment on Mr Trump's suggestion, before saying that Sir Keir is "happy with the make-up of the G7". The spokesman rejected the characterisation that the summit was already hopelessly divided on Russia and the Middle East.

Speaking on the plane to Canada, Sir Keir could not say whether he could guarantee unanimity on sanctions this week.

He said: "We've got President Zelensky coming so that provides a good opportunity for us to discuss again as a group.

"My long-standing view is, we need to get Russia to the table for an unconditional ceasefire. That's not been really straightforward. But we need to get to the table and if that doesn't happen, sanctions will undoubtedly be part of the discussion at the G7."

The last summit held in Canada, in 2018, ended in chaos when the president tore up the communique and left early following a row with Prime Minister Trudeau.

Sir Keir held a brief meeting with President Trump late last night, after which they confirmed they had signed a document implementing the US-UK trade deal agreed last month.

Mr Trump said: "We signed it, and it's done."

PM plays down 25% tariff threat

■ UK steel industry will still benefit from new trade deal with America, insists Starmer

SIR Keir Starmer has insisted Britain's steel industry will still benefit from a new trade deal with America – even though it still appears to face 25% trade tariffs.

The Prime Minister also said British Steel would not be forced to ditch its Chinese owners, despite concerns raised by US president Donald Trump.

Following weeks of uncertainty, Mr Trump approved an executive order for the trade deal to be implemented.

However, while US export tariffs on the UK's car manufacturers were reduced to 10% and aerospace industry taxes axed, there were

no promises about steel taxes in Mr Trump's order.

The US leader and Sir Keir held a press conference over the deal at the G7 summit in Canada on Monday.

'good progress'

But in an embarrassing moment, the US leader dropped the historic paperwork as he went to show it to the media – and Sir Keir ended up at his feet picking it up. Mr Trump told Sir Keir: "Oops, sorry about that," and the PM joked: "It's a very important document."


The president's executive order hinted he would like to see a move away from Chinese

ownership of British Steel by Jingye Group.

Meanwhile, the White House is demanding assurances from No10 that the owners will not use the company as a way for Beijing to dodge US tariffs. Sir Keir described the reduced tariffs for cars and aerospace as "really good progress".


He added: "In relation to British Steel, obviously it's referred to in the executive order, so we're moving on to the implementation stage.

"There's further work to do in relation to steel, but we're getting on and doing that work, and that doesn't require us to change the ownership of British Steel."

Campaigners hail easing of abortion laws

The Commons has voted to decriminalize abortion in a move hailed as a "landmark moment for women's rights".

Tonia Antoniazzi's amendment to the Crime and Policing Bill was passed in a free vote with a majority of 242.

The Labour MP said it would remove the threat of "investigation, arrest, prosecution or imprisonment" of women who terminate their pregnancy. Abortion is currently a criminal offence in England and Wales, except with authorized providers up to 24 weeks.

It can be later if the mother's life is at risk or the child would have a severe disability.

Ms Antoniazzi insisted the current safeguards would remain, including the 24-week limit and the requirement for two doctors' signatures, and abusive partners using violence or poisoning to end a pregnancy would still be criminalized. She told fellow MPs she had acted after seeing women investigated by police over suspected illegal abortions.

Heidi Stewart, of the British Pregnancy Advisory Service, said: "There will be no more women investigated after enduring a miscarriage, no more women dragged from their hospital beds to the back of a police van."

But Alithea Williams, of the Society for the Protection of Unborn Children, said: "If this clause becomes law, a woman who aborts her baby... even moments before birth, would not be committing a criminal offence. Our already liberal abortion law allows an estimated 300,000 babies a year to be killed. Now, even the very limited protection afforded by the law is being stripped away."

Evita ticket buyers cry foul as iconic showstopper is delivered offstage

■ Grumbles in the West End stalls as Don't Cry For Me, Argentina is performed offstage - and free - to passersby

A NEW production of Evita is considered the hottest ticket in London's West End right now, with audiences paying as much as £250 for a seat.

But one novel decision in the staging of the classic music has left some theatregoers feeling out of tune.

Keen to watch one of the biggest showstoppers in musical history - Eva Perón's performance of Don't Cry for Me Argentina - many were left bitterly disappointed when they learned that the scene would not take place on stage.

Instead, actress Rachel Zegler, in her West End debut, is performing the song and a short piece of dialogue on the balcony of the London Palladium

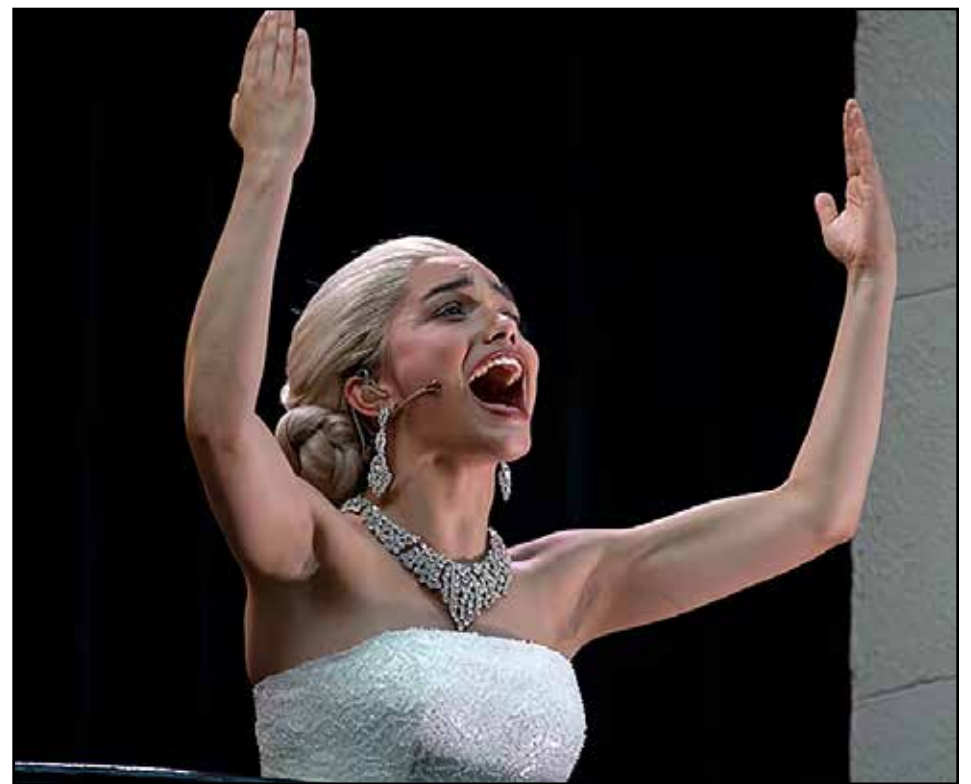
for passersby each night, while a video is projected to those inside.

The 24-year-old, who rose to fame in Steven Spielberg's West Side Story, surprised hundreds of people on the streets of Soho on Saturday when she belted out the song on the balcony for the show's second-half curtain raiser.

'generating buzz'

Crowds are now expected to assemble at the spot on Argyll Street at about 9pm every night for the duration of the show's run, which ends in September.

It is a move that has divided theatregoers. One fan said on social media that they "go to the theatre to share the same space with a perform-

er", while another said: "Sorry, are you saying I've paid £350 for 2 tickets and she's singing the biggest number outside at people who haven't paid?"

But others have argued that the outdoor

performance reinforces key themes in Evita, such as spectacle and political theatre.

Chris Peterson, the founder of OnStage Blog, wrote: "This isn't just clever staging or a viral moment for social media,

although it's certainly generating buzz. It's a reimagined theatrical gesture that reframes everything we think we know about Eva Perón. It turns a moment of private confession into a public performance."

Former Tory MP admits harassing ex-wife

■ UK's first transgender politician takes 'pragmatic view' in changing plea in Cardiff courthouse

A former Conservative MP has pleaded guilty to harassing her ex-wife.

Jamie Wallis, who is now known as Katie Wallis and uses female pronouns, represented Bridgend from 2019 to 2024.

At an earlier hearing, the 41-year-old from Butetown in Cardiff had denied harassing Rebecca Wallis, now known as Rebecca Lovell, between 14 February and 21 March.

Wallis was due to stand trial on Tuesday but changed her plea and admitted harassment by making unwanted

phone calls, sending unwanted messages and a voice note.

District Judge Rhys Williams told Wallis sentencing would take place on 14 July.

Wallis, who is the first MP to openly begin the process of gender transitioning, told the court: "Legally I am known as Jamie, but I prefer to be known as Katie."

gender transition

The court previously heard Wallis and the victim were in a relationship for more than 15 years and separated in 2020, with their divorce finalised in 2024.

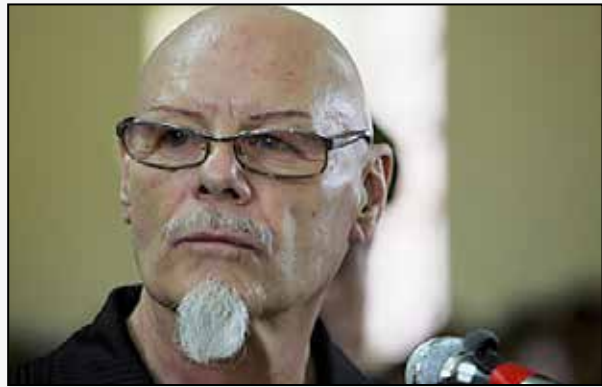
Narita Bahra KC, defending, said her client had taken "the very pragmatic view" to plead guilty after hearing the effect the case had on Rebecca Lovell.

Ms Bahra added further psychiatrist assessment would be needed along with a pre-sentence report to examine what effect Wallis' gender transition had

during the period of offending.

She said it was important to know "what was happening in Dr Wallis' life and mind" at that time.

No Release for Glitter

Gary Glitter's bid to be freed from prison has been rejected.

The 70s pop star, real name Paul Gadd, 81, was jailed for 16 years in 2015 for sexually abusing three schoolgirls between 1975 and 1980.

He was released in 2023 after serving half his sentence but was soon back behind bars

for trying to view images of children on the dark web.

The Parole Board said such "decisions are solely focused on what risk a prisoner could represent to the public if released".

A lawyer for one of Glitter's victims said the board's veto was "absolutely right".

Blaise Metreweli is to become the first female head of MI6.

She will take over as Chief of the Secret Intelligence Service when the current C, Sir Richard Moore, steps down this autumn.

Ms Metreweli, 47, joined the service in 1999 and holds the position of Q, the director general responsible for technology and innovation – a role made famous in the Bond films.

MI5 has already been

led by two female directors-general – Dame Stella Rimington and Baroness Eliza Manningham-Buller. And GCHQ appointed Anne Keast-Butler as its first female director two years ago.

Ms Metreweli said: "I am proud and honoured to be asked to lead my Service. MI6 plays a vital role – with MI5 and GCHQ – in keeping the British people safe and promoting UK interests overseas."

Fergie reveals her mental health struggles

SARAH Ferguson has opened up about the struggles she has faced over the years as she discussed mental health challenges.

This week the Duchess of York revealed she had visited the Paracelsus Recovery clinic in Zurich, which focuses on addiction problems.

While it is understood that she was not checked in as a patient, the Duchess was very open about her struggles.

Writing in a national newspaper, Sarah described "the profound scars" of her childhood that "led to feelings of unworthiness [that] contributed to an unhealthy attitude to food that often threatened to spiral into a full-scale eating disorder".

She discussed how her mother, Susan Barrantes, left the family home when Sarah was just 12 to move to Argentina. This saw her left her in the care of her father, Major Ronald Ferguson, and without her close sister, Jane, who had recently moved to Australia to get married. The events contributed to her "unhealthy attitude to food", she said.

Sarah, 65, also spoke about the impact that

press coverage during the time she was married to Prince Andrew had on her.

'cesspit'

The Duchess, who has been diagnosed with both breast and skin cancer in recent years, explained how she was impacted by "tabloid headlines of the 1980s and 1990s" and more recent "comments on social media, which I regard as a cesspit".

She had been cruelly referred to as the "Duchess of Pork" and "Fat Fergie" by some outlets.

In a social media message about her visit to the clinic, known for its care for those facing complex mental health

and addiction challenges, she wrote: "Mental health touches us all – it has no boundaries.

"We need to promote open conversations about mental health and how we can improve access to mental healthcare across society."

Sarah revealed that recent discussions online, combined with her shocking double cancer diagnosis, meant that her mind was forced to go "to some dark places".

In a post shared to Instagram, Sarah added: "I recently spent time at @paracelsusrecovery in Zurich, a clinic known for its discreet, bespoke care for those facing complex mental health and addiction challeng-

es, to learn more.

"What I found was not only a centre of clinical excellence, but a place of deep humanity.

"If you or someone you know is struggling, I encourage you to seek help. You are not alone, and there is no shame in taking the steps towards healing."

It is understood Sarah spent time at the Paracelsus Recovery clinic as a guest to deepen her knowledge of how she can use her platform to help issues concerning mental health.

Sarah continues to be a vocal advocate for charities such as Teenage Cancer Trust, Prevent Breast Cancer and Sarah's Trust.

London businesswoman's "Ethical Cola" sells billions in less than two years

A BRITISH MUSLIM woman who launched a rival to Coca-Cola has sold some two billion cans globally in just over 18 months.

Aykiz Shah launched Salaam Cola in October 2023, spending £160 on sample cans.

Last year, she reached a turnover of £5.1million in Europe, £1.6m from the UK alone.

She used social media to promote her firm and its charitable missions amid product boycotts over the Israel-Gaza war.

Salaam, a greeting in

Muslim countries, was soon stocked by grocery stores, fast food suppliers and ethnic minority retailers across the UK.

Ms Shah, 27, said: "We wanted to create more of an ethical drink for people who are going through poverty or malnutrition to be able to give back and help vulnerable people."

She credits her success to buyers looking for "ethical" firms.

Salaam donates 10% of proceeds to charitable causes, with £250,000 shared from UK sales alone last

year.

Ms Shah, who works from her kitchen in Brentford, West London, is developing other pop flavours, each with a nod to the country it helps.

Salaam Cola supports Palestine, with the diet version – Seriously No Sugar – helping Syria.

It made Yemenade to help malnourished children in Yemen and Lebanorange is set for release in a few weeks.

She said: "I initially thought it would be a predominantly Muslim-backed product but

Grandma dies of rabies after puppy scratch in Morocco

■ Yorkshire woman was infected while on holiday in February

A grandmother has died from rabies after being scratched by a puppy on holiday.

Yvonne Ford, 59, who was infected in Morocco four months ago, is the first person in the UK to die from the disease for seven years.

In a Facebook tribute to her mother, Yvonne's daughter Robyn Thomson said the grieving family were "choosing to speak up in the hope of preventing this from happening to others".

Robyn, 32, said: "Yvonne was scratched very slightly by a puppy in Morocco. At the time she did not think any harm would come of it and didn't think much of it.

"Two weeks ago she

became ill, starting with a headache, and [it] resulted in her losing her ability to walk, talk, sleep, swallow. We never thought something like this could happen to someone we love.

"Please take animal bites seriously, vaccinate your pets and educate those around you."

An inquest into the death of Yvonne, of Barnsley, South Yorkshire, was opened and adjourned in Sheffield on Wednesday.

There have been fewer than 10 cases of human rabies linked to animal exposures abroad reported in the UK since 2000.

In 2018, kebab shop worker Omar Zouhri, 58, of Aylesbury, Bucks, died of rabies following

a cat bite while visiting family in Morocco.

Britain has been rabies-free since 1922, with the exception of rabies-like viruses in some wild bat species.

Dog licensing, putting down strays and quarantining were credited with ending the virus. Rabies is almost always fatal once symptoms appear, but vaccination and early treatment can prevent it.

Dr Katherine Russell, of the UK Health Security Agency, warned people to be careful around animals in rabies-affected countries. She said: "I would like to extend my condolences to this individual's family at this time.

"If you are bitten,

scratched or licked, you should wash the site with plenty of soap and water and seek medical

advice without delay. "Human rabies cases are extremely rare in the UK and there are no

worldwide documented instances of direct human-to-human transmission."

I've been treated 'worse than a killer' moans Vardy

Rebekah Vardy claims she was treated worse than a paedophile or killer over the Wagatha Christie case.

The wife of football ace Jamie claims she is moving on from her clash with Coleen Rooney, which started with a tweet in 2019 and led to a multi-million-pound court case.

But speaking to Vanity Fair, Rebekah (above right) insisted that she "got the raw end" of the publicity, adding: "I think

murderers and paedophiles have faced far less scrutiny."

Mrs Rooney, wife of ex-England star Wayne, had publicly accused someone using Mrs Vardy's Instagram account of leaking private information about her, posting: "It'sRebekah Vardy's account."

Mrs Vardy sued for libel, but Mrs Justice Steyn found in July 2022 the allegation was "substantially true" and ordered her

to pay 90% of her rival's costs.

The clothes that the two wore to court were scrutinised, with most fashion experts judging Mrs Rooney, 39, the winner.

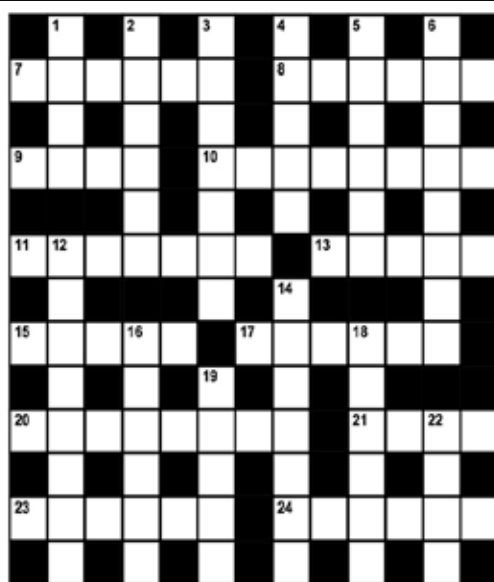
But Mrs Vardy, 43, said in the interview: "I am polar opposite to what you would class as the typical WAG. I'm not bothered.

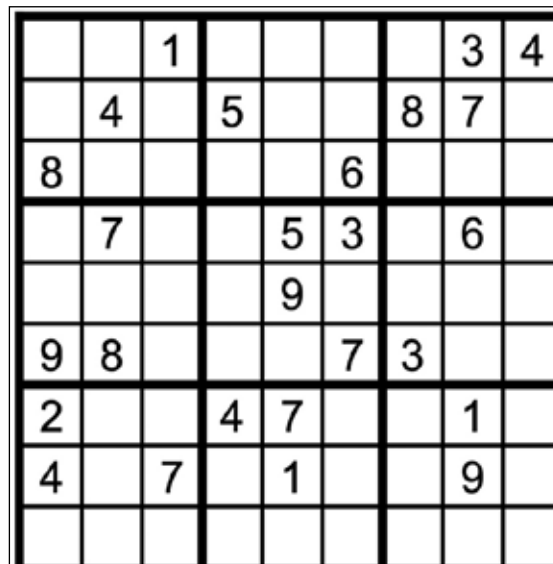

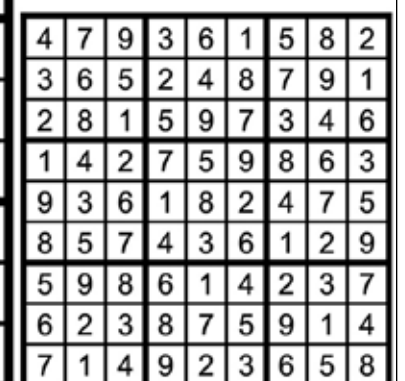

£1m slap on the wrist for City

■ Premier League issues small fine for repeatedly delaying kick offs and restarts

Manchester City have been fined over £1m by the Premier League after repeatedly kicking-off or restarting matches late last season.

Nine of City's matches last season started or restarted late, with the longest delay coming before the second half of the Manchester derby in December 2024 which resumed two minutes and 24 seconds later than billed.

The Premier League said City had accepted and apologised for the breaches, with the fines totalling £1.08m. They have 14 days to pay.

Last season the club were fined £2.09m for delaying 22 matches, and manager Pep Guar-

diola said he would try and make his team talks shorter.

A Premier League statement said: "Rules relating to kick-offs and restarts help ensure the organisation of the competition is set at the highest possible professional standard and provides certainty to fans and participating clubs.

"It also ensures the broadcast of every Premier League match is kept to schedule."

City are awaiting a verdict on 115 charges of alleged breaches of the Premier League's financial rules.

City were charged and referred to an independent commission in February 2023 following a

four-year investigation.

It is alleged City breached its financial

rules between 2009 and 2018.

City strongly deny all

charges and have promised to fight the charges, saying their case is sup-

ported by a "comprehensive body of irrefutable evidence".

Sacking Ange wasn't easy, says Levy

Tottenham chairman Daniel Levy says sacking manager Ange Postecoglou after he led the club to victory in the Europa League was "emotional-difficult".

The Australian was relieved of his duties just 16 days after a 1-0 victory over Manchester United in the final in Bilbao secured Spurs' first major trophy for 17 years.

Postecoglou paid the price for a poor domestic campaign in which his side finished 17th in the Premier League, with former Brentford boss Thomas Frank brought in to replace him.

"I don't regret appointing Ange, I'm very grateful to Ange. In his first season we finished fifth and in his second we were over the moon to win a trophy," Levy told the club's media team.

"But we need to compete in all competitions, and we felt that we needed a change.

"Emotionally it was difficult but we feel that

we've made the right decision for the club."

Levy has held his position at Tottenham for more than 25 years with Frank becoming the 13th permanent manager in that time.

"I've got very broad shoulders," Levy said.

"Failure is not an option, the desire [is] to succeed. And because it's so difficult, I want to succeed even more."

Levy and newly-appointed Spurs chief executive Vinai Venkatesham were both involved in the process of bringing Frank in after he spent seven successful years at Brentford.

The 51-year-old Dane has signed a deal that will keep him in charge at Tottenham Hotspur Stadium until 2028.

"We ran a really, really thorough process - at speed," Venkatesham said.

"We defined 10 characteristics that we think are important to be a successful manager at Tottenham Hotspur, we analysed in

real detail, through our technical staff, more than 30 candidates.

"We had a lot of time with the shortlist and Thomas was absolutely the number one candidate.

"We could not be more excited to have him join the club.

"Personally, one of the things I've excited about is that he is an outstanding developer of young players so I really look forward to seeing what he can do with the squad we have here."

Levy added: "Whenever you have a new coach, it's always a fresh start. [They] always have different ideas but we want to build on the success of winning a trophy last season.

"One of the things that stood out to me with Thomas was that he is clearly highly intelligent, a great communicator, super human being plus all the technical aspects which are obviously important."
