Macron: 'We must stand shoulder to shoulder'

Paris and London 'must defend the world order', insists French President

Emmanuel Macron urged the UK to stand "shoulder to shoulder" with the EU as Europe looks to reduce its dependencies on foreign powers amid geopolitical upheaval, in a speech to members of the Commons and the Lords on Tuesday.

There was first the pageantry, the trumpets, and the gun salutes upon the midday arrival of the French president and his wife Brigitte at Windsor Castle, King Charles III's royal residence where the couple spent the night.

Then came Macron's address at the Palace of Westminster, in front of members of both the House of Lords and the House of Commons – just as Nicolas Sarkozy had done in 2008, and as Donald Trump is due to do in September on his state visit to the UK.

'strategic autonomy'

After customary references to the bonds of brotherhood forged on the battlefields of the two world wars, Macron adopted a distinctly geopolitical tone. He called on Paris and London to "defend the world order" – in Ukraine, the Middle East, Africa, and the Pacific.

The French president, a staunch advocate for Europe's 'strategic autonomy', also advocated for the UK to be more closely involved in the EU's attempts to reduce its dependencies – militarily, economically, and technologically – on superpowers like the US and China.

"The United Kingdom cannot remain on the sidelines; we must move forward shoulder to shoulder," declared the French President, who reiterated the "responsibility" of Paris and London for the security of the European continent despite Britain's withdrawal from the EU.

"We are faced with new threats, with aggressive nuclear powers, with sometimes hesitating alliances," Macron explained, making the case for "building a strong European pillar in NATO."

His words echoed those

of Jacques Chirac, spoken in the very same place in 1996, when he advocated for Europe to equip itself "with the means to shoulder greater responsibility for its own defence," by developing within NATO "a European defence identity."

Migration progress

On the issue of migration, Macron noted that "decisions" would be taken at the Franco-British summit on Thursday. Talks on a deal that

could see the UK return migrants who have arrived from France – in exchange for taking in migrants wishing to join relatives already settled in the UK – have been complicated by opposition from some EU capitals.

The French president also announced that the Bayeux Tapestry – an 11th-century masterpiece depicting the Norman conquest of England – would be moved from Normandy to the British

Museum in London between summer 2026 and summer 2027.

A speech to both houses of the British Parliament is a major diplomatic event offered only to leaders on state visits – that is, by invitation of the monarch. Notable past speakers have included Nelson Mandela, Barack Obama, and Volodymyr Zelenskyy, all of whom attracted such large crowds that their speeches were held in Westminster Hall – a

space normally reserved for addresses by the monarch themselves.

Macron's pulling power did not quite reach that level, meaning he delivered his address in the much smaller but more ornate Royal Gallery.

Alongside Prime Minister Keir Starmer, Macron co-chaired a meeting on Thursday of the coalition of 31 countries providing aid for Ukraine and exploring security guarantees in the event of a ceasefire.

Post Office scandal may have cost 13 lives

- Several of the wrongly accused are thought to have committed suicide
- Lives ruined after IT system wrongly showed shortfalls in accounts

LONDON: Thirteen people may have taken their own lives and others were bankrupted or became seriously ill as a result of Britain's Post Office scandal, a public inquiry found on Tuesday, laying bare the toll of one of the country's worst miscarriages of justice.

Inquiry chair Wyn Williams said on Tuesday he was satisfied that executives at the state-owned Post Office knew, or should have known, that its computer system was prone to errors, yet they publicly maintained the fiction it was accurate.

From 2000-2013, the Post Office pursued branch managers, known as subpostmasters, for losses that appeared in their accounts but were caused by flaws in an IT system supplied by Japanese company Fujitsu. About 1,000 people were convicted.

Public outrage about the scandal mounted last year after a TV dramati-

zation of the case, "Mr Bates vs the Post Office", which led to legislation to exonerate those convicted.

compensation

In the 162-page first volume of his report, Williams called for urgent action to ensure "full and fair" compensation for victims. His recommendations included free legal advice and compensation for family members.

He said it was impossible to ascertain exactly how many people had been impacted, but said there were about 10,000 eligible claimants across four compensation schemes.

"Many thousands of people have suffered serious financial detriment," he said in a speech after the publication. "Many businesses and homes have been lost, bankruptcies have occurred, marriages and families have been wrecked."

"Tragically, I heard too

of people whom it is said that they were driven to take their own lives," he added.

Detailing 17 first-hand accounts, Williams said suffering ranged from those held liable for small amounts of money to those who were wrongly imprisoned, fell seriously ill or were driven to despair and suicide.

Postmaster Martin Griffiths was given notice of termination of his contract in 2013 after shortfalls in his accounts. He then deliberately walked in front of a bus, suffering multiple injuries which caused his death at the age of 59.

Following a request from the inquiry, the Post Office identified six former postmasters whose families said they had taken their own lives. A further seven people who were not postmasters had also taken their own lives as a consequence of false shortfalls, according to their families, the report said.

Others suffered mental and physical health problems, bankruptcy and relationship breakdowns.

Business Secretary Jonathan Reynolds said the publication of the report

was an important milestone for subpostmasters and their families.

"I am committed to ensuring wronged subpostmasters are given full, fair, and prompt redress," he said.

The inquiry has held 226 days of hearings and has questioned 298 witnesses. The second volume of the final report, which will include the role of the Post Office, will be published in due course.

Benefits 'too easy' to get, says Badenoch

Kemi Badenoch has said it is too easy for people to claim benefits in the UK, as she set out proposals to restrict welfare payments.

The Conservative leader said there needed to be a "crackdown on people exploiting the system".

In a speech setting out her party's plans, she called for foreign nationals to be barred from claiming disability and sickness benefits, while arguing that those with less severe conditions like anxiety and mild depression should not be signed off work.

A Labour Party spokesperson said: "The Conservatives had 14 years to reform welfare. Instead, they left the country with a broken system that holds people back and fails to support the most vulnerable."

In her speech Badenoch described Britain's benefits bill as a "ticking time bomb" that could "collapse" the economy.

It comes after Labour largely gutted its own plan for benefits cuts after

a backbench revolt.

Legislation to bring in remaining government cuts to sickness benefits was approved by MPs on Wednesday evening.

Badenoch told the BBC: "Our welfare system is being exploited by a whole bunch of people, both British and non-British, who should not be claiming benefits."

The Tories have proposed that disability and sickness benefits should only be paid to British citizens, with exceptions for those covered by international agreements, such as

citizens from EU countries who have acquired settled status in the UK.

At the moment, foreign nationals gain access to the welfare system when they are granted indefinite leave to remain or refugee status. Applicants for personal independence payments (Pips) generally need to have lived in Britain for at least two of the last three years.

Asylum seekers are not allowed to apply for benefits, although they have access to taxpayer-funded accommodation and separate financial support.

20 Years On: UK remembers 7/7 victims

■ William lays flowers for the dead

The names of the 52 people killed in London's 7/7 bombings were read out at a memorial service at St Paul's Cathedral on Monday, the 20th anniversary of the attacks.

Saba Edwards, the daughter of Behnaz Mozakka who died when one of the bombs detonated on the London Underground, began to cry as she read out her mother's name among the list of victims.

Thelma Stober, who was injured in the attack, joined her at the lectern as thousands of white petals were dropped from the cathedral's ceiling.

Families and survivors were joined by members

of the Royal Family and the prime minister to mark the anniversary.

Dean Andrew Tremlett said the service marked the "solemn anniversary of an act of terror inflicted on our city".

terrible casualties

"We give thanks for the spirit of this city: its openness, its endurance, and its steadfast refusal to let the hatred prevail."

A series of commemorative events were held across the capital on Monday to remember the victims of the bombings carried out by Islamist extremists.

The suicide attacks in central London saw bombs detonated on

three underground trains and a bus on 7 July 2005, causing terrible casualties during the capital's rush hour.

Saba Edwards's mother Behnaz was heading to Great Ormond Street Children's Hospital when she boarded a Piccadilly Line Tube train.

Speaking about her grief at the inquest five years after her mother's death, she said her family was "forced" to sell their home "because the reality of living there without her was too painful to cope with".

Ms Stober was on the underground at Aldgate station when one of the bombs was detonated. The blast threw her onto

the tracks, leaving her partly underneath the train with a piece of the door impaled in her right thigh and her left foot twisted.

When she saw rescuers in yellow and orange jackets approaching, she shouted: "Help me, help me, I'm alive. I don't want to die."

"If I could have amnesia permanently to eliminate everything about the incidents, I would," she said.

The National Service of Commemoration saw emergency services staff carry four candles through the cathedral, representing the locations devastated by the bombings: Russell Square, Aldgate, Edgware Road and Tavistock Square.

'senseless act'

Families and first responders then gave readings about each location, including George Psaradakis - who was driving the number 30 bus that was blown apart in Tavistock Square, killing 13 people.

Graham Foulkes, whose son David Foulkes was killed on the tube at Edgware Road, also addressed the congregation.

He said: "The good which is in Londoners and the countless visitors whom they host at any given moment is not erased by hatred

or threat, but rather is fostered to produce a harvest of hope for each generation."

The Duke and Duchess of Edinburgh attended the service on behalf of King Charles III, who had called on people to stand united "against those who would seek to divide us" in a message marking the anniversary of the "senseless act of evil".

The Prince of Wales attended a memorial service on Monday afternoon in Hyde Park, where he laid flowers and spoke to several people there, including Ms Stober.

Kemi Lasisi-Ajao, who was working at the Royal London Hospital at the time of the attacks, said she had spoken to Prince William at the service.

Speaking to PA news agency, she said she told him she had met his grandmother, Queen Elizabeth II, when the late monarch visited the hospital after the bombings.

Events were also held at the sites of the bombings.

At Russell Square - where half of all those killed that day lost their lives - floral tributes were laid, while a minute's silence was held at Edgware Road station to mark the first attack at 08:49 BST.

Prime Minister Sir

Keir Starmer and Mayor of London Sir Sadiq Khan also laid wreaths at Hyde Park's 7/7 memorial to mark the time the first bomb exploded.

'mutual respect'

Victims' families and emergency service staff later held a minute's silence at Tavistock Square, where the fourth and final bomb exploded at 09:48.

Sir Keir said the country would unite to remember the lives lost in the suicide attacks "and all those whose lives were changed forever". He added: "Those who tried to divide us failed. We stood together then, and we stand together now - against hate and for the values that define us of freedom, democracy and the rule of law."

King Charles said the attacks had shown the importance of "building a society where people of all faiths and backgrounds can live together with mutual respect and understanding".

He said his "special prayers remain with all those whose lives were forever changed on that terrible summer's day", including those who carried the "physical and psychological scars".

He praised those who helped with the rescue and the "extraordinary courage and compassion that emerged from the darkness of that day".

Yet another top Tory defects to Reform

Former Conservative MP and party chairman Sir Jake Berry has announced he is defecting to Reform UK.

Writing in the Sun, Sir Jake said: "Old Westminster politics has failed. But there's a better way."

He said he was backing Reform UK "because I've always believed that change comes with challenging the old order. In shaking up the system when it isn't working".

Sir Jake becomes the second former Conservative Cabinet minister to announce his decision to join Nigel Farage's party this week. On Monday, ex-Welsh Secretary Sir David Jones announced he had left the Conservatives for Reform UK earlier this year.

Sir Jake is the fourth former Conservative MP to switch to Reform in the last two weeks, after Sir David, Ross Thomson and Anne Marie Morris.

Sir Jake represented the Lancashire constituency of Rossendale and Darwen from 2010 until 2024, when he lost his seat to Labour.



BERRY: ".let's not kid ourselves. Britain is broken"

In a statement announcing his decision, Sir Jake was heavily critical of both his old party and Labour.

"For 25 years, I was proud to call myself a Conservative - 14 of those years, I served as an MP. I even sat at the Cabinet table twice. I believed in it. I gave it everything.

"But let's not kid ourselves. Britain is broken. It didn't start with Labour. The Conservative governments I was part of share the blame.

"We now have a tax system that punishes hard

work and ambition. Just this week, we saw record numbers of our brightest and best people leaving Britain because they can't see a future here. At the same time, our benefits system is pulling in the world's poor with no plan for integration and no control over who comes in."

Sir Jake's defection underscores Reform's growing political momentum - a trend highlighted by Labour's increasing focus on the party, shifting attention away from the Conservatives.

Britain bakes in new heatwave

SIZZLING Britain was braced for yet another heatwave this weekend, with the mercury expected to hit the mid-90s at the weekend.

The UK Health Security Agency (UKHSA) has issued yellow heat health alerts for every region in England which will remain in place until Tuesday.

The warnings mean that health and social care services could potentially be significantly affected by the weather – such as through a rise in deaths or an increase in demand for health services.

Yellow alerts are less serious than the UKHSA's amber alerts which had been issued during previous spells of hot weather this year.

Thursday saw much of England and Wales seeing temperatures reaching 86F, with the hottest spots found in the south Midlands, central southern and south-east England with temperatures topping 90F.

By Friday, the heat moved into Scotland and Northern Ireland with similar highs being reached.

While this latest heatwave will bring hotter weather for more of us, the highest temperature is unlikely to exceed the highest UK temperature of the year so far when 96.4 was reached on 1 July in Faversham, Kent.

Met Office criteria establish a heatwave is reached when a threshold temperature is met or exceeded for at least three consecutive days.

The threshold varies from 80F across the north and west of the UK, to 86F in parts of eastern England.

After the hottest opening day to Wimble-

Tributes flow for Tory titan Norman Tebbit

■ Key Thatcher ally dead at 94; he was the driving force behind her reforms curbing union power

Norman Tebbit, who served as a cabinet minister in Margaret Thatcher's government, has died aged 94.

Throughout the 1980s he worked as the chairman of the Conservative Party and led the departments of trade and industry and employment.

A loyal ally of Thatcher, Lord Tebbit backed her agenda, bringing in laws designed to curb union power - including making them liable for damages if they did illegal acts.

Conservative leader Kemi Badenoch described Lord Tebbit as "the leading exponent of the philosophy known as Thatcherism" and praised his "stoicism and courage" after he and his wife were severely injured by an IRA bomb in 1984.

The explosion at the Grand Hotel in Brighton during the Tory Party's annual conference killed five people and seriously injured 31.

'unstinting service'

Lord Tebbit suffered a broken shoulder blade, fractured vertebrae and a cracked collarbone, while Margaret Tebbit, was left permanently disabled.

In a statement released on Tuesday, Lord Tebbit's son William said: "At 11.15pm on 7 July 2025 Lord Tebbit died peacefully at home aged 94.

"His family ask that their privacy is respected at this time and a further statement regarding funeral arrangements will be made in due course."

Badenoch said Lord Tebbit "was an icon in British politics" and praised his "unstinting service in the pursuit of improving our country".

"To many of us it was the stoicism and courage he showed in the face of terrorism which inspired us as he rebuilt his political career after suffering terrible injuries in the Brighton bomb," she said.

"He never buckled under pressure and he never compromised."

Lord Michael Dobbs, the author of House of Cards who worked as Lord Tebbit's chief of staff, told BBC Radio 4's Today programme he was "a man of great humour, of great political insight and a man of tremendous courage too."

"Not only political courage because he was willing to pursue policies he thought were fundamentally right even though at the time they might have been unpopular but he was also a man of great personal courage – the way he dealt with the aftermath of the Brighton bombing," he said.

'self-made man'

"Politics misses tremendously people of that character who believe so deeply in what they are pursuing that they risk everything for it."

Thatcher's biographer Lord Charles Moore said he was the "first important personal example of Thatcherism in action because he was the self-made man from the working class and he was unapologetic about that".

Former Conservative leader Lord David Cameron described Lord Tebbit as "a man of great conviction, profound self-belief and with a direct and sometimes abrasive tone".

"I was sometimes on the hard end of that, but there is no doubting the tremendous impact he had on our country and my party," he said.

"For all his caustic tongue and sharp wit, he was also privately a kind and thoughtful man."

Another ex-party leader Sir Iain Duncan Smith, who took over Lord Tebbit's Chingford seat after he stood down in 1992, said he was "critical to Margaret's Thatcher's success".

"Sometimes she didn't

own that as much as she should have."

A spokesperson for Sir Keir Starmer said: "The prime minister's thoughts are with Norman Tebbit's children at this difficult time."

He described Lord Tebbit as "a major figure in politics during the 1980s" and said: "Many will remember the great strength he showed in the face of the atrocious IRA bombing at the Grand Hotel in Brighton."

Born in 1931 in the north London suburb of Ponders End, he left school at 16 and joined the Financial Times as a trainee journalist.

'get on your bike'

He learnt to fly planes during his National Service with the RAF and later worked for the British Overseas Airways Corporation.

In the mid 1960s, he became increasingly involved in politics and in 1970 won the seat of Epping for the Conservatives.

The constituency was later redrawn and renamed Chingford, which he represented until 1992, when he left the Commons for the House of Lords.

As a politician he gained a reputation for his forthright approach.

Labour's Michael Foot likened him to a "semi-

house trained polecat" and the satirical puppet show Spitting Image depicted him as a knuckle-duster-wielding thug.

In 1981, he made his famous "get on your bike" speech to the Conservative Party conference in which he criticised riots over unemployment, telling the audience that in the 1930s his father had not rioted but had "got on his bike and looked for work, and he kept looking till he found it".

In 1990, he provoked anger when he posed a "cricket test" to help determine whether a person was truly British.

"A large proportion of Britain's Asian population fail to pass the cricket

test," he said.

"Which side do they cheer for? It's an interesting test. Are you still harking back to where you came from or where you are?"

As party chairman he ran the Conservatives' 1987 general election campaign, securing a third successive victory for Thatcher.

However, after the election he left government in order to care for his wife.

He continued to prioritise his caring duties over a return to front-line politics, declining an offer from Thatcher to re-join her cabinet and deciding against running in the leadership election to replace her in 1990.

As drought bites, Yorkshire introduces first hosepipe ban

■ Measure comes as county suffers driest and warmest spring on record

The UK's first hosepipe ban came into force this week in Yorkshire as reservoir levels in the county dropped to their lowest levels on record.

Announcing the ban on Tuesday, Yorkshire Water said in a statement: "From 11 July, there are hosepipe restrictions in place across Yorkshire following the driest spring on record. While we're out 24/7 fixing leaks and looking after your water, we're asking customers to put down their hosepipes, so we can let our reservoirs recover."

"Our reservoir levels haven't actually increased since the last

week of January! Normally our groundwater sources and reservoirs get topped up over spring when the weather is changeable but this year we've had the driest spring on record and Yorkshire is officially in drought."

Customers who ignore the hosepipe ban could face fines of up to £1,000, but the utility said "we hope it won't come to that" as it urged households to help conserve water by sticking to the restrictions.

While Youlgrave Waterworks, a private firm which supplies 500 homes in Derbyshire, became the first to intro-

duce a hosepipe ban at the start of June, Yorkshire Water is the first major utility to bring in restrictions for its 2.3 million households.

The company said the region has experienced both the driest and warmest spring on record this year, receiving just 15cm of rainfall between February and June, less than half of what is expected in an average year.

higher demand

There has also been a higher water demand, leaving the region's reservoirs at 55.8% full, which is 26.1% lower than they would normal-

ly be at this time of year.

England has experienced the hottest spring from March to May on record, and the driest in over a century, followed by the hottest June on record, with two searing heatwaves hitting parts of the country in the second part of the month and into July, and another set for some areas this

week.

The temporary restrictions coming into force from Friday - when temperatures are set to hit late 20s and early 30s - and include using a hosepipe to water gardens and wash private vehicles, fill domestic pools or clean outdoor surfaces.

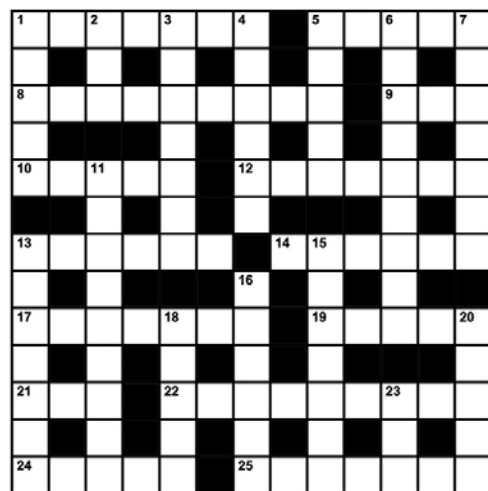
People can still wash

their car and water their gardens using tap water from a bucket or watering can, while the region's 139,000 businesses will be allowed to use a hosepipe if it is directly related to an essential commercial purpose - but not for other uses such as cleaning paths outside a business property.

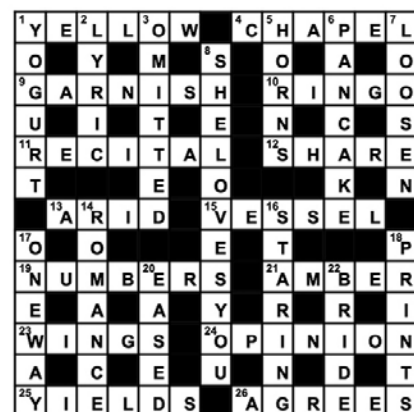

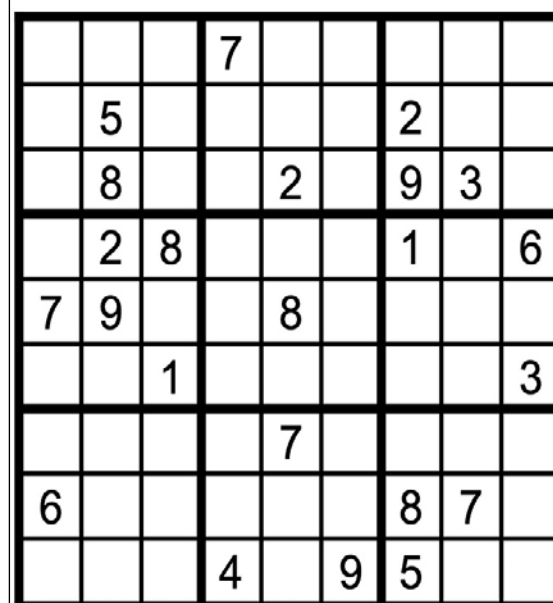
don (90F), the women's and men's finals over the weekend will also see temperatures exceeding that temperature.

In the silence, the truth echoes: Reunion redefines the crime drama

■ Amazon Prime's gripping tale of grief and redemption unfolds in both British Sign Language and English, driven by a revelatory performance from Matthew Gurney

In many respects, *Reunion* presents itself as a conventional thriller.

But don't get it twisted. Daniel Brennan (played by the mesmerising Matthew Gurney) is a man newly released from prison, where he served a lengthy sentence for the murder of his childhood friend, Ray (Ace Mahbaz). The crime, while confessed to, remains shrouded in mystery - Brennan has never explained his motive, and now, years later, he emerges into a world changed beyond recognition. His wife died while he was incarcerated, and his efforts to rebuild a relationship with his estranged daughter, Carly (Lara Peake), unfold alongside a brooding desire for vengeance - against whom or what, we are not immediately told.

Hovering over his fresh start is the ever-present threat of being recalled to prison, a danger heightened by the storm his release has caused among those he left behind. Chief among them is Anne-Marie Duff's Christine, the widow of the man Brennan killed, whose barely-healed life is ruptured by his return. Alongside her is Miri, Christine's daughter, portrayed with emotional precision by *EastEnders* alumna Rose Ayling-Ellis. Christine's current partner, Stephen (Eddie Marsan), a former police officer, pledges to protect them - but his motives are not quite as clear-cut as they first appear.

But what truly sets *Reunion* apart is its world. This is not merely a crime story; it is a deeply textured portrait of deaf life in modern Britain. Brennan, played by Gurney—

himself deaf since birth—is joined by Ayling-Ellis, also deaf from birth, in leading a bilingual production that fluidly shifts between British Sign Language (BSL) and spoken English. The script, penned by deaf screenwriter William Mager, weaves the challenges and nuances of the deaf experience into the drama without didacticism. There is no self-righteous messaging here, no polemic - just a richly human tale that places deaf voices squarely at its centre.

emotional toll

Brennan's time in prison is depicted with searing realism. For six years, he was unable to effectively communicate, denied access to an interpreter. The institutional neglect is palpable, and the emotional toll profound. In one telling moment, his probation officer — finally remembering to book a BSL interpreter for a meeting — overhears her say, "One sign can mean two different things depending on context." The phrase encapsulates the linguistic minefield that deaf people navigate daily. Are Brennan's parents disappointed or regretful? The ambiguity inherent in even the simplest communication becomes a symbol of the broader disconnect between the deaf community and the systems meant to support them.

In a particularly moving scene, Brennan signs his daughter's name—"Carly"—and in doing so pierces the defensive wall she has built around herself. The moment is simple, but devastating. Carly, bearing the emotional bruises of a father's ab-

sence, her mother's death, and a lost childhood friendship with Miri, suddenly sees herself acknowledged, recognised. "Long time since I've seen anyone sign 'Carly'," she says, with heartbreaking understatement.

The series drops hints—fragmentary flashbacks, brief recollections—of the night Ray died. We're shown enough to suspect that Brennan's anger wasn't unprovoked, and that something in his and Ray's past remains unresolved. Christine, desperate for answers, finds herself stonewalled. Brennan either cannot or will not explain. His silence is maddening for her, and for the audience.

Meanwhile, his probation officer Anna (Olive Gray) attempts to guide Brennan through his reintegration, but her goodwill is eroded by Brennan's increasingly erratic behaviour and the accumulation of licence breaches. Her initial failure to provide an interpreter—then her awkward promise to "call" him about his next appointment—demonstrates the subtle but significant challenges faced by deaf individuals in a hearing world that often defaults to ignorance.

Further tension comes in the form of Stephen, Christine's partner. From the moment he sees a photograph of Ray on the fridge, we sense something amiss. His desire to see Brennan recalled to prison appears motivated by more than just protective instinct. The question lingers: what exactly is Stephen hiding? And how does it connect to Brennan's own silence?

The performances throughout *Reunion* are exemplary. Gurney is a commanding presence whose portrayal of Brennan is layered and compelling. He captures the internal contradictions of a man torn between grief, fury, and paternal yearning. Brennan is volatile, yes, but also intensely human—haunted by loss, by guilt, by something unresolved. That Gurney had to wait until now for a major television role is an indictment of the entertainment industry's longstanding marginalisation of deaf actors.

Ayling-Ellis, already a household name, delivers a nuanced turn as Miri. Her performance is finely tuned, conveying a young woman trying to maintain her fragile equilibrium while reliving old traumas. Peake, meanwhile, impresses with her natural BSL delivery—so convincing that one might assume she's a fluent signer.

Duff is, as ever, compelling, though Marsan's attempt at a Sheffield accent may raise a few eyebrows north of the Watford Gap. Still, his involvement likely helped get the project greenlit, and for that, we can for-

give the odd wonky vowel.

Reunion is more than a thriller. It is a quietly radical piece of television, one that centres deaf experience without sensationalising or patronising. Its depiction of the deaf-hearing divide is neither sentimental nor patronising — it simply is, woven into the fabric of the story rather than layered clum-

sily on top. That in itself feels like a breakthrough.

This is drama that respects its audience, trusting them to piece together the clues—both narrative and emotional. It is also drama that trusts its performers to embody complex characters in all their contradiction. And in Gurney, it finds a leading man fully equal to that task.

Deep wreaks havoc as India square Test series

India won by 336 runs; series level at 1-1

Jamie Smith offered admirable final-day resistance but India's superb bowlers completed a thumping 336-run victory over England in the second Test at Edgbaston on Monday to level the series at 1-1.

The hosts largely put aside their attacking instincts, ignoring their target of 608, but were bowled out for 271 with 27 overs left on day five as they attempted to salvage a draw.

In a fine spell of seam bowling after heavy morning rain, Akash Deep had Ollie Pope playing onto his stumps in the third over and then produced a wicked nipbacker to pin Harry Brook lbw for 23.

After Ben Stokes fell in the final over before lunch, ending a partnership lasting 115 balls with Smith, England's wicket-keeper threw some counter-punches to follow his first-innings 184 not out with 88.

But, having hit four sixes, he holed out on the hook to give the irresistible Deep his first five-wicket haul in his eighth Test.

Amid a sea of Indian support, Deep took the final wicket of Brydon Carse to finish with 6-99 and 10 in the match.

India, whose chances were doubted after England's fine win in Headingley last week, leave Birmingham with

their first Test victory at Edgbaston at the ninth attempt.

It also brilliantly sets up the remainder of the series, which continues at Lord's on Thursday.

Though Smith struck some blows, England were outplayed across this match, despite attempting to bat out for a draw for the first time under Stokes and coach Brendon McCullum.

Doing so was always going to be tough. They have successfully survived a fifth day only once in the past 13 years and began three wickets down after Deep's burst on the fourth evening.

The morning rain reduced the overs the hosts needed to survive by 10 to 80 but they were never likely to recover when Pope and Brook were dismissed inside the day's first five overs and India chipped away.

Smith fell hitting out but the other batters were largely undone by India's skill, particularly that of 28-year-old Deep, rather than any attempt to attack.

Mohammed Siraj capped India's performance by taking a stunning one-handed catch to dismiss Josh Tongue while captain Shubman Gill fittingly took the final catch to follow his 430 runs in the match. India will recall star bowler Jasprit Bumrah after he was rested this week and

are right in this series.

Meanwhile, England, who were riding a wave on arrival in Birmingham, have been given a reality check – one which leaves plenty of questions to answer going into next week, particularly around the fitness of their pace attack given the four-day turnaround.

The day eventually began at 12:40 after rain. Within half an hour, Pope and Brook were back in the shed having been dismissed by Deep.

He was left out for the first Test but looks likely to play a major part in the series with his relentlessly accurate seam bowling.

Pope was slightly unfortunate to get a ball that bounced to hit his arm and deflect onto his stumps. Brook was helpless when Deep got the ball to jag back from outside off stump.

Only after easing to 50 from 73 balls did Smith show any real intent. A partnership with Chris Woakes lasted 70 deliv-

eries until Woakes top-edged trying to pat the ball into the leg side.

After that Smith, as he did in the first innings, took on the short-ball ploy. Deep was hit for two sixes but when Smith swung hard for a third time he was caught at deep-square leg, at which point England's race was run.

A disappointing result but one which sets up a delicious final rubber between the two teams this weekend.

Spurs seal £55m Kudus deal

Tottenham have agreed a £55m fee with West Ham to sign midfielder Mohammed Kudus.

The Ghana international is now set to have a medical before signing a long-term contract.

Hammers had rejected an initial £50m offer but once Spurs supremo Daniel Levy okayed a £5m

bump in the price a deal was quickly clinched.

Kudus, who has an £85m release clause, joined West Ham in a £38m deal from Ajax in 2023. He has made 65 Premier League appearances for the club, scoring 13 goals and providing nine assists.

At least six top clubs

have enquired about Kudus in recent weeks but well-placed sources the 24-year-old had reportedly prioritized a move to Spurs.

The North London club were also keen on Eberechi Eze but the winger's preferred destination looks likely to be their neighbors Arsenal.

Chelsea forward Lauren James, moved out wide following criticism of her side's midfield set-up in the loss to France, scored twice as the defending champions cruised to victory.

Her opener came after just 22 minutes, as she drilled the ball into the right corner from the edge of the box after a stunning long-range pass from goalkeeper Hannah Hampton in the build-up.

Sarina Wiegman's side were back to their slick best, defending well and winning the ball in midfield, as they coolly controlled proceedings in Zurich.

Georgia Stanway, who was disappointed with her performance against France, redeemed herself with a powerful strike to double England's lead in first-half added time and celebrated with her arms outstretched.

James capped off an entertaining display with her second on the hour mark when she pounced on the rebound from Ella Toone's saved effort, before Manchester United's Toone got on the score-sheet herself in the 67th minute.

The Lionesses were under pressure to win after falling behind in Group D - widely considered the toughest group in the tournament - and they could have added to their tally, but Alessia Russo's header was ruled out for offside in the build-up.

The Netherlands barely threatened and will have work to do to qual-

ify when they face group leaders France in their final game on Sunday, while England will fancy themselves against the lowest-ranked nation Wales, who are without a point.

England's midfield was torn apart against France with their defensive frailties on show and individual mistakes punished.

Stanway gave the ball away on countless occasions in Saturday's 2-1 defeat and there were question marks over whether James' free role left them vulnerable to counter-attacks.

Wiegman was also questioned on her decision to start the 23-year-old, who is undoubtedly one of the world's most talented players, in the number 10 role ahead of Toone.

So when the Lionesses boss chose to start James

out wide against her home nation, the Netherlands, there was intrigue to see whether the same issues would arise.

Simply put, they didn't.

England's structure was far more effective, albeit against a Dutch

side with less pace than the French, and Toone provided more stability as James was given a li-
