■ Duo who felled 'totemic symbol' to get 'some sort of thrill' each given four year sentences

Two men who chopped down the "irreplaceable" Sycamore Gap tree in an act of "sheer bravado" have each been jailed for four years and three months.

Daniel Michael Graham 39, and Adam Carruthers, 32, both from Cumbria, were convicted of criminal damage after filming themselves using a chainsaw to illegally fell the landmark tree by Hadrian's Wall in Northumberland.

Sentencing them at Newcastle Crown Court, Mrs Justice Lambert rejected a claim of "drunken stupidity" and said, while a full motive was not clear, felling the tree and the ensuing outrage gave the men "some sort of thrill".

public revulsion

The National Trust, which owned the more than 100-year-old tree, said the landmark could "never be replaced".

The pair, whose friendship imploded in the aftermath as the public revulsion became clear to them, drove to the site under the cover of darkness in the early hours of 28 September 2023.

They used the winds of Storm Agnes to help them topple the tree on

to the Unesco World Heritage Site wall, the court heard.

The value of the tree was disputed with prosecutors saying it was worth about £458,000 and Graham's team claiming it to be about £150,000, but Mrs Justice Lambert said the exact financial price did not really matter.

'sheer bravado'

The judge said the tree was a landmark of Northumberland and "symbol of the untamed beauty" of the landscape around Hadrian's Wall.

It was a place of "peace and tranquillity" which people returned to year after year, the judge said, adding it held great personal significance to many.

She said Carruthers used spray paint and a chainsaw to mark and then cut a wedge out of the tree, while Graham filmed it on his mobile phone.

Mrs Justice Lambert said a full motive was not clear, but she was "confident a major fac-

tor was sheer bravado," adding the action of felling the tree and the outrage it caused gave the men "some sort of thrill".

The men then "revelled in [their] notoriety" in the aftermath, the judge said.

She also rejected Carruthers' claim that he was drunk as the mission required skill and coordination as well as a "high degree" of planning by the two "experienced tree surgeons".

The tree had been planted in the late 1800s to be a "feature in the landscape", fulfilling that ambition and more by becoming a much-loved visitor destination and landmark at the former frontier of the Roman Empire.

'place of sanctuary'

It found global fame after featuring in a scene of the 1991 film Robin Hood: Prince of Thieves, starring Kevin Costner, and was popular with photographers and artists.

In a statement read to

the court, National Trust manager Andrew Poad said: "This iconic tree can never be replaced."

He said the trust cared for the "totemic symbol" on behalf of the nation and it "belonged to the people".

The tree was a "place of sanctuary" for many and its destruction led to an "unprecedented" outpouring of love and emotion, Mr Poad said, with the "overwhelming sense of loss and confusion felt across the world".

He said the reason for the "malicious" and "mindless" vandalism was "beyond comprehension" and the way it was felled to land

across the Roman wall was "reckless in the extreme".

But, he added that there were "signs of life" with shoots emerging

from the stump, while seeds taken from the tree had been used to grow saplings which would be placed around the country.

Brexit 'made Trump deal possible' says Mandy

■ The UK Ambassador to Washington, formerly a harsh critic, now has kind words for the President

Former arch-Remainer Peter Mandelson has admitted the UK's trade deal with the US was only possible because of Brexit.

Lord Mandelson is a former EU commissioner who sat on the board of the official Remain campaign in 2016, and is now Britain's ambassador to the US.

He said British carmakers were selling vehicles to America because of the trade deal agreed with US president Donald Trump – and that Brexit had made it possible.

He said: "Undoubtedly, we couldn't have done this deal if we had remained part of the European Union.

"We lost many other things by leaving, but we get the chance to do this deal. So there's some positives."

He said the deal gives a competitive advantage to British cars, such as luxury Aston Martins made in Warwickshire.

Lord Mandelson said in an interview: "That's very gratifying for me and the embassy team, having worked with London to achieve that.

"It means those Aston Martins and similar British products have a

17.5% competitive advantage over Mercedes and Ferraris."

The UK's deal with Donald Trump's White House means a 27.5% global tariffs on cars was reduced to 10% for British-made vehicles, with tariffs on aerospace products cut to zero.

However, a 25% tariff on UK steel and aluminium exports to the US is still in place, despite plans to eliminate this too.

'unique politician'

It comes as President Trump announced over the weekend that he would impose a general 30% tariff on goods from the EU. Lord Mandelson, who was a Cabinet minister in Labour governments led by Tony Blair and Gordon Brown, told The Times that Mr Trump turned on the charm when he began his ambassador role, calling Lord Mandelson "a handsome guy".

Praising Mr Trump, Lord Mandelson said: "Look, he's not only a unique politician – he's also going to be one of the most consequential presidents in American history. He has this sense of history, this grasp of

power, which I think perhaps recent inhabitants of the White House haven't quite seen.

"He is not a man for

endless seminars and thinking. He's not a victim of analysis paralysis. He has a very quick, easy way of grasping the core

points about an issue.

"And let's be honest: more often than not, there's a kernel of truth in everything he says."

In interview with BBC, President praises Britain as 'a great place'

Donald Trump has said the UK's departure from the European Union was "on the sloppy side" – but insisted Britain is now "getting straightened out".

The US president also told the BBC that Britain is "a great place – you

know I own property there".

He then spoke warmly about Sir Keir Starmer, despite political differences, and mentioned the new US-UK trade agreement.

'good trade deal'

He said: "I really like the Prime Minister a lot, even though he's a liberal. He did a good trade deal with us, which a lot of other countries didn't do."

Mr Trump is set to make an unprecedented second state visit in September. Like last time in 2019 and unlike Mr Trump's predecessor Barack Obama he will not be addressing Parliament, which will not be sitting. Asked about Nigel Farage's push to recall Parliament so he might speak to MPs, Mr Trump said: "Let them go and have a good time. I don't want that."

The visit – from September 17 to 19 – will focus on Windsor Castle, where the King is expected to host formal engagements.

Mr Trump said: "I want to have a good time and respect King Charles because he's a great gentleman."

During the interview, he was highly critical of Vladimir Putin over the despot's invasion of Ukraine.

Trump on trust

He said: "I'm disappointed in him. I'm not done with him, but I'm disappointed in him.

"You have a deal done four times, and then you go home, and you see he just attacked a nursing home in Kyiv. What the hell was that all about?"

His stance marked a sharp shift from earlier in his presidency, when he was accused of being

Farage blasts 'shoddy' UK treatment of Trump

Nigel Farage has said it is "shoddy" that Donald Trump will not have the chance to address Parliament during his unprecedented second state visit.

It comes after it was announced the US president will begin a three-day trip on 17 September, a day after the House of Commons breaks for the traditional party conference season.

The Reform UK leader said the "cowardly" timing of the trip showed the Labour government's "real priority" was to favour relations with Europe.

Downing Street denied the trip had deliberately been scheduled for the recess, saying questions on timing were for Buckingham Palace.

State visits, however, are traditionally organised in conjunction with government.

Last week France's President Emmanuel Macron gave an address to both Houses of Parliament during his three-day state visit to the UK.

However, such speeches are not automatic. Only around one in four state visits since 1952 have included a formal address to Parliament.

Since World War Two, three US presidents have addressed Parliament: Ronald Reagan in 1982, Bill Clinton in 1995 and Barack Obama in 2011.

Following Trump's first election win in 2017, then-Commons Speaker John Bercow said he would be "strongly opposed" to the US president making an address.

In 2019, more than 100 MPs signed a parliamentary motion accusing Trump of "misogynism, racism and xenophobia" and urging the then-Conservative government not to invite him on a state visit.

Nightmare couple guilty of killing newborn baby

■ Aristocrat with close links to the Royal Family and convicted rapist boyfriend face lengthy jail terms

AN aristocrat with close links to the Royal Family and her convicted rapist lover face lengthy prison sentences after they were found guilty of killing their newborn baby.

Constance Marten, 38, and Mark Gordon, 51, went on the run with daughter Victoria in early 2023 after their four other children had to be taken into care.

Marten had given birth to the tot in secret after social workers intervened amid allegations of domestic abuse by convicted sex felon Gordon.

Her family, who lived at Dorset estate Crichel House, has historic ties to the Windsors, and her father was a page to the late Queen.

During a massive £1.2million nationwide manhunt involving

more than 100 police, officers discovered a placenta in the pair's car, which they abandoned when it burst into flames near Bolton, Greater Manchester, on January 5 last year.

The duo then travelled across the country with baby Victoria, spending thousands of pounds from Marten's trust fund on taxis, before camping in a tent in sub-zero temperatures on the South Downs where the newborn perished.

'she wasn't alive'

During two trials at the Old Bailey, estimated to have cost over £1.6million, the juries heard how Marten received nearly £19,000 in payments from the trust over their two months on the run.

The couple were arrested near Brighton

on February 27, 2023, but refused to tell detectives where Victoria was – or if she was alive – with Gordon declaring: "What's the big deal?" The body was dumped in an allotment shed wrapped in a pink sheet and hidden beneath dirt and rubbish in a Lidl bag.

Marten told police: "I had her in my jacket and I hadn't slept properly in quite a few days, I fell asleep holding her sitting up and, when I woke up, she wasn't alive." Jurors were told Marten had been warned by social workers about the risk of falling asleep with a baby lying on her and that a tent was unsuitable.

She and Gordon went on trial at the Old Bailey in January last year, charged with manslaughter by gross negli-

gence, causing or allowing the death of a child, child cruelty, concealing the birth of a child and perverting the course of justice.

After a five-month trial, the jury failed to return a verdict on manslaughter, but convicted them of perverting the course of justice, con-

cealing the birth of a child and child cruelty.

At their subsequent retrial, which began in March, the CPS used fresh evidence from prosecution experts to explain the conditions and extremely high risk that Victoria was exposed to by her parents.

This included analysis of the weather data at the time, with temperatures close to freezing, and the effect of wind and wet clothing. The couple got legal aid for their defence, hiring 18 lawyers for around £600,000 – despite her being worth £2.4million.

sympathetic towards Putin. Asked if he trusted the Russian president, Mr Trump paused before replying: "I trust almost nobody."

The interview also marked the first anniversary of the assassination attempt on Mr Trump at a campaign rally in Butler, Pennsylvania.

Reflecting on the incident, which left one person dead and two injured, Mr Trump said: "I don't like to think about if it did change me," adding that to dwell on it "could be life-changing".

He said the shooting "happened very quickly" and that in the aftermath, his only thought was to "let the people know" he was unharmed.

Gunman Thomas Crooks was shot dead by Secret Service agents at the scene.

Struggling to tame Labour revolt, Starmer removes whip from four backbenchers

■ PM's troubles multiply as former leader Corbyn launches rival party

Sir Keir Starmer suspended four rebel backbenchers in the wake of the damaging revolt over welfare reform, as he tried to regain control of his fractious party.

Brian Leishman, Neil Duncan-Jordan, Chris HXinchliff and Rachael Maskell had the Labour whip withdrawn after being accused by a party source of "persistent s***headery".

All four had rebelled against attempts to cut the UK's ballooning benefits budget. They must now sit as independent MPs until the whip is restored.

The expulsions come just before the summer recess, suggesting the Prime Minister wants to deliver a stark warning to other potential rebels

before their return after the summer.

Alloa and Grangemouth MP Mr Leishman, 43, said of his suspension: "I am a proud Labour member, and I remain committed to the party. I wish to remain a Labour MP and deliver the positive change many voters are craving. I have voted against the Government on issues because I want to effectively represent and be the voice for communities across Alloa and Grangemouth.

"not my duty"

"I firmly believe that it is not my duty as an MP to make people poorer, especially those that have suffered because of austerity and its dire consequences."

Mr Duncan-Jordan,

MP for Poole, said: "Since being elected I have consistently spoken up for my constituents on a range of issues, including most recently on cuts to disability benefits.

"I understood this could come at a cost, but I couldn't support making disabled people poorer."

neck and neck

York Central MP Ms Maskell, 53, led the PIP – personal independence payment – rebellion that forced Sir Keir to ditch key welfare reforms on disability benefits. The suspensions are a high-stakes gamble, given fears left-wing Labour rebels may be tempted to join a new breakaway party led by former Labour leader Jeremy Cor-

byn and rising progressive MP Zarah Sultana.

A poll this week suggests that when included as an option, Mr Corbyn's new party is already neck-and-neck with Labour.

Find Out Now, which asked 650 Britons who they would vote for, found the Corbyn-Sultana party already winning more than 15% backing – level pegging with Sir Keir.

Forty-seven Labour MPs rebelled on the crunch vote, the largest of the PM's first year in office and the sixth largest rebellion in the history of Labour governments.

The four suspensions bring Labour's overall seat count down from 412 at last year's general election to 399.

domestic violence

Gordon is a rapist convicted of sexual offences in Florida in 1989 when he was just 14. He broke into a neighbour's house armed with a knife and hedge clippers and tortured her in a four-and-a-half hour ordeal. The brute was released after 22 years and returned to the UK.

He was also suspected of domestic violence in 2019, which left Marten with a shattered spleen while pregnant. Gordon then refused to let paramedics in to treat her. The latest case is the subject of a national child safeguarding review to consider if new laws are needed.

Det Supt Lewis Basford of Scotland Yard said: "The selfish actions of Mark Gordon and Constance Marten resulted in the death of a newborn baby who should have had the rest of her life ahead of her."

The killers will be sentenced at a later date.

Harry Potter actress conjures up driving ban

Harry Potter actress Emma Watson has been banned from driving for six months, after she was caught speeding.

Watson, who played Hermione Granger in the film franchise, drove a blue Audi at 38mph in a 30mph zone in Oxford on the evening of 31 July last year.

Watson already had nine points on her licence before the speeding incident occurred, the court heard.

The 35-year-old, now a student, was made to pay a total of £1,044 at High Wycombe Magistrates' Court on Wednesday.

She did not attend the five-minute hearing. Representatives for Watson have been approached for comment.

Watson's lawyer, Mark Haslam, told the court that she is a student, adding: "She is in a position to pay the fine."

The actress has been studying a master's degree in creative writing at the University of Oxford since 2023.

Watson shot to fame in 2001 with the release of Harry Potter and the Philosopher's Stone, alongside fellow child stars Daniel Radcliffe and Rupert Grint.

She starred in eight Potter films in total, with the last being released in 2011, before

Dry season worsens with four regions declaring a drought

■ Ministers call for hosepipe bans as East and West Midlands enter drought, joining Yorkshire and north-west

Four areas of England are now in drought as the East and West Midlands have joined Yorkshire and the north-west.

Continuing hot and dry weather was a hazard to crop production and wildlife, ministers said, as they urged water companies to put hosepipe bans in place to conserve water as levels deplete.

The water minister, Emma Hardy, said: "I have asked the national drought group to step up its response to ensure we are successfully managing the impacts of ongoing dry weather. Water companies must now take action to follow their drought plans – I will hold them to account if they delay."

England had a very hot and dry June. Rainfall was 20% less than the long-term average for the month, and it was the hottest on record for England. Reservoir levels have continued to fall as increased water use meets lack of rain, with overall storage across England at 75.6%. This

is below the level during the severe drought year of 2022, when they were at 77% capacity at this point in the summer. England's reservoirs are at their lowest levels for a decade.

The government's national drought group met on Tuesday to discuss their response to the prolonged dry weather, which has caused mass fish die-offs, low river flows, dangerous algal blooms and the beginnings of crop failures.

The Department for Environment, Food and Rural Affairs (Defra) said it was likely that yields for farmers would be lower than last year, particularly non-irrigated grains and straw.

Nature was also suffering, Defra said. Wildfires, drying up wetlands and coastal sites, and the loss of breeding seasons for rare species have all been seen. The national drought group is asking recreational water users including anglers, swimmers and boaters to report any environmental problems they see, such as fish in distress.

Officials said on Monday that as many as five of the Environment Agency's 14 areas of England were expected to go into drought this summer after the hottest June since records began in 1884.

Three heatwaves, which tend to increase water consumption, combined with a lack of rain, means that large swathes

of England are heading towards drought and the damage to the environment that entails.

Helen Wakeham, the Environment Agency's director for water and the national drought group chair, said: "This has been the driest start to the year since 1976, and we need to make sure our water supplies can sustain us through the summer."

"Today I have asked all the partners who make up the national drought group to step up their operational response to manage the drought and use water wisely. Environment Agency teams are out on the ground actively monitoring river levels and working to ensure there is enough water for the people and the environment."

Climate change: Britain's way of life 'under threat'

■ Met Office gives bleak assessment as nation gets wetter amid rising sea levels

BRITAIN'S way of life is "under threat" as heatwave and rainfall extremes become common due to climate change, Energy Secretary Ed Miliband has warned.

In a report to be released on Monday, Met Office experts said the country's climate is "notably different" from just a few decades ago.

For the first time, its annual report found UK sea levels are rising, while the nation is getting wetter, with extremes of rainfall, floods and storms in 2024.

Mr Miliband called the findings "a stark warn-

ing" to take action, adding: "Our British way of life is under threat. Whether it is extreme heat, droughts or flooding, we can see it actually with our own eyes, that it's already happening."

'central mission'

"That's why the Government has a central mission to make Britain a clean energy superpower and tackle the climate crisis."

But eco campaigners say Labour would sideline nature in pursuit of growth over its planning reforms.

Kathryn Brown, at

The Wildlife Trusts, said: "This report clearly reinforces that climate change is bringing more frequent extreme weather events to our doors – from heatwaves and droughts to floods and storms."

"Nature has a critical role to play in helping to safeguard homes, businesses and livelihoods from these harms, underpinning our resilience to climate change with huge financial savings."

spate of wildfires

She added: "We are particularly worried about the effects of

droughts on our nature reserves." Last year was the fourth warmest in records dating back to 1884, with the hottest spring, although that has already been beaten this year. Meanwhile, heat health alerts have been issued multiple times so far this summer, with temperatures well above 30C (86F) across the UK.

One effect has been the spate of wildfires seen, particularly on farmland. Records for 2024 show that spring was earlier than average for 12 of 13 the seasonal events monitored, and the earliest according to figures going back to

1999 for frogspawn appearing and blackbirds nesting.

It was also the longest time that leaves had stayed on the trees.

Figures showed England and Wales had the wettest winter too from October 2023 to March 2024 for more than 250 years, following floods in Derbyshire, Nottinghamshire, West Midlands, and across the North.

Professor Liz Bentley, chief executive of the Royal Meteorological Society, said the report reinforced the "clear and urgent signals of our changing climate".

The 76-year-old was driving at 46mph in a 40mph limit, the court heard.

She was also fined £1,044 and banned for six months.

audience was amazing, so to be able to bow out on a high like that was wonderful.

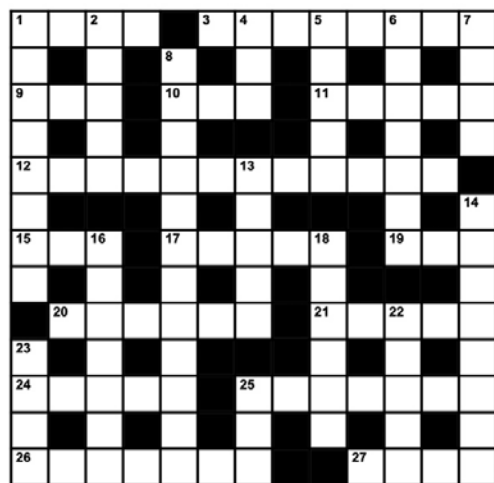
"We enjoyed it so much. The skating was good from our point of view, but the audience was phenomenal. They were the best audience ever."

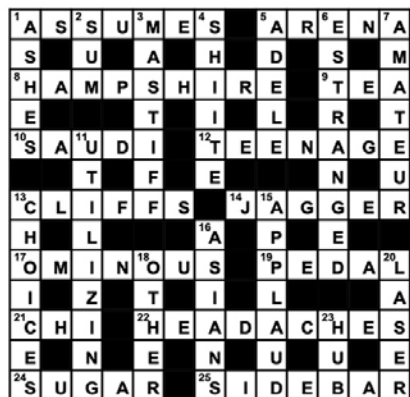

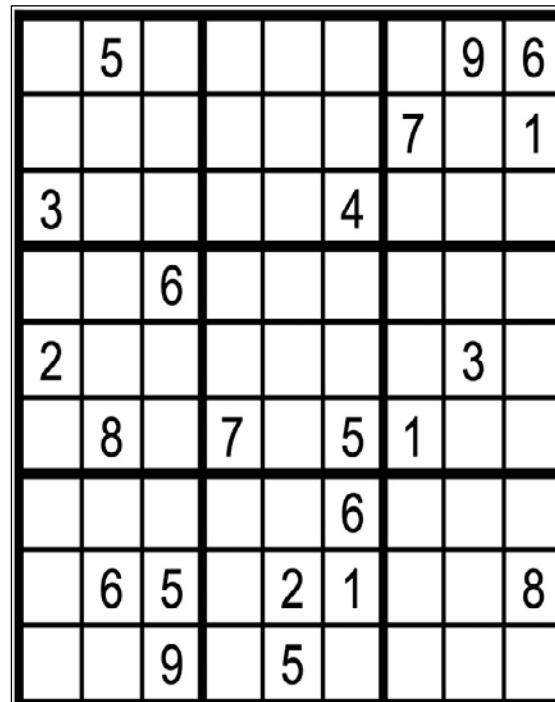

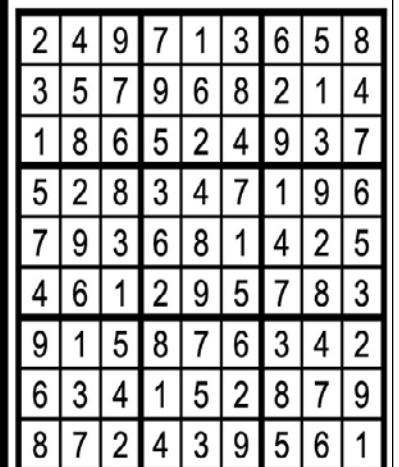

The Prince and Princess of Wales and their children George and Charlotte were the centre of attention at Wimbledon on Sunday for the men's final.

The royals took their seats on Centre Court to watch defending champion Carlos Alcaraz take on world number one Jannik Sinner in the highly anticipated heavyweight clash.

George, 11, and Charlotte, 10, looked delighted to be sitting at the front of the Royal Box but fans were disappointed that Louis, seven, did not join them.

The heat and the anticipated lengthy nature of the Alcaraz-Sinner clash meant mum and dad, perhaps wisely, decided to leave the playful prince at home.

Louis is famous for his cheeky antics during spectator events, most recently at Trooping the Colour.

Patron Kate presented the trophy to Sinner after he won the title for the first time by beating Alcaraz 4-6 6-4 6-4 6-4. Last year, Kate presented the Wimbledon men's final trophy to Alcaraz in her second public engagement since she announced her cancer diag-

nosis.

William wore a double-breasted blazer and white chinos, while Kate chose a striking royal blue dress for the occasion.

She also wore her "Wimbledon bow", a brooch featuring the tournament's iconic colours which, it is believed, she has worn every time she has visited.

George looked sharp in a black suit and Charlotte wore a beige summer dress.

Earlier Kate told an 11-year-old who was diagnosed with cancer that he was a "brave boy".

Before entering Centre Court, the family met Ambrose Caldecott, who has undergone chemotherapy over the last year and was chosen to perform the ceremonial coin toss before the final. Ambrose, who had bone can-

cer, told Kate about his experiences, to which she replied: "What a brave boy you've been."

The princess, who was diagnosed with cancer in 2024, confirmed she was free from the disease at the start of this year.

Ambrose said: "We spoke about tennis, our favourite sports, what I went through last year and how it affected me", adding that "she said she knew from her experience" his situation.

The Royals also met British pair Julian Cash and Lloyd Glasspool who made Wimbledon history on Saturday by winning the men's doubles title.

They are the first all-British pairing to win since Pat Hughes and Raymond Tuckey in 1936.

Cash, 28, said: "It was an absolute pleasure to meet them today. They're

England win a nailbiting Third Test

ENGLAND regained the upper hand in what is turning into a thrilling summer Test series by beating India by just 22 runs in a nailbiting third Test at Lord's.

And it was Ben Stokes who swung the match in the hosts' favor, claiming three wickets as India were bowled out for 170 in their second innings.

In an epic conclusion, the hosts had victory in their grasp until nerves were frayed by outstanding defiance from Ravindra Jadeja.

Chasing 193, India were 112-8 when Jadeja was joined by number 10 Jasprit Bumrah. They were together for almost 22 overs before Stokes, who bowled tirelessly from the Nursery End, drew Bumrah into a pull to mid-on. Bumrah's contribution to a stand of 35 was five from 54 balls.

Still Jadeja resisted, this time with last man Mohammed Siraj. Stokes refused to stop bowling. A delayed tea was taken with 30 required for India.

The injured Shoaib Bashir was summoned after the break, and incredibly got Siraj to defend the ball into the ground and back on to his stumps. Bashir, who has an injured finger on his non-bowling hand, set off on a delirious celebration, his last act of the series after he was ruled out of the final two Tests. Jadeja was left stranded on 61 from 181 balls.

The drawn-out finale was a direct contrast to a pulsating morning, when Stokes and Jofra Archer broke open the India bat-

ting with some irresistible pace bowling.

Archer ripped Rishabh Pant's off stump out of the ground, Stokes had KL Rahul lbw on review for 39. Washington Sundar, who confidently told the media on Sunday night "India will win", was sensationally held by Archer's agile swoop in his fol-

low-through. Jadeja began his vigil, first alongside Nitish Kumar Reddy for 15 overs, then Bumrah. Jadeja and Brydon Carse had to be separated after an acciden-

tal collision while Jadeja was running between the wickets.

England tried everything and thought they had Jadeja until he over-

turned being given lbw to Chris Woakes on 26. Once again, Stokes decided it was up to him.

After a spell of 9.2 overs in the morning, the talismanic captain launched into another of 10 up to tea. Bashir had the moment of glory, but it was Stokes who carried England on his back.

This was a slow-burner of a Test, one that occasionally ground to a halt. The finale was more than worth it, a rowdy Monday at a sold-out Lord's. By the end, England's win was the tightest in terms of runs

at this famous old ground.

It took three days for this match to spring to life. When it did, it was compelling. The deterioration of the pitch helped, but the real catalyst was the tension between the two teams. They are evenly matched and, if anything, India are unlucky to be behind. The last two Tests will be box-office viewing.

England look a better team with fire in their bellies, none more so than Stokes, the arch-competitor. He contributed to this win with bat and in

the field, then shouldered the bowling almost single-handedly on the final day.

England will be forced into one change for the fourth Test at Old Trafford on 23 July, with Bashir out because of a broken finger. India will wait on the fitness of Pant, who also has a finger injury.

In this wonderful year of Test cricket, with an Ashes series on the horizon, England are on the verge of winning a five-match series for the first time since 2018.

With Isak in their sights, Reds continue to spend

LIVERPOOL have signalled their determination to build on last season's title exploits by splashing the cash in spectacular fashion - with still more to come.

The Reds have already splurged more than £170m this summer - and now are interested in a player they would have to break the British transfer record to sign.

With a package for Newcastle United's Alexander Isak thought to cost up to £130m, their summer spending would soar to £300m, with midfielder Florian Wirtz joining for £116 earlier this summer and alongside £40m and £30m respectively for full-backs Milos Kerkez and Jeremie Frimpong.

Liverpool have explored other centre-forward targets, they have reportedly made a move towards Isak in recent days.

While he remains the

dream target, the Reds also have serious interest in Hugo Ekitike for whom Newcastle had a £70m bid turned down on Tuesday by Eintracht Frankfurt.

Liverpool have also checked in on Brentford's Yoane Wissa and Aston Villa's Ollie Watkins as they work through a range of striker options.

Arne Slot's big spending is due to several key factors.

They received £175m in prize money for winning the Premier League; last season was the club's first full campaign with an expanded Anfield Road End and a higher capacity; and from 1 August they have a new kit deal with Adidas which some reports value at £60m per season, more than their current partnership with Nike.

Those factors, combined with comparatively low transfer spending in previous windows, mean Liverpool find

themselves well within the Premier League's profit and sustainability rules (PSR) which limit clubs to losses of £105m over three years.

Their position could be further boosted. On Tuesday they rejected a £58.6m opening offer from Bayern Munich for forward Luis Diaz.

While Liverpool have

said Diaz is not for sale, they are understood to be open to selling Dar-

win Nunez, who has interest from Napoli and Saudi Arabia.

Women's Euros: England stumble into semi-finals with chaotic penalty shootout victory

England's women booked their place in the semi-finals of Euro 2025 in the most shambolic and heart stopping way imaginable on Thursday night, coming back from two goals down to force a penalty shoot out against Sweden, and somehow conjuring a victory only by being marginally less shambolic than their opponents.

Serena Wiegman's team will need to improve hugely and quickly to have any chance against Italy in their final four clash - after a dismal first 45 minutes which saw them lucky to go into the break only two goals down against a disciplined and tactically astute Sweden team.

England improved af-

ter the break but it wasn't until the introduction of substitutes that they were able to convert possession into chances, but with fifteen minutes left and still two goals down, an England win looked a distant hope. But then two goals in three minutes from Lucy Bronze and 19-year old Michelle Agyemang saw England turn the tie around and leave Sweden shell shocked.

England looked the stronger as the final whistle loomed, but Sweden were able to regroup and hold on for extra time and the overtime period was notable mainly for a stubborn stalemate with both sets of players looking exhausted and happy to hold on for spot kicks.

But then the real dra-

ma began, Alessia Russo nailing her first kick for England, and Filippa Angeldahl shooting tamely at Hannah Hampton. At that moment it looked like England were destined for the win, before Swedish goalie Jennifer Falk produced an astounding four saves from the next five penalties she faced. Sadly her teammates were unable to take advantage, missing four of their next five, with Falk herself sending one hopelessly over the bar. After six kicks each the score stood at 2-2 and up stepped Lucy Bronze to hammer home England's third, leaving Smilia Holmberg needing to convert to keep Sweden in the game. Sadly for the Swede, the pressure seemed too

"Then we go into extra-time, some players injured, some players cramping..Then we go to the penalty shootout and we miss a lot but they miss even more and we're through. I need to decompress I think!"
