LIONESSES BRING THE PRIDE!

Nation celebrates as England's women repeat as European champions

The Lionesses confessed they had not dreamt of the "surreal" scenes that greeted the Euro 2025 champions as 65,000 fans cheered their victory parade along The Mall to Buckingham Palace on Tuesday.

Star striker Alessia Russo, who scored the equaliser against Spain in Sunday's Basel final, said she felt "tired, but on cloud nine".

She added: "I mean this is just unreal. We didn't really know what to expect coming into it but everyone was so excited on the bus and it feels so nice to come back to England and celebrate with our fans.

"It's just a bit surreal. It's crazy to see this many people come out...heading up to Buckingham Palace – it's just crazy. I'd never have dreamt of anything like it."

'special, special people'

Skipper Leah Williamson said: "I've been crying all the way down The Mall. This is unbelievable, probably one of the best things we've ever, ever been a part of."

She described the team as "special, special people", adding: "We love each other,

we've got each other's back on and off the pitch. Tough moments, nasty things to deal with, and still we rise."

The flag-draped crowd included Princess Beatrice, her husband Edoardo Mapelli Mozzi and their children Sienna, Athena and Christopher.

After arriving on two open-top buses the team and staff lifted the trophy on a stage in front of the Queen Victoria Memorial.

Lionesses manager Sarina Wiegman danced alongside afrobeat star Burna Boy – her favourite artist – and Heather Small sang her 2000 hit Proud.

Families had flocked to London from across the country. Aspiring keeper Caitlin Farrelly, nine, from Manchester, said she has been inspired to join a team after seeing penalty shootout heroine Hannah Hampton and her

goalie predecessor Mary Earps play.

Claire Humble, 43, her daughter Ella Louise, 18, and friend Heidi, 18, arrived at the parade after a three-and-a-half-hour drive from Sandbach in Cheshire. Heidi said of the final: "We were lucky, but I still think we played better in the second half. [Spain] had the same chance that we had in penalties – it's just the way it goes."

John Farrelly, 46, an accountant, said: "We did have a bit of luck, but it's all about winning" before urging the Three Lions men's side: "Let's do what the women have done and bring that one home, too."

Claire McGeehan, 40, from Essex, said: "I can't believe how many people are here but it's good to see for the women's game."

Kassandra De Jesus, 46, from Hainault in east London, said that England's supersub Michelle Agyemang, 19

– named the best young player of the tournament – was "amazing...she kind of saved the day a few times, didn't she?"

And footballing brothers Gabriel, 10, and Noah, six, said that

they had been inspired by the women's team. Meanwhile, England's shootout heroine Chloe Kelly later apologised for swearing during an on-stage TV interview amid the victory celebrations.

The forward – who scored Sunday's decisive penalty and also the winner against Germany in the Euro 2022 final – posted: "Oops. Emotions got the better of me. Sorry for the F bomb. Love CK x"

Want to win? Here's how

■ Trump shares electoral tips with Starmer

THE US president has used a 'golf club summit' with Kier Starmer in Scotland to suggest the Prime Minister would be doomed to electoral failure unless he gets a grip on key UK issues.

Mr Trump gave his political tips to the PM as he met Sir Keir and his wife Lady Victoria at his Turnberry golf course on Sunday. He was asked about his relationship with the leaders of Labour and Reform, as his friend Mr Farage is tipped to win the next general election.

The president said he liked "both men" before giving the PM guidance for electoral success: "Politics is pretty simple, I assume there's a thing going on between you and Nigel and it's OK, it's two parties.

"But, generally speaking, the one who cuts taxes the most, the one who gives you the lowest energy prices and the best kinds of energy, the one who keeps you out of wars...whoever does these things [wins]. Low taxes, keep us safe, keep us out of wars, no crime, stop the crime, and, in your case, a big immigration component because I know that your attitude has become strong on immigration, strong on the

toughness on immigration."

He had earlier offered advice on tackling Channel migration, with small boat crossings up 50% this year to more than 24,000 arrivals in the UK. While not familiar with the crisis, Mr Trump said: "I love this country, as you know my mother was born in Scotland.

'magnificent'

"Europe is a much different place than it was just five years ago, 10 years ago, and they've got to get their act together. If you don't you're not going to have Europe.

"This is a magnificent part of the world and you cannot ruin it, you cannot let people come here illegally. There'll be murderers, there'll be drug dealers, there'll be all sorts of things that other countries don't want and they send them to you...and you've got to stop them. And taking a strong stand on immigration is imperative."

The president also said he thinks Sir Keir will be a "tax cutter" but slammed inheritance taxes on farmers as he praised them for their "way of life". He said he had acted to remove levies on farmland estates since he was voted back in to the White House.

Chancellor Rachel Reeves is due to hit farmers with an inheritance tax rise. Mr Trump's warning came amid fears that she is planning a big tax raid in the autumn.

He hinted that the UK will know soon if US tariffs on British steel imports will be eliminated, stay at 25% or increase. Asked by reporters when the tariffs might come down, Mr Trump said: "We're gonna know pretty soon, we're gonna have it pretty soon.

"These people are tough negotiators, OK. We're a big buyer of steel, but we're going to make our own steel and we're going to make our own aluminium for the most part.

"But we buy a lot of aluminium from right here and a lot of steel too."

Under the UK and US trade deal last month, tariffs on car and aerospace imports to the US fell. A similar pact for steel was not signed, leaving the levies at 25%.

In an awkward moment, Mr Trump again hit out at Labour's London Mayor Sir Sadiq Khan, saying: "I'm not a fan of your mayor. I think he's done a terrible job, the Mayor of London...a nasty person."

Sir Keir intervened to say "He's a friend of mine, actually", as Mr Trump went on: "I think he's done a terrible job. But I would certainly visit London."

A spokesman said that Sir Sadiq was "delighted that President Trump wants to come to the greatest city in the world", adding: "He'd see how our diversity makes us stronger, not weaker; richer, not poorer. Perhaps these are the reasons why a record number of

Americans have applied for British citizenship under his presidency."

The leaders met amid Mr Trump's four-day private trip to Scotland.

Sir Keir later joined him on his Air Force One jet to fly on to Aberdeen for dinner together after the PM had flown in from Switzerland where he had watched the Lionesses retain their Euros title by beating Spain on penalties on Sunday night.

On his historic second State visit due in September,

Mr Trump said: "The fact that it's never been done before... made it even more interesting. Being with Charles and Camilla, who I've got to know, they are really great people."

He added: "The UK is very lucky. You could have people that weren't great people. If he [Sir Keir] wants me to speak in Parliament, I'll do it." Mr Trump and his wife First Lady Melania are due to stay at Windsor Castle in September.

Trump praises 'beautiful' Turnberry

Donald Trump has delivered a rambling exposition on his "opulent and beautiful" golf resort at Turnberry as he continued to mix granular business interests and international diplomacy on his five-day trip to Scotland.

The UK prime minister, Kier Starmer, looked on in apparent discomfort during Monday's joint press conference as Trump answered a question initially pitched about the expense of refurbishing the Federal Reserve's historic building with a lengthy detour about the maintenance on his luxury golf resort.

Praising the "great craftsmen" of Ayrshire on Scotland's west coast, he described spending "probably \$100m

[£74m]" on the hotel: "We did a very great job. You see how beautiful it is?"

"We had ceilings that were in bad shape. They were falling down. It was very old. It wasn't properly maintained. Now it's brand new and beautiful, and we saved everything. If you look outside, it's equally opulent and beautiful."

With Trump's use of this visit to further his business interests already in the spotlight, Scotland's first minister, John Swinney, faced significant criticism after announcing that his government was in talks to provide £180,000 of public funding for the Aberdeenshire resort as it hosts the 2025 Nexo championship on the DP

World Tour next month. The US president earlier used his trip to repeat his call for the Open championship to return to Turnberry, declaring it "the best resort in the world".

Asked about the Open at Monday's joint press conference, Starmer said "the decision on the Open is not a decision for me" but was swift to praise Turnberry as "absolutely magnificent, both inside and out"

Swinney has refused to confirm the cost of policing Trump's visit, saying he remains in discussion with the UK government, but many critics have questioned why – as one Aberdeenshire protester put it on Monday – "our taxes are paying for his holiday".

Britain ready to recognize Palestinian state

■ Starmer bows to public opinion and party pressure

Prime Minister Keir Starmer said on Tuesday Britain was prepared to recognize a Palestinian state in September at the United Nations General Assembly in response to growing public anger over the images of starving children in Gaza.

Starmer spoke a day after talks in Scotland with U.S. President Donald Trump, who said he did "not mind" if Britain recognised a Palestinian state, though Washington - Israel's closest ally - has long declined to do so.

Britain became the second Western power on the U.N. Security Council to do so after France last week, reflecting Israel's deepening isolation over its conduct in its war against Hamas in Gaza, where a humanitarian disaster has set in and the Palestinian death toll has risen above 60,000.

Starmer said Britain would make the move unless Israel took sub-

stantive steps to allow more aid to enter Gaza, made clear there will be no annexation of the West Bank and committed to a long-term peace process that delivers a "two-state solution" - a Palestinian state co-existing in peace alongside Israel.

'reward for Hamas'

"The Palestinian people have endured terrible suffering," Starmer told reporters. "Now, in Gaza, because of a catastrophic failure of aid, we see starving babies, children too weak to stand, images that will stay with us for a lifetime. The suffering must end."

Starmer held a phone call with Israeli Prime Minister Benjamin Netanyahu before making his announcement, said a source, who asked not to be named.

In response, Israel's foreign ministry said in a post on X that Britain's move constitutes a "reward for Hamas" and

would harm efforts to reach a ceasefire in Gaza.

The sight of emaciated Gaza children has shocked the world in recent days. Earlier on Tuesday, a hunger monitor warned that worst-case scenario of famine was unfolding in Gaza and immediate action was needed to avoid widespread death.

Israel has denied pursuing a policy of starvation. Foreign Minister Gideon Saar said on Tuesday the situation in Gaza was "tough" but there were lies circulating about starvation there.

With international criticism intensifying, Israel announced steps over the weekend to ease aid access. But the U.N. World Food Programme said it was not getting the permissions it needed to deliver enough aid.

Starmer's decision marks a striking reversal in policy after he last week disappointed many in his party by rejecting

calls to recognise a Palestinian state, saying the timing must be right as part of a wider peace process.

The Prime Minister has previously insisted the government had said it was more focused on improving the situation on the ground for civilians stricken by the conflict than recognition.

Starmer has become increasingly vocal over the starvation and dev-

astation in Gaza, and has been under pressure to act from lawmakers in his Labour Party, many of whom have voiced strident opposition to Israeli policies since the October 7th, 2023 surprise Hamas attack.

The move carries great diplomatic and moral weight, even if it is mostly symbolic, according to Julie Norman, an associate professor at University College London

specialising in Middle Eastern politics.

The most immediate impact may be an upgrading of diplomatic relations with the Palestinians, according to one British government official.

Britain currently hosts a "Palestinian mission" of officials in London, but the recognition of a Palestinian state means it may be allowed open a fully fledged embassy.]

UK population soars to 61.8m

THE population of England and Wales soared by more than 700,000 in just a year with mass immigration the main cause, it was revealed on Tuesday.

Reform UK leader Nigel Farage called the rise "disastrous for the quality of life for everyone in the country", while Tories warned that pressure on housing and social cohesion was now unacceptable.

There were an estimated 61.8 million people in England and Wales in mid-2024 - up by 706,881 since mid-2023, according to figures from the Office for National Statistics.

It is the second largest rise ever, beaten only by the previous 12 months. Net international migra-

tion, the gap between arrivals and departures, was the "main driver" at 98% (690,147) of the leap.

Some 1,142,303 new people arrived in England and Wales while 452,156 left. There were also more births than deaths in the year.

Opposition politicians warned the rise was unsustainable. Mr Farage said: "It puts impossible pressures on public services and further divides our communities."

His fellow Reform MP Richard Tice said the figures "are deeply concerning and have serious implications for the housing crisis, crime rates and quality of life across Britain".

Shadow Home Secretary Chris Philp said: "These numbers are far

too high and must come substantially down. The pressure on housing and social cohesion is unacceptable.

"Mass low-skill migration is bad for the economy and costs more than it contributes." He said a Tory Government would toughen rules for people seeking indefinite leave to remain, to cut numbers.

He added: "The Conservative Party has put forward serious, workable policies to get immigration numbers dramatically down. This includes a hard cap on the number of visas issued, set by Parliament each year, and doubling the residency requirement for indefinite leave to remain from five to 10 years... and changing the criteria

for indefinite leave to remain so we can remove those who do not contribute."

Labour blamed the last Tory regime. Home Secretary Yvette Cooper said: "Under the Tories, overseas recruitment shot up while training in the UK was cut, lower skilled migration soared while

the proportion of UK residents in work plummeted, and hundreds of thousands of people were given visas to arrive and stay in the UK without any requirement on them to speak or learn English.

"To be successful, effective and fair, our immigration system must be properly controlled.

That is what this Government will deliver."

The population of England and Wales grew by an estimated 1.2% in the year to June 2024, down slightly from 1.4% in the previous 12 months but above the 1.0% in the year to mid-2022. Rises in the previous decade averaged 0.7%.

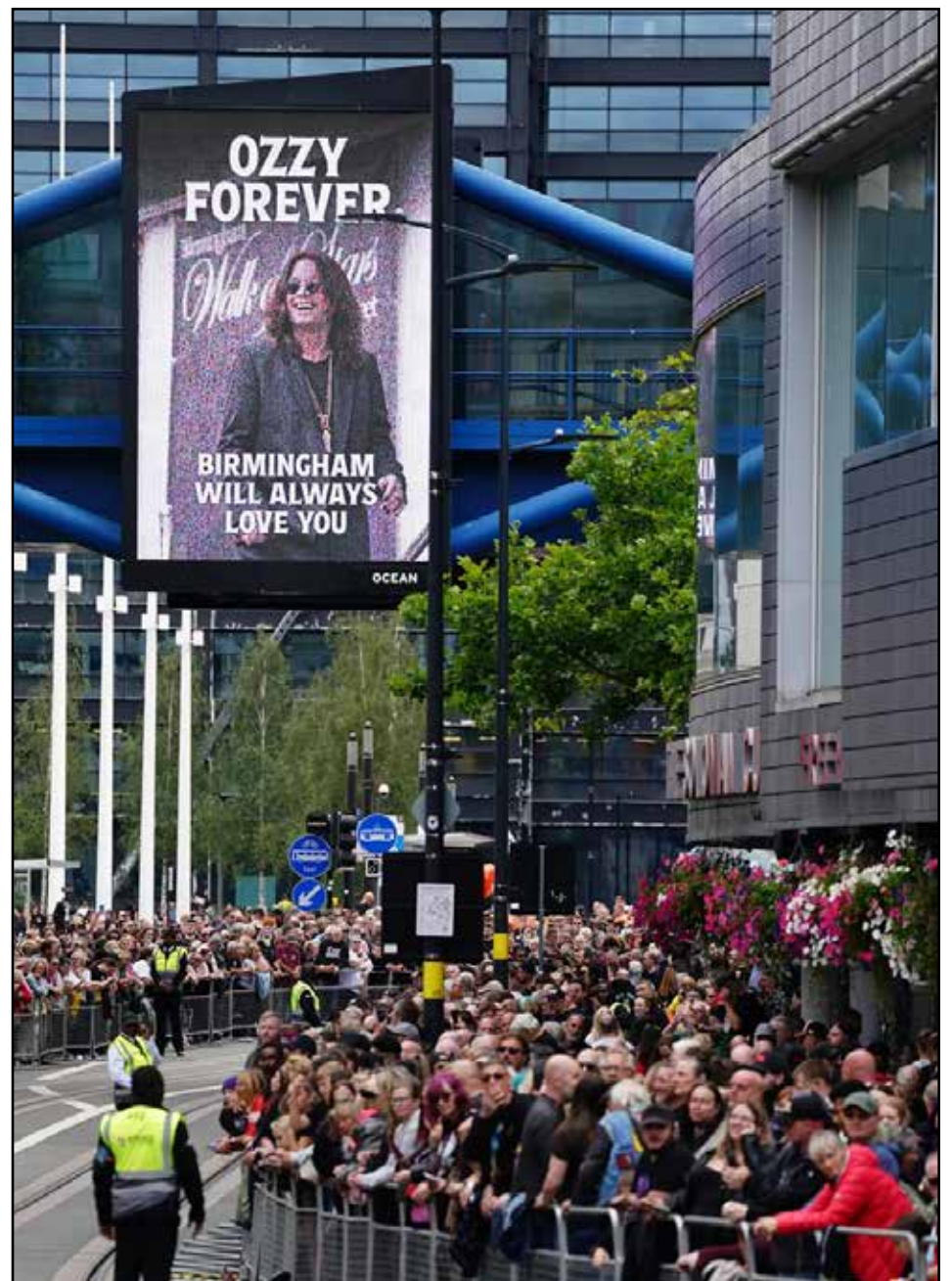

Student who broke WPC's nose found guilty of assault

A STUDENT who broke a policewoman's nose and knocked another to the ground using a "high level of violence" in an airport fight was this week found guilty of their assaults.

But a jury failed to reach a verdict on whether Mohammed Fahir Amaaz was also guilty – along with his brother Muhammad Amaad – of assaulting a male police officer during the same violent incident. Amaaz, 20, floored PC Lydia Ward with a punch to the face and forced PC Ellie Cook to the ground at Manchester Airport last July.

Video of officers final-

ly overpowering the men with one PC appearing to kick Amaaz in the head became a viral sensation and prompting a fury over what seemed to be excessive force.

But the video didn't show what came right before, as Amaaz pummelled the two WPCs.

A court heard both officers and a male colleague, PC Zachary Marsden, approached him at a car park ticket machine after a report was received that he had head-butted a customer in the Starbucks cafe in Terminal 2 arrivals.

But the prosecution said

Amaaz resisted arrest and inflicted a "high level of violence" on the Greater Manchester Police officers.

Amaaz was convicted of assaulting PC Ward causing actual bodily harm, and assaulting PC Cook and the Starbucks customer, Abdulkareem Ismaeila.

But after 10 hours of deliberations the jury could not reach a verdict on the two brothers' alleged assault on firearms officer PC Marsden.

Prosecutor Paul Greaney KC said the Crown intends to retry both brothers on that charge.

Lawyers had told Liv-

erpool Crown Court that CCTV footage showed Amaaz throwing 10 punches and Amaad, 26, aiming six at PC Marsden.

Amaaz was also said to have kicked the officer, hit him with his elbow, punched him from behind and had hold of him before PC Cook fired her Taser.

Mobile phone footage of a kick and a stamp by PC Marsden as Amaaz lay on the floor went viral when it was shared on social media.

Amaaz said he feared the "lunatic" male officer would "batter him to death". Amaad said he be-

lieved he was under attack.

The defence claimed the officers had used "unlawful force" as they grabbed Amaaz from behind without announcing themselves.

Describing how her nose was broken, PC Ward told the court she remembered "falling on the floor and everything went black" after a "really forceful" blow to her face. She added: "As I came round, all I could feel was blood pouring out of my nose."

"I was terrified to be honest. I was absolutely terrified. I had never experienced that level of violence

towards me in my life."

Amaaz was remanded in custody pending a bail application.

The Chief Constable of Greater Manchester Police, Sir Stephen Watson, welcomed the jury's verdicts but said the force was "actively supportive of a retrial in respect of the two counts where a verdict was not achieved".

He added: "Our officers first approached the man... following the unprovoked assault on an innocent man in the presence of his wife and children."

quickly to precisely the sort of outrageous criminal behaviour that rightly offends the public.

"Whilst assaults on police officers are sadly not uncommon – 44 of my officers are assaulted every week – such attacks can never be justified."

Mike Peake, chairman of the Greater Manchester Police Federation, said Amaaz's conviction showed the "worst side of police work our officers are faced with".

He added: "They deserve support in that work from the public and politicians. Officers are assaulted in GMP every week. We are bloodied and we are bruised."

The brothers' lawyer Aamer Anwar said: "As proceedings are still live, it would be inappropriate to comment further."

Rare Sumatran tigers born in Welsh zoo

Four rare Sumatran tiger cubs have been born at a Welsh Zoo, sparking new hope for the critically endangered species.

Mum Terima, who is 11, welcomed the "very noisy, and very cute" cubs around six weeks ago at Manor House Wildlife Park.

Park officials have been keeping news of the arrivals under wraps as the cubs were allowed to settle.

The four cubs, whose genders are yet unknown, were born on 8 June making Pembrokeshire home to seven tigers. Celebrity owner Anna Ryder Richardson said: "This is the largest litter in the UK, possibly in Europe, and it's

very exciting."

Kim Wilkins, head keeper at Manor Wildlife Park said having four cubs was "exceptionally rare", adding that a normal litter size for a Sumatran tiger is two or three.

"When I saw four I was over the moon, what an achievement," said Ms Wilkins.

The tigers at the park belong to a breeding programme, which makes recommendations as to which tigers move where "in order to keep a genetic variability to keep that gene pool healthy", Ms Wilkins added.

"When these babies grow up, they will

also join the wider breeding programme and will be moved around the world in order to keep that breeding process going."

There are estimated to be fewer than 400 Sumatran tigers left in the wild due to habitat loss and illegal poaching.

The Pembrokeshire

litter is believed to be the largest born in the UK, with three previously born at London Zoo and two at Chester Zoo last year.

Interior designer and TV presenter Ryder Richardson added: "This is a once in a lifetime opportunity. The tigers have a very important job to do because they

have been genetically matched to breed.

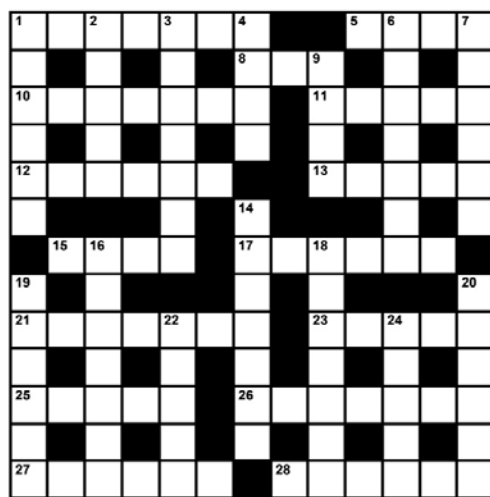
"The breeding group are really hoping that one of our four is a male."

The pairing and breeding of particular animals is managed by a studbook holder, who makes matches according to genetic diversity and other suitability criteria.

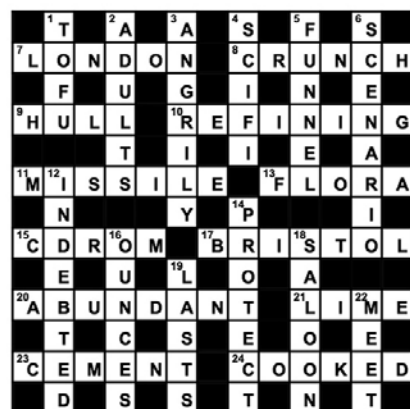

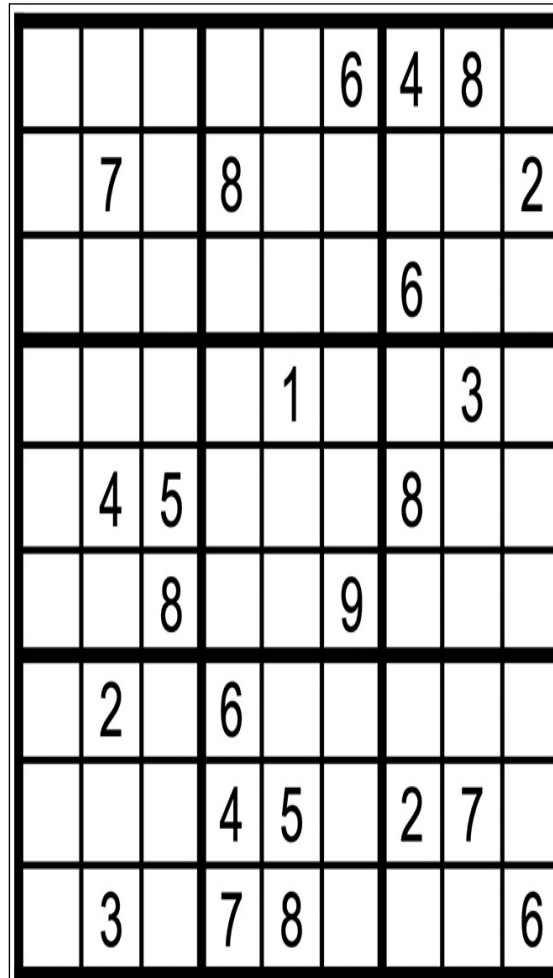

Brady questions Rooney's work ethic

NFL legend Tom Brady has questioned Wayne Rooney's attitude during the ex-England captain's tenure as manager of Birmingham City, where Brady is a minority owner.

In a new Amazon Prime documentary series, due to air on Friday, seven-time Super Bowl winner Brady tells colleagues: "I'm a little worried about our head coach's work ethic," before adding: "I mean, I don't know, I don't have great instincts on that."

Brady, who also calls Blues players "lazy and

entitled" in the series, made his comments about Rooney following a visit to the club's training ground in November 2023.

Filmed conversations between the former quarterback and then manager Rooney appear awkward.

In one exchange, the ex-Everton and Manchester United striker tells his employer about some of the cultural problems he perceives at the club.

"Why they're playing in the Championship and not the Premier League," Rooney says, "is because... we've all passed a ball, kicked the ball and run, but it's a focus, concentrated for 90 minutes."

In scenes that follow, Brady is filmed watching a training session, saying: "We've got a long road

ahead."

The retired quarterback - widely considered the best player in NFL history - became a minority owner in the club in August 2023, following a takeover the previous month by Knighthead Capital Management LLC, co-founded by financier Tom Wagner.

The club were relegated to League One in the first year under their new ownership after going through seven managers in 10 months.

Two months after Brady arrived in 2023, manager John Eustace was controversially replaced by Rooney, with the Blues sitting sixth in the Championship.

However, with the club then plummeting to 20th in the table, Rooney only lasted 83 days in

charge at St Andrew's.

At the time, Rooney said that he did not feel 13 weeks was "sufficient to oversee the changes that were needed".

During the series, Blues fan Paul Collins speculates that the appointment had been

based on a desire by the ownership to hire "one of the most recognisable English footballers of the last generation" in order to "put a load of eyes on Birmingham City".

Collins asks: "What qualifies Wayne to manage Birmingham City?

Nothing."

Brady also reflects on the owners' disastrous first season in charge.

"There was some good advice that I got that was like, 'listen, don't go in there and make these big, sweeping changes - you guys have time,'" he said.

moth effort on the fifth day but were ultimately frustrated by India's determination, a pitch that only had sporadic spells of life and a crucial Joe Root drop.

As ever, the home side looked to captain Ben Stokes for inspiration. After not bowling on day four, Stokes urged his fragile body through two spells, and had KL Rahul lbw for 90 at the beginning of the day.

When Shubman Gill wearily poked at Jofra Archer's spell with the second new ball, the prolific captain was out for 103 and England had an opportunity. India were four wickets down, 89 behind and had in excess of two sessions to bat.

But Root put down Ravindra Jadeja from the first ball he faced. England barely got another chance as Jadeja and Washington Sundar each made centuries. Their stand was an unbroken 203.

It meant England had to make do with only a second draw in 40 Tests since Stokes became captain in 2022, both on this ground, following the rain-affected stalemate with Australia in 2023. All four of Lancashire's County Championship matches on this ground this year have also been drawn.

England still lead 2-1 and somehow both teams must regroup for the final Test at The Oval, which began on Thursday.

Of chief concern among some weary England bodies will be Stokes, who seemed to be feeling shoulder and upper leg problems throughout the day.

India will be without wicketkeeper Rishabh Pant because of a fractured foot. The tourists also have decision to make on key pace bowler Jasprit Bumrah, who has played the maximum three Tests they stated he would before the series.

The tense, fluctuating and unpredictable nature of this series has had echoes of the epic 2005

Ashes. How apt that this ground has produced the same result - an unlikely draw - 20 years on.

On that occasion, Australia held on nine wickets down on a famous day when thousands of spectators were locked out of Old Trafford.

This was not as raucous or dramatic as two decades ago, but India's escape is no less remarkable.

Before lunch on Saturday they were 0-2, 311 behind and all but beaten. That they go to The Oval with a chance of squaring the series says so much about their spirit, especially captain Gill, who is having a magnificent summer.

Prince of Wales congratulated England supersub Michelle Agyemang on being named young player of the tournament. England boss Wiegman said after the game: "We said we can win by any means and that's what we have shown again.

"I am so proud of the team and the staff. It is incredible. It has been the most chaotic tournament on the pitch - all the challenges we had on the pitch against our opponents.

"From the first game it was chaos. Losing your first game and becoming European Champions is incredible. Football is chaos."

Kelly said afterwards: "I'm so proud of this team. So grateful to wear this badge and so proud to be English. It's unbelievable, not just the team, the staff behind us, and Sarina Wiegman, she's done it again. Unbelievable!"

On scoring the winning penalty, she added: "I was cool, I was composed, I knew I was going to hit the back of the net. I don't miss penalties twice."

Alessia Russo gave the Lionesses hope of retaining their Euros title with her second-half equaliser after Mariona Caldentey had netted the opener for Spain in the 25th minute.

It was a dogged Lionesses' performance for much of the second-half and extra-time as they dug in to keep the score level. Then the penalty shootout saw both Beth Mead and skipper Leah Williamson missing their spot-kicks.

But Hampton saved twice while Alex Greenwood, Niamh Charles and finally Kelly all hit the back of the net.

Repeat so sweet for Lionesses

Euro 2025: England's women dethrone world champs to secure second consecutive European crown

KIT'S back home again! The heroic Lionesses won a nail-biting penalty shootout Sunday night to bring down Spain and retain the European Championship.

Once again England's Chloe Kelly was the heroine, scoring the vital spot kick as Sarina Wiegman's comeback queens won back-to-back finals sparking wild celebrations across the country and in the Basel stadium.

Their victory, after going behind, makes the never-say-die women the first England football team to win a tournament abroad.

Kelly, who also scored the winning goal in the Euro 2022 final, clinched the victory 3-1 on penalties following two huge shootout saves from keep-

er Hannah Hampton.

Footage showed the Chelsea star seemed to have taped her notes on where Spain's penalty takers might strike on a patch under her left sleeve.

Supporters in pubs and fan zones danced on tables, threw their drinks in the air and excitedly hugged as England beat the world champions while the Prince of Wales and Sir Keir Starmer watched from the Swiss stands. King Charles said that the Lionesses had the Royal Family's "warmest appreciation and admiration" following their win, adding: "The next task is to bring home the World Cup in 2027 if you possibly can."

In a statement posted on X, Charles added: "This

brings you, your manager and all your support team my most heartfelt congratulations on winning the Euros 2025.

"For more years than I care to remember, England fans have sung that famous chant 'Football's coming home'.

"As you return home with the trophy you won at Wembley three years ago, it is a source of great pride that, through sporting skill and awesome teamwork, the Lionesses have made those words ring true.

"You have shown through your example over past weeks that there are no setbacks so tough that defeat cannot be transformed into victory, even as the final whistle looms. Well done, Lionesses."
