Support Pro Palestine group, get arrested, Met warns

- Police warn of mass arrests if Palestine Action protest in London goes ahead
- Hundreds likely to join weekend rally in support of proscribed group
- 300 UK Jewish figures urge PM to lift ban

THE METROPOLITAN POLICE received widespread condemnation this week after warning that protesters attending a planned pro-Palestinian demonstration could be arrested simply for showing up.

Last month Home Secretary Yvette Cooper banned the Palestine Action organization after activists caused an estimated £7m of damage to jets at RAF Brize Norton. But the ban has caused widespread criticism from human rights activists and civil libertarians across the country.

On Tuesday 300 left-leaning Jewish figures including the director Mike Leigh and author Michael Rosen warned the prime minister in a letter that the banning the group was "illegitimate and unethical".

Meanwhile, campaigners from the pressure group Defend Our Juries plan to descend upon Westminster on Saturday and are expected to be joined by 1,000 others. The group is asking those taking part to hold

up signs saying "I Oppose Genocide, I Support Palestine Action". This in theory will be sufficient for them to be arrested. More than 200 people have already been detained in response to the proscription last month.

'strain on the police'

A Met police spokesperson said the organisers of Saturday's planned protest are attempting to put the overcrowded criminal justice system under further pressure.

"We are aware that the organisers of Saturday's planned protest are encouraging hundreds of people to turn out with the intention of placing a strain on the police and the wider criminal justice system," they said.

"The Met is very experienced in dealing with large-scale protests, including where the protest

activity crosses into criminality requiring arrests. Our officers will continue to apply the law in relation to Palestine Action as we have done since its proscription. Anyone showing support for the group can expect to be arrested."

Starmer's official spokesperson urged people not to attend. "Any action that is in support of a proscribed group in the UK, of course we do not support and the court has confirmed their continued proscription status," they said.

"The home secretary previously said that those who seek to support this group may yet not know the true nature of this organisation, but people should be under no illusion this is not a peaceful or non-violent protest group."

Sadiq Khan, who was

vocal in urging Starmer to recognise a Palestinian state, declined to weigh in. A spokesperson for the mayor of London said: "The policing of Saturday's planned protest by Defend Our Juries is an operational decision for the Metropolitan police."

controversial ban

Two women and a man have already been charged with showing support for the group following a protest in central London last month.

Jeremy Shippam, 71,

of West Sussex, Judith Murray, 71, of Surrey, and Fiona Maclean, 53, of Hackney are due to appear at Westminster Magistrates' Court on 16 September, the Metropolitan Police said.

The three were arrested at a protest in Westminster on 5 July.

Supporting Palestine Action is a criminal offence, with membership or expressing support for the group punishable by up to 14 years in prison.

Commander Dominic Murphy, head of the Met's Counter Terror-

ism Command, said of Thursday's arrests: "We are also planning to send case files to the Crown Prosecution Service for the other 26 people arrested on the same day."

"I would strongly advise anyone planning to come to London this weekend to show support for Palestine Action to think about the potential criminal consequences of their actions."

The group has won permission to challenge its controversial ban.

Bank of England cuts interest rates to 4%

■ Easing comes as UK inflation fears lessen

The Bank of England has cut interest rates to 4%, taking the cost of borrowing to the lowest level for more than two years.

The cut, from the previous rate of 4.25%, is the fifth since August last year, but was only narrowly backed by the Bank's policymakers who took two votes to reach a decision.

Lower rates will reduce monthly mortgage costs for some homeowners but it could also mean smaller returns for savers.

'finely balanced'

The unprecedented second vote by policymakers suggests further interest rate cuts will be finely balanced amid concerns over rising prices, although the Bank's governor said the path for rates continues to be "downwards".

Inflation is now expected to peak at 4% in September, the Bank said in its Monetary Policy Report.

That is twice the Bank's target rate and above the 3.8% rate it predicted in its May re-

port.

However, while inflation is higher than the Bank would like - which would not normally lead to a rate cut - the economy has been struggling to grow and there are fears about the jobs market.

Andrew Bailey, governor of the Bank of England, said the decision to cut interest rates was "finely balanced".

"Interest rates are still on a downward path," he said. "But any future rate cuts will need to be made gradually and carefully."

He added the course of future rate cuts "is a bit more uncertain frankly".

Businesses told the Bank that "material increases" in National Insurance Contributions and the national living wage since April have added up to 2% to food prices.

'trading down'

The Bank said global adverse weather conditions had also lifted the cost of goods such as beef, coffee beans and cocoa.

But companies told the

Bank that they expected UK labour costs "to continue to push up food prices in the second half of the year", and in order to mitigate costs, they were having to cut staff.

They also reported shoppers were "trading down" by purchasing own-label items as opposed to branded products, and buying "cheaper cuts of meat".

Mr Bailey said the Bank did not expect higher inflation to persist, "but we have to watch this very carefully".

'essential of life'

On the other hand, UK employment is "softening" he said, with data showing job vacancies are continuing to fall and wage growth is slowing.

Mr Bailey said he is "very conscious" that inflation affects the cost of living.

"Food is a particularly important issue here because for those on the lowest incomes, food [is] a larger share of their consumption because it is the essential of life so we have to be very focused on this," he said.

Farage unveils his latest recruits

NIGEL Farage continues to ride high in the UK opinion polls this month, and his ambitions to be the next Prime Minister received a boost with two new major Reform UK recruits, as his part secured more high-profile defections from the Conservatives.

Rupert Matthews, the serving police and crime commissioner for Leicestershire, announced he was jumping ship, delivering a damning broadside of the Tories' recent time in office and of Kemi Badenoch's leadership of the party he had been a member of for 40 years.

Mr Matthews, who has also served as an MEP, claimed the Conservative Party is no longer putting Britain and the British people first, and accused Ms Badenoch of "cowardly capitulation to establishment orthodoxies".

He said all parties had played their role in the decline of Britain,

quipping: "It's almost as if they've looked at countries like Lebanon and Libya, the policies that have led to them becoming failed states and thought, 'That looks good, let's try that here in Britain'."

Mr Farage also announced a new justice adviser, Vanessa Frake, who was pictured alongside the party leader with Mr Matthews, George Finch, leader of Warwickshire council and crime adviser Colin Sutton.

Ms Frake will help formulate the party's policies in crime and policing ahead of the next general election.

The former prison governor said that having never supported a political party before, she now believes Mr Farage "is the leader this country needs to make the country safer".

Like Mr Matthews, she condemned both Tory and Labour governments for letting thousands of prisoners

out early, which she branded a "disgrace" that has put ordinary Britons at risk.

Ms Frake said it is now an undeniable fact that Britain is "lawless". She suggested Reform would look to convert parts of the high-security prisons estate into US-style supermax jails that hold inmates in cramped single cells, under 24-hour supervision.

She condemned the current situation, where evil murderers like Axel Rudakubana have been allowed to keep kettles which have then been used to attack prison officers.

While the appointment was greeted with delight in Reform circles, Ms Frake's refusal to rule out allowing transgender criminals to be jailed in women's prisons caused a backlash.

Ms Badenoch claimed it meant the Tories are the "only party standing up for women-only spaces".

to Sir Kier Starmer on Tuesday was signed by, among others, leading human rights lawyer Geoffrey Bindman KC and the playwright Gillian Slovo, and it expressed "horror" at the actions of Israel.


The letter said: "We

consider the proscription of Palestine Action to be illegitimate and unethical. It is time to end the government's hand-wringing over the level of slaughter and suffering in Gaza and the West Bank, mixed with tacit support to the Israeli state."

The Met is sceptical of claims that thousands of people could turn up on


Saturday. The force believes that a total in the low hundreds is more likely. Anyone arrested risks a terrorism conviction.

Police resources will be stretched at the weekend as a large, separate pro-Palestinian march is also scheduled for Saturday and anti-immigration protests are expected.

Harry left 'devastated' by bullying claims

THE Duke of Sussex is "absolutely devastated" by the report into claims of bullying at Sentebale, the charity he helped set up.

A watchdog this week "criticised all parties" for letting a "damaging" boardroom battle play out in the "public eye" that risked undermining public trust in the sector.

The Charity Commission investigated Sentebale after founders Harry and Prince Seeiso stepped down as its patrons in support of a group of trustees, who resigned following a dispute with trustees chair Dr Sophie Chandauka.

A war of words followed, with Dr Chandauka accusing the charity of bullying, harassment and misogyny as well as launching personal attacks on the Duke and Duchess of Sussex.

The regulator found no evidence of systemic bullying or harassment, including misogynoir – misogyny directed at black women. But it acknowledged "the strong perception of ill treatment" felt by some involved.

However, it did find weaknesses in the charity's management and criticised both sides for allowing the dispute to "play out publicly" and harm the reputation of Sentebale, which helps young people and children in southern Africa, particularly those living with HIV and Aids. A source close to Harry criticised the report, saying the prince was "devastated that the chair has been allowed to succeed with a hostile takeover".

They added: "It's a charity that Seeiso and Harry set up 19 years ago and certainly in Harry's adult lifetime it's been his life's work."

First female boss of MI5 dead at 90

Dame Stella Rimington, who "broke through barriers" as the first female boss of MI5, has died at the age of 90.

The trailblazer is widely credited as the model for Dame Judi Dench's M in the James Bond films.

She was born on May 13, 1935 in South Norwood, South London, and passed away on Sunday night surrounded by her loved ones and dogs.

Her family said she "held on to the life she loved until her last breath".

She joined MI5 full time in 1969, having been recruited two years earlier as a part-time typist by its office in the British High Commission in New Delhi.

In 1967 Dame Stella, the bored wife of a junior

diplomat, was asked to "help out" by an official known for his "Sunday curry lunches".

He was also the senior liaison officer for MI5 in New Delhi, and when the diplomat's wife accepted his offer she entered the shady world of espionage.

'true trailblazer'

The mother of two went on to lead each of the Security Service's operational branches before being appointed to the job of deputy director general in 1991 and then director general a year later.

Dame Stella found herself pitted against Russian agents and IRA terrorists as well as domestic "subversives" such as the leaders of the 1984 miners' strike.

She was the first boss

to be publicly identified and when a newspaper revealed the family home was forced to move.

In 1996 Dame Stella left MI5 and took to writing novels. She also became a Marks & Spencer director, where she used her spy skills to

eavesdrop on customers as they discussed products.

MI5's current chief Sir Ken McCallum said Dame Stella "ushered in a new era of openness and transparency about the work MI5 does to keep this country safe".

He added: "As the first

female head of any intelligence agency, Dame Stella broke through long-standing barriers and was a visible example of the importance of diversity in leadership."

MI6 chief Sir Richard Moore described Dame Stella, as "a true trailblazer".

Far right icon arrested on assault charge

Controversial figure charged after attack at London's St. Pancras

Far-right activist Tommy Robinson has been released on police bail after his arrest in connection with an assault at St Pancras railway station.

British Transport Police did not name Robinson, real name Stephen Yaxley-Lennon, but confirmed a 42-year-old man from Bedfordshire was arrested over an assault in London on 28 July.

The force said the arrest took place at Luton Airport shortly after 18:30 BST on Monday, following a notification that the man had boarded an incoming flight from Tenerife in the Canary Islands.

The man was arrested on suspicion of grievous bodily harm and taken into custody for questioning, police said. He was released on police

bail until 2 September while inquiries continue.

The statement added he had been wanted for questioning after leaving for Tenerife in the early hours of 29 July following the incident.

'he's come at me'

Last week, British Transport Police said that a man had "serious but non-life-threatening injuries" following the incident at the railway station in King's Cross.

The force confirmed later that week that the man had been discharged from hospital.

Video footage on social media emerged shortly after the alleged assault showing Robinson walking back and forth near a motionless man lying on the floor, near the stairs down to the northbound Thames-

link line.

The clip did not show how the man ended up on the floor.

Robinson then starts coming back up the stairs, appearing to try to talk to the passing commuter who called for help.

Robinson can be heard saying: "He's come at me, bruv."

In a video statement posted on X on Tuesday, Robinson said he went to the Spanish island on a pre-booked trip and he told police where he was, as well as his return date.

He also said he was shown the full CCTV footage of the incident in his police interview and called for detectives to

share it with the public, saying that it showed he acted in self-defence.

"If someone wants to come up and accost me, confront me and attempt to attack me, I'm within my rights to defend myself," he added.

"After seeing the CCTV, I know there's not a jury in the world that would convict me."

One in, one out - will it work?

■ New measure aimed at cutting small boat crossings makes it debut - but critics claim it is doomed to failure

CHANNEL CROSSING migrants are now being detained upon arrival and could be returned to France within weeks, as a new government scheme comes into force.

Home Secretary Yvette Cooper declined to say how many migrants were being detained under the UK's new "one in, one out" deportation deal with France, which began on Wednesday.

An official source said more than five nationalities are represented in the dozens held so far, but did not give a specific number.

Pictures showed the migrants wearing life jackets disembarking from Border Force boats

in Dover on the first day the pilot scheme came into force.

The Home Office also released edited footage which they say shows Border Force and Immigration Enforcement teams enacting the new scheme.

It says the footage shows some of those detained going through the first stages of the pilot process in the last 24 hours, including their initial processing, their biometric and security checks and their relocation to an immigration removal centre to await their return to France.

In an interview on

Thursday about the detentions, Cooper said: "The transfers to immigration removal centres are under way as we speak, so we won't provide operational details at this point that criminal gangs can simply use and exploit."

legal challenges

"But no-one should be in any doubt: anyone who arrives from now on is eligible for immediate detention and return."

She said the first migrants could be sent back within weeks and that she was prepared to resist any legal challenges aimed at preventing their

removal to France.

Cooper added: "It's the beginning of the pilot and it will build as well over time, but we're also clear that France is a safe country, so we will robustly defend against any legal challenge that people try."

Home Office figures reveal 155 migrants ar-

rived in the UK after crossing the Channel on Wednesday, the day the pilot scheme came into force. The government earlier said those detained will be held in immigration removal centres until they are returned to France.

A poster was being distributed across

northern France on Wednesday, warning would-be migrants of the new removals deal.

Crossover Of The Century? Takeout giants team up to serve sausage roll drenched in gravy

■ Greggs and KFC double the guilty pleasure in 'the mash-up the nation's been craving'

JUST WHEN you thought the vibrant British takeaway food scene couldn't possibly top itself, comes what food critics have dubbed the "culinary crossover of the century" in the form of a sausage roll drenched in gravy.

The idea is a collaboration between two of the most popular food purveyors eat-and-go foods in the British high street, bakery giant Greggs and American global icon KFC

The food giants have joined forces to offer a Greggs sausage roll with KFC gravy, claiming it is the "mash-up the nation's been craving" and is "seriously flavoursome".

It follows figures that revealed Britons consumed 15,000 litres of KFC gravy and more than one million Greggs sau-

sage rolls every day over the past year.

The two firms this week took the new combination on a three-day tour, handing samples out for free in London, Manchester and Newcastle.

A sharing bucket featuring six Greggs sausage rolls and a large tub of KFC gravy will also be available for £10 on August 15 and 16 through Uber Eats in London, Manchester, Newcastle and Birmingham.

KFC brand manager Phoebe Syms said: "At KFC, we bleed gravy. We go to obsessive lengths for our liquid gold, and so do our fans."

"In fact, it was them who inspired this once-in-a-lifetime event, calling for us to partner with Greggs and unite our iconic gravy with their iconic sausage rolls.

"Now we're joining forces for just a few days to give the people a taste of what they really want."

"It's time for gravy to meet pastry. You're welcome."

Fiona Mills, brand communications lead at Greggs, said: "With 96 layers of light puff pastry, perfectly baked to give that satisfying golden crisp and flaky goodness, we've always known our

sausage rolls are a true British icon. And why not pair one icon with another?"

"We can't wait to see what Greggs and KFC fans make of our latest partnership. We're sure fans of both brands will enjoy devouring their Greggs x KFC sharing bucket."

One happy Greggs customer, interviewed as he left a busy outlet in Lew-

isham, south east London, said: "A hot sausage roll may not be everyone's cup of tea on a hot summer's day," he said. "But I still get a couple of sausage rolls from Greggs every single morning... and when its gets colder outdoors and the nights draw in, there's nothing better to keep you warm. Adding gravy sounds like a match made in heaven to me."

Ozzy 'Died Of A Heart Attack'

Ozzy Osbourne died after a heart attack, his death certificate confirmed on Monday.

It also listed coronary artery disease and Parkinson's disease with autonomic dysfunction as "joint causes", and gave his occupation as a "rock legend, songwriter and performer".

The Black Sabbath singer's death at 76 on July 22 came a fortnight after his farewell gig at the Back To The Beginning show in Birmingham's Villa Park.

Ozzy was buried at his 250-acre home in Jordans, Bucks, in a private service after a funeral procession through Birmingham before crowds of fans.

Two ads featuring 'too skinny' models banned

Two advertisements from fashion giant Zara have been deemed "socially irresponsible" and banned for featuring models that appeared "unhealthily thin".

The UK's advertising regulator Advertising Standards Authority (ASA) has banned two "socially irresponsible" Zara adverts for depicting models considered "unhealthily thin". Zara confirmed that it had amended the product listings after receiving the complaint and removed the images.

The fast fashion retailer's ads, released in May, featured one model wearing an oversized white shirt with her "protruding collarbone" emphasised by the shirt's design and another model in a short white dress



whose "gaunt" appearance was accentuated by the design.

The ASA ruled that these images were irresponsible and ordered Zara not to use them again.

According to the watchdog, a shadow effect was used to make one of the model's legs appear "noticeably thin". They

added that the position of the model's upper arms and elbow joints made her body look "out of proportion".

The retailer then released a statement saying that both of the models had medical certification proving they were in good health, and that none of the images had been

modified, beyond minor lighting and colouring edits.

A Zara UK spokesman said: "We note the ASA's decision following an individual complaint regarding two images on our website which we removed when the ASA made us aware."

The statement added: "We are committed to responsible content and follow stringent guidelines and controls in the selection and photographing of models, as well as in the selection of images."

The ASA also investigated two other Zara advertisements, but neither of them ended up being banned.



Partey bailed on sex charges

Former Arsenal footballer Thomas Partey has been bailed after appearing in court accused of rape and sexual assault.

The Ghanaian midfielder, 32, (above) stood in the dock at Westminster Magistrates' Court on Monday.

He has been charged with five counts of rape against two women and sexual assault against a third woman.

The alleged offences took place between 2021 and 2022 while he was an Arsenal player.

His bail conditions include that he cannot contact the women and must notify police of any international travel or permanent changes of address. He is due to appear at the Old Bailey on September 2.

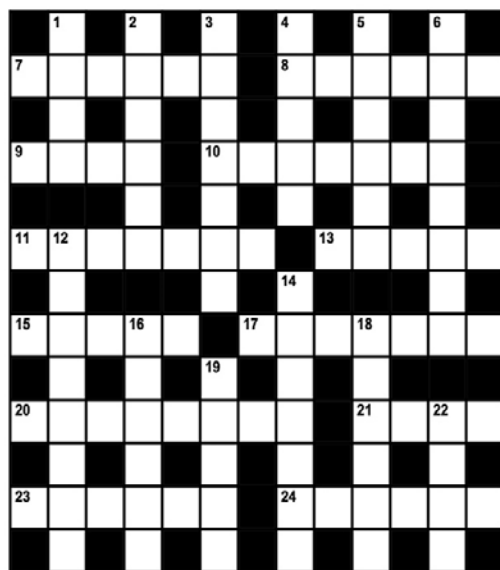
Partey's lawyer Jenny Wiltshire previously said he denies all the charges against him and he welcomed "the opportunity to finally clear his name".

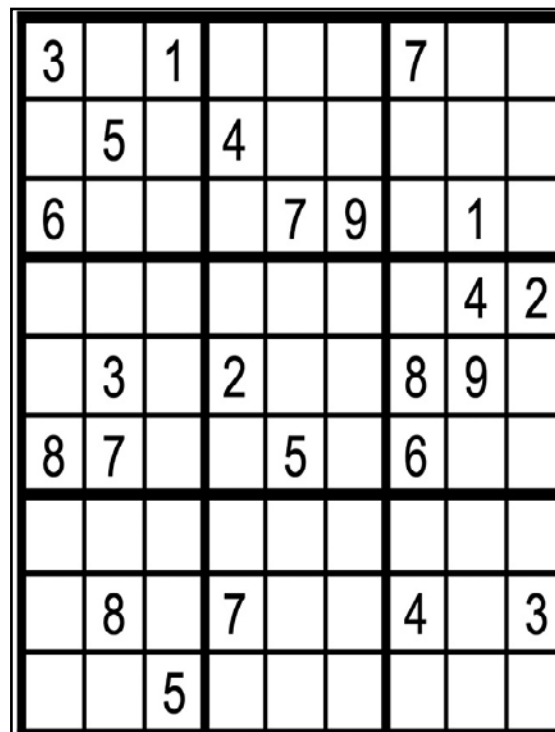

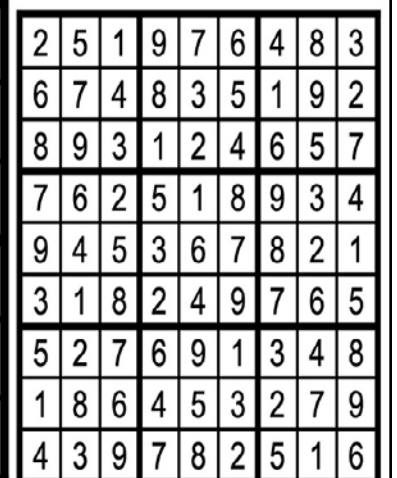

Seoul as part of their pre-season preparations, where Son made his farewell in a friendly against Newcastle. He departed the field when substituted to a standing ovation from around the ground and an impromptu guard of honor from both teams.

Frank, who replaced Ange Postecoglou as head coach in June, described Son as "a true Spurs legend" and "one of the greatest players to play in the Premier League".

Tottenham face Paris St-Germain in the Uefa Super Cup on 13 August and will have to do so without Son, although they will have new loan signing Paulinha available.

Son made his Tottenham debut in September 2015 and went on to make 333 Premier League appearances.

He scored 127 times in the league - level with former Chelsea striker Jimmy Floyd Hasselbaink at 16th in the league's all-time scorers list, above the likes of Dwight Yorke, Steven Gerrard and Ian Wright.

Son formed a memorable attacking partnership with Harry Kane, now at Bayern Munich, and the pair hold the record for the most goal combinations in the Premier League.

The pair registered a record 47 combinations, Son scoring 24 goals to Kane's 23. In a prolific two-season period - 2020-21 and 2021-22 - they linked up 21 times for goals.

Son became the first Asian player to win the Premier League golden boot, sharing the title with Liverpool's Mohamed Salah with 23 goals in the 2021-22 season, and a year later was the first from the continent to reach 100 Premier League goals.

India win nailbiting Fifth Test as classic series ends all square

India won by six runs; draw series 2-2*

England were denied a record-breaking run chase by an irresistible India on Monday, who snatched victory by six runs in one of the most dramatic conclusions in Test cricket history.

The drama provided a fitting finale to one of the great Test series in recent memory, a titanic clash between two finely matched teams which before inevitably ending in nail-biting fashion. In the end, a drawn series was probably the fairest result.

In scenes that will go down in British sporting folklore, Chris Woakes came out to bat at a packed Oval with his arm in a sling to support Gus Atkinson when England needed 17 to reach their target of 374.

Woakes was given a hero's welcome, then stood at the non-striker's end as Atkinson attempted to swipe England to victory.

Amid almost unbearable tension, Atkinson and Woakes somehow tried to inch England on, surrounded by the deafening din of the febrile Indian support.

After Atkinson clobbered Mohammed Siraj for six, Woakes ran a bye to wicketkeeper Dhruv Jurel, who missed the stumps, in order for Atkinson to pinch the strike.

India kept the field back. Prasidh Krishna bowled the next over. Woakes was able to run a two, then another vital single off the final ball to leave Atkinson with the strike.

But Atkinson was

bowled by the brilliant Siraj, giving India their narrowest victory in terms of runs in a Test.

It left one of the greatest series ever played level at 2-2, concluding 25 days of outstanding sporting theatre.

At the end of a fractious series, India broke off from the delirious celebrations to commiserate with Woakes, then embarked on a lap of honour, soaking up a historic win with their jubilant fans.

If the fourth day of this Test was astonishing for its fluctuations and high emotion, the fifth day provided drama that was barely believable.

England's target of 374 represented their second highest successful chase in Tests and the highest ever on this ground. They began Monday on 339-6, 35 adrift.

Jamie Smith and Jamie Overton were being given a torrid time on Sunday before the weather ended play early. England's task instantly looked easier on Monday when Overton pulled Krishna's first ball of the day for four and followed by inside-edging the next delivery past his stumps to the fine-leg fence.

The runs required were down to 27, then the pendulum swung once more.

Smith looked all at sea. He played and missed at his first two balls from Siraj and edged his third. There was a wait to see if Jurel had pouched the catch, but there was no doubt.

And then Siraj dismissed Overton, and two runs later Tongue was bowled by Krishna. There was confusion as to whether Woakes would bat, then came the sight of the 36-year-old walking down the dressing-room stairs with his left arm covered by his England sweater.

Woakes ultimately never faced a ball, but his bravery will not be forgot-

ten.

England were without injured captain Stokes, then had to deal with the injury sustained by Woakes on day one. The home side had a patched up pace attack and first-choice spinner Shoab Bashir is out with a broken finger.

The battered bodies reflects the gruelling nature of a gripping series, arguably the best to take place in Britain since the iconic 2005 Ashes.

By the end, England missed out on a first series win against India since 2018 and their first win against any team in a five-Test series in the same time period.

Huge price tag? I'm Wirtz it!

■ Liverpool's £100m+ star unfazed by transfer fee

FLORIAN WIRTZ says his huge price tag "doesn't matter" as he plans to take the Premier League by storm.

Champions Liverpool shelled out an initial £100million to take Wirtz from Bayer Leverkusen this summer and, should all add-on clauses be met, that will rise to £116m.

That would eclipse the British transfer record of £115m that Chelsea paid to take Moises Caicedo from Brighton in 2023.

Pressed on his club-record fee, Wirtz said: "I don't think about this. I just want to play football and how much money the clubs pay between each other doesn't matter."

Liverpool also remain in the hunt for Newcastle's Alexander Isak in a deal that could top

Wirtz's fee.

The Germany star cannot wait for his first experience of the Premier League, with the title holders kicking off the season at home to Bournemouth a week on Friday after they have contested Sunday's Community Shield against Crystal Palace.

Wirtz said: "I'm really looking forward to playing in England.

"There are some differences to the German league, but there are also some things I can learn and that can make me better. My team-mates say it's more intense, more physical. Every player is really strong, fast, but I'm aware of it."

Meanwhile, Liverpool have sold Tyler Morton, 22, to Lyon for £15m. The England Under-21 mid-

fielder came through the academy but has been angling for a move in search of action. Last season, Morton made only five appearances for the Reds, with none of those in the Premier League.

Liverpool have a 20 percent sell-on clause in the deal.

Manchester United's agreement to sign RB Leipzig striker Benjamin Sesko for £74m will take their summer spending on their forward line past £200m, but now the question is 'who is going to play in midfield?'

Head coach Ruben Amorim was determined to massively increase his side's goal output having scored just 44 times in the league last season, their worst return since being relegated in 1973-

The South Korea forward joined Spurs from Bayer Leverkusen in 2015 and has scored 173

goals in 454 appearances.

He was captain when Tottenham beat Manchester United in the Europa League final in May to clinch their first trophy in 17 years.

The 33-year-old described the decision as "the most difficult one I have made in my career" as he spoke to media

alongside new manager Thomas Frank.

"I came to north London as a kid - a very young age, a young boy came to London who even didn't speak English," Son said.

"Leaving this club as a grown man is a very, very proud moment."
