# Migrant numbers top 50,000 under Labour

■ Unwanted milestone is latest blow for embattled Prime Minister

The number of migrants to cross the English Channel in small boats since Labour came to power last summer has surpassed 50,000.

Home Office data shows 50,271 people have made the journey, after 474 migrants arrived on Monday.

Education Secretary Bridget Phillipson said the government "will turn this around", adding she appreciates "the frustrations that people feel".

At the general election, Labour pledged to "smash" people-smuggling gangs and reduce Channel crossing numbers. Conservative leader Kemi Badenoch said Tuesday's figure showed that plan "was just a slogan".

Separately, French authorities confirmed a woman died on Monday while trying to board a boat to make the crossing to the UK.

The woman is believed to have been in her 30s and died on Malo beach in Dunkirk, according to the Utopia 56 organisation, which supports displaced migrants at the French border.

Local media report the incident happened at around 4am on Monday morning and French authorities said she died despite resuscitation efforts from emergency services at the scene on the French coast.

## 13,000 higher

According to the International Organization for Migration (IOM), a UN agency, at least 20 people have died this year attempting to cross the Channel. Its figures in-

clude people who were travelling to a crossing point and died in other circumstances, such as car crashes or because of medical issues.

The Home Office said it was aware of the incident but would not be commenting further.

Figures released on Tuesday confirmed that the number of small boat crossings from the date that Labour came to power on 5 July last year had passed 50,000 by Monday, 11 August.

This is more than 13,000 higher than for the same period a year ear-

lier - as between 5 July 2023 and 11 August 2024 there were 36,346 migrant crossings in small boats.

This is not the first time 50,000 people have crossed the Channel during a 403-day period.

Between 8 October 2021 and 14 November 2022, under the previous Conservative government, there were 53,587 arrivals by small boat.

More migrants crossed the Channel between January and August 2025 than in the same period last year.

Government sources say there were an unusu-

ally high number of days with calm and warm weather at the start of this year, which partially contributed to the high number of crossings.

Politically the 50,000 milestone is deeply uncomfortable for the government, given its promise to smash the gangs that drive the small boat crossings - a key pledge of Sir Keir Starmer's when he became prime minister.

While on a visit to Derby, Phillipson told reporters the government had "inherited an enormous challenge" when it

comes to border control.

"We will turn this around with the extra measures that we're putting in place," she said.

The government has pointed to its "one in, one out" returns deal with France as a deterrent.

The pilot will see the UK return some migrants to France in exchange for receiving the same number of asylum seekers who are believed to have legitimate claims.

The first returns are due to happen within weeks - but the initial numbers are expected to be small.

# 474 arrested at Palestine Action demo

■ Home Secretary defends action, insisting: "Many people may not yet know the reality of this organization but the assessments are very clear - this is not a non-violent organisation"

Police have arrested 474 people at a demonstration in London in support of banned group Palestine Action.

The Metropolitan Police said 466 protesters were arrested for supporting the group, five for assaults on police officers, two for public order offences, and one for a racially aggravated offence.

Scores of people simultaneously unveiled handwritten signs with the message "I oppose genocide. I support Palestine Action" at the protest, organised by Defend Our Juries at Westminster's Parliament Square.

It was the biggest protest since the government proscribed the group in July under the Terrorism Act of 2000, making membership of or support for it a criminal offence, punishable by up to 14 years in prison.

## 'deeply concerning'

No officers were seriously injured, and the Met Police said the number of arrests was the largest made by the force on a single day in the last 10 years.

Home Secretary Yvette Cooper thanked police for their response, while charity Amnesty International

described the mass arrests as "deeply concerning".

Footage from the square showed officers moving among the protesters, who were mainly seated on the ground, and speaking to them before leading them away.

Protesters whose details could be confirmed at temporary prisoner processing points nearby were bailed with conditions to return to a police station at a future date and to not attend any further protests in support of Palestine Action.

People who refused to give their details or whose identities could not be verified were taken into custody.

## 'opposite of democracy'

Many of the protesters didn't want to speak to media who came to cover the protest, but one - who didn't give her name - told reporters: "If they ban Palestine Action, what other group is next? Until we're just no longer allowed to protest anything. That's the opposite of democracy."

Another, Claudia Penna-Rojas, 27, said: "I don't think anyone wants to get arrested, but I'm more concerned with what is happening to people in

Palestine right now, and I refuse to be a bystander."

Jacob Ecclestone, 86, said: "I believe in freedom of speech. What this government is trying to do is deeply authoritarian. And it's extremely dangerous."

Earlier, the Met Police had said about 500 to 600 people were in Parliament Square when the protest began, but that "many were onlookers, media or people not holding placards in support of Palestine Action".

At 13:00, when Big Ben chimed, hundreds of people sat on the square pulled out their placards, at which point the police started making multiple arrests at a time, work-

ing their way through the crowds.

Protesters patiently waited their turns. Some chose to walk out quietly. Those who refused to move, lying on the ground, were carried out by police to chants of "shame on you" directed at the officers.

The protest came just days after the first three people to be charged with supporting the group in England and Wales were named.

## 'disproportionate'

Yvette Cooper thanked police for their work handling Palestine rights protests across the UK on Saturday, saying there had been a "very small number of people whose actions crossed the line into criminality".

She defended the banning of Palestine Action, which she said was based on "strong security advice following serious attacks the group has committed" as well as "plans and ideas for further attacks, the details of which cannot yet be publicly reported due to ongoing legal proceedings".

"Many people may not yet know the reality of this organization, but the assessments are very clear - this is not a non-violent organisation. UK national securi-

ty and public safety must always be our top priority."

Shadow home secretary Chris Philp said protesters supporting Palestine Action "should feel the full force of the law".

But the chief executive of Amnesty International, Sacha Deshmukh, said people outraged by the "ongoing genocide" in Gaza were "entitled under international human rights law to express their horror".

"The protesters in Parliament Square were not inciting violence and it is entirely disproportionate to the point of absurdity to be treating them as terrorists," he said.

"We have long criticised UK terrorism law for being excessively broad and vaguely worded and a threat to freedom of expression. These arrests demonstrate that our concerns were justified."

The event's organizers, a civil rights group called Defend Our Juries, said the turnout "shows how repulsed and ashamed people are about our government's ongoing complicity in a livestreamed genocide".

It added that "Palestine Action and people holding cardboard signs present no danger to the public at large".

## TikTok bans a migrant's primer on how to cross the Channel

A migrant who shared videos on TikTok of how to cross the English Channel on a small boat, and encouraged others to make the crossing, has had his account removed.

Using the handle @alexandrah4200, the man gained hundreds of thousands of views on his videos, which included a live-stream from what he said was a UK asylum hotel, answering questions about his voyage.

TikTok removed his account after being asked about it by the Sun newspaper, which originally reported the story.

The social media giant said in a statement it took a "zero-tolerance approach to content promoting human smuggling".

It said that it removed the "vast majority" of such content before it was reported and that it was working with the National Crime Agency (NCA) "to identify and disrupt organised immigration crime online".

In the first of several videos, the man - who is thought to have arrived in the UK over the weekend - can be seen in an orange life jacket sitting in a dinghy in the middle of a body of water.

Later, he is seen giving viewers a look at his room in an asylum hotel in London.

In his streams the man reportedly advised others to make the dangerous crossing to the UK.

A Home Office spokesperson said: "We have made clear that it is unacceptable for any individual, whether they are a member of a smuggling gang or otherwise, to promote the criminal services of people-traffickers or for social media companies to allow it."

# Tributes flow for 'true force of nature' Biddy Baxter

■ Long-serving but feared Blue Peter producer hailed as 'remarkable woman' who 'leaves a lasting legacy'

**Long-serving Blue Peter editor Biddy Baxter, who turned the children's show into a television institution, has died at the age of 92.**

During her tenure, which lasted from 1965 to 1988, she introduced generations of children to the pleasures of sticky-backed plastic, on-screen pets, presenters' adventures and charity appeals - a recipe that stood the test of time.

She was also passionate about getting her viewers involved in the programme, long before audience participation became an industry mantra.

But she also gained a reputation as a formidable figure - a tyrant who fell out with presenters and jealously guarded the Blue Peter brand.

Peter Duncan, who was among the show's presenters in the 1980s, told BBC Breakfast she was "a wonderful, inspiring person" and "a true force of nature".

## 'powerhouse'

"She was a true enthusiast and a supporter of young people," he said.

The presenters could get "a right old telling off" if they messed up, but "I loved working with that kind of energy and that kind of expectation", Duncan said.

"She was truly a one-off within the BBC. If something upset her, she would trail off to see the DG (director general) and tell him what she thought. We need people like that now more than ever."

Peter Purves, who starred on the show in the 1960s and 70s, described Baxter as "an absolute powerhouse".

"She controlled everything about the programme, and with quite a rigid hand," he told BBC Breakfast.

"We didn't always get

on because of that, but she knew exactly what she wanted the programme to be, and it was a success absolutely because of her. She was a remarkable woman."

The BBC's chief content officer, Kate Phillips, paid tribute to Baxter as "a truly inspirational television producer who transformed children's broadcasting through her passion and commitment".

## make do and mend

"I was fortunate enough to work with Biddy, she was fabulous, formidable, and visionary, ensuring that children's thoughts, interests and ideas were at the very heart of Blue Peter," she said. "She enriched the lives of millions across the country and leaves an enduring legacy."

Joan Maureen Baxter was born in Leicester in May 1933. There were too many Joans in her class at school, so a nickname was made up on the spot.

Her upbringing during World War Two instilled in Biddy an ability to make do and mend, which later became part of the Blue Peter ethos.

She was educated at a local grammar school before going to St Mary's College, Durham University in 1952. At that time,

only 6% of undergraduates were women.

She joined the corporation in 1955 as a radio trainee studio manager, creating sound effects and seven years later was asked to take over as producer of Blue Peter, a programme whose life expectancy was thought to be short.

Conceived as something for children who had outgrown Watch with Mother, its survival was resting on the fact it was cheap to make.

The programmes, which lasted 15 minutes, were presented by Christopher Trace and a former Miss Great Britain, Leila Williams.

## whirlwind

Williams was fired just before Baxter joined the programme, and a new presenter, Valerie Singleton, was recruited to work with Trace.

Baxter tore into the programme like a whirlwind. Within a year she had introduced the iconic Blue Peter badge after commissioning a young artist called Tony Hart to design the ship logo.

She also decided to recruit a dog, so viewers who did not have a pet could share in a sense of ownership.

Baxter was appointed the programme's editor

in 1965 and the transformation of Blue Peter continued.

Location filming was introduced, more pets appeared, and appeals were launched to collect old toys and silver paper for good causes.

It was early example of recycling and designed so that even the poorest viewers could take part.

Baxter's stroke of genius was to tap the resources of her viewers by asking them to contribute ideas for things they wanted to see in the pro-

gramme.

The letters poured in, and Baxter set up a complicated card index system so children would get personal replies rather than a formatted letter.

"We could check the index and reply, 'Last time you wrote, your hamster had a sore paw. I do hope it's better.' It's only a tiny thing, but children aren't stupid."

One former producer was once asked whether there was a hierarchy. "Yes," he replied. "There was Biddy at the top and

everyone else at the bottom."

Baxter herself said she "never thought of me as being the slightest bit frightening".

But the "golden rule" was that the audience came first, she said. "We had to all give it our best possible shots and you never do get perfection. You never come to the end of a programme and think, gosh that was good. Always, always, something goes wrong, but it doesn't mean you should stop trying."

## RIP Stephanie Shirley: pioneering female business leader who came to Britain as child refugee from Nazism

**TRIBUTES** flowed this week for the pioneering women's business leader Stephanie 'Steve' Shirley, (right) who transformed herself from a child refugee from Nazism into a business leader who empowered generations of business women.

Competing in the overwhelmingly male-dominated fledgling computer industry in the 1960s,

she founded a company that pioneered outsourcing and opportunities for women, and reached a shareholder value of \$3bn. Believing that "money that isn't working has a kind of obscenity about it", she became one of Britain's foremost philanthropists, supporting research and practice in the care of children with autism.

A natural gift for math-

ematics led Shirley to a career in computing, when engineers and systems designers were first establishing that industry in the 1950s. At the time, women often had difficulty keeping their positions in the workplace after they married, and especially after they had children. Shirley married in 1959, and in 1962 she set up her own company, Freelance

Programmers, to provide outsourced software development.

With only £6 of capital, she started the business from her kitchen table. She decided to recruit women such as herself, experienced and professionally qualified but spending their time at home with domestic responsibilities.

All they needed was a telephone, and a pencil and paper to draw flowcharts and write code. At first Shirley had an uphill struggle to win clients, but after she took to signing her letters of introduction as Steve instead of Stephanie, the work began to flow in.

## flexible working

Major clients included the Anglo-French partnership that developed the supersonic Concorde airliner, for which Shirley's cottage industry workers programmed the black box flight recorder.

The company pioneered flexible working, all designed to suit the needs of female employees. In 1974 Shirley rebranded the company as F International (later the FI Group; it eventually became Xansa), the F not only for freelance, but for also flexible and free. Of its first 300 employees, only three were men; but after the introduction of the Sex Discrimination Act in 1975, she recruited men and women equally.

Although Shirley stepped down as chief executive in 1987, she remained the major shareholder until 1991. At that point she sold a controlling interest in the company to the staff: her proud claim was that she had made 70 of them into millionaires. With the flotation of the company in 1996, she too became personally wealthy, able to build up a substantial personal art collection – which she later gave away to charities.

## 146 now claim to have been abused by Al Fayed

The Metropolitan Police says 146 people have now come forward to report a crime in their investigation into former Harrods boss Mohammed Al Fayed.

In a video update sent to victims on Monday, Scotland Yard said women and men had reported crimes, and a number of new witnesses had also contacted the force to give evidence.

The Met is currently conducting an investigation into how it handled historical allegations, including sexual assault and rape, perpetrated by Al Fayed - who died in 2023 aged 94.

It is also looking into whether there may have been others who could face charges for enabling or assisting his behaviour. The force has previously said it was investigating at least five people.

In the update, Detective Inspector Karen Khan said the Met was working with international agen-

cies, including foreign police forces.

She said it was "difficult" to say when the investigation might be concluded because of the sheer number of survivors who had come forward.

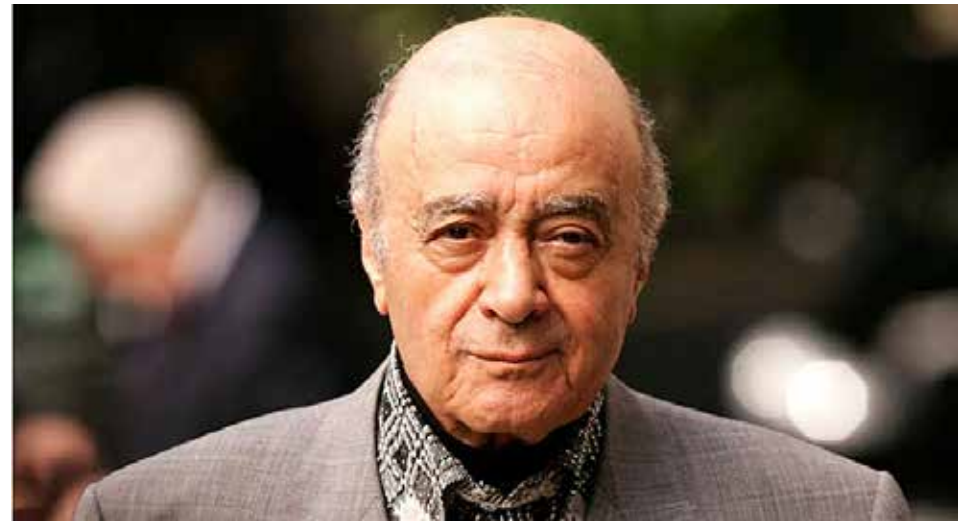
## 'truly sorry'

She also asked for victims and witnesses to continue to come forward but acknowledged there was a "reluctance" to trust the police by some.

Last month, the force wrote to alleged victims apologising, saying it was "truly sorry" for the distress they have suffered because Al Fayed will never face justice.

In a further update on Wednesday, the Met said the way the force "works has moved on immeasurably, and our teams have transformed the way we investigate rape and sexual offences".

"We're working with partners across the criminal justice system to ensure that victim-sur-

vivors are at the heart of our response, with a greater focus on suspects and their offending," a spokesperson added.

"We continue to support all victims and we urge anyone with information, whether they were directly affected by Mohamed Al Fayed's actions or aware of others who may have been involved, or committed offences to come forward."

The latest figure of 146 is more than double the

61 people who the Met said had reported allegations the last time it released a number in October.

Harrods said more than 100 victims of Al Fayed's abuse had entered its compensation scheme in July. Al Fayed owned the luxury department store between 1985 and 2010.

The store started issuing compensation at the end of April and the scheme remains open for new applications until 31

March 2026.

Eligible applicants could receive up to £385,000 in compensation, plus treatment costs, if they agree to be assessed by a consultant psychiatrist, or up to £150,000 without a medical assessment, Harrods said in March.

They are also offered a meeting with a senior Harrods' representative to receive an apology in person or by video, as well as a written apology.

## US woman in niqab guilty in botched murder plot

■ Wisconsin woman with no police record joins Birmingham family vendetta orchestrated by UK lover

A US woman who was hired as a killer and tried to shoot a man in the UK at point-blank range has been found guilty of conspiracy to murder.

Would-be assassin Aimee Betro, from West Allis in Wisconsin, flew into the country as part of a plot to attack a British family in Birmingham in 2019, before going on the run for nearly five years.

Her co-conspirators had been involved in a feud with the family, her trial heard.

During the case at Birmingham Crown Court, jurors were told Betro hid her identity using a niqab when she tried to fire shots at her target, but her gun jammed and the individual at whom she had aimed fled the scene unharmed.

Jurors deliberated for almost 21 hours before con-

victing Betro of conspiracy to murder, possessing a self-loading pistol with intent to cause fear of violence, and illegally importing ammunition.

## revenge

During the trial, they heard the defendant had been involved in a conspiracy with two men - Mohammed Nazir and Mohammed Aslam - as part of their vendetta against Birmingham businessman Aslat Mahumad.

Prosecutors said revenge was the men's motive after Nazir and Aslam were injured during disorder at Mr Mahumad's clothing boutique in July 2018.

A plot was hatched, the court heard, to have someone kill Mr Mahumad or a member of his family. That person was Betro.

But despite the events

in which she was a key player, detectives have suggested records point to Betro having virtually no criminal past prior to the murder plot.

She nevertheless produced a gun on a September night six years ago, with Mr Mahumad's son,

Sikander Ali, the one to face the barrel after she lay in wait outside their

family home.

Her convictions came after Nazir, 31, and his father Aslam, 59, both from Derby, were jailed last year having been convicted of conspiracy to murder.

Before the attempted shooting, Betro met up with Nazir, whom she had initially met on an online dating site some time earlier, police said.

Hannah Sidaway, from the Crown Prosecution Service in the West Midlands, said it was "sheer luck" that Mr Ali escaped unscathed.

Ms Sidaway said "only Betro" knew what drove her "or what she sought to gain from becoming embroiled in a crime that meant she travelled hundreds of miles from Wisconsin to Birmingham".

As the jury returned its verdicts, Betro, wearing a purple T-shirt and her hair in space buns, showed no obvious reaction and stared towards jurors.

She was found guilty by a majority 11-1 verdict on the conspiracy to murder and firearm charges, and by a unanimous verdict on the ammunition charge. She is due to be sentenced on 21 August.

# Shopkeeper who described shoplifters as 'scumbags' remains defiant despite receiving caution from local police

■ Wrexham man says he has received a positive reaction" and "huge amount of support" from locals over his blunt sign

A shopkeeper will not remove signs referring to "scum bag shoplifters" despite suggestions they "could be seen as provocative and offensive", he said.

Rob Davies placed notices in his Run Ragged vintage shop in Wrexham, informing customers "due to scumbags shoplifting, please ask for assistance to open cabinets".

Mr Davies, who has run the store for five years, said he has lost almost £200 worth of stock due to shoplifting and decided to lock cabinets containing higher valued items.

Official figures released in July show

shoplifting in Wales and England is at its highest level since current records began more than two decades ago.

But despite what he described as a "positive reaction" and "huge amount of support" from locals, he says a police officer visited having been prompted by a member of the public claiming that the sign was "provocative and offensive".

North Wales Police, however, said it did not appear Mr Davies had committed any offence.

"It would be up to the shop owner to decide whether he displayed such a sign in his store," the force said.

"We will contact the owner to identify which officer it was who spoke to him, and to ensure that any incidents of retail crime at his store are reported to officers at the earliest opportunity, to enable us to effectively respond to any offences."

Mr Davies, 61, said he had made a "difficult decision" to lock his cabinets.

"I had to start guarding myself and my livelihood so I put a little note on there and spent a couple of days thinking how I can word this so that nobody in this world is offended by it," he said.

"I came up with 'due to scumbags shoplifting,

please ask to access the cabinets' and I was even polite enough to put thank you at the end of it because I don't want to offend anybody.

"If you identify with being a scumbag and are offended by this then you're obviously looking to steal.. otherwise you wouldn't be offended by that."



## Foreign Secretary turns himself in over fishing jolly with JD Vance

Foreign Secretary David Lammy has reported himself to the Environment Agency for going fishing with JD Vance without a rod licence. He blamed the oversight on an "administrative error".

The agency says anglers in England and Wales aged 13 or over must have a rod fishing licence to fish for freshwater species

and can be fined if they do not have one.

The foreign secretary did not catch any fish when he went angling with the US vice-president at his official residence at Chevening House, Kent, last week.

The two men went carp fishing in a pond near the 17th-century house before they held talks about Gaza and other in-

ternational affairs at the residence during Vance's family holiday to the UK.

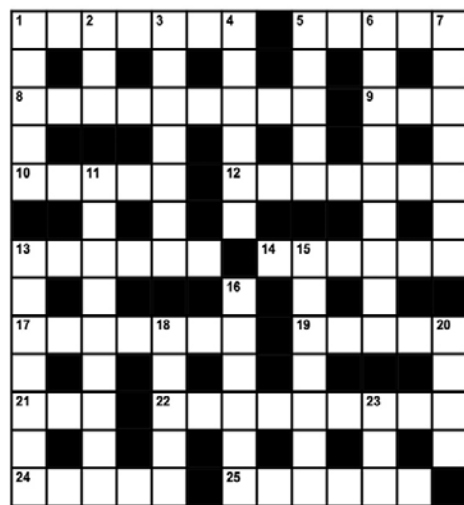
At the start of their meeting, the vice-president said: "Unfortunately, the one strain on the special relationship is that all of my kids caught fish, but the foreign secretary did not."

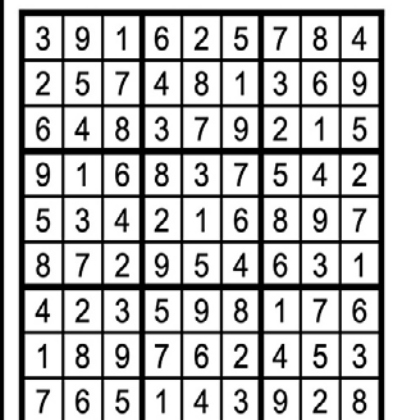

## Roma seek cut price deal for misfit Sancho

Roma have made a £20m offer to sign England winger Jadon Sancho from Manchester United, where he remains excluded from training with the first-team squad.

Juventus, who unlike Roma have qualified for this season's Champions League, are also known to be interested in Sancho.

The former Borussia Dortmund wide man returned to United in the summer after Chelsea paid a £5m penalty to get out of an obligation to buy him, having spent last season on loan at Stamford Bridge.

United are determined to sell Sancho.

However, the closer to September they get without a deal in place, the more likely they are to consider a potential loan move, given it would at least take a significant sum off their wage bill.

## Community joy for Palace

Crystal Palace started the new season with a suddenly familiar feeling, basking in trophy glory as triumphant underdogs at Wembley.

The FA Cup holders beat Premier League champions Liverpool 3-2 on penalties after a 2-2 draw to win an enthralling Community Shield on Sunday.

Goalkeeper Dean Henderson was the shootout hero for Palace as he saved from Alexis Mac Allister and Harvey Elliott, while Mohamed Salah sent his kick over the bar.

It allowed 21-year-old midfielder Justin Devenny, sent on as a stoppage-time substitute, to smash the winning penalty past Alisson.

Palace, who had not won a major trophy in their history until this year, have now earned two in three months at Wembley, having snatched the first at Manchester City's expense.

Four of Liverpool's five major summer signings

started, and two of those players combined to brilliant effect in the early moments at sun-drenched Wembley.

Florian Wirtz, Liverpool's £116m record signing, fed Hugo Ekitike on the edge of the box and the French striker turned and struck a low right-foot shot into the far bottom right corner, beyond the diving Henderson.

Palace were undaunted and deservedly equalised 13 minutes later when Jean-Philippe Mateta slotted in from the spot after Virgil van Dijk fouled Ismaila Sarr. But soon after, yet another Liverpool newcomer stepped up as right-back Jeremie Frimpong jinked into the Palace box and chipped what looked like a cross over Henderson, the ball hitting the far post and bouncing in.

Palace equalized when Ismaila Sarr was played outside by Frimpong and finished clinically in off the post.

# To be Frank, it all goes Spursy

**UEFA SUPER CUP: North London side throw away two goal lead and lose on penalties but new boss still sees much to like**

European champions Paris St-Germain produced a superb late recovery before winning a penalty shootout to clinch the Uefa Super Cup and deny Thomas Frank a first trophy as Tottenham boss.

Spurs led 2-0 after 84 minutes and were then seconds away from clinching an impressive victory Wednesday night before PSG substitute Goncalo Ramos headed in a 94th-minute equaliser.

That took the tie straight to penalties and PSG missed their opening effort as Vitorino Pereira fired wide, but Micky van de Ven, who had scored Tottenham's first goal earlier on, had his spot-kick saved by Lucas Cheva-

lier.

Mathys Tel shot wide for Frank's side before Nuno Mendes held his nerve to convert the winning penalty for PSG.

It meant Tottenham missed out on winning a second European trophy in three months.

Frank was taking charge of Tottenham in a competitive match for the first time since he replaced Ange Postecoglou, who was sacked 16 days after guiding the club to a 1-0 victory over Manchester United in the Europa League final in May.

Van de Ven put Tottenham ahead in Udine, Italy, reacting first to slide in the rebound after Chevalier had tipped Joao Palhinha's effort on to the crossbar just before half-

time.

Chevalier - expected to be PSG's regular goalkeeper this season after Gianluigi Donnarumma was surprisingly left out of their squad - was beaten again early in the second half when he got two hands to Cristian Romero's header following Pedro Porro's free-kick but could not keep the ball out of the net.

But PSG, who only returned to training a week ago after losing to Chelsea in the final of the Club World Cup in the United States in July, fought back in style.

Lee Kang-in started the recovery with an excellent strike from 20 yards, before Ramos dramatically took the tie to a shootout with PSG triumphing.

Before the match, PSG captain Marquinhos walked on to the pitch holding the Champions League trophy, while Romero, announced as Spurs' new captain earlier on Wednesday fol-

lowing the transfer of Son Heung-min to American side Los Angeles FC, held the Europa League trophy.

But by the end of the night in Italy, Marquinhos was lifting the Super

Cup aloft as PSG won this competition for the first time in their history.

However, Spurs will be left wondering how they missed out on what would have been their fifth European trophy.

## Toon close in on £40m Ramsey deal

last season.

Newcastle have also signed winger Anthony Elanga from Nottingham Forest and AC Milan defender Malick Thiaw on permanent deals this summer.

England goalkeeper Aaron Ramsdale, meanwhile, joined the Magpies from Southampton on a season-long loan earlier this month.
