RIP TERENCE STAMP

■ 1960s icon, best known for his comeback in Superman, dead at 87

Terence Stamp, the English actor who shot to fame in the early 1960s and whose career then languished before his comeback playing the arch-villain General Zod in the original Superman films, has died at the age of 87.

In a career that spanned six decades, the Oscar-nominated actor starred in films including *The Adventures of Priscilla, Queen of the Desert*, *Far From the Madding Crowd* and *Valkyrie*.

Stamp died on Sunday morning, his family said in a statement to Reuters news agency.

"He leaves behind an extraordinary body of work, both as an actor and a writer that will continue to touch people for years to come," they said.

'beyond gorgeous'

Bafta said it was "saddened" to hear of Stamp's death and highlighted his two Bafta nominations in 1963 and 1995.

His Superman co-star Sarah Douglas described him as "beyond gorgeous and talented".

"So saddened to learn that Terence has left us," she wrote on Instagram.

"I learnt so very much from him. What a start to my career to have spent so many months in his company.

"My love and heartfelt condolences to all who cared for him. What a loss."

Born in Stepney, east London, to working-class

parents on 22 July 1938 Stamp attended Plaistow grammar school before working in several advertising agencies in London, all the time wanting to be an actor. But, as he recalled: "It wasn't until I saw James Dean in *East of Eden* that I began to think that maybe I could actually do this." He then applied for and won a scholarship to the Webber-Douglas Academy of Dramatic Art in South Kensington.

He had a spell as assistant stage manager, then actor, with a repertory company in Devon, before making his London stage debut in *A Trip to the Castle* at the Arts Theatre, in 1960. However, more important, in the same year, was the four-month tour in Willis Hall's second world war army drama *The Long and the Short and the Tall*, in which the 21-year-old Stamp played Private Sammy Whitaker, the callow wireless operator, with 27-year-old Michael Caine as the rebellious private "Bammo" Bamforth. The two Londoners struck up a friendship and moved together into a flat.

He was fortunate

that his career began at the time when it helped an actor to have working-class origins. Following Caine, Albert Finney and Tom Courtenay, the cockney Stamp was catapulted into stardom shortly thereafter, making his debut playing the titular role in *Billy Budd*, a 1962 film about a naive young seaman in the 18th century.

high profile girlfriends

His performance earned him an Oscar nomination for best supporting actor and a Golden Globe for best newcomer.

He was an in-demand actor much of that decade, most notably playing kidnapper Freddie Clegg in *The Collector*, and Sergeant Troy in *Far From the Madding Crowd*.

During his Swinging London heyday, Stamp was known for his good looks, fashion sense and high-profile girlfriends, including actress Julie Christie - who he later starred alongside in *Far From the Madding Crowd* - and supermodel Jean Shrimpton.

His relationship with Christie only lasted a year but was immortalized

by the Kinks in the song *Waterloo Sunset* with the line "Terry meets Julie", believed to reference the

pair. Stamp was approached to replace Sean Connery when he relin-

Epping revolt over migrant hotels could lead to flood of similar actions

■ Government forced to consider camps instead after Essex town wins key victory against mandated hotel housing for asylum seekers

THE GOVERNMENT is bracing for a flurry of lawsuits from local authorities opposed to migrant housing schemes following a landmark legal victory from the Essex town of Epping.

Epping council was granted a temporary High Court injunction on Tuesday blocking migrants from being placed at The Bell Hotel which is owned by Somani Hotels Limited.

Thousands of people have protested near the hotel in recent weeks after an asylum seeker living there was charged with sexually assaulting a 14-year-old girl in the town.

Mr Justice Eyre made his judgement after refusing an 11th-hour effort from Home Secretary Yvette Cooper to get the council's case dismissed.

'intolerable strain'

Asylum seekers must be moved out of the hotel by 16:00 BST on 12 September, the judge ruled.

All 80 rooms at the hotel are seemingly occupied and, as of last month, it was home to about 140 men.

The Home Office had warned the decision would "substantially impact" its ability to house asylum seekers in hotels across the UK.

Protests staged outside The Bell Hotel have been attended by both people against its use for asylum seekers and those in support of migrant rights.

But Conservative council leader Chris Whitbread said the repeated demonstrations were escalating tensions in the area and risked causing "irreparable harm".

Reacting to the court ruling, he added: "The last few weeks have placed an intolerable strain on our community but today we have some great news.

"We have seen the protests that started off quite violently become peaceful protests, run by the people of Epping Forest.

"What I call upon the residents tonight is if they decide to go outside The Bell Hotel, don't protest, don't over-celebrate. This is the beginning. It is not the end."

Both the Reform and Conservative parties see the immigration as a key issue to bleed support

away from the Labour government, with both Tory leader Kemi Badenoch and Reform leader Nigel Farage immediately weighing in on the court's decision.

Ms Badenoch has already written to authorities nationwide urging them to explore planning laws and apply for injunctions to close asylum hotels.

'harsher' environment

And Shadow Justice Secretary Robert Jenrick called for barristers to "join the fight" in a new movement called "Lawyers for Borders" to work with "patriotic" councils and communities calling for an end to the policy, which is costing £5.77million a day

Home Secretary Yvette Cooper is now facing growing pressure to abandon hotel housing for migrants altogether, and to instead expand migrant camps in disused military bases and other unused public land sites. Furthermore one Tory MP claimed that a 'harsher' environment would help reduce the numbers crossing the English Channel in

small boats. Out-of-town camps for processing asylum seekers are used in several European countries including Germany.

Mrs Badenoch said: "In the case of Epping, this challenge was brought under the Town and Country Planning Act 1990.

"I am encouraging Conservative council leaders to take the same steps if your legal advice supports it.

"But it is the Labour Government which is trying to ram through such asylum hotels without consultation and proper process. They are treating residents and councils with contempt. You may also wish to take advice from planning officers on the other enforcement options available in relation to unauthorised development or change of use."

emergency plans

Meanwhile, Mr Jenrick said: "Every patriotic council, whether Conservative, Reform, whatever, should follow Epping's lead and seek an injunction.

"And if you are a council or a community group and you need our help, contact my office. If you're a lawyer and you want to join the fight, contact me. Let's create a new movement, Lawyers for

Borders.

"We have to work together. Our country is in a mess.

Barrister Steven Barrett was the first to back the campaign, declaring on social media: "I will be supporting Lawyers for Borders. Laws and rules are borders – they keep us safe. For too long all the people of this beautiful country have been betrayed. No more."

Security Minister Dan Jarvis admitted emergency plans were being drawn up to house asylum seekers in case migrant hotels were ordered to close. He said: "We're looking at a range of contingency options and we'll look closely at what we're able to do.

"The important point to make is nobody really thinks hotels are a sustainable location.

"That's why the Government made a commitment that, by the end of this parliament, we would have phased out the use of them."

Shadow Home Secretary Chris Philp called on ministers to house migrants on former military bases and asylum barges, such as the Bibby Stockholm, as the Tories planned.

Mr Philp, who last week visited France with the Express to see migrant camps and view queues of

migrants boarding buses to the beaches, said: "Illegal immigrants who have entered the UK should not be put up in hotels that many Brits couldn't afford to stay in.

"Every illegal immigrant should be immediately deported either back to their country of origin or a third country like Rwanda.

Former Home Office minister Damian Green on Wednesday said the Government should "go back to the idea of camps".

The Tory, who lost his seat in last year's general election, added: "What they should do is toughen up the accommodation we offer to make it clear that it's a deterrent.

"So go back to the idea of camps, whether purpose-built Nightingale Hospital-style buildings on parts of the land the Government owns, or existing military camps. So that it is not seen as offensively luxurious."

Nigel Farage described the ruling as 'a victory for the parents and concerned residents of Epping.' He added: "They do not want their young women being assaulted on the streets. This community stood up bravely, despite being slandered as far-right, and have won. They represent the vast majority of decent people."

interpret the character put off producer Harry Saltzman.

"I think my ideas about it put the frighteners on Harry," he said. "I didn't get a second call from him."

"When the 1960s ended, I think because I'd been so identified with it, I kind of ended as well," he later told BBC Radio 4's Desert Island Discs.

He moved away from acting for a while, buying a round-the-world ticket and ending up in India where he studied yoga and spent time living in a spiritual retreat.

comeback

After being almost invisible for a decade, Stamp returned to the limelight as the arrogant arch villain General Zod in *Superman* (1978) and *Superman II* (1980). From then on Stamp appeared in an average of two or three films a year. In Stephen Frears's *The Hit* (1984), he is a British ex-con exiled in Spain; in Oliver Stone's *Wall Street* (1987), he is Sir Larry Wildman – the nemesis of the stock market speculator Gordon Gekko (Michael Douglas) – who lends the word "mate" an emphasis of menace, and in the title role of Steven Soderbergh's *The Limey* (1999), he is another ex-con, this time seeking revenge for the murder of his daughter.

In a departure from anything he had ever done before, Stamp dragged up for Stephan Elliott's 1994 cult comedy classic *The Adventures of Priscilla, Queen of the Desert* (1994), playing Bernadette Bassenger, a trans woman and performer who joins two drag queens on a road trip across the Australian outback.

Eight years for drug dealing e-bike killer

■ 'No real remorse' from 20-year-old who was pulling a wheelie on the pavement when he struck a great grandfather

A drug dealer who killed a great-grandfather when he crashed after pulling a wheelie on an e-bike has been sentenced to eight years and three months' detention.

Dylan Green, 20, had his girlfriend as a pillion passenger on the bike, which he later said could travel up to 50mph, when he collided with 86-year-old Bart O'Hare as he stepped into the road on his way to a chip shop in Burnley, Lancashire, in March last year.

Mr O'Hare's daughter Marika Mausolf addressed Green from the witness box at Preston Crown Court on Monday and said: "Not once did you show any thought or concern for him after taking your girlfriend out on

an illegal bike and pulling wheelies on the road with no consideration for my dad.

"Your selfish attitude was to try and diminish your actions by leaving my dad to suffer so you could get rid of the bike." She said: "You've broken my family in so many ways that I cannot begin to explain."

Footage played in court showed Green, who was on bail for drugs offences at the time, pulling a wheelie as he drove down Accrington Road shortly after 4.15pm on March 22 last year.

The wheelie lasted for 37 metres, the court heard.

The collision was not shown on camera but in the moments after, Green

could be seen returning on the bike, which was being ridden on the pavement.

Philip Astbury, prosecuting, told the court Mr O'Hare was thrown into the air following the collision, which happened when he was less than ten feet into the roadway.

Tyre marks showed Green's bike had returned to two wheels shortly before the crash but Mr Astbury said the wheelie had "entirely compromised Dylan Green's view of the road ahead of him".

He added: "Dylan Green and his girlfriend fled the scene on his e-bike, which has never been recovered."

About 45 minutes later, Green returned to the scene with two other



86-year-old Bart O'Hare died from his injuries, which included a fractured skull

males, one who told a police officer Green was responsible but suggested Mr O'Hare "ran out in front of him", the court heard.

Mr O'Hare, who had two granddaughters and five great-grandchildren, died in hospital a number of days later, having suffered head and chest injuries including a fractured skull.

Kristian Cavanagh, defending, said Green had demonstrated remorse "in his own way" and night terrors and panic attacks which he suffered were a reflection of how he felt.

Recorder of Preston Judge Robert Altham told Green: "You should have been wearing a helmet. You should have been displaying L plates. You should have passed a basic test. You should have been insured. You should not have had a pillion passenger."

He said: "Whilst you are undoubtedly sorry to be caught I do not detect any real remorse."

Green, of Burnley, Lancashire, pleaded guilty at an earlier hearing to causing death by dangerous driving and causing death by driving while uninsured.

Are they delulu? Cambridge dictionary gets with the times, adding tradwife and skibidi

"Skibidi", "tradwife" and other slang terms popularised on social media are among thousands of new words to be added to the Cambridge Dictionary this year.

Skibidi is a gibberish term which gained popularity via a viral animated video series on YouTube, while tradwife is a shortening of "traditional wife" – a married mother who cooks, cleans and posts on social media.

More than 6,000 new words have been added, including those that relate to tech giants and remote working.

"Internet culture is changing the English language and the effect is fascinating to observe and capture in the dictionary," said lexical programme manager Colin McIntosh.

Skibidi is defined in the dictionary as "a word that

can have different meanings such as 'cool' or 'bad', or can be used with no real meaning as a joke". An example of its use is "What the skibidi are you doing?"

Reality TV star Kim Kardashian revealed her familiarity with the phrase when she posted a video on Instagram showing a necklace engraved with "skibidi toilet" – the name of the YouTube series.

An earlier use of the word came in 2018 when the band Little Big released a track called Skibidi.

The music video has been viewed more than 700 million times and features a dance that went viral.

As well as new phrases, some shortened versions of existing terms have been added, including "delulu" – a play on the



word "delusional", with a similar definition: "believing things that are not real or true, usually because you choose to".

An increase in remote working since the pandemic has seen "mouse jiggler" – a device or piece of software used to make it seem as though you are working when you are not – gain its place in the dic-

tionary.

Other work-related words to make the cut include "work wife" and "work spouse", which acknowledge workplace relationships where two people help and trust each other.

Some composite terms such as "broligarchy" have also been added. Merging "bro" and "oli-

garchy", it means "a small group of men, especially men owning or involved in a technology business, who are extremely rich and powerful, and who have or want political influence".

Mr McIntosh said Cambridge Dictionary only added words which they believed could stand the test of time.

Sir Billy's plea to fans over online scammers

Sir Billy Connolly has warned fans about online scammers impersonating him and his wife Pamela Stephenson.

The comedy legend, 82, said on his website: "I have learned that, unfortunately, online scam artists are targeting my fans. They are impersonating me, often reaching out to fans soliciting direct messaging."

He warned the fraudsters create "multiple" deceptive social media pages and email accounts, adding there "could well be criminal intent".

Sir Billy continued: "For the protection of all my fans and supporters, please be aware of the following: My official Facebook page is my ONLY social media account."

He stressed his only other online presence is his website, billyconnolly.com. The star added: "I NEVER interact directly with fans or supporters, and would never suggest they direct message me, meet me, send me money or purchase goods directly."

"If you are asked for any of the above, it is a scam."

Sir Billy said Pamela and his children also do not have any social media accounts, adding: "My likeness and the sound of my voice can be created by AI ... so beware!"

Criminals can use cloning technology to replicate a person's voice from just a few seconds of audio, which is captured from a video shared online. Deepfake images of stars are often used in scams.

Play for Today makes return to UK small screens

■ Series aims to follow original in tackling 'thornier issues', and to support talent from lower-income backgrounds

IT WAS one of the most influential British television series of the last century, renowned for exploring thorny societal issues and bringing the work of emerging talent, such as Ray Winstone, Alison Steadman, Helen Mirren and Dennis Potter, to mass audiences.

Now Play for Today is being revived on Britain's Channel 5, to give young writers, actors and producers from lower-income backgrounds a way into TV, helped by established talent.

Continuing the series' history of politically charged social realism, the first four productions cover a failing Adolescence-style school in special measures, celebrity and historical abuse, ageing and money, and feature appearances from stars includ-

ing Anita Dobson, Nigel Havers, Sue Johnston and Alan Davies.

The channel's commissioning editor Paul Testar said Play for Today was "synonymous with high-quality stand-alone television dramas". Its revival would help "shape the future of British drama", he added, providing an "opportunity to support emerging talent behind the scenes – from writers and directors to production teams – especially those from lower-income backgrounds who haven't always had clear pathways into the industry".

Play for Today was a BBC One anthology drama series that ran from 1970 until 1984, designed "to rattle the cages of the establishment" and famed for bringing Abigail's Party and Rumpole

of the Bailey to the small screen.

It featured more than 300 productions, the most controversial of which was Scum – a prison drama starring Winstone that was considered so harrowing it was banned from broadcast and later

remade as a film.

The drama in which Dobson stars, Never Too Late, is about ageing, rebellion and independence. Speaking to the Guardian, she said it would resonate because "[we] live in a society now where older people

are living much longer, so it's really important, I think, that their voices are heard as much as young people's voices".

"I hope it makes lots of people feel positive and hopeful that life is never over until the last bell rings."

Golden Eagle may be on the way back

■ Bird of prey was eradicated from country in the 19th century

England could soon welcome back golden eagles after more than 150 years, following a study that has identified sufficient suitable habitats for their reintroduction.

While these majestic birds of prey are occasionally spotted in northern regions like Northumberland, these individuals are part of Scotland's expanding population.

The species was eradicated from England in the 19th century, largely due to persecution by those who perceived them as a threat to livestock and game birds.

The last resident golden eagle in England vanished from its Lake District reserve in 2015.

Now, Environment Secretary Steve Reed is

overseeing ambitious plans to bring the birds back.

It is understood that a forthcoming feasibility study by Forestry England, though not due for publication for several months, is set to conclude that England possesses the capacity to support a thriving golden eagle population.

If such a scheme were to go ahead, it would likely mirror methods used to reintroduce red kites and sea eagles in other parts of the UK.

Duncan Orr-Ewing, the head of species and land management at the bird charity the RSBP, said the survival of golden eagle populations in England depended in the availability of prey.

"The main prey of golden eagles are things like grouse, rabbits, hares. But they can also take other things like deer calves, we've seen badgers, fox cubs, all of these sort of things. And you've got grouse moor estates. So I don't think prey availabil-

ity is going to be a problem," he said.

The Department of the Environment, Food and Rural Affairs (DEFRA) said a reintroduction programme would also involve public engagement, and consider the impact of golden eagles on other

species and the wider environment.

A spokesperson for the department said: "The recovery of golden eagles offers hope for the future of the species in Britain. Any next steps of their reintroduction in England will be set out in due course."

Paul Weller sues former accountants over Gaza

■ Jam founder claims firm fired him as a client after he claimed Israel was committing genocide

Paul Weller is suing his former accountants who stopped working with him after he shared statements saying Israel was committing genocide in Gaza, according to a legal letter.

The Jam's former frontman filed a discrimination claim against Harris and Trotter after the firm ended the professional relationship after more than three decades.

In a pre-action letter, Weller's lawyers say the musician, 67, was told in March that the accountants and tax advisers would no longer work with him or his companies.

According to the letter, a WhatsApp message al-

legedly from a partner at the firm included: "It's well known what your political views are in relation to Israel, the Palestinians and Gaza, but we as a firm are offended at the assertions that Israel is committing any type of genocide.

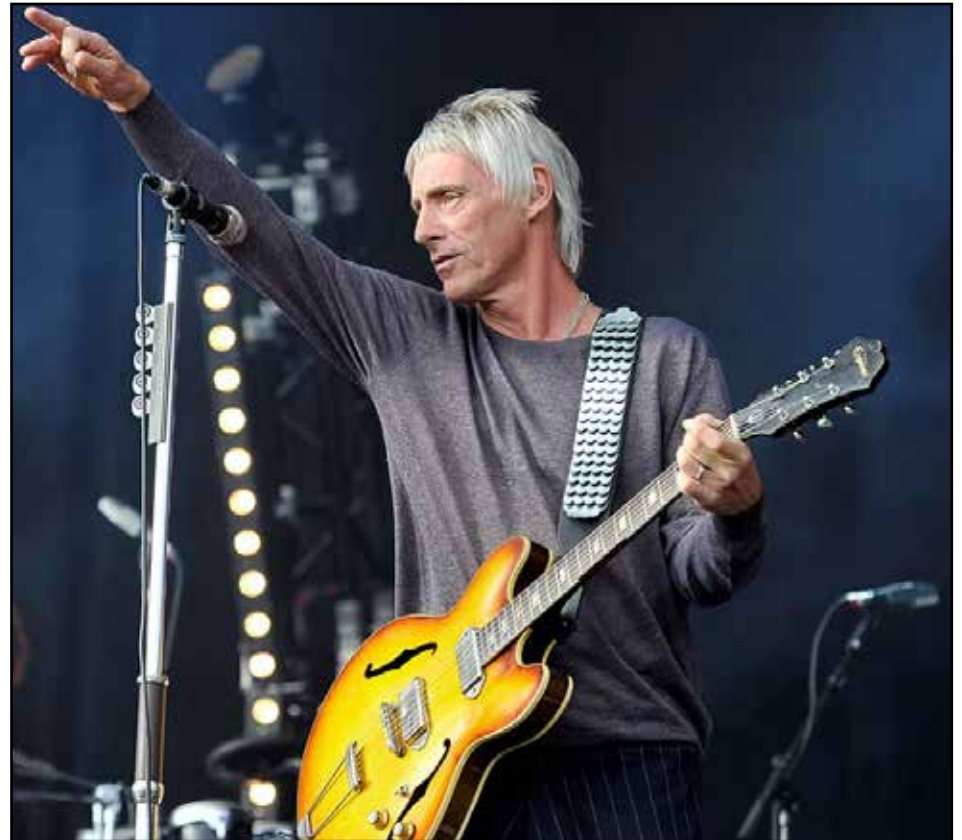
"Everyone is entitled to their own views, but you are alleging such anti-Israel views that we as a firm with Jewish roots and many Jewish partners are not prepared to work with someone who holds these views." Weller's lawyers claim that by ending their services, the firm unlawfully discriminated against the singer's protected philosophical beliefs

including that Israel is committing genocide in Gaza and that Palestine should be recognised as a nation state.

The singer said: "I've always spoken out against injustice, whether it's apartheid, ethnic cleansing or genocide. What's happening...in Gaza is a humanitarian catastrophe.

"I believe they have the right to self-determination, dignity, and protection under international law, and I believe Israel is committing genocide against them. That must be called out. Silencing those who speak this truth is not just censorship – it's complicity."

He said he was taking

legal action "to help ensure that others are not similarly punished for expressing their beliefs". Weller will donate any damages he receives to humanitarian relief efforts in Gaza, the letter also states.

Cormac McDonough, a lawyer at Hodge Jones and Allen, representing Weller, said that his case "reflects a wider pattern of attempts to silence artists and public figures who speak out in support of Palestinian rights".

Harris and Trotter have not commented on the lawsuit.

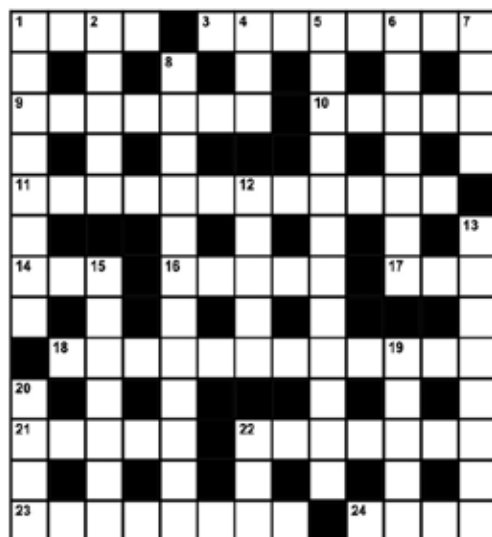


Weller has been actively fundraising for Gaza aid organizations since the Israeli invasion

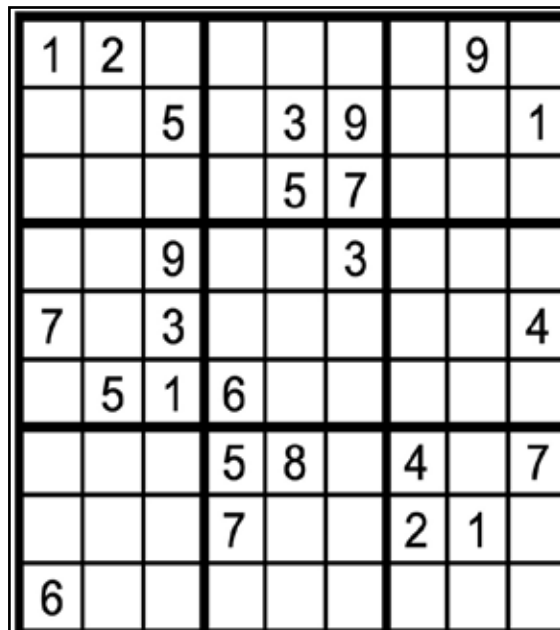

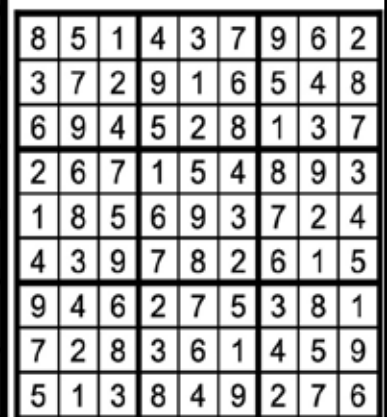

This 'Ballad' strikes all the right notes

■ Recent British release is now streaming on Peacock

NOW STREAMING on Peacock is James Griffiths' gently eccentric comedy *The Ballad of Wallis Island*, and it may prove music to your ears - and soul. The plot centers on two long-forgotten folk musicians who are coaxed back on stage by their strangest fan: a lottery winner who wants nothing more than a private concert in his crumbling island home. It sounds like the setup for a sketch, yet what follows is less spoof and more bittersweet meditation on fandom, failure and the impossibility of turning back the clock.

Herb McGwyer (Tom Basden) and Nell Mortim-

er (Carey Mulligan) were a folk duo who briefly flirted with stardom in the late 2000s. They played Glastonbury, smiled from the covers of NME, but never came close to Dylan or Cat Stevens. Today Herb is bruised and washed-up, clinging to a solo career nobody wants, while Nell is settled in Portland, making jam with her bird-watching husband. Both thought their folk days were long behind them.

Enter Charles (Tim Key), their self-appointed biggest fan. Twice blessed by lottery luck, Charles decides to spend his fortune on staging the ultimate reunion: not in a stadium,

but in his front room on the wind-battered Wallis Island. When Herb arrives by motorboat, wading through icy surf to the shore, he discovers there is no "Wallis Lodge" - just Charles' ramshackle house

and his bottomless enthusiasm.

Key's performance is a delight. Charles is a motor-mouthed eccentric, incapable of silence, but beneath the babble is a man weighed down by private grief. Like John Candy's Del Griffith in *Planes, Trains and Automobiles*, his cheeriness masks loneliness. Key gives him real pathos, balancing irritation with warmth so finely that you forgive his lack of boundaries.

Basden plays Herb as the straight man: spiky, slouched, defensive, his face doing most of the talking. It's a subtle turn that contrasts beautifully with Key's verbal torrent. More importantly, Basden supplies the music - tender, convincing folk songs played completely straight. They give the film its emotional ballast and stop it drifting into parody.

Mulligan, though less present, grounds the story. As Nell, she is warm, wary and entirely believable as the partner who once abandoned both band and boyfriend. Her arrival with her new husband (Akemnji Ndiforinyen) reopens old wounds but also sparks the film's most moving scenes. When she and Basden sing together, there is a tangible history: affection mixed with regret, and the faintest glimmer of what might be again.

Griffiths and cinematographer G. Magni Ágústsson give *Wallis Island* a

strong sense of place. Its single shop never has anything in stock; the paint is peeling, the air salty. Yet the camera treats the island with affection, never mockery, bathing its battered edges in soft light. The setting mirrors the story itself: shabby, yes, but full of soul.

The film's flaw is its focus. Charles is fascinating - part clown, part confessor - while Herb, despite Basden's fine work, sometimes feels underwritten. Perhaps that blankness is deliberate: most idols, after all, are less interesting than their fans imagine. But the

narrative drags whenever Charles disappears from view, only to spark back to life when Nell joins the mix.

Still, *The Ballad of Wallis Island* charms precisely because it refuses to settle into any single box. It isn't broad comedy, nor outright romance, nor cynical satire of fandom. Instead it drifts somewhere in between - a funny, fragile study of people stuck between nostalgia and reality. Its humour is gentle, its songs sincere, its heart unexpectedly large.

Nottingham Forest have signed Douglas Luiz from Juventus on a season-long loan with a conditional obligation to make the deal permanent next summer.

Serie A side Juventus for £42.35m on a five-year contract. Luiz made 204 appearances in all competitions for Villa and scored nine goals in 35 Premier League games in the 2023-24 season before his move to Italy.

Reds team-mate Alexis Mac Allister, Manchester United captain Bruno Fernandes, Newcastle striker Alexander Isak, Chelsea forward Cole Palmer and Arsenal midfielder Declan Rice were also on the shortlist.

"Later down the line, I want to be one of those incredible players people speak about, so to do that I have to do what they did and what they followed after," he said. "It's a nice recognition but there's more to win and I can't wait."

Wissa:

Wissa had flown home early from their pre-season camp in Portugal in July after which he threatened not to play or train for the club again if they did not sanction his protracted move to St James' Park.

Since then there had been a slight thawing of relations resulting in Wissa returning to first-team training while continuing to make absolutely clear he wanted to join Newcastle.

Indeed, Wissa has been expecting Brentford to agree his move to Tyne-side this week after the west London side completed the signing of Dango Ouattara from Bournemouth. Brentford have already lost fellow forward Bryan Mbeumo this summer to Manchester United.

Gunners score Eze win

■ Palace star jilts Spurs, makes last minute switch to childhood club Arsenal

ARSENAL inflicted a damaging psychological blow on arch-rivals Tottenham Hotspur this week, pipping them to signing the highly-rated Eberechi Eze from Crystal Palace.

For the Gunners, who swept in to make the deal in a matter of hours following several weeks of negotiation between Palace and Spurs, the move is a ruthless statement of intent designed to show this is the season they can finally claim the biggest prizes.

As for Spurs it was a huge setback. They club were ready to roll out the welcoming carpet for the England forward on Wednesday, with every indication a deal for the

27-year-old was virtually done.

The dramatic turnaround came after Arsenal had assessed the seriousness of a knee injury to forward Kai Havertz, which could potentially put a dent in their attacking resources - a weakness that played a significant part in manager Mikel Arteta's side finishing empty-handed for the fifth year in succession last season.

Instead of taking the cheaper option of exploring the loan market, as was first expected, Arsenal went for broke in spectacular style by setting up a £60m coup to take Eze to Emirates Stadium.

It is a strategy in stark

contrast to the inertia that gripped Arsenal last season, when their failure to solve an obvious problem - by signing a recognised striker - cost them dearly.

Spurs thought they had Eze wrapped up, with the possibility of a cash-plus-Richarlison deal discussed, but Arsenal moved with lightning speed once they were confronted by the possibility of Havertz facing a spell on the sidelines.

Arsenal have been linked with Eze all summer, but it was thought their interest had cooled once Ethan Nwaneri agreed a new five-year contract, on top of signing Chelsea winger Noni Madueke in a £48.5m deal.

Havertz's injury, and its potential consequences, reignited that interest to leave Spurs stunned.

As well as Madueke, the Gunners have concluded moves to sign Spain's outstanding midfielder Mar-

tin Zubimendi in a deal worth up to £60m and, at least 12 months too late, a recognised striker in Viktor Gyokeres, from Sporting for £64m.

In Eze, who had two years left on his Palace

contract, Arsenal will get a versatile forward rich in natural talent who is a match-winner - as he proved when scoring the winner against Manchester City in May's FA Cup final.



Bees reject £40m Wissa bid

Brentford have turned down Newcastle's improved bid of £40m for striker Yoane Wissa.

The Magpies were proposing a £35m initial fee plus a further £5m in additions.

Newcastle reopened talks with Brentford on Wednesday but sources said that the latest bid fell below the Bees' valuation of the player.

It is understood Wis-

sa held talks with Brentford's owner Matthew Benham on Tuesday, a development that prompted the discussions.

The Magpies' previous bid for the 28-year-old was worth up to £30m.

Earlier this week, Wissa removed all association with Brentford from his Instagram account, as his future took a fresh twist.

The DR Congo forward

wants to join Newcastle but so far Brentford have refused to sanction his exit. He scored 19 goals in the Premier League last season. The Magpies see Wissa as a natural replacement for wantaway striker Alexander Isak, who looks almost certain to join Liverpool before the end of the transfer window.
