# Police duo in bid to cop more royalties

■ Rock icon feels the sting as former bandmates seek \$1.5m in London court

Sting has been sued by his former bandmates in The Police over alleged lost royalties for the songs they recorded together between 1977 and 1984.

In a civil case filed in Londond's High Court, guitarist Andy Summers and drummer Stewart Copeland, claim they have been underpaid for their contributions to songs like Roxanne and Every Breath You Take.

Although they did not receive writing credits on those songs, they say the band entered an "oral agreement" to share income in 1977, which was later formalised in written contracts.

Sting, who wrote all of The Police's biggest hits, denies underpaying his bandmates. In court documents, his lawyers called the claims "illegitimate."

## most-played song

The Police formed in 1977 and quickly became one of the UK's most commercially successful bands.

They earned a US number one single with Every Breath You Take, taken from their fifth album, Synchronicity, in 1983.

It was later recognised

as the most-played radio song of all time and was heavily sampled on P Diddy and Faith Evans' 1997 song I'll Be Missing You.

However, the band split up in 1984 amid personal and musical animosity.

Copeland later told The Guardian that the band "beat the crap out of each other" during the "very dark" recording sessions for Synchronicity.

## 'very personal thing'

In 2022, Sting, whose real name is Gordon Sumner, said he felt the band were holding him back.

"My frustration was I would have written an album's worth of material but also had to entertain these others songs that were not as good," he told Mojo Magazine.

"Explaining to someone why their song isn't working is a bit like saying their girlfriend's ugly. It's a very personal thing... That pain was something I didn't

want to go through any more."

Although Sting was the band's primary songwriter, the other members both made contributions to their albums - and Summers has often claimed that he originated the iconic guitar riff on Every Breath You Take.

In 1977, documents submitted to the High Court show the band agreed that, when any one member received publishing income for a song they'd written, they would share a percentage of that money, usually 15%, with the other two members, in what was termed an arrangers' fee.

In the court documents, none of the members agree how that arrangement came into place.

## 'oral agreement'

Summers recalls it taking place on the street outside their manager Miles Copeland's office in Notting Hill.

Sting, however, con-

tended there was no "oral agreement" - but that Copeland had floated the idea during a visit to his flat in Bayswater to help "keep things sweet" with his bandmates, who were not present.

Either way, the agreement was formalised in 1981, and revised again in 1995 and 2016.

The current legal dispute centres around which categories of publishing income Summers and Copeland should receive compensation.

It's a complicated area, but royalties are generally split into two separate categories:

Performance royalties

- which are paid when a song is played in public, on the radio, or via a streaming service and mechanical royalties - paid when a song is pressed to CD or vinyl, but also when it is streamed on demand.

Summers and Copeland argue that they should be paid for both of these categories, while Sting says their agreement only covers mechanical royalties.

Sting's lawyers further contend that, under the terms of the band's 2016 agreement, all three members agreed not to pursue any historic or future claims over royalties.

His bandmates claim that does not stop them disputing the terms of the 2016 agreement.

They claim a loss of about £1,500,000. Sting's lawyers denied they had been underpaid and argued that, in fact, Summers and Copeland may owe him money that has been overpaid to them.

In 2022, the musician sold the rights to his songwriting catalogue to Universal Music Group, with the deal covering both his solo hits and songs he penned for the Police.

The deal was estimated to be worth \$200 million (£149 million).

# British shipyards set for £10bn bonanza

## Deal to build warships for Norway is UK's largest ever marine contract

**WARSHIPS for Norway's navy will be built in Britain as part of a £10billion deal.**

The move is the UK's largest ever international warship contract and will safeguard 4,000 jobs, the Government said on Monday.

All the Type 26 frigates will be built at BAE Systems' yard in Govan, Glasgow, where work is already under way on eight vessels for the Royal Navy.

The new contract is expected to support 2,000 jobs at BAE in the coming years and a fur-

ther 2,000 in the supply chain into the latter part of the next decade, said the Ministry of Defence.

More than 400 British businesses, including 103 in Scotland, will benefit, it added.

### 'work as one'

The deal will mean a combined UK-Norwegian fleet of 13 anti-submarine frigates – eight British and five Norwegian – to operate jointly in northern Europe.

The aim is to strengthen Nato's northern flank amid rising Russian military activity.

Sir Keir Starmer learned of the decision during a call with his Norwegian counterpart Jonas Gahr Store. The British PM said: "This success is testament to the thousands of people across the country who are not just delivering next-generation capabilities for our Armed Forces but also national security for the UK, our Norwegian partners and Nato for years to come."

Norway should start receiving its ships – which detect, track and destroy enemy subma-

rines – in 2030.

Defence Secretary John Healey said: "We will train, operate, deter and, if necessary, fight

together. Our navies will work as one, leading the way in Nato, with more world-class warships in the North

Atlantic to hunt Russian submarines, protect critical infrastructure and keep both our nations secure."

# Kemi: Drill, baby drill

## Top Tory vows to focus on using UK's fossil fuels

**TORY leader Kemi Badenoch has promised to extract all North Sea oil and gas to end the net zero drive and focus on using Britain's fossil fuels.**

She insisted it was "absurd" to leave the resources untapped.

The Government has committed to banning new exploration licences.

Mrs Badenoch announced that the Tories plan to completely overhaul the North Sea Transition Authority, which oversees the issuing of licences,

dropping the word transition and giving it a simple order to extract the maximum possible amount of fossil fuels.

### 'absurd situation'

Ahead of her speech, Mrs Badenoch pledged that "we are

going to get all our oil and gas out of the North Sea".

She said: "We are in the absurd situation where our country is leaving vital resources untapped while neighbours such as Norway extract them from the same seabed.

"Britain has already decarbonised more

than every other major economy since 1990, yet we face some of the highest energy prices in the developed world."

### 'fair and orderly'

The Government said: "We are delivering a fair and orderly transition in the North Sea to drive growth

and secure skilled jobs, with the biggest ever investment in offshore wind.

"We are committed to not issuing new licences to explore new fields because they will not take a penny off bills, cannot make us energy secure, and will accelerate the worsening climate crisis."

# Father Ted writer nicked for posts on trans issues

■ Comedy writer intercepted by five armed officers at Heathrow after flying in from Arizona

The writer of TV's *Father Ted* has been arrested at Heathrow over three social media posts on transgender issues.

Graham Linehan, who also created the *IT Crowd*, said he was intercepted by five armed officers after flying in from Arizona and told he was under arrest over the messages.

Writing on Substack, the 57-year-old Irishman said he was taken to a cell and then questioned over the posts, published on X in April.

He said the posts related to him challenging a "trans-identified male" in a "female-only space".

Linehan said after questioning by police that his blood pressure "was over 200 – stroke territory" and he was taken to hospital and kept under observation before being discharged and released on bail.

The Metropolitan police did not identify Linehan but a spokesperson said: "On Mon-

day, 1 September, at 1pm officers arrested a man at Heathrow airport after he arrived on an inbound American Airlines flight.

"The man in his 50s was arrested on suspicion of inciting violence. This is in relation to posts on X.

## contentious

"After being taken to police custody, officers became concerned for his health and he was taken to hospital. His condition is neither life-threatening nor life-changing. He has now been bailed pending further investigation.

"The arrest was made by officers from the MPS aviation unit. It is routine for officers policing airports to carry firearms. These were not drawn or used at any point during the arrest."

Legal and regulatory oversight of social media posts in the UK has become an increasingly contentious political

topic on both sides of the Atlantic. US officials have expressed concerns over the Online Safety Act and the country's vice-president, JD Vance, has said the UK is going down a "very dark path" of losing free speech.

The case of Lucy Connolly, a British woman who was jailed after last summer's riots for a post on X calling on people to set fire to hotels housing asylum seekers, has become a cause célèbre for the right.

## backlash

Connolly, who was jailed for two years and seven months, was released last month.

Linehan's arrest prompted a backlash from various figures, including author JK Rowling and opposition politicians.

Downing Street declined to comment directly on the arrest. The prime minister's official spokesperson said the

arrest was "an operational matter for the police". He added: "The prime minister and the home secretary have been clear about where their priorities for crime and policing are, and that's tackling antisocial behaviour, shoplifting, street crime, as well as reducing serious violent crimes like knife crime and violence against women."

He also rejected Rowling's claim that the UK

was engaging in "totalitarianism".

Rowling had earlier attacked Linehan's arrest, in a post on X asking what the UK had become. The tech billionaire Elon Musk reposted Rowling's tweet, adding: "Police state."

Opposition politicians also criticised the arrest. Former shadow justice secretary Robert Jenrick called it "ridiculous and a complete waste of po-

lice time".

Shadow cabinet minister Claire Coutinho said: "You live in a society? Occasionally you're going to be offended. That's how it works."

Labour backbencher Jonathan Hinder said the arrest showed the need for a "serious reset to get the priorities right" in policing, while Independent MP Rupert Lowe said: "I stand with Linehan."

# MAGA fave Farage makes hay in DC, likening UK to North Korea

■ Reform leader draws withering criticism from leading Democrat

The Reform UK leader has likened the UK to North Korea as he criticised the arrest of *Father Ted* writer Graham Linehan.

Nigel Farage said the country is now sinking into an "awful authoritarian situation".

He made the remark while giving evidence on civil liberties at a meeting of Washington's House Judiciary Committee in the US.

Mr Farage referenced the arrest of Irish comedy writer Mr Linehan over comments on social media about transgender people.

He said: "It doesn't give me any great joy to be sitting in America and describing the really awful authoritarian situation that we have now sunk into."

He went on to warn Americans they could face the same treatment, adding: "He's not even a British citizen, he's an Irish citizen."

"This could happen to any American man or woman that goes to Heathrow, that has said things online that the British Government and British police don't like."

Mr Farage added: "So I've come today as well

to be a klaxon, to say to you don't allow, piece by piece, this to happen here in America.

"And you would be doing us and yourselves and all freedom-loving people a favour if your politicians and your businesses said to the British Government, you've simply got this wrong. At what point did we become North Korea? Well, I think the Irish comedy writer found that out two days ago at Heathrow airport.

"This is a genuinely worrying, concerning and shocking situation."

He also blasted the Online Safety Act, and the

imprisonment of Lucy Connolly for stirring up racial hatred against asylum seekers.

One of the posts said: "If a trans-identified male is in a female-only space, he is committing a violent, abusive act.

"Make a scene, call the cops and, if all else fails, punch him in the balls."

Another featured a photograph of a trans rights protest, with the comment, "A photo you can smell".

A follow-up post then said: "I hate them. Misogynists and homophobes. F\*\*\* em."

Meanwhile, Mr Farage

was branded a "Putin-loving free speech impostor and Trump sycophant" by a US congressman ahead of his speech.

Democrat representative Jamie Raskin slammed him for missing Prime Minister's Questions in the Commons to fly to America and voice concerns about free speech in Britain to politi-

cians in Capitol Hill.

Mr Raskin went on to address the British people. "To the people of the UK who think this Putin-loving, free speech impostor and Trump sycophant will protect freedom in your country, come on over to America and see what Trump and MAGA are doing to destroy our freedom."

# Killer gets 45 years for prison officer 'execution'

■ Former inmate waited for four years to get revenge on prison officer who exposed affair with female officer

A VENGEFUL drug dealer who shot dead a prison officer who exposed his sexual relationship with a woman jail guard has been locked up for at least 45 years.

Elias Morgan, 35, wanted retribution after dad-of-three Lenny Scott, 33, found a phone that revealed the affair at HMP Altcourse, Merseyside, Preston Crown Court heard.

When Mr Scott refused a £1,500 bribe and reported the mobile, Morgan, of Edge Hill, Liverpool, said: "I'll bide my time" and made a gun gesture.

Four years later, after Morgan was freed and Mr Scott, from Prescot, Merseyside, had left the Prison Service, the threat was carried out.

The ex-officer was shot six times as he left a gym in Skelmersdale, Lancashire, on February 8 last year. Morgan fled on

an electric scooter.

Passing sentence on Tuesday Mr Justice Goose told Morgan: "This murder was a carefully planned, revenge killing of a prison officer. He was loved, respected and made his family proud."

Detectives traced phone and vehicle data

showing the gunman had stalked his victim to learn his daily schedule.

The trial heard Mr Scott had found the phone in Morgan's cell in March 2020 but left the Prison Service in 2021 and played no part in the ensuing prosecution. Prison officer Sarah Williams admitted misconduct in a

public office in June 2023.

Morgan denied a charge of unauthorised possession of a mobile and a court hearing was due on February 19, 2024 – 11 days after Mr Scott was murdered.

## 'strong, brave, honest'

He was convicted of murder following a nine-week trial. Paula Scott, the victim's mum, told convicted armed robber Morgan from the witness box that her "son was ev-

erything you are not.

"He was strong, brave, honest, respectful. He lost his life for standing up for what was right. You are a vile, inhuman, coward.

"Lenny, thank you for being my son, I will forever be proud of you."

Ex-partner Lucy Griffiths, the mum of Mr Scott's twin boys, described him as a devoted father and a "kind, caring and compassionate man".

She added: "He adored his children. The moment he was murdered our world came crumbling down."

Ms Griffiths said she finds notes under the kids' pillows asking him to come back home.

Lucy Carnhill, mother of Mr Scott's young daughter, said the child, "was his world".

She added: "My life is consumed by grief. All I have now is memories and photos."

## Boxing great Bugner dead at 75

■ British heavyweight enjoyed long career but was faulted by many for his defensive style

Boxing legend Joe Bugner died aged 75 this week, after a career in which he held his own with the greatest but failed to win the kind of adulation a British heavyweight could usually expect.

Tough enough to take both Muhammad Ali and Joe Frazier the distance, he earned grudging admiration for his abilities but never quite won over the nation.

His Hungarian roots and a safety-first style might have contributed, but British fans never got over his controversial win over national treasure Henry Cooper.

Bugner's sculpted face and torso and a defensive approach relying heavily on a ramrod jab led sports writer Hugh McIlvanney

to say he had "the physique of a Greek statue but with fewer moves".

But he always welcomed a challenge in a career that spanned four decades and encompassed 69 wins, 13 defeats and one draw. He once said: "Get me Jesus Christ and I'll fight him tomorrow."

Born in Szoreg, Hungary, on March 13, 1950, Jozsef Kreul Bugner was taken out of the country along with his four siblings by their single mum Margaret after the 1956 Soviet invasion.

He once said his mother "had more balls than anyone I have met in the boxing ring".

The family settled in St Ives, Cambridgeshire, and Bugner's talent was soon spotted. After being

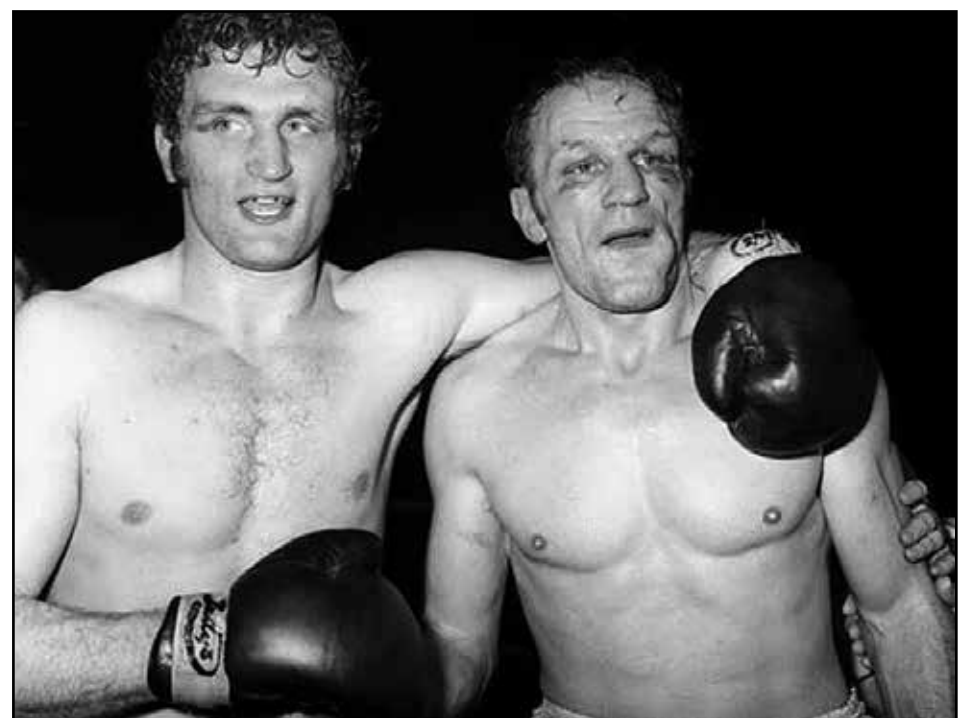
advised to turn professional at 17 in 1967, Bugner was knocked out by a bus driver on his debut.

But he bounced back to win 31 of his next 33 bouts before a seminal meeting with Cooper in 1971.

Bugner was 21 when he claimed Cooper's British, Commonwealth and European crowns. Referee Harry Gibbs awarded upstart Bugner victory by a quarter of a point after 15 gruelling rounds.

It caused such fury that Bugner said years later: "I wish I'd never ruddy fought Henry Cooper. It got me chased out of England. In the eyes of the press I was a refugee who'd come to Britain and made a fortune beating people up."

Four years later, in 1975,

his only attempt at the world heavyweight title ended with a wide points defeat to Ali.

It was Bugner's second shot at Ali, having fallen short in 1973, the year in which he also took on

Frazier. Ali and Frazier shared 10 opponents and Bugner is the only one neither could finish.

Bugner went 15 rounds with Ali, his face bloodied and swollen. Ali was impressed, saying: "Watch

out for Bugner. He'll be the champion a couple of years from now."

It was one of the few predictions The Greatest got wrong.

He retired for the first **cont. on page 5, col. 4**

# Straight out of Essex!

■ **"Ketamine Queen" whose drugs killed Friends Star Perry is a British immigrant from a respectable and wealthy Sikh family**

A DRUG dealer known as the "Ketamine Queen", who has admitted selling Friends star Matthew Perry the dose that killed him, was born into a respectable Sikh family from Loughton, Essex.

Jasveen Sangha, a joint UK-US citizen, is the fifth and final defendant charged over the actor's overdose death to plead guilty.

Her grandparents amassed a fortune from an East London clothing business supplying luxury department stores. It is believed they stayed in the UK in a £2.7million home with a Rolls-Royce, Ferrari and Mercedes on the drive before their children, Jasveen's parents, moved to California in

1987.

Sangha was sent to a high school in Calabasas, the affluent city that is home to the Kardashians among other celebrities. Well-known locally as a party girl, Sangha went on to graduate from the University of California. On Instagram she showed off an aspirational lifestyle, including photos with the rich and famous in cities around the world.

### Sangha's stash house"

But privately, said prosecutors, she was a prolific drug dealer, with her North Hollywood home known as "Sangha's stash house".

Making good on a deal she signed on August 18, she admitted one count of maintaining a drug-in-

volved premises, three counts of distribution of ketamine and one count of distribution resulting in death.

Three other counts relating to the distribution of ketamine and one count of distribution of methamphetamine unrelated to the case were dropped when she appeared in a Los Angeles court yesterday.

Arrested and placed in custody in August last year, Sangha, 42, had been due to go on trial later this month. She could get up to 65 years' jail when she is sentenced on December 10 as the judge is not bound to follow any terms of the plea deal. However, prosecutors have indicated they will not push for the maximum term.

time afterwards but was back within months, knocking out Richard Dunn in a round in 1976 to regain the British, Commonwealth and European belts. He fought sporadically for the next decade before being stopped by Frank Bruno in eight rounds at White Hart Lane in 1987.

After moving to Australia in the 1980s he was dubbed "Aussie Joe" as he finally won the affection he was denied in Britain.

He made a comeback in 1995, and won the Australia and WBF heavyweight titles before retiring for good in 1999, aged 49.

He appeared in 1994 action-thriller Street Fighter with Jean-

Claude Van Damme and Kylie Minogue, and in ITV's I'm A Celebrity in 2009. He married Melody Bowd in 1968. They had three children but divorced.

She later claimed that he had been violent.

He met Australian journalist Marlene Carter and settled with her in Los Angeles. They wed

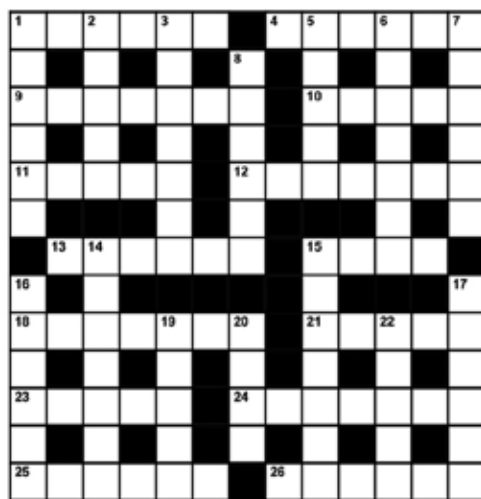
in 1978 with Tom Jones as best man then moved to Australia where they opened a vineyard, but it failed in 1989.

Marlene died before Bugner. He spent his final years in a Brisbane care home after being diagnosed with dementia. He is survived by his children James, Joe Jr and Amy.

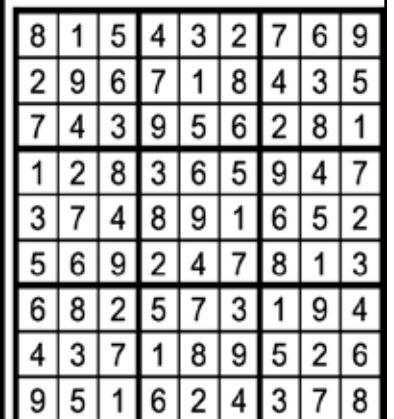

# Missing You: give this one a swerve

■ **British police drama has twists and turns aplenty...but will likely leave you feeling nauseated**

"Missing You", Netflix's adaptation of Harlan Coben's latest thriller, is riding high on the streaming platform, and it opens with so much promise but leaves us feeling rather... missing it. You might want to do the same.

Detective Kat Donovan (Rosalind Eleazar) receives a jolt when the ostensibly vanished fiancé - Josh Buchanan (Ashley Walters) - resurfaces on a dating app after eleven long, silent years. It's a gripping premise that sets the heart racing and the expectations high. What follows, however, is a maelstrom of twists, turns, and revelations so incessant that the original story—that of a woman seeking closure—becomes nearly forgotten amid the chaos.

Performances remain

one of the few steadfast anchors in the deluge. Eleazar injects commitment and sincerity into Kat's turmoil, holding the viewer's attention even when the plot frays. James Nesbitt, arriving as crime boss Calligan, brings welcome gravitas (and scenery-chewing grandeur) to an otherwise lopsided tone. Yet, no amount of acting bravura can entirely salvage a script that seems allergic to subtlety.

## Absolutely woeful?

From the outset, the series stumbles in execution. Reviewers noted over-explanation, repetitive exposition, and a dizzying array of red herrings that inhibit emotional investment. Plot beats are stated, restated, and restated again while the visual palette does little to lift the gloom. Critics lament the

uninspired cinematography and muddy lighting, which drain what little atmosphere the narrative might have cultivated. For a series that hinges on suspense and mood, the aesthetic feels inscrutable rather than immersive.

What, then, of the

ending? Brace yourself: it's not so much a resolution as it is a tumble through revelations, one more impossible than the last. All roads lead to an elaborate finale where Josh confesses to (spoiler alert) accidentally killing Kat's father during a fray involving a knife and a bungled cover-up. The crime syndicate used fake dating profiles to ensnare victims, and the eventual close sees Kat brush Josh's hand with hers—an emotionally ambiguous gesture that, admittedly, sticks.

Eleazar herself defended this finale in an interview, suggesting the muted, open-ended climax reflects the real human inability to instantly process trauma - or neatly tie things up. "I like when things aren't fully resolved," she mused, likening the last hand-touch to a moment of shared shock rather than easy reconciliation.

Social media has been scathing: "Absolutely WOEFUL series" said one review, while The Sun sniffed: "Awful acting, even worse plot... pathetic ending!"

It's clear Missing You divides opinion. There are those who appreciate

the relentless momentum, however far-fetched; and those who find that the twists are less clever than contrived, the pacing frenetic to the point of fragmentation.

If you're seeking a sleuthing tale grounded in emotional realism, Missing You may frustrate more than it satisfies. Its saving graces - most nota-

bly Eleazar's performance and an unapologetic commitment to shock - cannot fully redeem a mystery that feels adrift beneath its own convolutions.

Nonetheless, if you relish a binge that's bizarrely entertaining, packed with twists, and famished for cliché, there may yet be a guilty-pleasure to be had amid the wreckage.

## ■ In surprise move, Spurs announce long-serving chairman is stepping down

**IN A SHOCK announcement on Thursday, Spurs revealed that Daniel Levy's near 25-year reign as executive chairman is over.**

The club said he had "stepped down", but multiple reports suggest the decision was taken out of Levy's hands.

Well-placed sources said the ownership agreed for him to leave his position amid a belief that change would lead to greater sporting success.

Levy was appointed

in March 2001 and leaves after the club won the Europa League in May to end a 17-year wait for a trophy.

The 63-year-old was the Premier League's longest-serving chairman and earned an estimated £50m-plus during his time in charge, but he was also the target of regular protests from Spurs fans, especially last season.

Levy will go with immediate effect and there will be no notice period, with the timing of his

departure after the summer transfer window a deliberate move.

"I am incredibly proud of the work I have done together with the executive team and all our employees," said Levy, who had a reputation in football for being a shrewd operator and tough negotiator.

"We have built this club into a global heavyweight competing at the highest level. More than that, we have built a community.

"I was lucky enough

## Reds finally seal Isak deal



The striker moves from Newcastle for a record British transfer fee

Liverpool have finally signed striker Alexander Isak from Newcastle United for a British record transfer fee of £125m, with the Swede saying he "wanted to create history and win trophies" at Anfield.

Newcastle sources claim the deal could be worth as much as £130m with add-ons.

Sweden international Isak, 25, had a medical on Monday before signing a six-year contract, and the deal takes Liverpool's

summer spending to about £416.2m, without add-on fees.

Isak, who will wear the number nine shirt with the Reds, told the Liverpool website: "This is the next step for me in my career. I'm super happy that I've been given this chance and I'm very motivated to do something well with it.

"I want to create history. I want to win trophies. That's ultimately the biggest motivation for me.

"This is the perfect

place for me to grow even further and to take my game to the next level and help the team as well."

Liverpool had an original £110m offer for Isak rejected in August but have now landed their first-choice target of the summer.

The protracted saga came to an end on the final day of the transfer window, with the Reds announcing the deal at 21:30 BST, two and a half
