# Mandy fired over Epstein friendship

- Starmer's hopes to restore authority are dashed
- Labour grandee no stranger to controversy

**LONDON:** Sir Kier Starmer's embattled premiership suffered another blow this week as he was forced to fire Peter Mandelson as Britain's ambassador to the U.S., after a trove of emails revealed the depth of his ties with the late convicted U.S. sex offender Jeffrey Epstein.

Mandelson made his name as Tony Blair's spin doctor and remains one of the party's most influential grandees behind the scenes, but was forced from the country's most desirable diplomatic post after some of his letters and emails to Epstein were revealed this week.

Starmer, struggling in opinion polls after numerous setbacks, had strongly backed his ambassador on Wednesday as a state visit by U.S. President Donald Trump, with whom Mandelson had developed strong ties, looms next week.

### 'my best pal'

Trump has also faced questions about his links with Epstein, with the White House denying that an alleged birthday letter from him to the late financier is authentic.

Mandelson quickly became untenable after U.S. lawmakers released documents including a letter calling Epstein "my best pal".

Emails were then published in the media showing that Mandelson had advised Epstein to fight for early release in 2008 when he was about to be sentenced to 18 months in jail for soliciting a minor.

"The emails show that the depth and extent of Peter Mandelson's relationship with Jeffrey Epstein is materially different from that known at the time of his appointment," the foreign office said in a statement.

The reporting of Mandelson's suggestion that Epstein's first conviction was wrongful and should be challenged was "new information", it said, adding that

Starmer had asked for his removal.

On Wednesday, Mandelson had said he deeply regretted ever meeting Epstein, and that he had carried on the association "for far longer than I should have done", suggesting he had believed the lies of a "charismatic criminal liar".

### 'decisive action'

Mandelson's statement initially seemed to satisfy the prime minister. Starmer had heaped praise on Mandelson, the first political appointee to the position in almost half a century, for his efforts in securing a trade deal with the United States.

But after twice being forced out of cabinet under Blair, Mandelson was no stranger to controversy.

He was photographed on holiday with Ep-

stein, one of several of Mandelson's friends or former friends, which raised questions about the ex-ambassador's judgment.

In 2008, it was revealed that Mandelson had spent time on a yacht belonging to Russian businessman Oleg Deripaska, who is now under sanctions over Russia's war in Ukraine. Mandelson denied granting favours to the Russian businessman while he was European trade commissioner.

Several Labour officials

had warned Starmer about employing Mandelson, but the British leader went ahead, believing he could help build UK-U.S. relations under a Trump administration.

A spokesperson for Starmer told reporters that after reviewing the new information, Starmer had taken "prompt and decisive action" earlier on Thursday, saying the British leader found the emails "reprehensible".

But some lawmakers in his party suggested

Starmer should have moved more swiftly against Mandelson. The prime minister was also criticized after he backed his former deputy, Angela Rayner, when questions were raised late last month about her tax affairs, before he accepted her resignation last week.

With economic growth failing to ignite, potential tax rises looming and Nigel Farage's populist Reform UK overtaking Labour in the polls, Starmer's party is growing restless.

## ■ Phillipson and Powell confirmed as final contenders in Labour deputy race

**BRIDGET PHILLIPSON** will square off against **Lucy Powell** for the Labour deputy leadership, as the duo emerged as the only candidates with enough votes to enter the party's ballot.

The position has been vacant since Angela Rayner's resignation last week, and although the Prime Minister can make his preferences plain, Labour Party rules mandate a vote of the parliamentary members for the position.

It all makes for a difficult week for Sir Kier Starmer, with Downing Street reportedly 'in turmoil' following Thursday's sacking of US Ambassador Peter Mandelson.

Powell clinched 117 MPs' nominations, taking her over the threshold to enter the ballot, while Bell Ribeiro-Addy, the leftwing Labour MP, failed to make the cut-off.

Phillipson, the education secretary, had already won enough nominations from MPs by Wednesday night but added to her tally of endorsements on Thursday, reaching 175.

Phillipson said: "I am so proud to have received well over half the nominations made by Labour MPs from all wings of our party and from all corners of the country.

"Labour only wins when our party comes together: that is why I plan to give a voice at the cabinet table to all parts of our movement so that we have the best chance of delivering a second term.

### 'bridge for all'

"My message now to Labour party members is simple: back me to unite our party and our movement so we can beat Reform at the next election and build the Britain our children deserve."

After clinching the nominations, Powell said: "This is not a contest I expected nor any of us wanted but we must use it to focus on how the new deputy leader can be a bridge for all parts of our movement and help the government deliver the progressive change the country needs.

"I am Labour through and through. I will al-

ways fight for our party, our values and our traditions. At a time when there are forces trying to spread division and hatred, Labour must be the voice of unity and hope.

Labour MPs have depicted the race as a proxy war between the prime minister and the Greater Manchester mayor, Andy Burnham, often tipped as a successor to Starmer. Powell, the MP for Manchester Central who was recently removed as leader of the House of Commons, is close to Burnham and was endorsed by him for the deputy leadership. He also told reporters this week it was vital that Starmer's deputy be someone from the north of the country, adding to the widespread sentiment at the party's grass roots that is upper ranks are 'too southern and too middle class' and thus out of touch with the party's working class roots.

Powell's team have dismissed the talk of proxies as wrong and sexist, but there are increasing fears about how the deputy leadership debate will play out. Many of those MPs

who were removed in the recent reshuffle have backed Powell.

Lord Mandelson was forced to quit over new-

ly revealed affectionate emails with the late child sex offender and billionaire Jeffrey Epstein. The group said the misjudg-

ment over Mandelson's appointment showed Starmer was running a "narrow and brittle political project".

## Rayner: in the end, she had to go

**Angela Rayner resigned as deputy prime minister and housing secretary on Friday after failing to pay enough tax on her £800,000 flat in Hove.**

Her departure comes after the prime minister's ethics adviser Sir Laurie Magnus said Rayner had "acted with integrity" but concluded that she had breached the ministerial code.

He said she did get legal advice when buying the property, but failed to seek further expert tax advice as recommended.

Writing to the PM, Rayner said she accepted she "did not meet the highest standards" when purchasing her property.

"I deeply regret my decision to not seek additional specialist tax advice given both my position as housing secretary and my complex family arrangements."

Rayner said she took "full responsibility for this error", adding: "It was never my intention to do anything other than pay the right amount."

Her resignation is a

huge blow for the prime minister who began the week with a shake-up of his Downing Street team in the hope of putting a difficult first year in government behind him.

It also kicked off a big reshuffle of ministers at the top of government, with David Lammy leaving his foreign secretary role to replace Rayner as deputy prime minister.

Lammy also takes on the justice secretary role, while Shabana Mahmood moves to the Home Office.

## Starmmer reported to ICC for Chagos

The Prime Minister has been reported to the International Criminal Court and accused of crimes against humanity by campaigners for the Chagos community.

Sir Keir Starmer is accused of preparing to allow the "deportation or forcible transfer of population" of the Chagos Islands after the archipelago was handed over to Mauritius.

The referral to the ICC brands the movement of Chagossians from the islands in the 1960s and 70s "one of the longest-standing and most egregious cases of displacement in modern history".

It adds Sir Keir and former Foreign Secretary David Lammy have "knowingly perpetuated crimes against humanity" by failing to allow them to return.

The referral adds: "By signing and promoting the May 22, 2025, agreement, the Prime Minister has knowingly entrenched deportation, persecution and other inhumane acts."

Sir Keir was criticised for the surrender of the islands to Mauritius.

Fury was compounded after he agreed to pay up to £47 billion over the next 100 years to Mauritius to lease the Diego Garcia military base back.

Campaigners briefly disrupted the signing of the deal, being granted a short interim injunction hours before it was handed over.

Campaign chief Beatrice Pompe said: "We are pleading with all those who have the power to make a difference to please step in and stop these crimes against humanity. We are the indigenous of the Chagos Islands, we bear their name, and we need our voices to be heard."

# Harry meets Charles in London as hopes of reconciliation rise

■ Relations between father and son have been frosty for several years

**PRINCE Harry** this week met his father for the first time in 19 months, boosting reconciliation hopes.

The King hosted a 55-minute private tea for his estranged younger son in his London home. It was the first time that Charles and Harry have met since the Duke of Sussex flew in from California after the monarch's cancer diagnosis was made public in February last year.

Relations have been fraught following Harry's repeated public attacks on the Royal Family in the five years since he and his wife Meghan stepped down as senior working royals.

Buckingham Palace and the Duke's office both declined to give further details of Wednesday's brief get-together, but Harry said of the King "Yes, he's great, thank you" when he was asked at a later Invictus Games event.

### less than an hour

The Prince had been driven to Clarence House at 5.20pm after an engagement at the Centre for Blast Injury Studies in Imperial College London. The King, who is still having regular cancer treatment, had earlier returned to the capital from Balmoral for several audiences – and Wednesday afternoon was the only time Harry had free from engagements in his four-day UK trip.

At 4.15pm the King presented Holocaust survivor Manfred Goldberg, 94, with an MBE.

The Duke then spent just less than an hour at Clarence House before crossing London to the Invictus Games Foundation event.

Heavy traffic on the four-mile trip, made worse by Tube strike crowds, meant Harry was nearly three quarters of an hour later arriving at the Gherkin skyscraper.

His estrangement from the Royal Family means he is ineligible for a jam-busting police convoy.

Father and son's February 2024 meeting lasted just 45 minutes and they have barely spoken since. But while the feud played out in public, sources close to the King have repeatedly said the monarch is "a forgiving man who very much loves his son".

### 'peace summit'

The comments signalled that the door to reconciliation remained open and over recent months there have been signs that tensions are easing.

In July, senior aides to the King and the Duke were pictured together in London in what was dubbed a "peace summit".

While the term may have been an exaggeration, it showed the first steps towards opening channels of communication. In May, Harry had lost his legal battle for Home Office-provided security when on UK soil. While a devastating blow to him, it removed another hurdle to repairing relations as Harry was no longer suing the King's Government in the King's courts.

This week's visit may be seen as a test of the Duke's loyalty and trustworthiness after so many leaks and briefings attributed to his team, with both sides so far remaining tight-lipped about the meeting.

While hopes of a father-son reconciliation were raised, Harry and older brother William remained very much estranged – Wednesday was the third day in a row that the two conducted engagements in the UK, echoing royal life from the 2010s. But instead of teaming up to mark World Suicide Prevention Day as in the past, the brothers had separate engagements.

### brothers apart

The Prince of Wales went to Cardiff to launch

a mental health center and was praised for raising the profile of the issue. The future King was at the city's Principality Stadium to see its hub run by the Jac Lewis Foundation with funding from the Royal Foundation of the Prince and Princess of Wales.

It will provide support to hundreds of people who may be at risk of suicide – a safe space where locals can access professional wellbeing and mental health services.

The charity was set

up in memory of footballer Jac, who was 27 when he died by suicide in February 2019. William met his parents Jesse and Janet on the pitch with his friends and former Ammanford AFC teammates Rhys Fisher and Shaun Williams, who started the foundation.

More than 7,000 people die by suicide each year in the UK – an average of 19 lives lost per day. Men account for 75% of suicides and rates are the highest in the North of England and Wales.

## London-born boy becomes first millennial saint

A London-born boy has become the first millennial saint, in a ceremony steeped in an ancient ritual presided over by Pope Leo on Sunday.

In his short life, Carlo Acutis created websites documenting "miracles" as a means of spreading Catholic teaching, leading some to nickname him God's influencer.

His canonization had been due in late April,

but was postponed following the death of Pope Francis.

More than a million people are estimated to have made a pilgrimage to the Italian hilltop town of Assisi where Carlo's body lies, preserved in wax.

But there is another pilgrimage site associated with Carlo Acutis that has seen an increase in visitors since it was announced that he

was to be made a saint – Our Lady of Dolours Church in London.

The font at the back of the Roman Catholic church in the Chelsea area was where Carlo was baptized as a baby in 1991.

To the side of the church an old confession booth has been converted into a shrine to him. In it, a relic holder contains a single

# Supertramp founder Rick Davies dies at 81, a decade after being diagnosed with cancer

■ **Davies formed the band in 1969 and wrote hits like Goodbye Stranger and Bloody Well Right**

**Supertramp founder Rick Davies, who wrote and sang some of the rock band's hits, has died at the age of 81.**

The English vocalist and keyboardist died on Saturday, a decade after being diagnosed with multiple myeloma, a type of blood cancer, the band said.

"As co-writer, along with partner Roger Hodgson, he was the voice and pianist behind Supertramp's most iconic songs, leaving an indelible mark on rock music history," a statement said. "His soulful vocals and unmistakable touch on the Wurliitzer became the heartbeat of the bands' sound."

Davies wrote songs including 1974's *Bloody Well Right*, their US chart breakthrough; and 1979's

*Goodbye Stranger*.

Born in Swindon, Wiltshire, in 1944, Davies started off in a series of bands including one called The Joint. They didn't make it big but did attract the support of Dutch millionaire Stanley August Miesegaes, who offered to back Davies if he started a new group.

## chart success

So Davies put an advert for new bandmates in *Melody Maker* magazine in 1969, and Supertramp were born, with funding from Miesegaes for their first few years.

Davies shared writing and vocals with Hodgson, and the band found chart success with their third album, *Crime of the Century*, in 1974.

They made it big in the USA five years later with

the album *Breakfast In America*, which included hit singles *The Logical Song* and the title track, as well as *Goodbye Stranger*.

The LP sold more than 30 million copies worldwide and was nominated for two Grammy Awards in 1980, including album of the year.

Relations between the two frontmen soured, however, and Hodgson left the group in 1983.

Davies continued to record and tour with Supertramp. They announced a reunion tour in 2015, but it was cancelled when Davies was diagnosed with cancer.

## 'resilience'

"Beyond the stage, Rick was known for his warmth, resilience, and devotion to his wife Sue, with whom he shared



"Rick's music and legacy continue to inspire many," the band said in tribute

over five decades," the band added in their statement.

"After facing serious health challenges, which kept him unable to continue touring as Supertramp, he enjoyed performing with his hometown buds as Ricky and the Rockets.

"Rick's music and legacy continue to inspire many and bears testament to the fact that great songs

never die, they live on."

Supertramp's classic line-up also included bassist Dougie Thomson, saxophonist John Helliwell and drummer Bob Siebenberg.

In 1977, Davies and Hodgson agreed to reduce their 50% share of songwriting royalties in order to give the trio and the band's manager a cut - a move Hodgson said

was intended "to keep the band functioning and happy".

That arrangement lasted until 2018, and Thomson, Helliwell and Siebenberg sued Hodgson and Davies in 2021.

Davies settled out of court in 2023. Last month, a US appeals court ruled that Hodgson must share royalties with his ex-bandmates.

## Smuggling gangs 'wreaking havoc' says new Home Secretary Mahmood

■ **1,097 migrants arrived in small boats on her first day in office**

**Home Secretary Shabana Mahmood said smuggling gangs are "wreaking havoc" after 1,097 migrants arrived in small boats on her first day in office.**

It took this year's total Channel arrivals past 30,000 in record time, increasing pressure on Sir Keir Starmer following his Friday reshuffle after Angela Rayner quit over a tax scandal. Ms Mahmood has vowed to "explore all options to restore order to our immigration system" and sources close to her added nothing is "off the table".

After the migrants reached the UK on Saturday, the new Home Secretary said: "These small

boat crossings are utterly unacceptable and the vile people smugglers behind them are wreaking havoc on our borders.

"Thanks to our deal with France, people crossing in small boats can now be detained and removed to France and I expect the first returns to take place imminently

"Protecting the UK border is my priority as Home Secretary."

Ms Mahmood met with her government counterparts from the US, Australia, Canada and New Zealand in London this week regarding measures aimed at stopping the people-smuggling gangs. The Home Office said the Five Eyes security alliance also discussed

plans to tackle child sexual abuse online and the spread of deadly synthetic opioids such as fentanyl.

Ms Mahmood said: "Rebuilding our reputation on the world stage is how we tackle serious organised crime and secure our borders.

"We have already reset our relationship with the EU, struck a people smuggling deal with the G7 and operationalised a first-of-its-kind returns agreement with France.

"We will agree new measures to protect our borders with our Five Eyes partners, hitting people smugglers hard.

"As the security threats we all face become more complex and

span continents, we are stronger and safer together." Ms Mahmood took over as Home Secretary from Yvette Cooper, who in turn replaced David Lammy as Foreign Secretary, in the Cabinet reshuffle that had been triggered by Deputy PM Ms Rayner's exit.

Saturday's arrivals took this year's total to

30,100 - 37% up on the 22,028 at the same point last year.

Ms Mahmood is expected to move shortly to prevent foreign criminals and failed asylum seekers from avoiding deportation.

The former Justice Secretary is set to tighten up on "the interpretation and the application" of

Article 8 of the European Convention on Human Rights - the right to a family life - in the shape of fresh guidance or even additional legislation.

Shadow Home Secretary Chris Philp said: "These are the same gangs Labour promised to 'smash' at the last election. They are now admitting they have failed."

# Parthenogenesis in Shropshire! zoo iguana gives birth to eight hatchlings - without mating

Animals giving birth is not usually shocking for staff at Telford's Exotic Zoo, but a lizard in their care recently left them stunned after giving birth without mating.

A female casque-headed iguana produced eight hatchlings during the last week of August in a so-called "virgin birth" at the Shropshire zoo.

## "quite surprised"

It is due to a process called parthenogenesis, which allows unfertilized eggs to develop into embryos, creating offspring that are identical genetic clones of their mother.

"When we confirmed the eggs were fertile without any contact with a male, our jaws hit the floor," said Scott Adams, the zoo's owner.

"We were quite surprised when our long-term resident decided to lay some eggs, we thought, we'll pop them in the incubator," Mr Adams said, "they stayed looking quite white, quite healthy."

"A couple of months later, we've got eight babies running around."

"They're all females, they're all pretty much clones of mum," Mr Adams said.

"They all speak at

exactly the same time," he joked.

"This is one of the rarest events in the animal kingdom."

## "life finds a way"

The hatchlings are living in the zoo's specialist reptile nursery, where temperature and humidity is maintained around the clock.

"For us, it's a powerful reminder that life finds a way in the most unexpected circumstances."

It is hoped they will be on display in a public enclosure in the coming weeks, while two of the babies are heading off to another

zoo.

Casque-headed iguanas are native to Central and South America, and the zoo said this was one of few documented cases

of parthenogenesis in zoos worldwide.

"This story gives us an amazing opportunity to talk with our visitors about genetics, evolution, and the

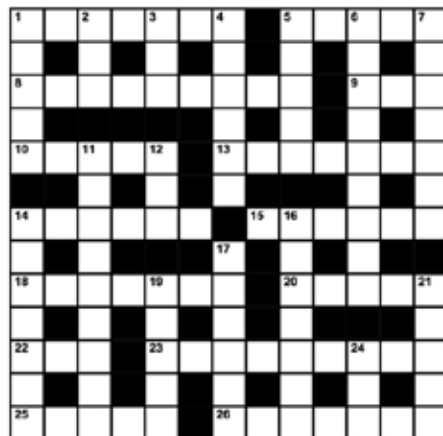
challenges that reptiles face in the wild," said Mr Adams.

"It's not just exciting, it's important for science and conservation education too."

strand of Carlo's hair.

"His family were in finance and they were working really temporarily in London," says Father Paul Addison, a friar at the church.

"Although they didn't use the church much, they decided to

come and ask to have the child baptized. So Carlo was a flash, a very big flash, in the life of the parish community," he says.

Carlo was not yet six months old when his parents moved back to their home country of Italy, and he spent the rest of his life in Milan.

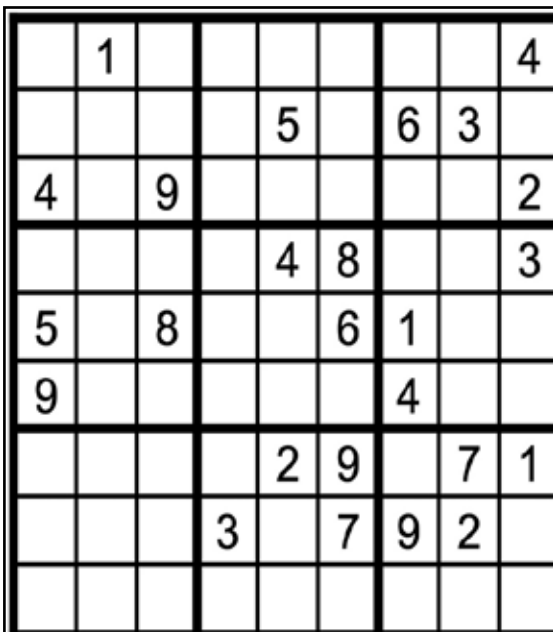
While some who knew Carlo Acutis say he did not appear to be

especially devout, as a teenager he did create a website – pages of which are now framed at the church in Chelsea – in which miracles were documented.

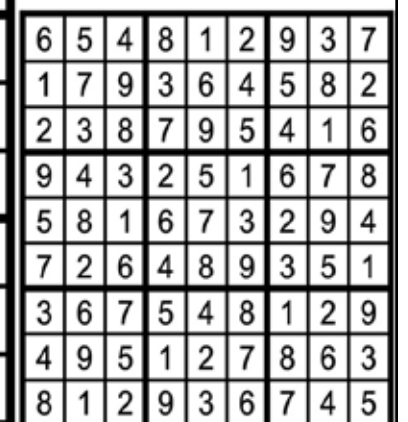
Carlo died of leukaemia aged just 15.

In the years after his death, Carlo's mother, Antonia Salzano, visited churches around the world to advocate for him to be a saint.

# I'll be brave, promises Tuchel

■ Basking in the glow of humbling Serbia, England coach vows to leave out the big names if the new stars earn their place

THOMAS TUCHEL has promised to carry on being "brave" – even at the expense of some of England's big names.

England produced one of their best results in years by thrashing Serbia 5-0 on Tuesday and did it without Jude Bellingham, Bukayo Saka, Cole Palmer and Trent Alexander-Arnold.

Morgan Rogers, Noni Madueke and Elliot Anderson stepped up and have staked a claim ahead of next year's World Cup, with Tuchel promising competition will be fierce.

wanted a tighter squad to ensure there is positive tension in the camp and also that players will always see every call-up as a privilege.

But he also spelled out that he is ready to make big calls – and will do it again ahead of next summer's tournament. Tuchel said: "I'm always brave. You know that. But I don't talk now about hypothetical names that can be left

out. Let's see who's fit and available.

"We took some brave decisions already. We nominated a squad of only 21 to keep the competition going.

"The competition is on. If you are in camp, you are in your best behaviour, your best shape, best form and you make the best of it.

"It's a privilege to be in camp and then fight for your place.

"If you can, help everyone to be better and to grow and this is what we did."

Tuchel also says that the win in Serbia underlined just how important

teamwork is together with team spirit.

He added: "This was teamwork in its purest form. They have the quality to play for us and hunger to play for their

country and everyone gets his chance.

"If a big player misses out on a tournament, we need solutions, if he misses a camp, we need to have solutions.

"We have to focus on guys who are available and who are ready to be the best versions of themselves and the best teammate possible and this is what we did."

## Ange given Forest hot seat

Ange Postecoglou says he doesn't "have to prove anything to anyone" as he starts his reign as Nottingham Forest's new boss.

Postecoglou was appointed on Tuesday, with the club sacking Nuno Espirito Santo late on Monday after 21 months in charge at the City Ground.

The Australian returns to management three months after he

was sacked by Tottenham following a dismal Premier League season, in which they finished 17th.

However, Postecoglou ended Spurs' 17-year trophy drought by leading them to the Europa League title in May.

The 60-year-old was initially praised for the attacking style he implemented at Spurs, but he was forced to defend himself from criticism for

sticking to his high-intensity principles as Spurs lost 22 of their 38 league matches last season.

Asked if he wanted to prove doubters wrong, Postecoglou said: "I don't see it as a point to prove. I don't have to prove anything to anyone.

"I do like my teams to play exciting football and score goals and get fans excited. I make no apol-
