# King hails 'enduring bond'

**"Anchored by the deep friendship between our people, this relationship which, with good reason, we and our predecessors have long called 'special', has made us safer and stronger."**

THE King hailed the "enduring bond", "deep friendship" and "unparalleled partnership" of Britain and the US at this week's white tie State Banquet held in Donald Trump's honour.

He spoke of a "new era" in the special relationship between the two nations in a short speech peppered with jokes, cultural references and personal flourishes.

On the first day of the president's second such State Visit, the King said: "This unique and important occasion reflects the enduring bond between our two nations.

"Anchored by the deep friendship between our people, this relationship which, with good reason, we and our predecessors have long called 'special', has made us safer and stronger."

## 'lionhearted kingdom'

Referring to next July's 250th anniversary of the US Declaration of Independence, he continued: "It is remarkable how far we have come... The ocean may still divide us, but in so many other ways we are now the closest of kin.

"Today, our alliance spans every field of endeavour and shows vast potential for growth.

"The United Kingdom was your partner in the first trade deal of your administration, Mr President, bringing jobs and growth to both our coun-

tries. And no doubt we can go even further as we build this new era of our partnership."

In his address, full of respect for Britain and the monarchy, Mr Trump called the visit "truly one of the highest honours of my life".

Praising the UK as a "lionhearted kingdom", he said the two nations are "each beautiful on its own but really meant to be together", before adding: "The bond is priceless, eternal, irreplaceable and unbreakable.

"But this is truly one of the highest honours of my life..."

"For many decades, His Majesty the King has epitomized the fortitude, nobility and the spirit of the British monarchy and the British people."

Addressing the King, Mr Trump said: "I have such respect for you and such respect for this country", before saying that "his remarkable son, HRH The Prince of Wales", would have "unbelievable success in the future".

He then described his wife Princess Katherine as "so radiant, and so healthy and so beautiful".

Wrapping up his speech, Mr Trump

heaped praise on the King and Queen, saying: "A very very special man, and also a very very special Queen. It's a great honour to be with you."

Earlier the King had made jokes about Britain's "splendid golf courses" and the American media's attempt to marry him off to President Nixon's daughter Tricia in the 1970s as well as more serious references to conflicts and efforts to build a better world.

## 'renewing our bond'

The 76-year-old monarch also spoke about safeguarding the planet while addressing the climate change-sceptic US leader: "Our legacy for the next 250 years and beyond is to ensure that our children, grandchildren and those who come after them can experience the awe and magnificence of the natural treasures found in the countryside, on the coasts, in the seas."

His Majesty then concluded his address by proposing a toast and adding: "In renewing our bond tonight, we do so with unshakeable trust in our friendship and in our shared commitment to independence and liberty."

The banquet was held

in Windsor Castle's grand Great Hall, with 160 guests seated at a 52-yard table.

The guest list reflected the transatlantic relationship.

As well as politicians, dignitaries, business leaders and members of the Royal Family, attendees included Apple boss Tim Cook, golfer Nick Faldo, media magnate Rupert Murdoch and GB rower Dame Katherine Grainger.

## grand entrance

Guests tucked into Hampshire watercress panna cotta and quail egg salad before a main course of chicken ballotin then dessert of a vanilla ice cream bombe with Kentish raspberry sorbet. Drinks included Warre's 1945 Vintage Port in recognition of Mr Trump being the 45th and 47th US

President.

Earlier in the day the royal red carpet was rolled out for the Trumps, with a carriage procession through the private Windsor estate, an unprecedented military ceremony, a Red Arrows flypast and an opportunity to lay a wreath on the tomb of the late Queen Elizabeth.

Mr Trump, 79, and wife Melania, 55, made a grand entrance as the president's Marine One helicopter landed on the lawn of the Walled Garden just after noon.

Prince William, 43, welcomed Mr Trump with a handshake and the president patted the heir to the throne affectionately on his right arm and said: "Hello, my friend. How are you?"

Kate, also 43, who was wearing a maroon Emilia Wickstead dress, a Jane Taylor hat and a feath-

er brooch, greeted Mr Trump with a handshake and a beaming smile. He told her: "You're so beautiful, so beautiful."

William and Kate escorted the couple, who walked hand-in-hand, to Victoria House, where King Charles and Queen Camilla were waiting on the gravel pathway.

Built in 1844 during Queen Victoria's reign, the house is not typically used for royal engagements. But it is just one of the changes to the traditional format of a state visit - due to it being Mr Trump's second.

William said: "This is my father," as they approached the 76-year-old monarch.

After a few minutes of animated conversation, the Trumps joined the senior royals for a scenic carriage ride through the Windsor estate.

# MP Danny Kruger says Tory party 'is over' as he defects to Reform

■ East Wiltshire MP says he hopes others follow his path and accuses former party of clinging to 'defunct institutions'

Conservative MP Danny Kruger has become the first sitting Conservative MP to defect to Reform UK.

Kruger has been an MP since 2019, and sat on Tory leader Kemi Badenoch's team as a shadow work and pensions minister.

"The Conservatives are over," he told a press conference, sitting alongside Reform party leader Nigel Farage.

Kruger said he had been "honoured" to be asked to help Reform prepare for government, and said he hoped that Farage would be the next prime minister.

The East Wiltshire MP - who has said he

would not be triggering a by-election - said the Conservatives were no longer the main party of opposition.

## "toxic brand"

He said: "There have been moments when I have been very proud to belong to the Tory party", but added: "The rule of our time in office was failure.

"Bigger government, social decline, lower wages, higher taxes and less of what ordinary people actually wanted."

He added: "This is my tragic conclusion, the Conservative Party is over, over as a national party, over as the principal opposition to the

left."

Although he said he had "great regard" for Badenoch, he said the Tory party had a "toxic brand", adding: "We have had a year of stasis and drift and the sham unity that comes from not doing anything bold or difficult or controversial."

Describing his move leaving a party he has been a member of for 20 years as "personally painful", he said his "mission" with Reform would be to "not just to overthrow the current system, it is to restore the system we need".

Kruger's defection is damaging for Badenoch, not only as a Tory think-

er and veteran, but also as the most significant among several from the party moving to Reform.

Speaking after the press conference, Kruger told the BBC he had come to the conclusion the Conservative Party doesn't have "any chance" of winning the next election.

## New blow for Starmer as senior aide quits over offensive text messages

Paul Ovenden, a senior aide to Prime Minister Sir Keir Starmer, has resigned after offensive and sexual text messages came to light in which he recounted a conversation

about veteran MP Diane Abbott.

The messages were reported in the Daily Mail, and are understood to have been made eight years ago, as part of an on-

line private conversation.

In a statement to ITV News, Mr Ovenden said he was "truly, deeply sorry for it and the hurt it will cause".

A spokesperson for

the prime minister called the messages "appalling and unacceptable", saying: "As the first black woman to be elected to Parliament, Diane Abbott is a trailblazer who has faced horrendous abuse throughout her political career."

They added: "These kinds of comments have no place in our politics."

Abbott has declined to comment on Mr Ovenden's resignation.

Mr Ovenden was Sir Keir's director of political strategy and the messages are understood to have

been made when he was a press officer for the Labour party.

In the messages, he recounted colleagues' comments made during a more explicit version of the game Snog, Marry, Avoid with graphic sexual imagery relating to Abbott.

Abbott is the longest-serving female MP in

Parliament, having represented the Hackney North and Stoke Newington constituency since 1987.

For much of her parliamentary career she has been a Labour MP, but earlier this year was suspended from the Parliamentary Labour Party for comments she made about racism.

# Stay in your lane, Elon!

■ Home Secretary rebukes Musk for chilling warning at Tommy Robinson rally in London which drew 150,000

ELON MUSK has been told to not to interfere with British democracy after he addressed a 150,000 strong rally in central London on Saturday, telling them to 'fight back or die'.

Home Secretary Shabana Mahmood said the language used by Musk when addressing the "Unite The Kingdom" march in London, organized by far-right activist Tommy Robinson, was "abhorrent".

Speaking over a video link, the tech billionaire criticised "uncontrolled migration", later adding: "Whether you choose violence or not, violence is coming to you. You either fight back or you die."

## 'deeply dangerous'

He also said there had to be "a change of government in Britain" and that there should be a "dissolution of Parliament and a new vote held".

Responding to his comments, Mahmood said: "Whether you're a hostile state or a hostile billionaire, no-one gets to mess with British democracy."

She added that the "vast majority" of people would react to Musk's

words with "a shake of the head".

Liberal Democrat leader Sir Ed Davey has also criticised Musk, telling the BBC: "He doesn't use language sensibly, he is deeply irresponsible, deeply dangerous."

Earlier on X, the social media platform owned by Musk, Sir Ed had said British democracy was "too precious to be a plaything for foreign tech barons" adding: "Elon Musk doesn't care about the British people or our rights. He only cares about himself and his ego."

Musk said Sir Ed was "a craven coward".

Speakers at the main protest expressed anti-immigration sentiments and spoke in favour of freedom of speech.

As part of the event, Musk had a conversation with Robinson during which he made his controversial comments.

Musk said: "I think there's something beautiful about being British and what I see happening here is a destruction of Britain, initially a slow erosion but rapidly increasing erosion of Britain with massive uncontrolled migration."

"This is a message to

the reasonable centre, the people who ordinarily wouldn't get involved in politics, who just want to live their lives.

"They don't want that, they're quiet, they just go about their business."

## 'ambiguity'

"My message is to them: if this continues, that violence is going to come to you, you will have no choice."

Asked about his comments in Parliament, Mahmood said Britain was "a tolerant country and yes, we are a diverse country".

"You can be English with roots that stretched back a thousand years.

"But you can also be English and look like me." Earlier, a Downing Street spokesman echoed Mahmood's comments saying: "The last thing the British people want is this sort of dangerous and inflammatory language which threatens violence and intimidation on our streets."

"I don't think the British people will have any truck with that kind of language and rightly so."

The Liberal Democrats have called on the government to rule out awarding contracts to Musk's Tesla

company which produces electric vehicles, batteries and solar panels.

He also said he would encourage people to leave Musk's social media platform X but that he would be staying, saying the Liberal Democrats were "calling him out on his own platform".

Taking questions at a press conference on Monday, Reform UK leader Nigel Farage was also asked about Musk's language.

He said there was a "degree of ambiguity" in his words but added: "If the fight that Musk was

talking about was about standing up for our rights and free speech, if it was about fighting in elections

to overcome the established parties, then that absolutely is the fight that we're in."

## Royals mourn the Duchess of Kent

King Charles and other senior royals have gathered with friends and family to remember Katharine, the Duchess of Kent, whose funeral was held at Westminster Cathedral.

But Queen Camilla sent her "deep regrets" at having to miss the service because she was recovering from acute sinusitis.

The Prince and Princess of Wales, among many who have paid warm tributes to the widely-respected, music-loving duchess,

joined mourners at the Requiem Mass, alongside the Duke of Kent and his three children.

This is the first Catholic funeral for a member of the Royal Family in modern times - and a message from Pope Leo was read out during the service.

The Pope's message praised the duchess for her "dedication to official duties, patronage of charities and devoted care for vulnerable people" and sent his "heartfelt condolences, together with the assurance of

my prayerful closeness" to the King, the Duke of Kent and their family.

Queen Camilla's absence because of ill health was announced by the palace ahead of the funeral.

"Her thoughts and prayers will be with the Duke of Kent and all the family," said a statement from Buckingham Palace.

Princess Anne and her husband Sir Tim Laurence and Prince Andrew with his former wife Sarah Ferguson were among the roy-

# Aristocrat and rapist lover get 14 years jail for killing their baby

## They 'blamed everyone else' after tot froze to death

**A couple have been jailed for 14 years for the gross negligence manslaughter of their newborn daughter when they went on the run with her to avoid dealing with social services.**

Constance Marten, 38, and Mark Gordon, 51, were sentenced on Monday after being found guilty in July following a lengthy retrial at the Old Bailey.

The decomposed body of their baby, Victoria, was found in a shopping bag in Brighton in 2023. Police had been searching for the couple for 53 days after officers found evidence of a recent birth in a burnt-out car near Bolton.

Passing sentence, Judge Mark Lucraft KC told the couple "neither of you gave much thought to the care or welfare of your baby" and said there had been "no genuine expression of remorse" from either of them.

They were sentenced on the basis Victoria died of hypothermia - both defendants had argued against that during the hearing.

Gordon will serve a further four years on extended licence, the judge said. There was no reaction from either defendant as they were sentenced.

### **heavily pregnant**

The first trial found Marten and Gordon guilty of concealing the birth of a child, perverting the course of justice by not reporting her death, and of child cruelty, but the jury failed to reach a verdict on the manslaughter charge.

The court heard that when Marten was heavily pregnant, they had decided to live off grid to avoid Victoria being taken off them by social care authorities. Their four other children had previously been taken into care.

During the police manhunt that spanned different parts of England once the circumstances of the birth were uncovered, the couple slept outside and took steps to avoid being found, such as taking long taxi rides that criss-crossed the country.

They were eventually located on 27 February 2023, and Victoria was discovered dead two days later in an allotment shed in the Hollingbury area of Brighton.

She had died while the couple were living in a tent on the South Downs in January that year.

### **'tragic accident'**

In their trial, the couple had said Victoria's death was a tragic accident after Marten fell asleep holding the baby - but the prosecution called on evidence from experts on hypothermia, one of whom described the conditions the newborn would have experienced living in a tent in the mid-

dle of winter.

During a months-long retrial, the judge said the couple tried to "sabotage" and "manipulate" proceedings.

Firstly there were many days when one or other of them claimed illness, dental pain or just tiredness from travelling back and forth to court from their respective jail cells, causing proceedings to overrun by many months.

When in court, both displayed disruptive and unpredictable behaviour, disrespected the judge, were rude to dock officers and would often talk

during proceedings.

On one occasion, Judge Lucraft said about Marten that he has "never had that sort of attitude" shown to him by anyone in his 13 years as a full-time judge.

During the latter stages of the retrial, Gordon parted company with his legal team and took on the role of representing himself in court, despite having no legal training.

Disruption continued during Monday's sentencing hearing, during which the judge told off both defendants for passing notes in the dock. He

told them it showed "a complete lack of respect".

During the retrial, the jurors were told of Marten's privileged upbringing in a wealthy family. They also learned that Gordon had been convicted of rape in Florida in 1989 when he was aged 14.

For legal reasons, this conviction - for which he was sentenced to 40 years in prison and deported back to the UK after serving 20 years - was not made known during the first trial, but was disclosed the second time around.

## Main Maddie suspect released from German jail

**German prosecutors' prime suspect in the disappearance of Madeleine McCann has been released from prison in Germany, where he has been serving a sentence for an unrelated offence.**

Christian Brückner was driven out in a black Audi by his lawyer with a police escort shortly after 09:00 local time (07:00 GMT). He could not be seen in the car but police confirmed he had left Sehnde prison.

Brückner had been convicted of raping a 72-year-old American woman in Portugal in 2005, and will

be fitted with an ankle tag after his release from the prison near the northern city of Hanover.

The German national, 48, has never been charged with any crime in relation to the McCann case. He denies any involvement.

Local police spokesman Lars Dehnert told reporters: "We said before that we wanted this to happen as smoothly as possible", adding that Brückner would be escorted for a short distance.

"With this our police operation has terminated," he added.

"We don't have any

knowledge about where Christian B is going to go. This is happening in co-operation with his lawyers," the spokesman said.

One of Brückner's lawyers, Philipp Marquort, added: "I think Mr Brückner is just relieved that all of the release process is over and that he is now out."

He said that "all the drama of today has gone", adding: "I know where he is - but I can't say because he needs to now settle down... before his next court appearance."

In the UK, Metropolitan

Police Commissioner Sir Mark Rowley said Brückner "remains a suspect for us" and that the force's investigation into Madeleine's disappearance remains a missing person inquiry.

### **strict release terms**

Madeleine was three years old when she vanished in the Portuguese resort of Praia da Luz in 2007. She and her siblings had been left sleeping in a holiday apartment while her parents, Kate and Gerry, went to a nearby restaurant.

Her disappearance has

become one of the highest-profile unsolved missing person cases in the world.

German prosecutors have pointed to evidence - including mobile phone data - indicating Brückner may have been in the area when Madeleine vanished, and have consistently insisted that they think he is responsible.

However, they have not found strong enough evidence to bring charges.

Nevertheless, Brückner has been handed strict release terms by a regional court at the request of prosecutors who fear their

suspect could flee beyond their jurisdiction.

He will wear an electronic ankle monitor for five years as part of his probationary supervision, prosecutor Hans Christian Wolters said.

He must also contact a probation officer at least once a month and get court approval of any change of residence, the prosecutor said.

Mr Wolters recently said that "the psychiatric expert assumes that due to his personality, there is a justified risk [that Brückner] will commit crimes again".

# Bloody Sunday shootings 'unnecessary' court told

## ■ Trial of unnamed soldier for 1972 deaths opens in Belfast

The shooting dead of two men on Bloody Sunday was "unnecessary and gratuitous", the trial of a former British soldier has been told.

Soldier F, who cannot be named for legal reasons, is accused of murdering James Wray, 22, and William McKinney, 26, as well as five counts of attempted murder in 1972.

Thirteen people were shot dead by the Parachute Regiment when it opened fire on civil rights demonstrators in the Bogside area of Londonderry. About 15 others were wounded.

The non-jury trial is taking place at Belfast Crown Court, where Soldier F is screened from public view by a black curtain

around part of the dock.

The former paratrooper, whose identity remains protected by a court order, has entered pleas of not guilty.

He also denies the five counts of attempted murder.

Soldier F is further accused of attempting to murder Patrick O'Donnell, Joseph Friel, Joe Mahon, Michael Quinn and an unknown person.

Prosecution lawyer Louis Mably KC said the shootings were "unjustified" and none of the victims posed any threat.

"They were unarmed and shot as they ran away."

Mr Mably went on to allege that the soldiers who fired, including Soldier F, then gave a false

account of what had happened.

"What they did was to falsely claim that the civilians they targeted were armed," he said.

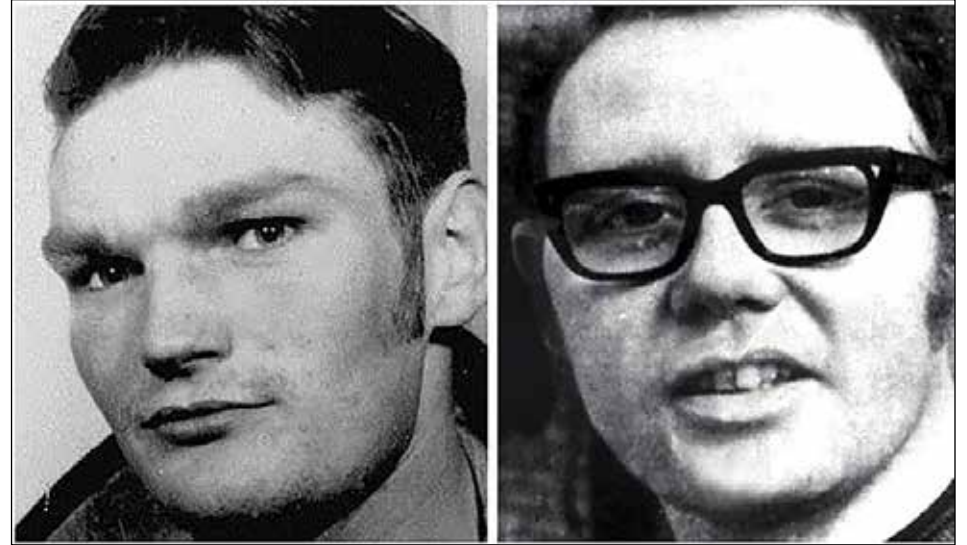
"It was demonstrably false."

Mr Mably told the court Bloody Sunday had had a "long lasting and profound effect" on Northern Ireland.

He said the trial would have a narrow and specific focus on events that took place in a courtyard in the Glenfada Park area of Derry's Bogside.

He said the civilians in the courtyard were unarmed and "did not pose a threat to the soldiers and nor could the soldiers have believed that they did".

The trial continues.

## Cheating scandal rocks stone skimming event

The world stone skimming championships have been rocked by a cheating scandal, after several competitors were disqualified for tampering.

More than 2,200 people, from 27 countries, attended this year's event on the tiny island of Easdale off the west coast of Scotland.

Entrants choose their own stones and judges use a measuring device, the "ring of truth", to ensure they are no bigger than three inches in diameter.

Each competitor is allowed three skims and stones must bounce at least twice on water before sinking.

Rules state that stones must come from naturally occurring island ground into a "suspiciously circular" shape to help them bounce on water.

Organiser Dr Kyle Mathews told reporters that the offenders had "held their hands up"

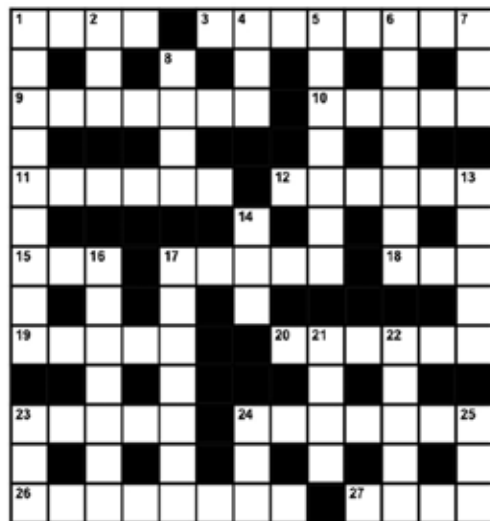

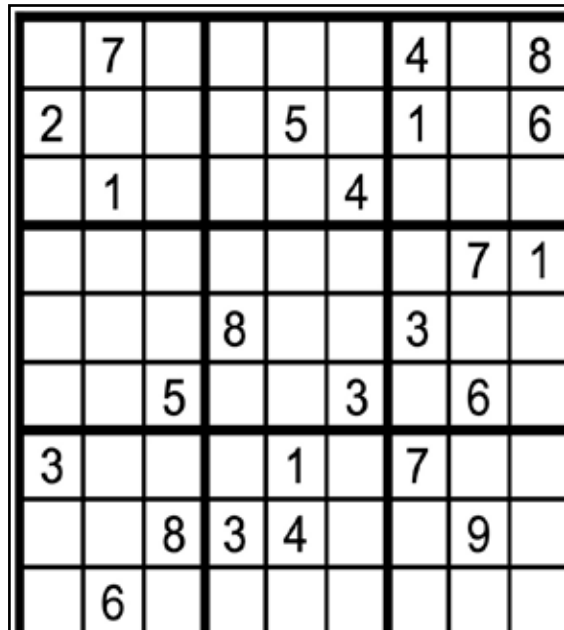

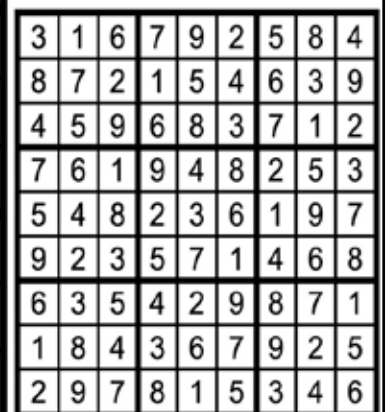

# Huge night for the Brits as Adolescence wins big at the Emmys

Owen Cooper named best supporting actor

British actor Owen Cooper on Sunday became the youngest male ever to win a primetime Emmy Award, in a night dominated by Netflix's acclaimed drama *Adolescence*.

Cooper, 15, was named best supporting actor in a limited series for his portrayal of a schoolboy accused of murdering a classmate.

The four-part drama also won best limited series, as well as prizes for its directing and writing, and acting prizes for Stephen Graham and Erin Doherty.

In his acceptance speech, Cooper said: "Standing up here is just wow, it's just so surreal."

"When I started these drama classes a couple of years back, I didn't expect to even be in the United States, never mind here."

Cooper, who played

teenager Jamie Miller, said: "I think tonight proves if you listen, and you focus and you step out your comfort zone, you can achieve anything in life."

"Who cares if you get embarrassed? Anything can be possible. I was nothing about three years ago, I'm here now."

He also thanked his family, co-stars, and the show's production team, adding: "It may have my name on this award, but it really belongs to the people behind the camera."

Cooper broke the record previously held by Scott Jacoby, who was 16 years old when he won a Primetime Emmy in 1973 for *That Certain Summer*.

Roxana Zal remains the youngest acting winner overall. She was 14 when she won an Emmy in 1984 for *Something About Amelia*. Bindi Irwin is the

youngest person to have won a Daytime Emmy, when she was nine.

*Adolescence* was widely praised by critics and viewers for its exploration of the impact of smartphones and social media on teenagers.

In his acceptance speech for leading actor, Graham said: "This kind of thing normally doesn't happen to a kid like me, I'm just a mixed-race kid from a block of flats in a place called Kirkby."

"So for me to be here today in front of my peers and be acknowledged by you is the most humbling thing I could ever imagine in my life, and it shows you that any dream is possible."

Doherty, who played a child psychologist who works with Jamie, won best supporting actress in a limited series.

## Trump arrests "Orwellian"

The arrest of four men after images of Donald Trump alongside Jeffrey Epstein were projected on to Windsor Castle on Tuesday was "Orwellian" and "ridiculous", the group behind the protest said this week.

The political campaign group Led By Donkeys confirmed that it was behind the stunt, which saw several images of Trump and Epstein projected on to a tower while a soundtrack questioning the relationship between the two men was played on a speaker.

A letter the US president allegedly sent to Epstein was also projected on to the castle, along with pictures of Epstein's victims, news clips about the case and police reports.

The police said in

a statement that four adults were arrested on suspicion of malicious communications after an "unauthorised projection" at Windsor Castle, which they described as a "public stunt". The four remain in custody.

## Tributes flow for Ricky Hatton, boxing great found dead at 46

Former world champion Ricky Hatton (above) has died at the age of 46.

Nicknamed 'the Hitman', he won world titles at light-welterweight and welterweight and was one of Britain's most popular fighters.

His body was found at his home in Manchester on Sunday.

A Greater Manchester Police spokesperson said: "Officers were called by a member of the public to attend Bowlacre Road, Hyde, Tameside, at 6:45am today where they found the body of a 46-year-old man. "There are not currently believed to be any suspicious circumstances."

Hatton, who won 45 of his 48 professional bouts across an esteemed 15-year career, last fought professionally in 2012.

Hatton's younger brother and former boxer Matthew posted on X: "I love you Richard. See you on the other side."

"Ricky was one of a kind," wrote former Manchester United and England midfielder David Beckham on Instagram. "Just heartbreaking."

Former heavyweight world champion Tyson Fury wrote on Instagram: "RIP to the legend Ricky Hatton."

"There will only ever be one Ricky Hatton. Can't believe this - so young."

Hatton was a well-known Manchester City fan and a minute's appreciation - applause, cheers and songs - was held before Sunday's Premier League match against Manchester United at Etihad Stadium.

City manager Pep Guardiola said Hatton was a "true champion" and "part of the Man City family".

Former England and Manchester United footballer Wayne Rooney, who carried Hatton's belts into the ring before a fight with Jose Luis Castillo in 2007, said on X he was "devastated" and Hatton was a "a legend, a warrior and a great person".

Oasis frontman Liam Gallagher posted on X: "Absolutely devastated to hear the news about Ricky Hatton. It was an absolute honour to know him and carry his belts. RIP champ. Live forever."

Hatton earned notable world title wins over Kostya Tszyu and Jose Luis Castillo, before defeats by Floyd Mayweather and Manny Pacquiao.

He inspired a devoted following during his glittering career.

More than 30,000 fans travelled to Las Vegas for Hatton's title fight with Mayweather in 2007, and a chorus of "there's only one Ricky Hatton" echoed around the MGM Grand

even after he was stopped.

Those same chants were heard in his final professional fight in his home city of Manchester five years later.

Hatton made an unsuccessful professional comeback in 2012, when he lost to Vyacheslav Senchenko in Manchester, and fought Marco Antonio Barrera in an exhibition in 2022.

After agreeing to fight former rival turned friend Barrera, Hatton spoke about his battles with depression.

In 2023 he was the subject of a documentary 'Hatton', in which he discussed his personal life and mental health issues.

Former light-welterweight world champion Amir Khan wrote on X: "Today we lost not only one of Britain's greatest boxers, but a friend, a mentor, a warrior."

"Rest well, Ricky. You'll always have your place in the ring of our memories."

Frank Warren was Hatton's promoter from his professional debut in 1997 to his world title victory over Tszyu in 2005.

He wrote on X: "A superbly talented fighter who inspired a generation of young boxers and fans in a way very few had done before, due to both his personality and the entertainment he provided in the ring."

## ■ Former United striker grabs a brace in Champions League opener

Marcus Rashford made a spectacular Champions League bow for Barcelona as Newcastle United's campaign got off to a losing start at St James' Park on Thursday night.

Rashford, on loan from Manchester United, became Newcastle's tormentor when he broke open a tight encounter with two swift second-half goals.

In front of England head coach Thomas Tuchel, Rashford flashed a fine header beyond Newcastle keeper Nick Pope from Jules Kounde's cross after 58 minutes to silence a typically feverish Tyneside atmosphere.

Rashford produced an even better moment nine minutes later when he hammered home a stunning 20-yard drive in off the crossbar past the helpless Pope. These were his first Champi-

ons League goals in almost four years.

It capped a highly impressive night for Rashford, who figured in the Champions League on loan at Aston Villa last season, playing a full part in Barcelona's vast array of attacking talent, even without brilliant injured teenager Lamine Yamal.

Newcastle manager Eddie Howe sprung a selection surprise, leaving new £69m striker Nick Woltemade on the bench in preference to using Anthony Gordon in the central position.

Gordon struggled to make an impact as Barcelona's superiority told the longer the game went on, with Rashford as the deadly finisher.

The England striker was given a deserved standing ovation from Barcelona's supporters when he was substituted with ten minutes left.

Newcastle were given hope of a comeback when Gordon slid home a finish at the start of seven minutes of added time, but Barcelona held out.

England striker Harry Kane exploited error-prone Chelsea to score twice in Bayern Munich's 3-1 Champions League win Wednesday night.

Kane, 32, won and scored a penalty before sealing victory in the second half through a curled shot after a Malo Gusto mistake.

Earlier, Chelsea defender Trevoh Chalobah scored an own goal, while a returning Cole Palmer placed a shot into the top corner to pull one back on his 100th appearance in all competitions for the west Londoners.

There were warnings in the second half as Michael Olise and Kane

missed good chances when Chelsea - back in the Champions League for the first time since the 2022-23 season - were chasing an equaliser.

Ultimately, Gusto's misplaced pass led to

Kane's curled shot in the 63rd minute that ended the match as a contest.

It was one of a number of defensive mistakes, including the visitors switching off at a drop-ball situation

before Chalobah's own goal and midfielder Moises Caicedo bringing Kane down in the box.

Chelsea squandered a positive start, missing early chances through

## Another record for Haaland

Erling Haaland broke another record by becoming the quickest player to score 50 Champions League goals as Manchester City were made to work hard in their opening game victory over Napoli on Thursday.

Haaland took only 49 games to reach the milestone, lofting home a header in the second half to set City on their way to three points, as Kevin de Bruyne's much-anticipated return to Etihad Stadium lasted a disappointing 26 minutes.

De Bruyne left City in the summer after a distinguished decade at the club and was given a warm welcome back by home supporters, but the joy of returning to a

place he calls "home" was short lived.

The Belgium international was sacrificed in the first half by boss Antonio Conte following captain Giovanni di Lorenzo's dismissal for bringing down Haaland as last man.

City took control of the game as expected but Pep Guardiola will have been left wondering how his side did not go in ahead at half-time after peppering the Napoli goal but finding keeper Vanja Milinkovic-Savic in inspired form.

The Serbian made a string of superb saves, keeping out Tijjani Reijnders' drive, smothering Phil Foden's low shot, and pushing away Rodri's well-struck vol-

ley.

Milinkovic-Savic also clawed away headers from Nico O'Reilly and Ruben Dias and somehow grabbed Reijnders' shot on the goalline after it took a deflection off Matteo Politano - all in the first 45 minutes.

But 11 minutes into the second period City made the expected breakthrough as Haaland latched on to Foden's dinked pass and nodded in to finally breach Milinkovic-Savic's goal.

Jeremy Doku showed quick feet to add a second and seal victory, as returns to Manchester for former United players Scott McTominay and Rasmus Hojlund ended in dismay.
