Andrew and Epstein:it just gets worse

- Prince Andrew told Jeffrey Epstein 'we're in this together' in newly released 2011 email
- Royal sent email after Virginia Giuffre photo emerged but later claimed he had cut off Epstein in 2010

Prince Andrew's involvement in the Jeffrey Epstein scandal took another turn this week as it emerged he had told the financier in an email "we are in this together" after a picture of the British royal with his arm around a teenage Virginia Giuffre was first published in 2011.

The email will pile further pressure on the Duke of York and the royal family because he previously claimed he had ceased contact with the convicted child sex offender by that point.

Correspondence between the king's younger brother and Epstein, published in the Mail on Sunday and the Sun on Sunday, appears to show that was not the case.

'keep in close touch'

Andrew emailed Epstein on 28 February 2011, the day after the well-known photograph of the duke, Giuffre and Ghislaine Maxwell was made public. He told Epstein to "keep in close touch" and expressed a wish to "play some more soon".

In 2019, Andrew told

the BBC's Newsnight programme that he broke off his friendship with Epstein in December 2010, after the two men were photographed together strolling in New York.

But he wrote to Epstein in the message after the photo was published: "I'm just as concerned for you! Don't worry about me! It would seem we are in this together and will have to rise above it. Otherwise keep in close touch and we'll play some more soon!!!!"

He is said to have signed off with: "A, HRH The Duke of York, KG."

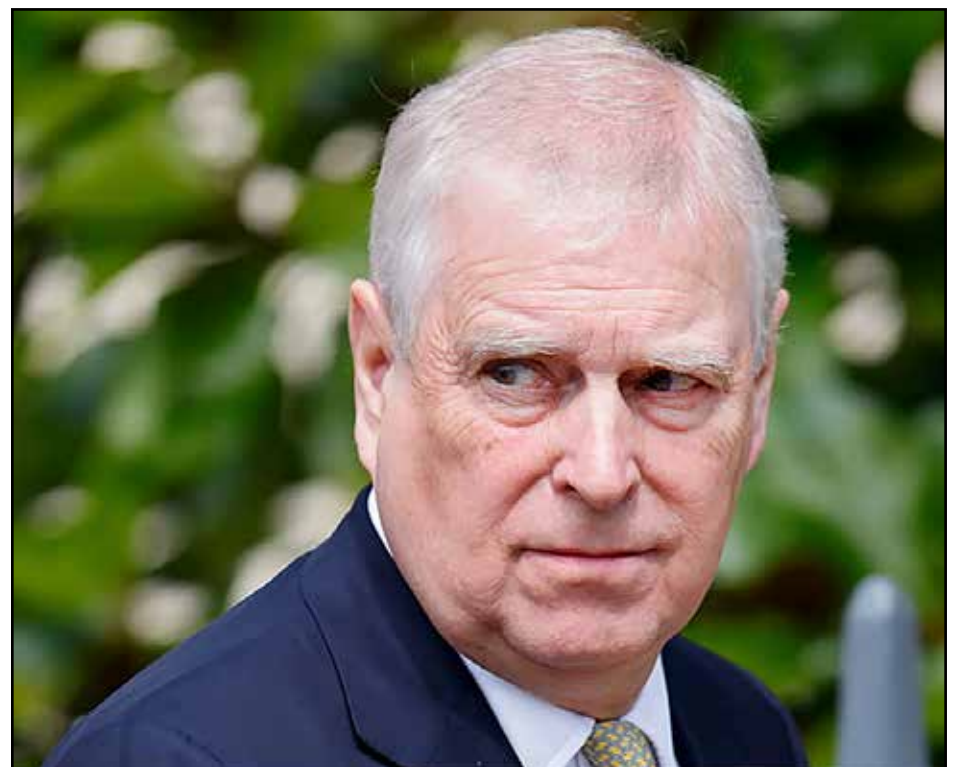
Epstein was found dead in his cell at a federal jail in Manhattan in August 2019 while he awaited trial on sex trafficking charges. The death was ruled a suicide.

In 2008 he pleaded guilty to charges of solicitation of prostitution and of solicitation of prostitution with a minor, for which he served time in jail.

In January this year, a section of the email from the Duke of York emerged in court documents. At the time it was reported to be from a "royal family member".

misleading account

It related to a claim made by the Financial Conduct Authority, the UK banking regulator, and appeared in court documents for a legal case involving the former Barclays chief executive Jes Staley. Staley was appealing against a finding by the watchdog that he had given a misleading

account of the nature of his relationship with Epstein.

In a November 2019 interview with Newsnight, Andrew told the journalist Emily Maitlis: "I ceased contact with him [Epstein] after I was aware that he was under investigation and that was later in 2006 and I wasn't in touch with him again until 2010."

He later said that in December 2010 "I had to show leadership and I had to go and see him and

I had to tell him 'that's it'."

Also this weekend, it emerged that Tony Blair met Epstein in Downing Street while he was prime minister after a recommendation by Peter Mandelson, who last month was sacked as US ambassador after new information emerged about how close he had been to the convicted child sex offender.

Blair's meeting emerged in papers re-

leased at the National Archives and predated Epstein's criminal conviction. Epstein visited Blair on 14 May 2002.

Mandelson was then a backbench Labour MP, having resigned from government for a second time amid controversy. He had described Epstein to Blair's chief of staff, Jonathan Powell, now the UK national security adviser, as "safe" and a "friend" in an email before the meeting.

China spies present 'daily threat' to UK, says MI5 boss

■ Sir Ken McCallum speaks out after controversial collapse of court case, claiming the CCP is intent on carrying out "large scale espionage"

Chinese state operatives present a daily national security threat to the UK, the head of MI5 Sir Ken McCallum has said.

In a speech, he said MI5 had intervened operationally to disrupt Chinese activity of national security concern in the past week.

Addressing a row over the collapse of a case involving alleged spying on behalf of China in the UK, Sir Ken said the alleged activity was disrupted by MI5 and that it was "frustrating when prosecutions fall through".

The government and the Crown Prosecution Service (CPS) are facing questions over the collapse of the case.

The CPS dropped the case last month after deciding the evidence did not show China was a threat to national security.

But witness statements from the UK's deputy national security adviser Matthew Col-

lins - published late on Wednesday - are clear that the Chinese are carrying out spying operations against the UK, raising questions for the government and the CPS about why the prosecutions did not go ahead.

In the documents, he said China was carrying out "large scale espionage" against the UK and was "the biggest state-based threat to the country's economic security".

Sir Ken described Mr Collins as a "man of high integrity and a professional of considerable quality".

In his speech, Sir Ken said "Chinese state actors" presented a threat to UK national security but added that the "overall balance" of the UK's relationship with China was "a matter for the government".

"When it comes to China, the UK needs to defend itself resolutely against threats and seize the opportunities that demonstrably serve our

nation," he said.

The Conservatives have accused the government of allowing the spy case to collapse to avoid jeopardising economic relations with China.

'too weak'

Downing Street said it would have been "absurd" for the PM to step in last month after being told the case was going to collapse, stressing it was a "criminal matter" for the CPS to handle independently.

In a letter to the prime minister, Conservative leader Kemi Badenoch said the events leave "a strong impression that your government undermined Britain's national security because you are too weak to do anything other than appease China".

In his reply, Sir Keir argued that the prosecution's case relied on the then Conservative government's policy towards China at the time of the alleged offences, between 2021 and 2023.



McCallum said China was "the biggest state-based threat to the country's economic security".

"In other words, the prosecution's case required demonstrating that the position of the then Conservative government was that China was an enemy of the United Kingdom," he said, and it was "plainly wrong" to suggest that had been the case.

The head of the CPS Stephen Parkinson is also in the firing line, with MPs suggesting there was sufficient evidence to put the case before a jury.

He is reported to have told senior MPs on Wednesday that the evidence was "5%" short of what would have been required to stand a chance of getting a con-

viction.

Former parliamentary researcher Christopher Cash, 30, and academic Christopher Berry, 33 were accused of collaborating with a Chinese Communist Party leader who was deputy director of the Central National Security Commission, chaired by President Xi Jinping.

In one message, Mr Cash is alleged to have told Mr Berry: "You're in spy territory now."

Both men deny any wrongdoing. China's foreign ministry spokesperson Lin Jian said: "China's position is very clear: we firmly oppose peddling China spy narratives

and vilifying China."

In a Commons debate, former Security Minister Tom Tugendhat, for whom Mr Cash was a parliamentary researcher, accused the government of being obsessed with following the correct process, rather than doing everything it could "to make sure the prosecution works".

"Who the hell's side are you on?" he asked the government.

In a statement released on Wednesday evening, Mr Cash said he had been placed in an "impossible situation" because he had not "had the daylight of a public trial to show my innocence".

New migrants will need 'A-level English skills'



NOT SO EASY? the changes come into force on January 8th next year

Some migrants coming to the UK will need to speak English to an A-level standard under tougher new rules set to be introduced by the government.

The changes, which

will come into force from 8 January 2026, will affect some graduates and those applying for skilled worker or scale-up visas, which are for people employed by fast-growing businesses.

The new rules form part of wider plans to cut levels of immigration to the UK outlined in a white paper in May.

Quash our convictions, demand Skye Bridge scofflaws

When the Skye Bridge opened exactly 30 years ago this week, motorists were charged £4.70 to drive their cars one way over the crossing.

It led to high-profile and often ingenious protests by some islanders, with some even spending time in prison for failing to pay the fine for non-payment.

Now, more than 20 years after the Scottish government bought the bridge and cancelled the tolls, campaigners are calling for their convictions to be scrapped.

Prominent campaigner Robbie the Pict said the convictions should be quashed as a matter of principle.

"I've got 130," he told reporters this week. "On 130 occasions I refused to pay the toll - I've never paid it."

The £20m bridge opened on 16 October 1995, in place of a ferry service which had run between the island village of Kyleakin and the Kyle of Lochalsh.

It was hoped that the 500m (546 yard) crossing would make the island more accessible and help boost its economy.

The bridge was built under the private finance initiative (PFI) and the tolls were set up so the bridge company could recoup its investment.

But the price of a one-way crossing, which soon rose to £5.70 and was said to be the most expensive in Europe, caused anger among the local community and led to almost a decade of protests.

By comparison, at that time motorists were charged 80p to cross the Forth Road Bridge which connected Edin-

Farage threat earns Afghan immigrant five year stretch

A man who came to the UK on a small boat and threatened to kill Nigel Farage has been jailed for five years.

Fayaz Khan, 26, made a gun gesture with his hand, pointed to an AK-47 tattoo on his face and named the Reform UK leader in a TikTok post in October 2024.

Authorities believed the Afghan migrant had given them a false name and he was actually a 31-year-old called Fayaz Hussein, Southwark Crown Court heard.

Speaking outside court, Farage said it was a "win" that "violent criminal" Khan had been jailed.

The defendant was found guilty on Friday of making threats to kill the MP for Clacton, in Essex.

'pretty chilling'

In the video on his "madapasa" account on TikTok, Khan pointed towards his face tattoo and said he was going to "pop, pop, pop" Farage, referring to him as "Englishman Nigel".

Farage described the threat as "pretty chilling" during the trial, adding: "Given his proximity to guns and love of guns, I was genuinely worried."

"The only reason we know about this guy is because somebody sent it to me on TikTok," he added after the sentencing.

"It makes me wonder how many other madapasas are there now in this country?"

It followed Khan shouting from the dock that he wanted to go back to Afghanistan, accusing Farage of using him "because you want to be prime minister".

A Home Office spokesman said: "When foreign nationals commit serious crimes in our

country, we will always do everything in our power to deport them."

Khan was one of 65 migrants on board a black inflatable boat that entered the UK by crossing the English Channel.

"The defendant lives-tweeted the recording of his crossing, which appears to have gathered a large online viewing," said prosecutor Peter Ratliff.

'Enemies'

The court heard Khan gave a false name because he had "enemies he did not want to find him".

However, the prosecution said it was "more likely" he had given misleading details due to his criminal record while living in Sweden.

Mr Ratliff also disputed Khan's claim that he was unaware it was illegal to arrive in the UK by small boat.

He claimed Khan "intended to encourage others" by documenting his journey from Sweden to the UK, sharing it with hundreds of thousands of viewers online.

The court was told Khan had 17 previous convictions in Sweden, including for carrying a knife, threatening behaviour and vandalism.

Khan was also jailed in June 2019 after using threatening behaviour towards a public servant.

On 12 October 2024, Farage uploaded a video to YouTube entitled "the journey of an illegal migrant", which showed Khan and referenced "young males of fighting age coming into our country about whom we know very little".

Jurors in Khan's trial were told he responded with a TikTok video two days later, threatening Farage.

In the video, he said: "You

not know me. I come to England because I want to marry with your sister. You not know me.

"Don't talk about me more. Delete the video.

"I'm coming to England. I'm going to pop, pop, pop."

Mr Ratliff told the jury that while Khan said "pop, pop, pop", he made "gun gestures" with his hand and headbutted the camera.

During sentencing, Khan's barrister said the defendant wanted to

apologise to Farage and his sister "for any offence and upset caused".

He was also sentenced to eight months - to run concurrently - for entering the UK illegally, having previously pleaded guilty to the offence.

Cardiff council takes on the SUVs

Cardiff council will force drivers with larger vehicles to pay more for parking, becoming the first local authority in the UK to impose a parking premium to combat the dangers of larger vehicles.

Councillors voted on Thursday to approve a new parking plan for the city whereby owners of larger vehicles will be charged more for parking permits because their cars "take up more parking space and are a dan-

ger to other road users". The plan states that vehicles that weigh more than 5290lb fully laden will be subject to a surcharge "to encourage drivers to switch to smaller vehicles"; this will later be reduced to 4,000lb for non-electric vehicles.

There has been a growing backlash against the sharp increase in large vehicles on roads, which cause more pollution and are more likely to cause fatalities if involved in a

collision. Research has shown that sports utility vehicles (SUVs), which combine features of a passenger car with an off-road vehicle, have increased from 3% to 30% of existing cars in the past two decades.

Oliver Lord, the UK head of the campaign group Clean Cities, said "other cities across the UK could learn from Cardiff's leadership".

you come to this country, you must learn our language and play your part."

"This country has always welcomed those who come to this country and contribute," Mahmood said.

"But it is unacceptable for migrants to come here without learning our language, unable to contribute to our national life."

Applicants will be tested in person on their speaking, listening, reading and writing at Home Office-approved providers, with their results checked as part of the visa process.

"going rate"

Those applying for skilled worker, scale-up and high potential individual (HPI) visas will be required to reach B2 level - a step up from the current B1 standard which is equivalent to GCSE.

To come to the UK on the skilled worker visa, migrants have to work for a government-approved employer and earn at least £41,700 a year, or the "going rate" for their type of work, whichever is highest.

Further English language requirements for other visa routes and family dependants are expected to be introduced in due course, Home Office Minister Mike Tapp told Parliament on Tuesday.

The prime minister previously said the changes outlined in the white paper would make the UK's immigration system "controlled, selective and fair".

Home Office estimates suggest the measures could reduce the number of people coming to the UK by up to 100,000 per year.

■ Tommy Robinson claims Musk is paying his legal costs as trial begins

Tommy Robinson claimed Elon Musk was paying his legal costs, as he went on trial for refusing to comply with a request made by counter-terrorism police as he tried to leave Britain last year.

The far-right activist, whose real name is Stephen Yaxley Lennon, refused to give police the pin for his phone because it had "journalistic material on it" after they stopped him at the Channel tunnel on 28 July 2024, a court heard.

The activist had arrived alone at the Channel tunnel in a silver Bentley belonging to a friend and was on his way to the Spanish resort of Benidorm with more than £13,000 in a small bag, the first day of the trial at Westminster magistrates court heard.

'vague replies'

The money was said to have been from a collection to offset the expenses from organizing a major rally of Robinson's supporters that took place the day before in Trafalgar Square. Robinson told police he was white English but was travelling on an Irish passport he had recently obtained and that he lived in Spain.

Police were suspicious of his "vague replies" to questions and requested access to his iPhone under schedule 7 of the Terrorism Act, which allows for the stopping of anyone passing through a UK port to "determine whether they may be involved or concerned in the commission, preparation or instigation of acts of terrorism".

Robinson, who denies failing to comply with the counter-terrorism powers, said in video recorded before he entered court: "Thankfully, I haven't

had to beg for donations today because Elon Musk has picked up the legal bill for this absolute state persecution."

Musk had neither confirmed nor denied Robinson's claim at press time.

The X and Tesla boss has emerged as an ally of Robinson and recently appeared on a live video link at a far-right rally organised in London by Robinson, where Musk told the crowd: "Whether you choose violence or not, violence is coming to you."

'emerging threat'

Opening the case, the prosecutor Jo Morris said officers "became concerned" about the activist's demeanour after he drove alone into the police inspection area. He had been recognised by police at an early stage and was restrained when he tried to start filming them and recorded a message that he was being detained, she said.

When he was asked to hand over the phone's pin, Robinson was said to have replied: "Not a chance, bruv ... You look like c**ts so you ain't having it."

He told police at the tunnel and said in a later interview at Folkestone police station that his phone contained information about "vulnerable girls" whom he had spoken to during what he described as his journalistic reporting on grooming gangs.

PC Mitchell Thorogood, a counter-terrorism officer who was in the booth when Robinson arrived at Folkestone, told the court that the Bentley Bentayga SUV - prices for which start at £170,000 - had attracted their attention. It was also a last-minute booking and "unusual" for someone to take a long

trip in someone else's car.

Asked by Robinson's barrister, Alisdair Williamson KC: "Do terrorists drive in high-value, high-visibility vehicles?" he replied that terrorists could drive "any type of vehicle".

The lawyer, who said that the activist "frequently" travels to Benidorm later suggested that stop may have been "discriminatory" against Robinson's political beliefs.

Sgt Farmer, who car-

ried out an initial consideration of the decision to stop Robinson under counter-terrorism powers, told the court that the activist's involvement in the English Defence League (EDL) and the "emerging threat level" from the far right had also been cited as a factor.

Under questioning, Farmer said he had experience as a public order officer policing demonstrations by the EDL. He said he was aware it had

disbanded in 2014 but said there was still a concern over far-right ideology "in terms of perceived Islamophobia".

Earlier, District Judge Sam Goozee gave an instruction that Robinson's address should not be published, after Williamson said there were "credible threats" against the activist's life.

The trial, which is expected to take two days, was adjourned until Tuesday.

burgh and Fife. Protests co-ordinated by Skye and Kyle Against Tolls (Skat) drew in islanders from all walks of life and attracted international attention.

On its opening day, the first motorists arrived at the tollbooths in their cars and refused to pay.

Dozens of cars followed, and driver after driver refused to pay the toll.

Several hours later, after refusing to leave, the protesters were charged and reported to the procurator fiscal.

Other protests involved

driving flocks of sheep across the bridge, while others paid their tolls in pennies.

Hundreds of people refused to pay, with some facing 100 or more criminal charges.

In total, 130 people ended up with criminal convictions, and some spent time in prison because they refused to pay the fines.

Robbie the Pict, who legally changed his name from Brian Robertson and founded the mini state of "Pictland" on an acre of land in Skye in 1977, led the protests.

He said the convictions were more of a "nuisance" than anything else,

and said they should be quashed as a matter of principle.

"There needs to be some form of public inquiry so that these convictions can be quashed and so that people can have their record as a decent citizen properly restored," he said.

"The matter must be pursued. It's not over yet."

The Scottish government finally bought the bridge in 2004 for £27m and cancelled the toll, making the bridge free to use.

Local people celebrated with a huge Hogmanay party on both sides of the bridge, with fireworks lighting up the sky.

Library reissues Oscar Wilde's card

The British Library has honoured late Irish writer Oscar Wilde by reissuing a reader's card in his name, 130 years after his original was revoked following his conviction for "gross indecency".

The celebrated novelist, poet and playwright was excluded from the library's reading room in 1895 over his charge for having had homosexual relationships, which was a criminal offence at the time.

The new card, which was collected by his grandson, author Merlin Holland, on Thursday at a ceremony at the venue on what would have been his grandfather's 171st birthday.

The gesture is intended to "acknowledge the injustices and immense suffering" Wilde faced, the library said.

Mr Holland said the new card is a "lovely gesture of forgiveness and I'm sure his spirit will be touched and delighted".

The decision to revoke Wilde's pass for the library - then the British Museum reading room - was recorded without comment in the trustees' minutes for 15 June 1895.

He had been in prison for three weeks at the time after being handed a two-year prison sentence with hard labour.

The author was convicted after he lost a libel trial against Lord Queensberry, who had accused him of being homosexual after discovering that his son, Lord Alfred Douglas, aka Bosie, was Wilde's lover.

The library regulations at the time said anyone convicted of a crime should have their

card revoked.

The British Library holds handwritten drafts of some of Wilde's most famous plays including *The Importance of Being Earnest*, *An Ideal Husband*, *A Woman of No Importance* and *Lady Windermere's Fan*.

mere's Fan.

Its collection also includes *De Profundis*, the letter he wrote to Bosie from Reading Jail.

Speaking to BBC Radio 4's *Today* programme on Thursday, Mr Holland said he felt both "proud" of his grandfather and slightly burdened by the responsibility of handling his legacy.

"People will so often write in to me and say, 'I cannot tell you how much your grandfather's *De Profundis* meant to me,'" he explained.

"It has a note of positivity at the end... he's going to come out of prison and do something again.

"And people have written to me saying, 'In a moment of terrible depression about my own

life I read *De Profundis*, and I just wanted you to know that your grandfather's letter from prison meant so much to me'."

Dame Carol Black, chair of the British Library, described Wilde as "one of the most significant literary figures of the nineteenth century".

She said that by reissuing his library card, "we hope to not only honour Wilde's memory but also acknowledge the injustices and immense suffering he faced as a result of his conviction".

She added that they were "delighted" to welcome his grandson - who is the author of a new book, *After Oscar: The Legacy of a Scandal* - to receive the library card on his behalf.

real vision by standing up to the SUV 'car-spreading' that is taking over our streets," he said. "It's only fair that those driving the biggest, heaviest and most polluting vehicles pay more for the extra space and danger they bring."

The Welsh capital is following in the footsteps of Paris, which last year tripled parking charges for SUV-style vehicles, leading to a two-thirds reduction in the number of SUVs using surface parking.

The decision in Cardiff follows a public consultation in which two-thirds (66%) of respondents said they agreed that larger vehicles should pay more for permits.

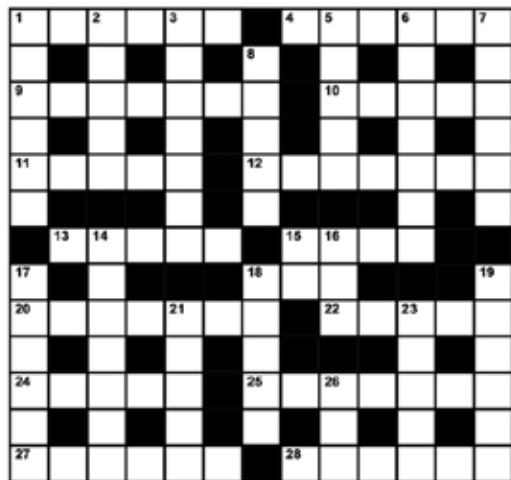
Dan De'Ath, the cabinet member for transport, said SUVs were "much larger than your average car, they produce far more wear and tear on our roads, but fundamentally if you hit a child while driving a heavy SUV the chances of that child dying are grossly inflated".

He said: "We don't think it's unreasonable to ask people driving those kinds of vehicles to pay a little bit more for road wear and the extra space they take up."

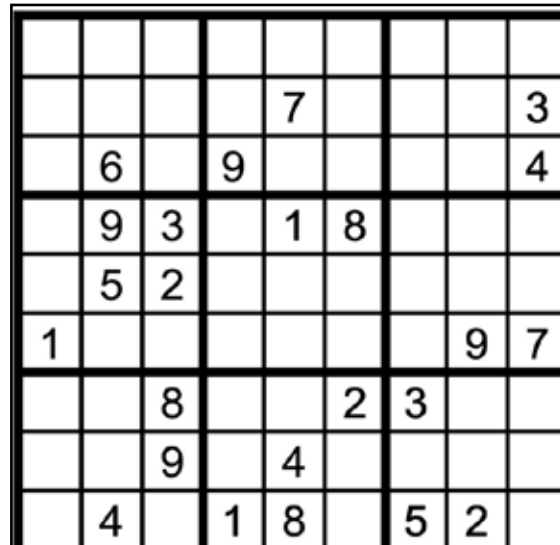

All Guts, All Glory: Sumo summit comes to London

■ When push comes to shove...Britons get a bellyful of what really happens in the Japanese traditional sport

They're getting through 150lbs of rice a day and the wholesaler has run out of noodles. Yes, sumo returned to London this week.

The famed Japanese sport is holding a Grand Tournament outside of its homeland for only the second time - and this is a sport that has records going back more than 1,500 years.

It's 34 years since the Royal Albert Hall hosted the only previous such event on foreign soil - and the appetite for tickets meant all five days sold out immediately.

"I'm happy that sumo is back after so many years," said sumo star Onosato. "I hope I can show the UK fans how fantastic sumo is."

"Being a yokozuna (professional wrestler) has a lot of responsibility," fellow sumo idol Hoshoryu told Sky Sports. "We have to show everyone an example of what a

yokozuna is - and that's very difficult.

"My uncle was a yokozuna - and I'm happy to follow in his footsteps. But I came here to London as a yokozuna which he didn't, so I'm even happier."

At the recent Aki Basho - the most prestigious tournament on the sumo calendar - the pair finished with identical records after 15 days of bouts.

It all came down to a final play-off between the two yokozuna - the first time that had happened in 16 years. It was Onosato who came out on top on that occasion.

Hoshoryu says he is a big fan of basketball and football. He follows Chelsea, although his favourite players are going back a bit: "Didier Drogba and Petr Cech. He's the 'keeper. I like this guy!" The wrestlers - or rikishi - have a rigorous training regime.

They live in communal blocks called stables and practice starts early. Perhaps surprisingly, everyone skips breakfast. After training and practice - and for the younger rikishi, chores - the wrestlers all eat together.

The staple of their diet is chankonabe, a hearty stew packed with meat and vegetables. The feeding of the 40 rikishi who have come over for the five-day tournament is a challenge in itself.

Donagh Collins, the CEO of co-organisers Askonas Holt, said: "We are going through 70 kilos of rice a day. Somebody told me that the wholesaler for the noodles has run out of noodles. We're really pushing the system here."

The ring - or dohyo - is just 4.55m in diameter and quite small when two giant wrestlers leap at each other.

The aim of the fights is to either get your opponent onto the floor - or, more spectacularly, shove or hurl them out of the dohyo, so spectators in the ringside seats may be getting extremely up-close to the wrestlers.

The last time the tournament was in Britain, the massive Konishiki, known as the Dump

Truck, took centre stage.

The giant Hawaiian was the heaviest-ever rikishi coming in at 287kg

- or 45 stone. That's a lot of wrestler to dodge if he comes falling out of the ring towards you.

British pair squash pumpkin record

Twin brothers have broken two world records for the world's largest and heaviest pumpkin.

Stuart and Ian Paton, from Lymington in Hampshire, have been growing giant pumpkins for over 50 years.

They said they had come close to breaking

the records several times before - even surpassing them one year - but a small hole in the giant squash led to their disqualification.

But after their giant fruit weighed in at 2,819lbs (1,278kg) with a circumference of over 21ft (6.4m) at a giant veg-

etable weigh-off in Reading last weekend, the record was finally theirs.

"It was an amazing feeling, it's hard to describe really," said Stuart.

His brother Ian added: "I kind of had an inkling when the fork-

lift started beeping and flashing red."

The previous heaviest pumpkin record holder was 2,749lbs (1,247kg), while the former largest was over 20.2ft (6.1m) in circumference - both grown in the US.

It is the first time the world record has been held in the UK with the weigh-in taking place at Wargrave Nursery in Reading.

The pair said they became interested in growing oversized gourds when they were 13.

Hatton death ruled a suicide

Former boxing world champion Ricky Hatton died by suicide, an inquest on Thursday morning revealed.

The Manchester Coroner's court announced that Hatton, 46, was discovered unresponsive after being found hanged on the morning of Sept. 14 at his house in Hyde, Greater Manchester. Hatton's manager, Paul Speak, was the one who discovered the famed pugilist.

Hatton was last seen on Sept. 12, two days before his death. He was supposed to appear at an event on Sept. 13, but did not turn up.

Hatton had long suffered from mental health battles, as well as drug and alcohol addictions. He was open about his battles with depression and failed suicide attempts.

"I tried to kill myself several times," Hatton told the BBC in 2016. "I used to go to the pub,

come back, take the knife out and sit there in the dark crying hysterically."

After brief details were released in the hearing Thursday, led by senior coroner Alison Mutch, the inquest was opened and adjourned until March 20, 2026.

Hatton, a former two-division world champion, was scheduled to return to the ring on Dec. 13, ending a 13-year lay-off. He was due to fly to Dubai on the day that he was found dead.

His funeral took place in Manchester this past week, with thousands turning out on the streets of Greater Manchester to pay their respects to a boxing legend.

Mr Speak said in the interview that Mr Hatton was 'in a really good place' before his death and had been preparing to take his daughters to see Oasis the following week, to go to Thailand for a boxing convention and for Christmas

in Tenerife.

His main focus was a fight in Dubai in December against Abu Dhabi's Eisa Al Dah.

Mr Hatton's son Campbell also paid tribute to his father on Good Morning Britain.

Opening up about his grief, he said: 'It has been very up and down, really, but just as a family, we're trying to take each day at a time, really.'

Reflecting on the love shown for Ricky at his funeral, Campbell added: 'He always said he was more proud of his fanbase than all the belts and his titles.'

'Surprised is probably the wrong word because it was obvious how much he was loved by the amount of people that followed him all over the world to watch him box.'

'To actually see every-

one in the streets, it was a very long route that we went down, and there was never a point where the streets weren't full. To actually see it in terms of the amount of people, it was surreal really.'

Stars including Liam Gallagher, Wayne Rooney and Tyson Fury were among those in the congregation for a private memorial service at Manchester Cathedral.

Broad: Aussie Ashes squad 'worst since 2011'

It's the game before the games, the chatter for the Ashes.

And well-known former protagonists from Australia and England have started the verbal jousting that comes with one of the oldest sporting rivalries in the world.

Ex-Australia opening batter David Warner raised the level this week when he said the Australians were competing to win the Ashes, while England would be playing for a "moral victory" for its so-called Bazball approach to test cricket.

Warner predicted a 4-0 win for Australia - expecting the weather inevitably to play some part in a draw along the way - although suggested England could win one test if Australia skipper Pat Cummins is ruled out through injury.

But Stuart Broad, a longtime spearhead

for the England attack, snapped back on Thursday by declaring Australia's squad will be the worst to wear the baggy green since 2010-11.

"It's probably the worst Australian team since 2010 when England last won, and it's the best English team since 2010," Broad told a BBC podcast. "It's actually not an opinion, it's fact."

Broad, who was part of the squad that won Down Under in 2010-11, and also the squads that lost there three times since, highlighted uncertainty over the composition of Australia's batting top-order, as well as the fitness concerns over Cummins as areas to exploit for England.

"When have we ever, since 2010, been discussing who is going to bat No. 1, 2, 3, 6, 8 and who is going to be the spare bowler for Australia?"

Broad said. "You're always go in there going: 'well, the Aussies, they're really strong. They've just got the same bowlers, the same team'."

In the 2010-11 series, Broad said, Australia was trying to replacing greats Glenn McGrath, Shane Warne, Matthew Hayden and Justin Langer, and

didn't have a front-line spinner.

"They changed the seamers all the time, and they had a bit of a mixed match of batters," Broad said. "So I don't think anyone could argue that it's their weakest team since 2010."

That assessment hit where it hurts for the

Aussies, being the last series where Australia lost an Ashes match on home soil.

In fact, that was Australia's only Ashes series loss at home since it reclaimed the urn in England in 1989. And the home record since is 13 wins, two draws, no defeats in tests.

It carried on, with a period of silence in the stadium sparking the response "are you Wembley in disguise?" from England's fans.

Some of the chanting was light-hearted but the message was clear. England's travelling support on this rain-soaked night in Riga did not appreciate being taken to task by their own head coach and made their feelings obvious at great volume.

Belgium prove the bogey again for Wales

Wales' hopes of qualifying automatically for the World Cup were effectively ended as they lost 4-2 at home to Belgium in midweek in an absorbing contest that left the play-offs as their only realistic remaining route to next summer's finals.

Craig Bellamy's side started brilliantly and took a seventh-minute lead as Joe Rodon headed in from a corner, only for Kevin de Bruyne's controversial penalty to puncture the joyous atmosphere after Ethan Ampadu was harshly penalised for handball following a video assistant referee (VAR) check.

Belgium ruthlessly seized control from that point, cutting Wales to shreds on the break as Jeremy Doku - electrifying all game as he has been for Manchester City this season - sped clear and pulled the ball back for Thomas Meunier to hammer the visitors ahead.

De Bruyne, Doku, Leandro Trossard and others missed chances to add

a third goal for the visitors, who eventually put the result beyond doubt when De Bruyne scored his second spot-kick after a much less contentious, clear-cut handball from Jordan James.

Substitute Nathan Broadhead fired in powerfully to raise the faint prospect of a Welsh comeback, which was swiftly extinguished when Trossard restored Belgium's two-goal advantage moments later.

Belgium overtake North Macedonia at the top of Group J, and they are now four points ahead of third-placed Wales with games against Kazakhstan and Liechtenstein to come.

In order for Wales to finish top and qualify automatically, the Belgians would need to lose both those matches - unlikely in the extreme - and Bellamy's side would have to win both their remaining games for a turnaround of miraculous proportions.

Wales may well keep their side of the bargain but it is unthinkable that

Belgium would surrender their lead - to Wales at least - from this position of strength.

Therefore, Wales are all but certain to be in the play-offs in March. They will have home advantage for the play-off semi-final if they finish second in their group and, failing that, they will still have a play-off place - albeit away for the semi-final - if they finish third, thanks to their Nations League success.

Their final group po-

sition will likely come down to their final game against North Macedonia in November.

And while Wales are still capable of accomplishing Bellamy's stated aim of getting to next summer's tournament in the United States, Canada and Mexico, the route they must take there is looking more convoluted than they would have hoped.

"We knew we needed to win. We were here to win," Bellamy said.

"The draw wasn't going to get us first place. We knew that. We're aware of our play-off positioning as well.

"But to me I honestly love playing these top teams. It's so good. Your heart is in your mouth at times, you're really living on the edge.

"I definitely liked a lot of our game. I'm really proud of the players. And I know that's no consolation to the people who are watching on or the players themselves."

Kevin Muscat edges closer to Rangers job

Rangers are close to agreeing a deal to secure Kevin Muscat as their new head coach with personal terms and details still to be finalised.

The 52-year-old former Ibrox defender is currently in charge of Chinese league leaders Shanghai Port, who have four games left in their season.

One of the key issues holding up an announcement is Shanghai's match against Qingdao Hainiu, which takes place at 11:00 BST on Friday.

It is understood Rangers and Muscat are sensitive about upsetting plans for that match by formally agreeing a deal between both clubs before kick-off.

Rangers are also working to secure Muscat's backroom team and tie

up all the relevant paperwork needed for the Australian to coach in Scotland.

Youth coach Stevie Smith will take charge of the side for Saturday's league match against Dundee United at Ibrox, but it is yet unclear who will be in the dug-out for the Europa League game away Brann Bergen on Thursday.

Muscat emerged as favourite for the job after former manager Steven Gerrard withdrew his candidature at the weekend saying the timing was not right for him to return to Ibrox.

Former Sheffield Wednesday manager Danny Rohl was also under consideration, but the German also pulled out the race on Wednesday.

Crawley-born Muscat,

who spent a season as a Rangers player, started his coaching career with Melbourne Victory, with whom he won the A-League title.

After a less successful spell with Sint-Truiden in Belgium, he led Yokohama F Marinos to the J-League title before tak-

ing charge of Shanghai in 2023, won the title last season and is four games away from retaining it this term.

Rangers were left seeking a new head coach after sacking former Southampton boss Russell Martin just 17 games into the ex-Ibrox defender's

reign.

The Glasgow side head into Saturday's game against United sitting eighth in the Scottish Premiership, nine points behind city rivals and reigning champions Celtic - and two more adrift of leaders Heart of Midlothian.

■ Tuchel's men stroll to Latvia win to clinch World Cup qualification with two games to spare

England confirmed their qualification for next summer's World Cup by overwhelming Latvia, 5-0 in Riga on Tuesday night.

Thomas Tuchel's side needed victory to assure their place in the showpiece, the outcome never in doubt as England outclassed a Latvian side ranked 137th in the world.

Amid the celebrations, it was at times an uncomfortable night for Tuchel, who felt anger and frustration from England's travelling fans as they chanted sarcastically, and loudly, in response to the head coach's criticism of

"silent" supporters after the friendly against Wales at Wembley.

The bigger picture, however, reveals that England qualified with two games to spare after a flawless first campaign for Tuchel, who succeeded Sir Gareth Southgate in January.

Anthony Gordon put England ahead after 26 minutes with a low, curling finish and captain Harry Kane scored twice more before the interval, first with a strike from the edge of the area then from the spot after his shirt was pulled.

England added a fourth

just before the hour when Latvia's Maksims Tonisevs bundled Djed Spence's cross into his own net.

Substitute Eberechi Eze further emphasised England's dominance with a dribble and low finish to make it 5-0 after 86 minutes.

Tuchel's England tenure started off as something of a slow burner, but sparked into life with the outstanding 5-0 win in Serbia.

England found a momentum and fluency in Belgrade that had previously eluded them under Tuchel. They now look a serious threat, led by their

remarkable captain Kane, who took his tally to 76 goals in 110 appearances with his double in Riga.

And to underscore their growing menace, England have now scored 13 goals without reply in their past three games.

Tuchel may not have

been presented with the most testing qualifying group when taking over from Southgate after Lee Carsley's interim period in charge, but six wins from six games without a goal conceded is still an impressive return.

England keeper Jordan

Pickford made two routine saves in the second half, extending his sequence of international clean sheets to nine in a row.

It also means Tuchel can use qualifiers that are now effectively dead rubbers against Serbia at Wemb-

Fans 'right to boo' after win - Adams

Che Adams believes fans "were right" to show their dissatisfaction and frustration following Scotland's World Cup qualifying victory over Belarus on Sunday.

A small section of the Hampden crowd booed when the full-time whistle blew on a 2-1 win over Belarus after sub-par performance from Steve Clarke's side.

And there had been a similar reaction at half-time against Greece three days earlier after a goalless 45 minutes that were dominated by the visitors.

With head coach Clarke admitting Sunday's win left him "disappointed" and supporters unconvinced, Adams insists the team camp was positive while admitting they can "do better".

"I think they were right [to boo]. It was some poor decision-making, not concentrating in key moments of the game," said the Torino striker.

"We need to do better next time. At times it felt

like we were pressing singly or not together as a unit. It's difficult to put a finger on anything specifically.

"But it was a positive camp. Six points all round. So we know how difficult it's going to be next camp but we need to stick together now and get things right.

"It's a long and difficult campaign to get to the World Cup, but we're two games away from achieving great things, so everyone's concentrating on that."

Scotland are now unbeaten in 13 consecutive

home World Cup qualifiers (excluding play-offs - W10 D3). Their last defeat was more than 12 years ago - 2-0 to Belgium in September 2013.

Scotland have won back-to-back matches at Hampden for the first time since June 2023 (run of six consecutive victories). They have as many wins at home in their last two as they managed in their previous 10 (W2 D3 L5).

John McGinn made his 81st appearance for Scotland, moving him level with Craig Gordon in joint-fourth on the all-time appearance list. Only Kenny Dalglish (102), Jim Leighton (91)
