A PRINCE NO MORE...

■ **Disgraced Andrew stripped of royal titles and turfed out of Windsor mansion**

Prince Andrew has been stripped of his "prince" title and will leave his Windsor mansion, Royal Lodge, Buckingham Palace announced on Thursday.

The King has "initiated a formal process" to remove his titles, it said, and Andrew will now be known as Andrew Mountbatten Windsor.

Andrew, 65 - the King's younger brother - has continued to face more questions about his private life in recent months.

His links to paedophile financier Jeffrey Epstein have caused problems for the Royal Family. The prince, who relinquished his titles earlier this month, has always strongly denied any wrongdoing.

"His Majesty has today initiated a formal process to remove the Style, Titles and Honours of Prince Andrew," Buckingham Palace said in a statement on Thursday evening.

"Prince Andrew will now be known as Andrew Mountbatten Windsor."

It also addressed the place where he lives, Royal Lodge.

"His lease on Royal Lodge has, to date, provided him with legal protection to continue in residence.

"Formal notice has now been served to sur-

render the lease and he will move to alternative private accommodation. These censures are deemed necessary, notwithstanding the fact that he continues to deny the allegations against him.

'very brutal'

"Their Majesties wish to make clear that their thoughts and utmost sympathies have been, and will remain with, the victims and survivors of any and all forms of abuse."

The language of Buckingham Palace's statement was "very brutal," observed leading royal historian Kelly Swaby.

"Ordinary people don't care about the semantics, they want to see punishment, and public opinion is very much against Andrew, the Palace knows that, and the language very much reflect that".

The decision was made, and action taken, due to serious lapses in Andrew's judgement, it is understood.

It is also understood that the wider Royal Family and the government was consulted, and made clear it supports

the decision.

It is understood Andrew will be relocated to the Sandringham Estate in Norfolk, but details about his specific housing have not been released.

The wider Sandringham estate covers approximately 20,000 acres (8,100 hectares) with 600 acres (242 hectares) of gardens - and the Palace has not said which property he will stay in.

One of the options previously suggested as where he could move to was Wood Farm, located on the estate surrounds, a cottage privately owned by the monarch.

privately funded

Described as "small and intimate" by former housekeeper Teresa Thompson, the cottage has strong associations with Andrew's parents.

His father, the late Duke of Edinburgh, chose the secluded property as his permanent home when he retired from public life in 2017.

It is understood that Sarah Ferguson, 66, Andrew's ex-wife, will also move out of Royal Lodge and will make her own living arrangements.

Formal notice was given to surrender the lease at the Royal Lodge on Thursday and it is understood that Andrew's move to Sandringham will take place "as soon as practicable".

It is understood Andrew's accommodation will be privately funded by the King.

And the King will make "appropriate private provision" for his brother as he moves out of his home.

Royal sources have previously said the King has tried to apply pressure, and last year cut off Andrew's funding last year.

Andrew also cultivated his own independent sources of funding since leaving public life,

including business connections with China, the Gulf States and a recently curtailed project with a Dutch start-up company.

Earlier this week, Parliament's spending watchdog, the Public Accounts Committee wrote a letter detailing

the "considerable and understandable public interest in the spending of public money" relating to Andrew.

The letter asked what the Crown Estate's plan was to ensure value for money in any future agreements with Andrew.

Andrew: how will his titles will be removed?

Andrew is understood not to have objected to the King's decision to remove his titles. Knight Grand Cross of the Victorian Order will also be removed.

The titles being stripped are: Prince, Duke of York, Earl of Inverness, Baron Killyleagh. And he will no longer have the right to be called His Royal Highness. The honours of Order of the Garter and

To remove the titles, the King will send Royal warrants to the Lord Chancellor - who is David Lammy - to officially remove them.

His birth certificate will not need to be changed as

Two military sites earmarked for housing migrants

■ Anxious Starmer tells MoD staff: go faster, go further
 ■ Sites not "luxury accommodation by any means"

Hundreds of asylum seekers could be housed in two military sites in Inverness and East Sussex as the government seeks to end the use of hotels.

Discussions are under way over the use of the sites to accommodate 900 men. There are around 32,000 asylum seekers currently being housed in hotels.

Prime Minister Sir Keir Starmer told reporters he had told Home Office and Ministry of Defence officials to "go faster, go further" to locate appropriate military sites.

The government has pledged to end the use of asylum hotels, which have cost billions of pounds and become a focal point for anti-migrant protests, by 2029.

Asylum seekers are due to be housed in the Cameron Barracks in Inverness and Crowborough army training camp in East Sussex by the end of November, under plans being drawn up by ministers.

Speaking to the BBC, Sir Keir said he

was "really pleased" that more asylum seekers would be housed on military bases "by the end of this year".

Defence Minister Luke Pollard said the sites were not "luxury accommodation by any means," but "adequate for what is required".

sites 'cost more'

"That will enable us to take the pressure off the asylum hotel estate and enable those to be closed at a faster rate," he said.

The National Audit Office concluded in March 2024 that large sites such as military bases would cost more than hotels to accommodate asylum seekers.

Pollard said costs were currently being assessed and would "depend on the base".

"But I think there's something that is of greater significance that we've seen over the past few months, and that is the absolute public appetite to see every asylum hotel closed."

He would not be drawn on how many

asylum seekers were to be moved or when that would happen.

He said there would have to be sufficient engagement with local authorities and adequate security arrangements in place. "Those conversations have been going on for some time now," he added.

Inverness's Liberal Democrat MP Angus MacDonald said he supported the use of military sites to house asylum seekers, but that the chosen base seemed "a bit odd" given it is in the town centre.

mixed response

"It's effectively the same," he claimed, adding that to his knowledge it was an open barracks without security.

"I very much thought the idea of putting them in army camps was to have them out of town, and make them less of an issue for the local population."

The plans for Crowborough Training Camp have prompted a mixed response among resi-

dents.

Conservative MP Nusrat Ghani, whose Sussex Weald seat includes the Crowborough site, said she was "furious," noting the former Tory government had rejected the plan as "wholly inappropriate."

'billions squandered'

One local recalled that there had not been any problems when Afghan families, evacuated during the withdrawal from Kabul in 2021, were previously housed there.

Others expressed concern about the impact on local services, with

one stressing: "There's enough people waiting for [doctor's] appointments."

Ministers are also considering industrial sites, temporary accommodation and otherwise disused accommodation.

A Home Office spokesperson said: "We are furious at the level of illegal migrants and asylum hotels."

"This government will close every asylum hotel. Work is well under way, with more suitable sites being brought forward to ease pressure on communities and cut asylum costs."

As of June 2025, there were 32,000 asylum

seekers being accommodated in hotels, a drop from a peak of more than 56,000 in 2023 but 2,500 more than last year.

A report on Monday found billions of taxpayers' money had been "squandered" on asylum accommodation, with the Home Affairs Committee concluding hotels were being relied upon as a "go-to" solution rather than a stop-gap.

In response, Sir Keir said: "I can't tell you how frustrated and angry I am that we've been left with a mess as big as this by the last government."

the title change will not apply respectively.

The news comes just weeks after Andrew voluntarily gave up his other royal titles, including the Duke of York.

Princess Eugenie and Princess Beatrice will retain their titles, as they are the daughters of the son of a Sovereign. This is in line with King George V's Letters Patent of 1917.

Until this month, Ferguson kept the title Sarah, Duchess of York - but she reverted to her maiden name of Ferguson after Andrew was stripped of his Duke of York title.

Andrew still remains eighth in line to the throne.

Complicated process

Removing royal titles is a complicated process and was last done by King George V during World War One when he revoked titles of his relatives who were on the German side.

The Titles Deprivation Act 1917 was used two years later to strip the titles from Leopold Charles, Duke of Albany, Earl of Clarence and Baron Arklow; Ernest Augustus, Duke of Cumberland and Teviotdale, Earl of Armagh; Ernest Augustus, Duke of Brunswick, Prince of Great Britain and Ireland; and Henry, Viscount Taffe of Corren and Baron of Ballymote.

The surname Mountbatten Windsor was created in 1960, and combines the surnames of the late Queen Elizabeth II and Prince Philip when they married.

In 1917, fearful of the anti-German sentiment in the UK the reigning monarch, George V, adopted the name Windsor to replace the original Germanic sounding house of Saxe-Coburg and Gotha dynasty.

He renamed the lineage Windsor, after the castle.

RIP Prunella Scales, a true national treasure

■ **Comic actress enjoyed a long career, but will be forever best known as the formidable Sybil in the classic Fawlty Towers**

Prunella Scales, one of Britain's finest comic actors, died this week at the age of 93.

But despite a long and distinguished career on stage and screen, she will inevitably be remembered as Sybil Fawlty in the 1970s TV comedy, *Fawlty Towers*.

It was Sybil's mission in life to keep tabs on her "stick insect" husband Basil - played by John Cleese - between cigarette-fuelled phone conversations with her friend, Audrey.

It fell to her to placate guests who had been shouted at, totally ignored or, in some cases, throttled by Basil when in one of his more manic moods.

Her nightmarish laugh, gravity-defying hairdo and ferocious temper were part of a carefully constructed character that ranks as a comic masterpiece.

'absolutely perfect'

And while many actors would have distanced themselves from too close an association with a single role, Scales always expressed her delight in having been part of the *Fawlty Towers* experience.

The show's creator John Cleese paid a moving tribute to his former co-star, describing her as "a really wonderful comic actress" and adding: "Scene after scene she was absolutely perfect."

Prunella Margaret Rumney Illingworth was born near Guildford on 22 June 1932.

It was a family deeply in love with the theatre - with her mother, Bim Scales, a former actor who'd given it all up for marriage and children.

Bright and bookish, after wartime evacuation to

the Lake District, Prunella attended Moira House Girls School in Eastbourne.

In 1949, she won a scholarship to the Old Vic Theatre School in London. Two years later, she secured a position as an assistant stage manager at Bristol Old Vic.

rarely out of work

At drama school, Scales had been thought of as a junior character actor rather than an obvious Juliet.

"We all wanted to look like Audrey Hepburn," she later told her biographer, "but I wasn't attractive and nobody fancied me."

But she started picking up small roles in plays, and, while rehearsing for a part at Worthing's Connaught Theatre, she met Andrew Sachs, who would later star as Manuel, the Spanish waiter, in *Fawlty Towers*.

There was an early television appearance in 1952, as Lydia Bennet in a BBC production of *Pride and Prejudice*, which featured Peter Cushing - better known for his roles in horror movies - as Mr Darcy. And her first big screen roles came a year later - in romantic comedy, *Laxdale Hall*, and David Lean's *Hobson's Choice*, opposite Charles Laughton.

Throughout the late 1950s and early 1960s, she was rarely out of work - appearing on stage, film and television, including a brief stint as a bus conductor, Eileen Hughes, in *Coronation Street*.

She also met fellow actor Timothy West.

After what Prunella described as "a mild Times crossword and Polo mints flirtation", they got together, and married in

1963.

Her big TV break came with *Marriage Lines*, a BBC sitcom about a newly married couple, George and Kate Starling.

Scales appeared opposite Richard Briers, then one of the biggest stars in television comedy. The show proved hugely popular and ran for five years.

Then came *Fawlty Towers*, which propelled her to iconic status.

John Cleese and his then wife, Connie Booth, had submitted the first script of *Fawlty Towers* to the BBC.

Actress Bridget Turner had been approached to

play Sybil Fawlty but she had turned it down and Scales auditioned for the role.

She later remembered that Cleese was a hard taskmaster.

"John, quite rightly, was extremely rigorous about learning the script, and if you didn't, he could get quite cross, which was fair enough."

Only 12 episodes were ever made.

The first series, which aired in 1975, failed to win huge audiences but, as it continued, its hilarious mix of absurd pratfalls and embarrassing situations grew in popularity.

Scales thought hard about how to play Sybil Fawlty, and decided that her social background had to be inferior to her husband Basil's.

At first, John Cleese and his wife and fellow writer Connie Booth were unsure about the treatment.

"Once they heard the first reading in rehearsal," recalled Scales, "they were sold on the idea."

Later in her career, she was, all too often, called upon to play "dragons" and "old bags" when she hankered after more glamorous roles.

But when asked what

she thought was the high point of her career, Scales had no hesitation in picking Sybil Fawcety.

"It was a tough job," she insisted, "but I'm still proud of it." She even thought it helped get the paying public into theatres.

"I like to think that if the public have seen you in one thing they'll come and see you in another," she said.

gentle journeys

Away from acting, Scales was a committed campaigner.

She served as president of the Campaign to Protect Rural England and she was a lifelong Labour Party supporter, who counted Neil Kinnock as a "dear friend".

With Timothy West, she made 10 series of Great Canal Journeys for Channel 4.

The programmes took viewers on gentle journeys through the inland waterways of Britain and - in later episodes - Egypt, India and Cambodia.

In the programmes, Scales told how her short-term memory was beginning to fade.

Her husband had noticed it first, when she began missing her lines in a production of *A Woman of No Importance* in 2003.

But the problem took a long time to get diagnosed.

In 2014, Timothy West confirmed that Prunella was suffering from vascular dementia. Before long, she had difficulty remembering when her sons were born or what year she had got married.

A decade later, they celebrated 60 years of marriage, but her condition had reached a point where she knew little of her surroundings.

And, in November 2024, West died at the age of 90. She is survived by two sons and one stepdaughter, seven grandchildren and four great-grandchildren.

Am I Madeleine? It's 50/50, says accused McCann stalker

■ Trial of Julia Wandelt opens at Leicester Crown Court

The alleged stalker of Madeleine McCann's parents has told a jury she is still "50-50" about whether she is their missing daughter.

Julia Wandelt, who a jury heard has repeatedly claimed she is the missing child, is on trial at Leicester Crown Court alongside Karen Spragg, accused of stalking Kate and Gerry McCann, causing serious alarm and distress.

Cross-examination of Miss Wandelt began on Wednesday, during which the 24-year-old said she had concerns for her safety and believes someone "slipped something" in her drink days before her trial.

Polish national Miss Wandelt and Mrs Spragg, 61, deny the charges.

'neither yes or no'

During cross-examination, prosecutor Michael Duck KC asked Miss Wandelt: "As we stand here, do you still entertain the belief that you could be Madeleine McCann?"

Miss Wandelt said: "It's neither yes nor no. Because it is very easy to provide me with the documentation, so if I am not her, and it really is negative, I would like to see the documentation."

"Now, I would say I'm 50-50. What's the issue with providing the whole paperwork?"

Mr Duck KC asked again: "Do you, Julia Wandelt, believe you may still be Madeleine McCann?"

In response, Miss Wandelt said: "It will be neither yes nor no. It is not yes, and not no. I am in between."

Asked what would satisfy her, Miss Wandelt raised her voice and tearfully told the jury: "An investigation into my disappearance, into what happened to me, why am I here?"

'I would walk away'

Mr Duck KC asked Miss Wandelt: "If you had seen a negative DNA test result, would you have walked away?"

Miss Wandelt replied: "If I received the entire paperwork, yes, I would walk away."

Earlier on Wednesday, when answering questions from Mrs Spragg's barrister Simon Russell Flint KC, Miss Wandelt, of Jana Kochanowskiego in Lubin, Poland, said: "Even in prison, a few days before my trial, someone slipped something in my drink and the officers didn't want to help."

"I have been concerned about my safety since I told my story."

DNA test

The defendant tearfully told the jury she agreed that she was "vulnerable".

The court has previously heard results of the DNA test - taken by Miss Wandelt after she was arrested at Bristol Airport in February - "conclusively proved" she is not Madeleine.

Jurors were told police contacted the de-

fendant about the DNA test on 1 April.

Miss Wandelt said she felt this was "disrespectful" given the contact came on April Fool's Day - and knowing how long she had been waiting.

"From all other days, they chose April Fools Day," Miss Wandelt said.

Mr Duck KC asked Miss Wandelt about the "multiple times" her calls to the McCanns went unanswered.

The court heard Miss Wandelt did not see it as unwanted contact, and added: "I thought Kate [McCann] was threatened or for some reason could not talk to me."

Mr Duck asked: "By

whom?"

Miss Wandelt said: "I don't know. Somebody who did not want the truth to come out."

Mr Duck KC told the court part of Miss Wandelt's thought process was that Gerry McCann and officers from Operation Grange - the Metropolitan Police investigation into Madeleine's disappearance - were threatening Mrs McCann.

He asked Miss Wandelt: "What is your attitude and manner towards Gerry McCann?"

Miss Wandelt responded: "I don't want to say anything bad about him."

Addressing Miss Wandelt, Mr Duck KC

said: "Do you entertain the possibility that Gerry had something to do with the disappearance of his own daughter?"

In response, Miss Wandelt said: "Yes."

When asked to expand on her answer, Miss Wandelt said her response was "mostly based on memories", adding "but also the way he came across as not letting Kate say anything".

The court heard Miss Wandelt's visit to the UK in December 2024 - during which she encountered the McCanns on their own doorstep in Rothley, Leicestershire - was the first time she met co-defendant Mrs Spragg.

The trial continues.

Coogan's 'Lost King' Libel Drama Ends with Payout — But He Says He'd Tell It Again

■ Star loses heavily in court for his depiction of Richard III researcher as “devious”, “weasel-like” and a “suited bean-counter”.

Steve Coogan has said he stands by *The Lost King* — despite shelling out “substantial damages” after a High Court libel battle over its portrayal of a university official involved in the discovery of Richard III’s remains.

The actor-producer and his companies, Baby Cow and Pathé, agreed to settle a claim brought by Richard Taylor, then deputy registrar of the University of Leicester. Taylor sued over being shown in the 2022 film as a slippery bureaucrat blocking amateur historian Philippa Langley’s efforts to find the king’s body beneath a city car park.

Taylor’s lawyers said he was portrayed as “devious”, “weasel-like” and a “suited bean-counter”, while Judge Lewis previously ruled the film suggested he knowingly misled the public and was “smug, dismissive and patronising” — a depiction that carried a defamatory meaning.

‘serious harm’

Taylor’s barrister, William Bennett KC, told the court his client’s reputation had suffered “serious harm” and “enormous distress”. Coogan and his partners have now agreed to pay damages, cover legal costs and add an on-screen clarification that Taylor’s character

was fictional and that he “acted with integrity” in real life.

Neither Coogan nor his co-defendants attended court, but the Alan Partridge star later issued a statement saying the film remained “the story I wanted to tell”. He said it was “unfortunate” that ill health had prevented Langley from giving evidence in his defence, adding that *The Lost King* was always “Philippa Langley’s story”.

“If it wasn’t for Philippa Langley, Richard III would still be lying under a car park,” Coogan said. “It is her name that will be remembered long after Richard Taylor has faded into obscurity. That is the

story I wanted to tell, and I’m happy I did.”

Langley, who spearheaded the dig and co-operated with Leicester University, said on her website she had wished for a judge’s independent ruling but could not attend court due to illness.

Taylor, now chief operating officer at Loughborough University, said outside court he had felt “cross and completely helpless” when the film premiered - but the outcome brought “success and vindication after a long, gruelling battle”.

While praising Langley’s “driving confidence” in launching the search, he added pointedly: “Hers was a remarkable contribution. But it did not extend to leading the archaeological search or scientific analysis, for which she was neither qualified nor experienced.”

He also paid tribute to the collaborative effort behind the 2012 discovery: “It was a fantastic piece of academic work involving volunteers, the Richard III Society and academics from many

universities. A truly remarkable team effort.”

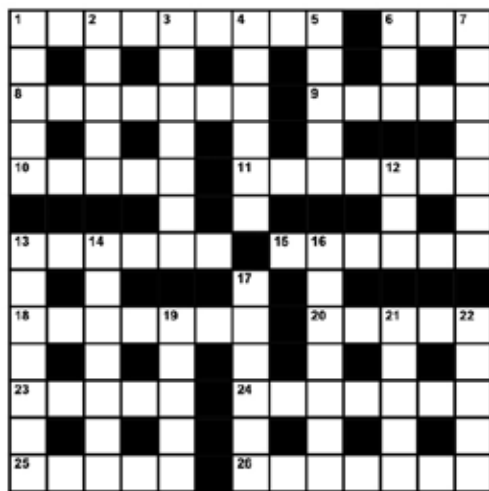
In the film, Taylor is played by Lee Ingleby as a smug university man undermining Langley (Sally Hawkins), while Coogan plays Langley’s husband and co-wrote the screenplay with Jeff Pope.

A joint statement from Coogan, Pathé and Baby Cow said: “We are deeply aware of the responsibility that comes with real-life portrayals. We remain proud of this film and are pleased this matter has now been settled.”

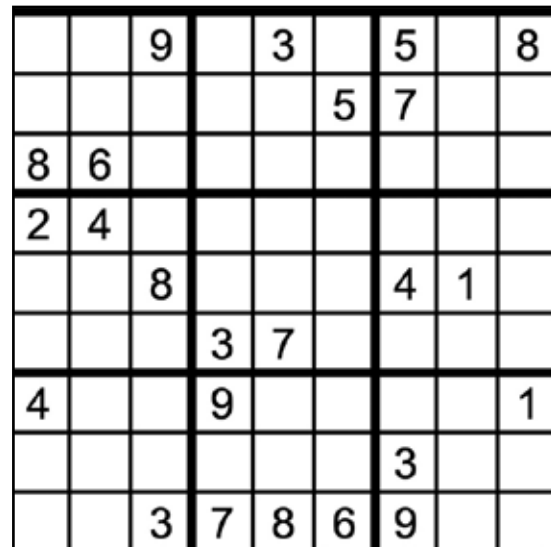

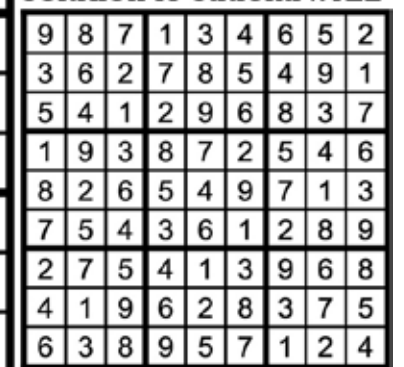

SO THERE I was at Becky Towers on Wednesday night, downing a large G&T on my slightly threadbare sofa while allowing myself a moment's silence as the credits rolled on the season finale of *Slow Horses*, wondering how on earth I was going to get through the week without Lamb, Cartwright and Ho to keep me company.

And almost as if it read my mind, my Apple TV only popped up and served me up a cracking new British telly addiction, didn't it?

As soon as I copped that *Down Cemetery Road* was co-written by *Slow Horses* originator Mick Herron I pressed play, all the better to quickly get over the loss of my Slough House besties... and almost instantly found

myself in a rebound relationship with Emma Thompson.

If you like your thrillers garnished with dry humor, a pair of terrific leading ladies and the occasional government-sized corpse in the wardrobe, this great British outing will tug your collar and refuse to let go. The papers have been at each other's throats over it, which, frankly, makes for better viewing.

The pilot episode introduces us to Ruth Wilson as the restless art historian Sarah Tucker, forced into hosting a classically British dysfunctional dinner party by her hopeful but hopeless banker husband, which is rudely interrupted by a neighboring house blowing up. Next thing we know there is a missing child, a whole web of official skullduggery and beastly capitalist villains who have no idea

who they are up against.

Almost by accident Tucker enlists Joe Silverman (Adam Godley) a bookish private detective who help her, and the added bonus is his unconventional partner, Zoë Boehm, played to the hilt by Emma Thompson. Blunt, bristling and impossibly watchable, she goes full force after those responsible for his untimely death and chews the scenery without a hint of indigestion - the sort of performance that makes you want to stand up and applaud in the wrong place. The Guardian went as far as to crown her "magnificent", and it's hard to argue; she brings a keen, tart intelligence and a fizz of mischief that lifts even the murkier corners of the plot.

As Tucker and Boehm start poking at holes the size of Oxford colleges, they form a detective double-act that's equal parts spiky banter and steely determination.

Fans of Herron's wry nastiness will recognize the signature tone: sly, rather smug about its cleverness, yet frequently rewarding when it lands. Critics from *The Independent* hailed it as a "grisly detective treat" with a nervy, arch wit that keeps you clicking "next episode."

But — and there's a meat-and-potatoes but here — not everyone's handing out roses. The *Financial Times* found the narrative a touch overfed, accusing the series of trying to do too many things at once until the whole thing threatens to wobble. The complaint lands: at times the conspiracy threads multiply like rabbits, and the tonal shifts (from droll to deadly se-

rious to ridiculous spectacle) can feel like being dragged around Oxford by a very enthusiastic tour guide who won't stop shouting.

Still, spectacle and mess are not mutually exclusive. When the show wants to be electric, it is electric: sharp dialogue, arresting visuals and brisk pacing mean that even when the logic takes a holiday, it's an entertaining one. The ensemble cast is full of familiar faces who do solid work; Adeel Akhtar etches a memorable presence, while sup-

porting players help the conspiracy feel both large and claustrophobic.

fizzing chemistry

If you want a tidy, cosy whodunnit set in the dreaming spires of Oxford where everything is wrapped up with a bow and sandalwood, this isn't it. If you're after great performances, fizzing chemistry and the pleasure of seeing clever writing and theatrical presence collide - sometimes gloriously, sometimes awkwardly — there's a lot to like.

My advice? Watch it

with a friend who likes to shout at the telly. Cheer for Emma Thompson, who more than leans into the mischief, and admire Ruth Wilson as she turns domestic boredom into bite-sized obsession. Roll your eyes at the occasional overreach, enjoy the spots of true genius, and make a list of moments you'd describe as "utterly daft - and brilliant." On balance, *Down Cemetery Road* is messy, audacious and frequently brilliant: the kind of drama that sparks conversation and, in true

Guehi, whose potential £35m move to Liverpool collapsed on transfer deadline day in September after Palace failed to sign a replacement.

“I was given ten minutes to decide,” says O’Neill

Over two decades on from his first stint as Hoops manager, 73-year-old Martin O’Neill has again taken charge on an interim basis alongside former player Shaun Maloney.

The former Nottingham Forest star got off to a flier as he watched his men hammer Falkirk 4-0 on Monday, and had described his feelings ahead of the match as a “nervous excitement”.

O’Neill’s return to his old stomping ground seemed to take him by surprise as much as anyone in Scottish football, coming hard on the heels of the resignation of Brendan Rodgers Monday night.

To many observers of the Glasgow giants, it seemed that O’Neill felt a sense of duty to the Irish businessman who owns the club, Dermot Desmond, when he answered his call, agreeing to a comeback requested by the man who first gave him the manager’s job at Parkhead 24 years ago.

“I sometimes wondered throughout my career whether I ever really, really enjoyed it,” O’Neill said, whose tenured managerial career seen him take charge of clubs including Aston Villa, Sunderland and Leicester. “And I’m probably too miserable to enjoy it. But now, at this ripe old age, I’m going to try and enjoy it.”

“But the only way I will do, the only way I’ve ever lived it, is really by trying to win football matches.”

“So from that viewpoint, I had no... well, I say no hesitation. I was given only 10 minutes to make my mind up. And so I had to do it in that time. So I’m fine with it.”

O’Neill back at Hoops after shock Rodgers exit

THE BIGGEST story in British football this week was the shock departure of Brendan Rodgers from Celtic and the appointment of 73-year-old former manager Martin O’Neill as his replacement.

Rodgers resigned Monday night to end his second spell in charge of the Scottish champions, a day after Celtic suffered a 3-1 defeat at Hearts to fall eight points behind the Premiership leaders.

explosive statement

The 52-year-old Northern Irishman’s departure was followed by an explosive statement from Celtic’s major shareholder Dermot Desmond, who described Rodgers as “divisive, misleading, and self-serving”.

O’Neill, 73, returns to the club to take interim charge along with former forward Shaun Maloney, with Celtic saying “the process to appoint a new permanent manag-

er is under way”.

Celtic confirmed the resignation of Rodgers with a 134-word statement which did not mince words.

It said: “Celtic Football Club can confirm that football manager Brendan Rodgers has today tendered his resignation. It has been accepted by the club and Brendan will leave his role with immediate effect.

“The club appreciates Brendan’s contribution to Celtic during his two very successful periods at the club.

“Brendan leaves Celtic with our thanks for the role he has played during a period of continued success for the club and we wish him further success in the future.

“The process to appoint a new permanent manager is underway and the club will update supporters further on this as soon as possible.

“We are pleased that during this interim pe-

riod former Celtic manager, Martin O’Neill and former Celtic player, Shaun Maloney have agreed to take charge of Celtic first-team matters. Further details will be confirmed shortly.”

‘self-serving’

“Every player signed and every player sold during his tenure was

done so with Brendan’s full knowledge, approval, and endorsement. Any insinuation otherwise is absolutely false.

Regrettably, his words and actions since then have been divisive, misleading, and self-serving. They have contributed to a toxic atmosphere around the club and fuelled hostility

towards members of the executive team and the Board. Some of the abuse directed at them, and at their families, has been entirely unwarranted and unacceptable.”

“What has failed recently was not due to our structure or model, but one individual’s desire for self-preservation at the expense of others.”

Chelsea finally edge through after surprise Wolves fightback

Chelsea survived a late scare in a Carabao Cup last-16 victory at Wolves Wednesday night, where a mutinous atmosphere against manager Vitor Pereira and the club’s ownership morphed into hopes of a dream fightback.

First-half goals from Andrey Santos, Tyrique George and Estevao Willian helped the Blues into the quarter-finals, despite a chaotic second half in which Tolu Arokodare scored once and David Moller Wolfe scored twice for Wolves, with Chelsea’s Jamie Gittens settling the tie.

Returning striker Liam Delap, who came on to the pitch in the 60th minute after 10 weeks out, was sent off late on for two yellow cards.

Chelsea had been 3-0 up at half-time but were forced to throw on reg-

ular starters Enzo Fernandez, Marc Cucurella, Pedro Neto and Moises Caicedo to see out the victory during a second-half wobble.

Remarkably, Chelsea had been 2-0 up after just 15 minutes, immediately sparking Wolves fans’ chants of “We want Fosun out” - directed at the Chinese owners - and “You’re getting sacked in the morning” - directed at Pereira, with the club bottom of the league and winless.

Errors, including a 30-yard backpass from Arokodare five minutes into the match, allowed Santos to find the corner with his shot for his first Chelsea goal.

The second, a wonderful team goal, culminated in Gittens crossing for George to finish from close range.

But the game swung

on Pereira’s substitutions, beginning in the 19th minute, bringing off experienced defender Matt Doherty for midfielder Rodrigo Gomes and Marshall Munetsi and Ladislav Krejci coming on in further half-time changes, after Willian lobbed goalkeeper Jose Sa just before the interval.

Support returned when Hwang Hee-chan played in Arokodare to score immediately after half-time, and Wolfe then volleyed into the corner after Yerson Mosquera’s long throw-in.

It was a chaotic last 20 minutes for Chelsea, with Delap sent off, Gittens scoring a sensational

volley to restore a two-goal advantage and Wolfe lobbing goalkeeper Filip Jorgensen just 60 seconds later to spark a nervy six minutes of added time.

The Blues’ reward is a quarter-final trip to League One Cardiff City, the only side from outside the Premier League to reach the last eight.

Arne Slot's line-up gamble backfired as a much-changed Liverpool lost 3-0 at home to Crystal Palace in the Carabao Cup last 16 - the Reds' sixth defeat in seven games.

Slot named three teenagers in his midweek starting line-up and a further five among his substitutes as he made 10 changes from the team that was beaten 3-2 at Brentford on Saturday.

But poor defending allowed Palace's Ismaila Sarr to score twice in a four-minute spell at the end of the first half to take the game away from the hosts, before Jeremy Pino added a late third with a low curled finish.

With no-one older than

21 on the bench and first-team players Virgil van Dijk, Ibrahima Konate, Dominik Szoboszlai, Cody Gakpo, Florian Wirtz, Mohamed Salah and Hugo Ekitike all absent, Liverpool made a tame exit in a competition they had won twice in the past four seasons.

Federico Chiesa, who scored in Liverpool's loss to Newcastle in last season's final in March, had two good opportunities but fired one attempt over with another saved by Walter Benitez.

An error from England defender Joe Gomez allowed Sarr to score the opener, before the Senegal attacker got his second soon after - having been given far too much space

when collecting Pino's pass.

Liverpool's miserable evening then saw 18-year-old defender Amara Nallo shown a straight red card in the 79th minute for hauling down Justin Devenny who was racing through on goal. Pino's third sealed a convincing win for the Eagles.

Wednesday's loss continues a dismal run of form for the Premier League champions - who have a tough run of games coming up.

They host Aston Villa in the league on Saturday, Real Madrid in the Champions League on Tuesday and then travel to Manchester City on Sunday, 9 November.
