'Proudest moment' as football star is knighted

THE BOY from Leytonstone done good. He's now Sir David Beckham.

The soccer star, 50, officially received his knighthood from King Charles III, 76, at Windsor Castle on Tuesday.

David, a longtime friend of the royal family, was honored in the Investiture ceremony for his "services to sport and charity."

Three of David's children, Romeo, 23, Cruz, 20, and Harper, 14, also supported him on the big day. Eldest son Brooklyn, 26, was noticeably absent amid ongoing family feud rumors.

After the ceremony, David said that he "couldn't be prouder" about his new title.

"People know how patriotic I am - I love my country," the retired athlete stated. "I've always said how important the monarchy is to my family."

Academy product

"I'm lucky enough to have travelled around the world and all people want to talk to me about is our monarchy," he added. "It makes me proud."

Beckham was joined by his wife Victoria and his parents Sandra and David at Windsor Castle.

Victoria, who received an OBE in 2017 for services to the fashion in-

dustry, designed and made the suit that her husband wore at the castle.

"[King Charles] was quite impressed with my suit," said Beckham.

"He's the most elegantly dressed man that I know, so he inspired quite a few of my looks over the years and he definitely inspired this look.

"It was something that my wife made me.

"I looked at old pictures of him when he was quite young in morning suits and I was like 'OK, that's what I want to wear' - so I gave it to my wife and she did it."

Beckham played 115 times for his country and captained the Three Lions for six years between 2000 and 2006.

The former Manchester United and Real Madrid midfielder featured in three World Cups for England, as well as two European Championships.

Beckham emerged from United's academy in 1992 and spent 11 years in the first team before joining Real in 2003 in a £25m deal.

Olympic role

He played for four years in the Spanish capital before joining Major League Soccer team

LA Galaxy. He had two loan spells at AC Milan during his time in Los Angeles, before finishing his career at Paris St-Germain in 2013.

But Beckham's impact extends far beyond the pitch.

Born in east London, he played a role in securing the 2012 Olympics for London.

He has worked with humanitarian aid organisation Unicef since 2005 and had a fund named in his honour in 2015 to mark a decade-long partnership between the two.

Beckham, who was awarded an OBE by Elizabeth II in 2003, queued for more than 12 hours to see the Queen lying in state following her death in 2022.

"It's special to be here, to celebrate and to hear the different stories that people have," Beckham said afterwards.

Beckham became an ambassador for the King's Foundation in 2024, supporting King Charles' education programme and efforts to ensure young people have a greater understanding of nature.

He part-owns League Two side Salford City alongside former United and England team-mate

Gary Neville, and is also co-owner of MLS side Inter Miami.

Victoria celebrated her husband's new honor over the summer with a heartfelt Instagram tribute.

"You've always been my knight in shining armour, but now it's official. Sir @davidbeckham!!!" the former Spice Girl wrote. "What an honour, I couldn't be prouder of you. Your dedication to

the things that matter most - your country, your work, your passion, and most of all, your family - has never wavered."

"The way you've touched so many lives over the years with kindness and humility speaks volumes about the man you are and continues to inspire us everyday," Victoria added. "But above all else, I'm so proud to call you mine. I love you so much xxxx."

Cleared of terror charge, Robinson praises Elon Musk

■ Far-right activist — who has had backing from the tech billionaire — is cleared after two-day trial over police request to access his phone.

Far-right activist Tommy Robinson has been cleared of a terror offense after he was tried for refusing to give police access to his phone during a border stop at the Channel Tunnel on July 28, 2024.

District Judge Sam Goozee found Robinson, whose real name is Stephen-Yaxley Lennon, not guilty of failing to comply with counter-terrorism powers. Robinson is a key figure on the far right of British politics, and has earned high-profile international backing, including from X owner Elon Musk.

“I cannot convict you”

Announcing the decision on Tuesday, Goozee said: “I cannot put out of my mind that it was actually what you stood for, and your political beliefs, that acted for the principal reason for this stop.”

The judge added that the police officer’s decision to stop Robinson had been based on a “protected characteristic,” adding: “I cannot convict you.”

Speaking outside Westminster Magistrates Court, a jubilant Robin-

son - whose anti-immigration rallies in the U.K. have attracted tens of thousands of supporters - said the judge “found that the police discriminated against me based on my political beliefs.”

And he heaped praise on Musk, who he has claimed footed his legal bills.

fresh scrutiny

“First of all, thank you, Elon Musk, thank you,” he said. “If it wasn’t for Elon Musk ... why did it take an American businessman to fight for our justice here, and our fight against terrorism charges for journalists?”

Robinson has previously claimed that the X boss paid his court fees, which he on Tuesday said amounted to “nearly £100,000” for this trial. Musk’s team has not confirmed this claim, but the X and Tesla owner addressed a mass British demonstration organized by Robinson in September.

The comments on Musk have already prompted fresh scrutiny of the Tesla owner’s interventions in British politics. Musk

is a frequent critic of the country’s Labour government, and even predicted “civil war” in the country over its migration policy.

Labour MP Emily Darlington, who sits on the House of Commons Science, Innovation and Technology select committee, said: “Mr Lennon’s comments shine a light again on those from outside the U.K. that are seeking to influence our democracy. The government must take this seriously.”

“Whatever today’s result in court, the news that Elon Musk is yet again interfering in the British system to work with the far right will send a shiver down the spines of tens of millions of decent British people,” said Max Wilkinson, home affairs spokesperson for the opposition Liberal Democrat party.

terror powers

Westminster Magistrates’ Court heard that officers demanded Robinson share the pin to his phone under Schedule 7 of the Terrorism Act during a stop in July last year.

Robinson is said to have told officers that there was “journalistic material” on his device and refused. The Terrorism Act gives officers the power to stop someone passing through a U.K. port to assess “whether they may be involved or concerned in the commission, preparation or instigation of acts of terrorism.”

Speaking outside the court about the request by police to give the PIN to his phone, Robinson claimed it showed the state was “trying to get

my access to my work that I do and my investigations that I do as a journalist.”

The verdict also raises questions about the police’s use of terror powers to stop and question citizens. A section of the judge’s verdict states: “I accept it may be impossible to draw (sic) a line between your political beliefs, philosophical beliefs and terrorism as there can be a clear overlap.”

Jonathan Hall, the U.K.’s independent reviewer of terrorism legis-

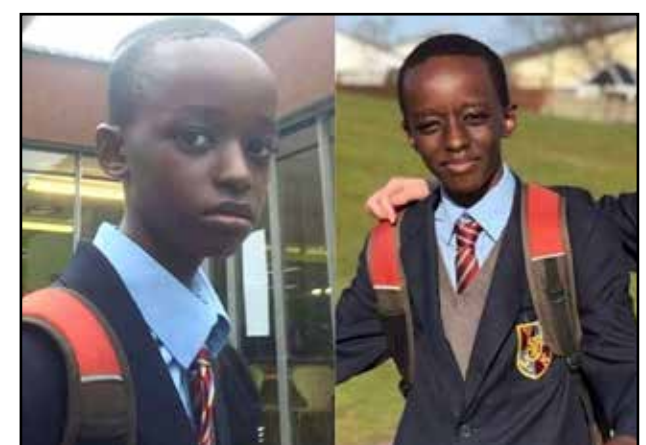
lation, said: “The case was not about whether Tommy Robinson was a terrorist. It was about whether the police misused their powers.

“Ultimately, the judge could not be sure that stopping Robinson under the Terrorism Act was lawful and so he dismissed the case. The judge found that the police might have just stopped Robinson because of his beliefs, rather than for the purpose of determining whether he was a terrorist.”

Father of teen killer ‘desperately sorry’ for his failures as a parent

The father of Southport attacker Axel Rudakubana told the inquiry into the 2024 tragedy that his failure to confront his son’s violent behaviour and monitor his activities had “catastrophic consequences, for which I am desperately sorry.”

Speaking via video link to the inquiry at Liverpool town hall, on Monday, Alphonse Rudakubana said he had been “very scared” of his son and avoided confrontation, which meant he did not check the teenager’s internet use. Axel, who later stabbed three young girls to death at a Taylor Swift-themed holiday

club, had been stockpiling weapons and searching online for violent material.

“The combination of fear and the desire to

avoid confrontation by not inquiring into his activities undoubtedly prevented me from doing things that would be

expected of a parent," Alphonse said in a written statement. "This had catastrophic consequences, for which I am desperately sorry."

He accepted "his share of the responsibility" for the attack but also accused schools of unfairly targeting his son and making "malicious" referrals to the PREVENT counter-terrorism scheme.

The inquiry heard that moments before the 17-year-old left home to carry out the attack, his parents and older brother found knife packaging, but they did not alert police. Days earlier, Alphonse had prevented his son from returning to his former school, where he is believed to have planned another attack.

Axel's brother, Dion Rudakubana, said he was "surprised" to see his brother leave home alone for the first time in over two years and initially feared violence. But his parents dismissed the concern, thinking Axel had gone for a walk.

By 2024, Axel's behaviour at home had become "very frightening," Alphonse said. He recalled an incident where Axel poured oil over his head and threatened to kill him. "I had lost control of him. I had no authority as a father," he told the inquiry.

The teenager had a long history of violent behaviour, previously excluded from school for carrying knives and caught by police in 2022 with a blade on a bus, where he told officers he wanted to kill someone.

His brother Dion told the inquiry that Axel had been amassing parcels in the house that he feared contained weapons. "I was worried the parcels had something bad in them," he said, but admitted he never reported his concerns.

The inquiry continues.

Man in custody after horror knife attack on packed train

■ Eleven hospitalized in shocking attack on Doncaster-Kings Cross evening train

A 32-year-old man has been remanded in custody, charged with 10 counts of attempted murder after multiple people were stabbed on a train on Saturday evening.

Anthony Williams was arrested after the attack on an LNER train from Doncaster to London King's Cross, which stopped in Huntingdon, Cambridgeshire, shortly before 10pm local time.

Mr Williams, who gave his address as "no fixed abode", appeared at Peterborough Magistrates' Court on Monday wearing a grey tracksuit and handcuffs.

He was also charged with possessing a bladed article and one count of actual bodily harm in connection to an alleged assault on a police officer in custody.

Mr Williams is also accused of carrying out an earlier knife attack on another train in east London at about 00:45 on Saturday morning.

He is charged with a separate count of attempted murder and possessing a bladed article after a person suffered facial injuries in the attack at Pontoon Dock DLR station in Silvertown.

The court named the victims of the 10 counts of attempted murder at Huntingdon Railway Station as: Scott Bletcher, David Presland, Sachin Balakrishnan, Michael Paffett, Kevin Neely, Jonathan Gjoshe, Stephen Crean, Samir Zitouni, Rasza Aslam, Scott Green.

Mr Williams, whose address was listed in court documents as Cuckmere Lane, South-

ampton, will next appear at Cambridge Crown Court on 1 December.

The attack took place on the 18:25 London North Eastern Railway (LNER) service from Doncaster, South Yorkshire, to London's King's Cross station.

Police received the first call from passengers

on board at 19:39. Soon after the train was diverted to Huntingdon, an unscheduled stop.

Emergency crews took 10 people to Addenbrooke's Hospital in Cambridge - which is 30 minutes away from the station - and one person later went to the hospital for treatment.

A railway staff member who protected passengers during the Huntingdon attack is in a "critical but stable condition" in hospital, according to Transport Secretary Heidi Alexander.

Eleven people have been treated in hospital and five are still receiving care.

MPs seek George Cross for train attack heroes

Early Day Motion from Lib Dem MPs seeks country's highest civilian honor for heroic duo

Three MPs have called for two men who confronted the knife-wielding train attacker to be awarded the George Cross.

Pippa Heylings, South Cambridgeshire's Liberal Democrat MP, submitted an Early Day Motion to Parliament which called for Samir Zitouni and Stephen Crean to be given the medal that recognises civilians who display bravery in the face of danger.

Mr Zitouni, an LNER (London North Eastern Railways) worker on-board the Doncaster to London train, was critically injured during the

attack on Saturday after trying to help passengers.

Mr Crean has been hailed a hero after he confronted the train attacker and tried to block him from getting into the buffet car, where people were hiding.

The Early Day Motion has been supported by two other Cambridgeshire Liberal Democrat MPs, Charlotte Cane and Ian Sollom, and their party leader Ed Davey.

The George Cross is the highest honour that can be awarded to civilians.

Early Day Motions are a parliamentary process whereby MPs can call for

something to be debated in the House of Commons.

The motion, however, does not have the power to award the honour.

A recommendation has to be made by the George Cross Commit-

tee, which is then submitted through the prime minister to King Charles III.

In a joint statement the Cambridgeshire MPs said: "The bravery shown by Samir Zitouni and Stephen Crean un-

doubtedly saved lives.

"Their bravery and disregard for their own safety in putting others first represents the very best of Britain.

"Mr Zitouni placed himself in harm's way to

Sir Alan Bates agrees multimillion-pound settlement over Post Office scandal

■ Government settles claim from former post office operator more than 20 years after he began his campaign for justice

Sir Alan Bates has agreed a multimillion-pound settlement with the government more than two decades after he began the campaign for justice for post office operators over the Horizon IT scandal.

Bates has previously accused the government of presiding over a "quasi-kangaroo court" system for compensation, and last year said that post office operators may return to court over delays with settling claims.

The 70-year-old, who was knighted last year, was portrayed by the

actor Toby Jones in the hit ITV drama *Mr Bates vs the Post Office*, which thrust the plight of post office operators into the national spotlight. Bates revealed in May that he had been handed a "take it or leave it" compensation offer of less than half his original claim.

Bates, who led the campaign over the scandal, which has been called Britain's biggest miscarriage of justice, said the final offer amounted to 49.2% of his original claim.

convictions overturned

Sky News has reported that his original claim could have been in the region of £10m, indicating a final settlement with the government of between £4m and £5m.

"We can confirm that Sir Alan's claim has reached the end of the scheme process and been settled," a government spokesperson said. "We pay tribute to Sir Alan Bates for his long record of campaigning on behalf of victims

and have now paid out over £1.2bn to more than 9,000 victims."

About 3,200 compensation claims remain outstanding.

More than 900 post office operators were convicted of offences including fraud, false accounting and theft between 1999 and 2015 after the faulty Horizon IT system falsely showed that money was missing in branch accounts.

The convictions were overturned last year by an unprecedented act of parliament.

Earlier this year, Bates accused the Department for Business and Trade (DBT), which took over administration of the compensation schemes from the Post Office, of reneging on assurances given when they were set up.

"The subpostmaster compensation schemes have been turned into quasi-kangaroo courts in which the DBT sits in judgment of the claims and alters the

protect passengers, sustaining serious injuries in the process, while Mr Crean confronted the attacker to give others time to reach safety.

"Both men's actions were nothing short of heroic, and they deserve the highest recognition our country can give.

"We would also like to pay tribute to the response of the train driver, emergency services, and the incredible staff at Addenbrooke's Hospital, who continued Samir's and Stephen's example of selflessness and care to ensure the safety and recovery of all those affected."

Anthony Williams, 32, of no fixed abode, was charged with 10 counts of attempted murder relating to the train stabbing and a count of attempted murder in connection with an attack in London.

He is due to appear at Cambridge Crown Court on 1 December.

Serial rapist cop Carrick facing 30 year jail term

Serial rapist and former Metropolitan Police officer David Carrick will serve a minimum of 30 years in jail.

Carrick was told he had taken "monstrous advantage of women" as he was sentenced to 36 life terms on Monday.

The 48-year-old committed violent and degrading sexual offences against a dozen women over two decades.

His victims, one of whom had a gun held to her head while being raped and another who was hit with a whip, spoke of how they had "encountered evil".

Flanked by two security guards, Carrick showed no emotion as he was sentenced by Mrs Justice Cheema-Grubb.

"You behaved as if you were untouchable," she told him.

"The malign influence of men like you in positions of power stands in the way of a revolution of women's dignity."

The judge also praised the bravery of his victims, some of whom were in the packed courtroom, saying that the voice of courage cannot be denied.

Home Secretary Suella Braverman said Carrick's crimes, carried out from

goalposts as and when it chooses," he told the Sunday Times in May.

More than 550 post office operators were vindicated in 2019 when a 400-page judgment found the faulty system relied upon to secure the convictions was not "remotely robust" and the Post Office agreed to pay £58m to settle the claims.

In July, the first volume of the public inquiry into the scandal, led by retired high court judge Sir Wyn Williams, was published with findings including that at least 13 people had taken their own lives as a result of being accused of wrongdoing by the Post Office.

The offer of 49.2% came after Bates's case was

assessed by Sir Ross Cranston, a former high court judge, who adjudicates on cases in which a claimant disputes a compensation offer from the government and then objects to the results of a review by an independent panel.

Lawyers representing Bates declined to comment.

2003 to 2020, were a "scar on our police".

Southwark Crown Court heard he would "use his power and control" to stop victims reporting him, with one stating it was "drilled into" her that he was a police officer.

In statements read out in court, another victim said she felt she had "encountered evil" after being repeatedly raped by Carrick who put a handgun to her head.

Another woman said Carrick hit her with a whip and would shut her in a small cupboard as punishment while "whis-

pling at her as if she was a dog".

Carrick's crimes include dozens of rape and sexual offences, mostly committed in Hertfordshire, where he lived, and all took place while he was a serving officer.

Mrs Justice Cheema-Grubb said: "These convictions represent a spectacular downfall for a man charged with upholding the law, and empowered to do so even to the extent of being authorised to bear a firearm in the execution of his duty.

"You were bold and, at times, relentless, trusting that no victim would

overcome her shame and fear to report you.

"For nearly two decades you were proved right, but now a combination of those 12 women, by coming forward, and your police colleagues, by acting on their evidence, have exposed you and brought you low."

Carrick, who had undertaken a course on domestic violence in 2005, was sacked by the Met the day after he pleaded guilty. The force's Commissioner, Sir Mark Rowley, has apologised for failings and said opportunities to remove him from policing were missed.

Now THAT'S what you call a cold one: rare bottle of Artic brew to be opened 150 years later

A brewer plans to open up a 150-year-old bottle of beer, made for an Arctic expedition, so a modern version can be created.

The original Allsopp's Arctic Ale was bottled in Burton-upon-Trent for Sir George Nares, when he set out to reach the North Pole in 1875.

It was later discovered in a box in a garage in Gobowen, Shropshire, and sold at auction for £3,300 in 2015.

The buyer was Dougal Gunn Sharp, founder and master brewer of Edinburgh-based Innis & Gunn, and he now plans to use the ale to seed a new limited-edition beer.

Samuel Allsopp & Sons in Burton-upon-Trent designed the

beer for sailors enduring temperatures as low as -40C and it had an alcohol strength of about 9%.

The beer was said to resist freezing because of its unfermentable sugars and it had six times the calorie content of conventional beer.

It was used on a number of British Arctic expeditions and records from the time said it was dark brown and so thick it had to be lifted from the brewing copper in buckets.

Mr Sharp plans to work in partnership with Allsopp's Brewery on the new beer, which will be called Innis & Gunn 1875 Arctic Ale.

He said: "Some people might think it's madness to open it, but I think the real madness would be to leave it sit-

ting on a shelf.

"Beer is meant to be shared, particularly on this, its 150th anniversary."

Mr Sharp also said there was "something very special" about being able to taste a "piece of brewing and maritime history".

Jamie Allsopp, founder of the revived Allsopp's Brewery and a direct descendant of Samuel Allsopp, said there was "something uniquely romantic about Allsopp's Arctic Ale".

He said the beer was "one of the strongest and most extraordinary beers ever made" and he said when he was first approached by Mr Sharp with the idea of making a new version "I honestly thought he was mad."

The idea of using the original beer to create a new one was "a kind of

alchemy", he said.

The new beer will be released later this year,

with a small number of hand-bottled examples sold through a ballot.

Frankie the flighty flamingo leaves keepers in a flap

Frankie the flamingo may have been tickled pink when she escaped her wildlife sanctuary in Cornwall but her keepers are worried by her disappearance.

The four-month-old female flamingo managed to take flight on Sunday, despite having her feathers clipped, from the walled garden at Paradise Park near Hayle.

Staff from the park are searching the surrounding area and have responded to nearby sightings of the young bird, who was last seen at the park at 8am on Sunday.

Sightings were reported near Porthtowan - about 13 miles away by road - on Sunday morn-

ing and back in Hayle on Sunday afternoon.

Paradise Park said on social media on Monday that it had not found the young flamingo and searches were continuing. The park said on Instagram: "Huge thanks to everyone who has shared sightings of Frankie, our missing flamingo, and helped to spread the word by sharing our posts appealing for info.

"We are worried for her and will be continuing the search today so will be very grateful if you let us know if you see her.

"On Sunday morning Frankie managed to take flight from the walled garden at Paradise Park

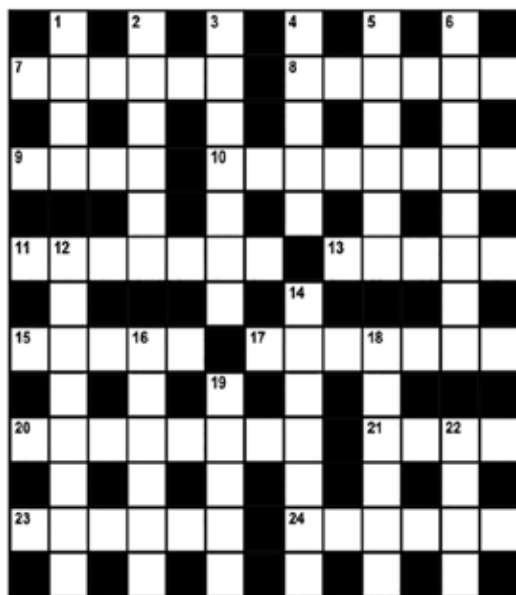
in Hayle despite having clipped feathers. She was seen at the Park at 8am, near Porthtowan at 10.15am, then above Hayle River and Copperhouse Pool, Hayle between 12 and 2pm."

Frankie hatched on 1 July 2025, the first flamingo chick to hatch on the nest and be reared by its parents at Paradise Park.

The Caribbean flamingo is known for its long legs and neck and distinctive pink plumage. Their legs let them wade in deep water and they filter their food of algae and shrimp out of the mud, which is what gives them their pink colouring. They can live until the age of 40.

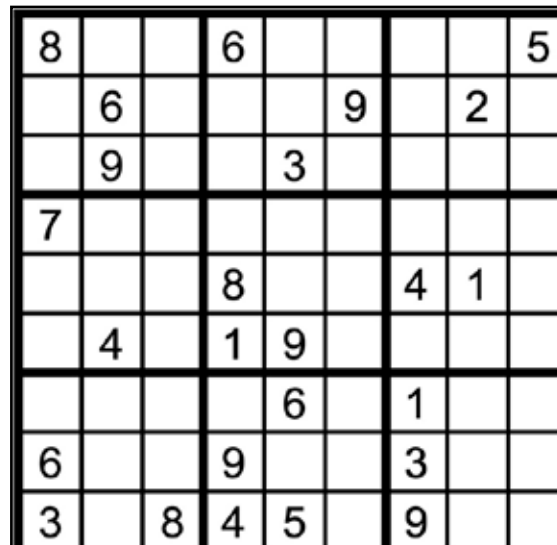

Octogenarian star plans to shrug off his recent spate of injuries to reprise iconic role

Sir Ian McKellen has insisted he will reprise his iconic role as Gandalf in the next instalment of the Lord Of The Rings - despite recent injuries.

The actor, 86, revealed his plans to return to the role which he initially played in Peter Jackson's film trilogy of The Lord of the Rings - comprising The Fellowship of the Ring, The Two Towers, and The Return of the King, between 2001 and 2003.

A new live-action Lord of the Rings movie, given the

working title The Lord of the Rings: The Hunt for Gollum, is scheduled for release on 17 December 2027, with filming pegged to start in New Zealand in May 2026.

His determination may come as a shock to some, after Sir Ian fell off the stage of the Noel Coward theatre in the West End in June, when he was playing Sir John

Falstaff in The Player Kings - a modern interpretation of Shakespeare's Henry IV - leading to a chipped vertebra and fractured wrist.

'not slowing down'

Despite approaching his ninth decade, Sir Ian vowed 'not to slow down' amid his health woes, saying: 'Next year, I'm talking about going back to Middle Earth and reprising a little bit of Gandalf, I am not slowing down.'

Sir Ian's fall saw him forced to pull out of the rest of the run as Sir John Falstaff, last year following the shock injuries which stunned fans.

He later said he felt 'ashamed' and 'emotional' for letting down West End audiences, and said that it had made him 'aware there isn't much time left'.

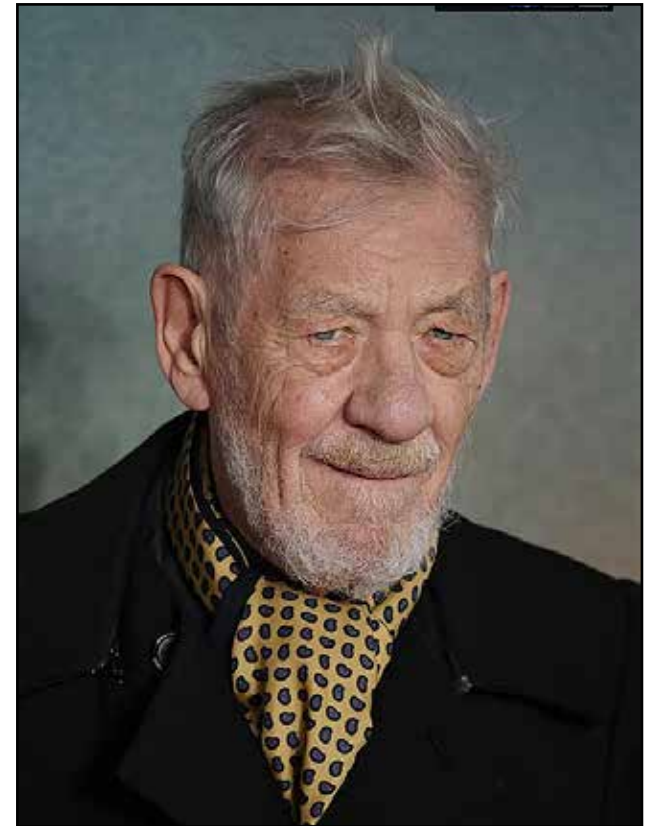
Speaking to the Daily Mirror, Sir Ian gave a nod to his fall, saying: 'Well, I am in the sense that however hard you are working on a film, it's not as hard work as being in

the theatre or, as I now realise, anywhere near as dangerous...

'I think if I had been a bit younger, I might have jumped up or sat down or something to stop it. There was something in my head that was saying, 'This is the end'....

'But it was the end of that production for me. I fell into the lap of someone on the front row. And thanks to that lap, and thanks to the padding I was wearing, I did very little damage, but I thought I was a gonner.'

But even though they only had 10 players on the pitch, Van de Ven scored one of the goals of the season. He picked up the ball inside his own half, on the edge of his own penalty area and stormed down the pitch, dribbling past

Champions League: MacAllister rises to the occasion as Liverpool secure a seismic victory

Liverpool were back to their brilliant best as they dominated Real Madrid on Tuesday night with an outstanding performance to secure a crucial Champions League victory at Anfield.

Arne Slot's Premier League champions ended a spell of six defeats in seven games with a win against Aston Villa on Saturday, and the revival continued as Real were overpowered.

Liverpool's victory was far more convincing than the scoreline suggests, with Alexis Mac Allister finally breaking the deadlock in the second half as former Reds defender Trent Alexander-Arnold watched from the bench with his new side strictly second best.

Only the brilliance of Real keeper Thibaut Courtois kept Liverpool at bay, with a string of superb saves, including four from Dominik Szoboszlai and a brilliant reflex stop from Virgil van Dijk's header.

But the giant Belgian keeper was powerless to stop Liverpool finally getting the goal their superiority deserved when Mac Allister stole in to head home from Szoboszlai's free-kick after 61 minutes.

Alexander-Arnold came on late in the game, amid a storm of booing from the Liverpool fans who once idolised him, but he was unable to fashion a breakthrough as Real - with Jude Bellingham and Kylian Mbappe subdued - unable to deny Slot's team an important three points.

Conor Bradley has long been regarded as the heir apparent to the vacancy left behind by Alexander-Arnold, and the 22-year-old Northern Ireland defender showed exactly why with an outstanding display.

Liverpool's fans revelled in Bradley's physical battle with Vinicius Jr, chanting his name to the echo while reserving their fury for the local boy who left Anfield behind.

Bradley's progress has been curtailed by injuries, but he was the symbol of a Liverpool display which carried all the old intensity and creation that deserted them during their recent run of losses.

Szoboszlai was outstanding in midfield, only denied by the brilliance of Courtois, while match-winner Mac Allister's return to form in the last two games has also transformed a side that looked lost earlier this season.

Liverpool's defence never yielded to Real at any point, and it was only when Courtois was at his defiant best that it looked like the Reds might not get the win that pushes them up into sixth in the table, a standing that would earn them automatic passage into the last 16 without the need for a play-off.

Bellingham had the perfect stage to deliver a reminder of his quality after his recent much-discussed exclusion from head coach Thomas Tuchel's England squad. Bellingham has been in form as Real lead La Liga, but he was largely anonymous as Liverpool controlled the game for virtually its entirety, apart from one breakthrough in the first half when he forced keeper Giorgi Mamardashvili to save with his feet.

In the end, like the rest of his team-mates, Bellingham was simply unable to make any serious impact in a disappointing display from the visitors.
